(57) **CLAIM**

The ornamental design for an organizer kit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an organizer kit showing my new design;

FIG. 2 is a front elevational view with the rear view being a mirror image thereof;

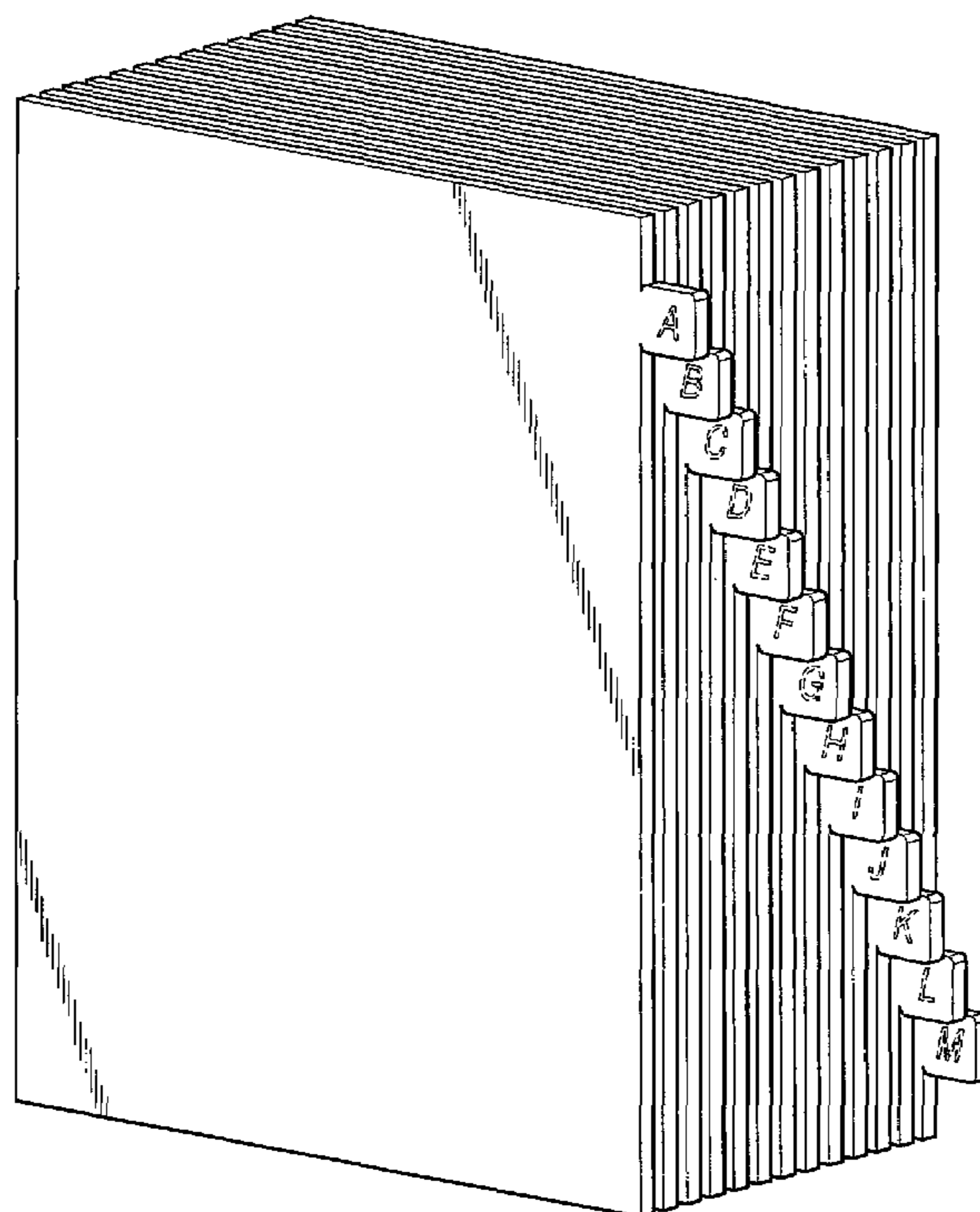
FIG. 3 is a right side elevational view thereof;

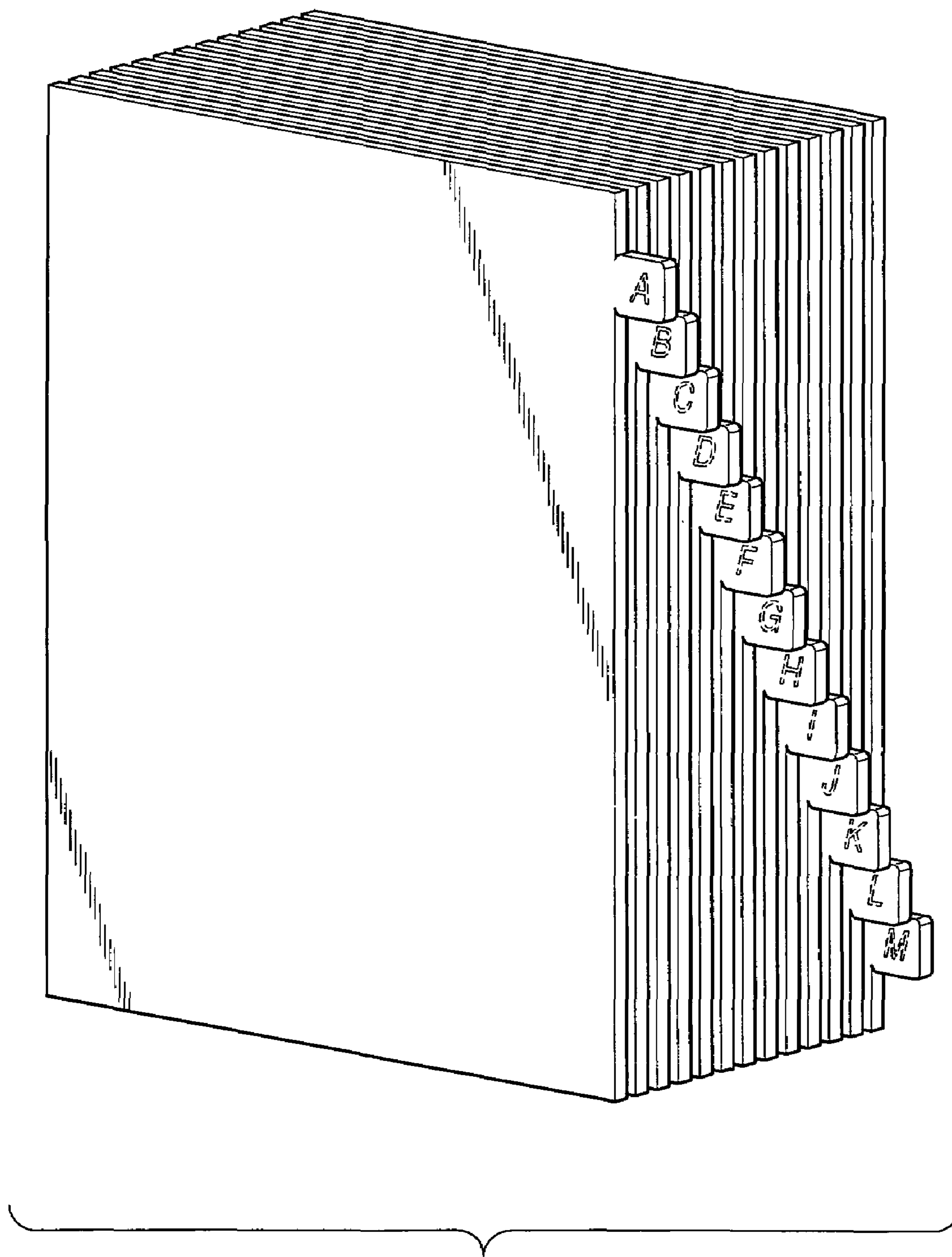

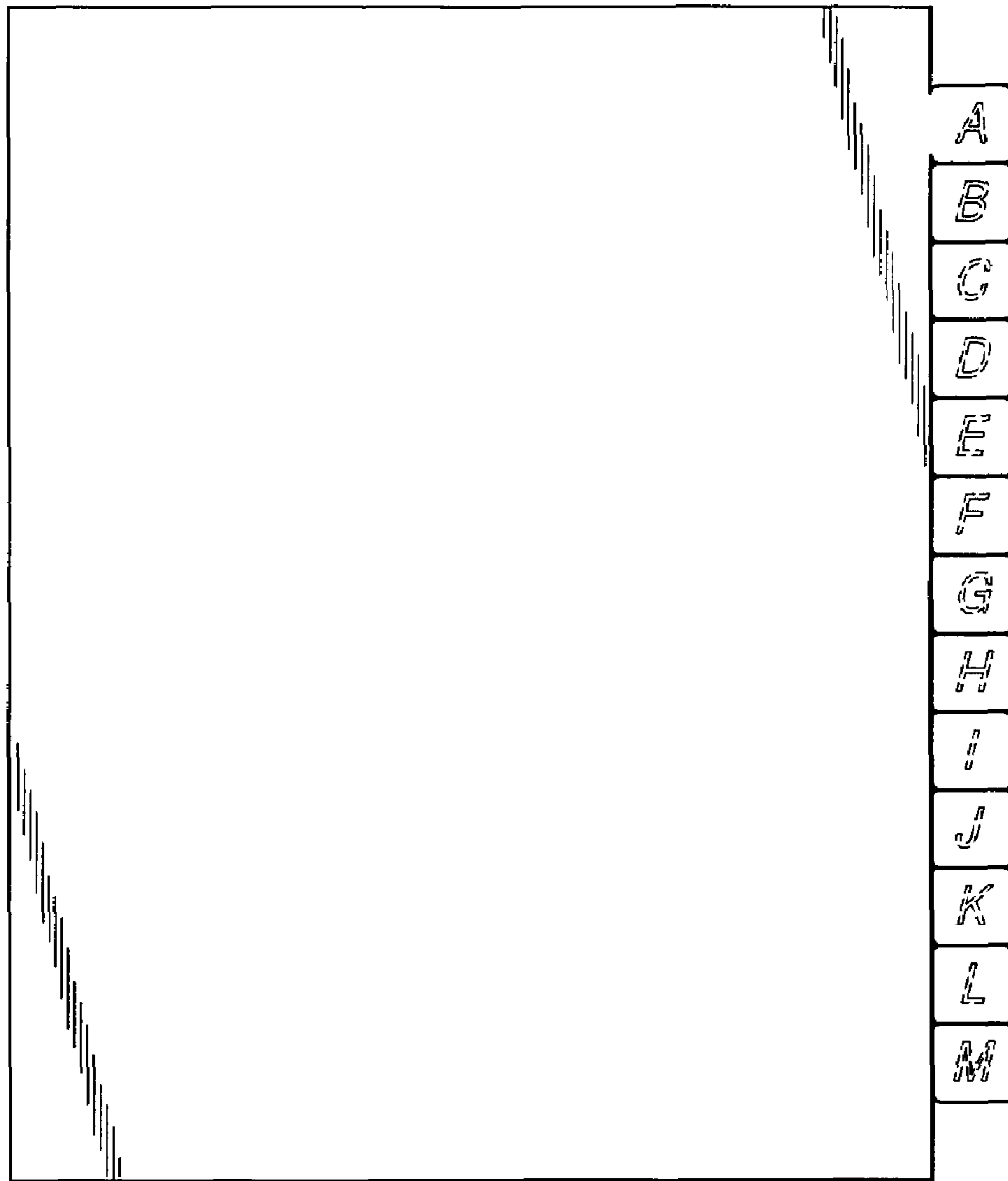

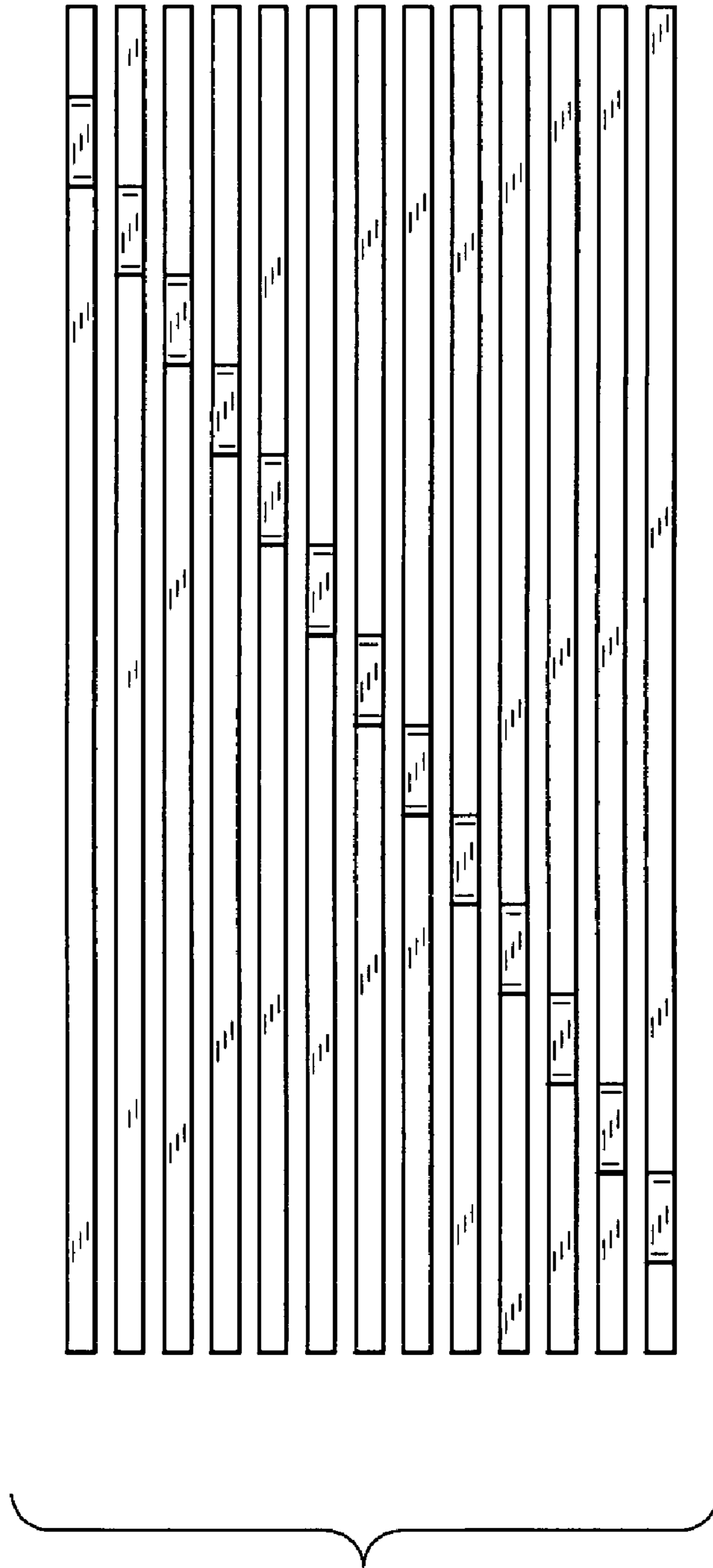

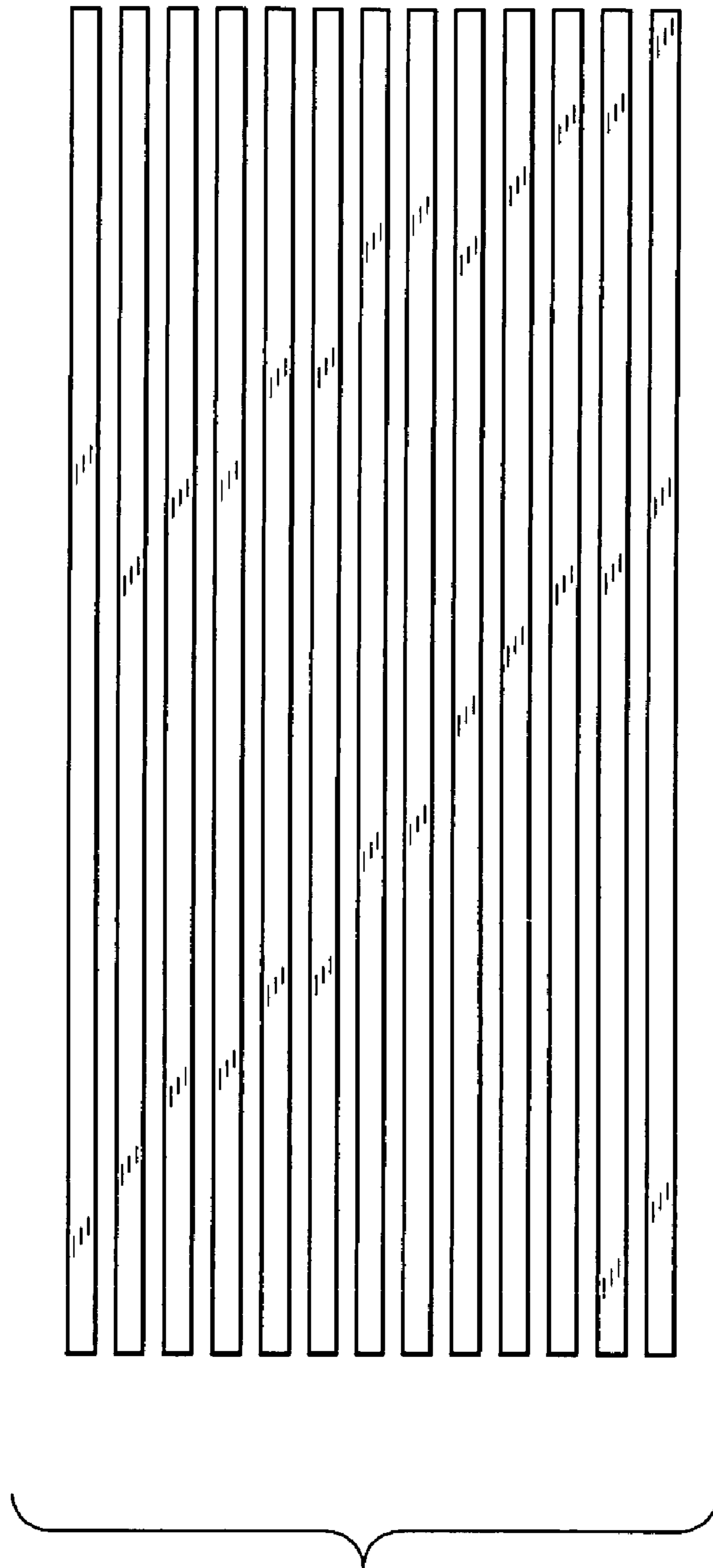

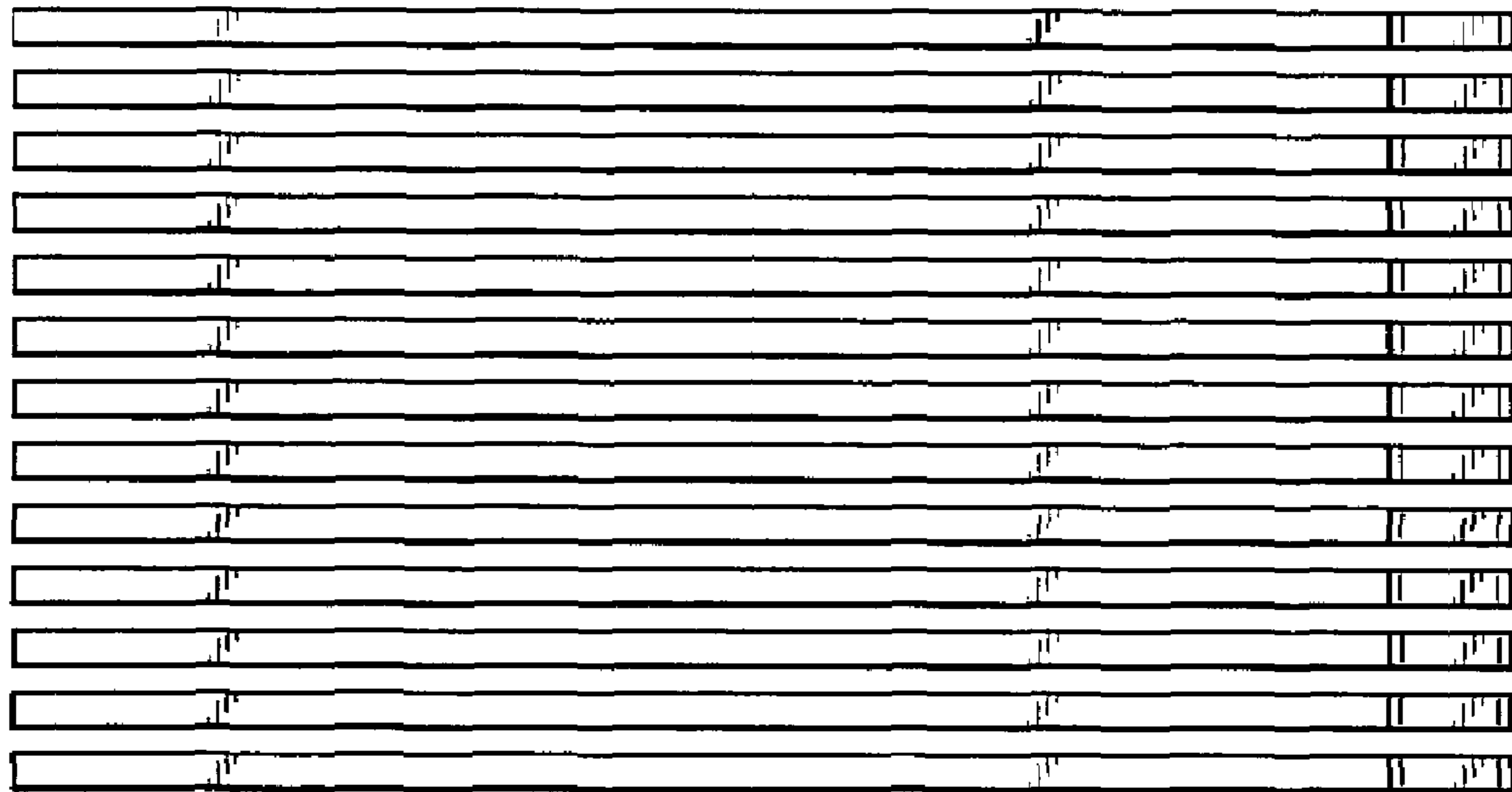
