(57) **CLAIM**

I claim an ornamental design for the open face simulated neon sign, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the open face simulated neon sign;

FIG. 2 is a rear elevational view of the open face simulated neon sign;

FIG. 3 is a plan view of the open face simulated neon sign of FIG. 1;

FIG. 4 is a bottom view of the open face simulated neon sign;

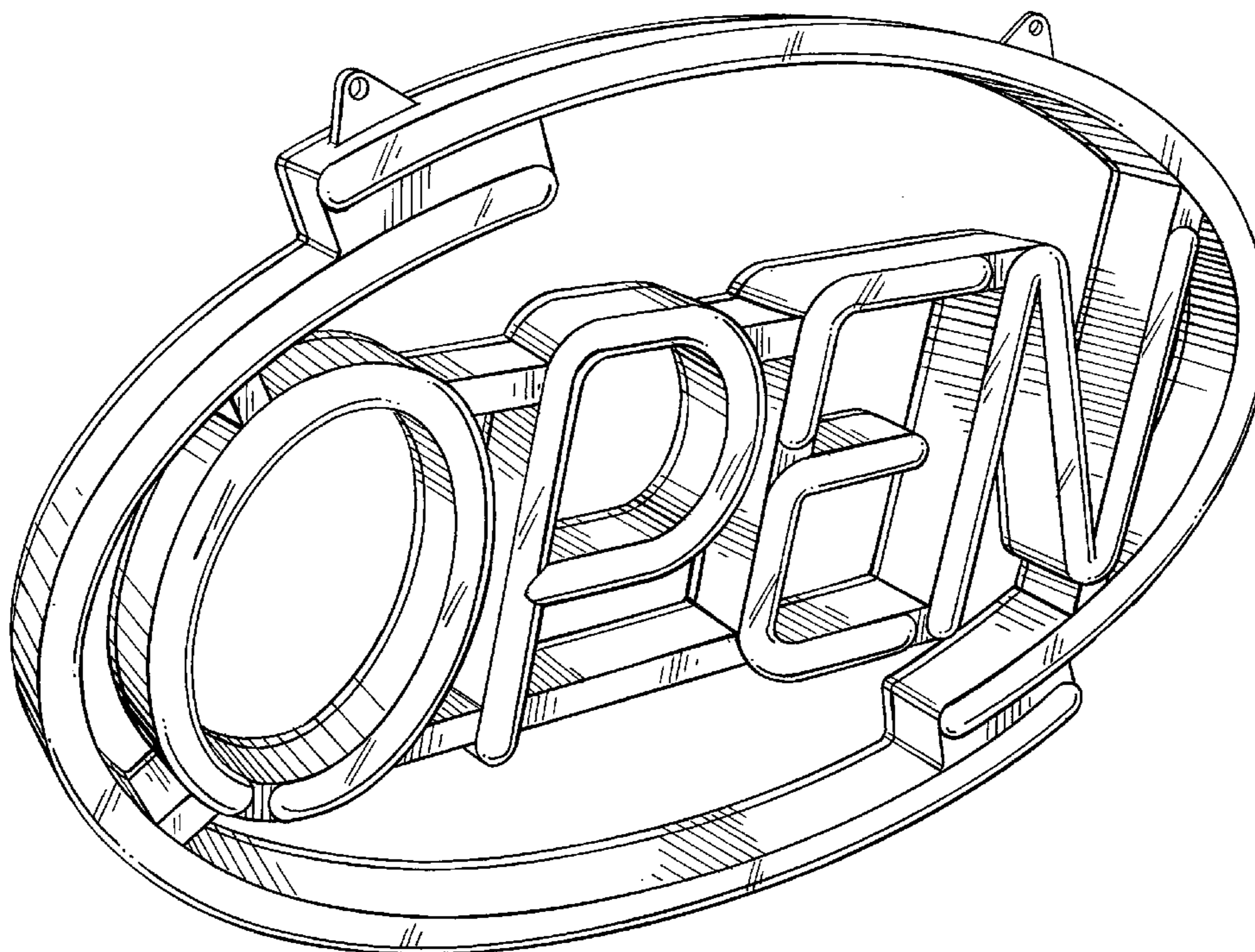
FIG. 5 is a left side end view of the open face simulated neon sign;

FIG. 6 is a right side end view of the open face simulated neon sign; and,

FIG. 7 is a perspective view of the open face simulated neon sign of the present invention.

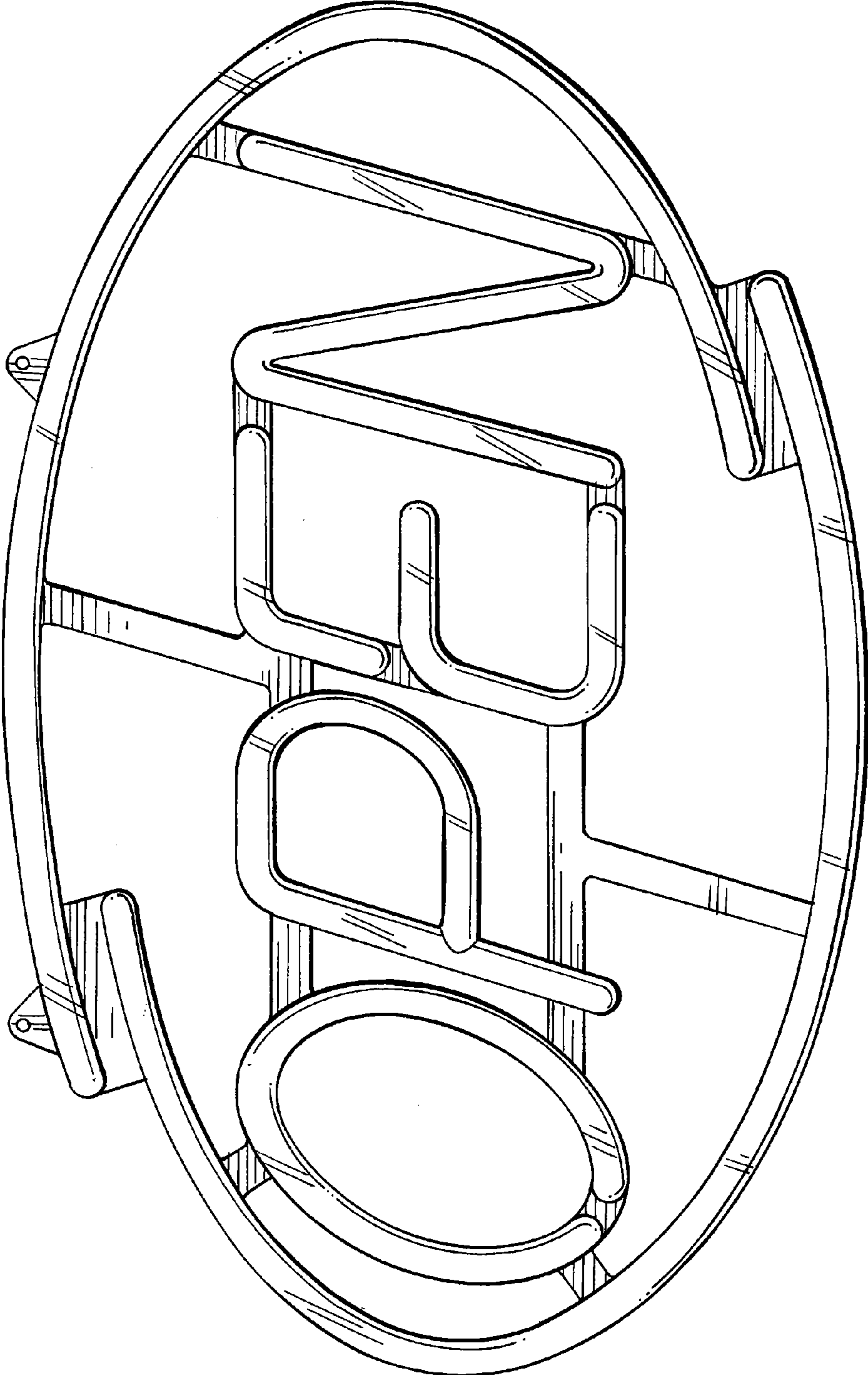

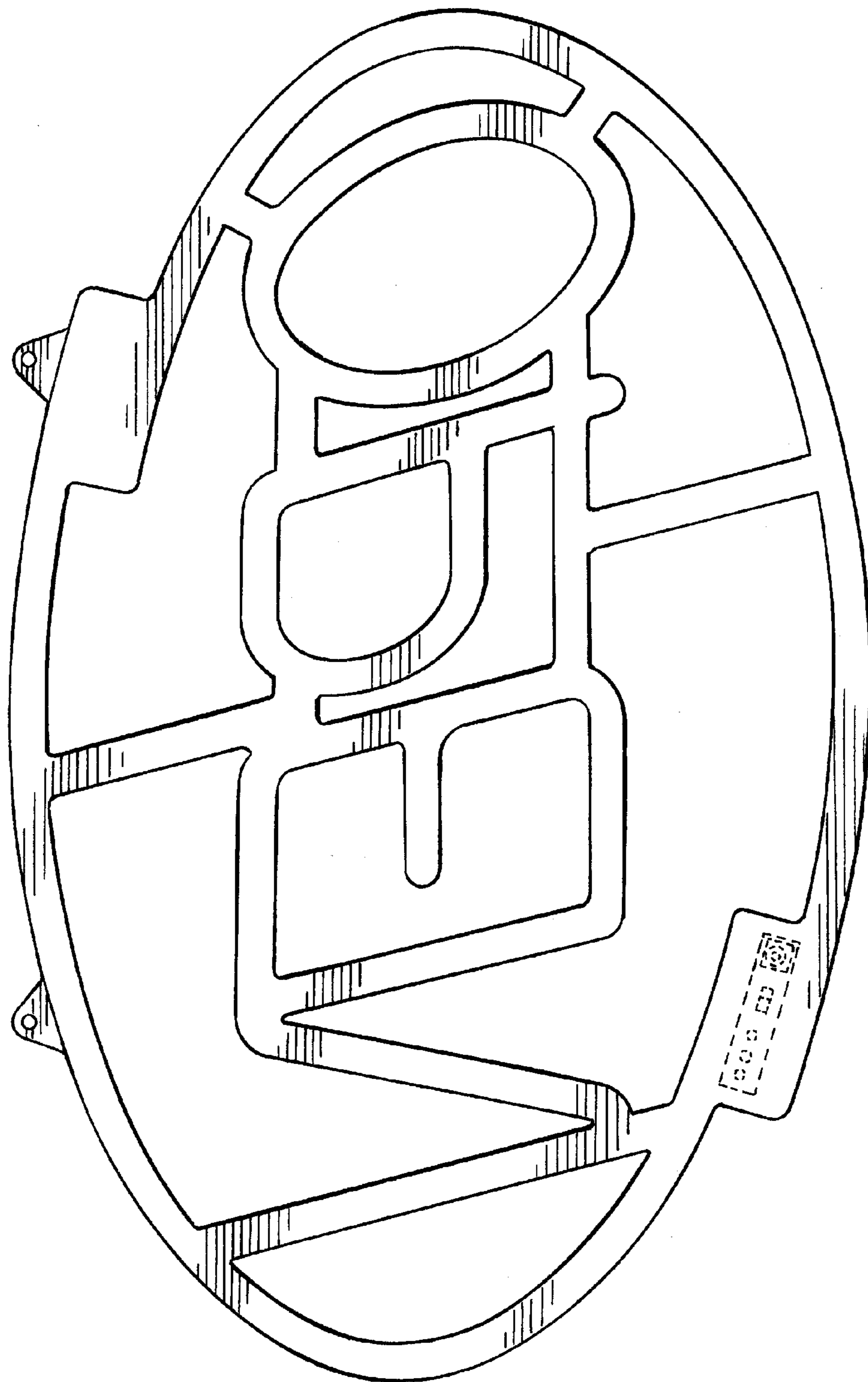

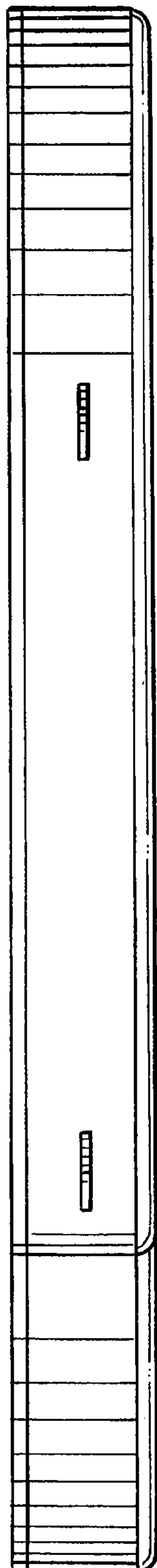

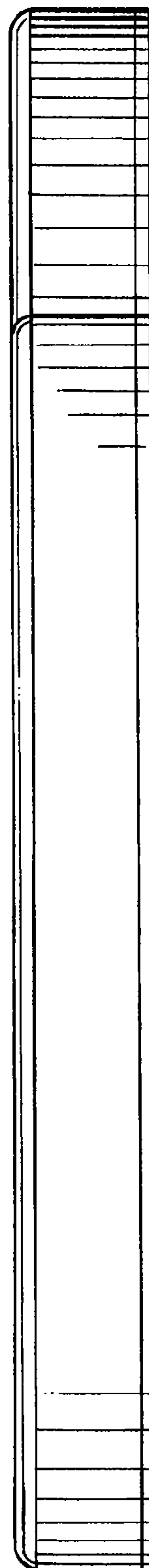

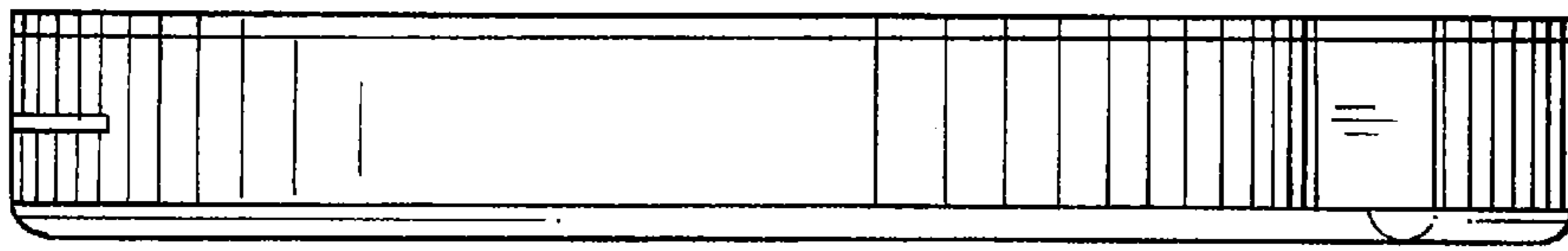

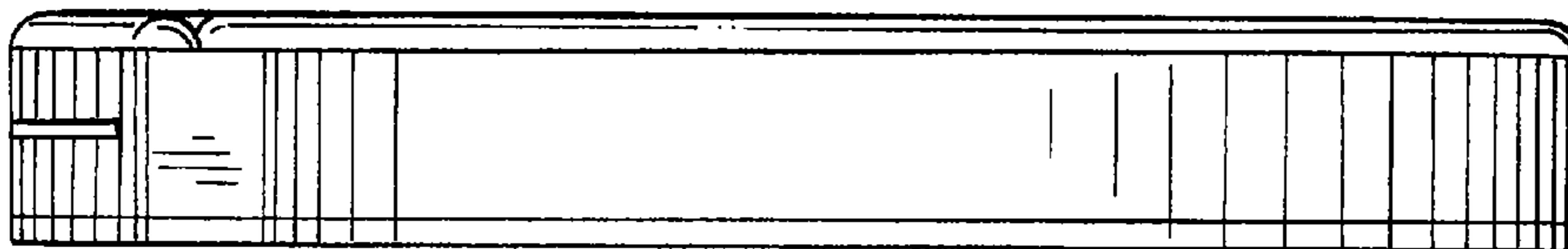

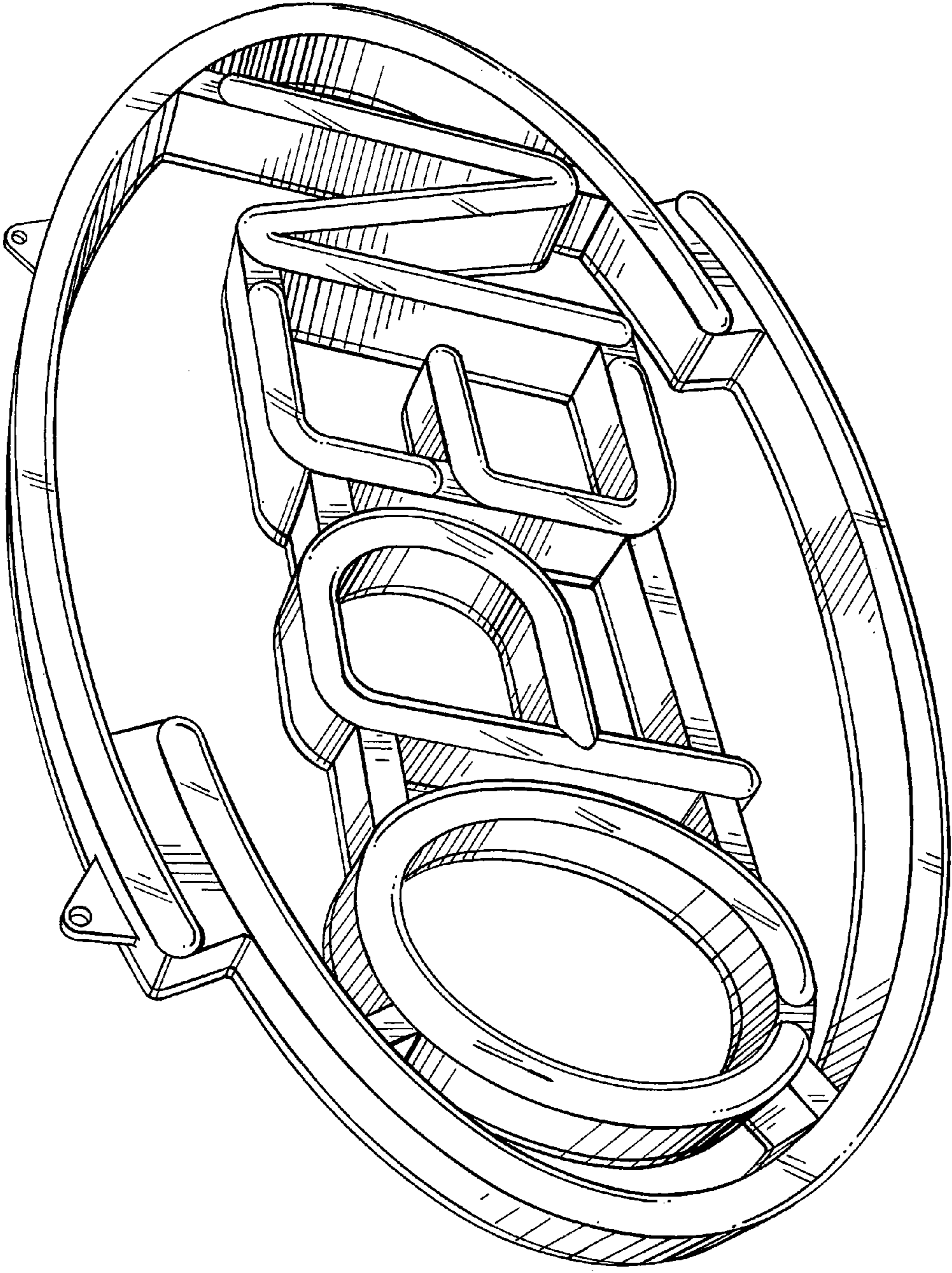
