(57) **CLAIM**

I claim an ornamental design for the electronic sign housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the electronic sign housing;

FIG. 2 is a rear elevational view of the electronic sign housing;

FIG. 3 is a plan view of the electronic sign housing of FIG. 1;

FIG. 4 is a bottom view of the electronic sign housing;

FIG. 5 is a right side end view of the electronic sign housing;

FIG. 6 is a left side end view of the electronic sign housing; and,

FIG. 7 is a perspective view of the electronic sign housing of the present invention.

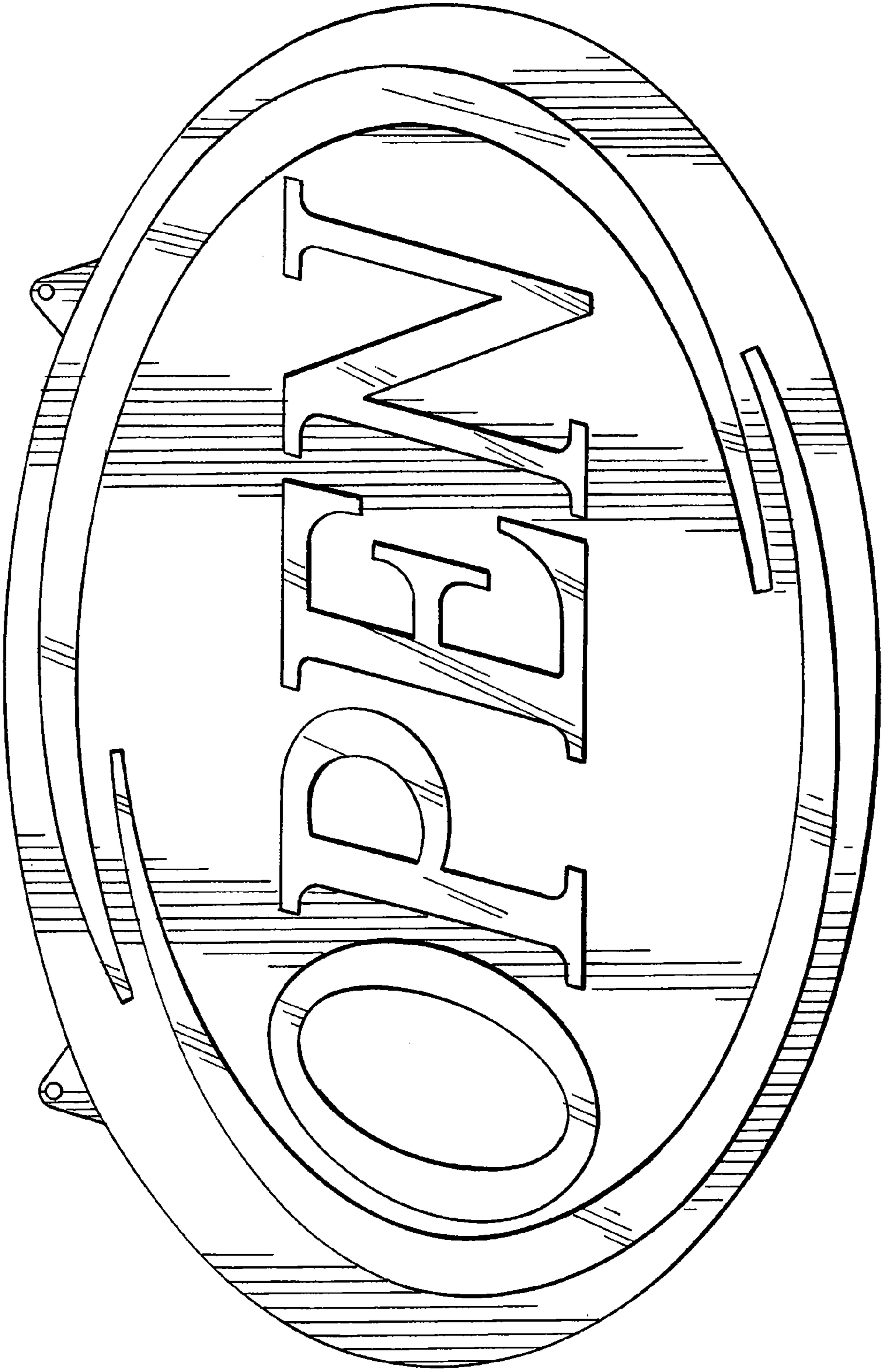
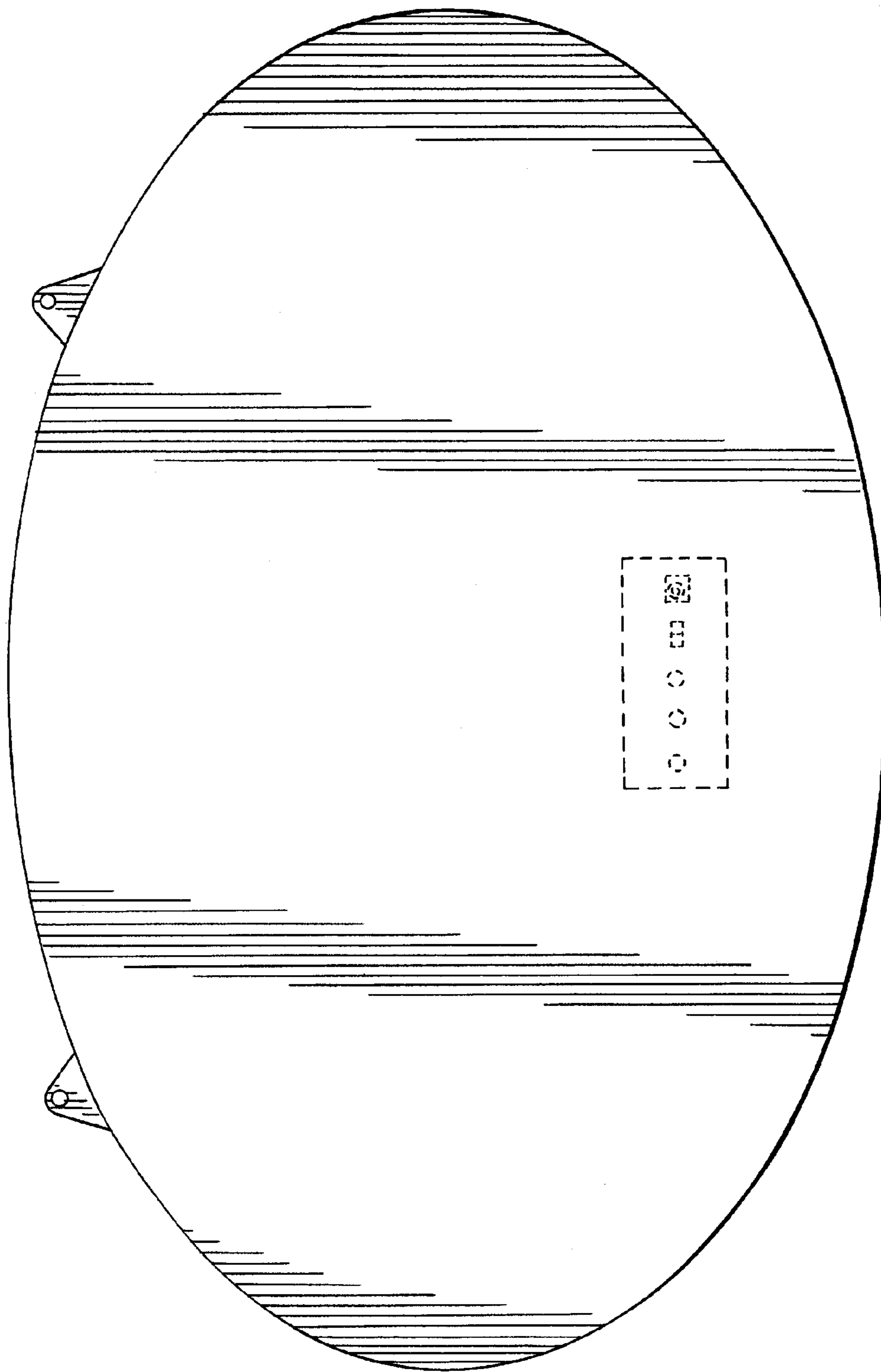
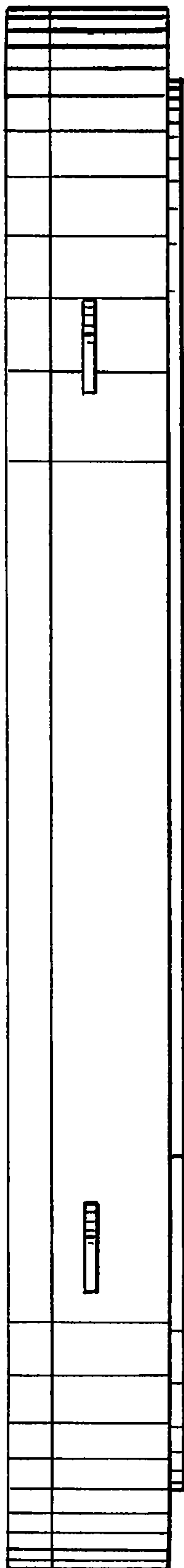


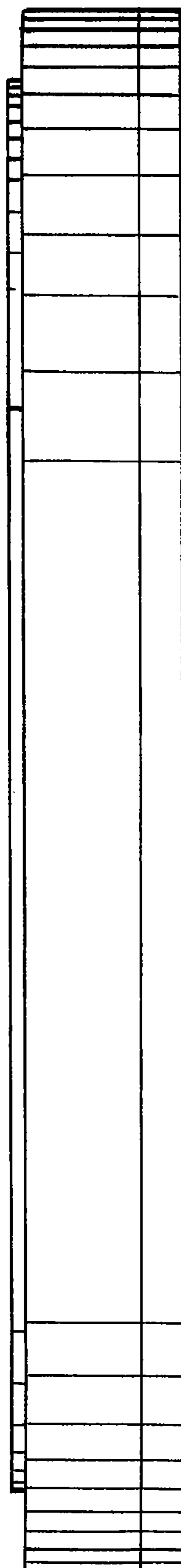

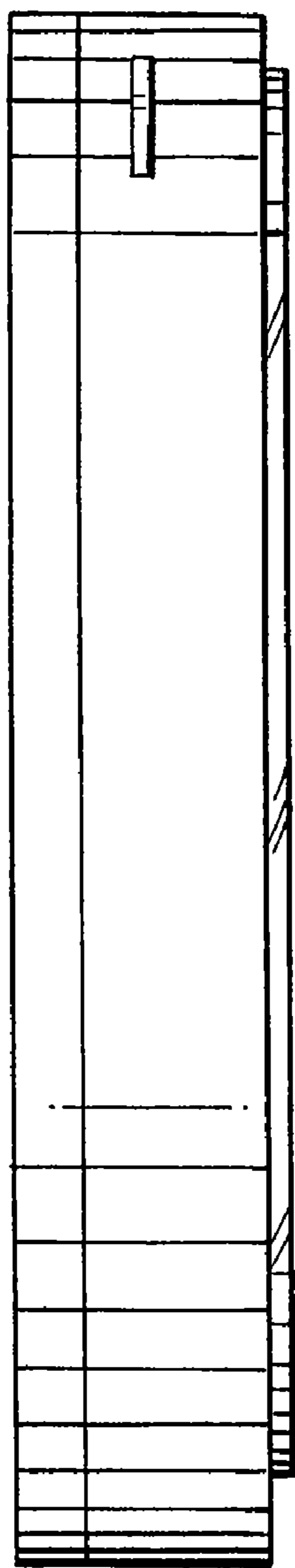

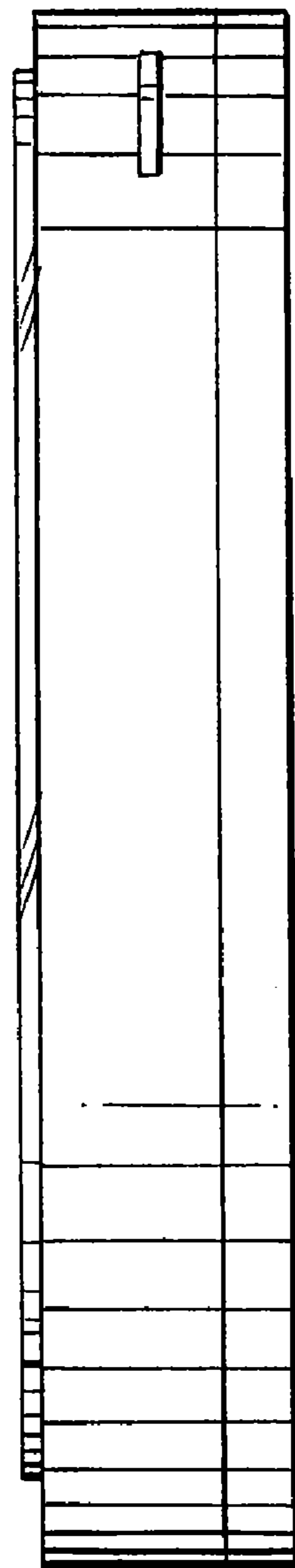

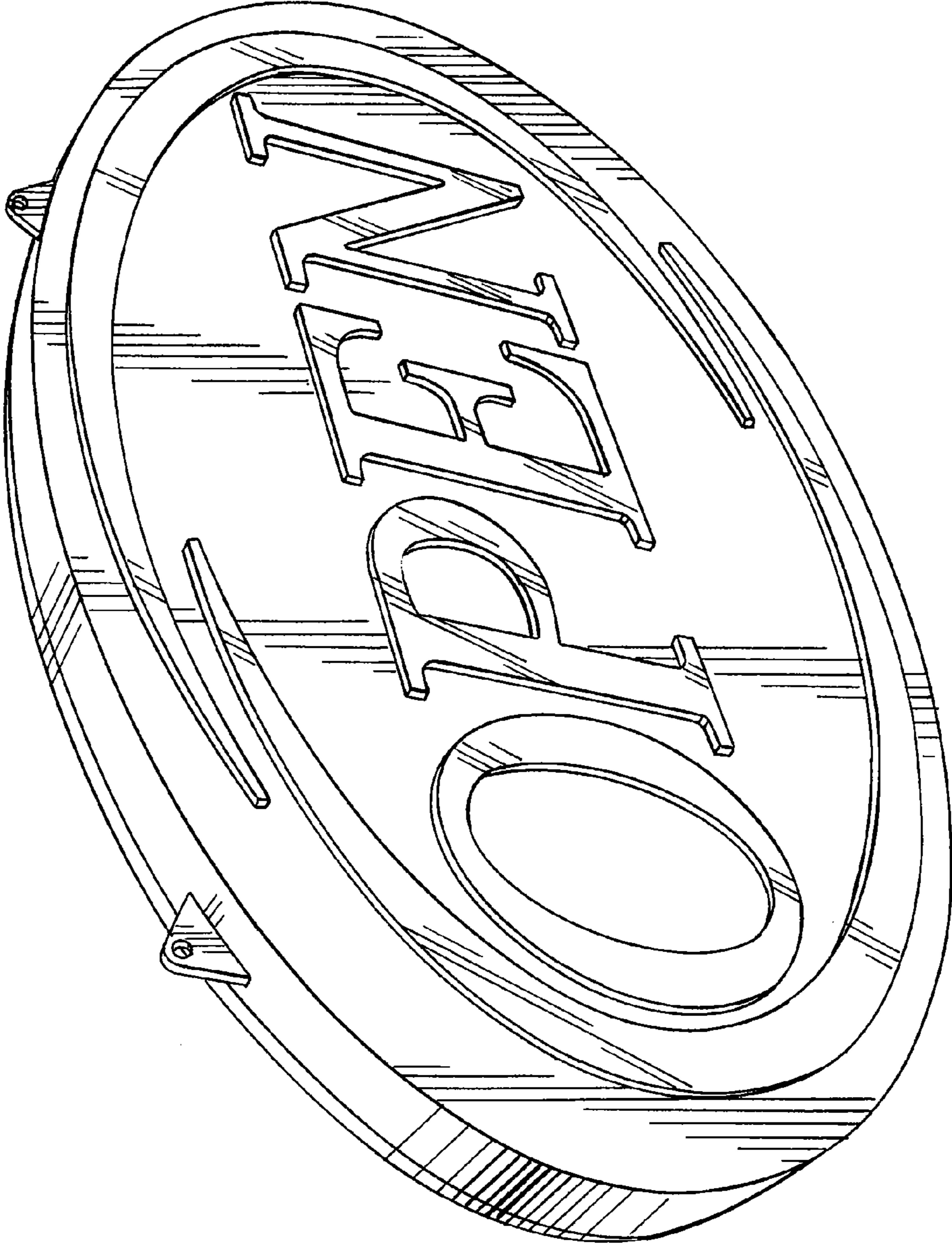
