DESCRIPTION

FIG. 1 is a top plan view of the hand paddle of the present invention showing our new design;

FIG. 4 is a right side elevational view thereof; and,

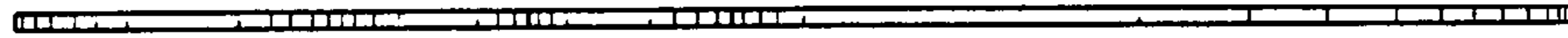

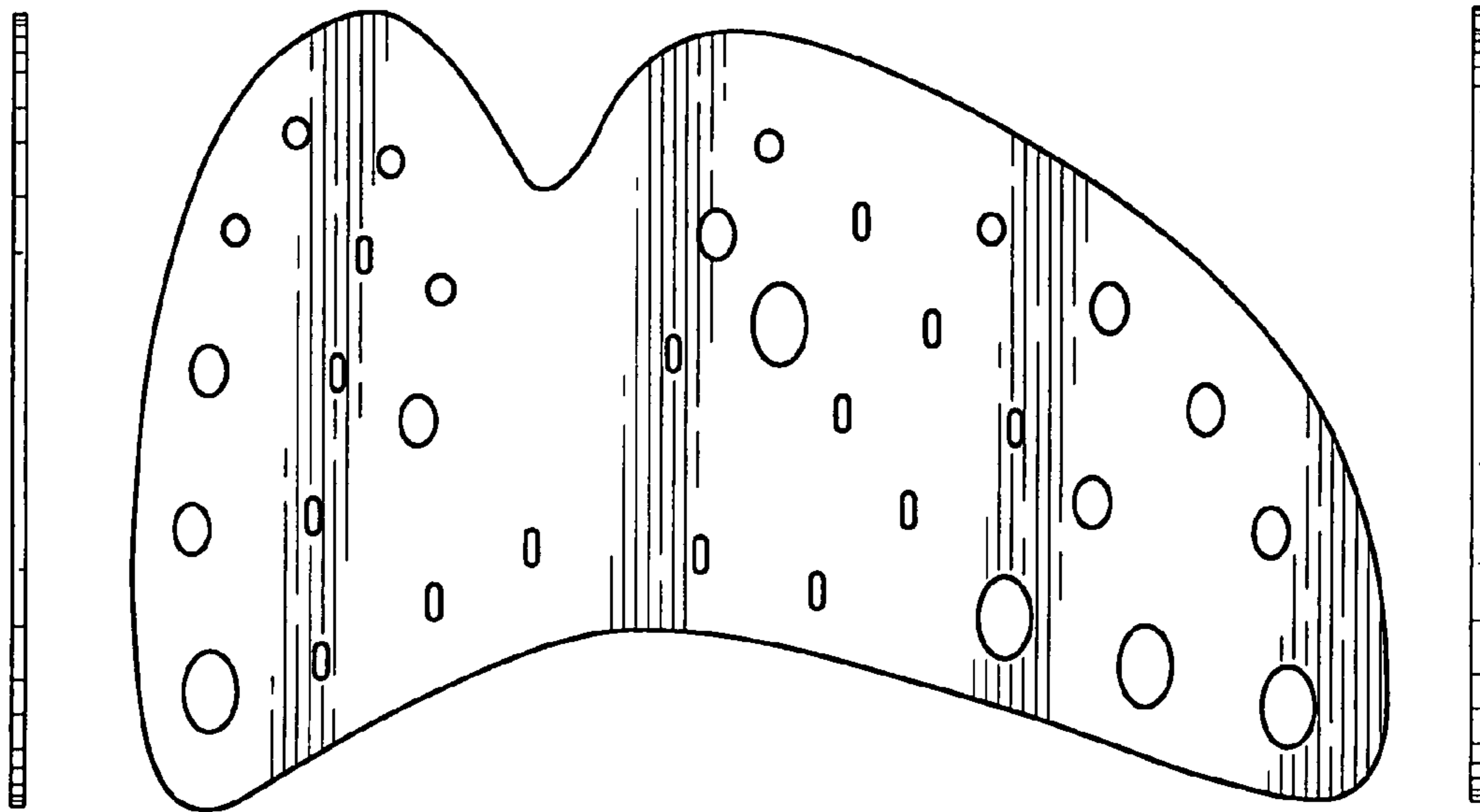

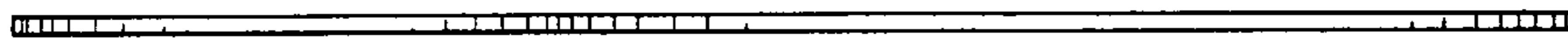
