DESCRIPTION

FIG. 1 is a side view of a fire arm with ergonomic grip showing our new design;

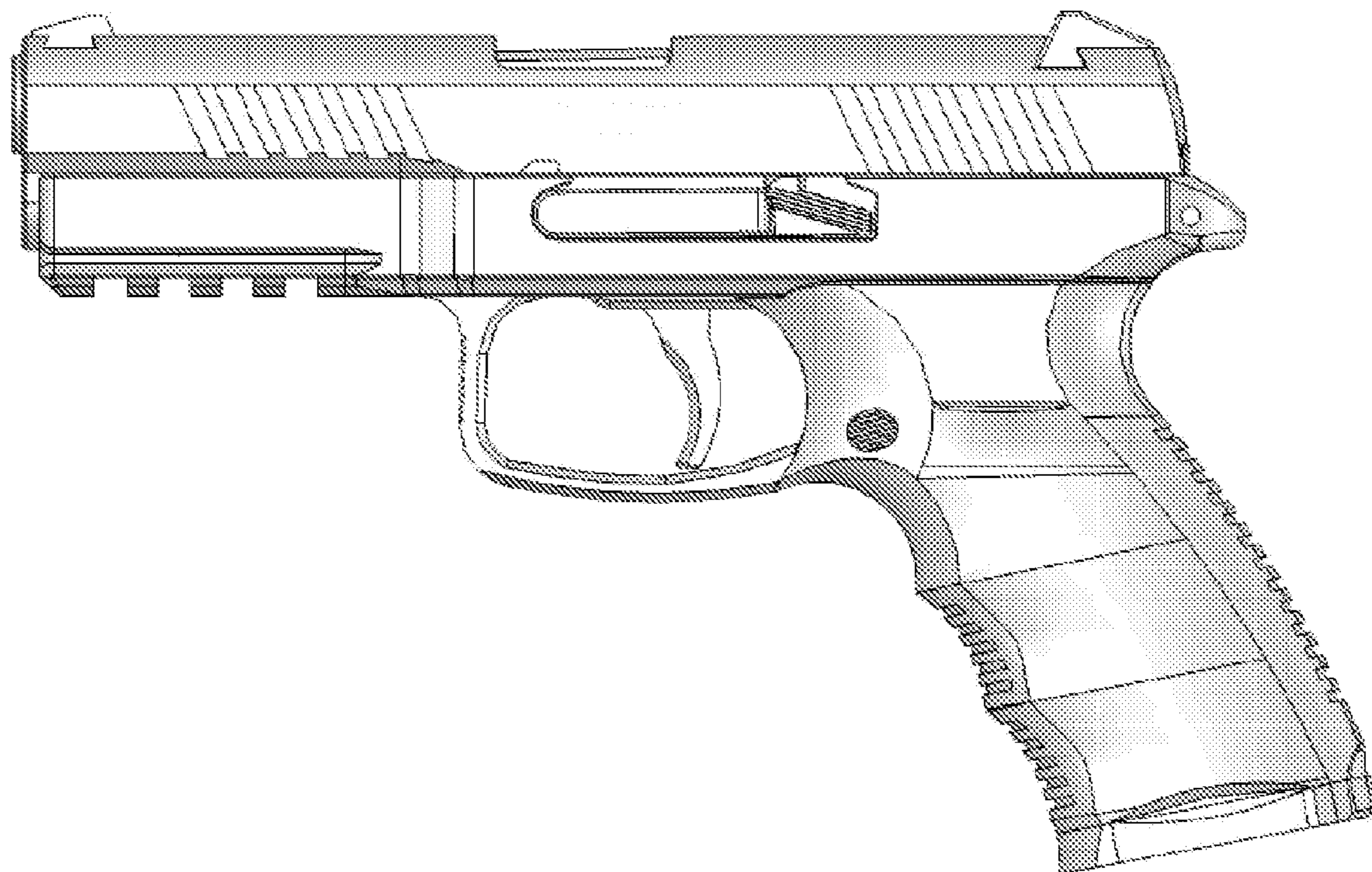
FIG. 2 is a rear view of the fire arm of FIG. 1;

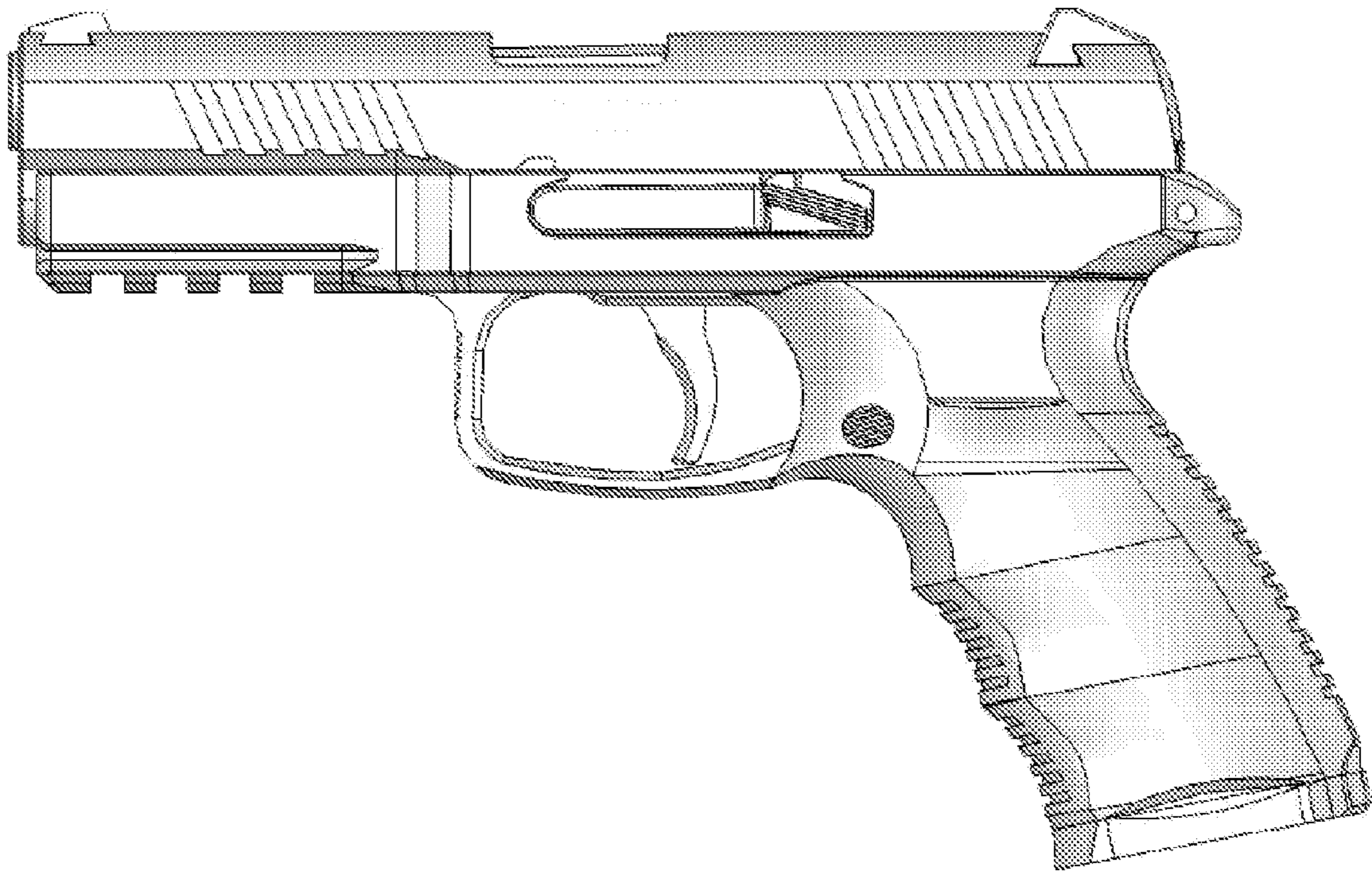

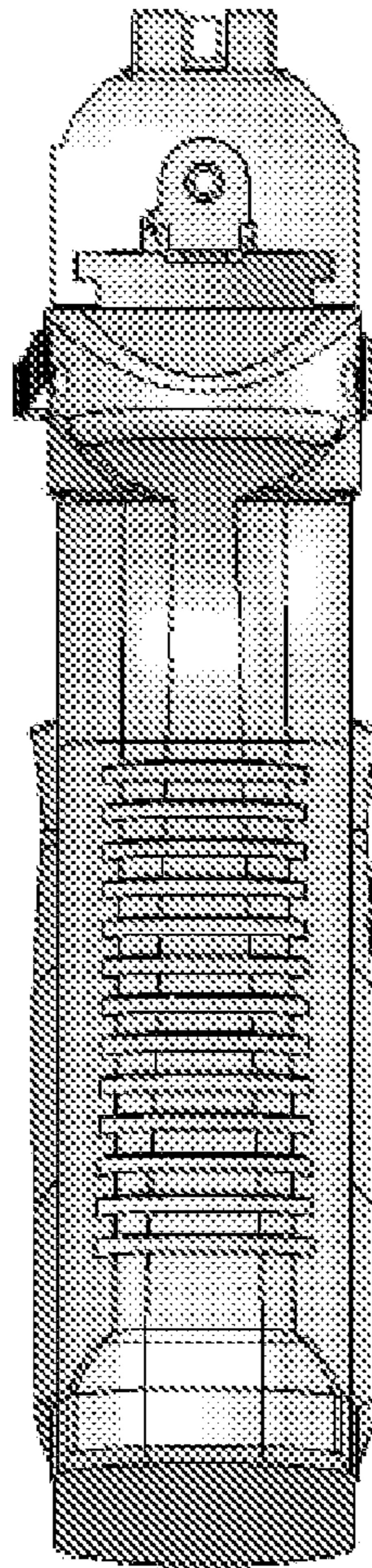

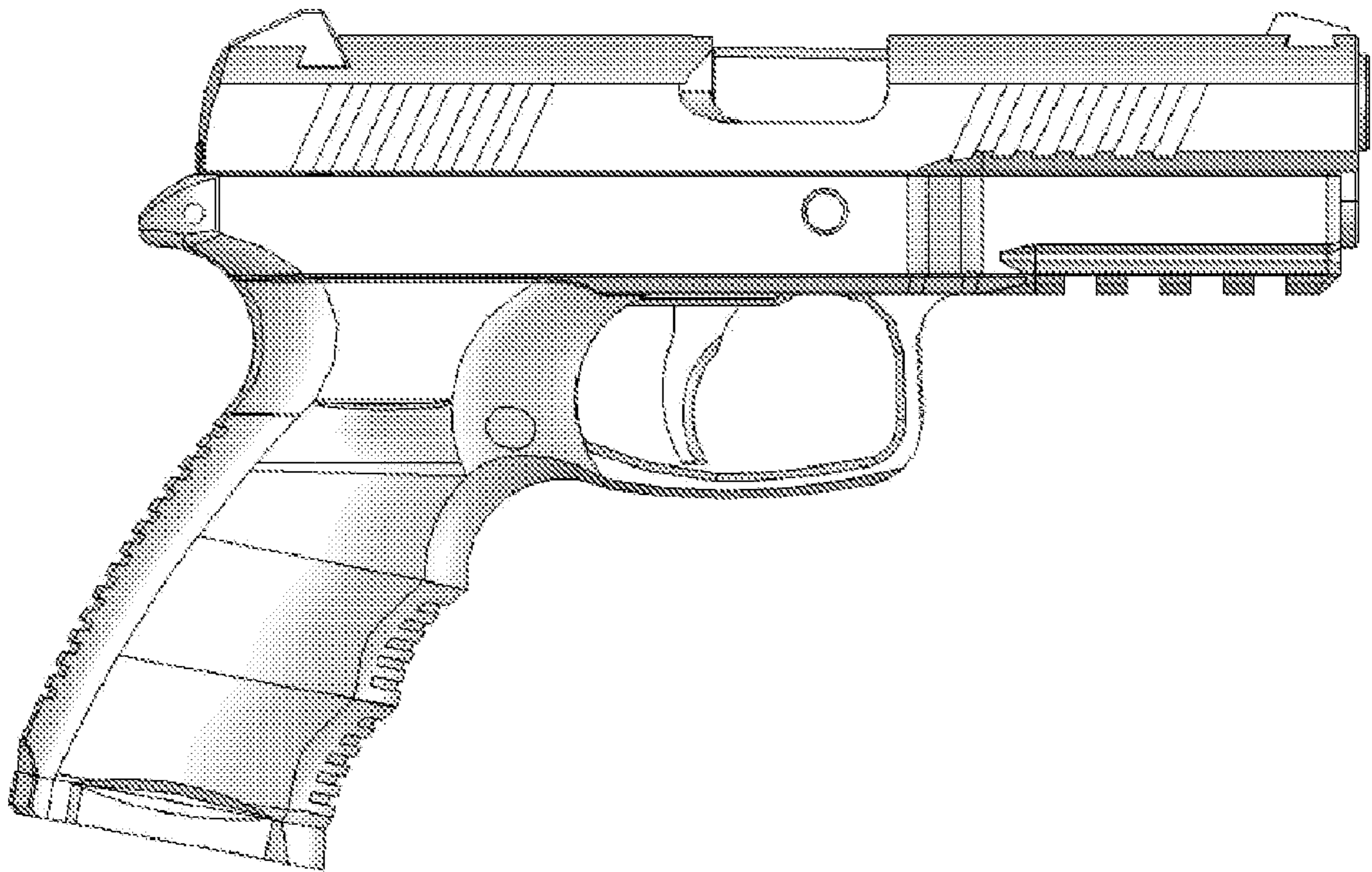

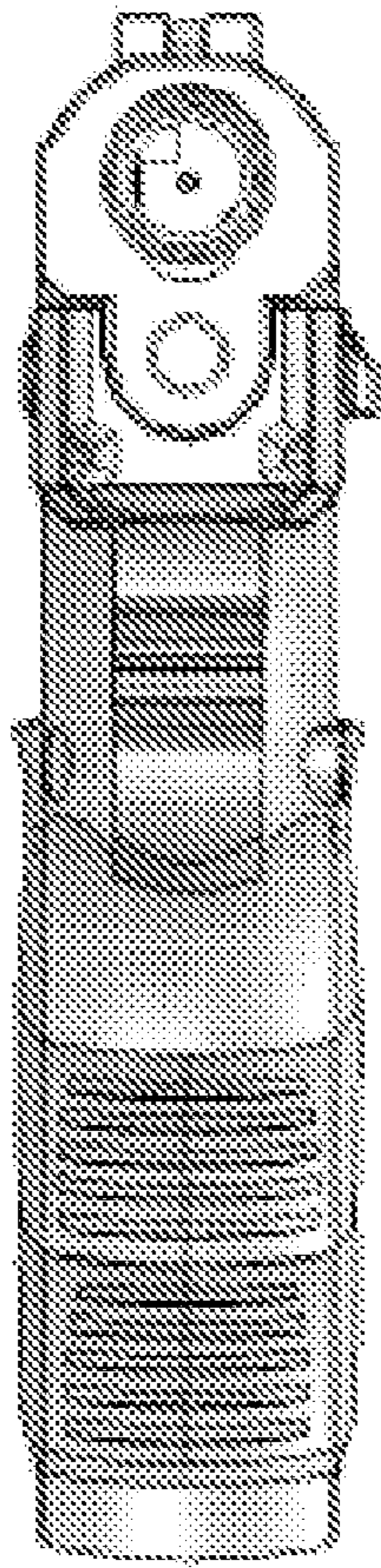
