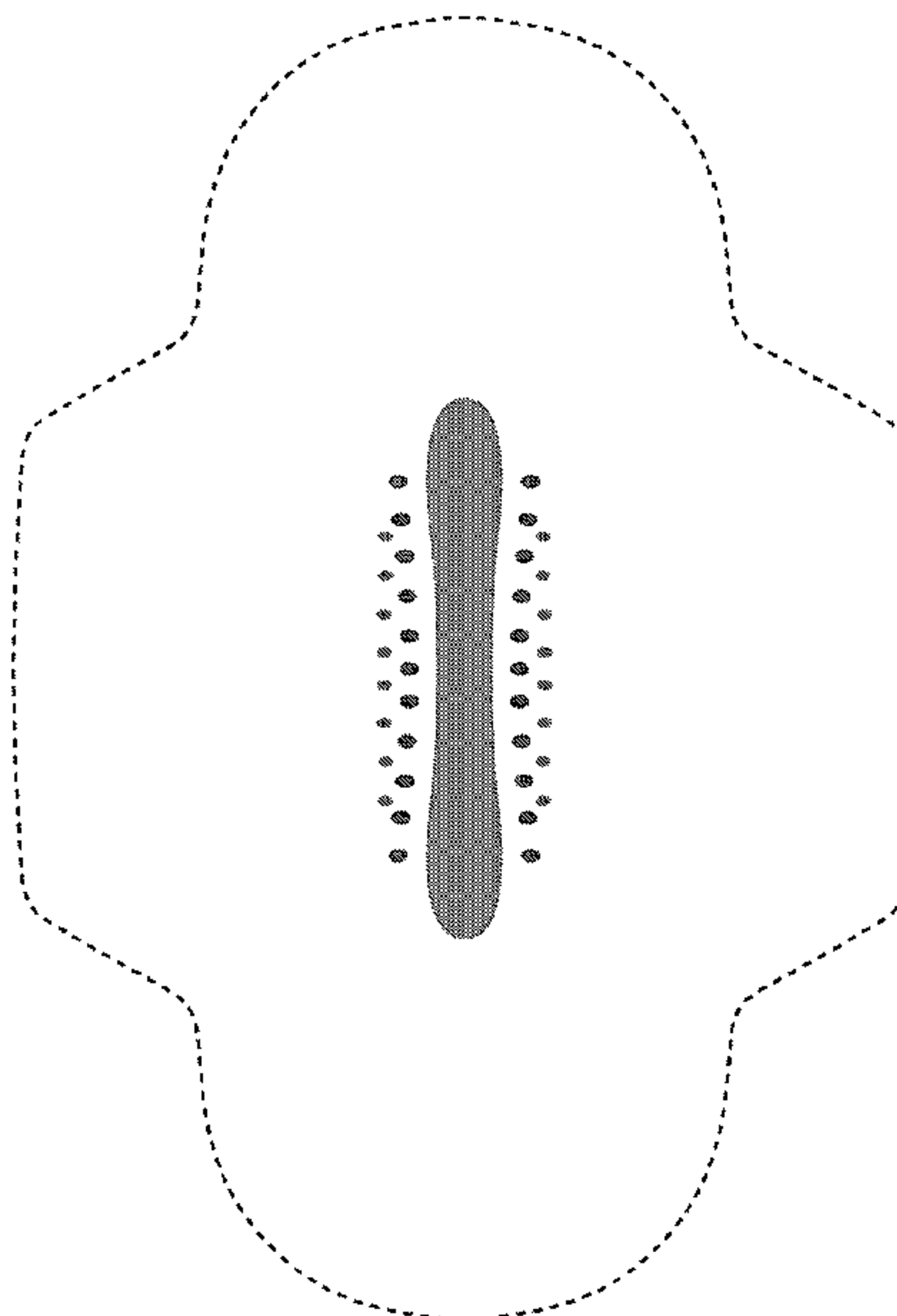
The ornamental design for a sanitary towel, as shown and described.

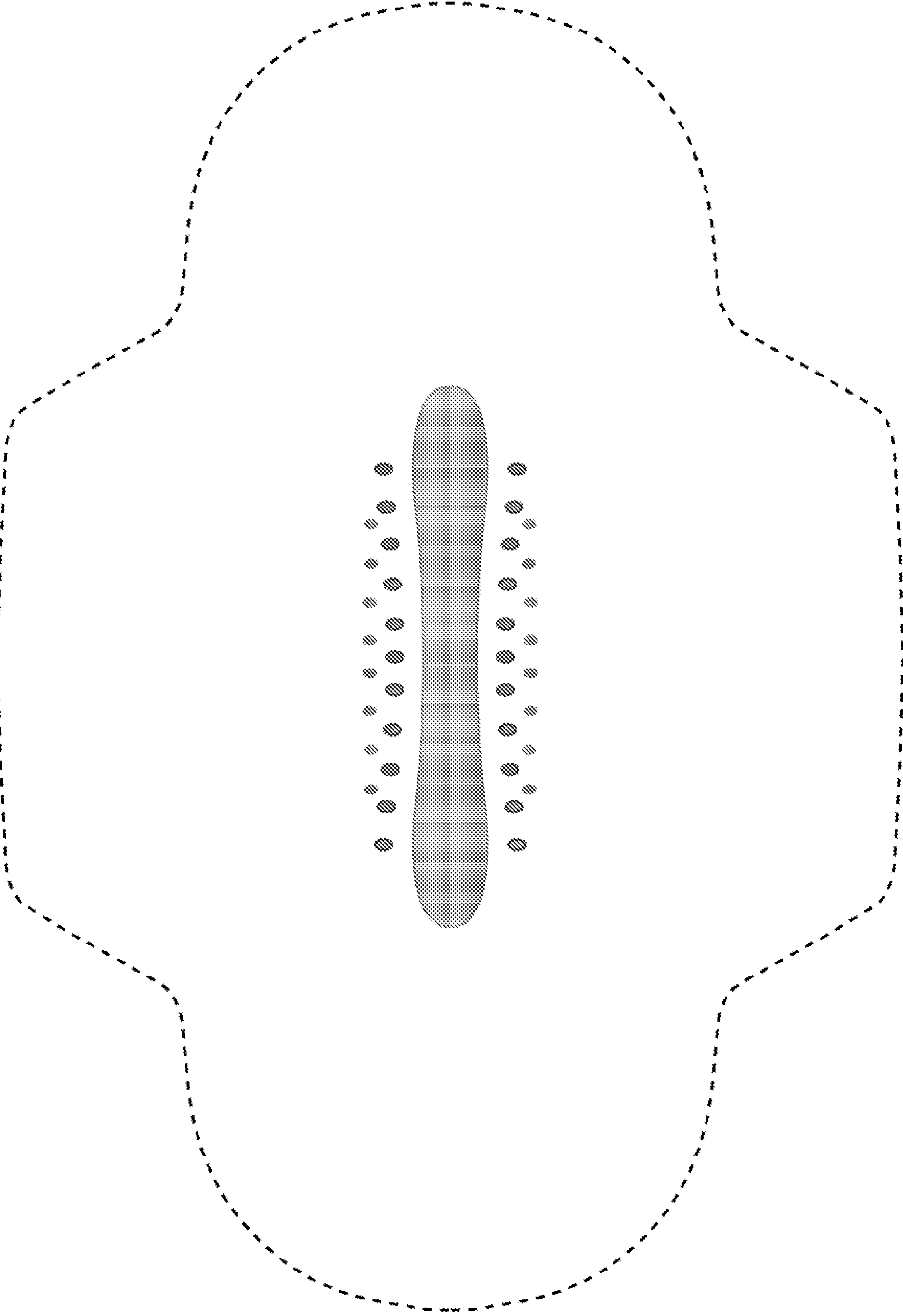
DESCRIPTION


