The ornamental design for a plastic media filled blast/ballistic mobility wall, as shown and described.

**DESCRIPTION**

FIG. 31 is a rear elevation view thereof;

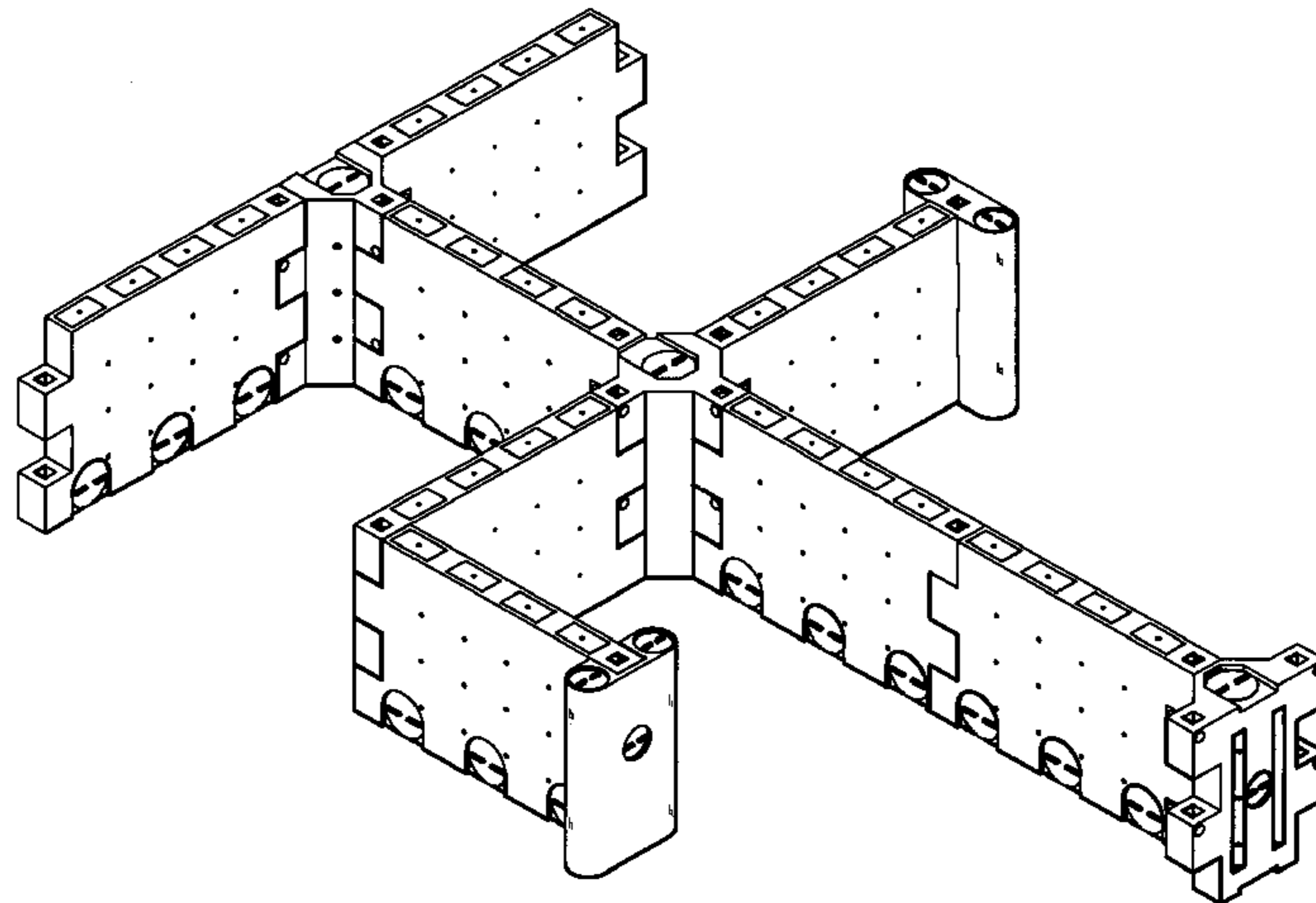
FIG. 32 is a left elevation view thereof;

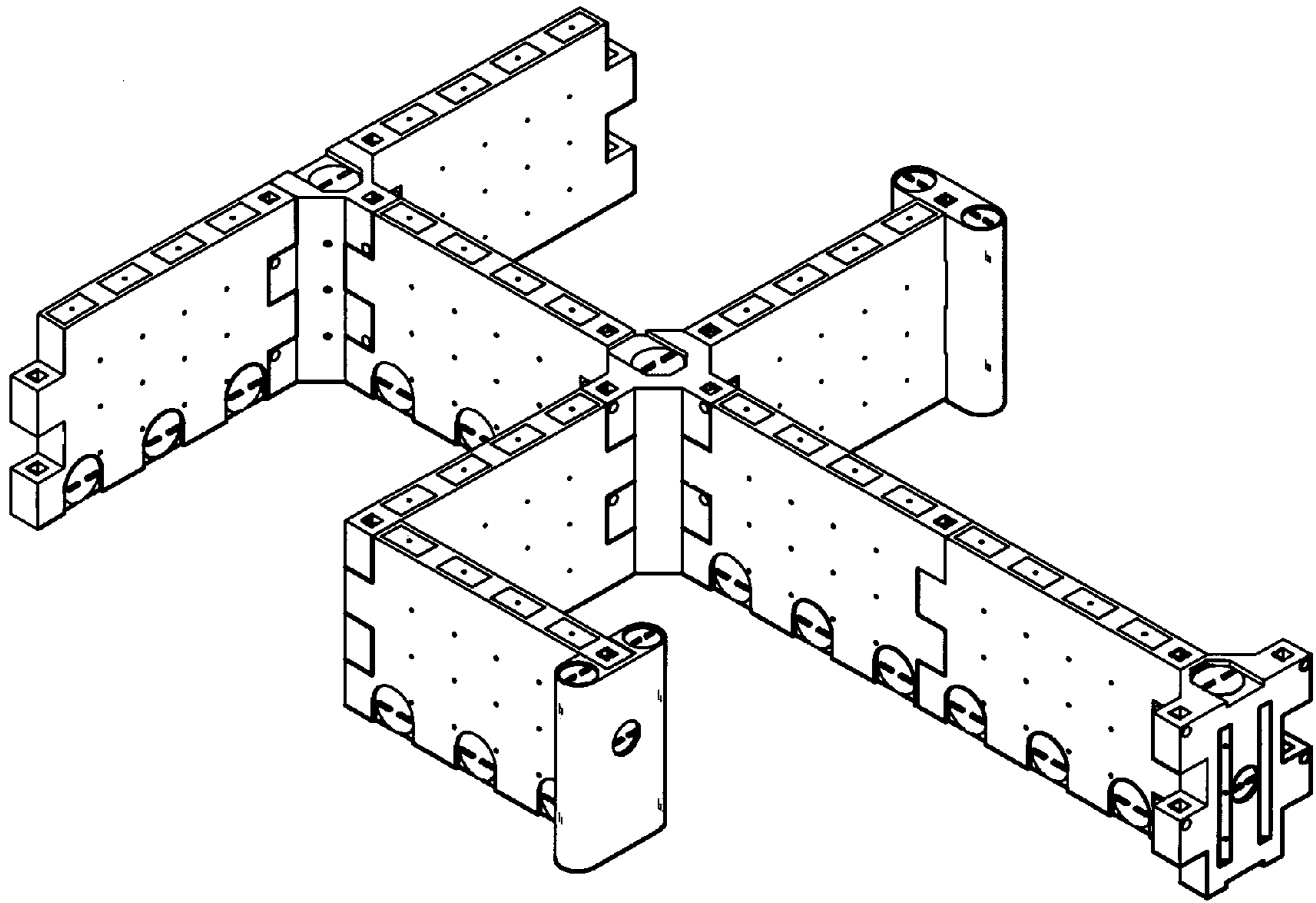

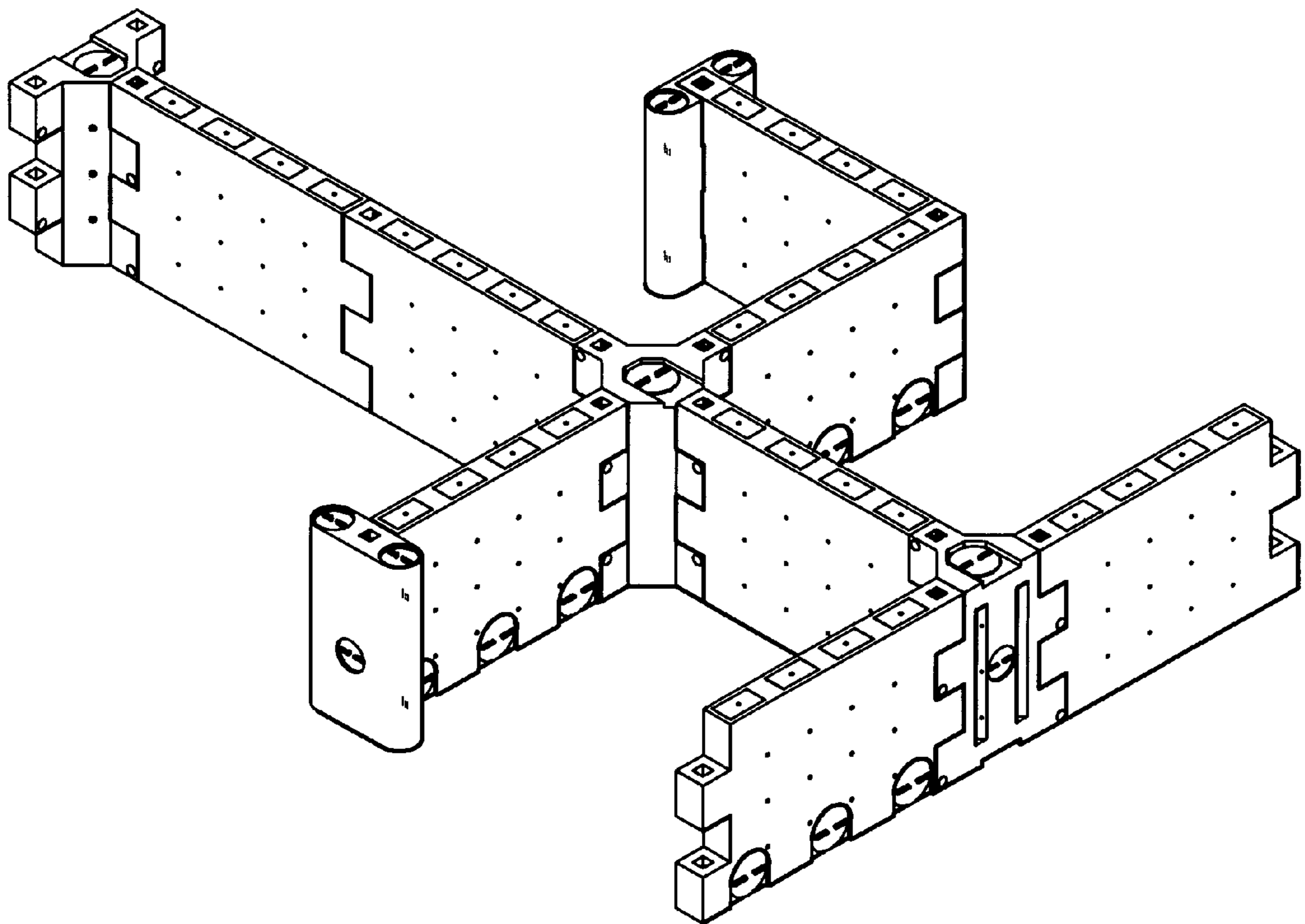

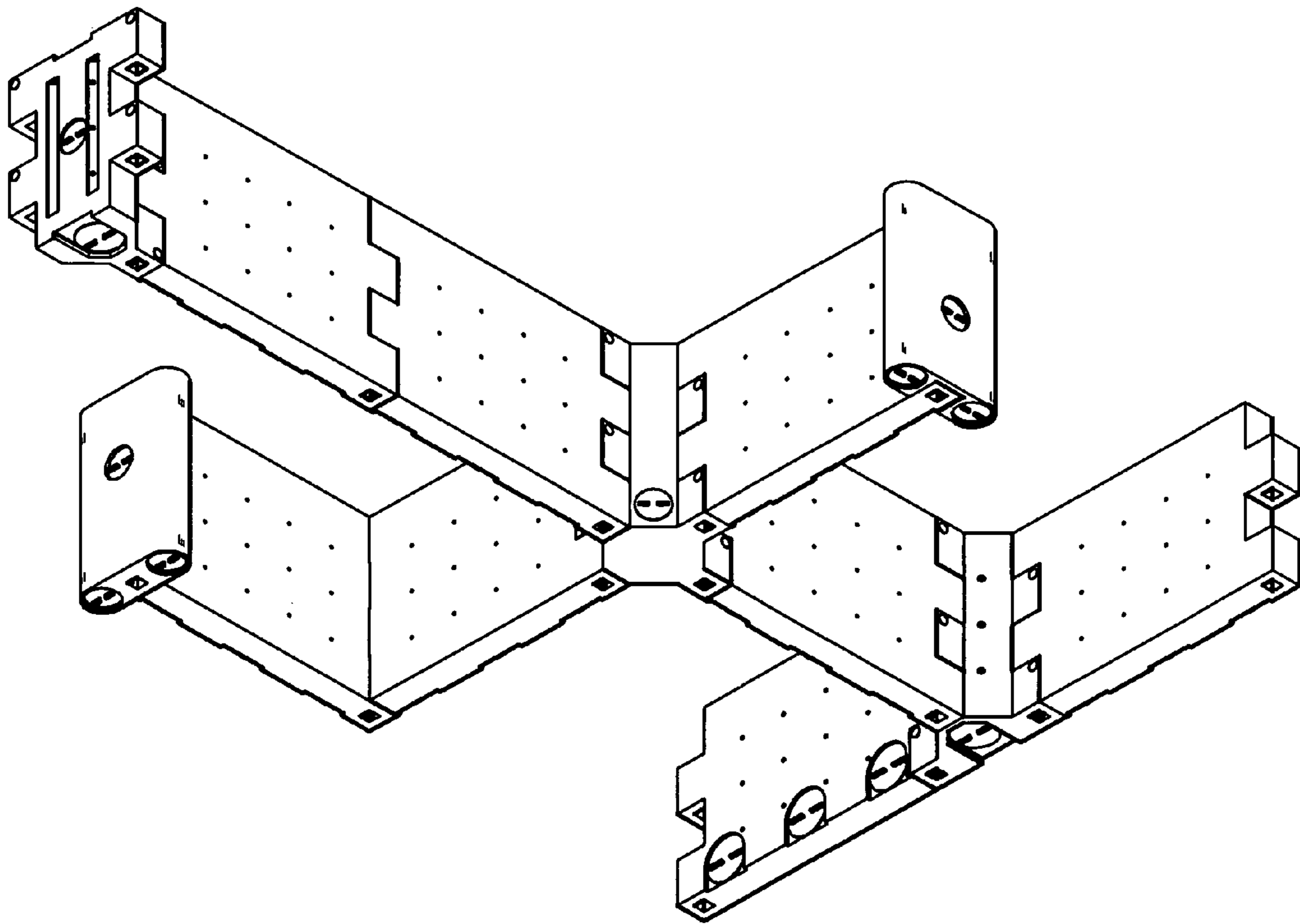

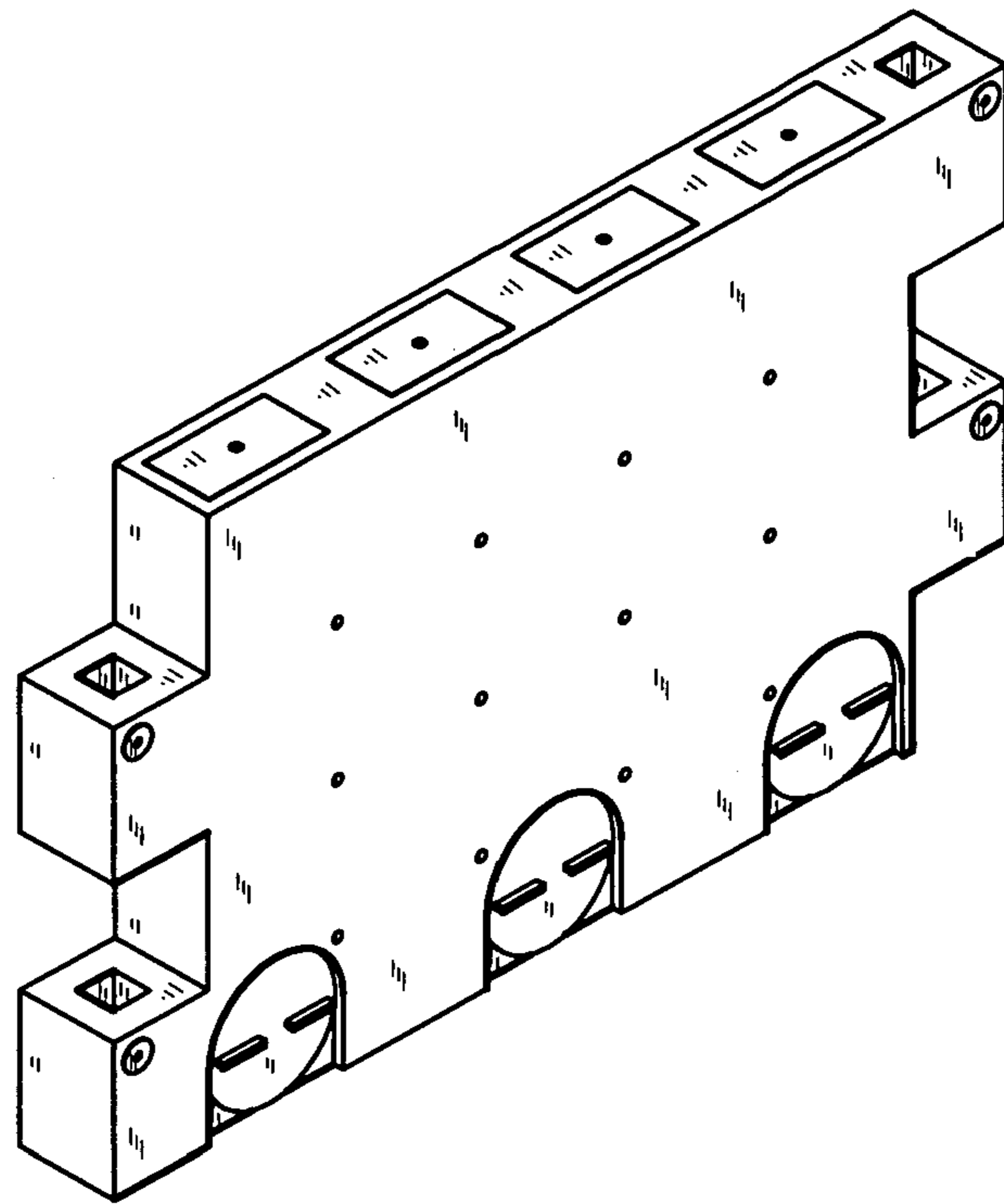

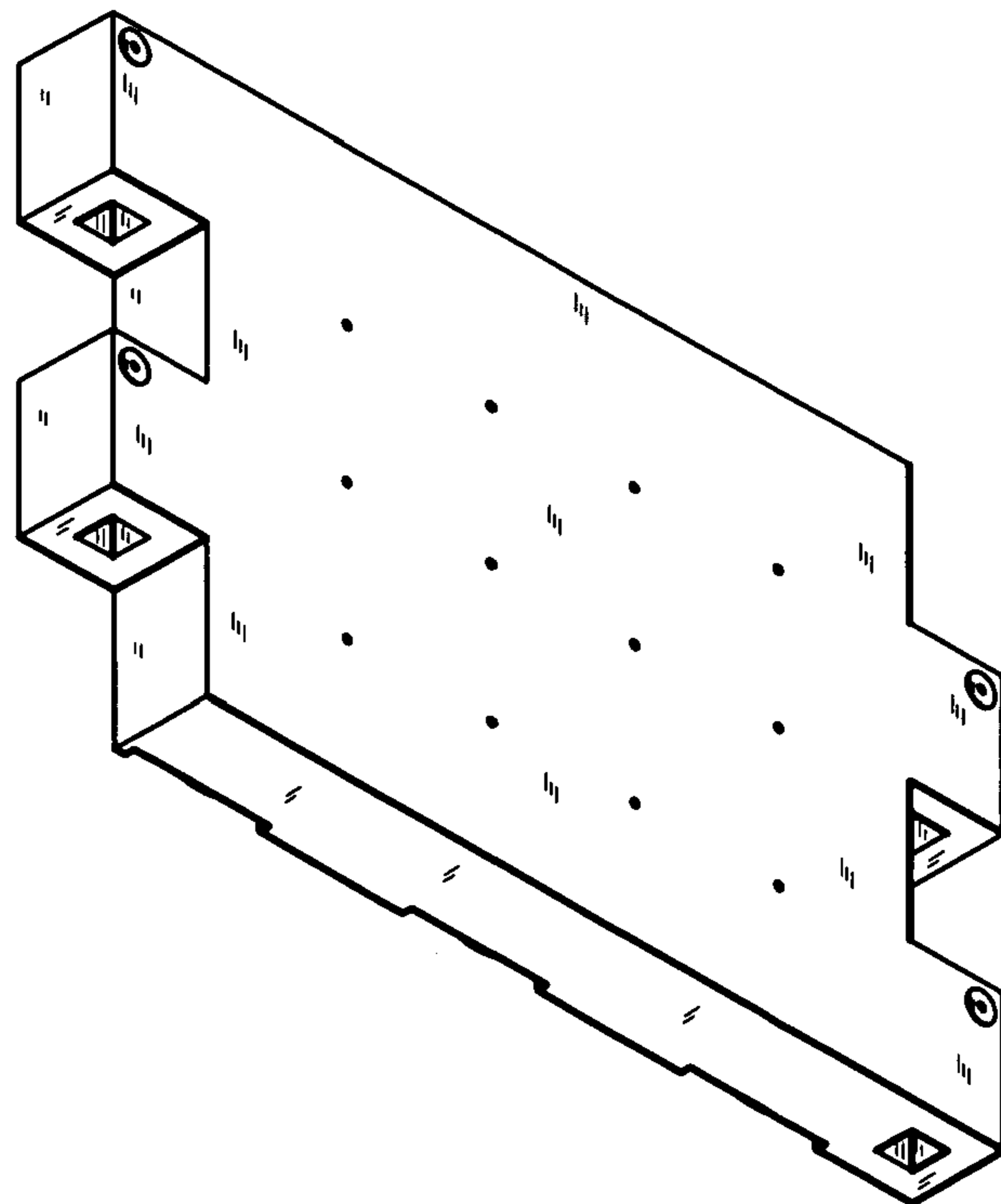

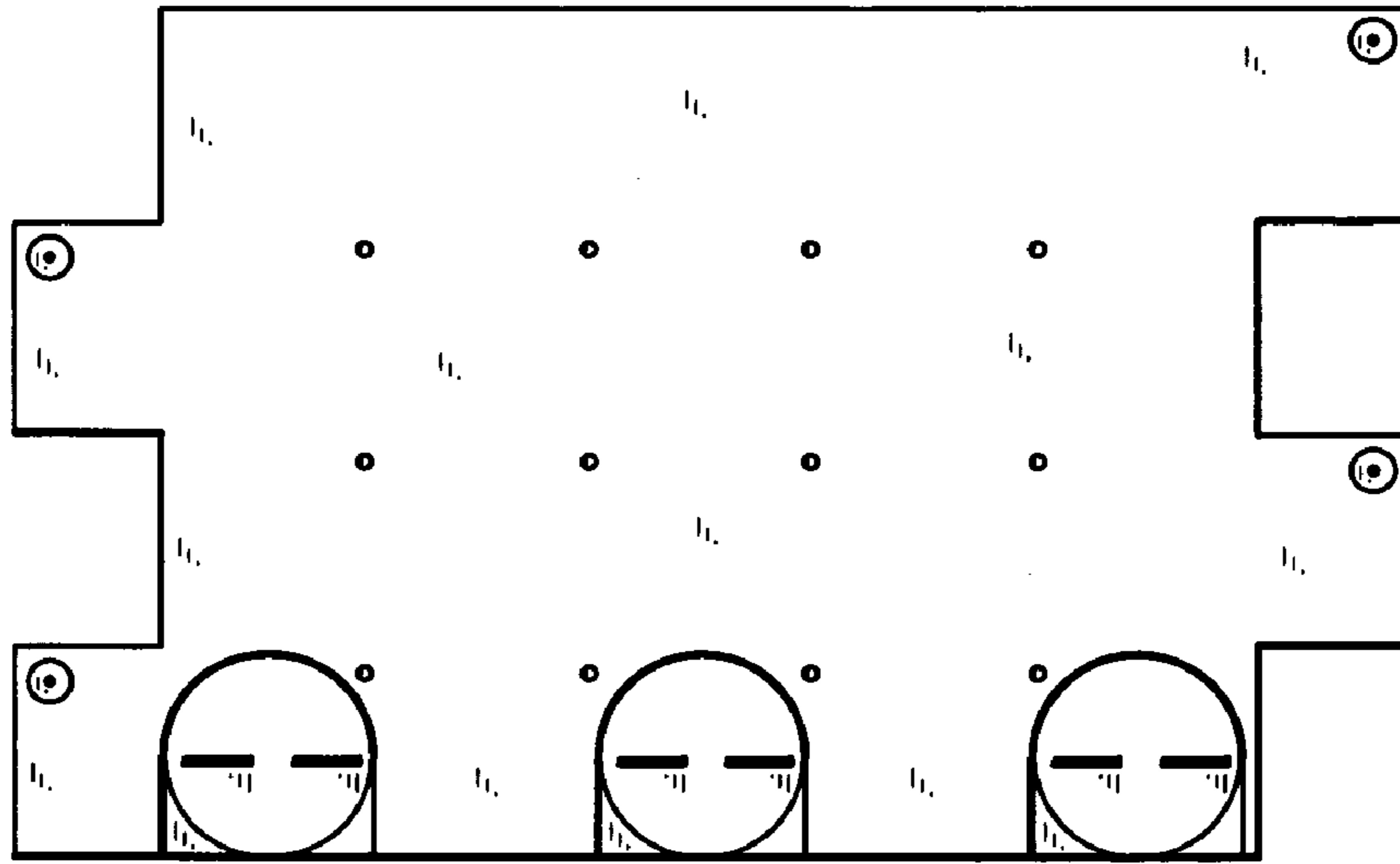

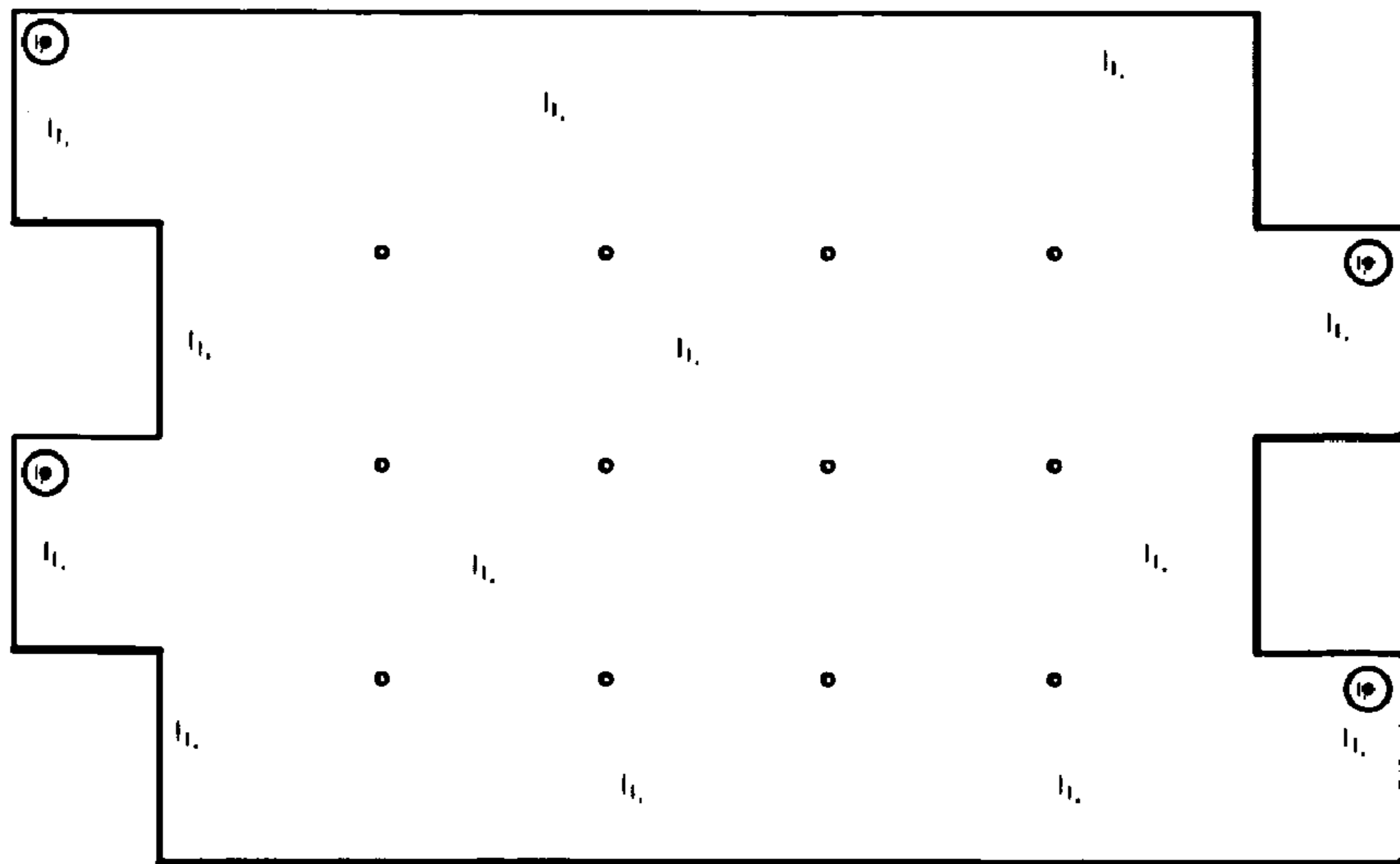

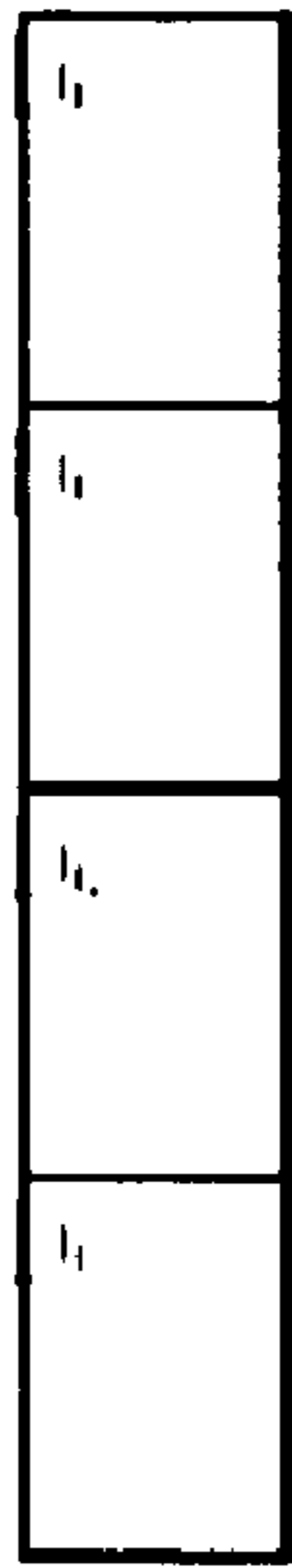

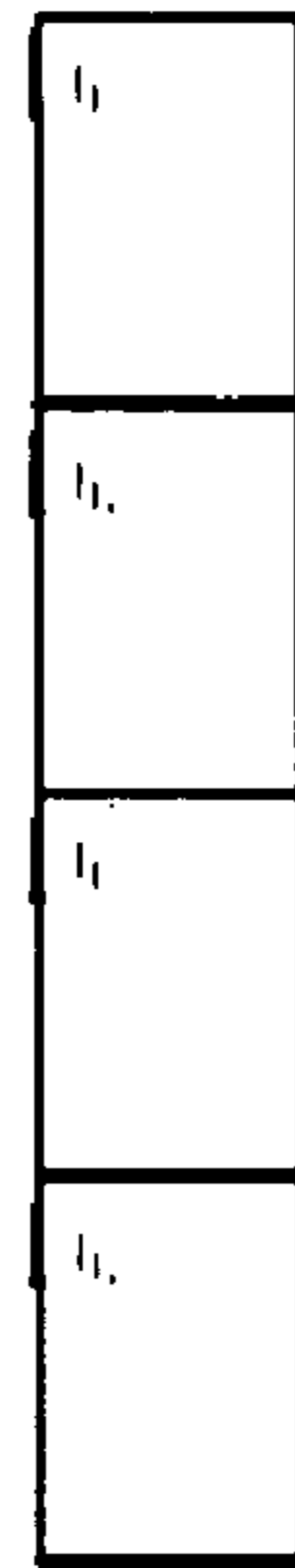

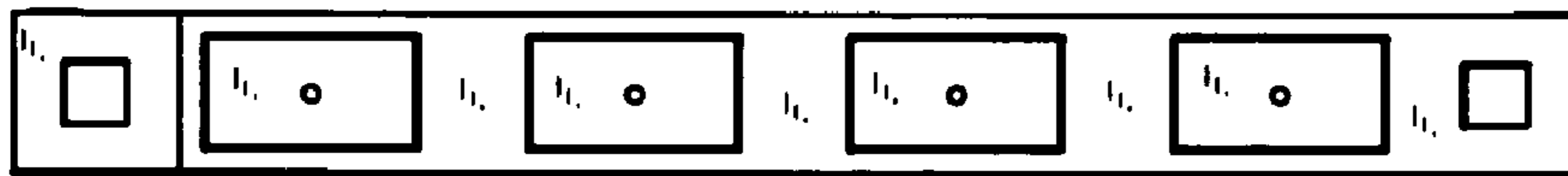

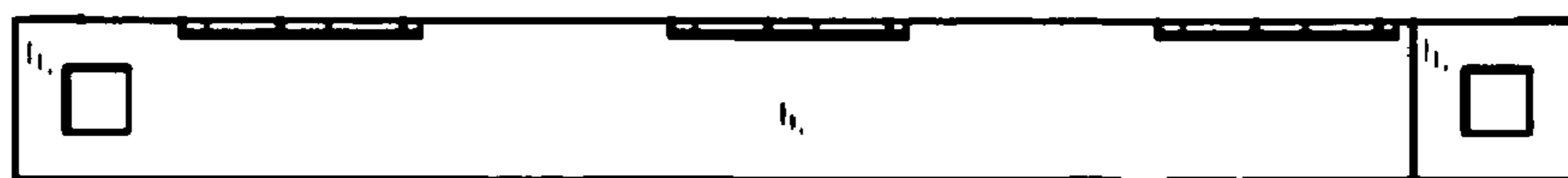

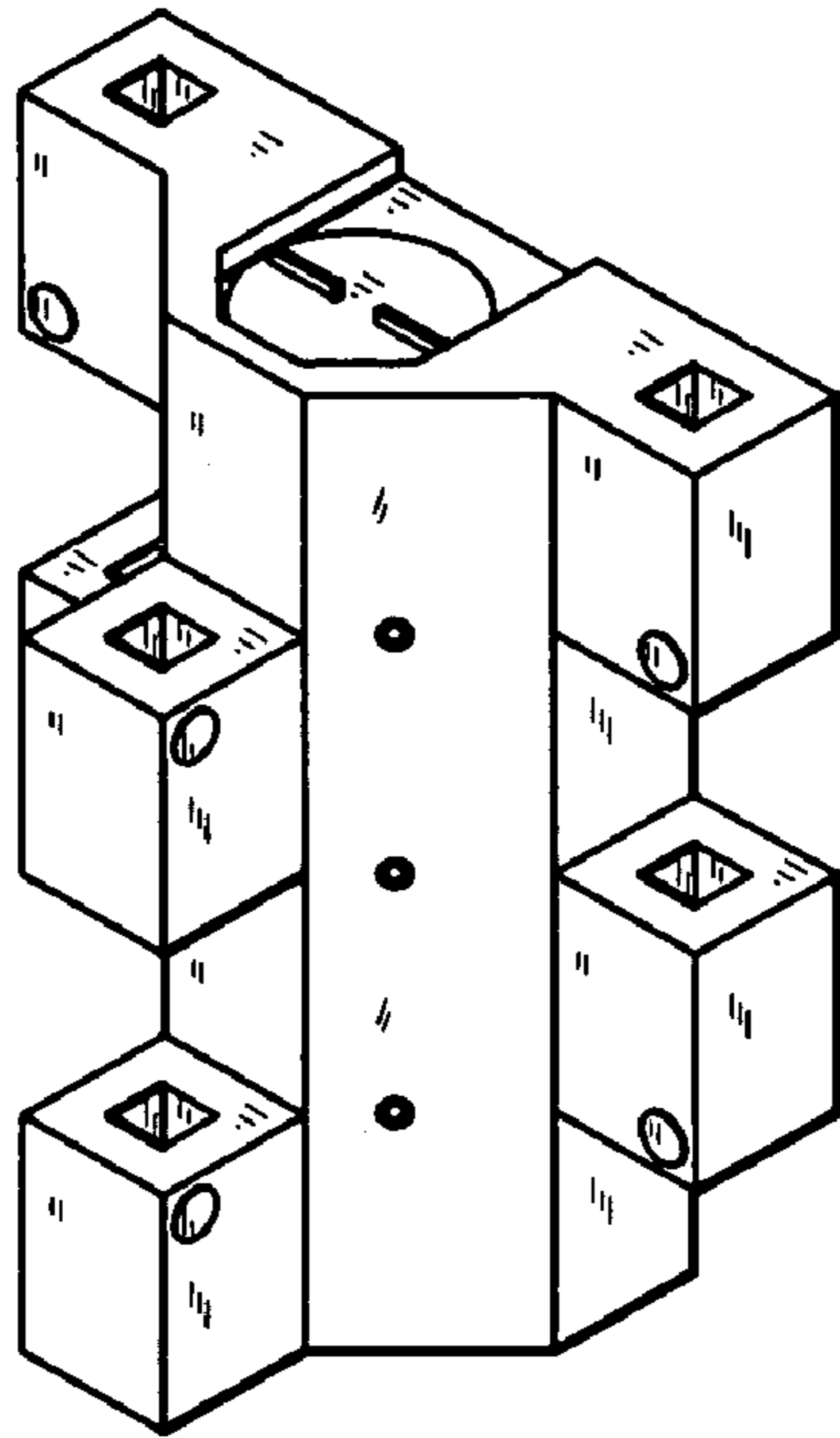

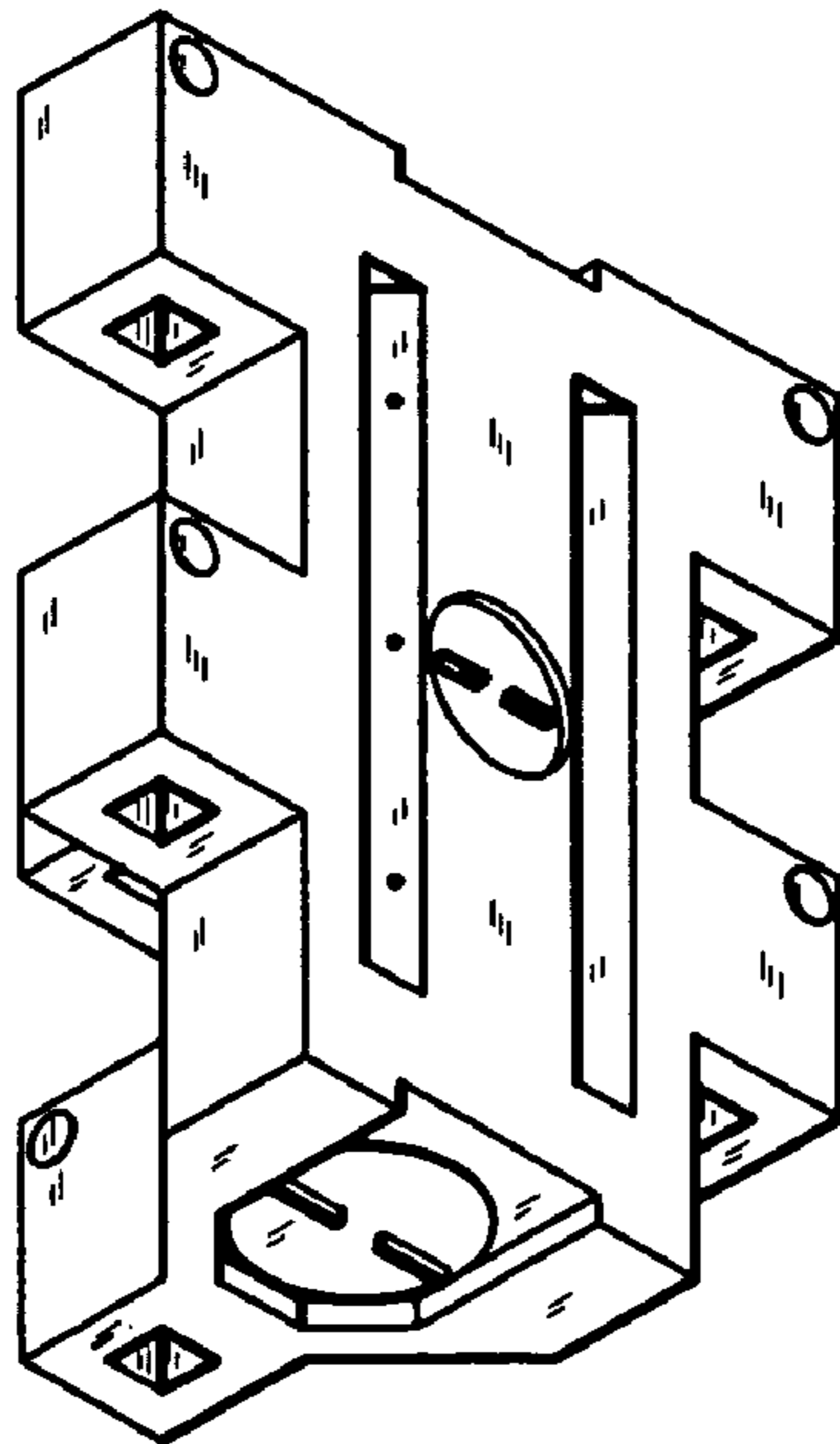

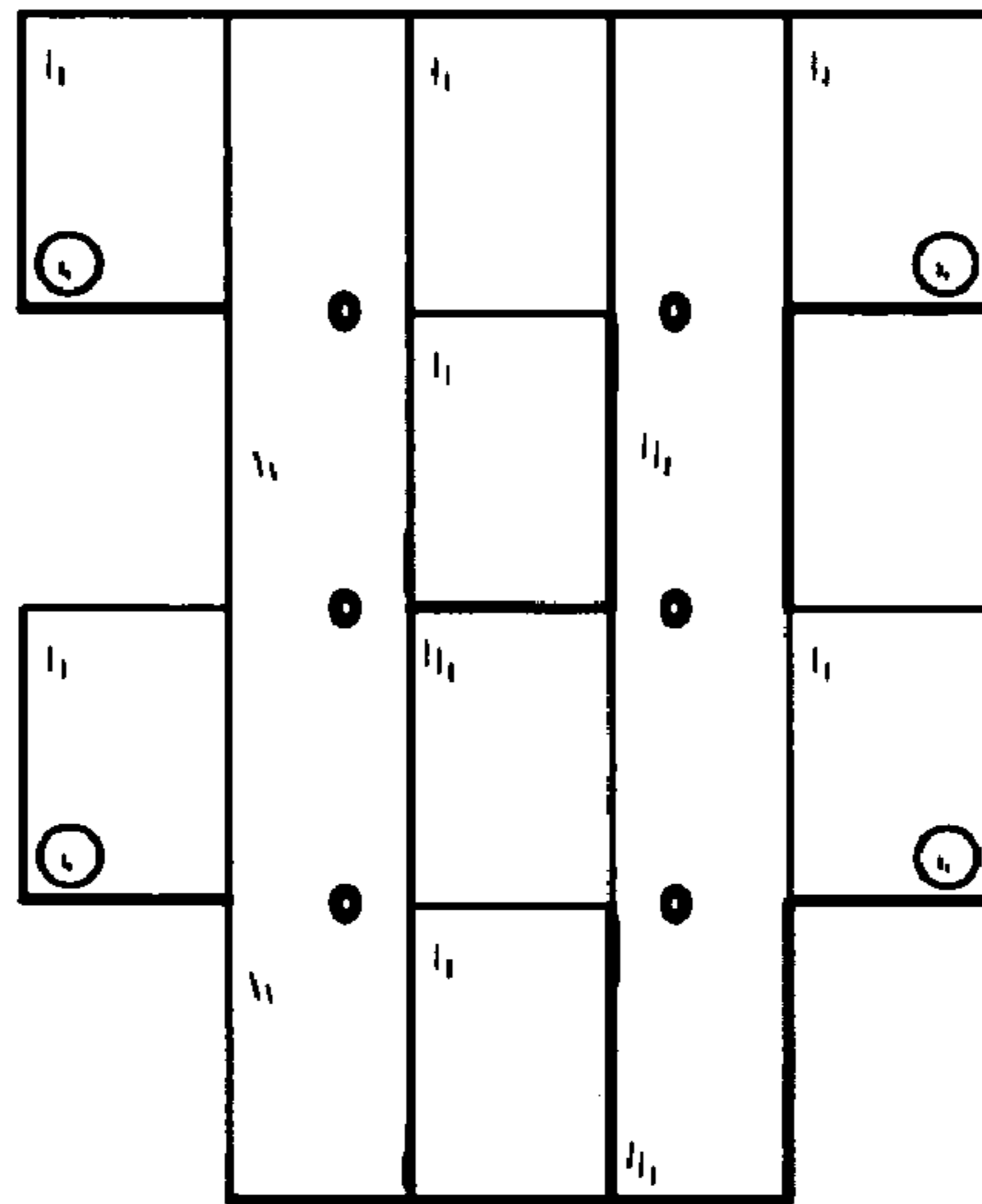

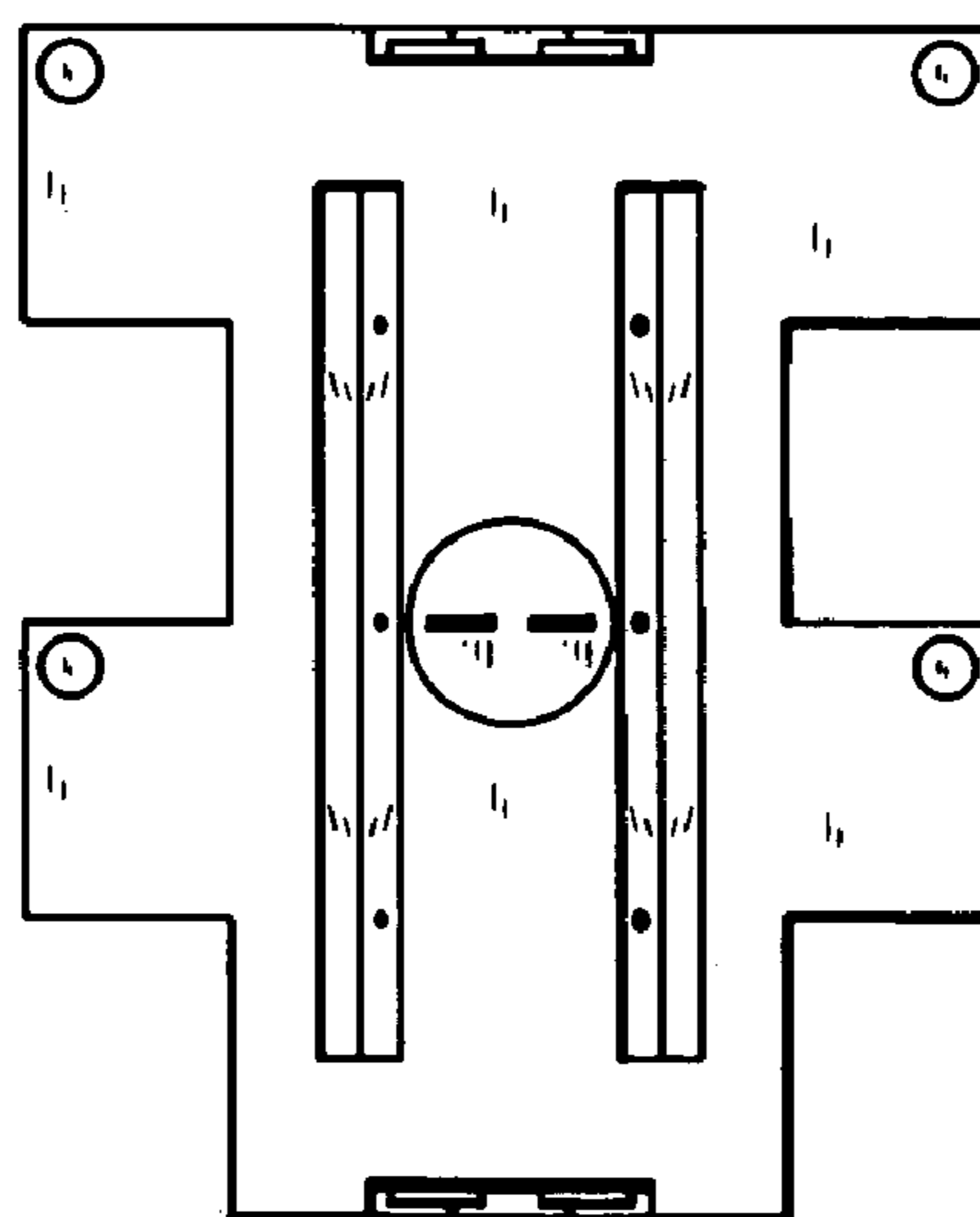

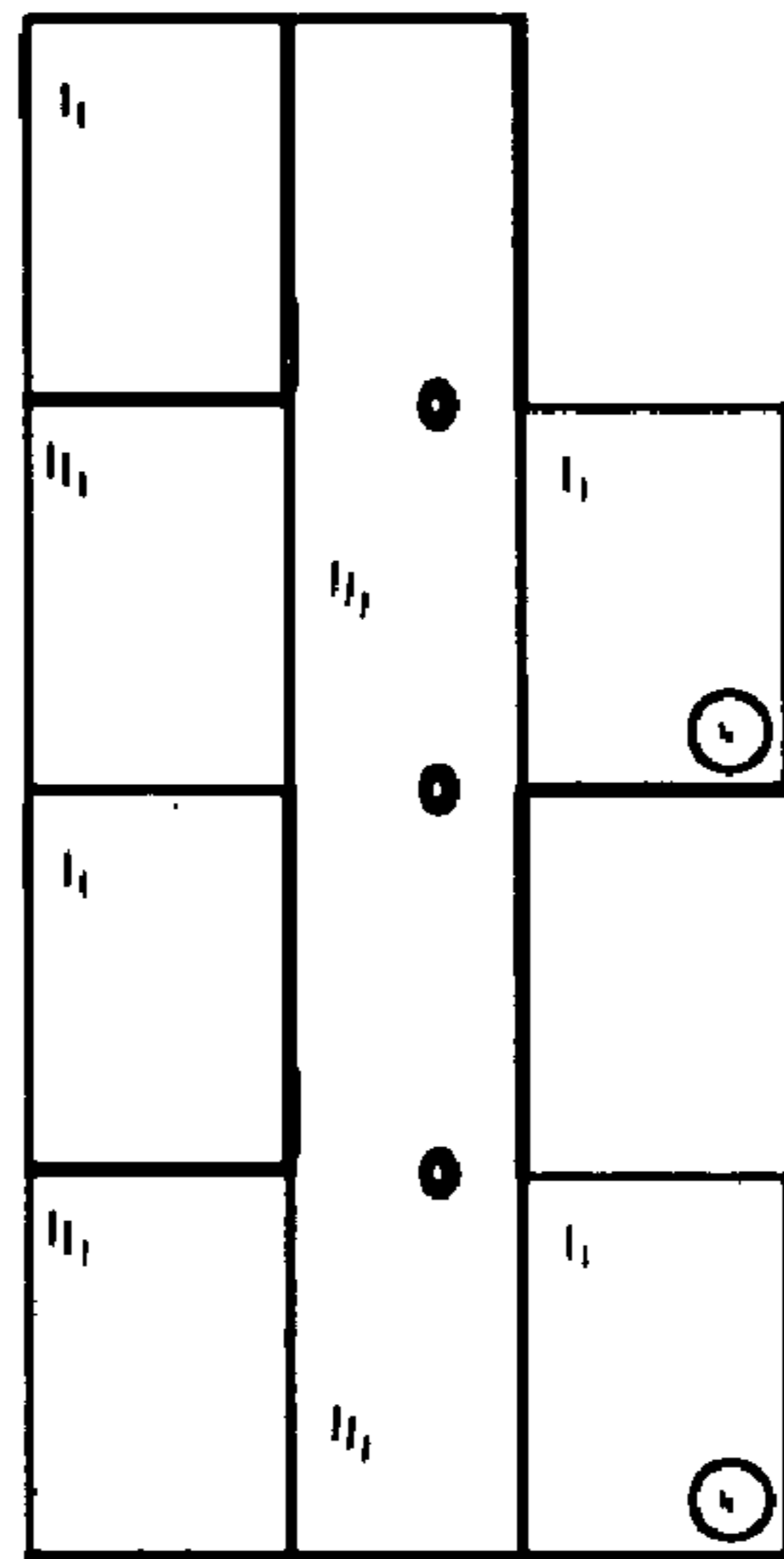

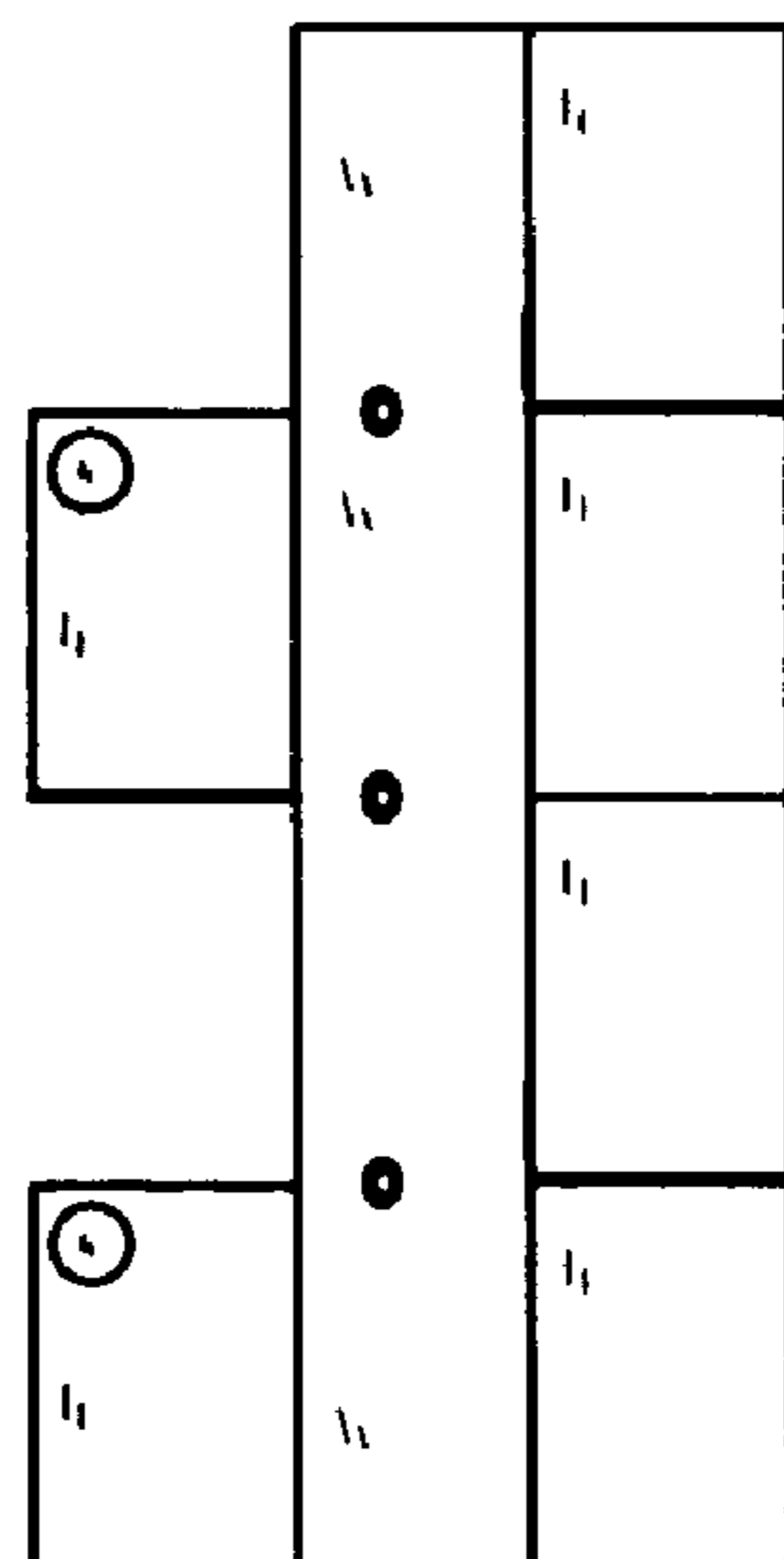

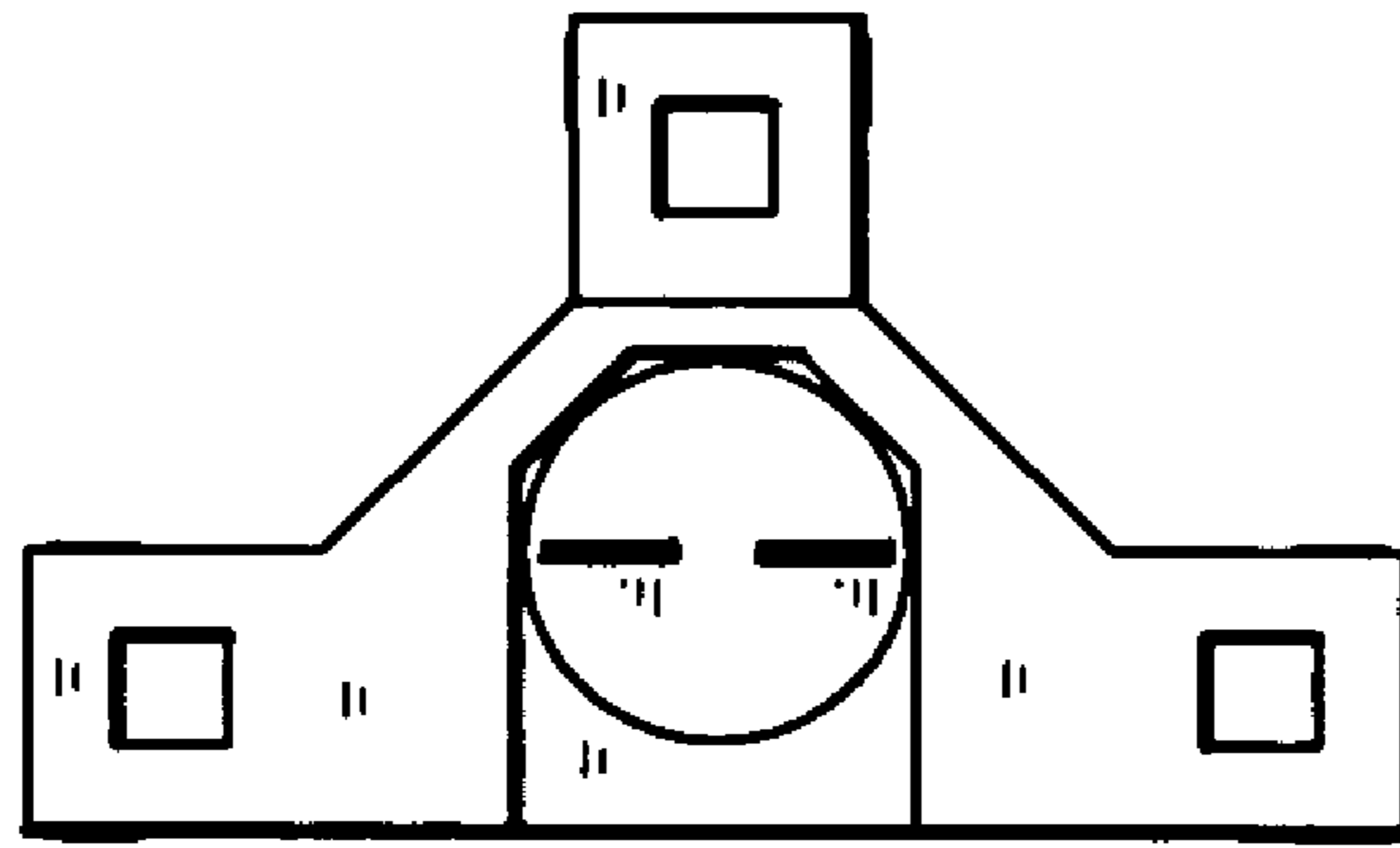

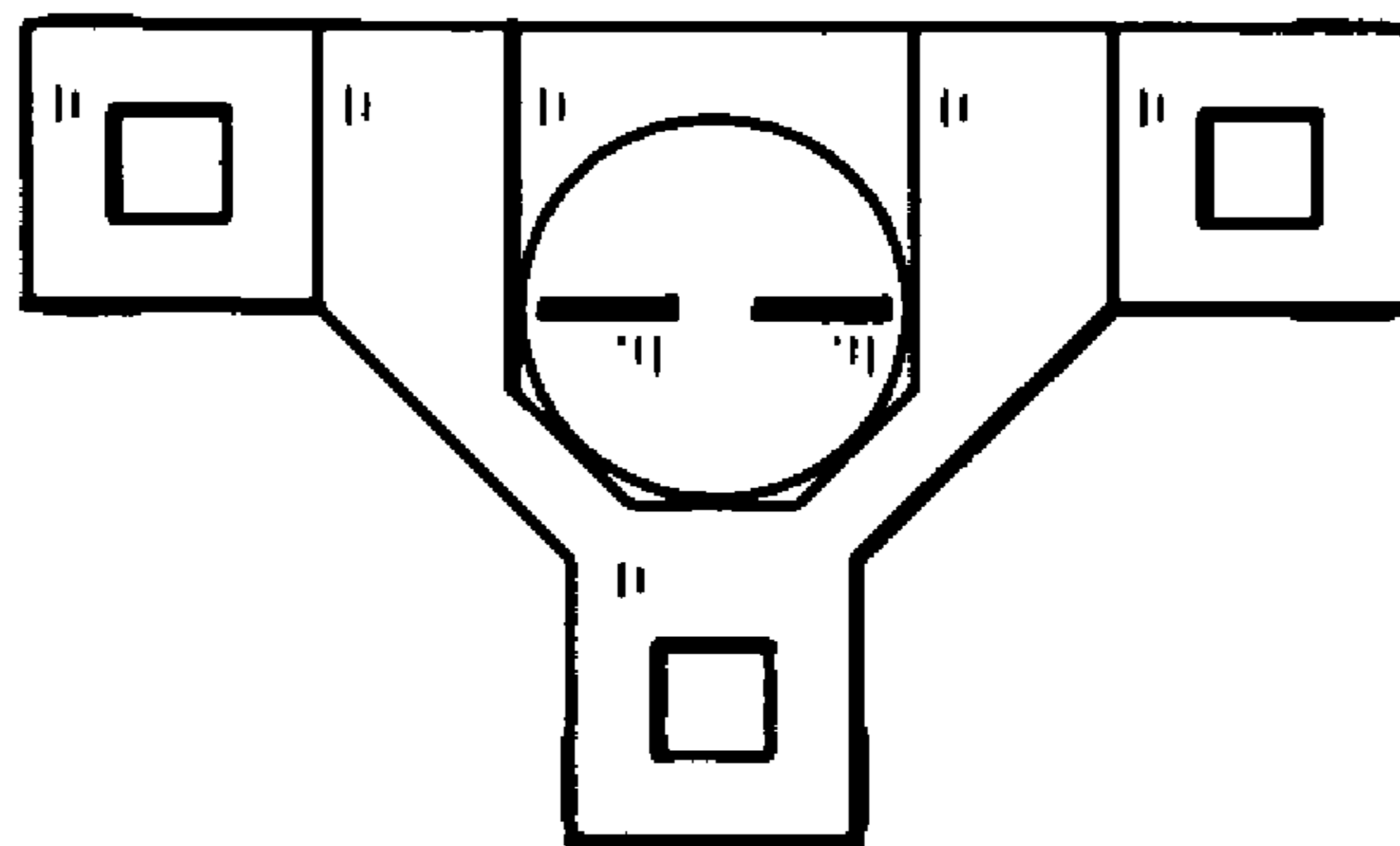

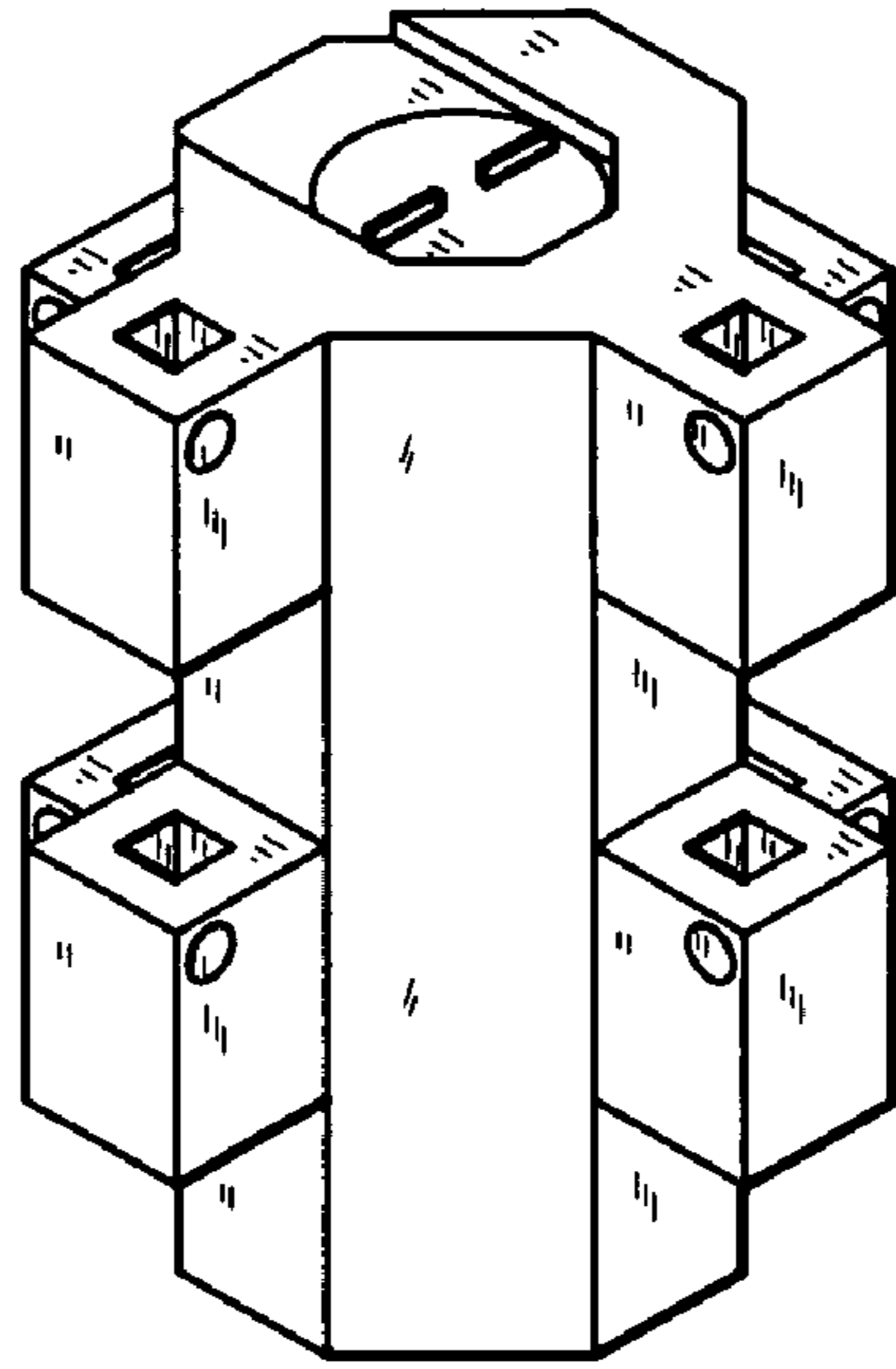

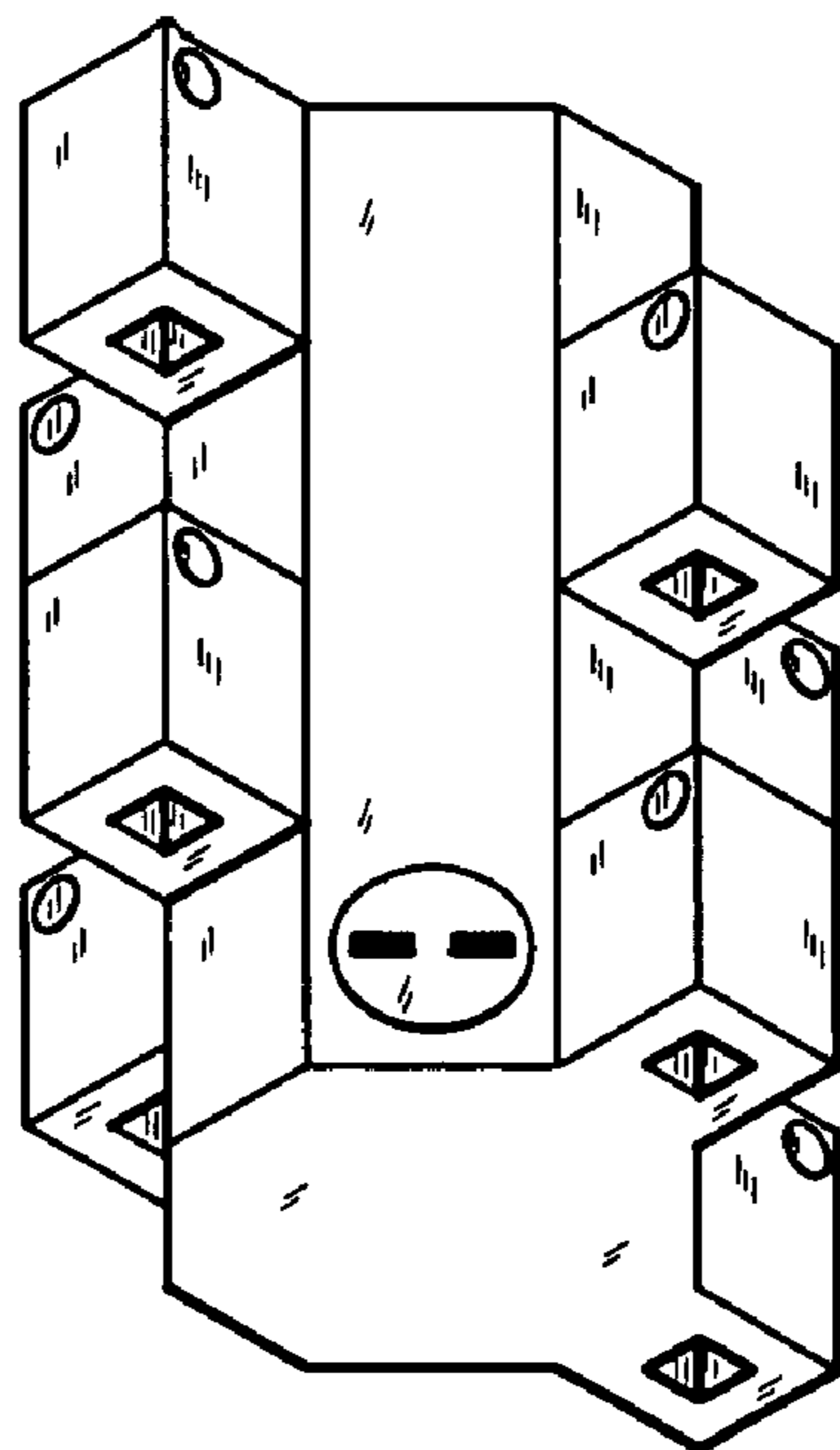

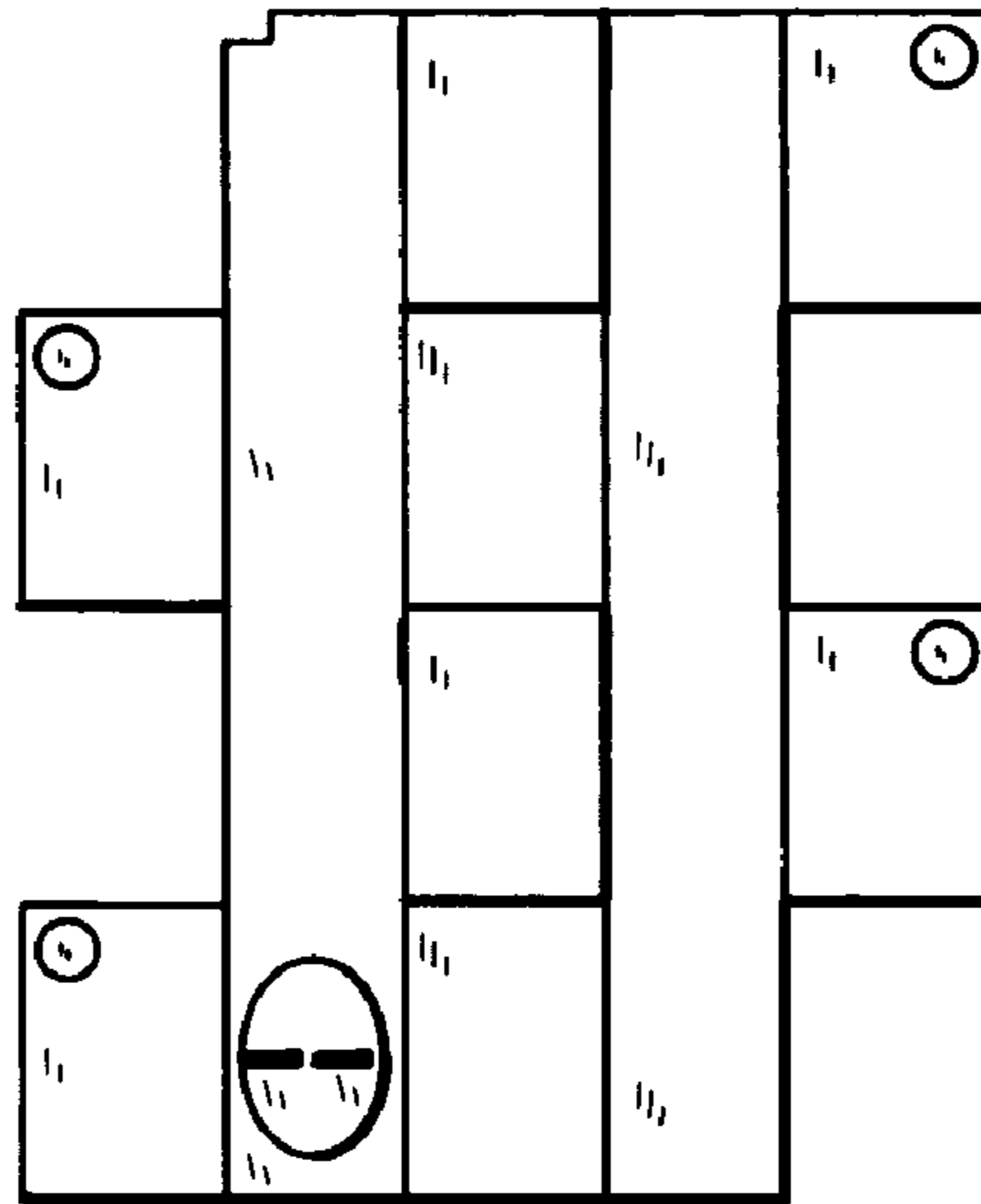

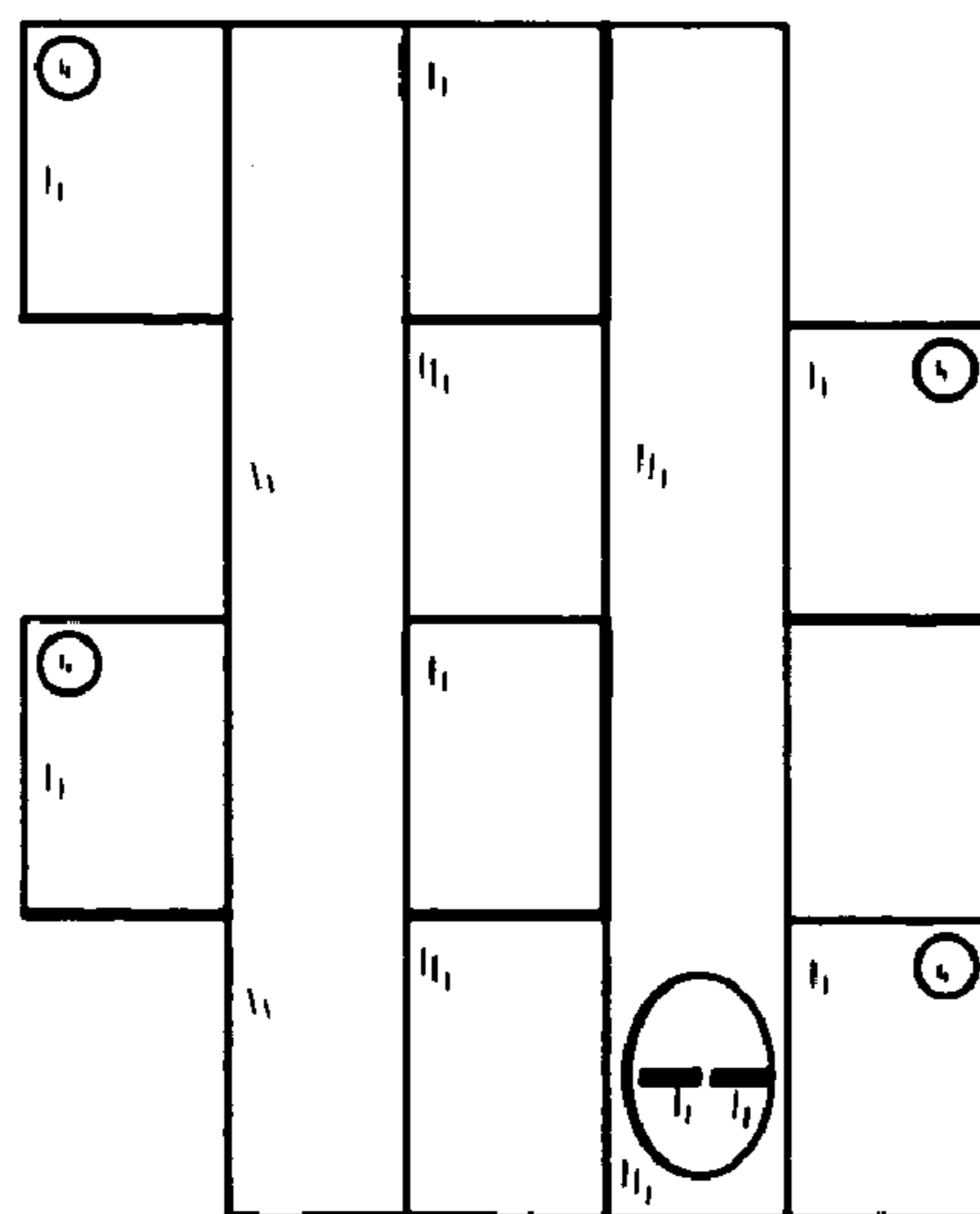

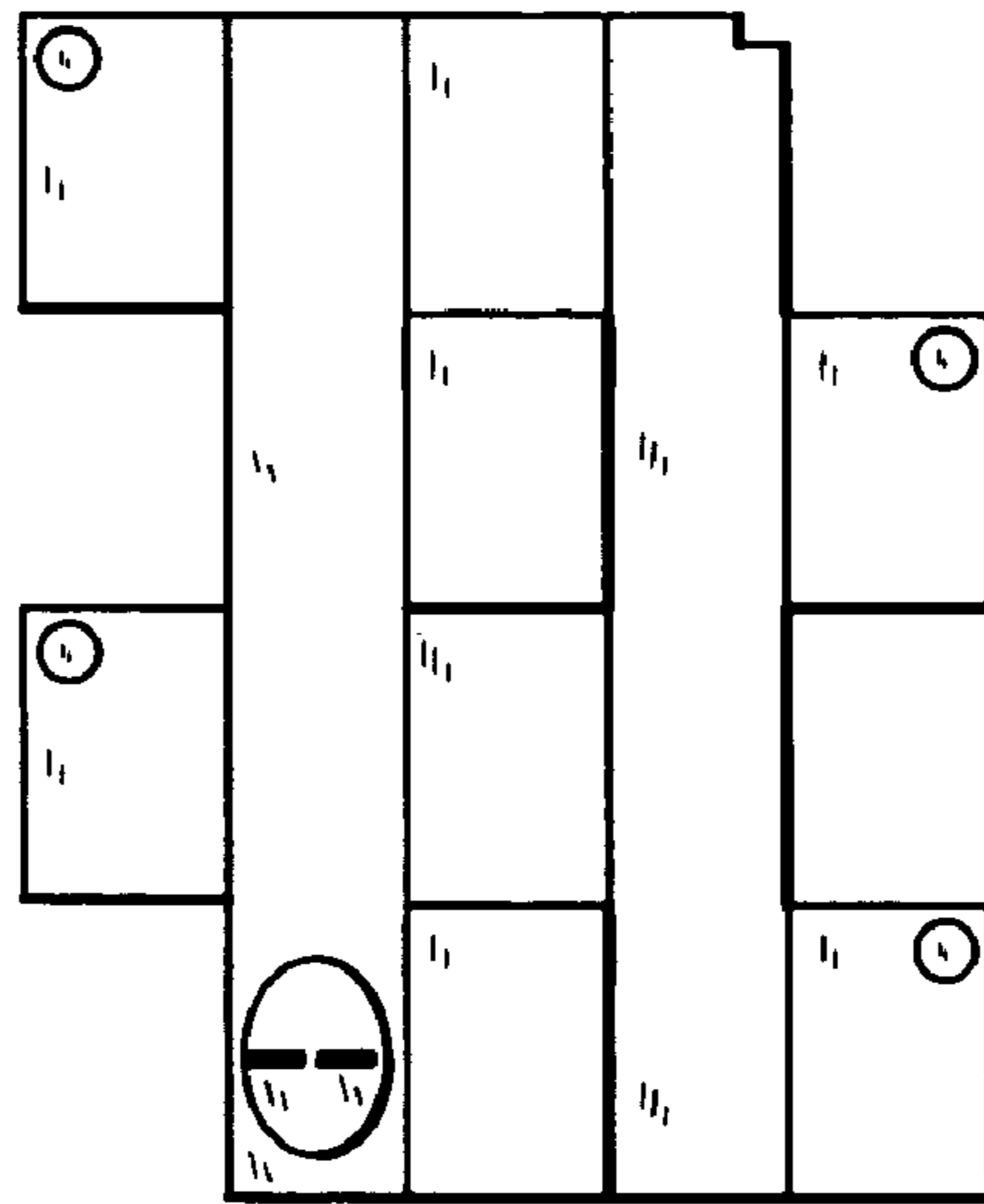

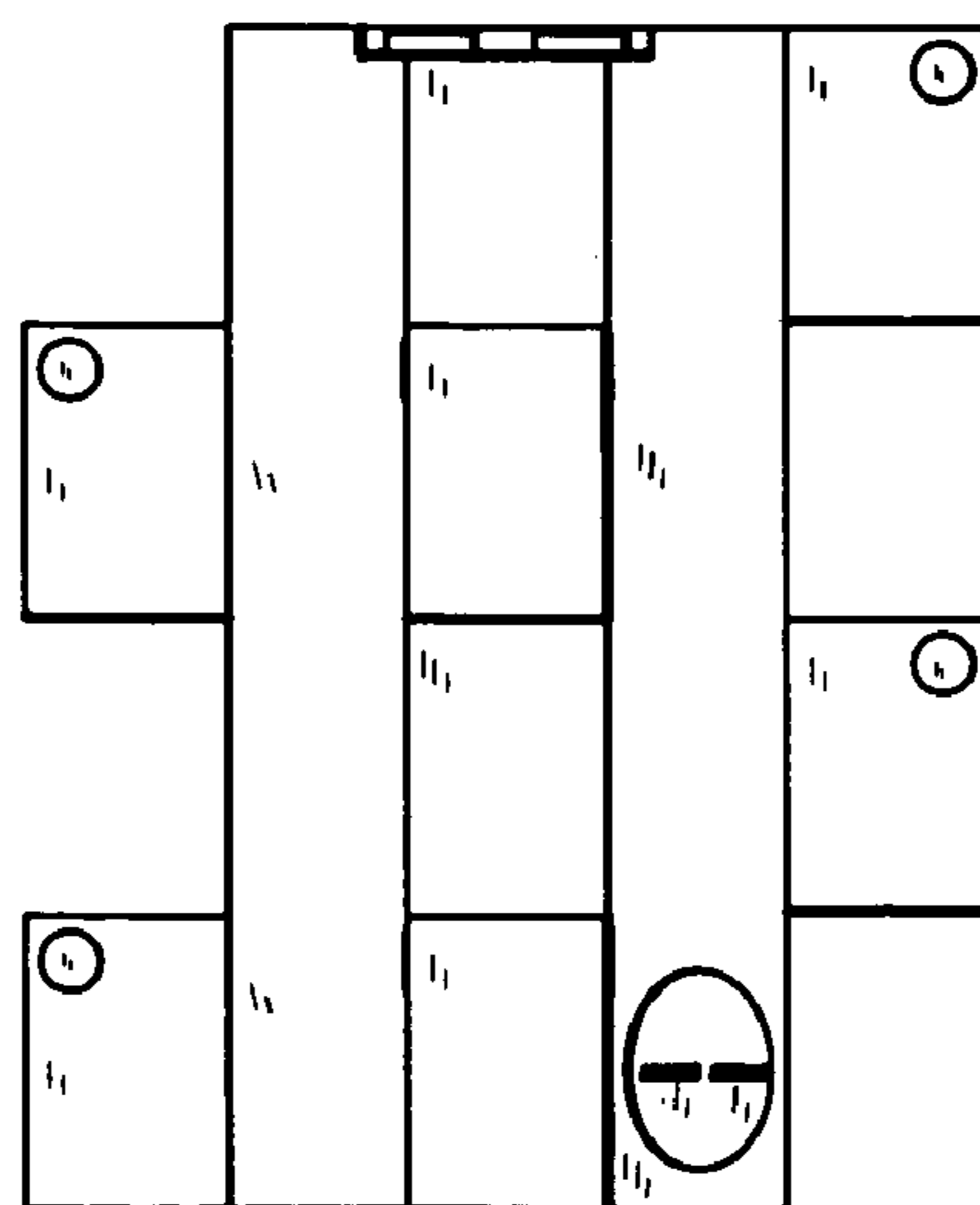

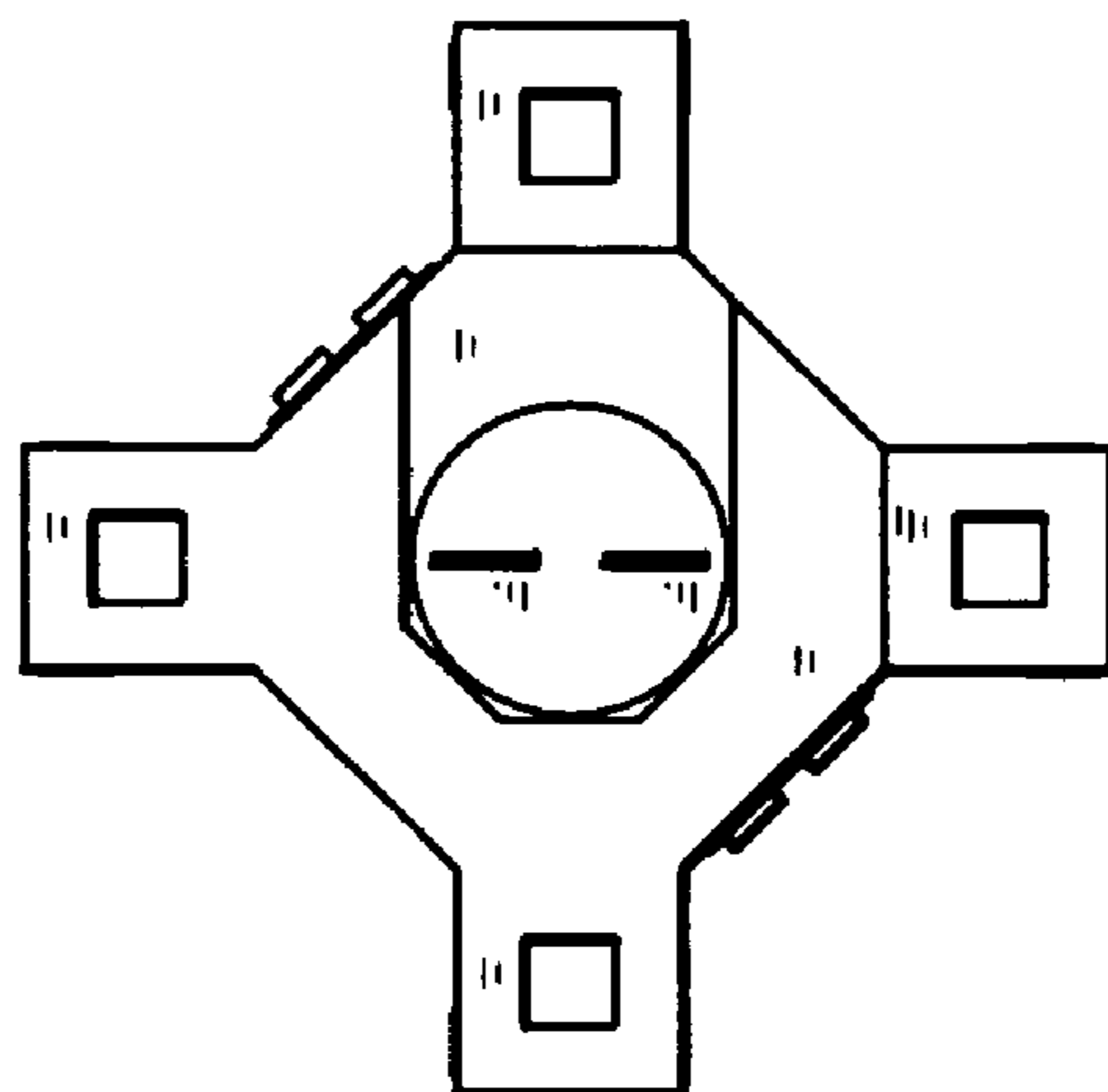

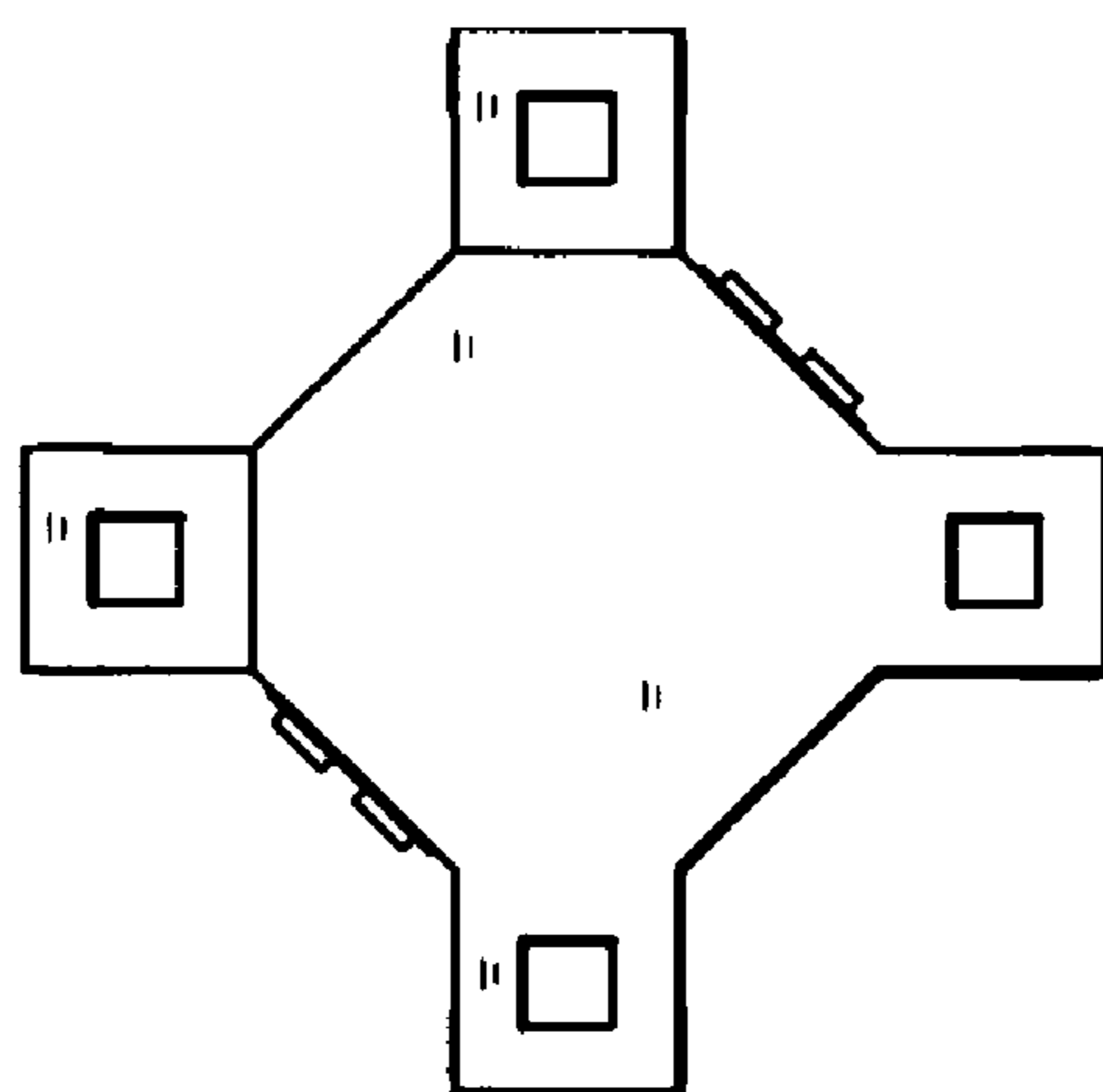

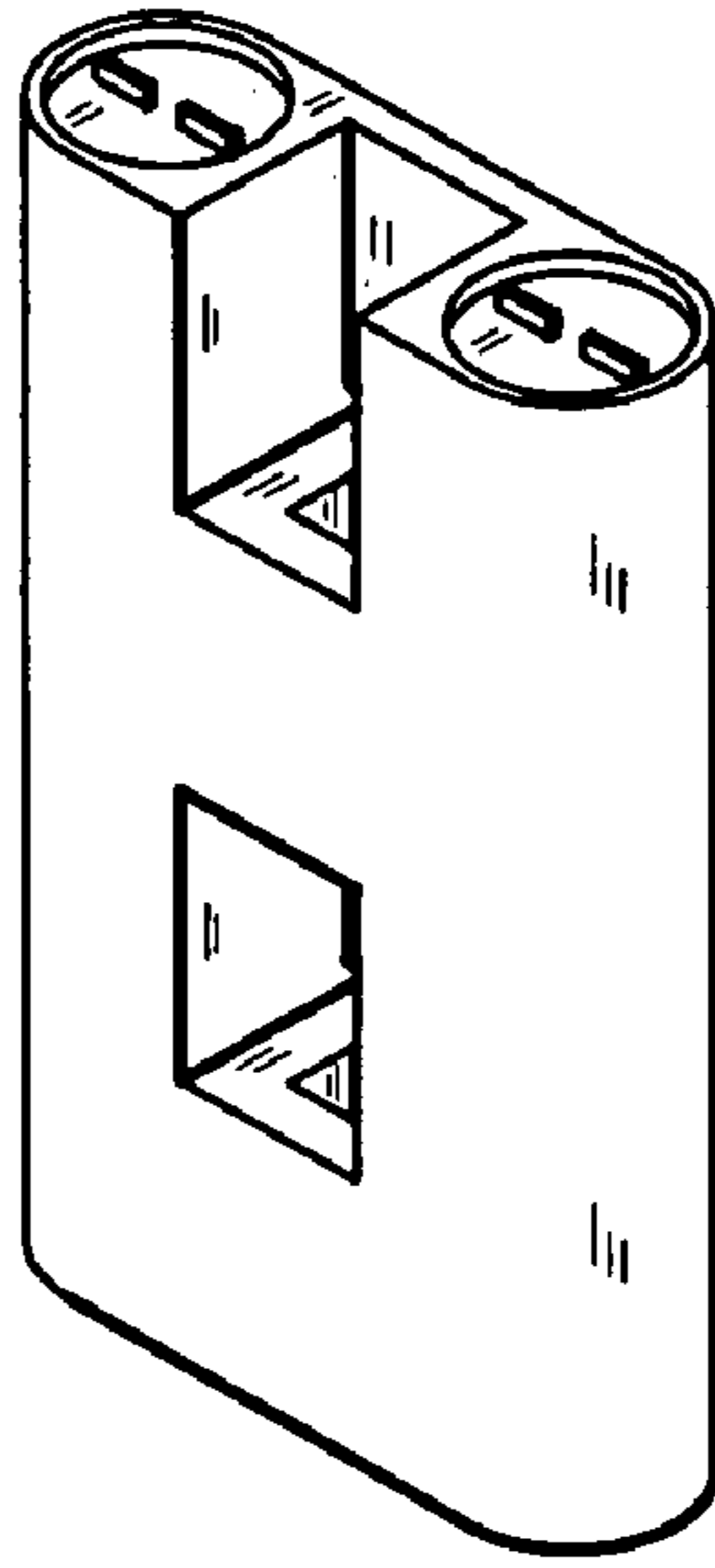

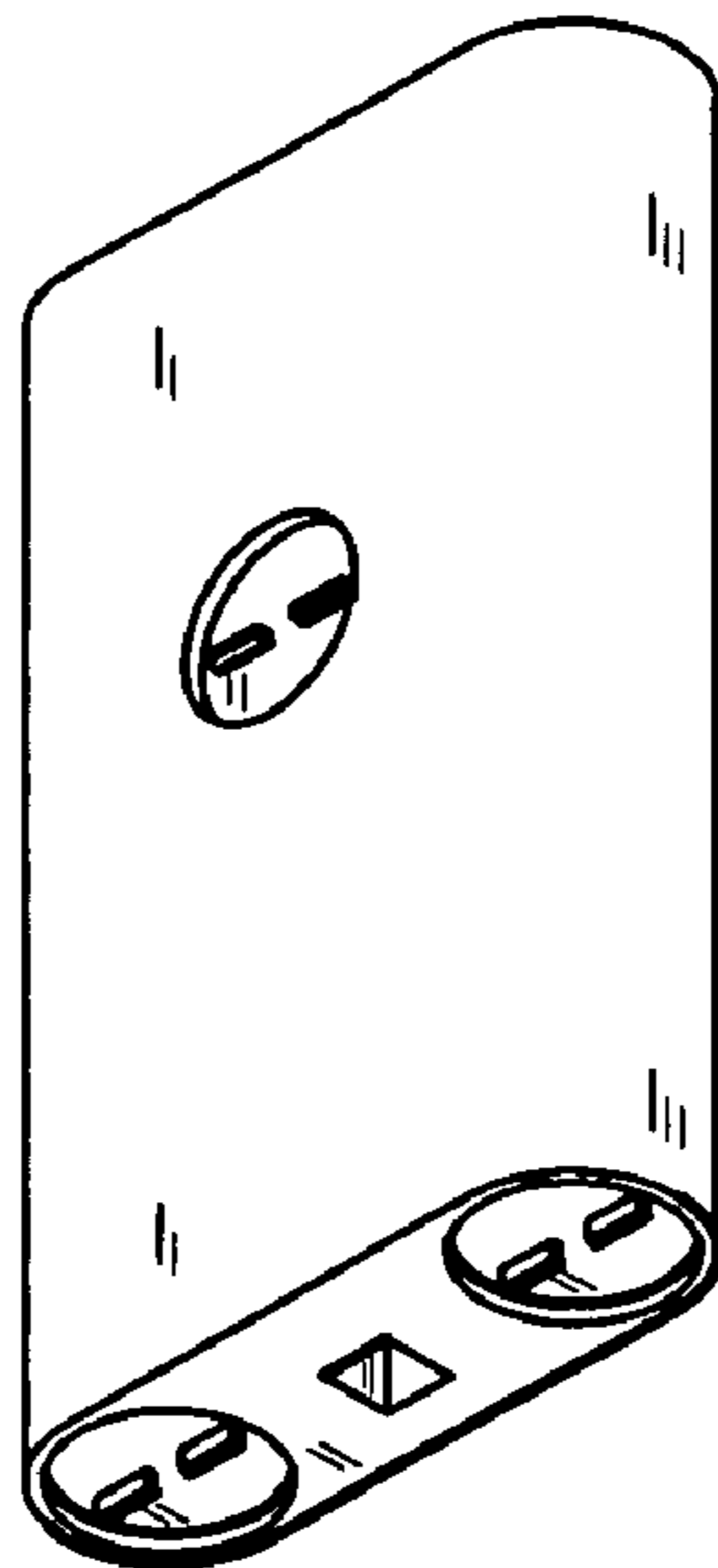

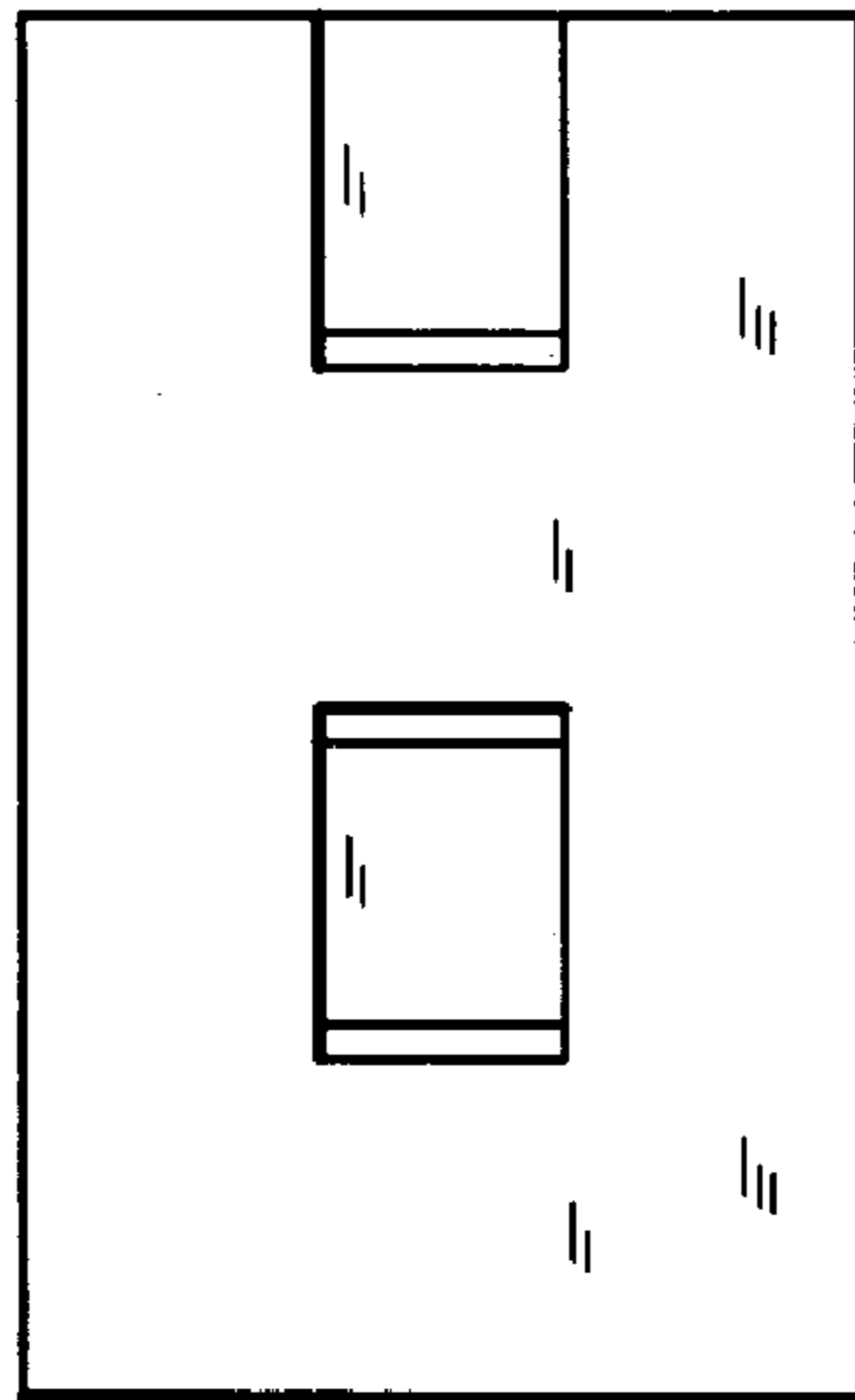

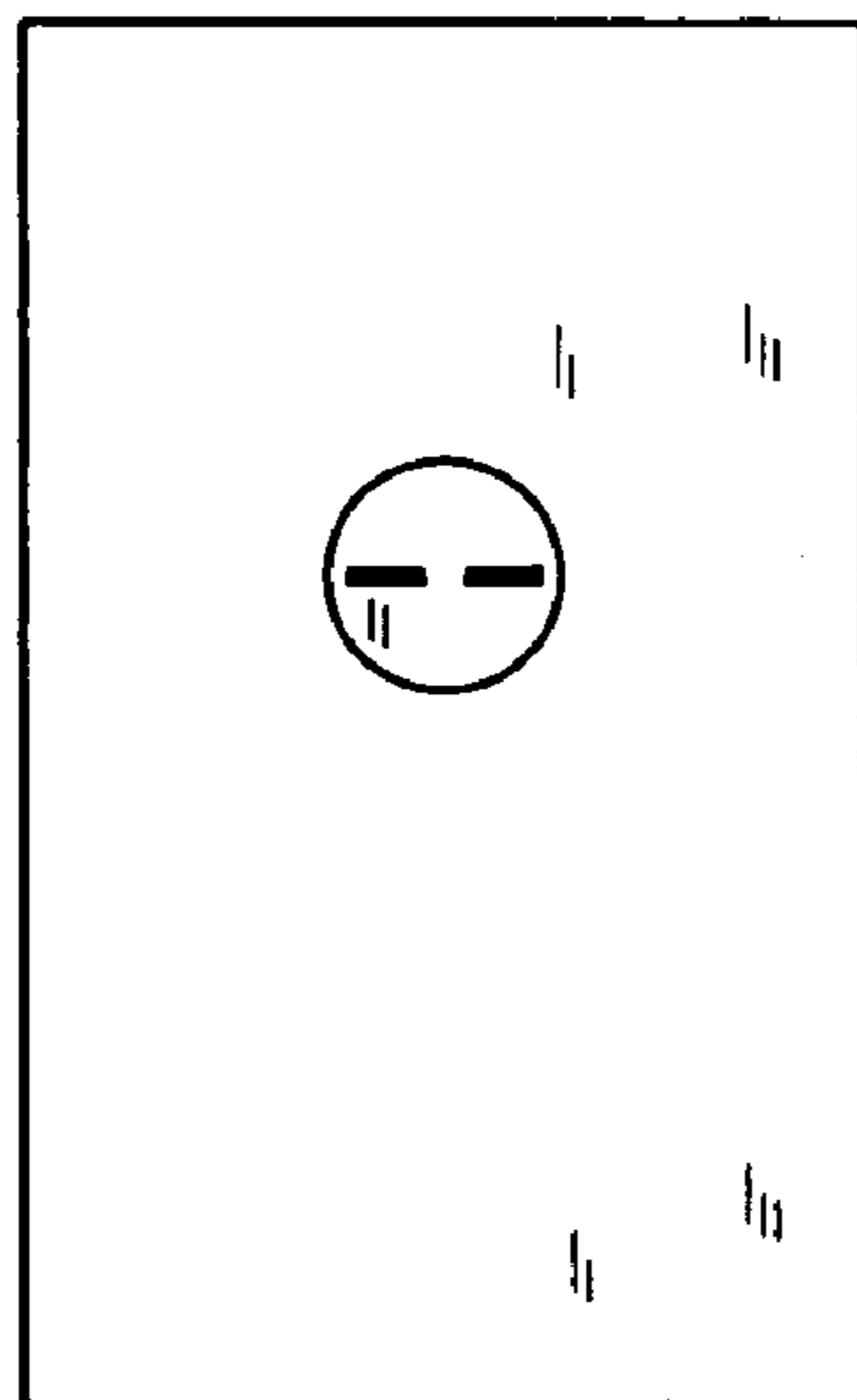

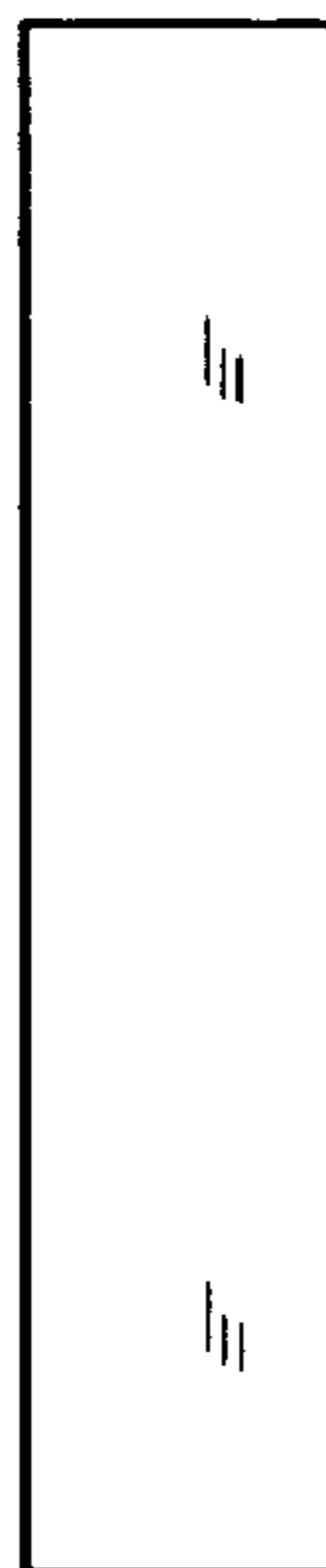

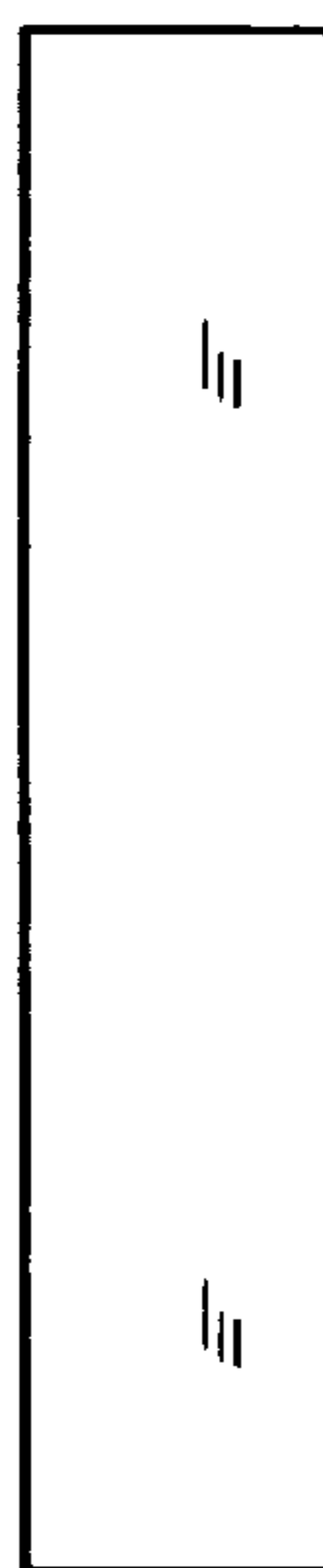

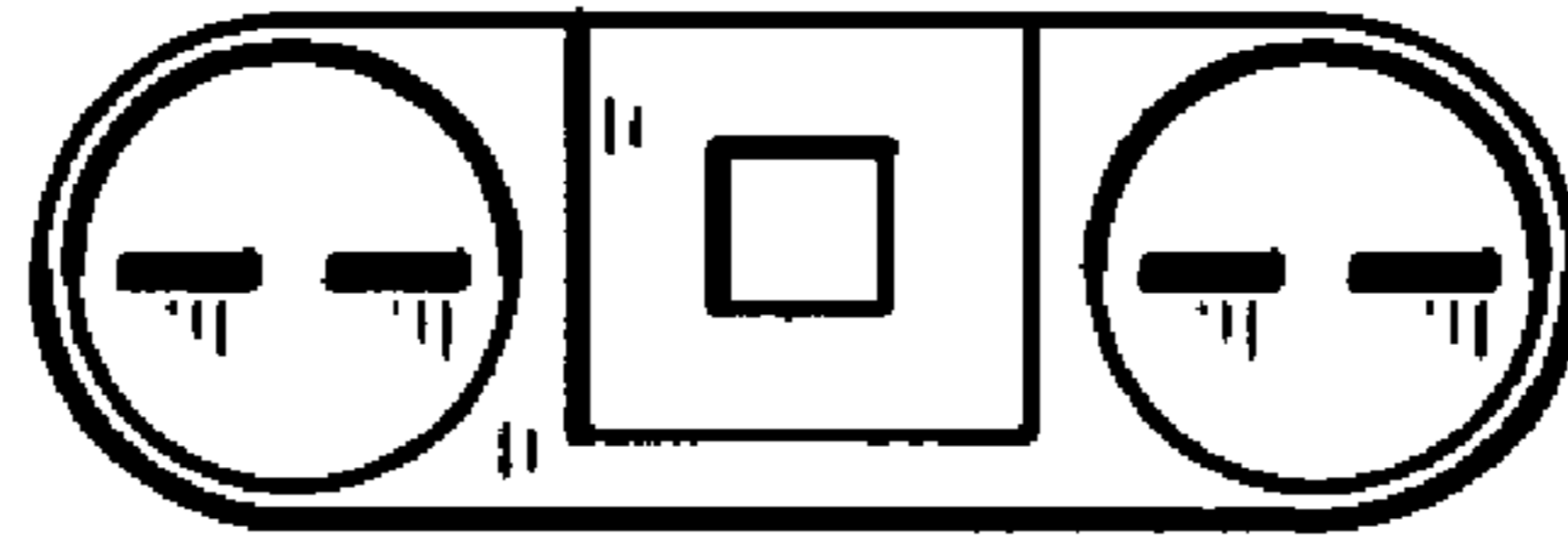

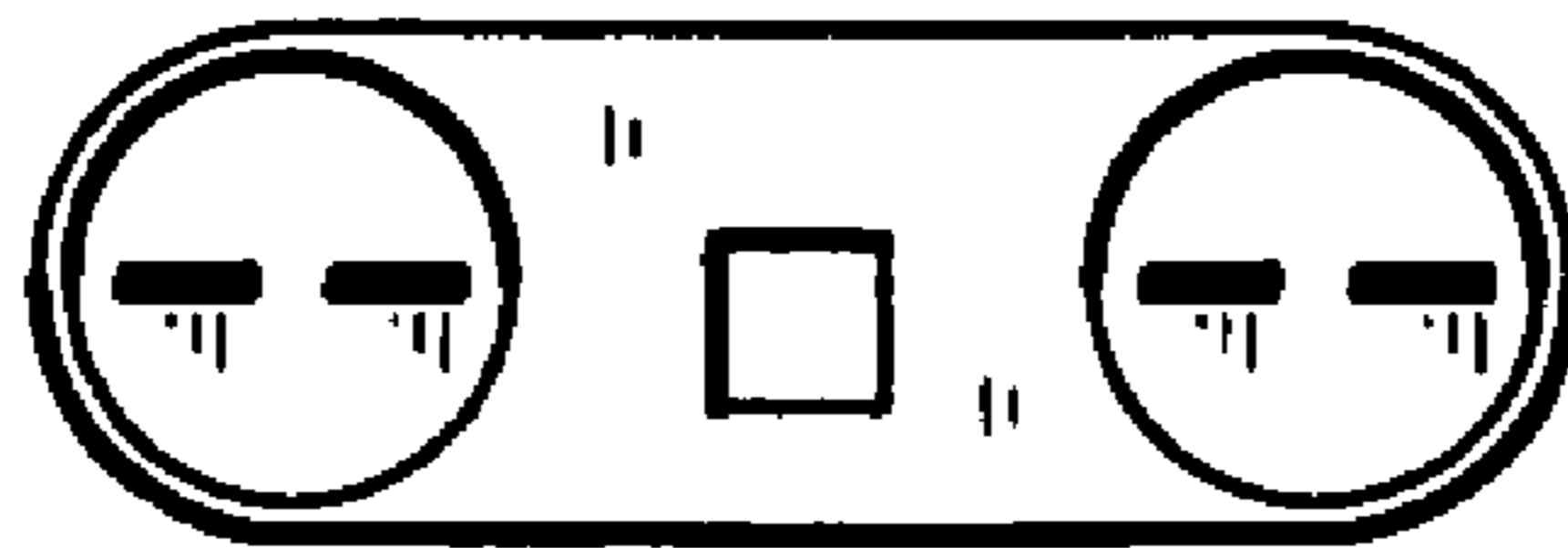
