FIG. 5 is a right view of the panty.

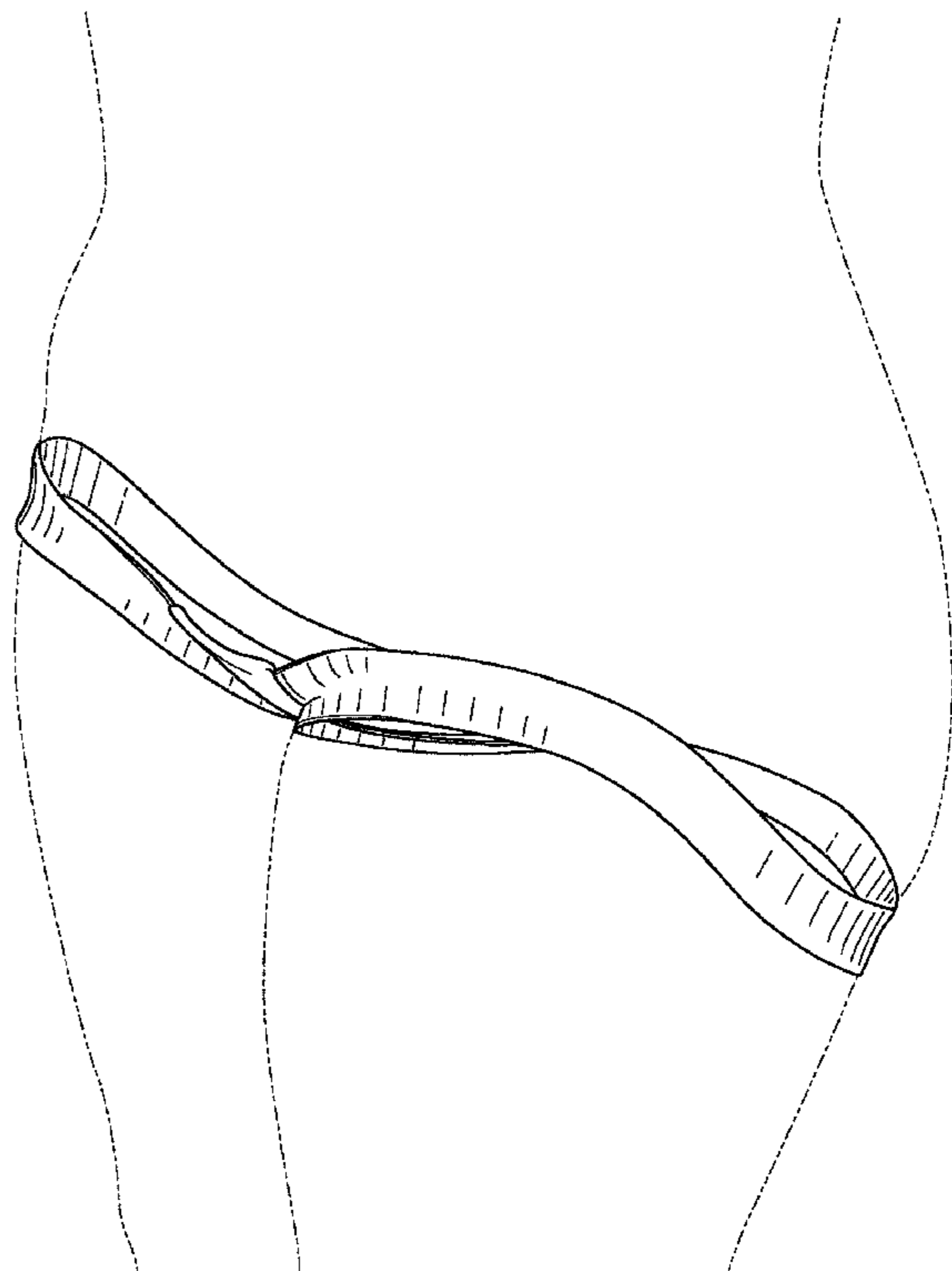
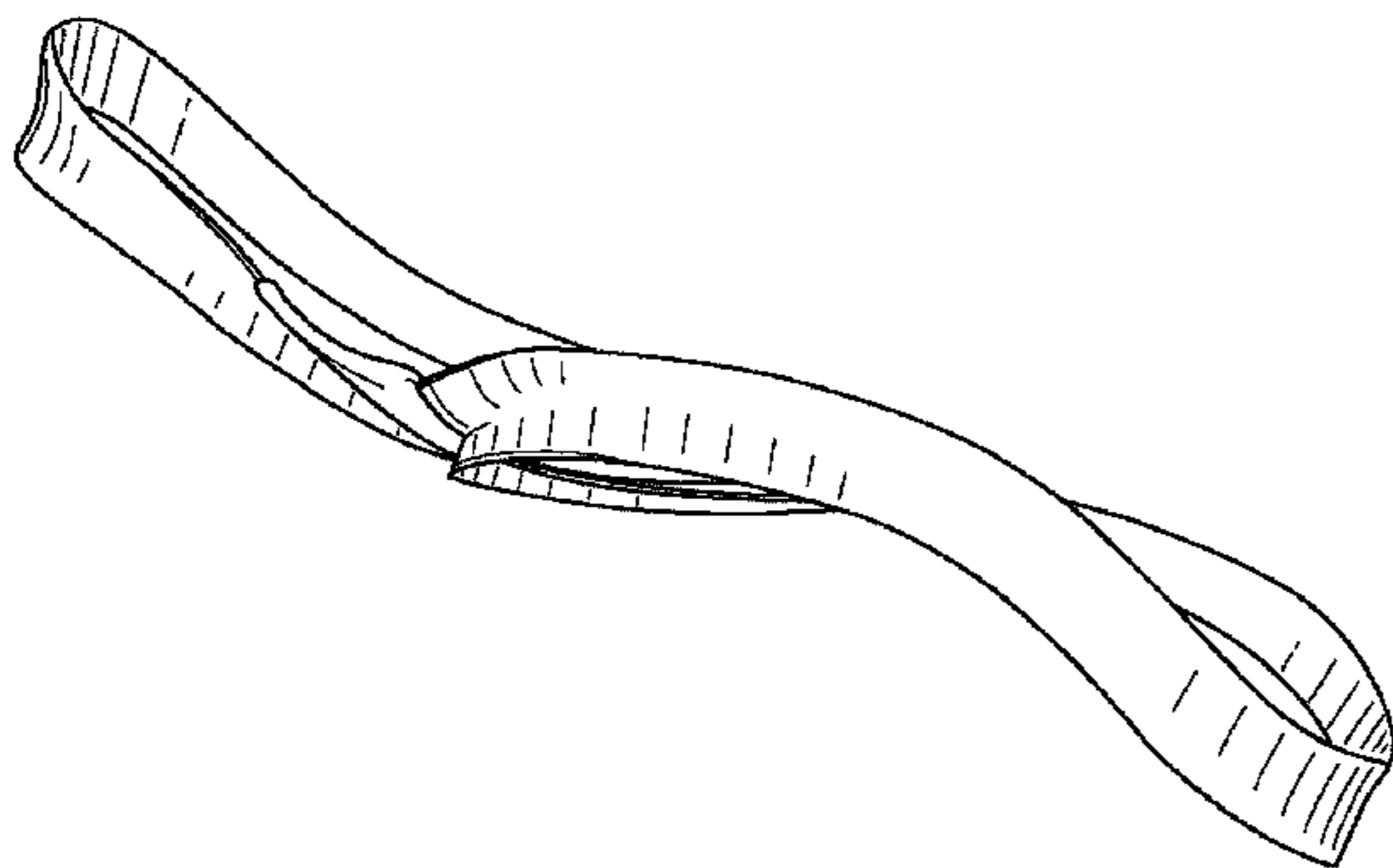
FIG. 6 is a top plan view of the panty.

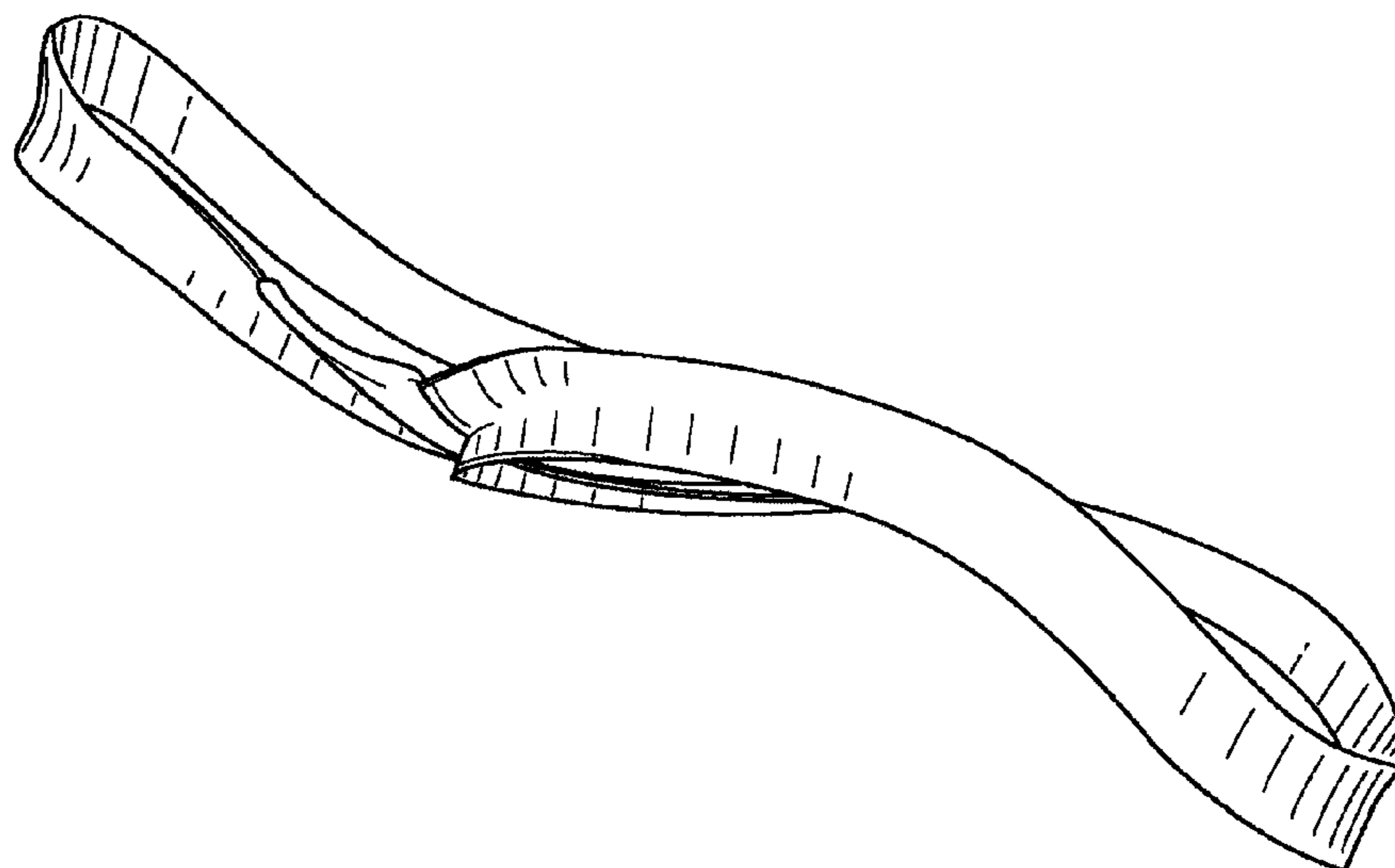

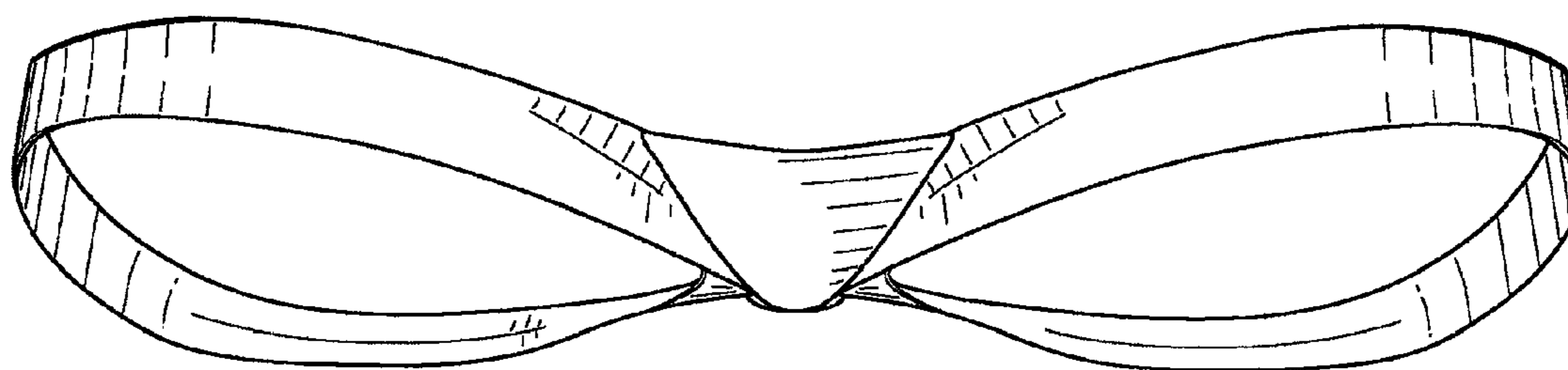

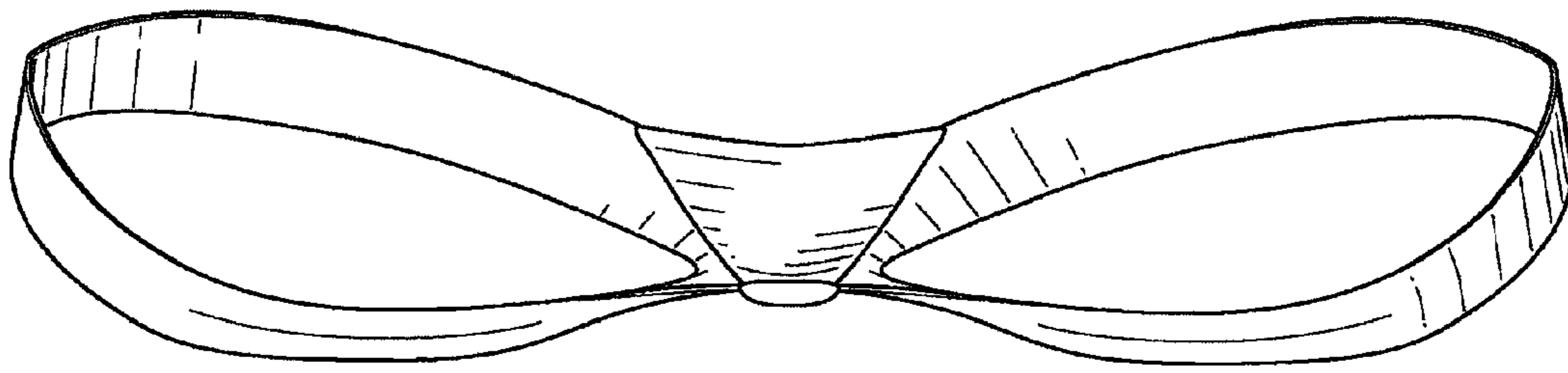

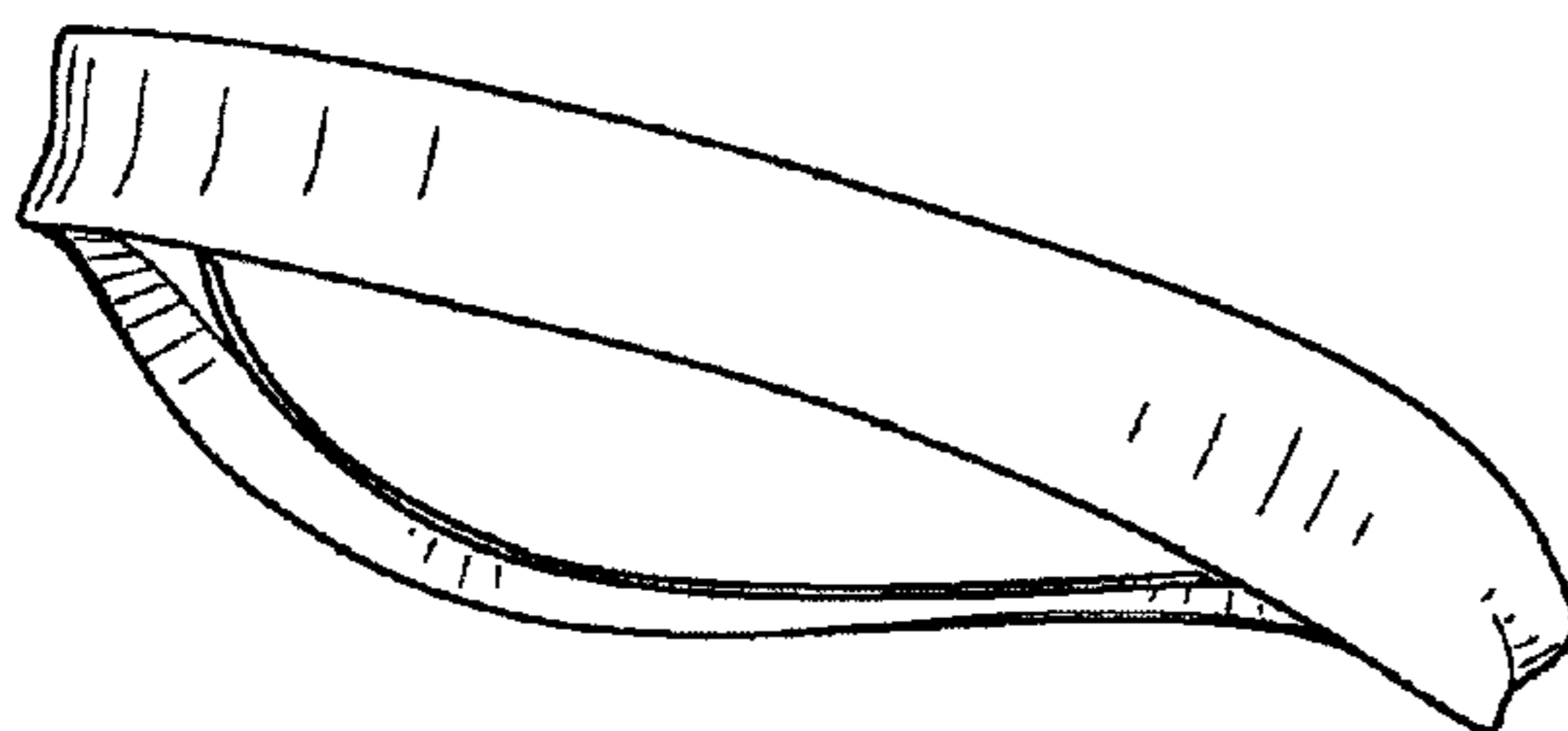

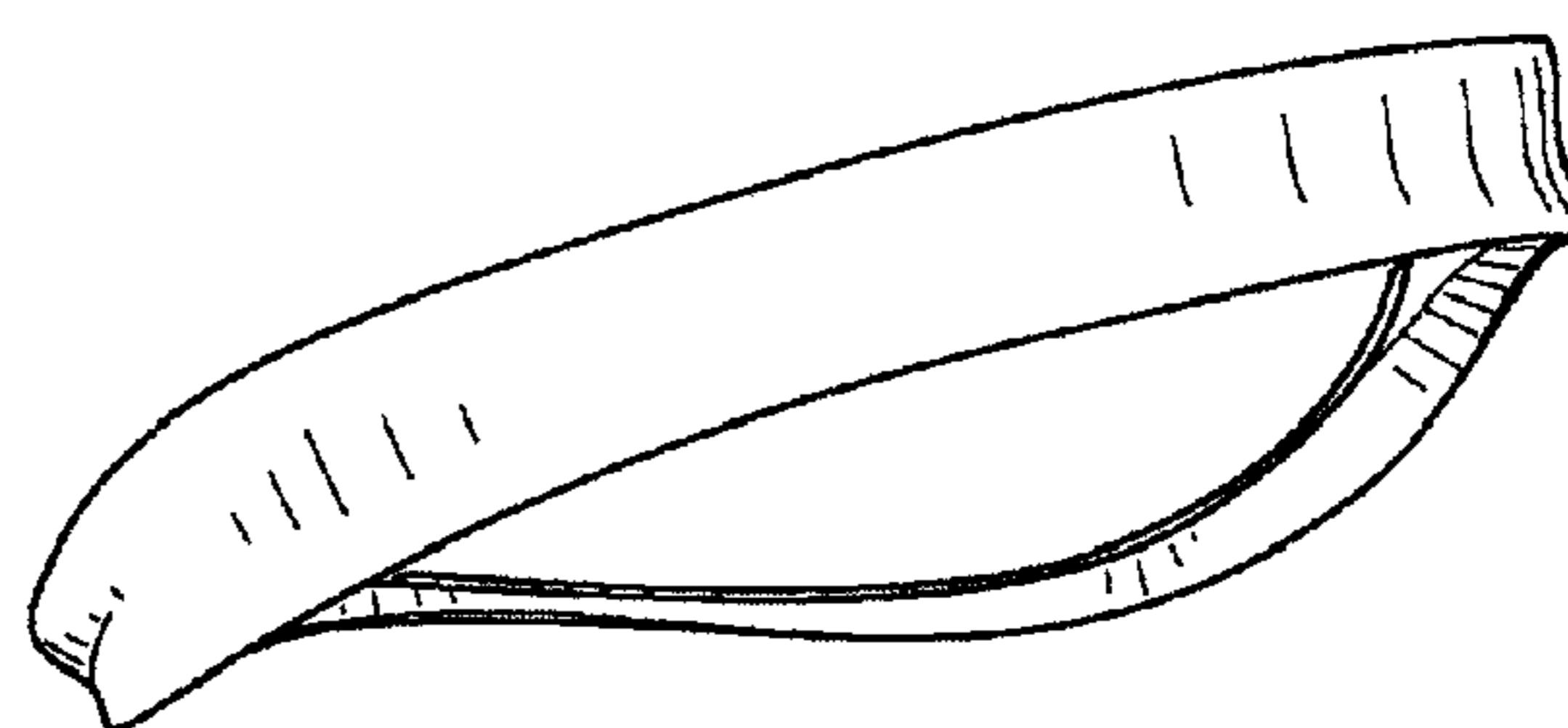

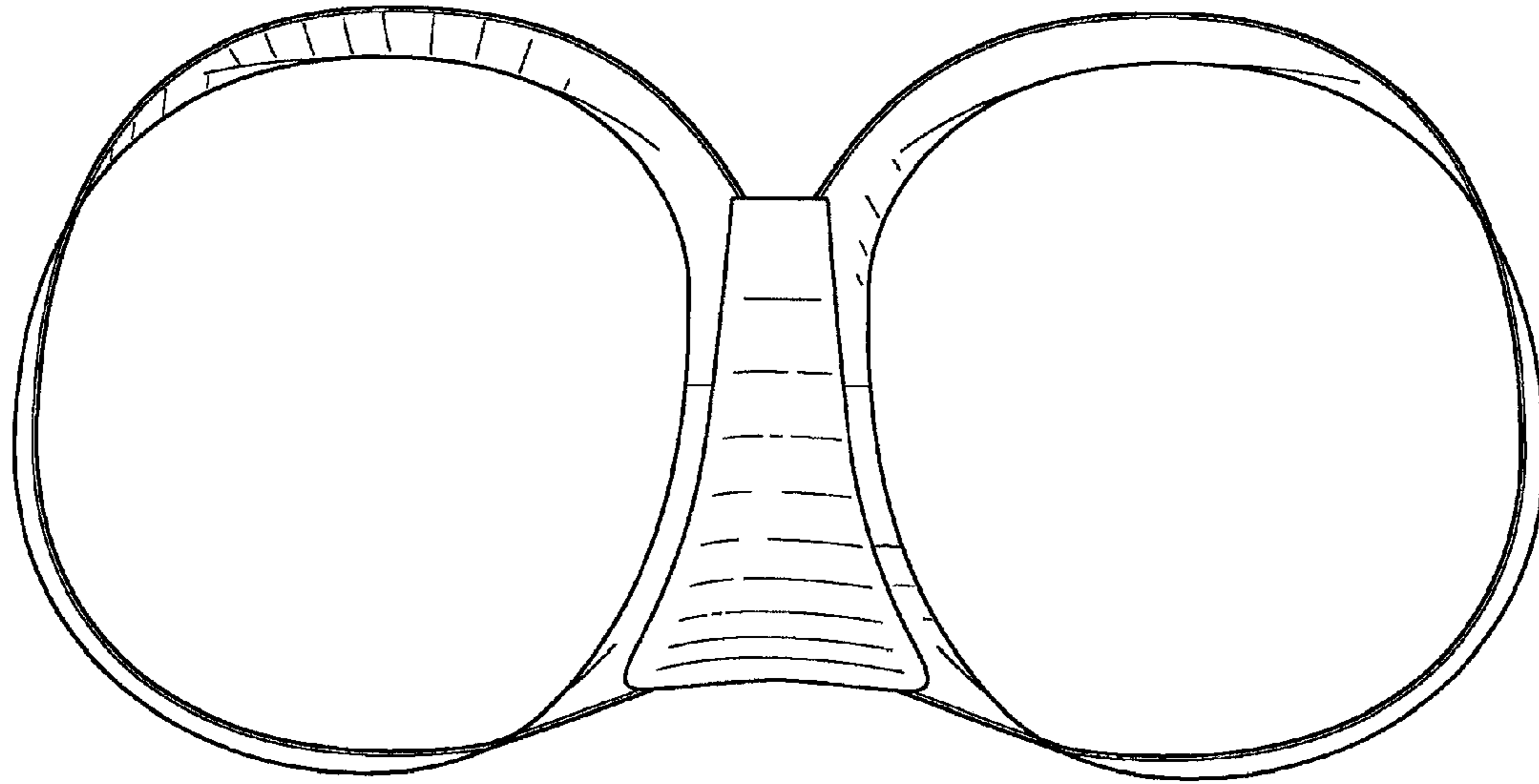

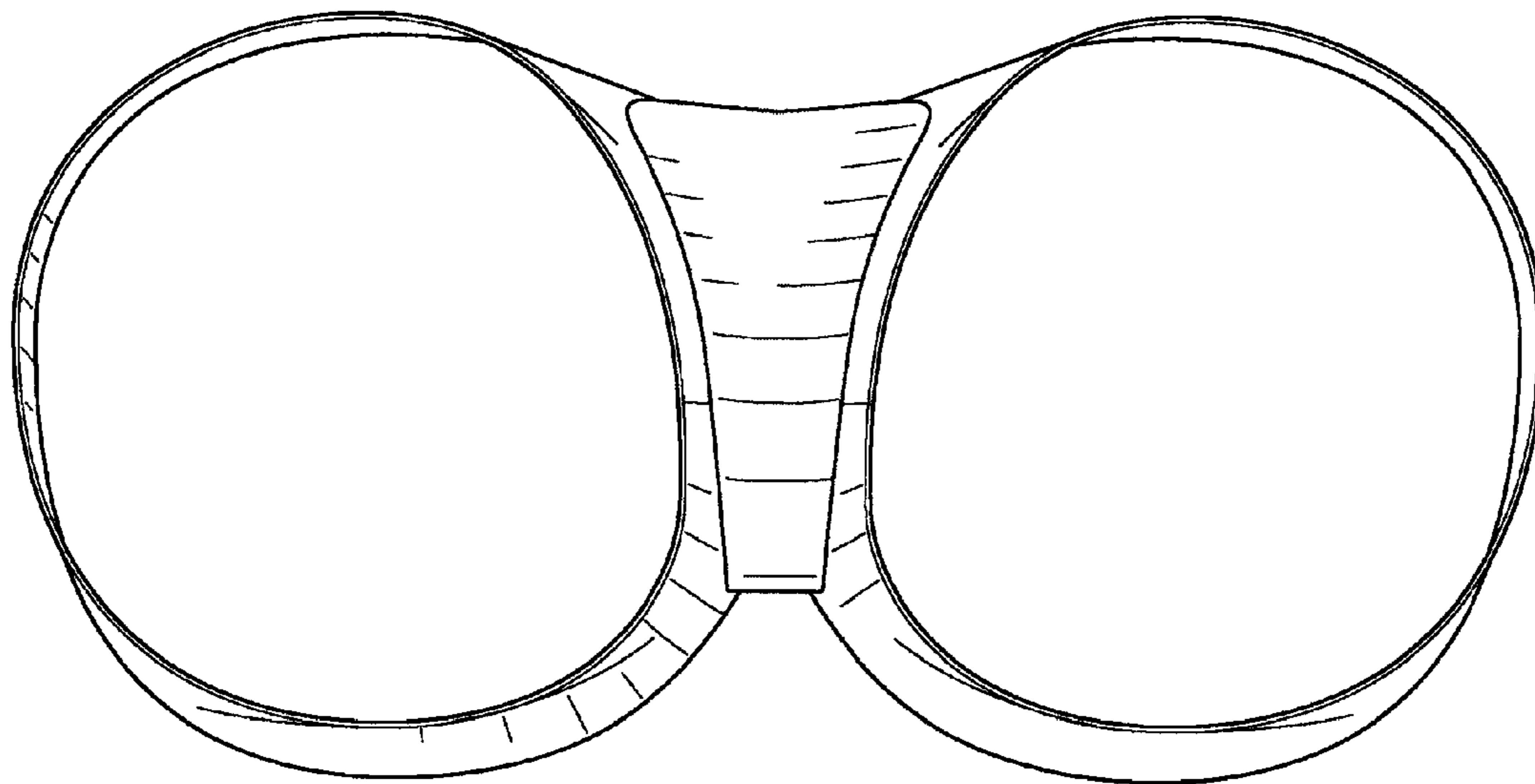

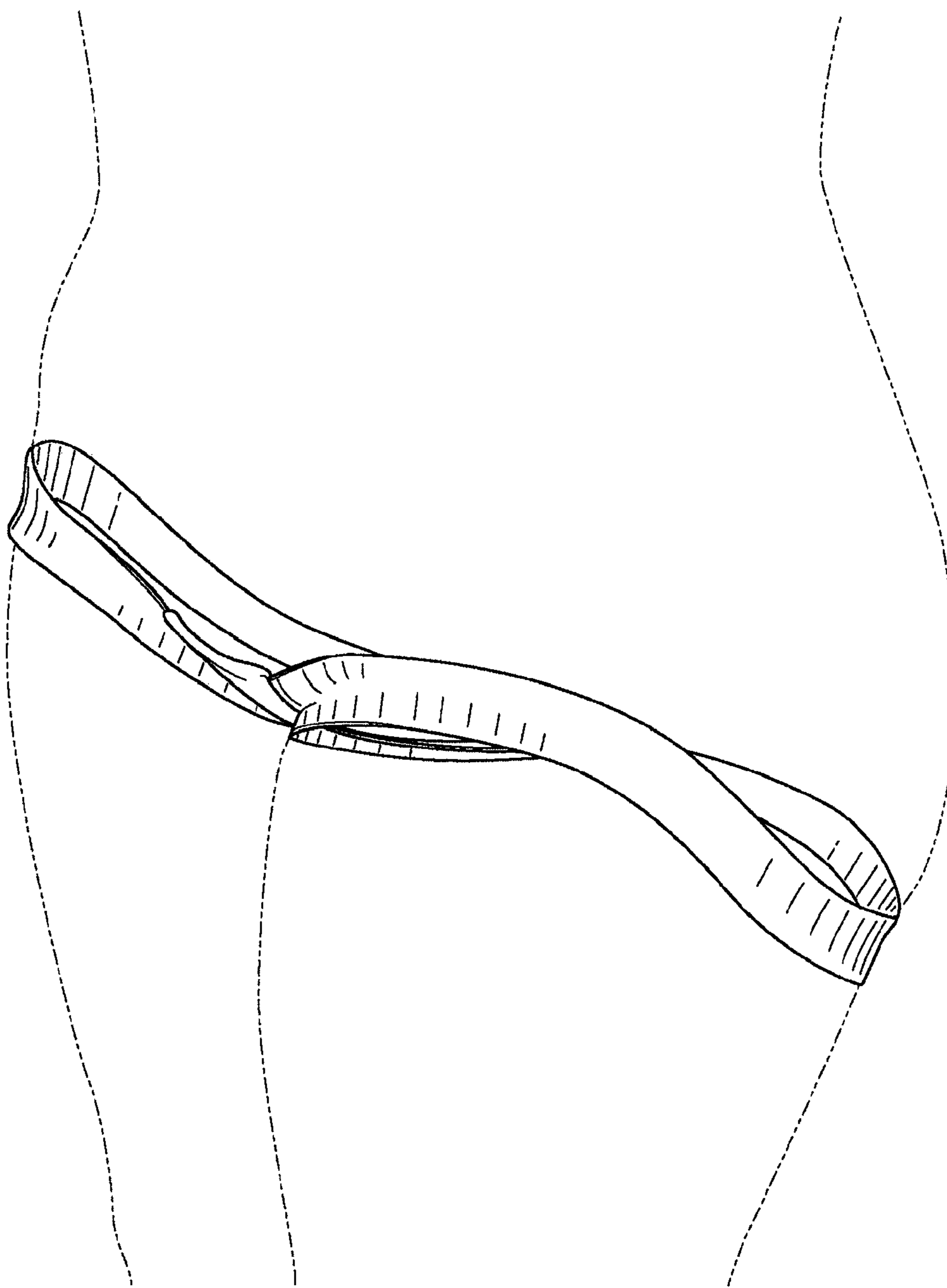
