FIG. 4 is a left view of the camera case.

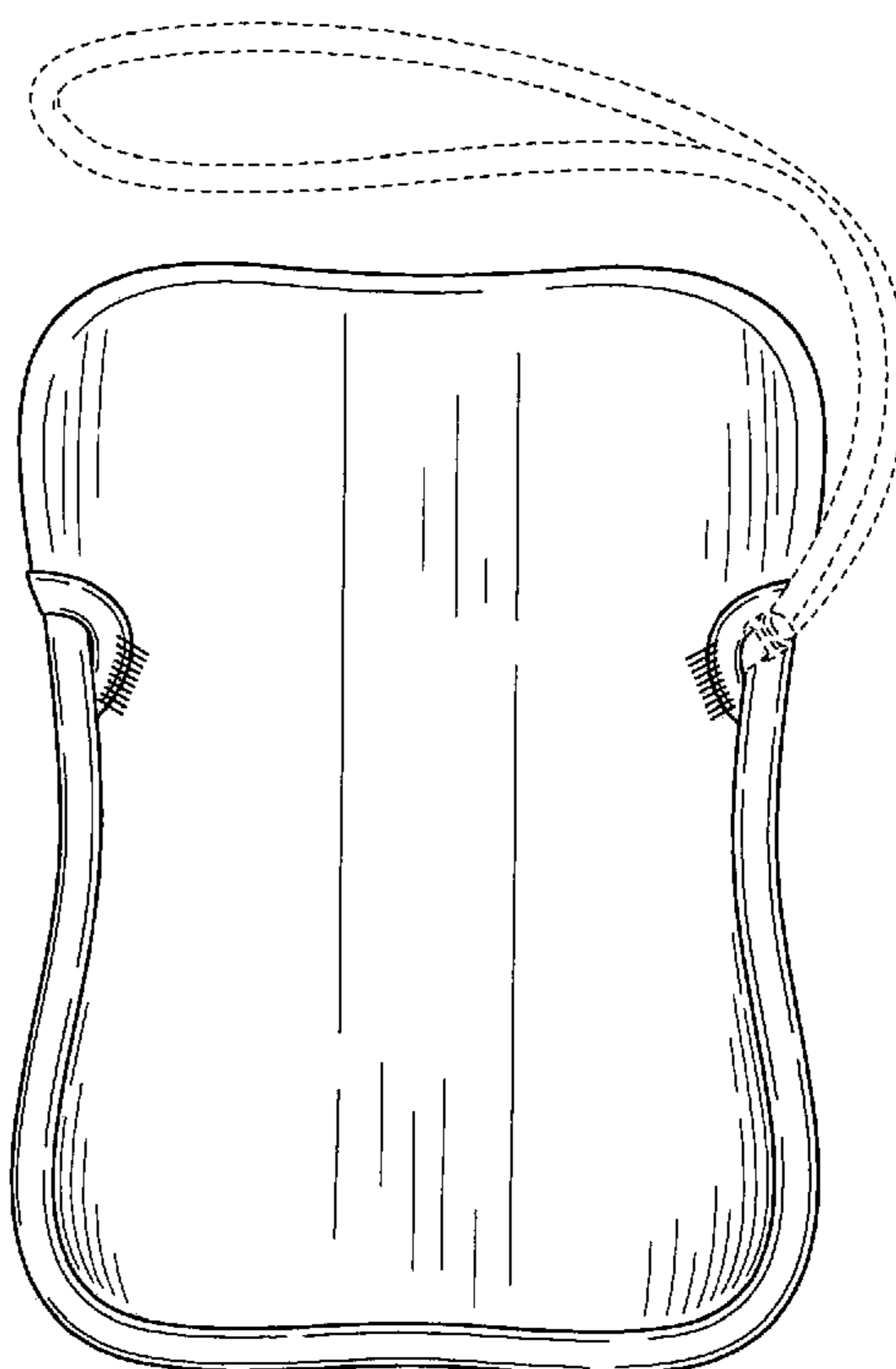
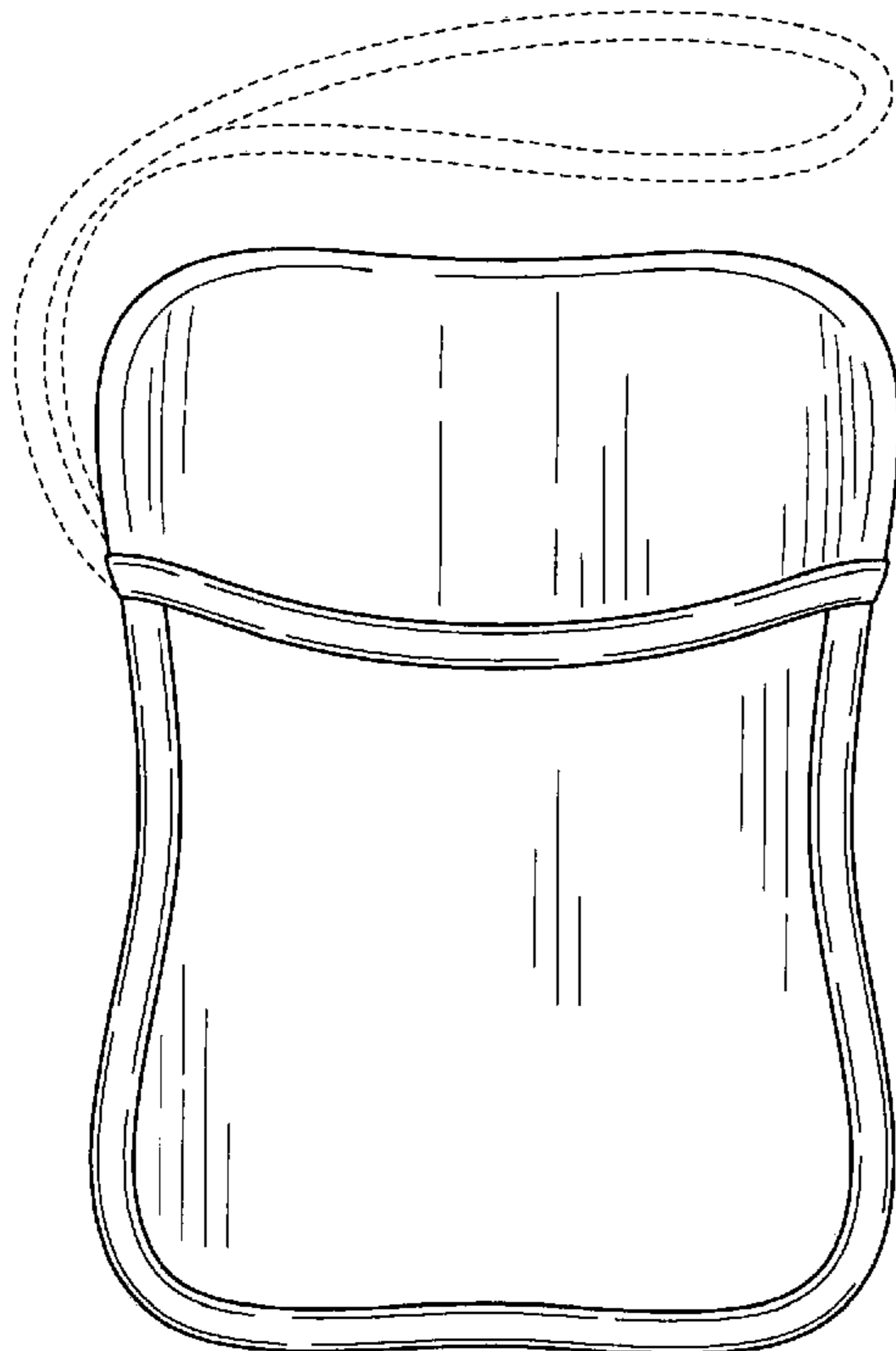
FIG. 5 is a right view of the camera case.

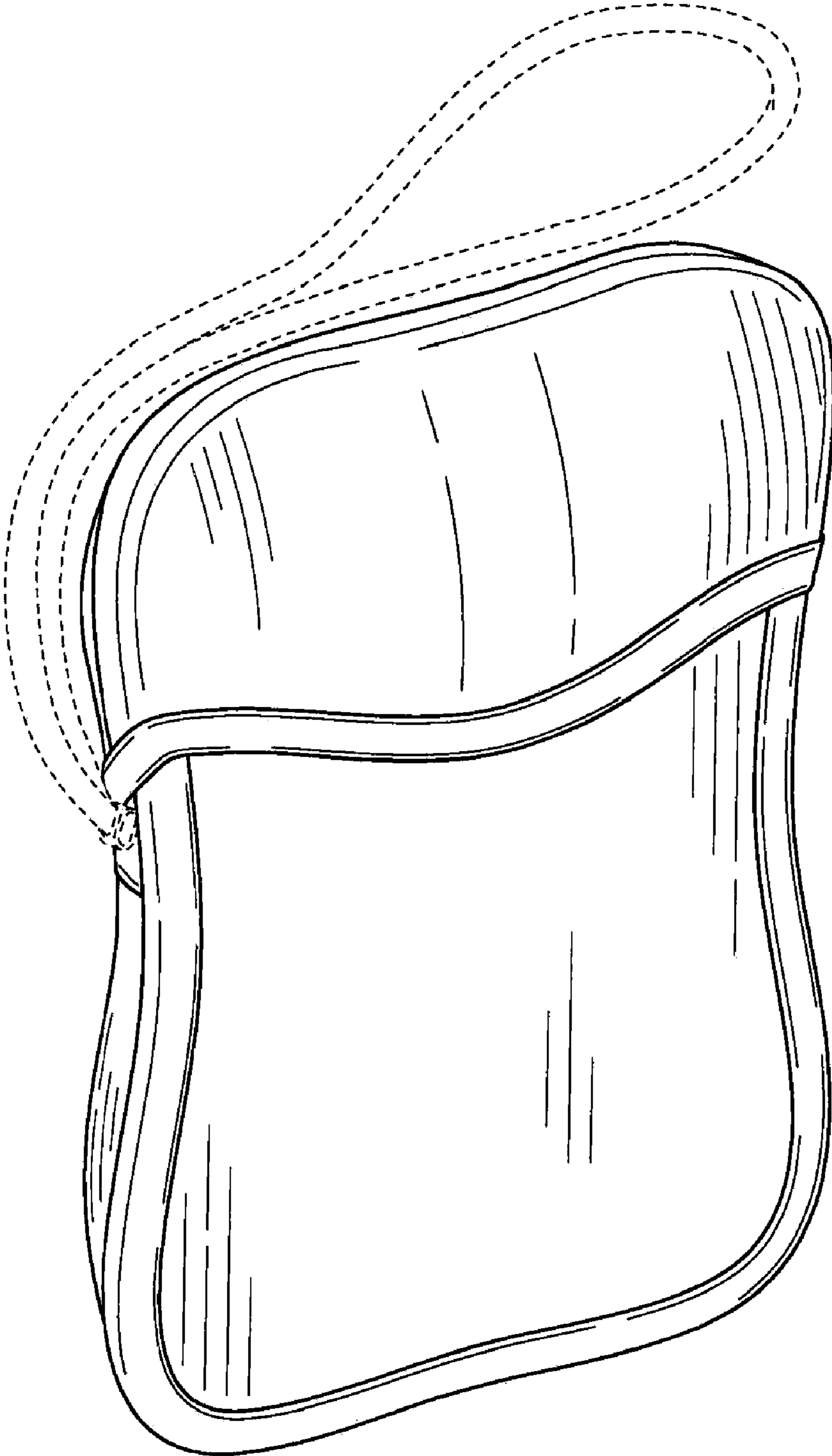

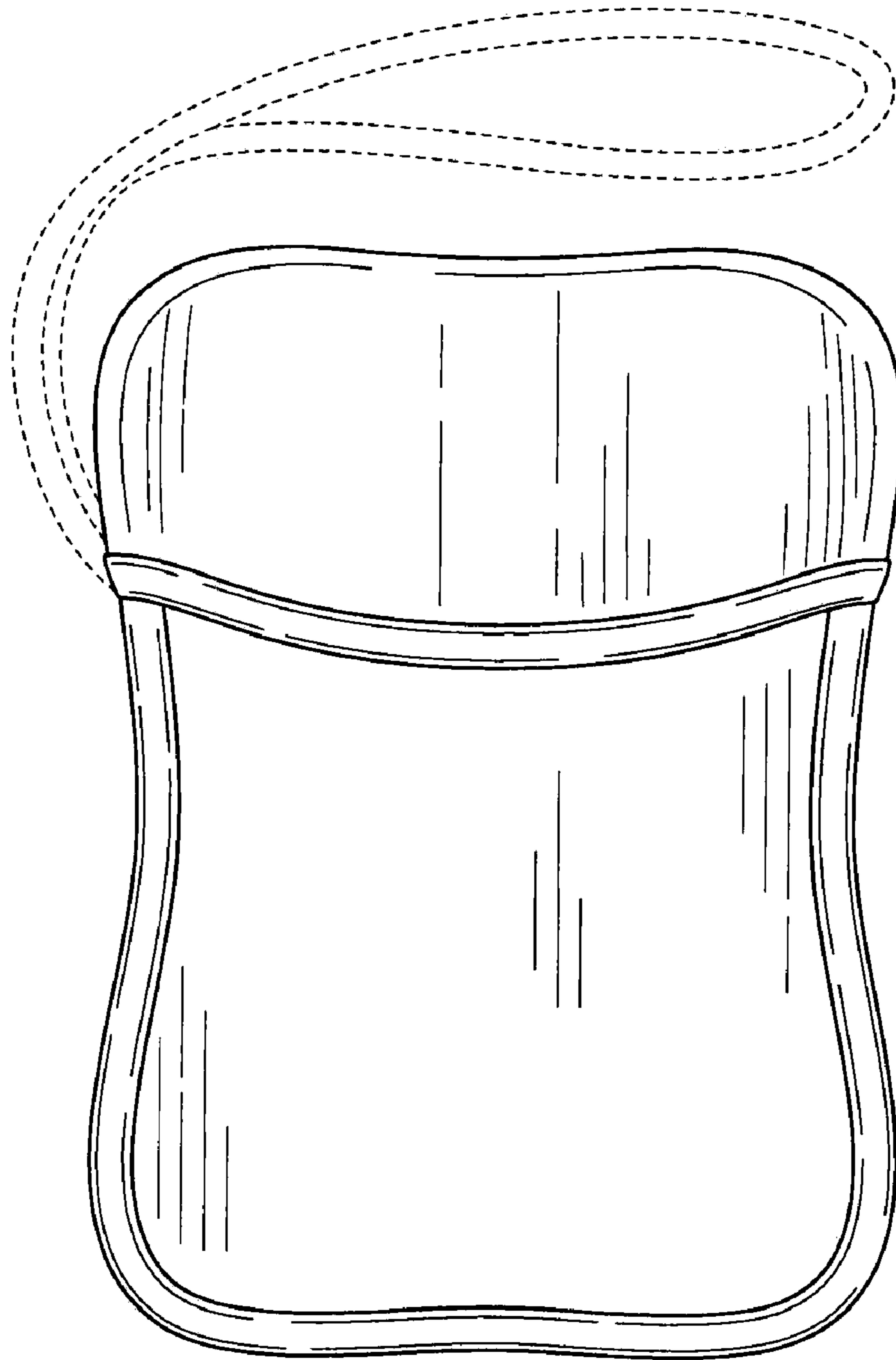

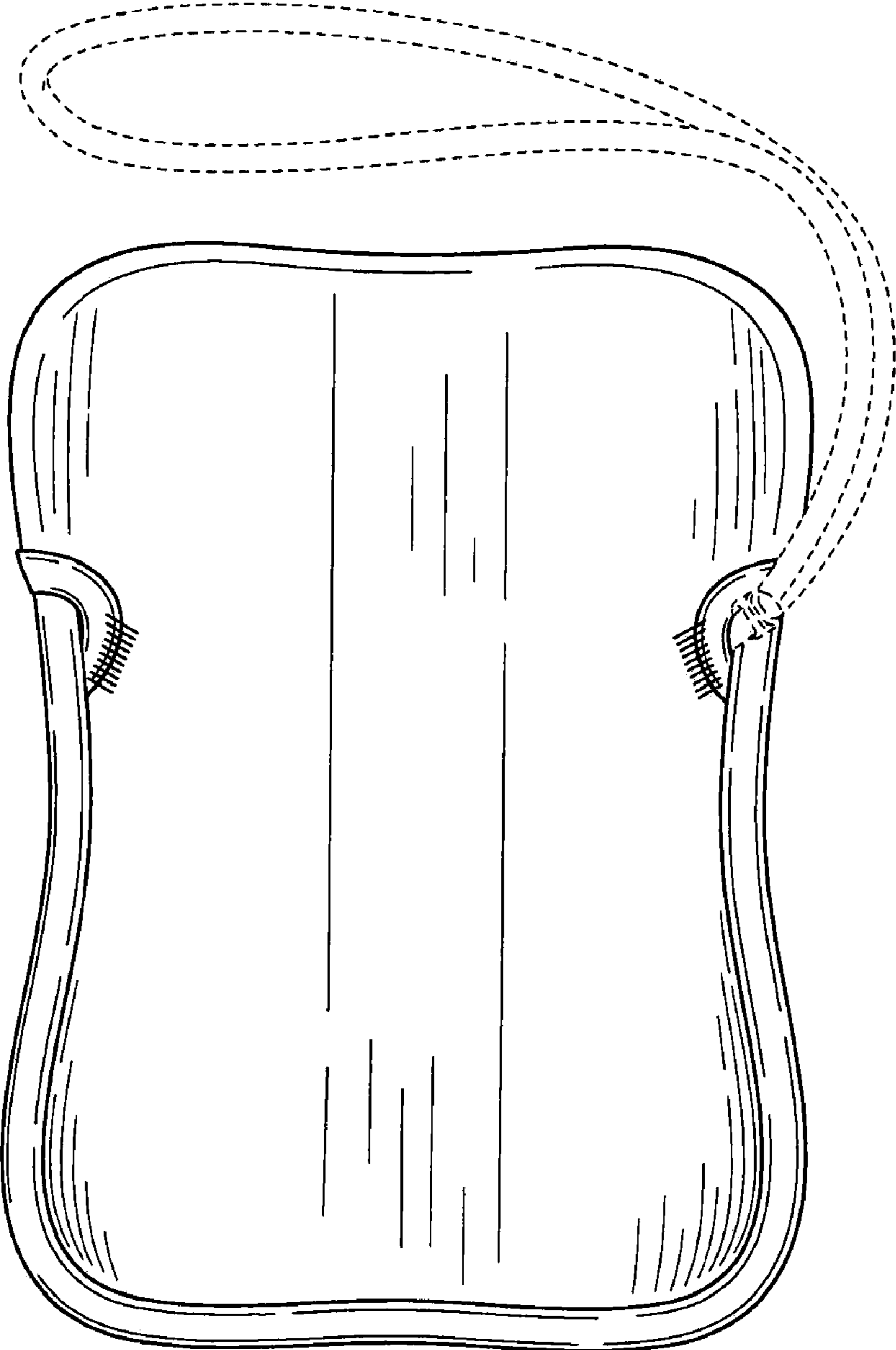

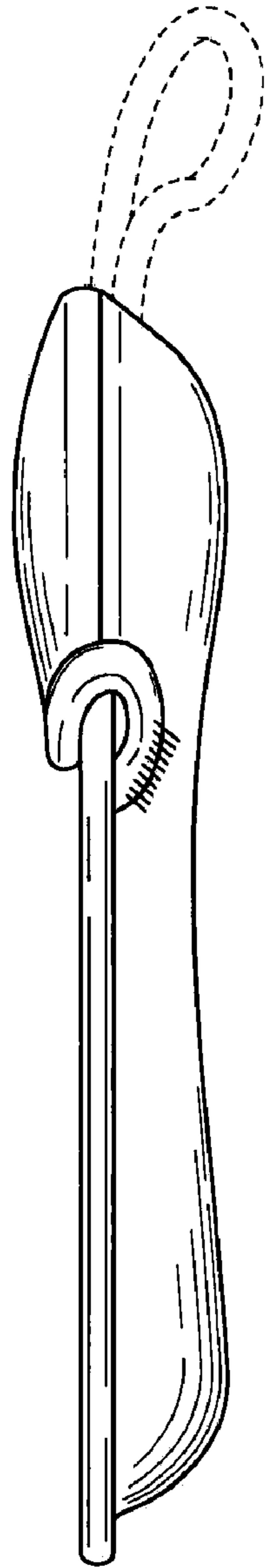

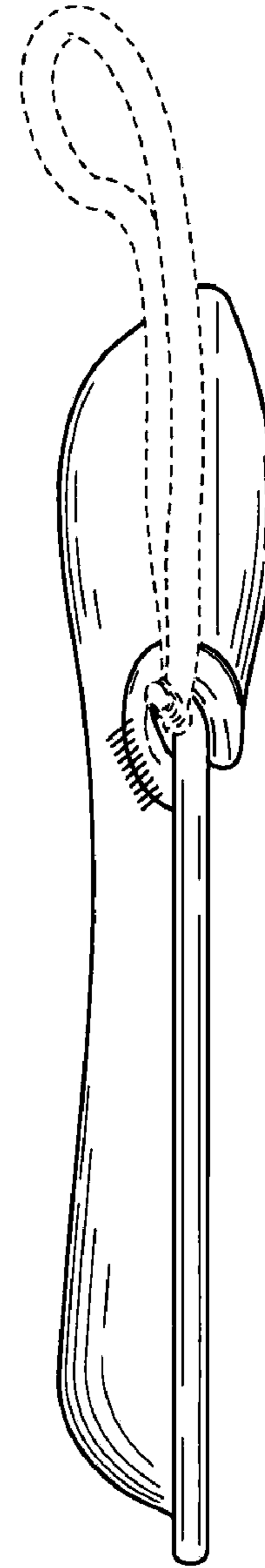

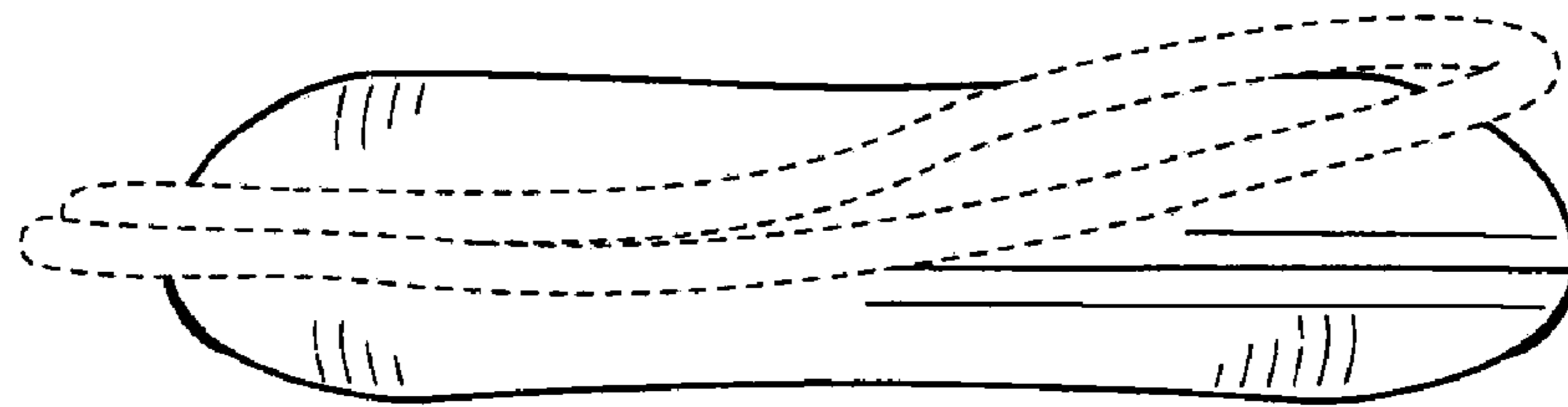

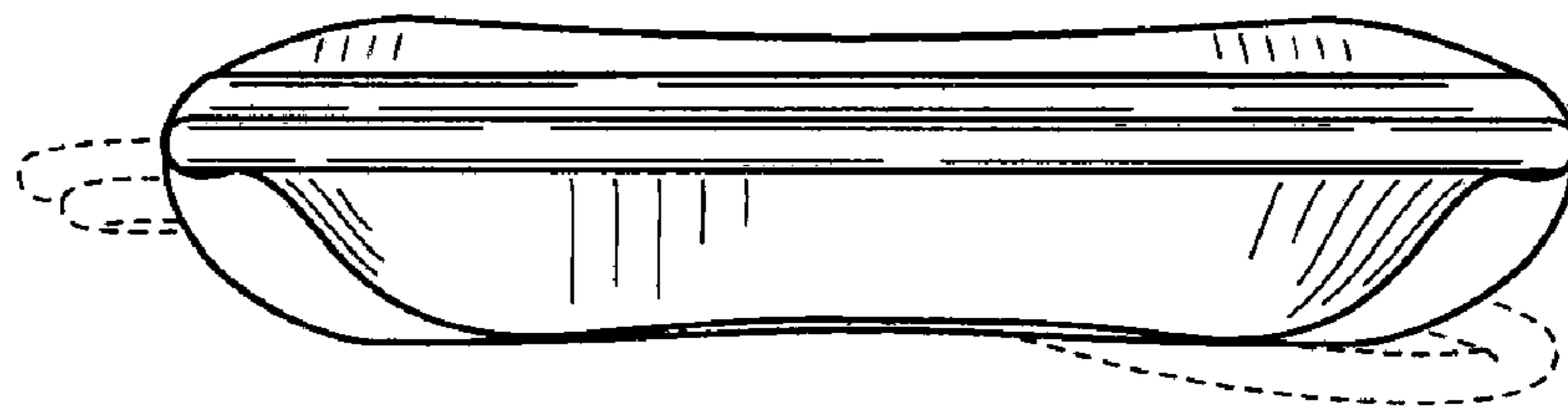
