(57) **CLAIM**

The ornamental design for a soap dish, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the soap dish according to the invention;

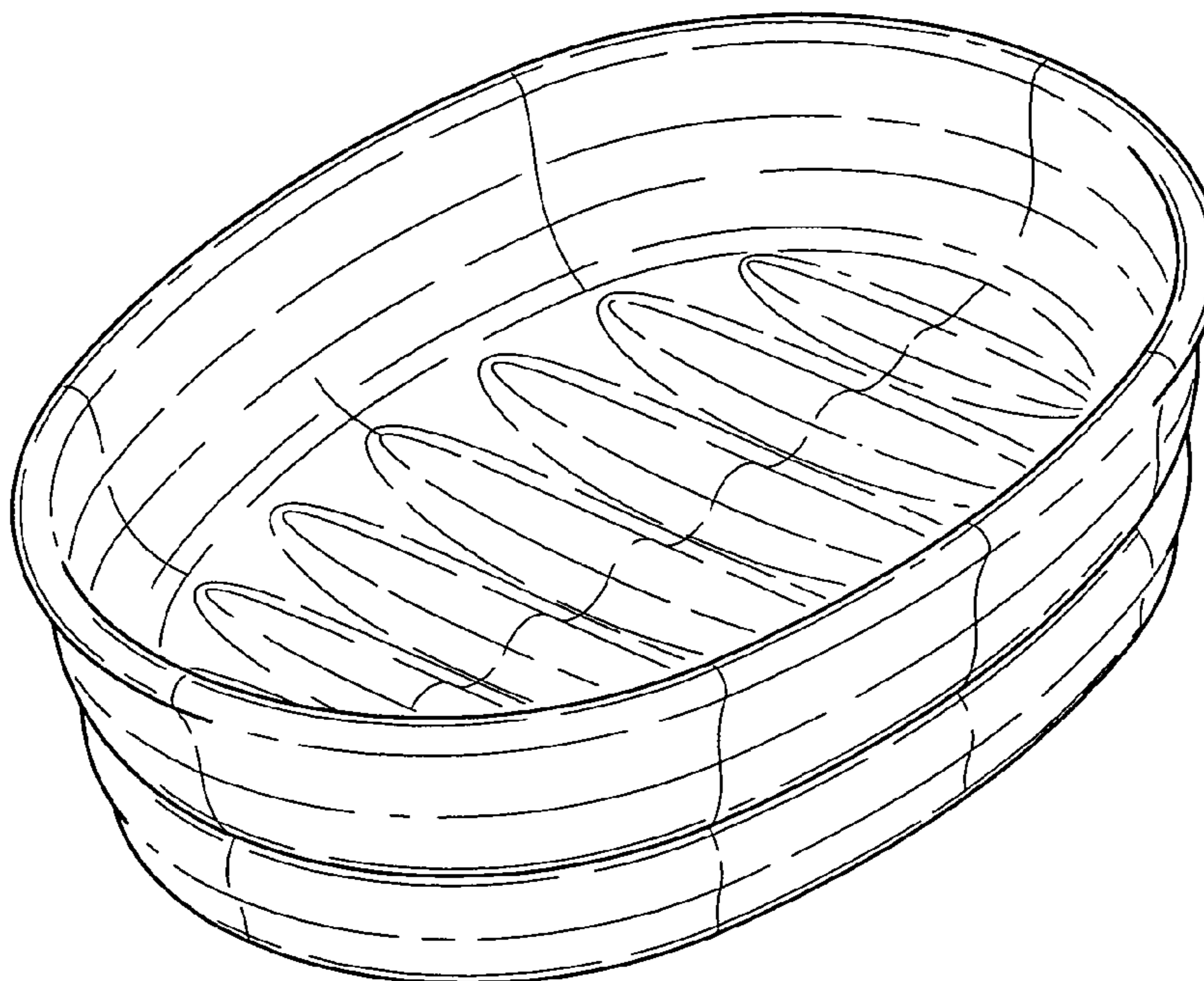
FIG. 2 is a top view of the soap dish as shown in FIG. 1;

FIG. 3 is a bottom view of the soap dish as shown in FIG. 1;

FIG. 4 is a side view of the soap dish as shown in FIG. 1, the opposing side view of the soap dish as shown in FIG. 1 being identical to the side view as shown in FIG. 4; and,

FIG. 5 is a front view of the soap dish as shown in FIG. 1, the rear view of the soap dish as shown in FIG. 1 being identical to the front view as shown in FIG. 5.

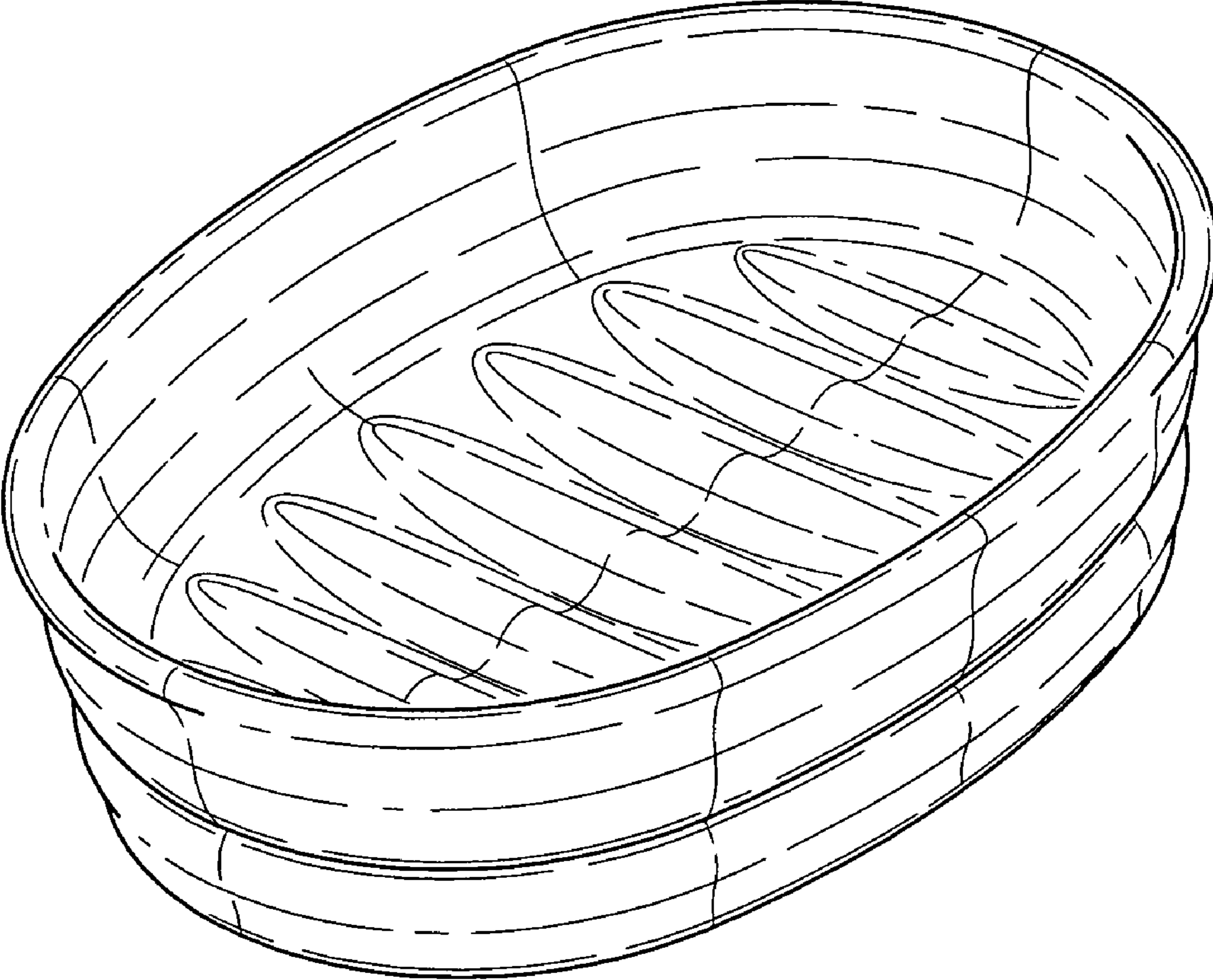

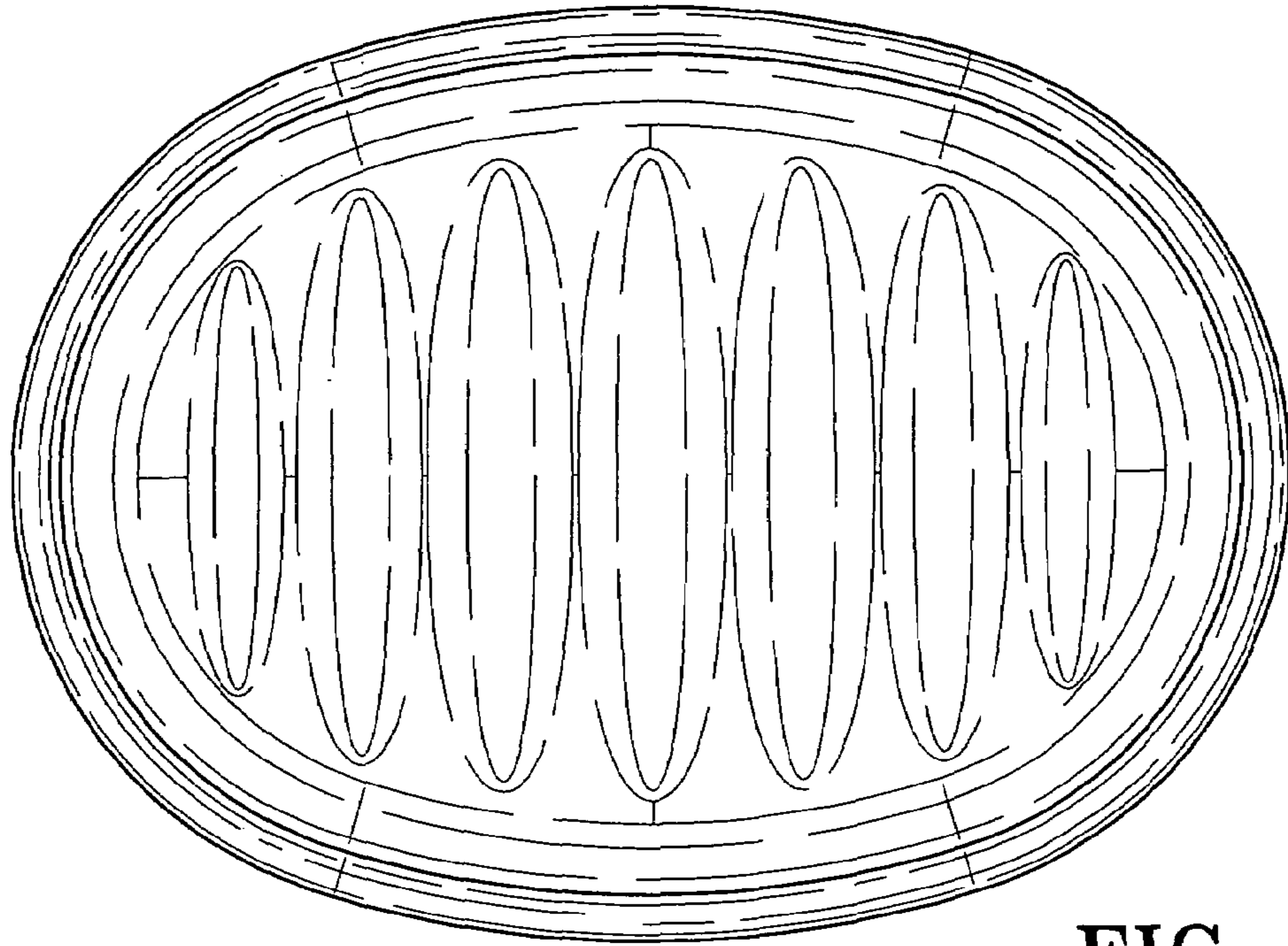

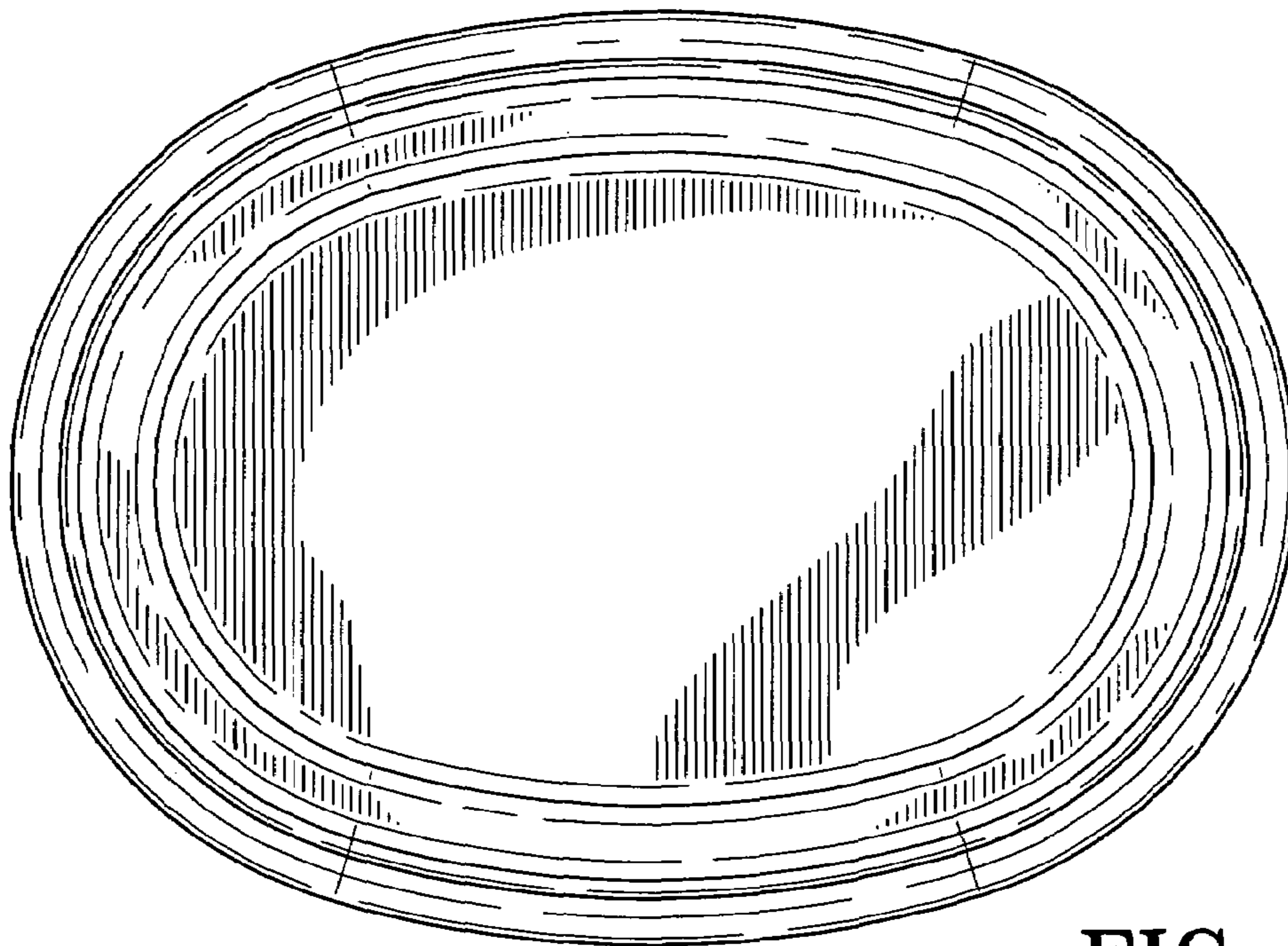

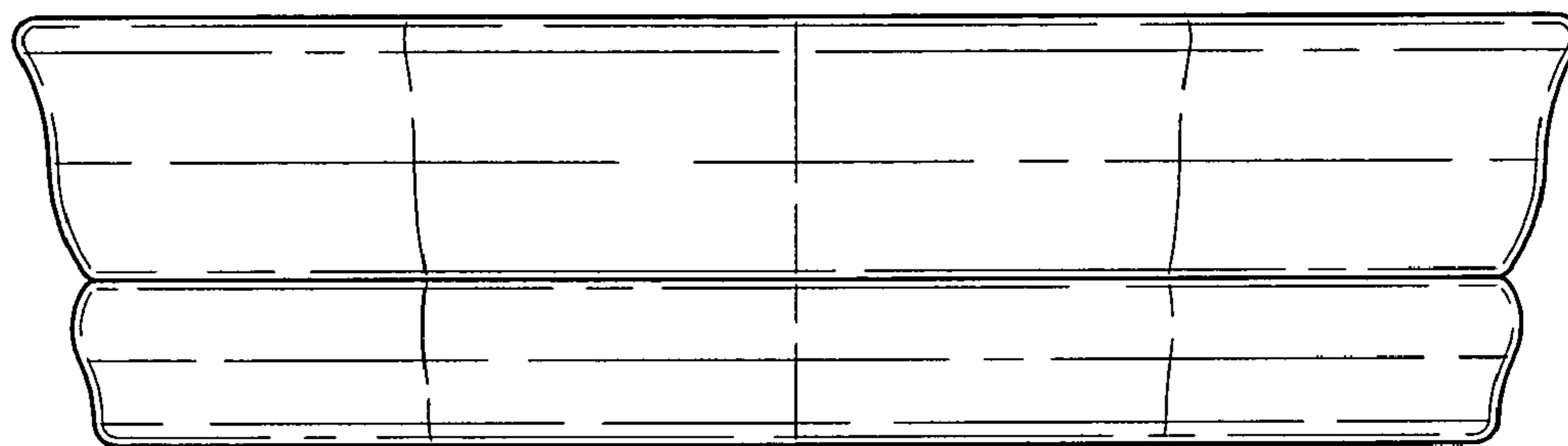

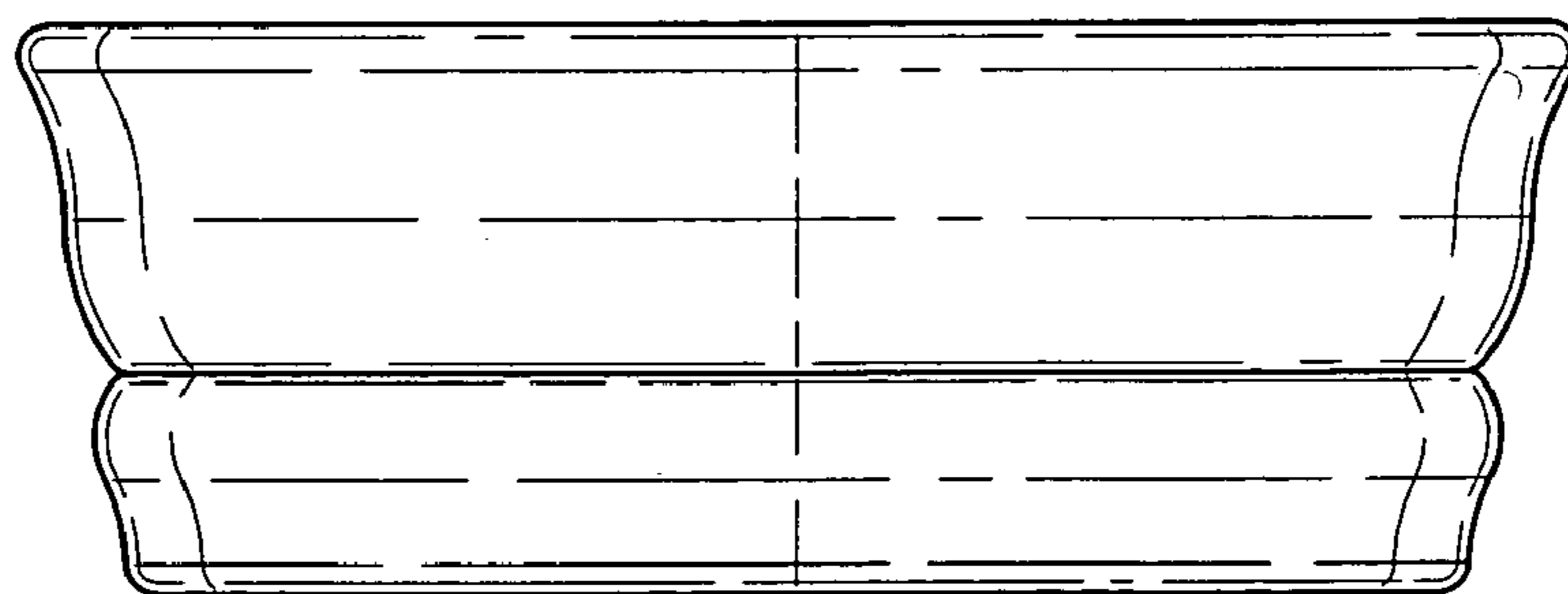
