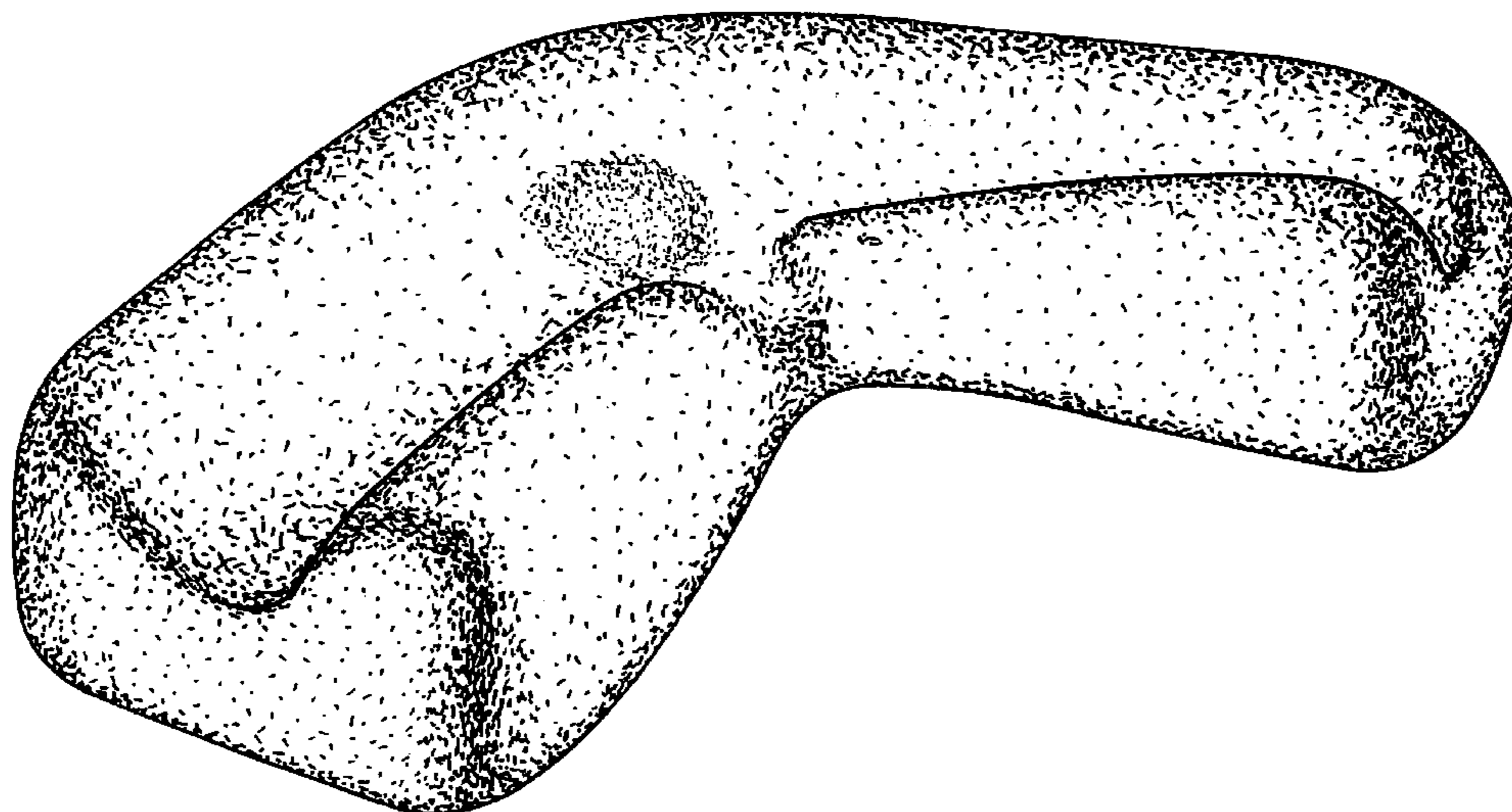

The ornamental design for a pillow, as shown and described.

**DESCRIPTION**  
FIG. 1 is a top and right side perspective view of a pillow constructed according to our new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a side elevational view thereof;  
FIG. 5 is a rear elevational thereof; and,  
FIG. 6 is a cross-sectional view taken along lines 6—6 of FIG. 2.

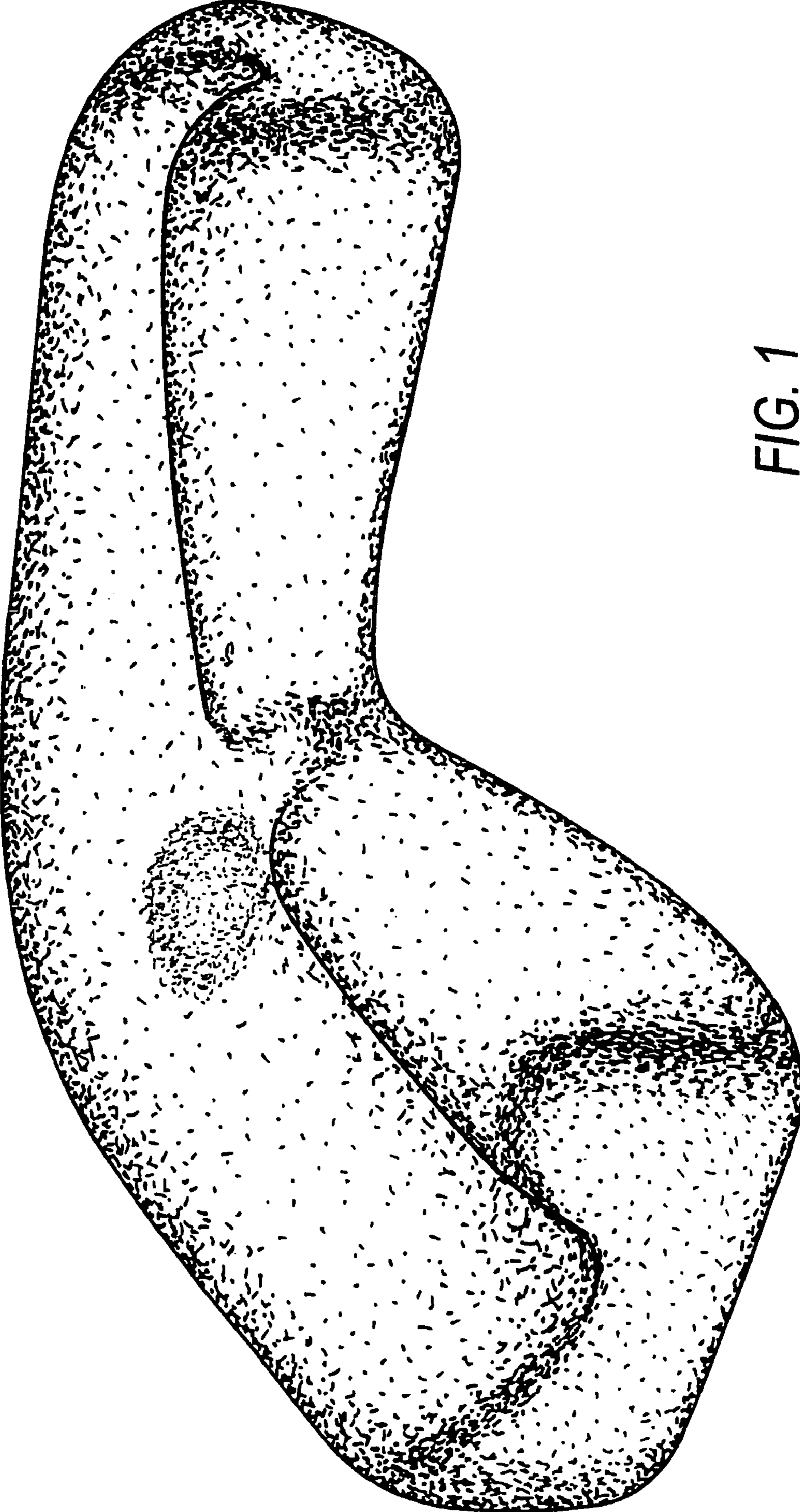

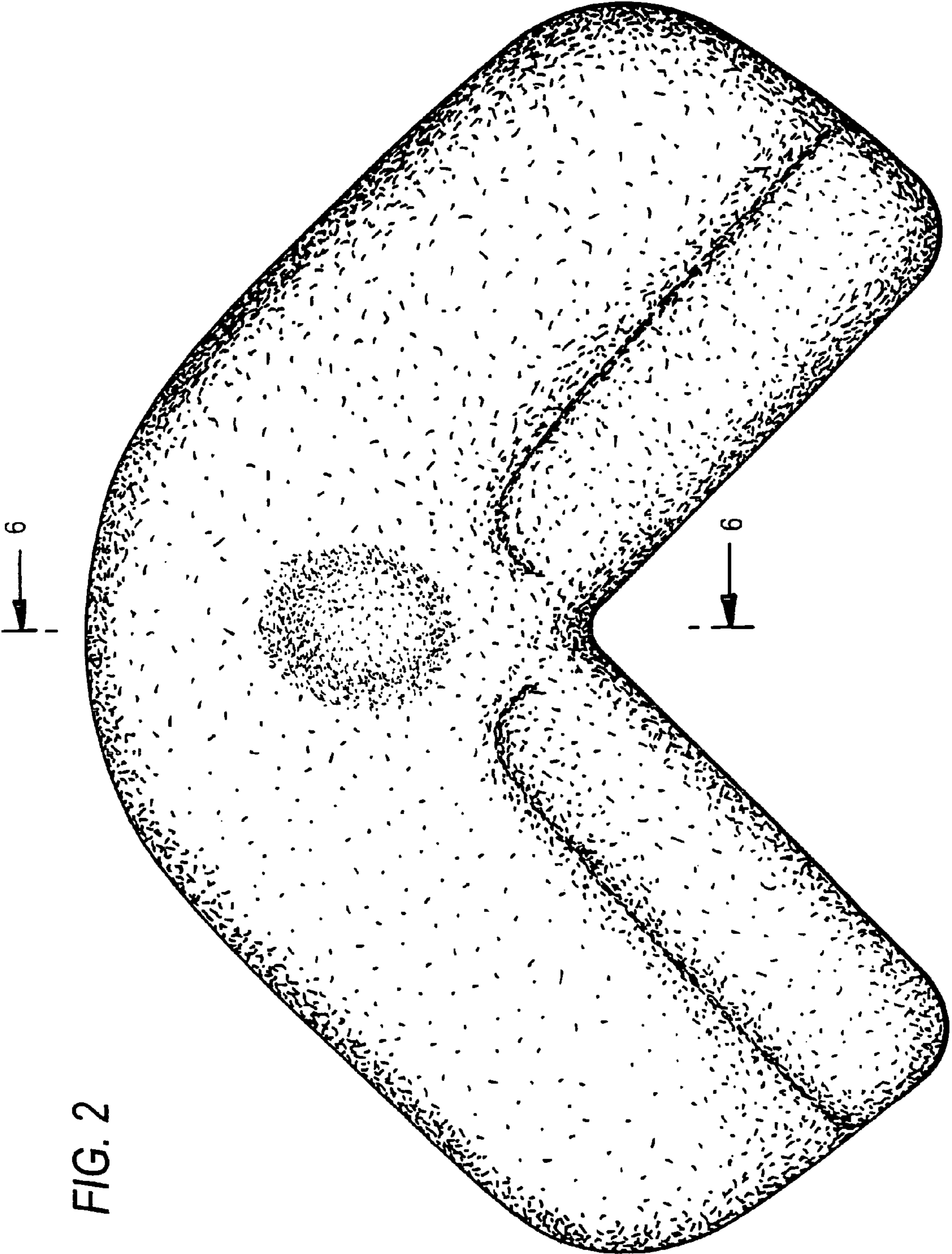

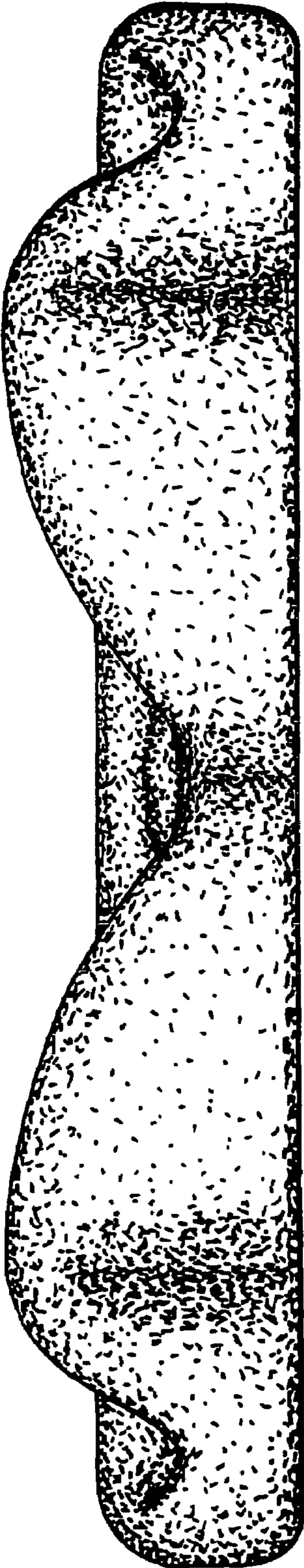

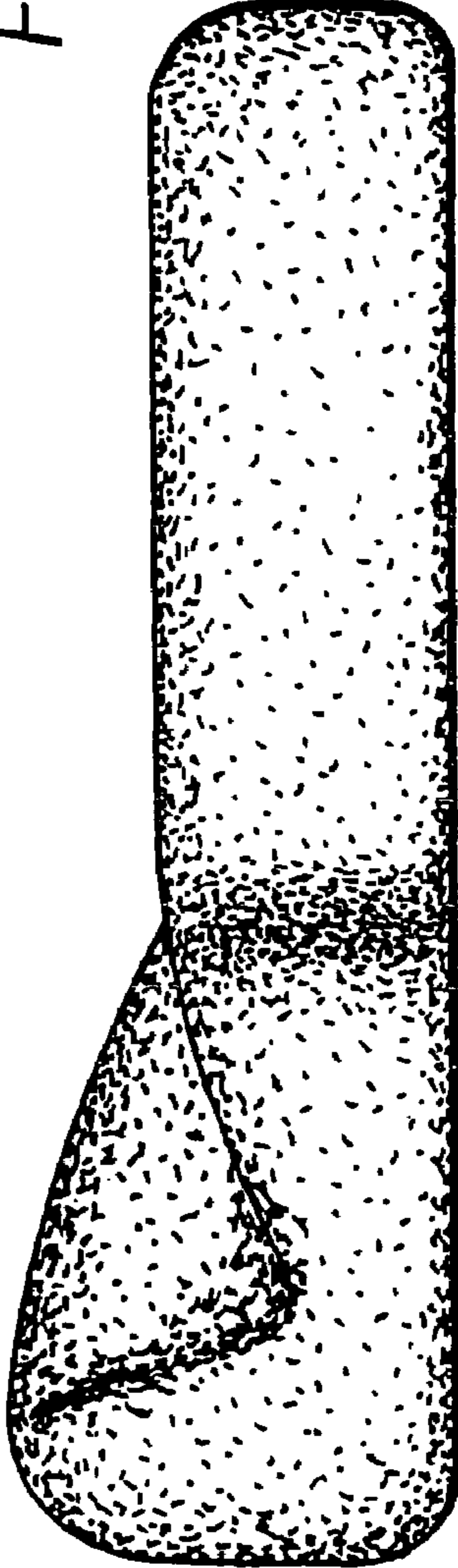

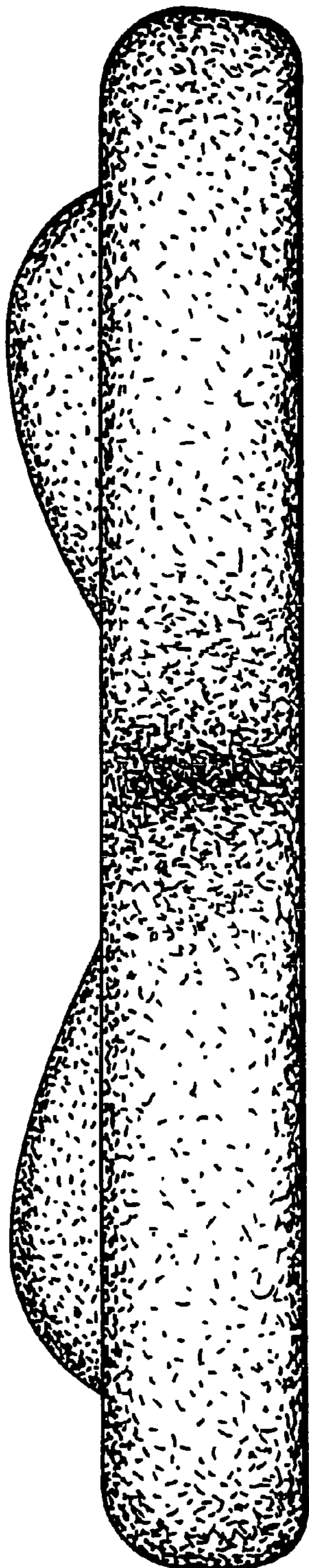
