The ornamental design for a pan assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pan assembly according to my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is an end elevational view thereof, the opposite end view being a mirror image;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a bottom plan view thereof; and,

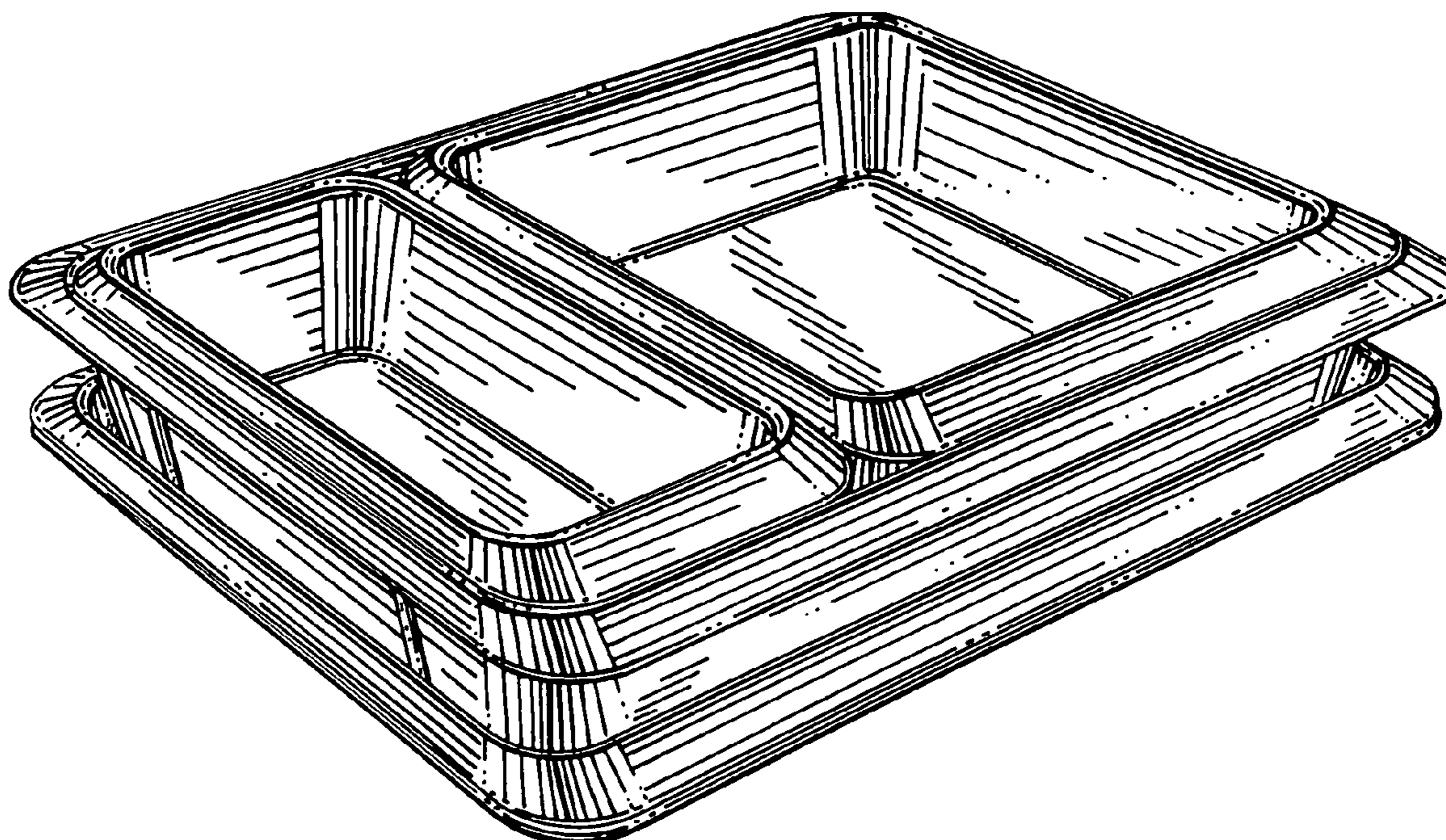

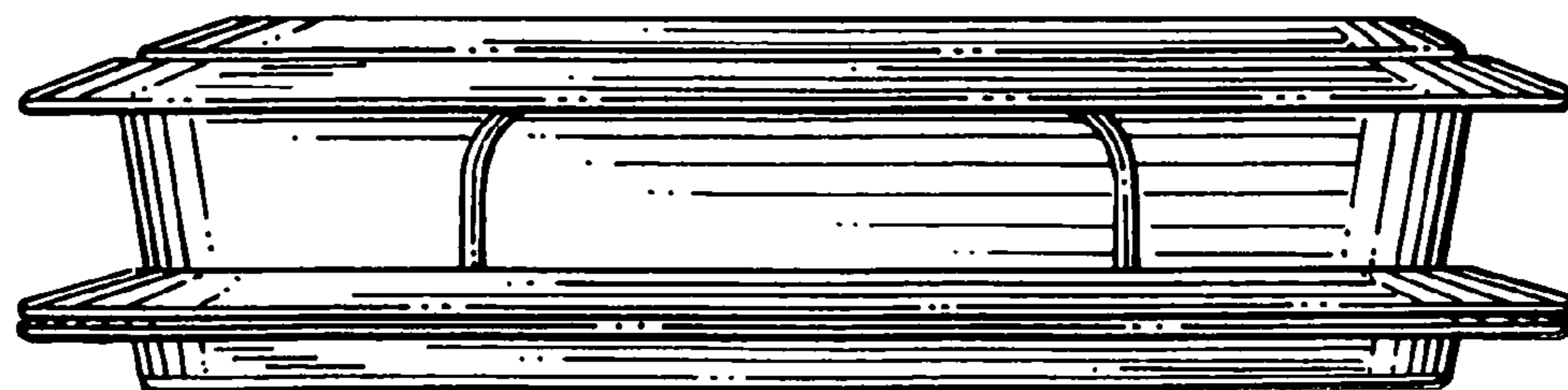
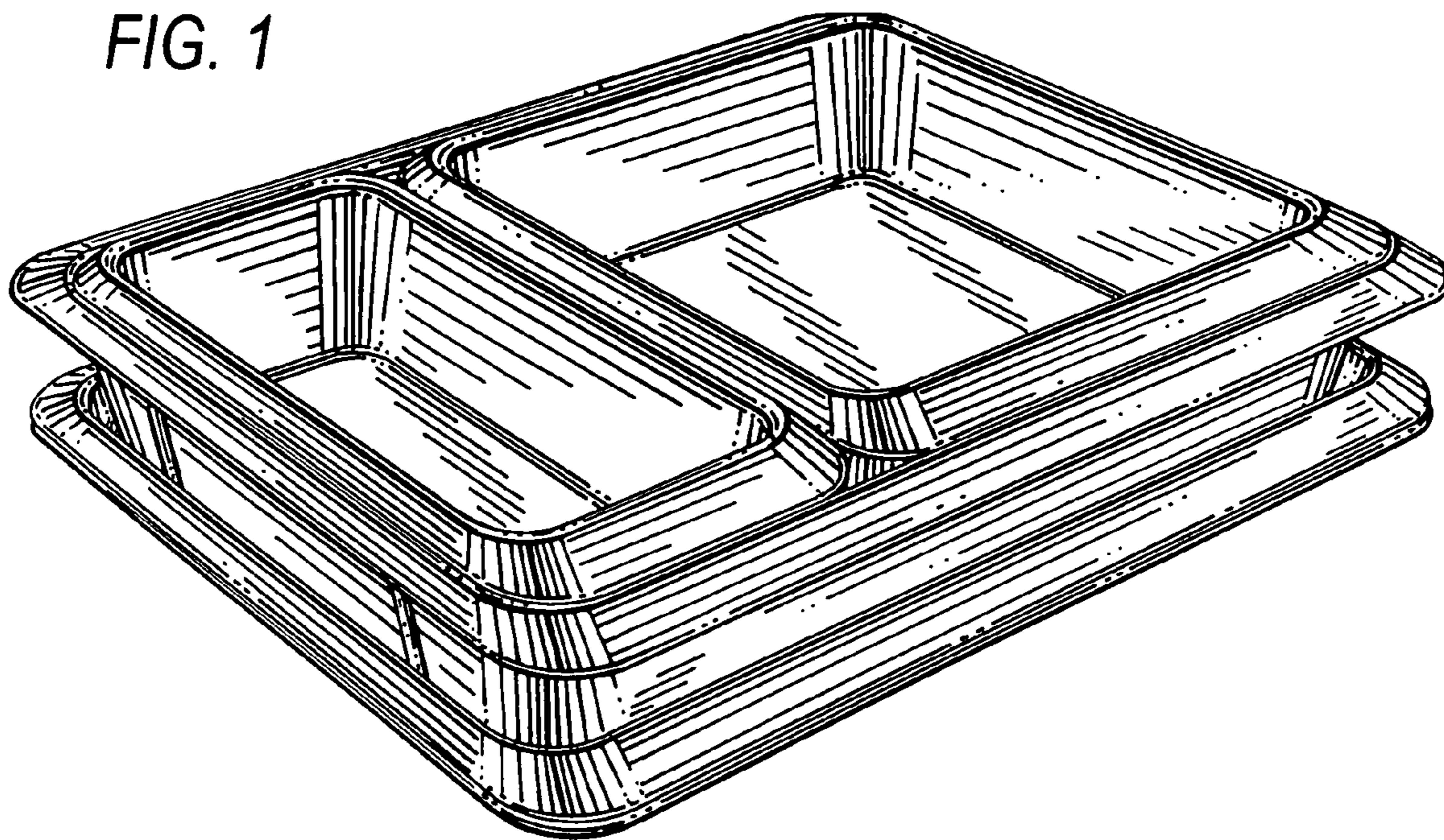

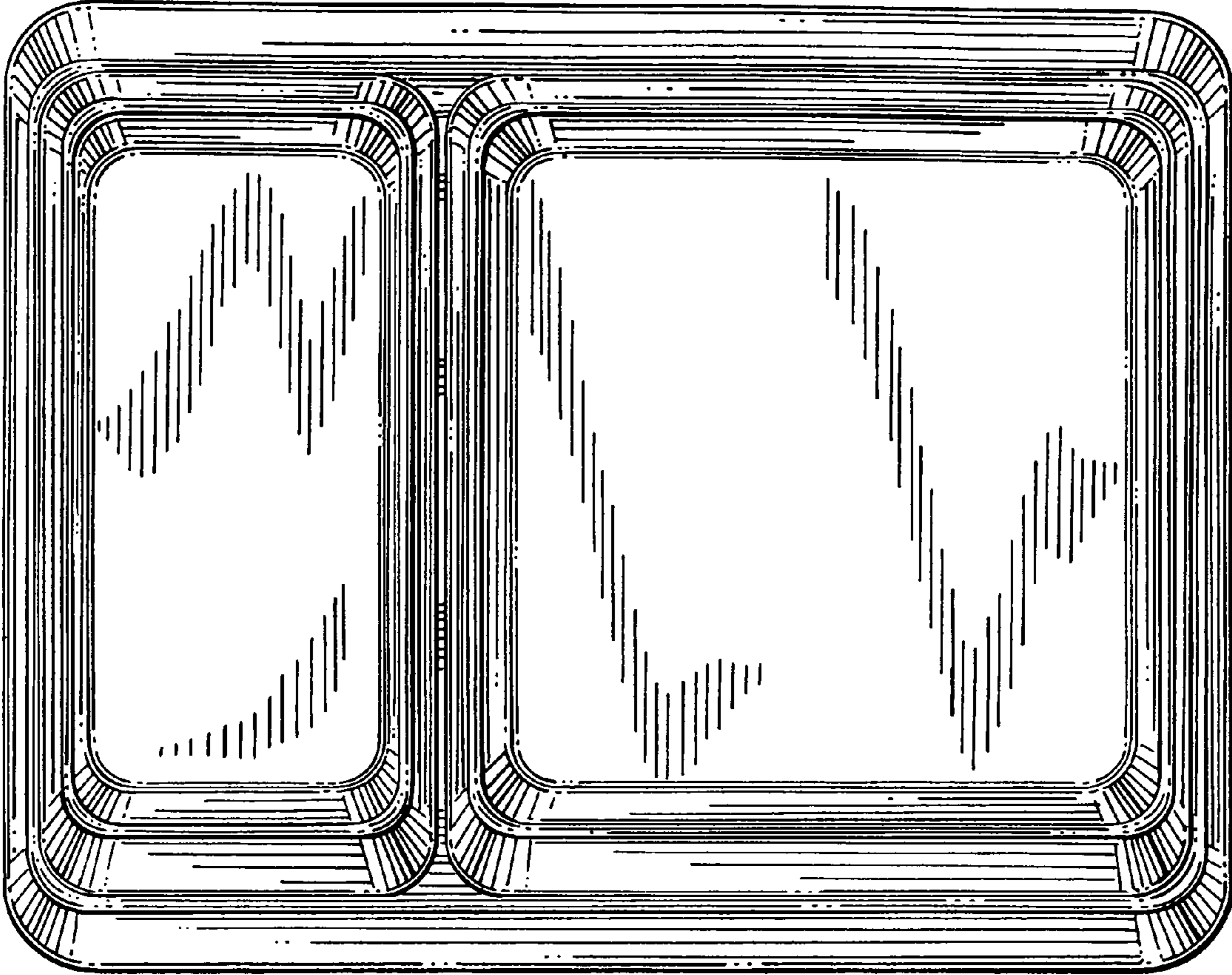

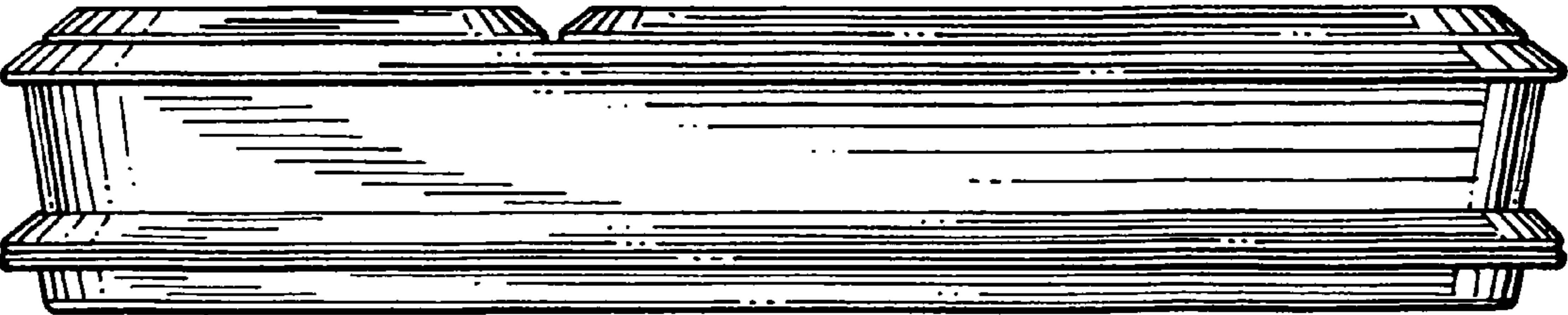

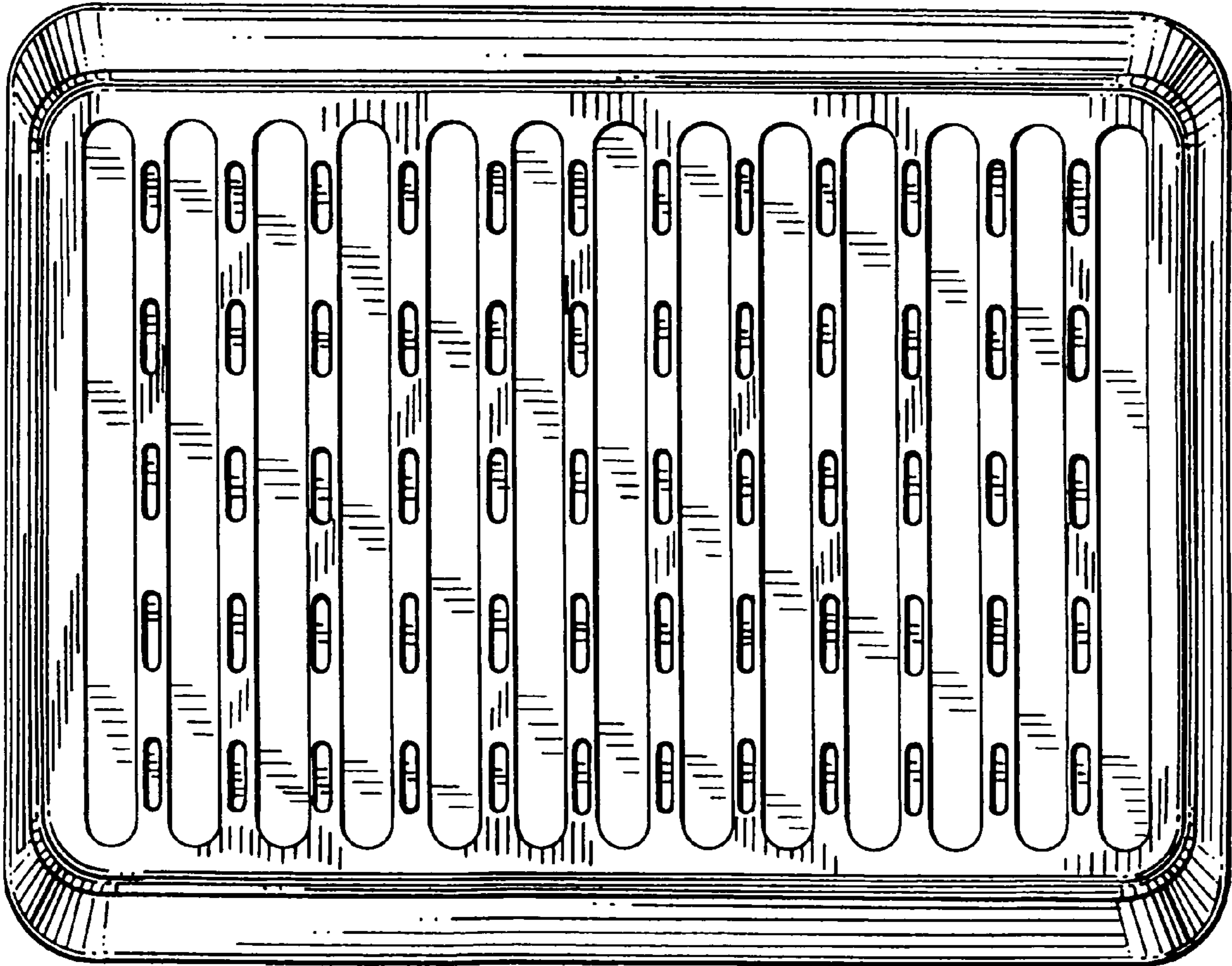
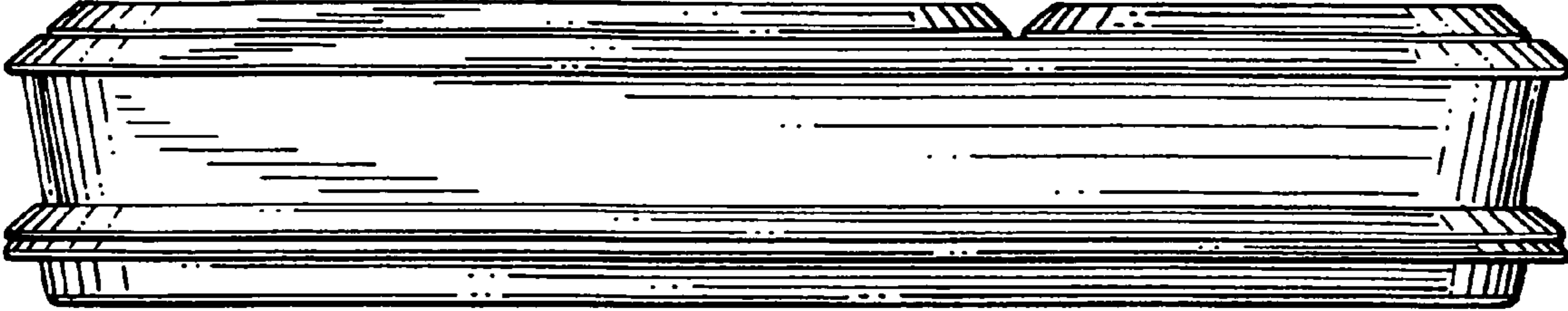
