(57) **CLAIM**

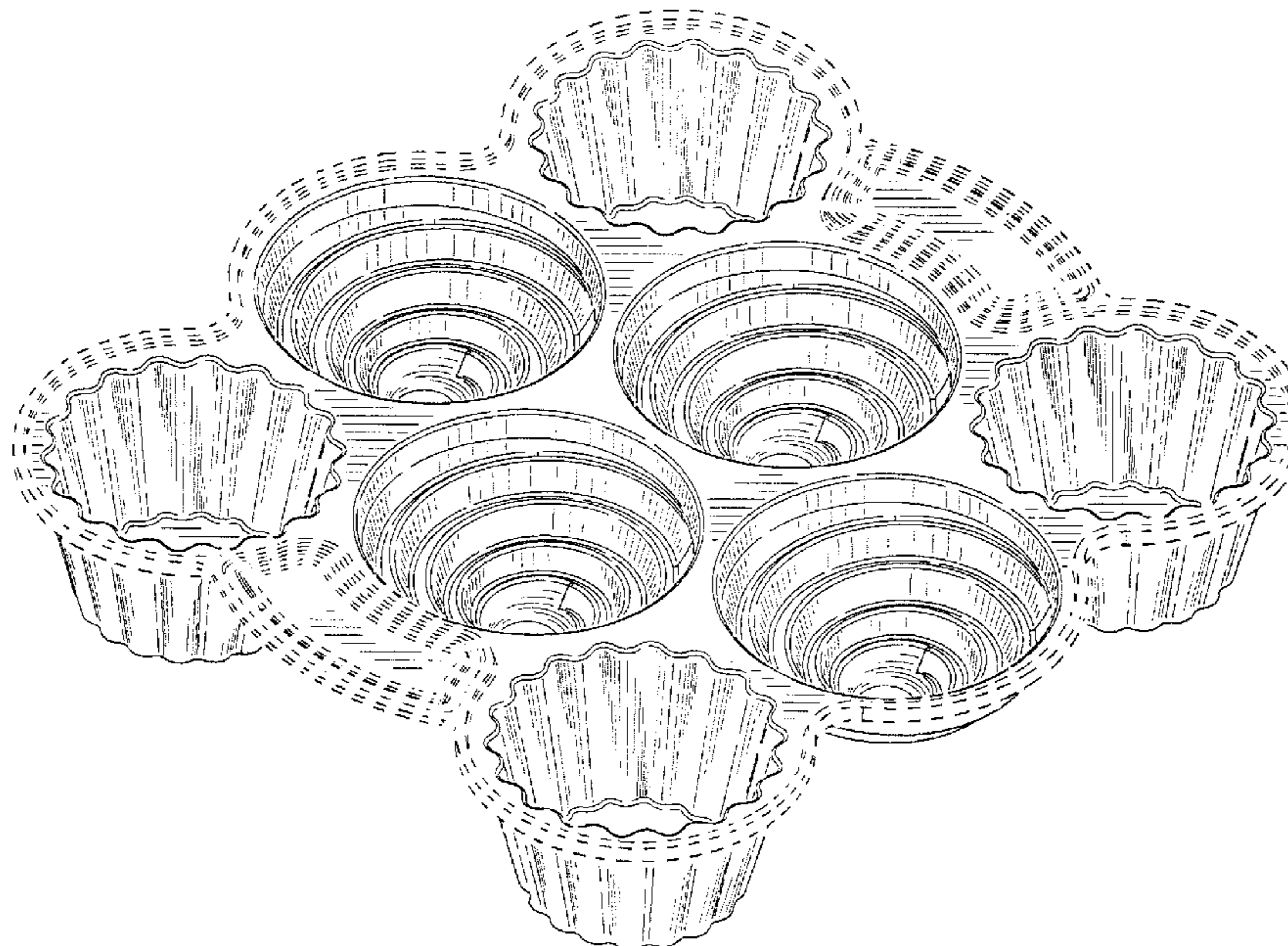
The ornamental design for a cupcake pan, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cupcake pan;
FIG. 2 is a front elevational view of the cupcake pan;

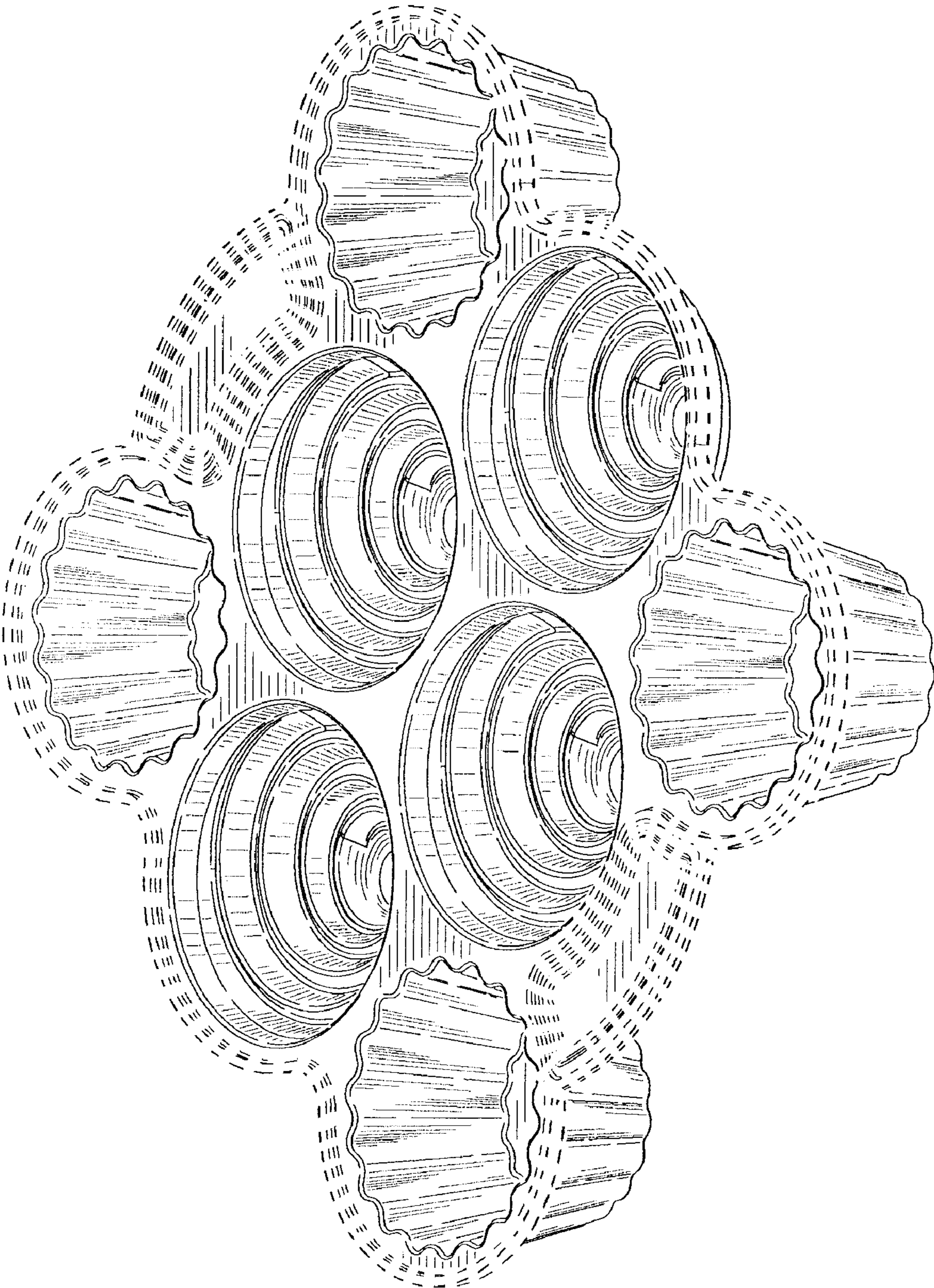

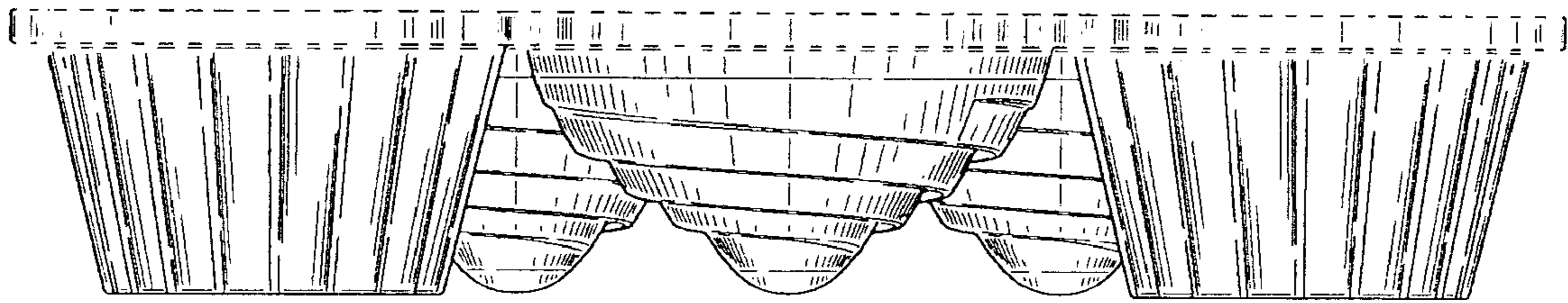

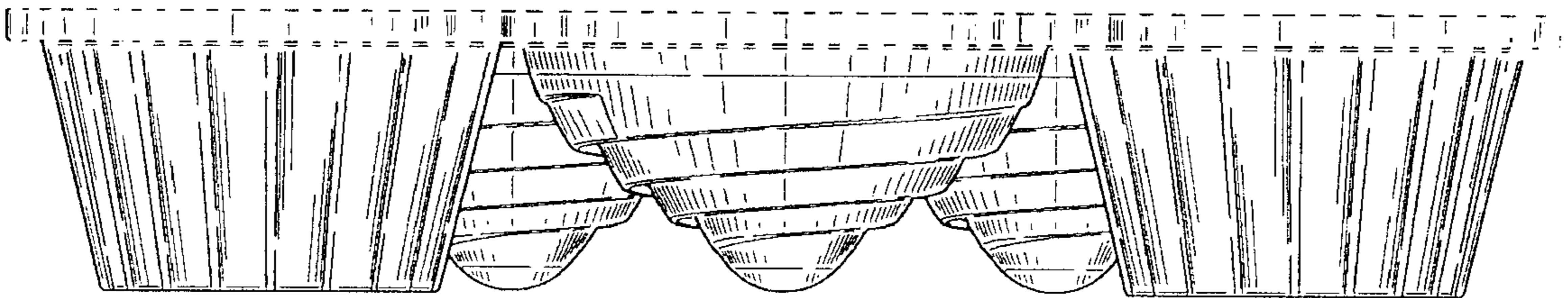

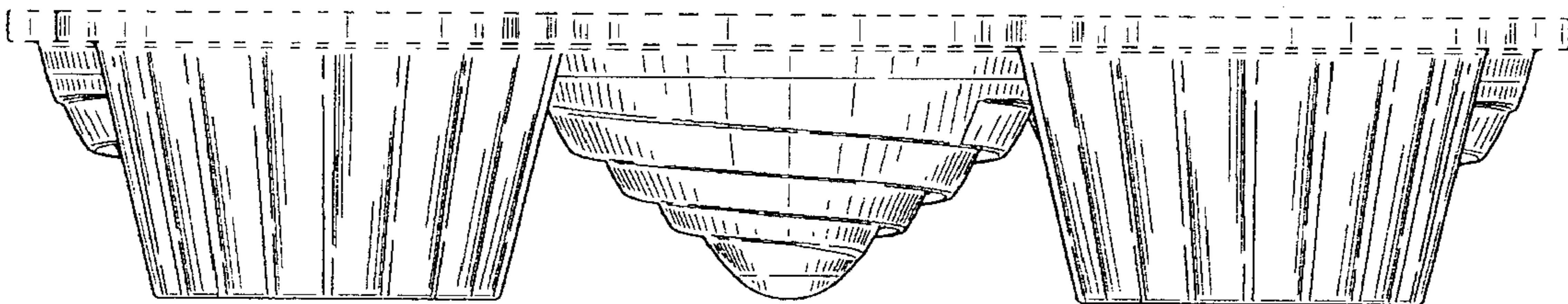

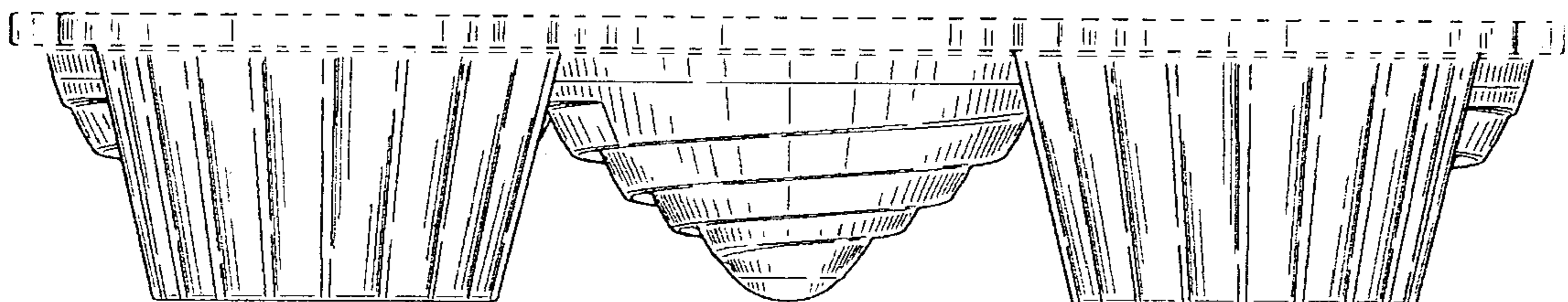

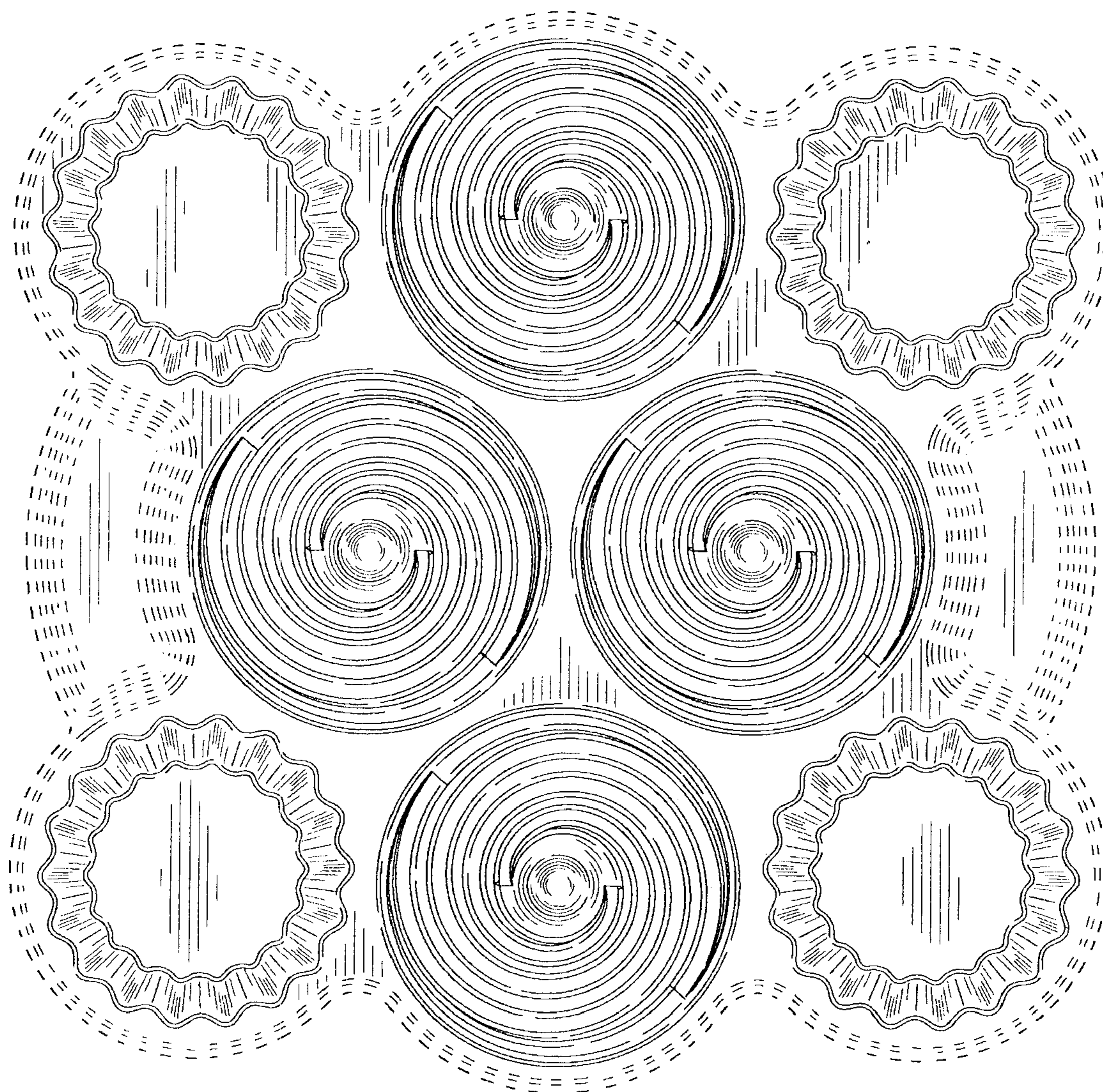

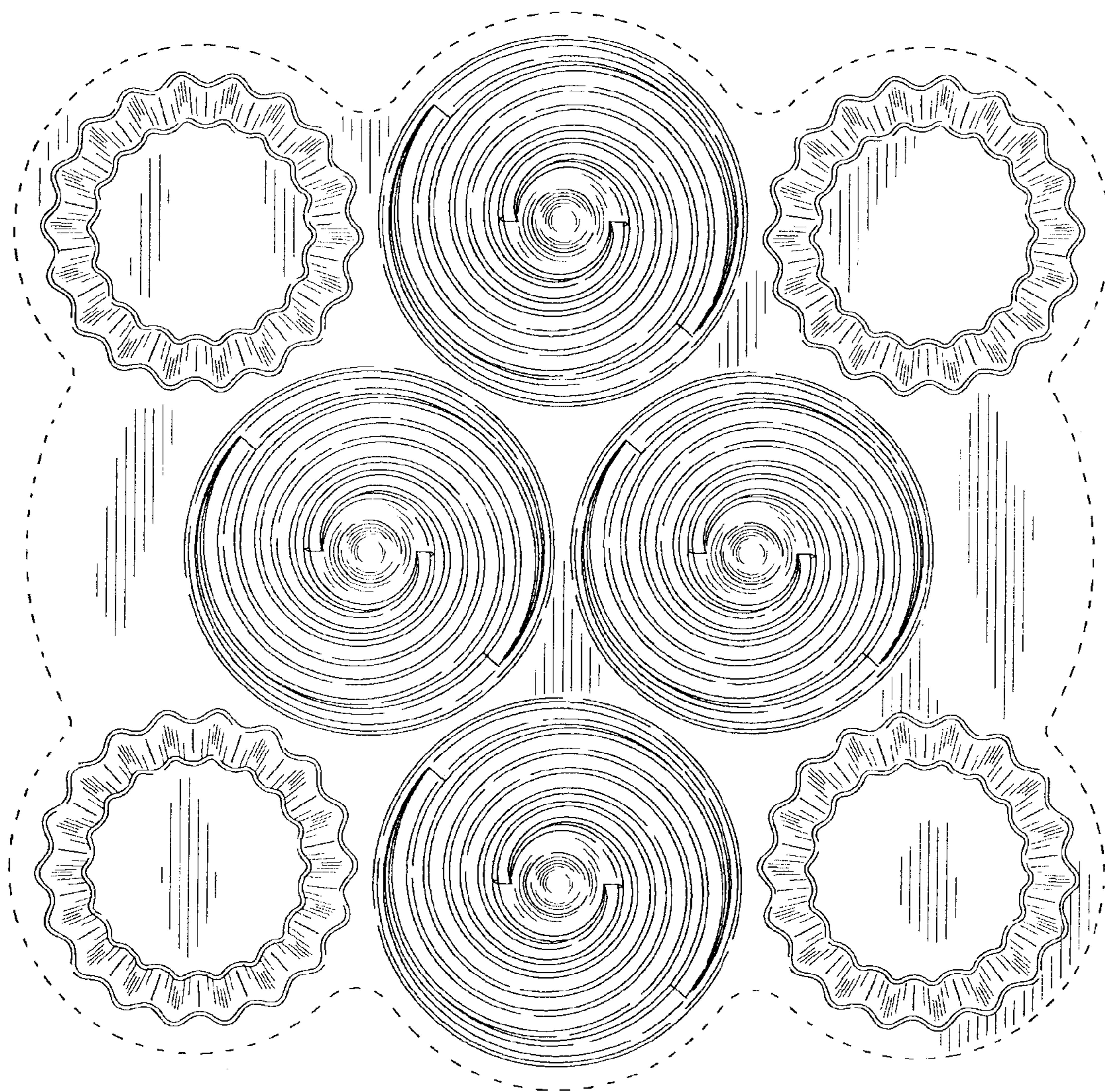
