(57) **CLAIM**

The ornamental design for a handle for a utensil, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a handle for a utensil for being attached to a lid of a kitchen appliance in accordance with my new design;

FIG. 2 is a left-side elevation view of the handle shown in FIG. 1;

FIG. 3 is a right-side elevation view of the handle shown in FIG. 1;

FIG. 4 is a front elevation view of the handle shown in FIG. 1;

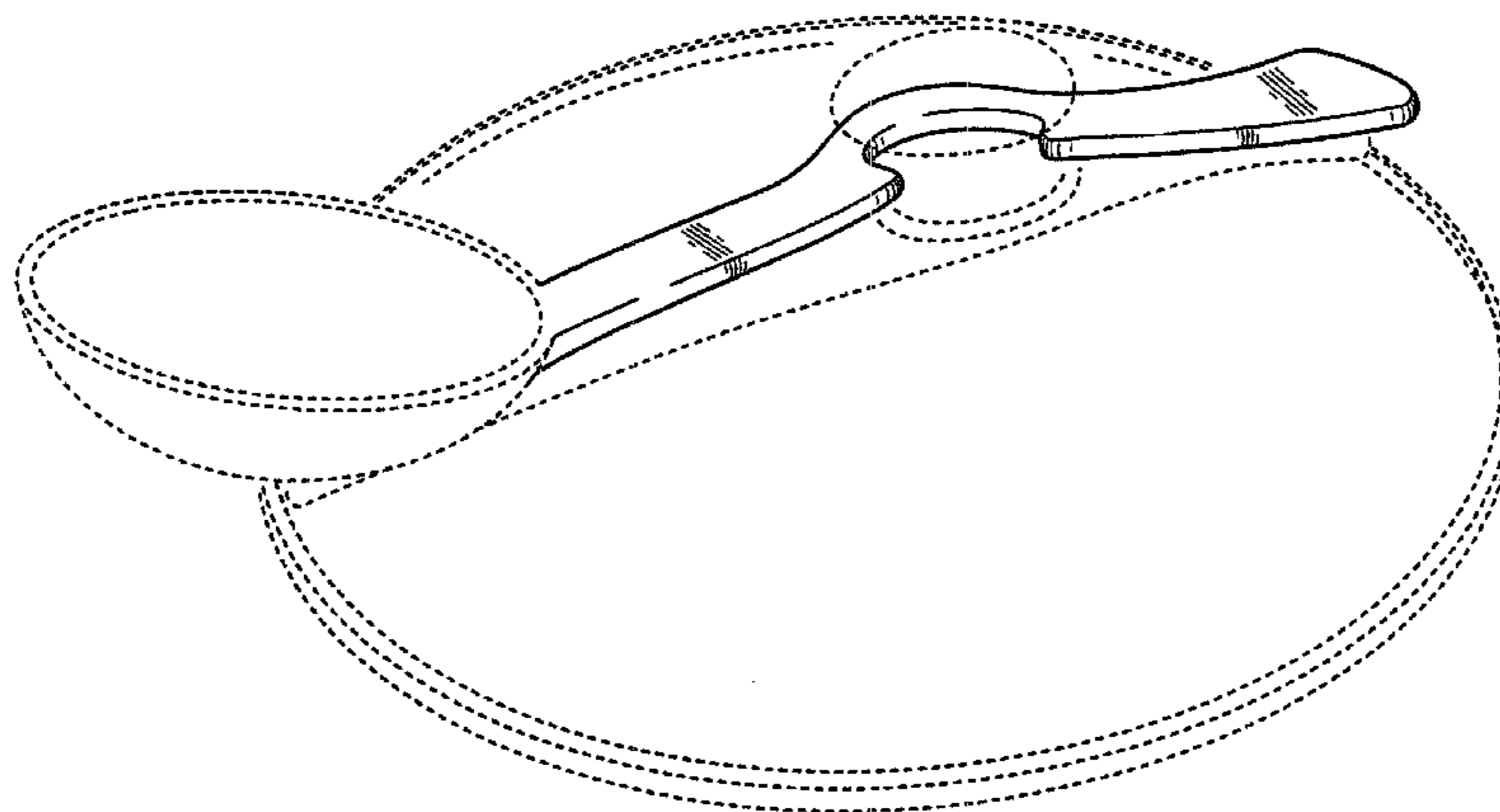
FIG. 5 is a rear elevation view of the handle shown in FIG. 1;

FIG. 6 is a top plan view of the spoon handle in FIG. 1; and,

FIG. 7 is a bottom plan view of the handle shown in FIG. 1.

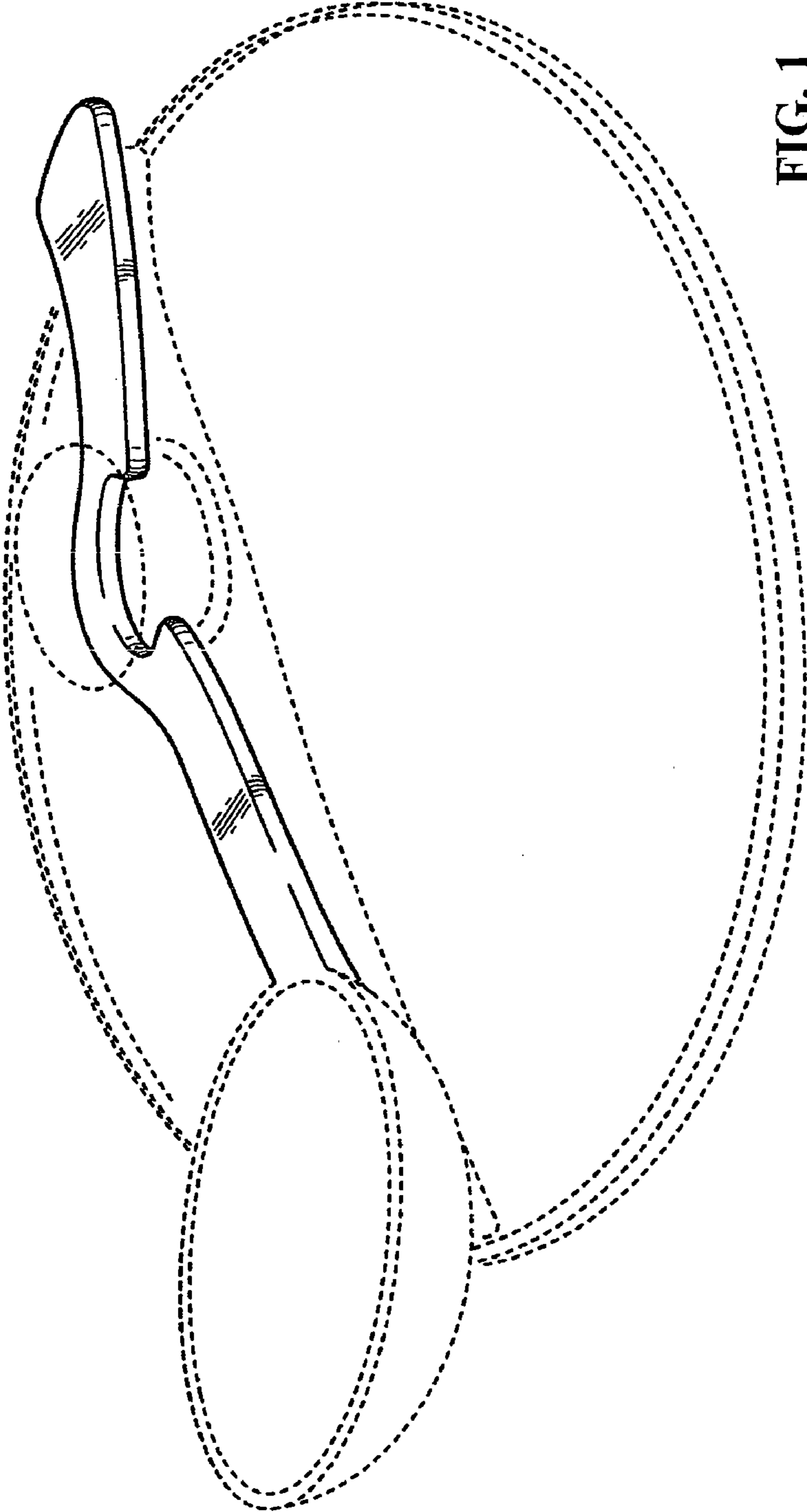

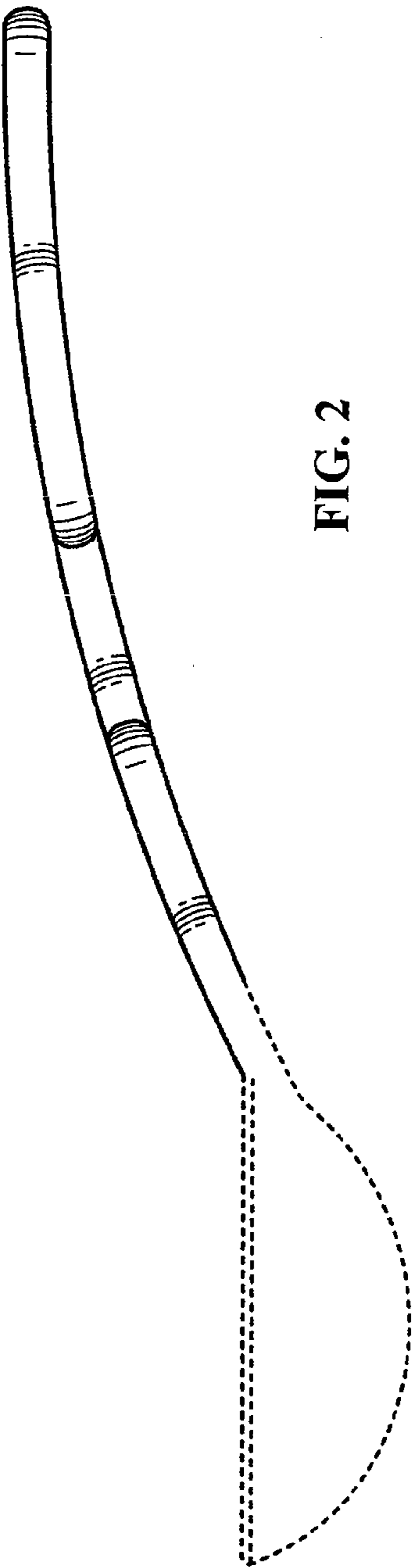

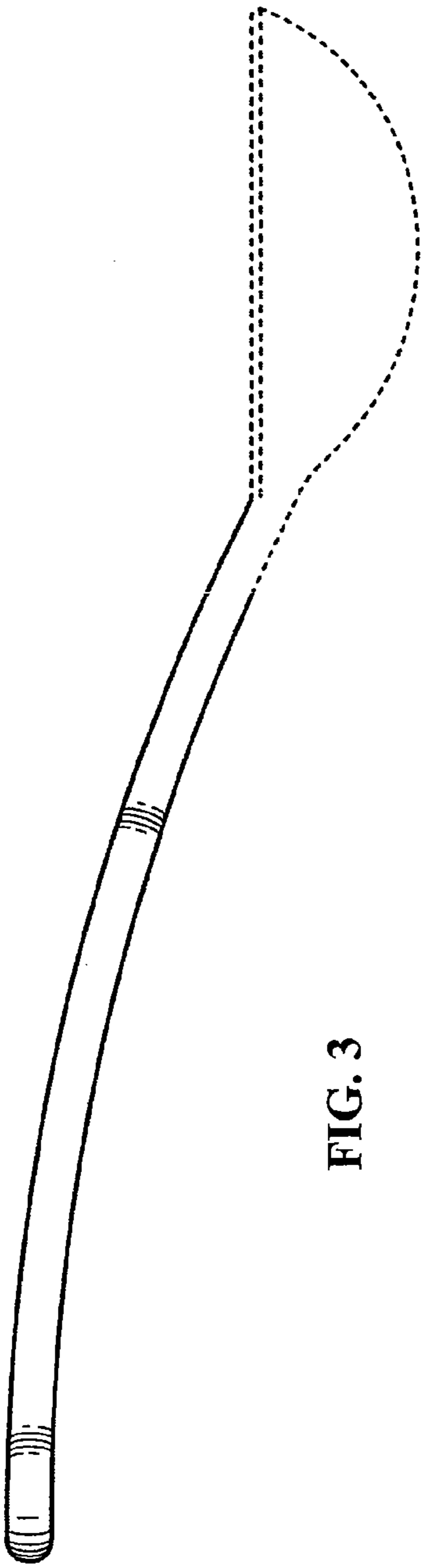

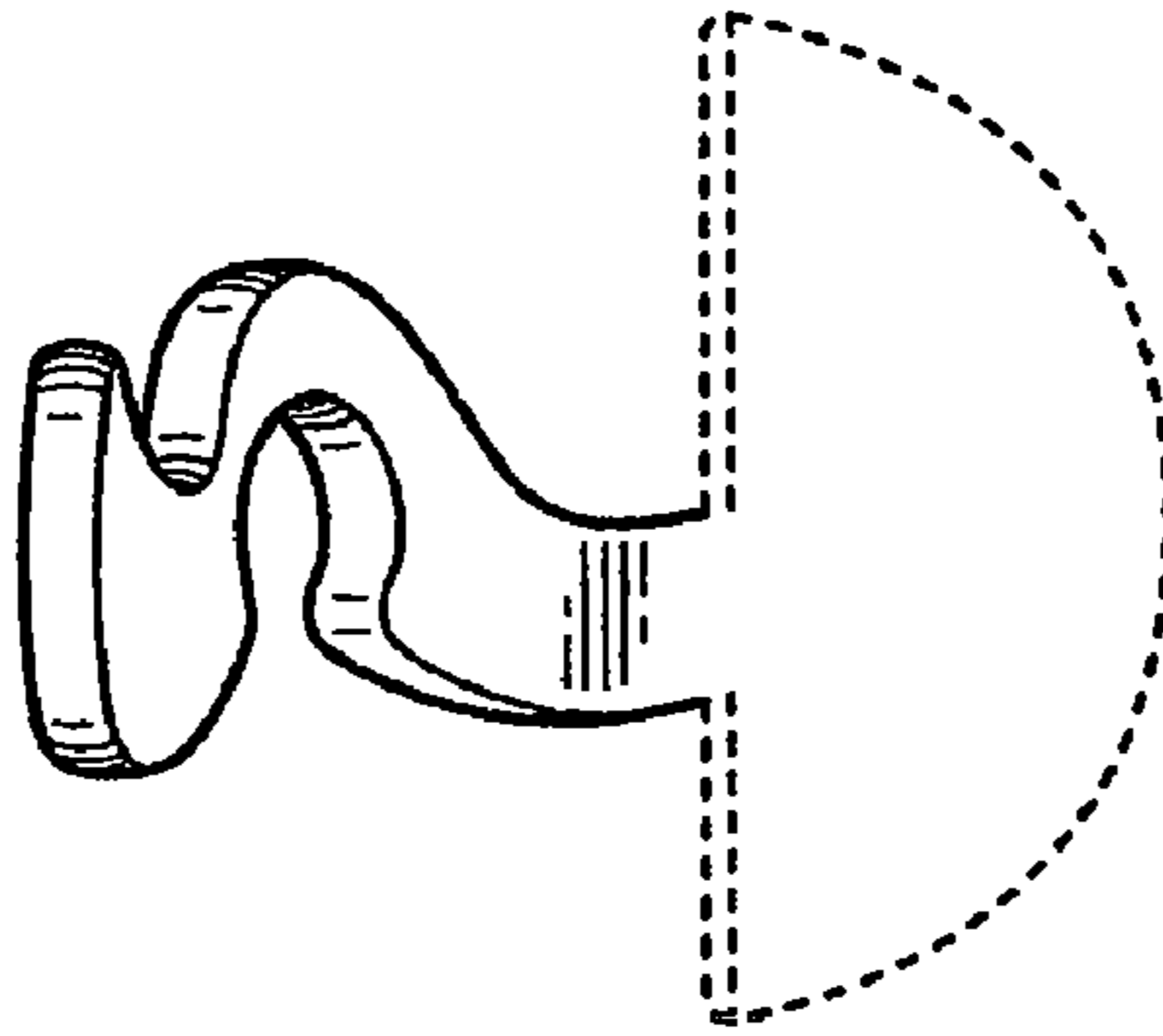

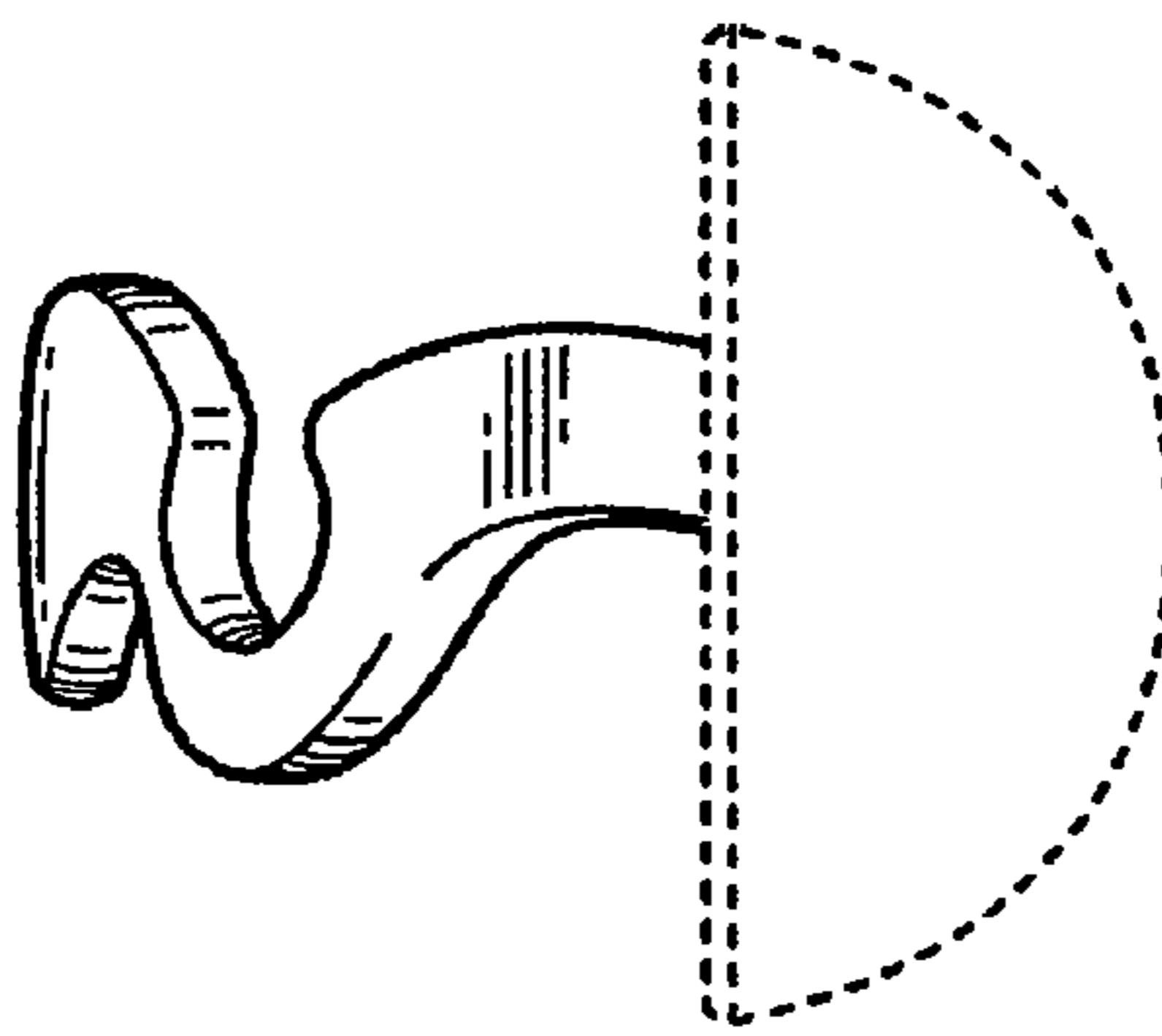

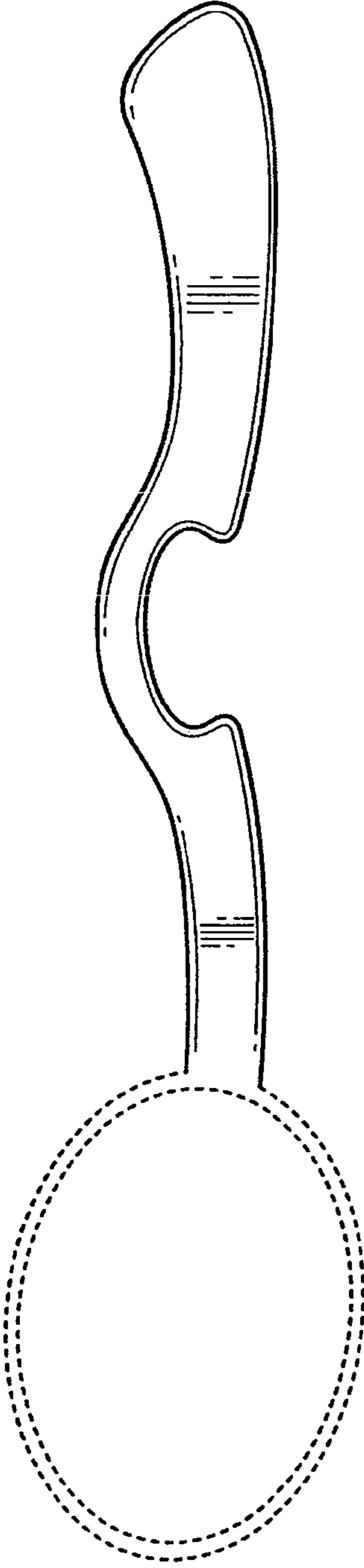

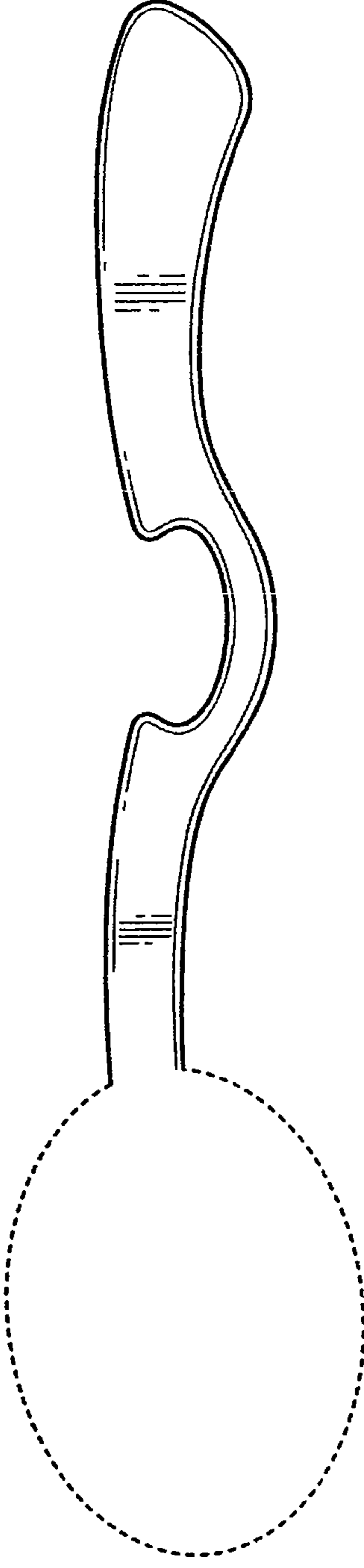
