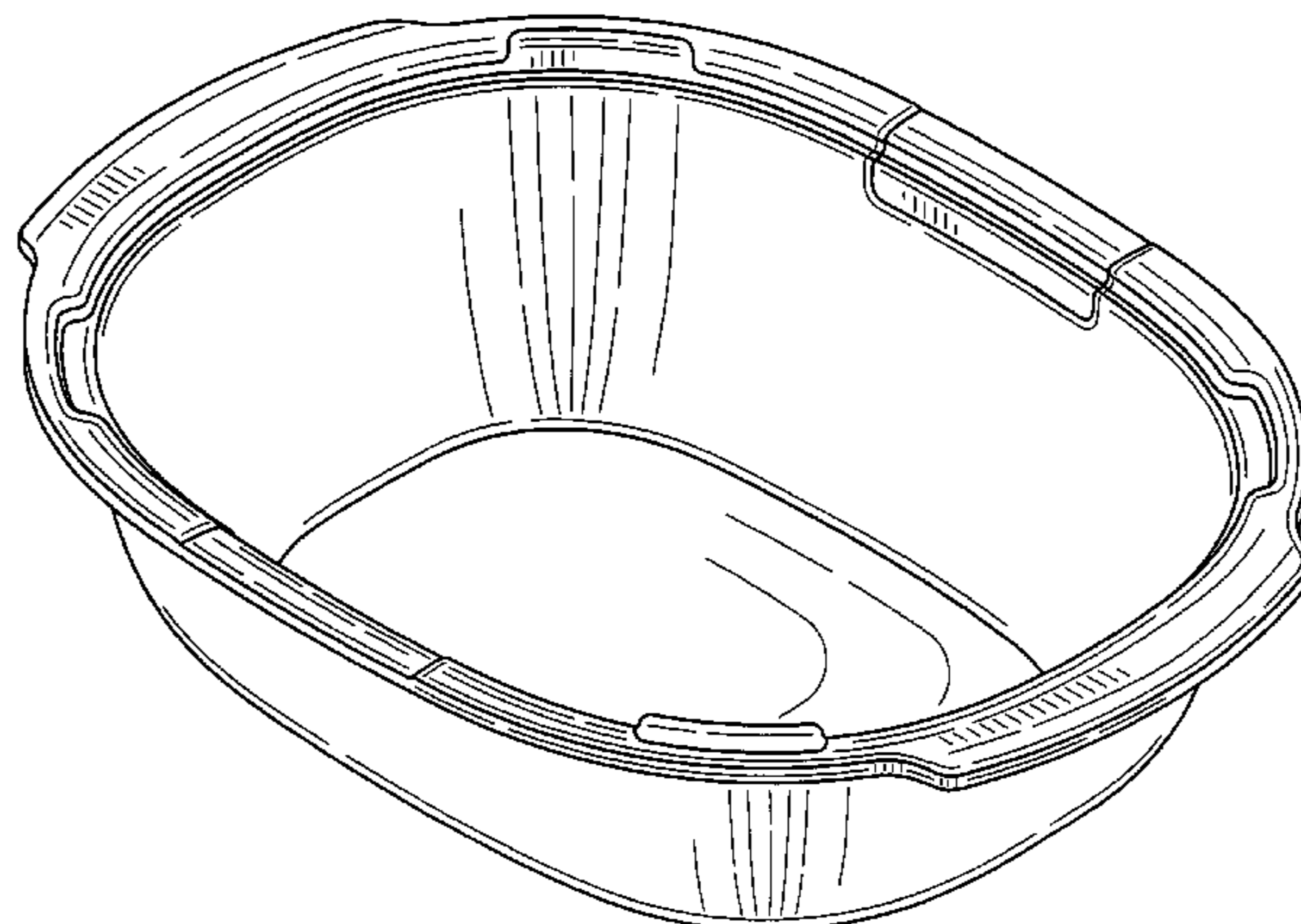
(57) **CLAIM**

The ornamental design for a casserole dish, as shown and described.

DESCRIPTION

- FIG. 1 is a top, side and front perspective view of a casserole dish showing my new design;
- FIG. 2 is a front elevation view, the rear elevation being identical thereto;
- FIG. 3 is a right side elevation view, the left side being identical thereto;
- FIG. 4 is a top plan view thereof;
- FIG. 5 is a bottom plan view thereof;
- FIG. 6 is a bottom, side and rear perspective view thereof;
- FIG. 7 is a top, side and front perspective view of a modified embodiment of the design shown in FIGS. 1 through 6;
- FIG. 8 is a front elevation view, the rear elevation being identical thereto;
- FIG. 9 is a right side elevation view, the left side being identical thereto;
- FIG. 10 is a top plan view thereof;
- FIG. 11 is a bottom plan view thereof; and,
- FIG. 12 is a bottom, side and rear perspective view thereof.

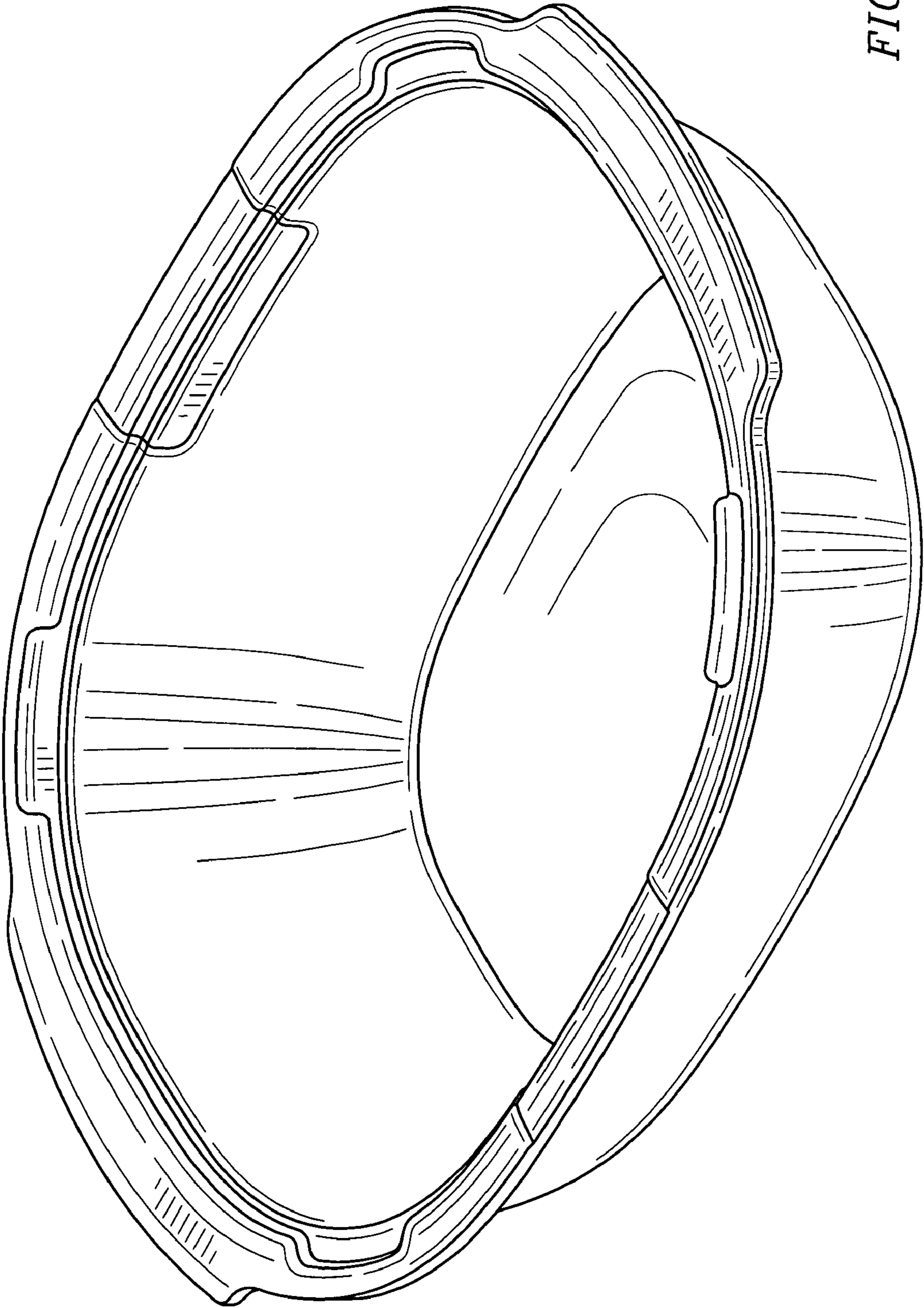

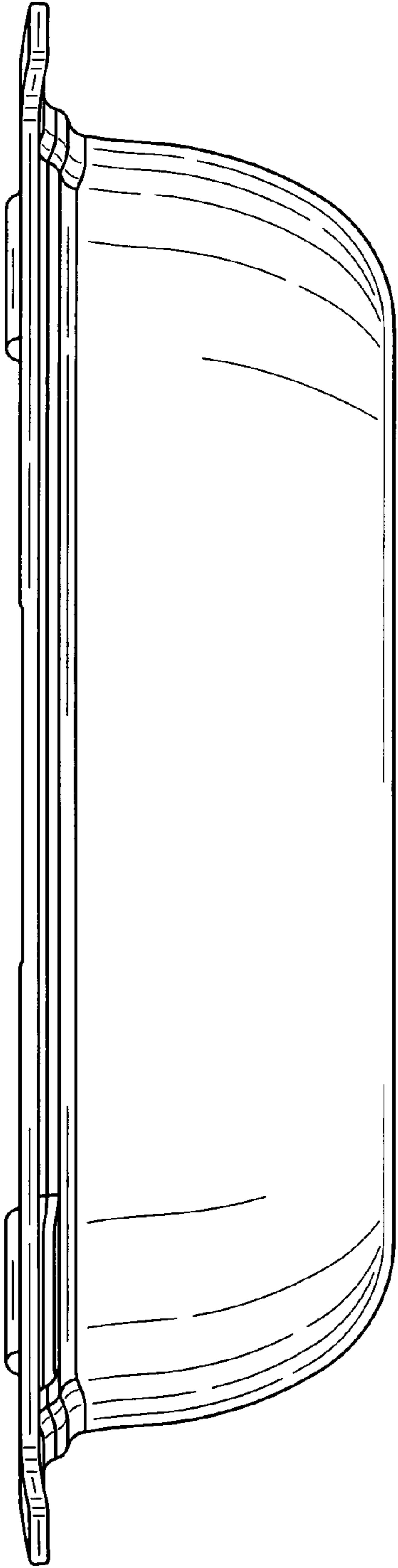

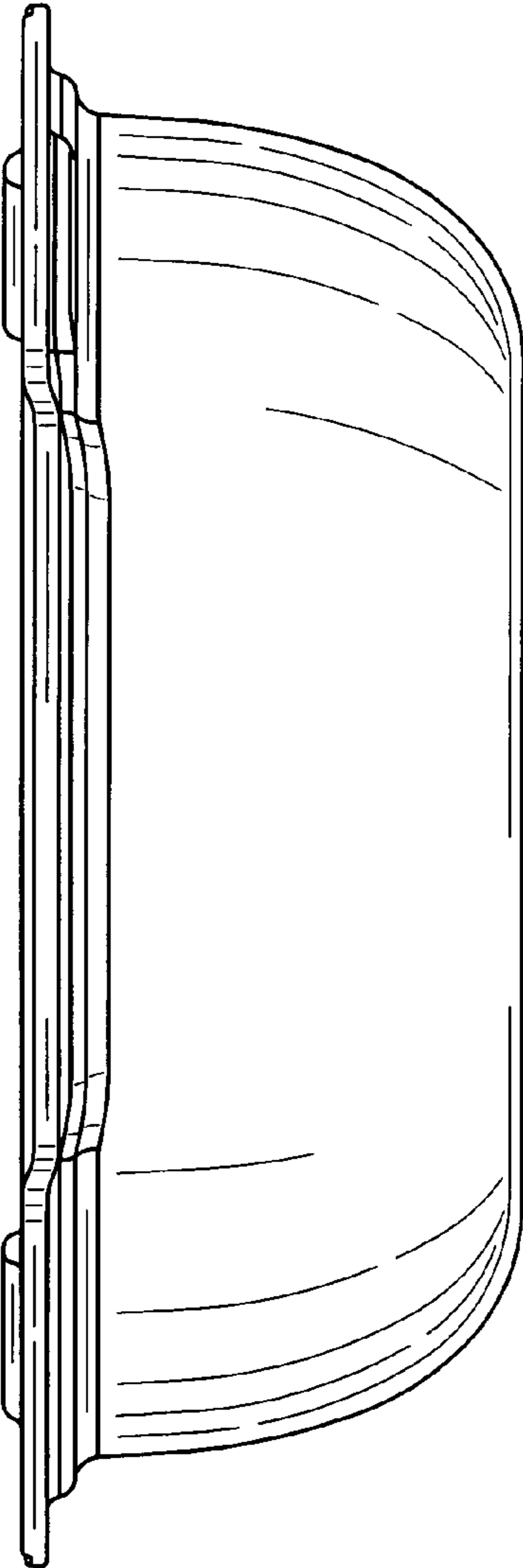

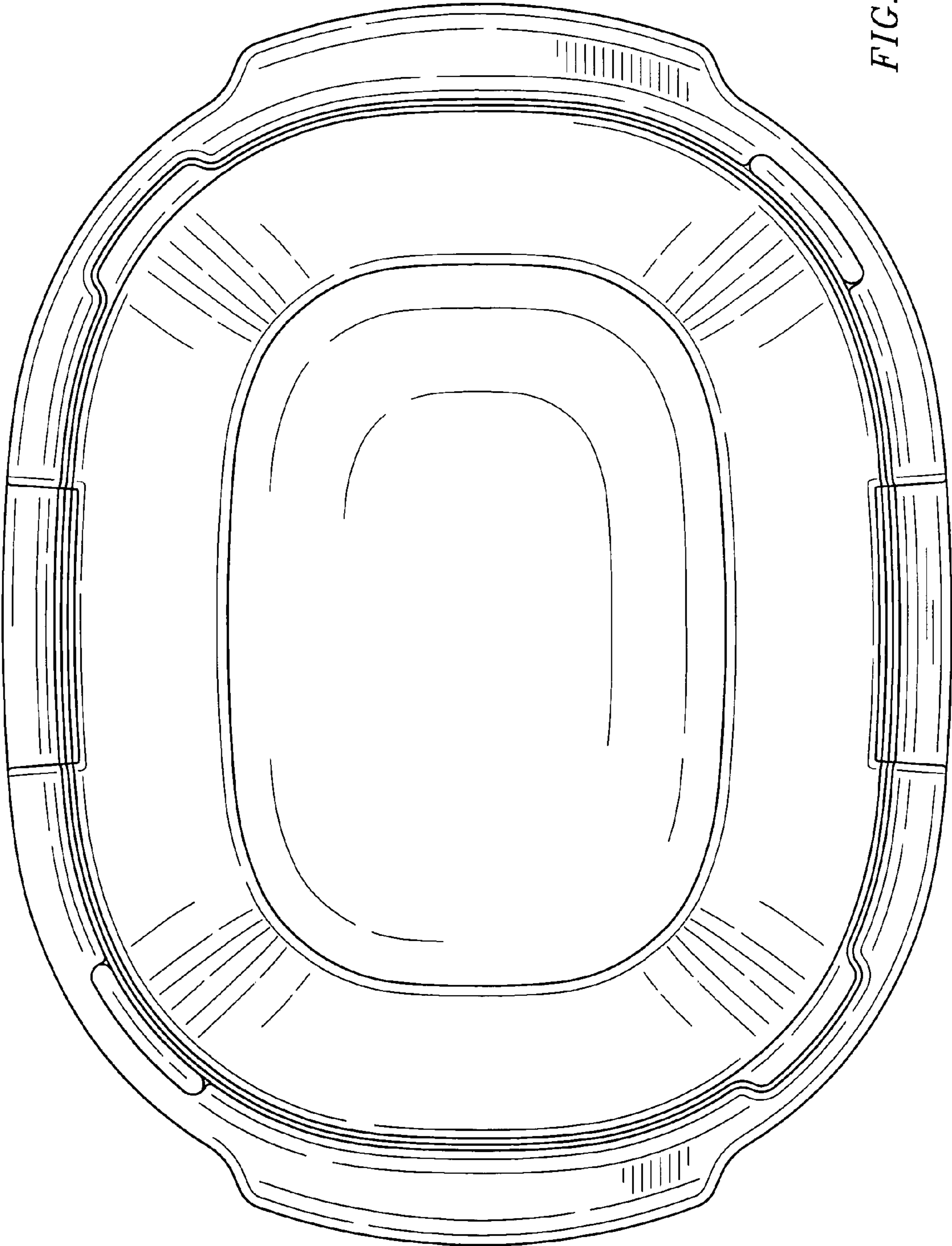

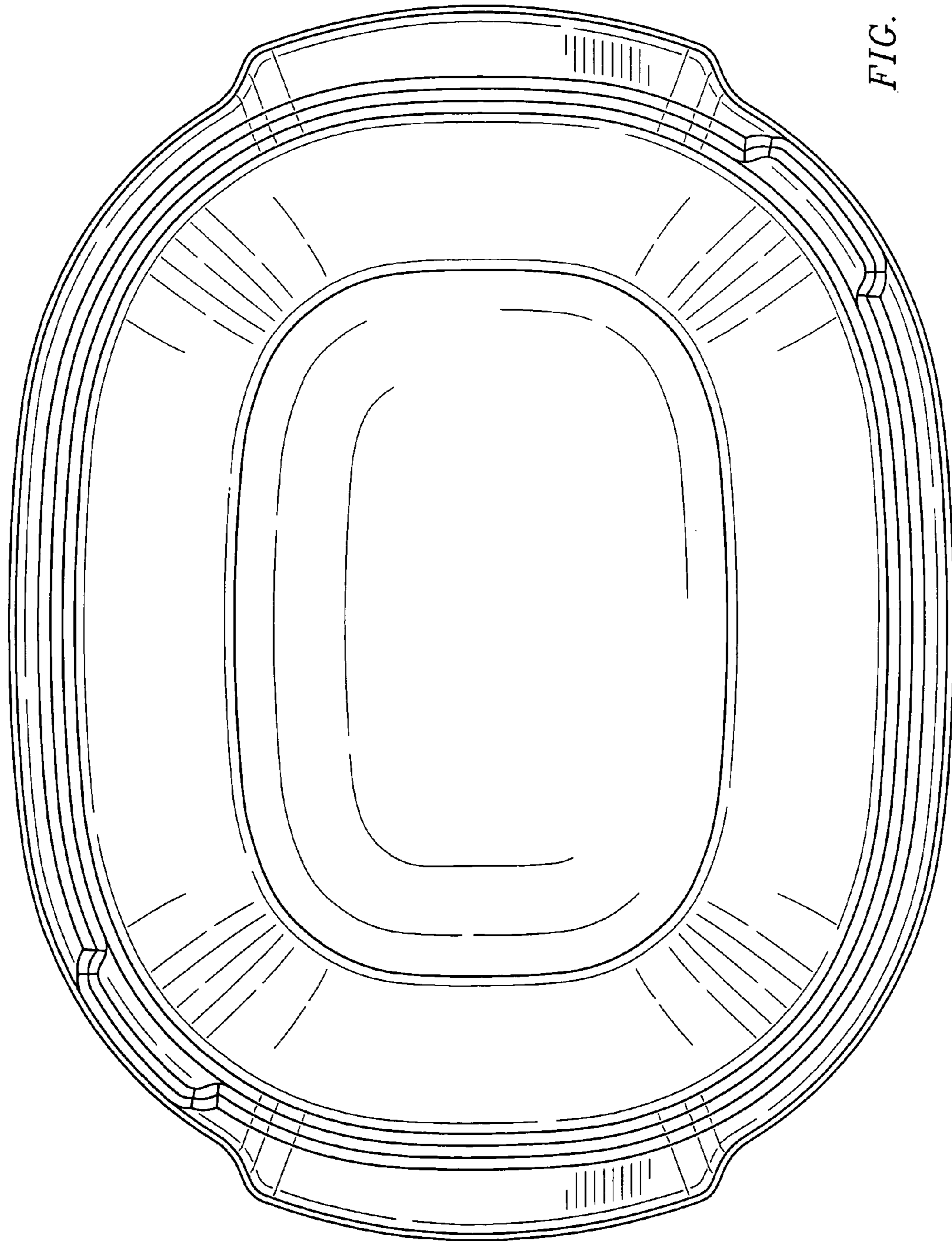

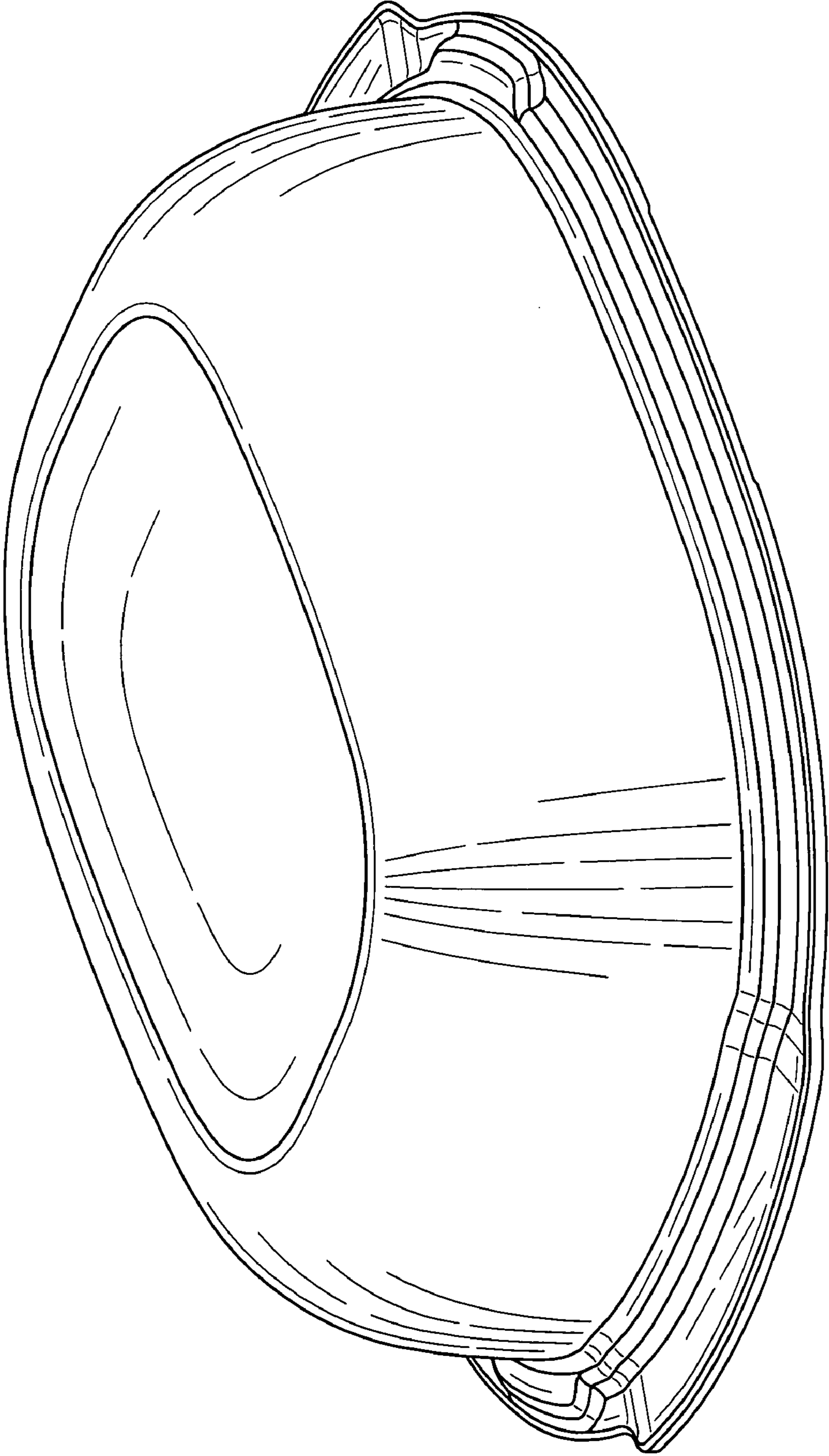
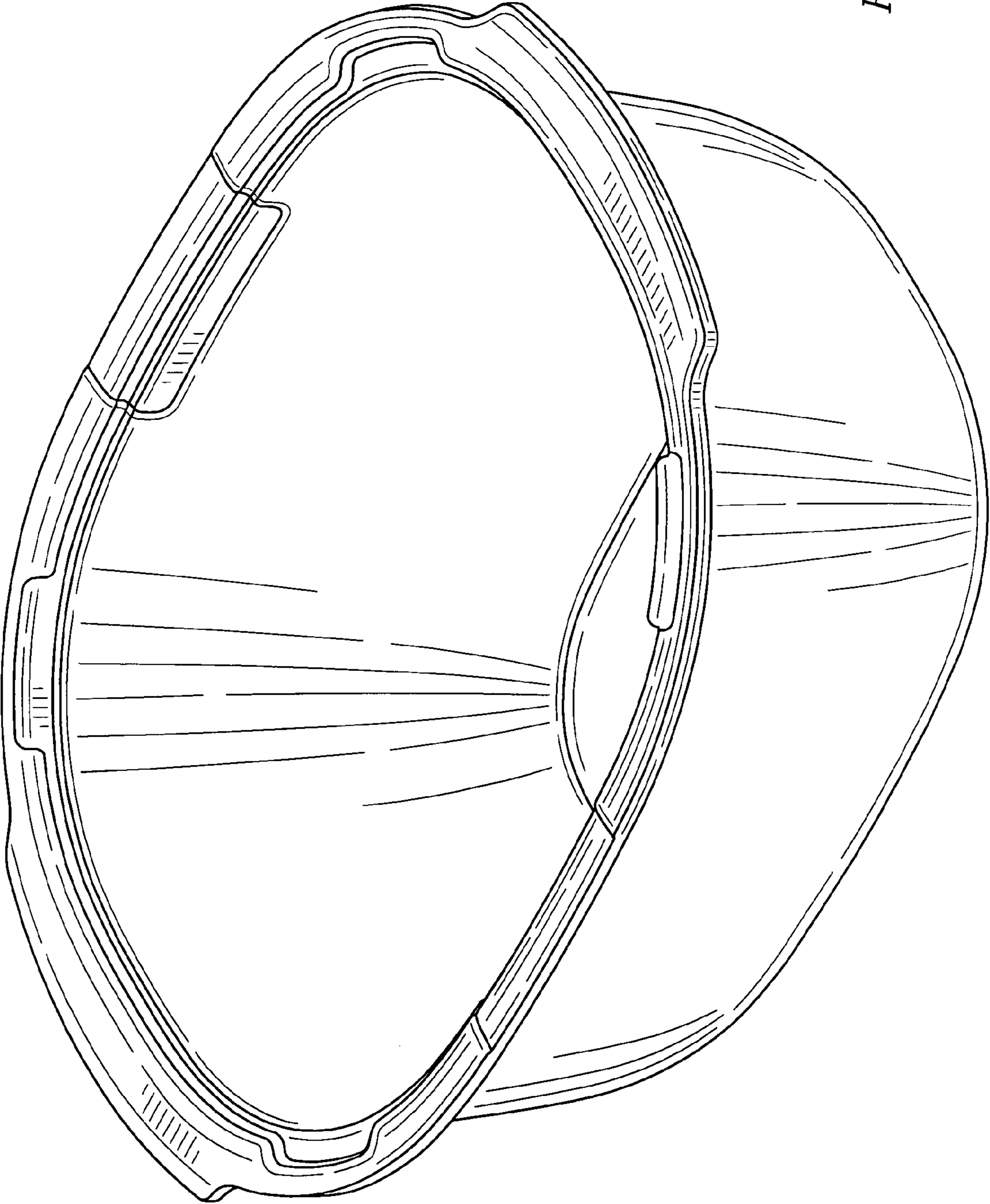

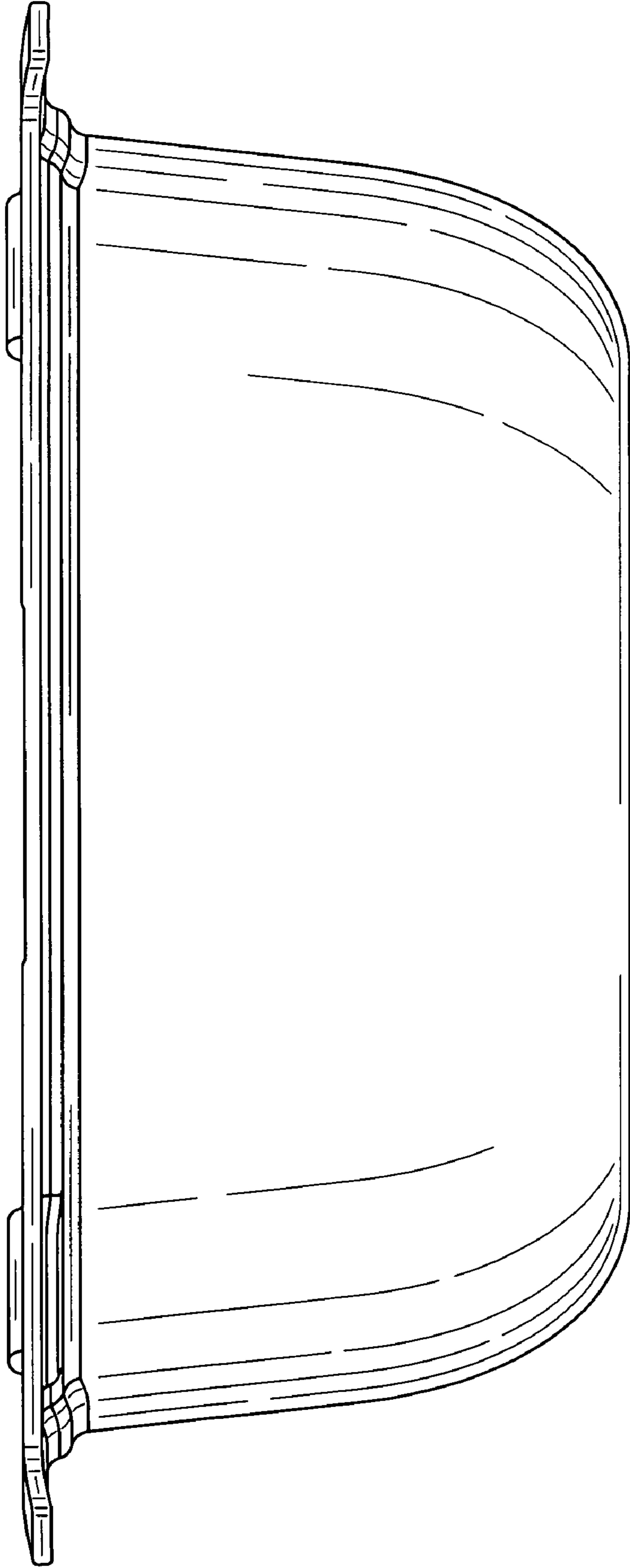

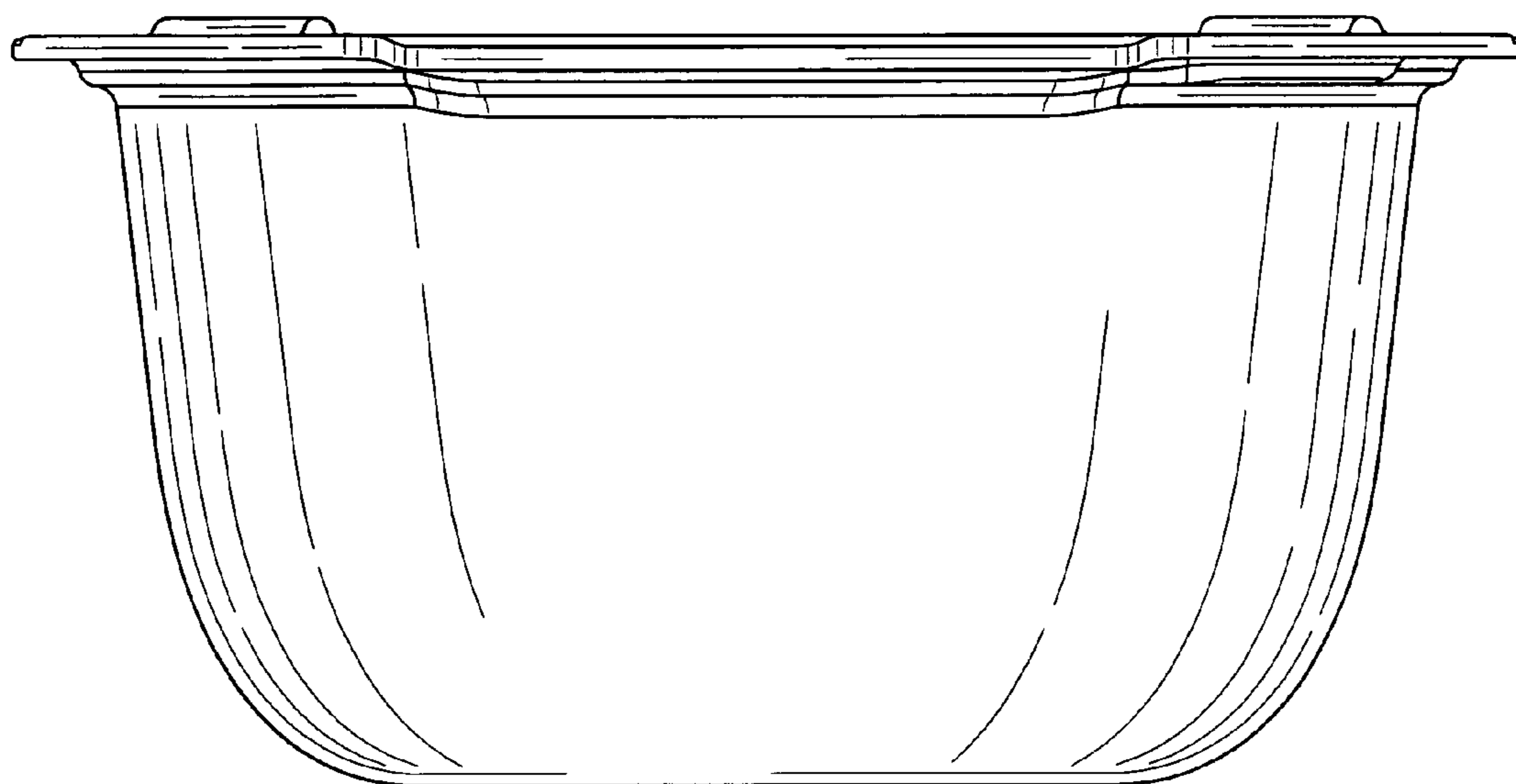

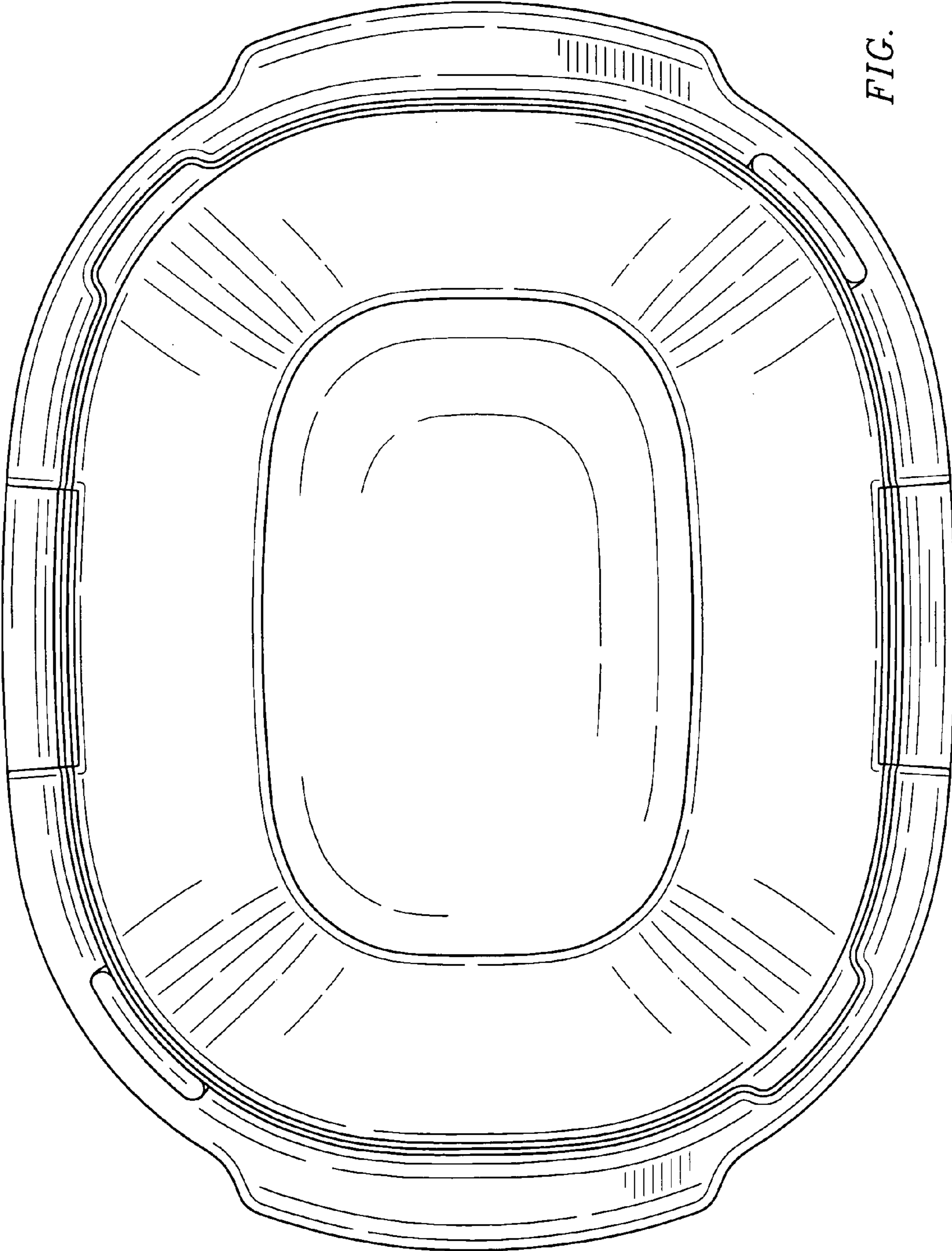

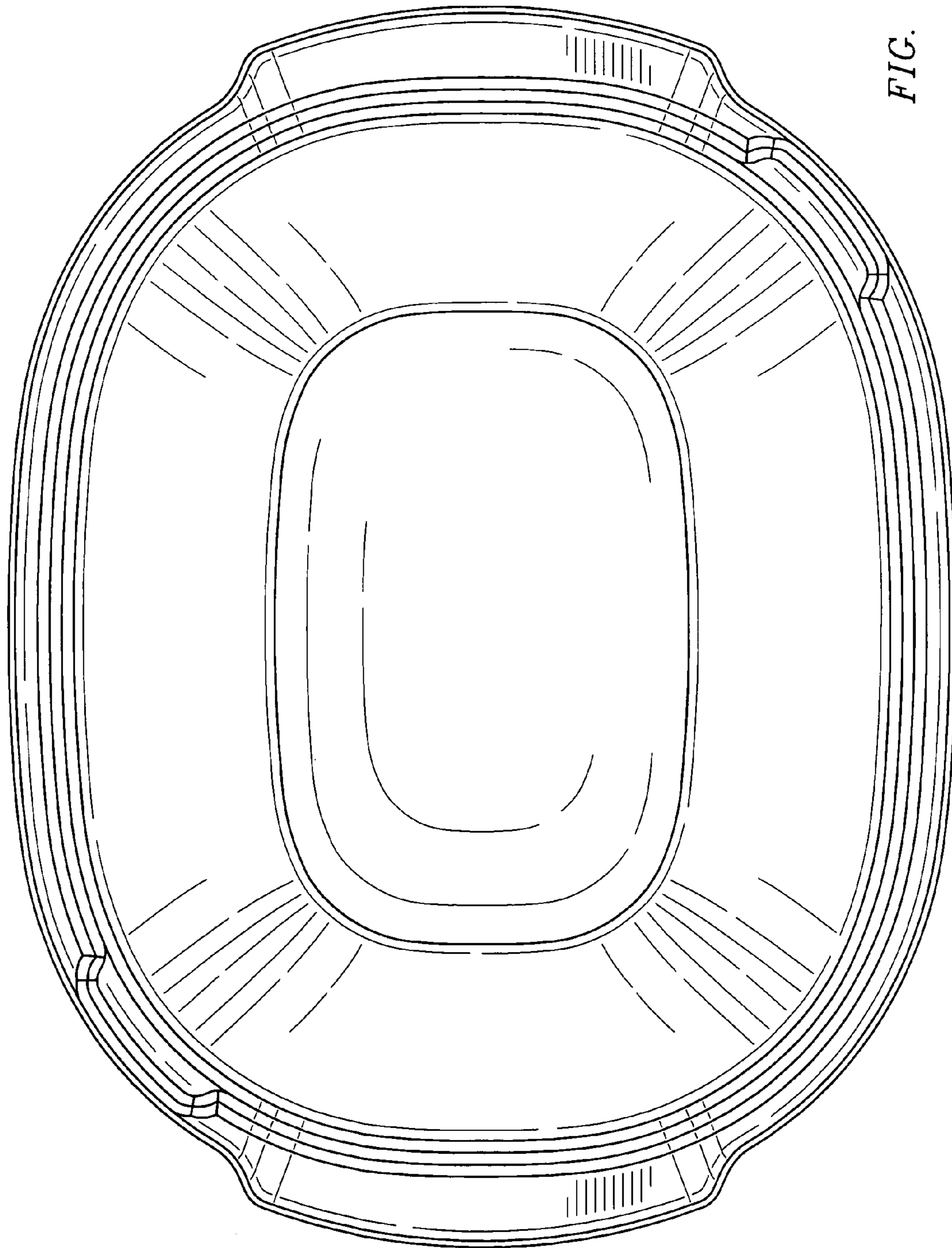

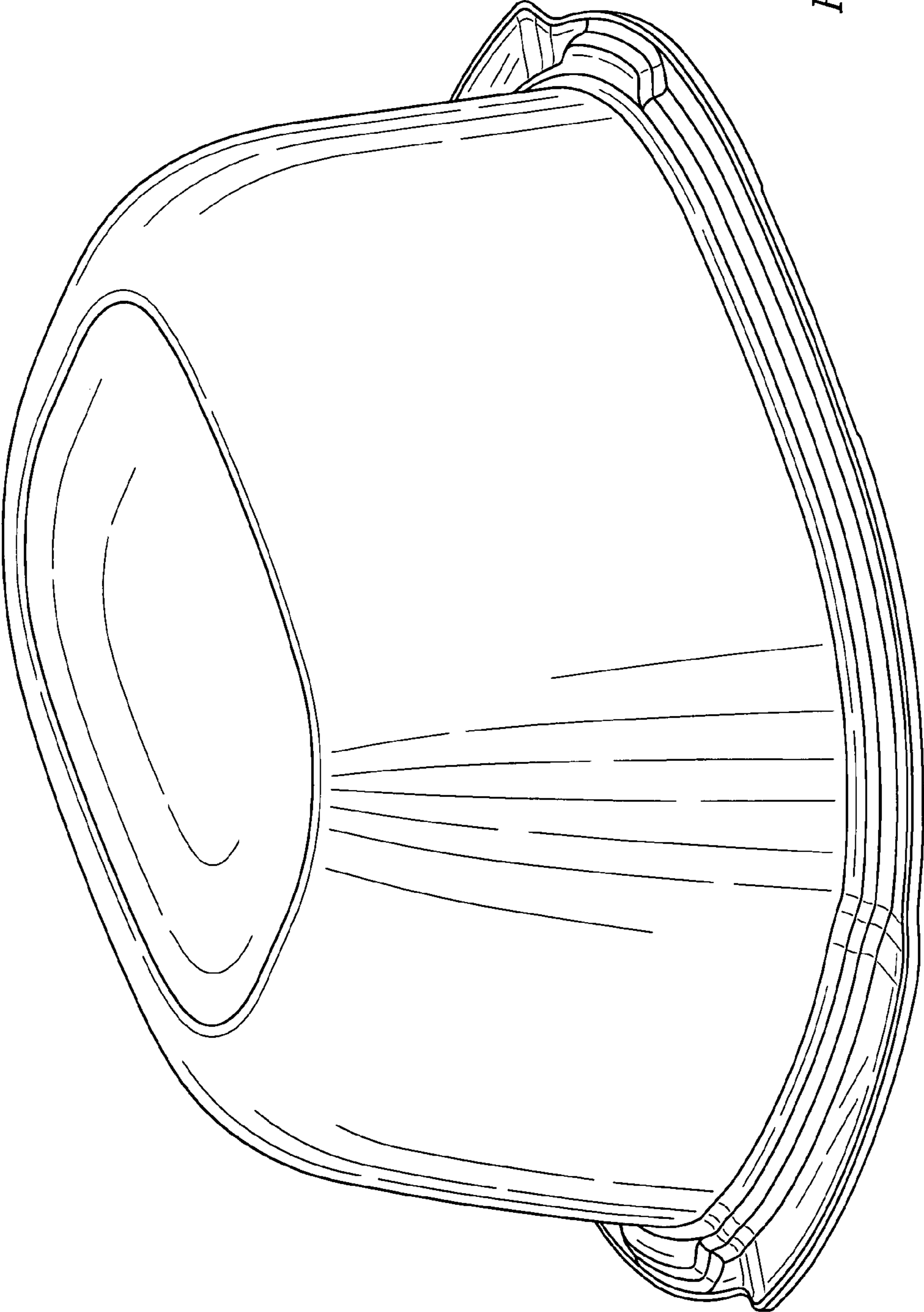
