DESCRIPTION

FIG. 1 is a perspective view of a novel design for a cutting tool handle;

FIG. 2 is a top plan view of the cutting tool handle of FIG. 1;

FIG. 3 is a side elevation of the cutting tool handle of FIG. 1;

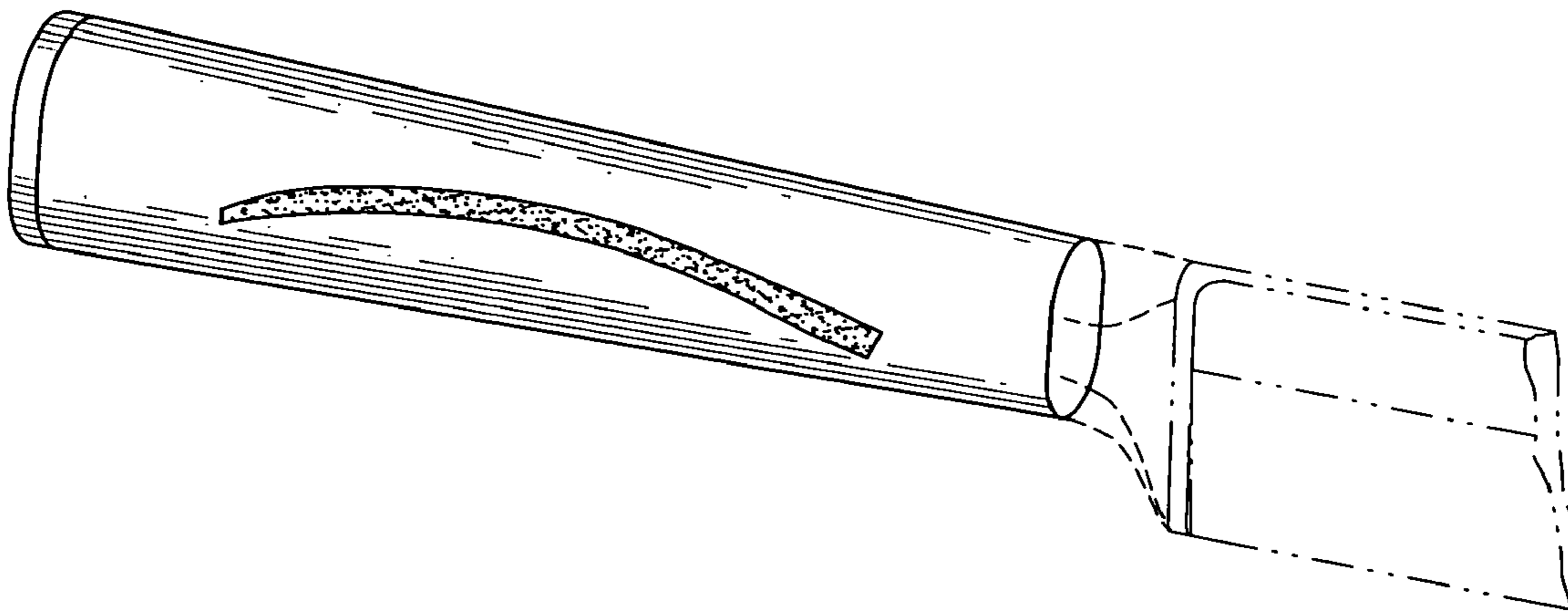
FIG. 4 is a bottom plan view of the cutting tool handle of FIG. 1;

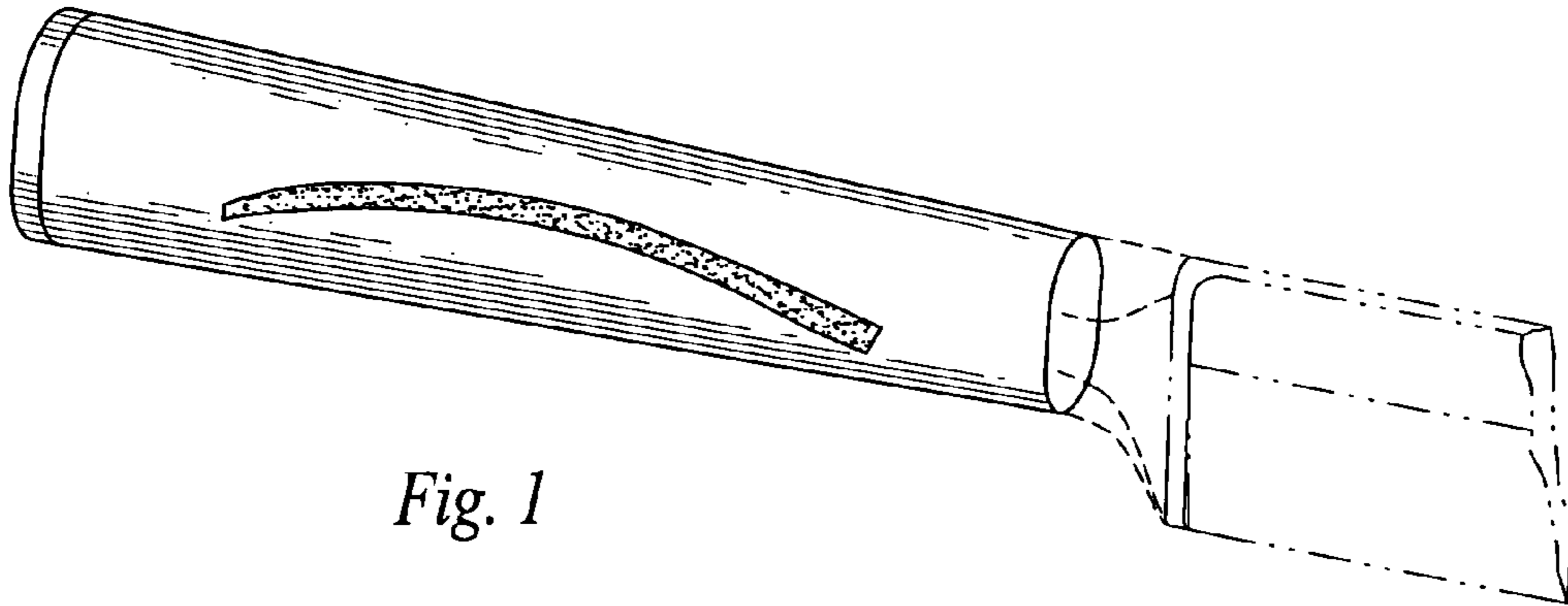

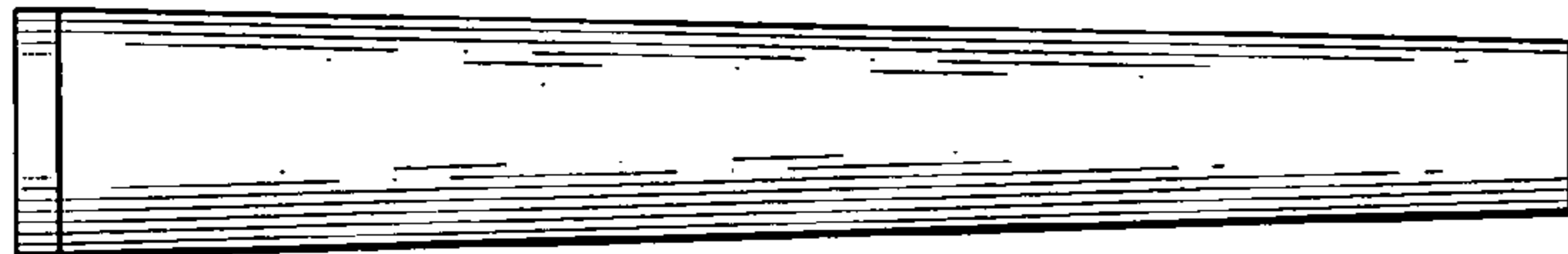

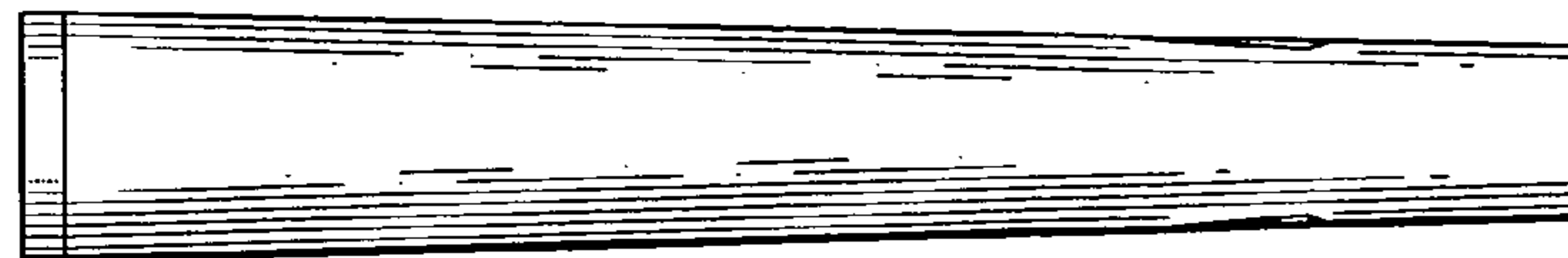

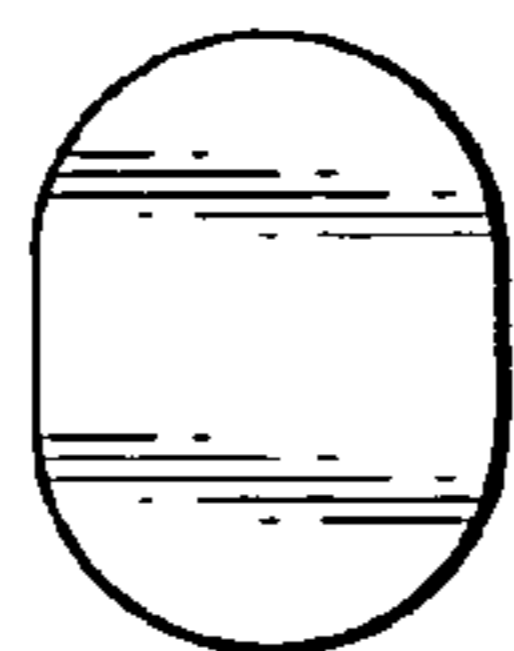

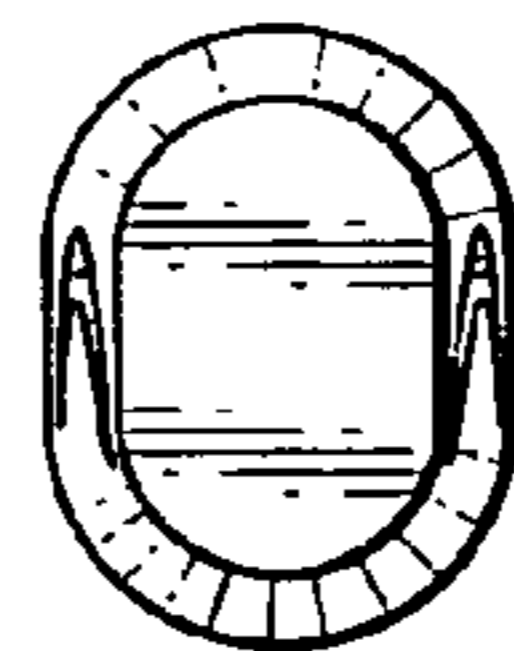
