FIG. 3 is a rear elevational view thereof;

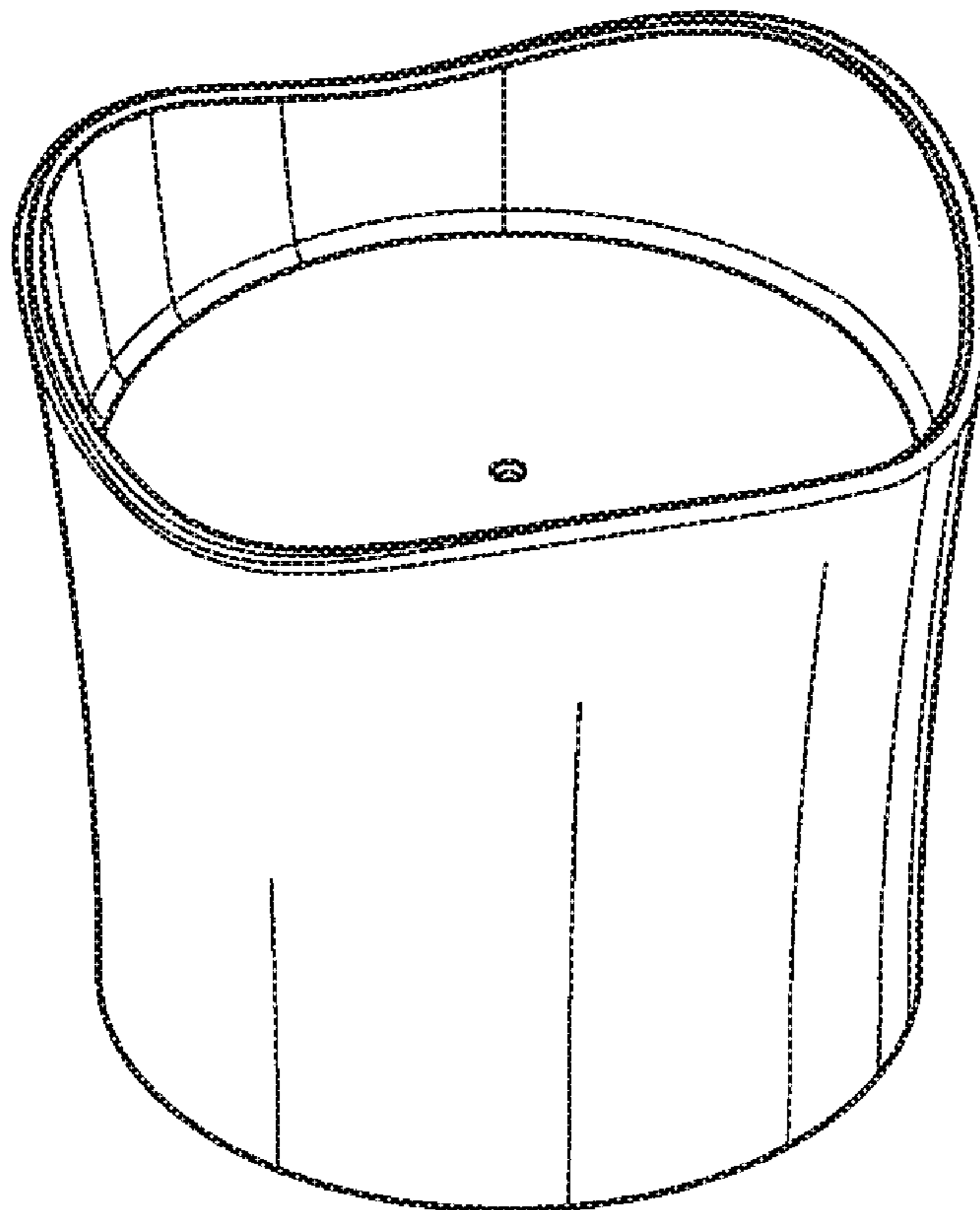
FIGS. 4 and 5 are side elevational views thereof;

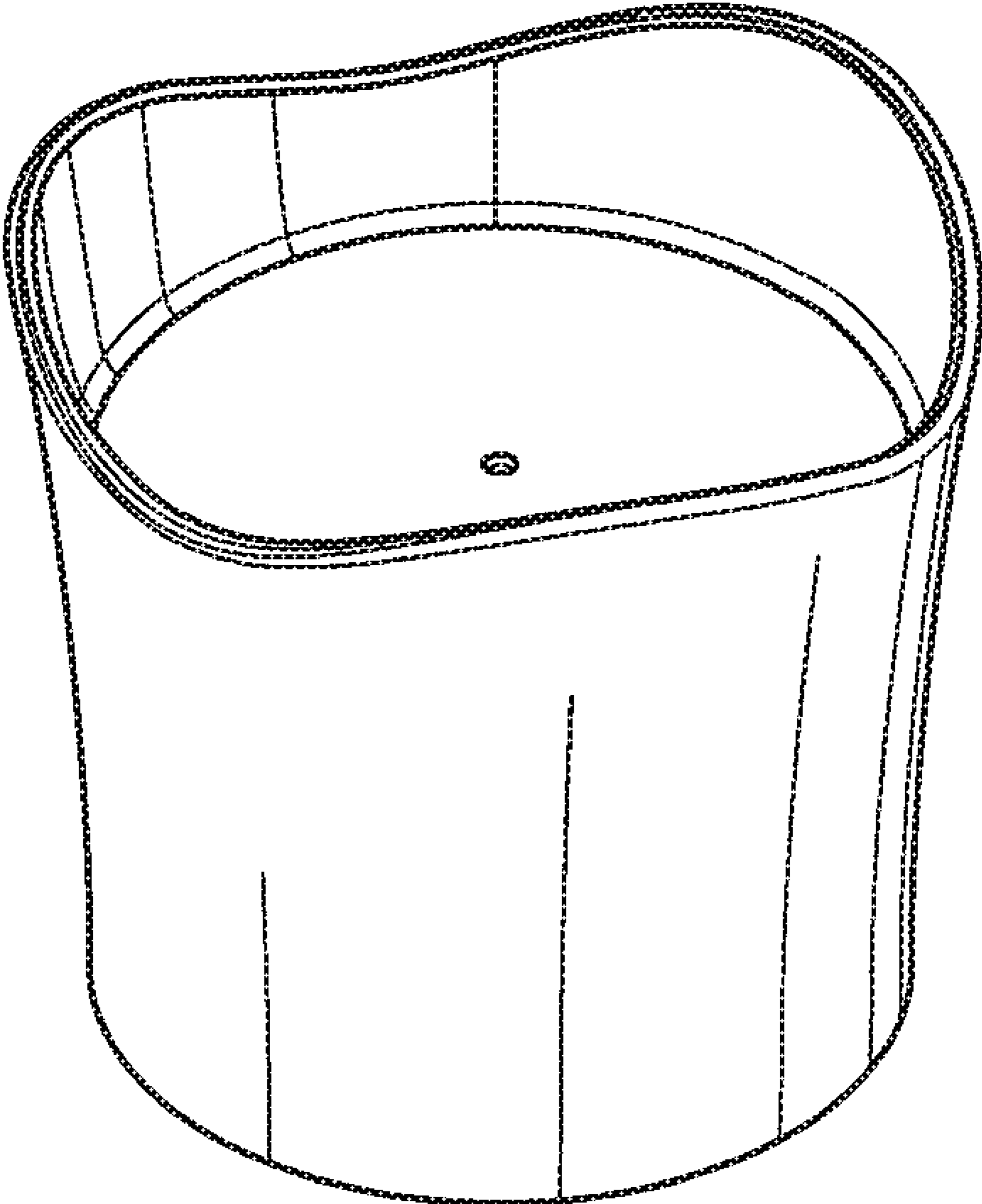
FIG. 6 is a top plan view thereof; and,

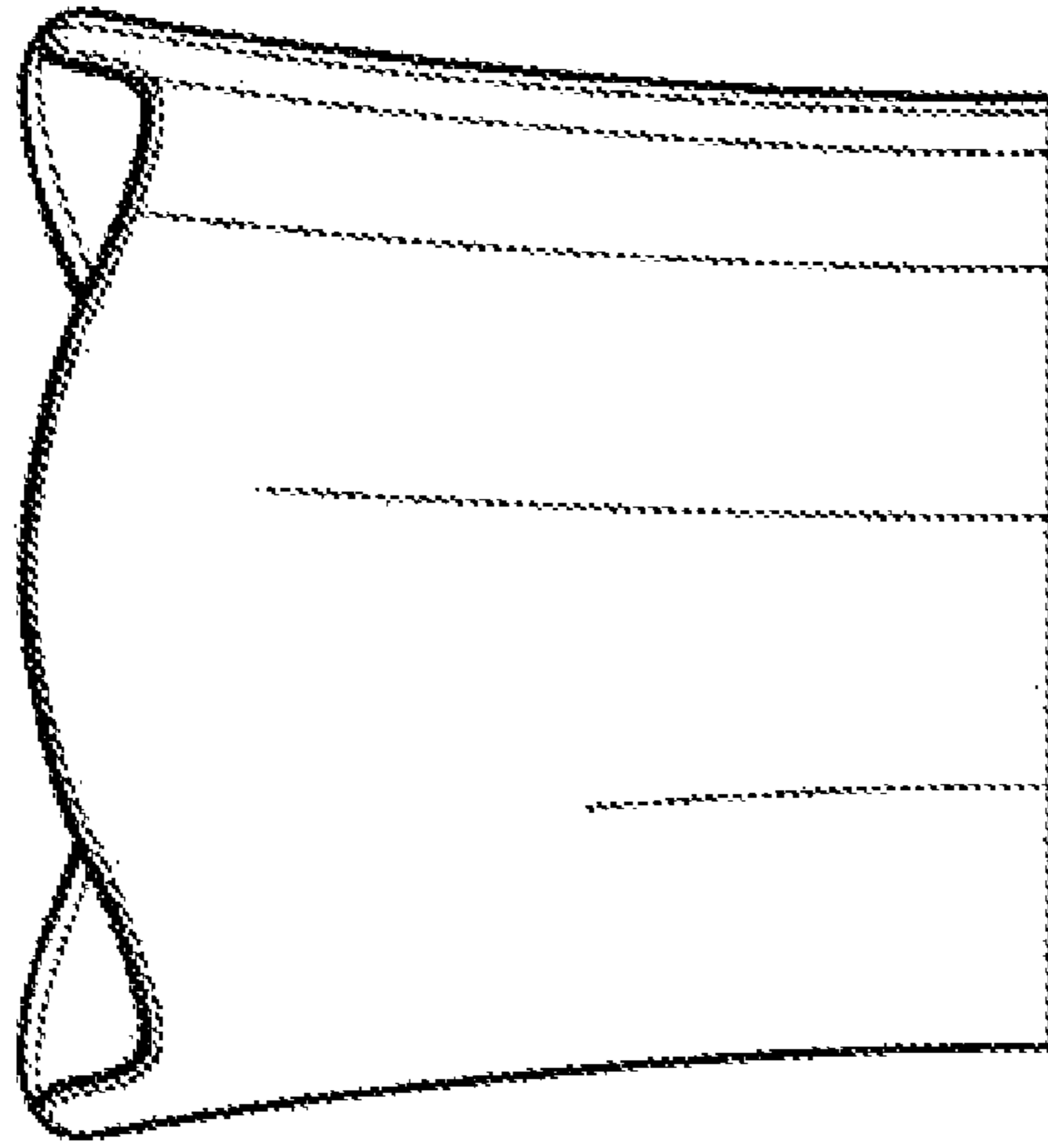

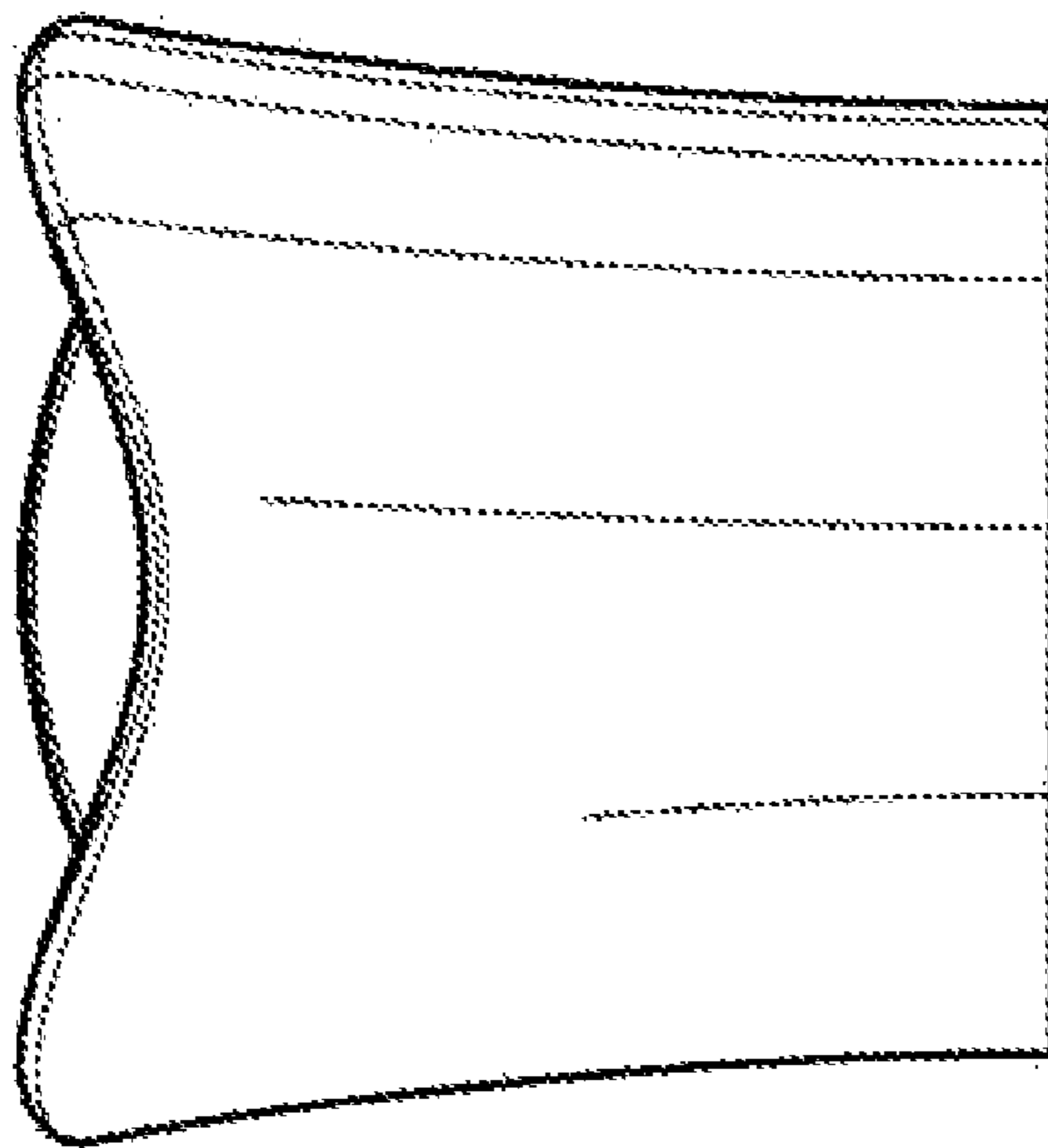
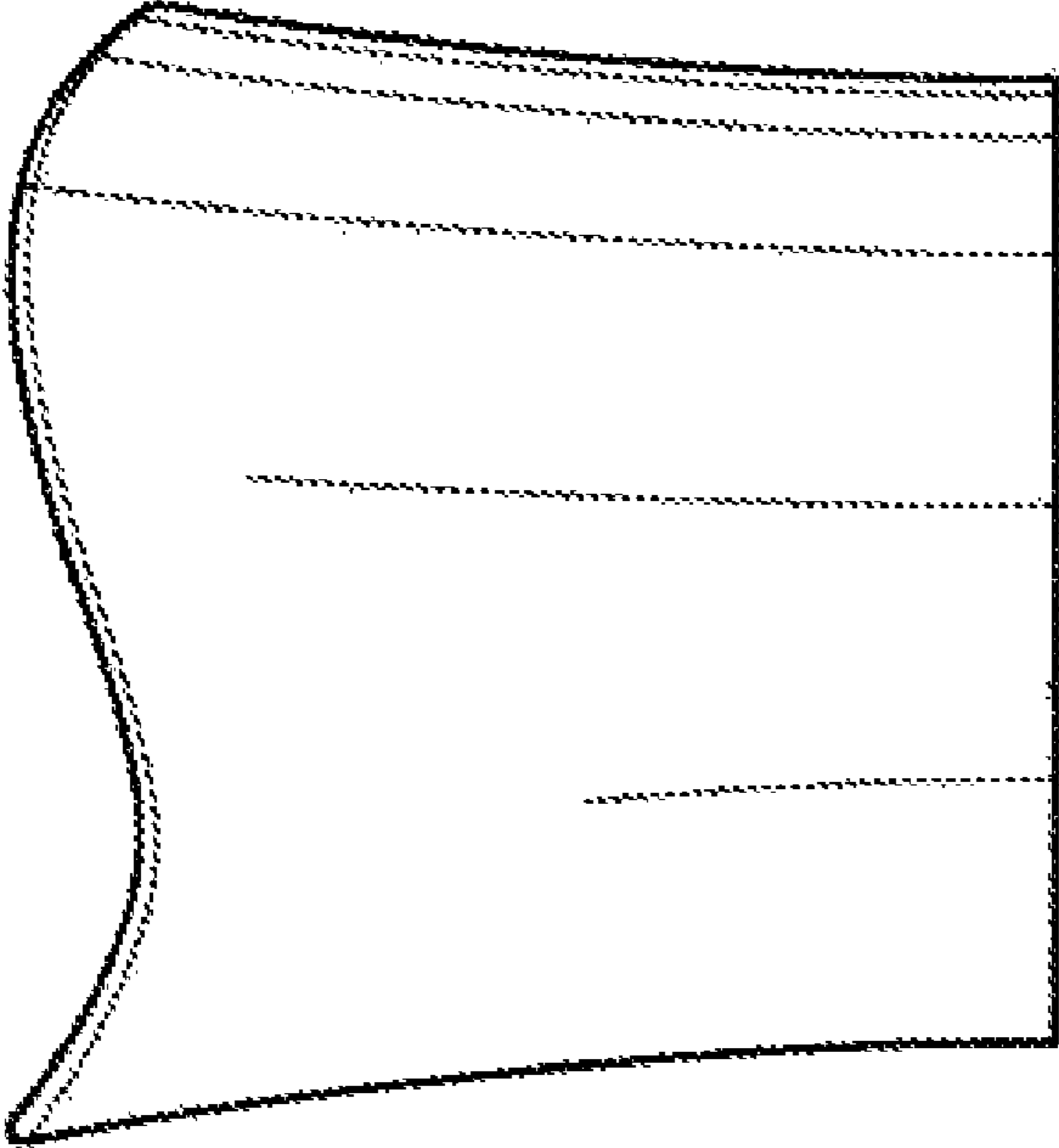
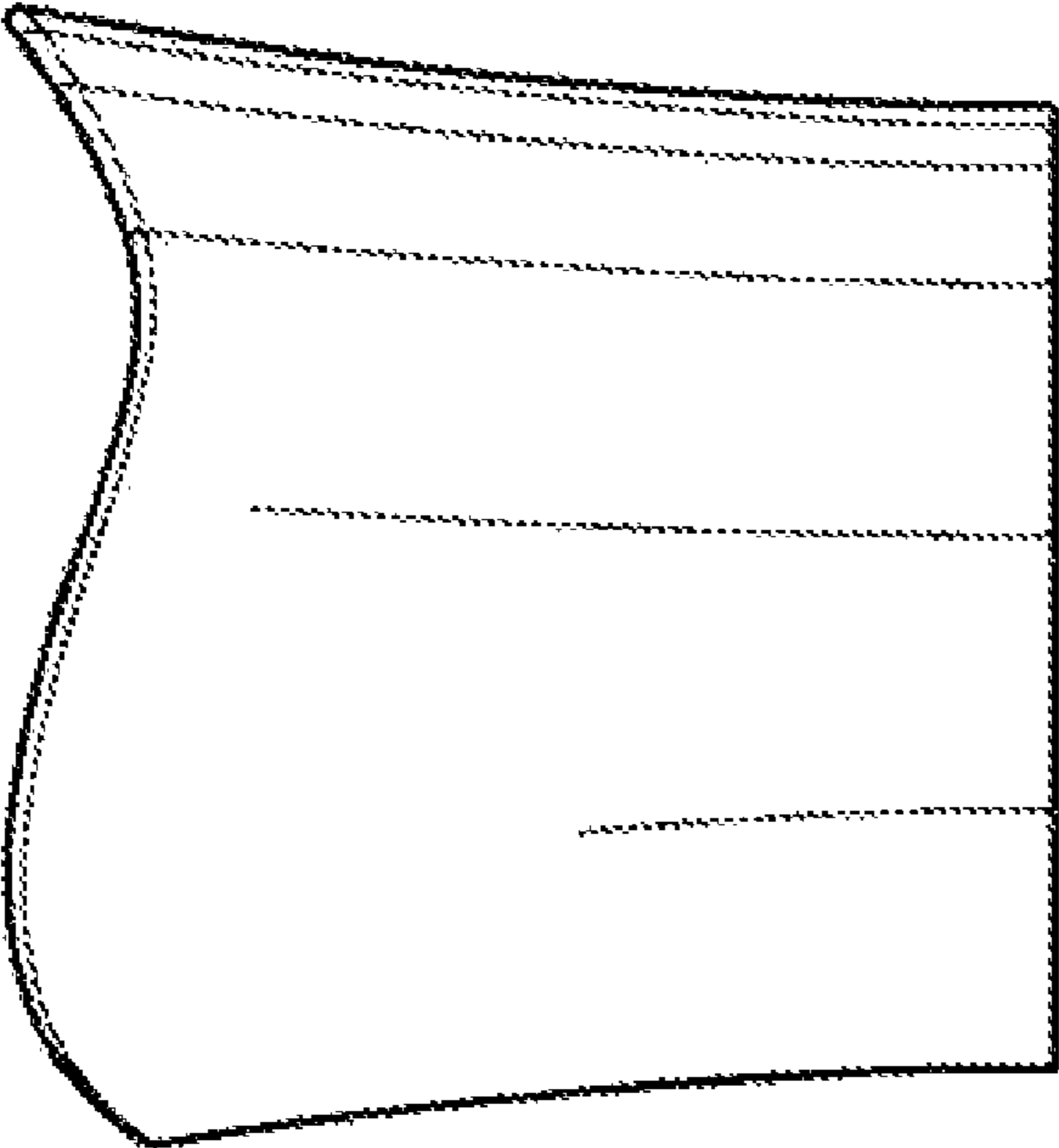

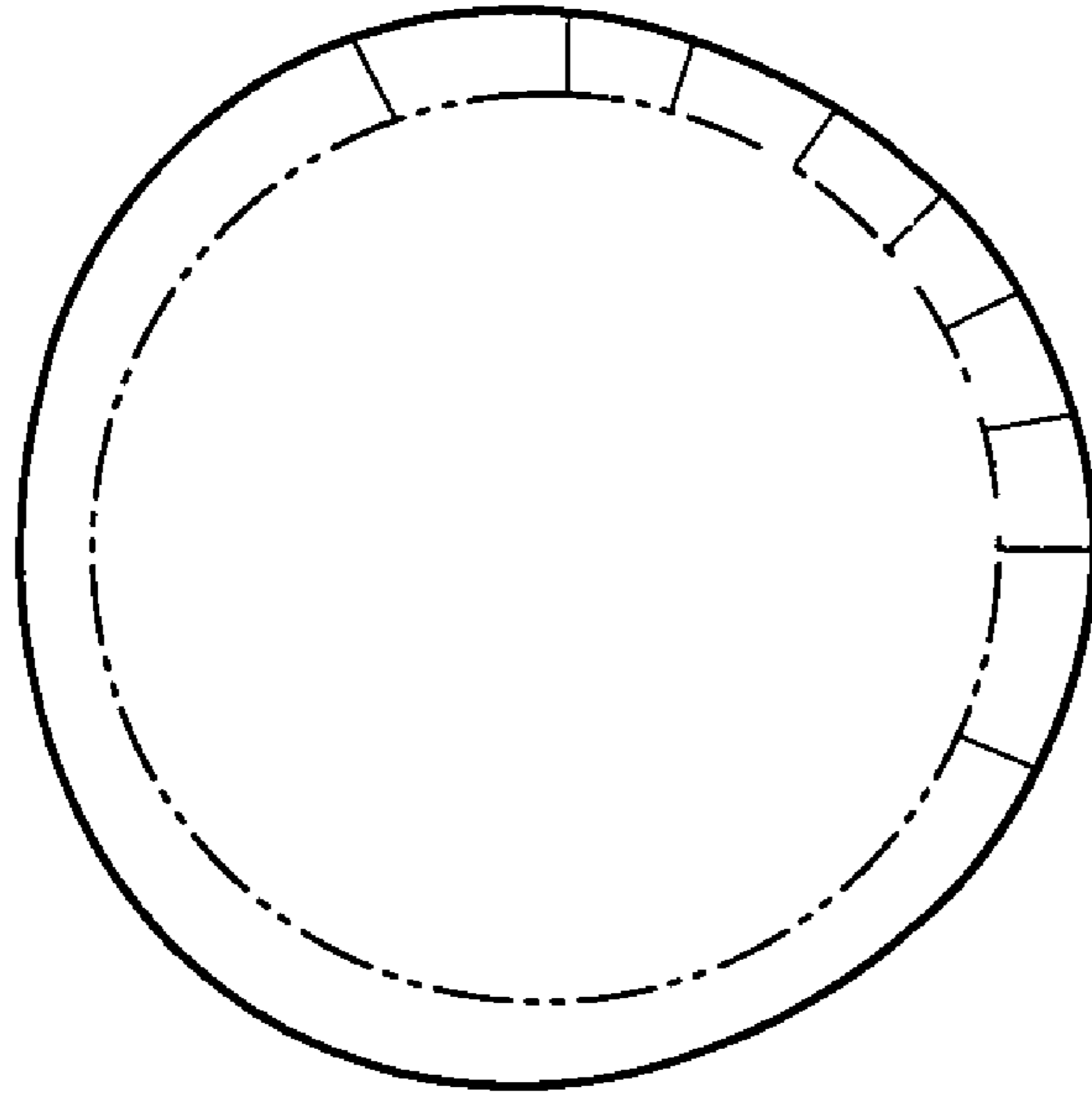

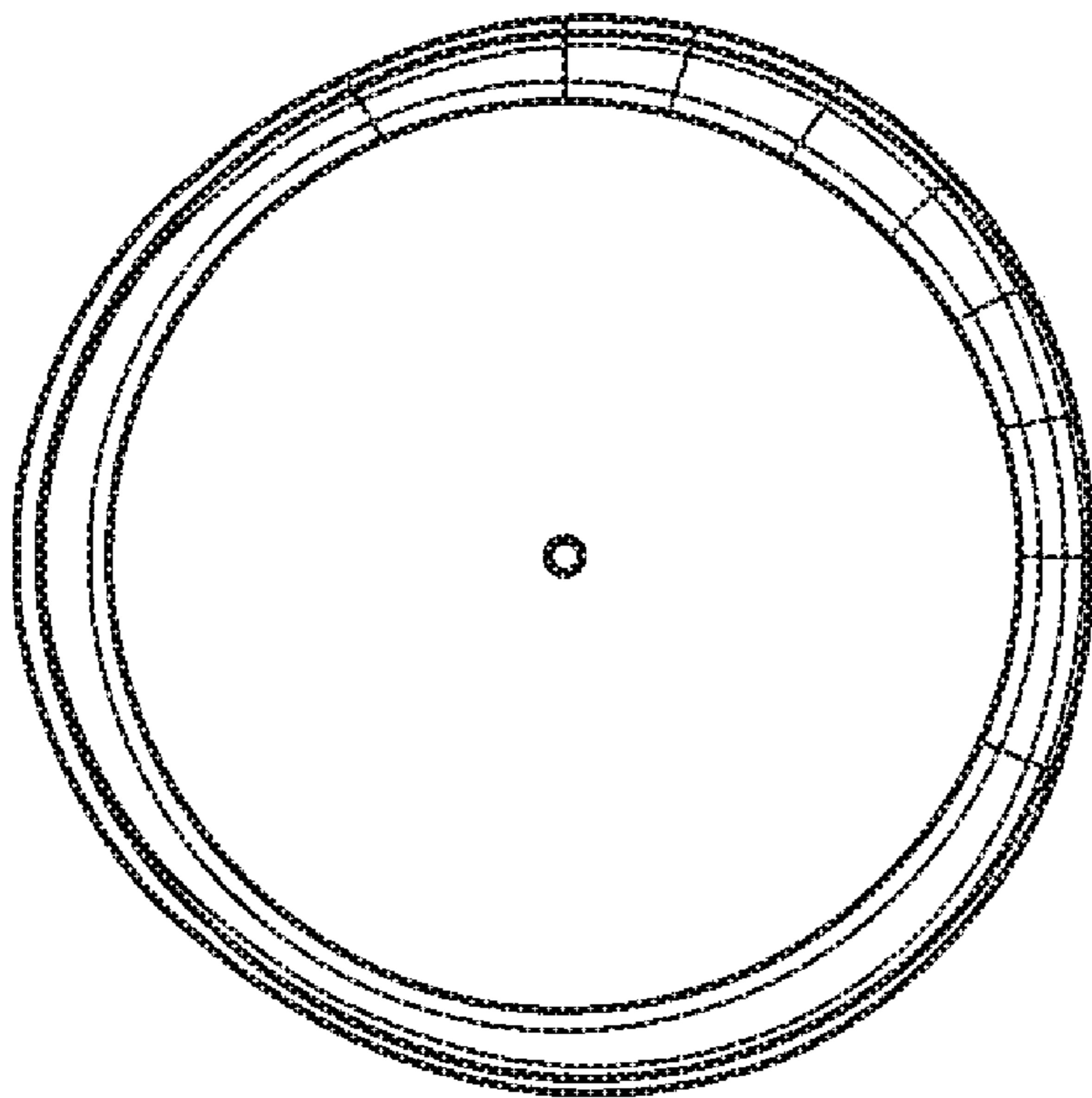
