DESCRIPTION

FIG. 1 is a perspective view of a motorcycle windshield trim, with parts of a motorcycle being shown in phantom lines and forming no part of the claimed design;

FIG. 2 is a front elevation view of the motorcycle windshield trim of FIG. 1;

FIG. 3 is a rear elevation view of the motorcycle windshield trim of FIG. 1;

FIG. 4 is a right-side elevation view of the motorcycle windshield trim of FIG. 1, the left-side elevation view being a mirror image thereof; and,

FIG. 5 is a top view of the motorcycle windshield trim of FIG. 1.

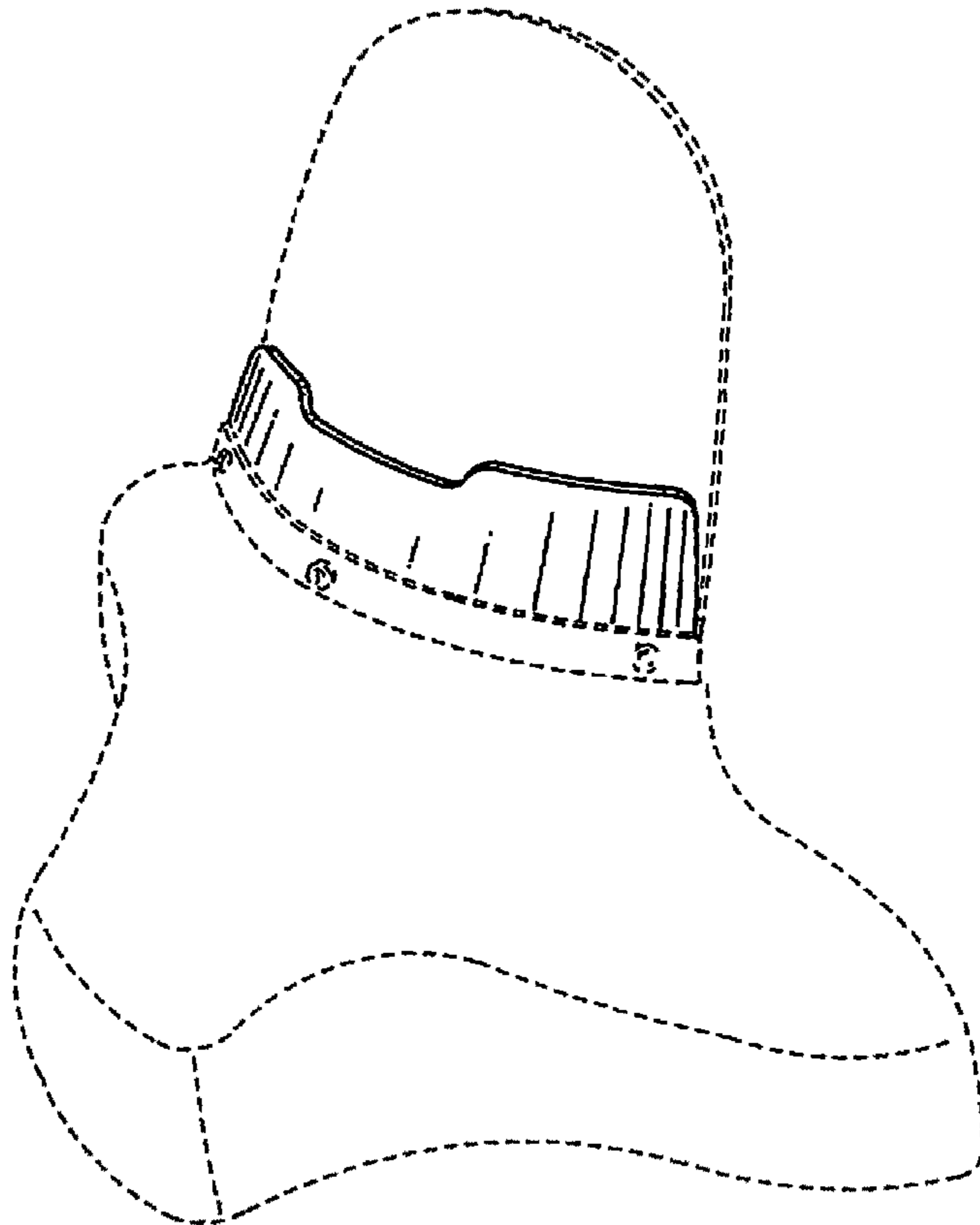

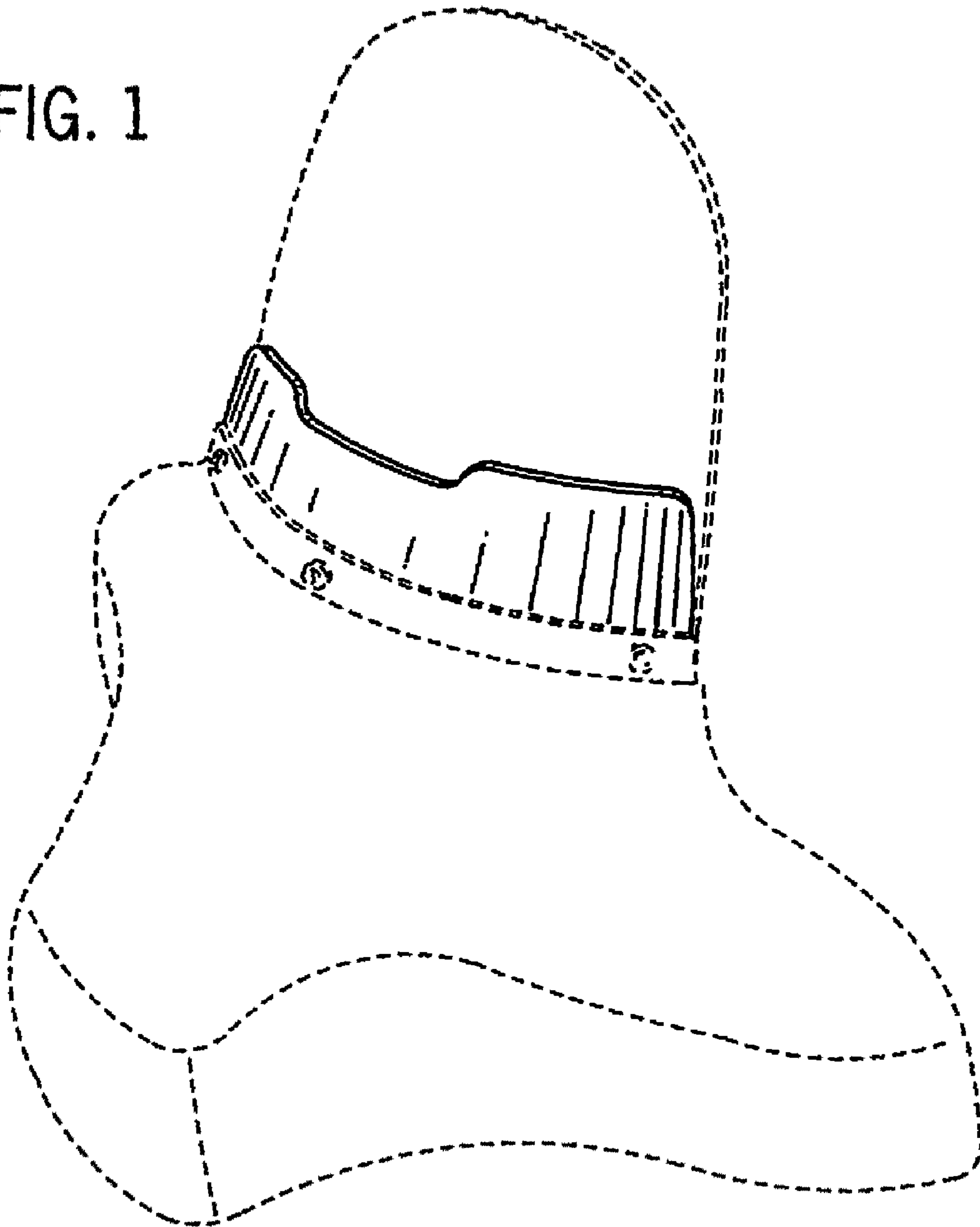

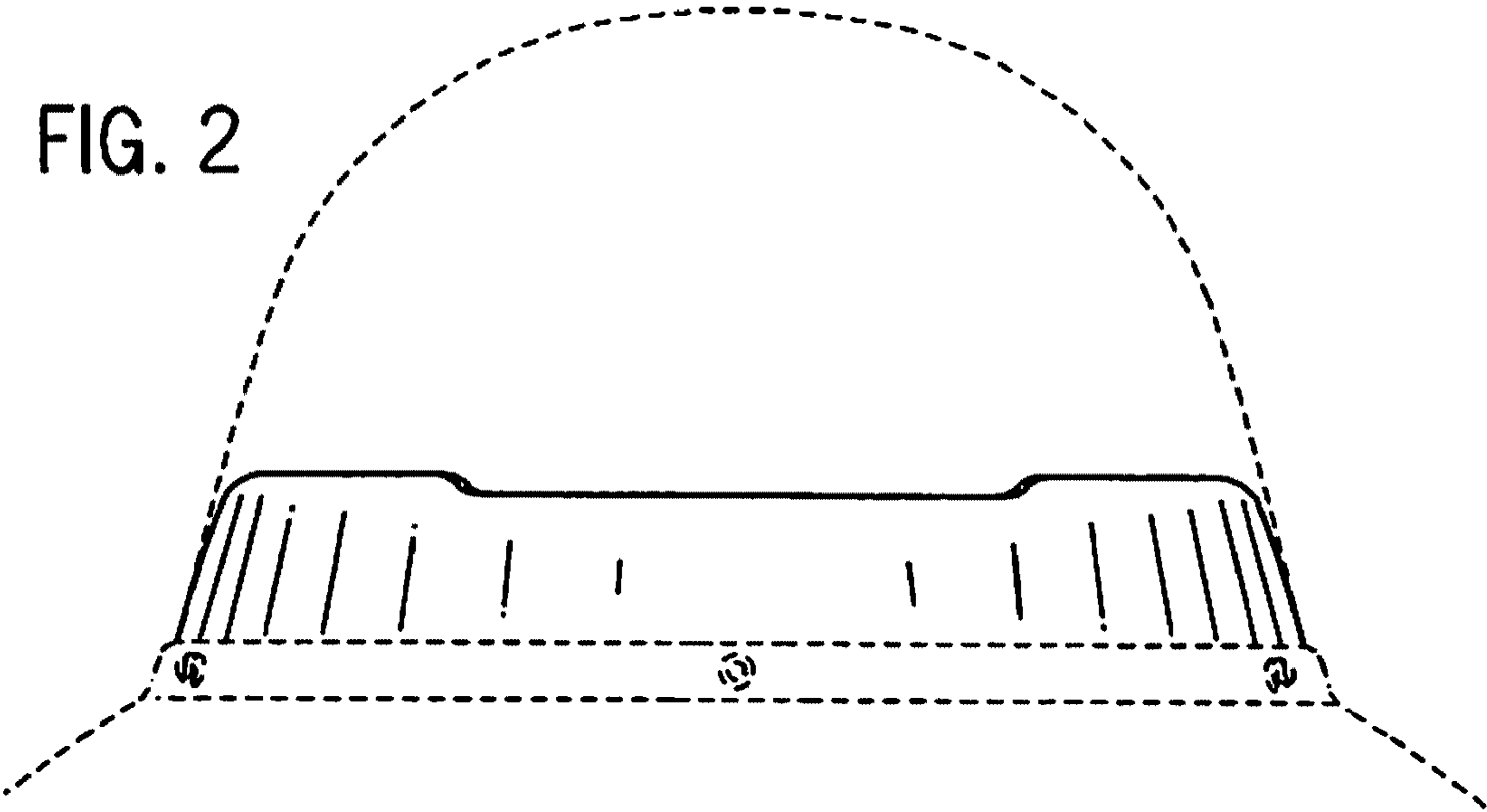

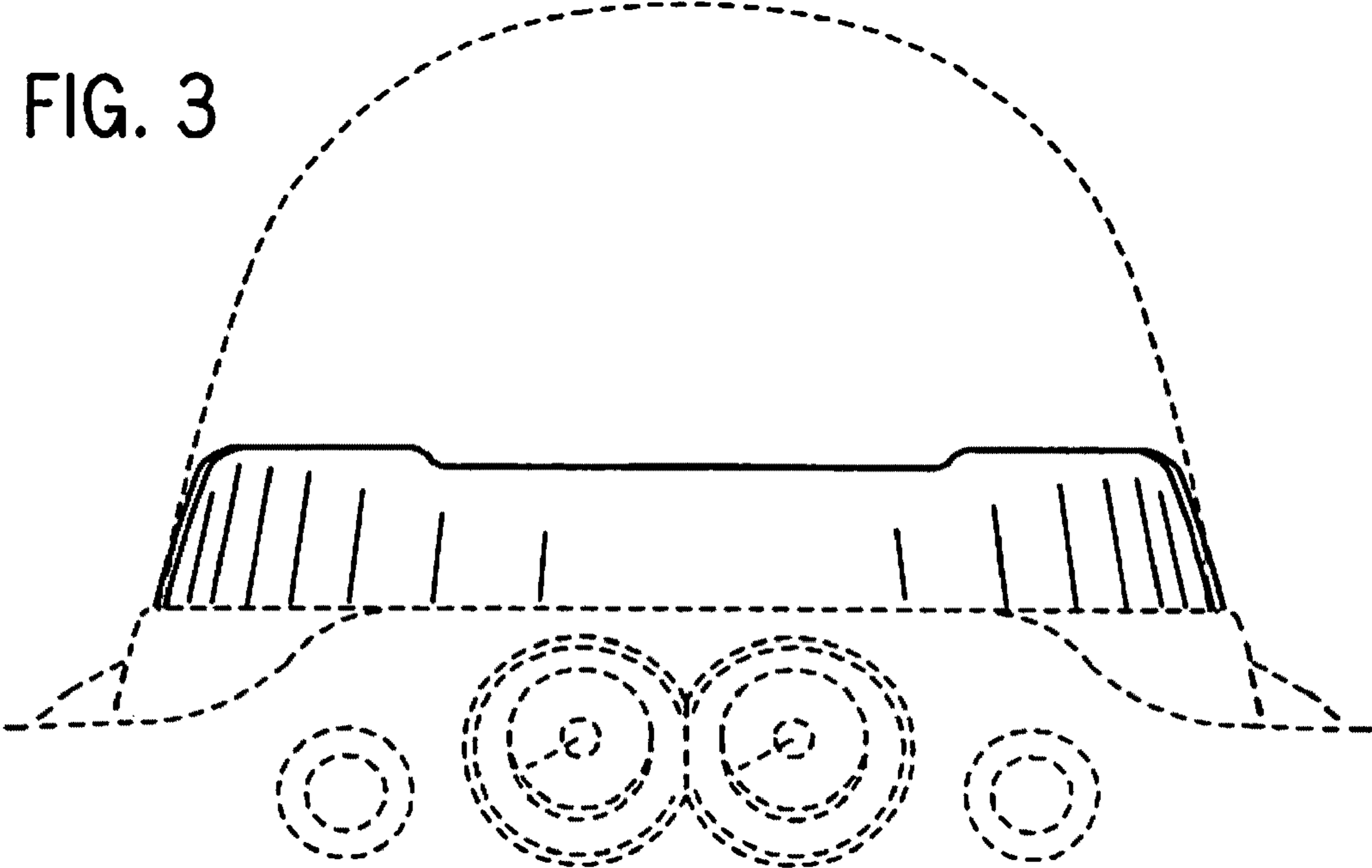

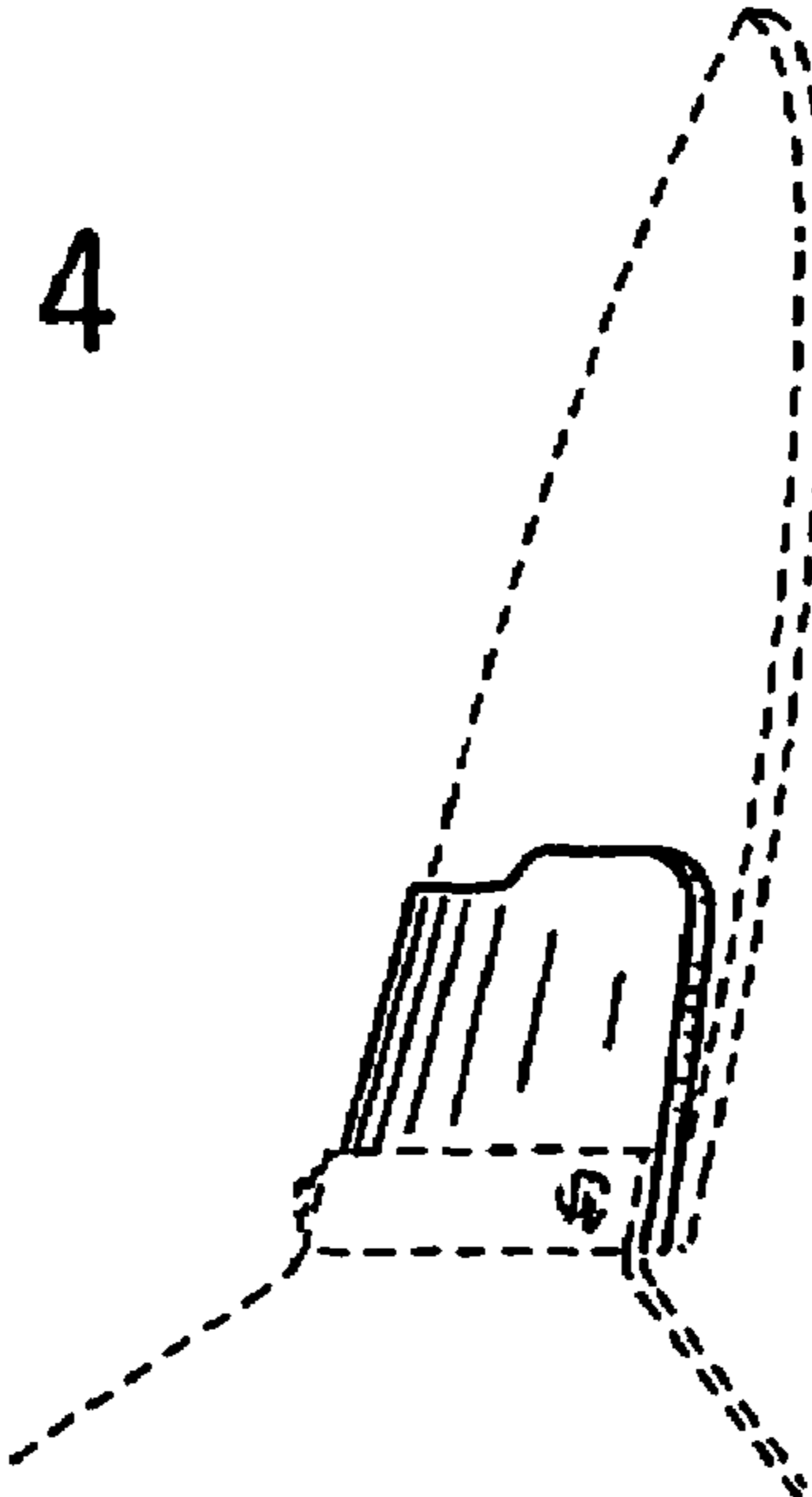
