(57) **CLAIM**

The ornamental design for a foot pedal controller, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a foot pedal controller, showing my new design, in a typical, un-depressed, usage condition;

FIG. 2 is a bottom perspective view thereof;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a front side elevation view thereof;

FIG. 5 is a left side elevation view thereof;

FIG. 6 is a rear side elevation view thereof;

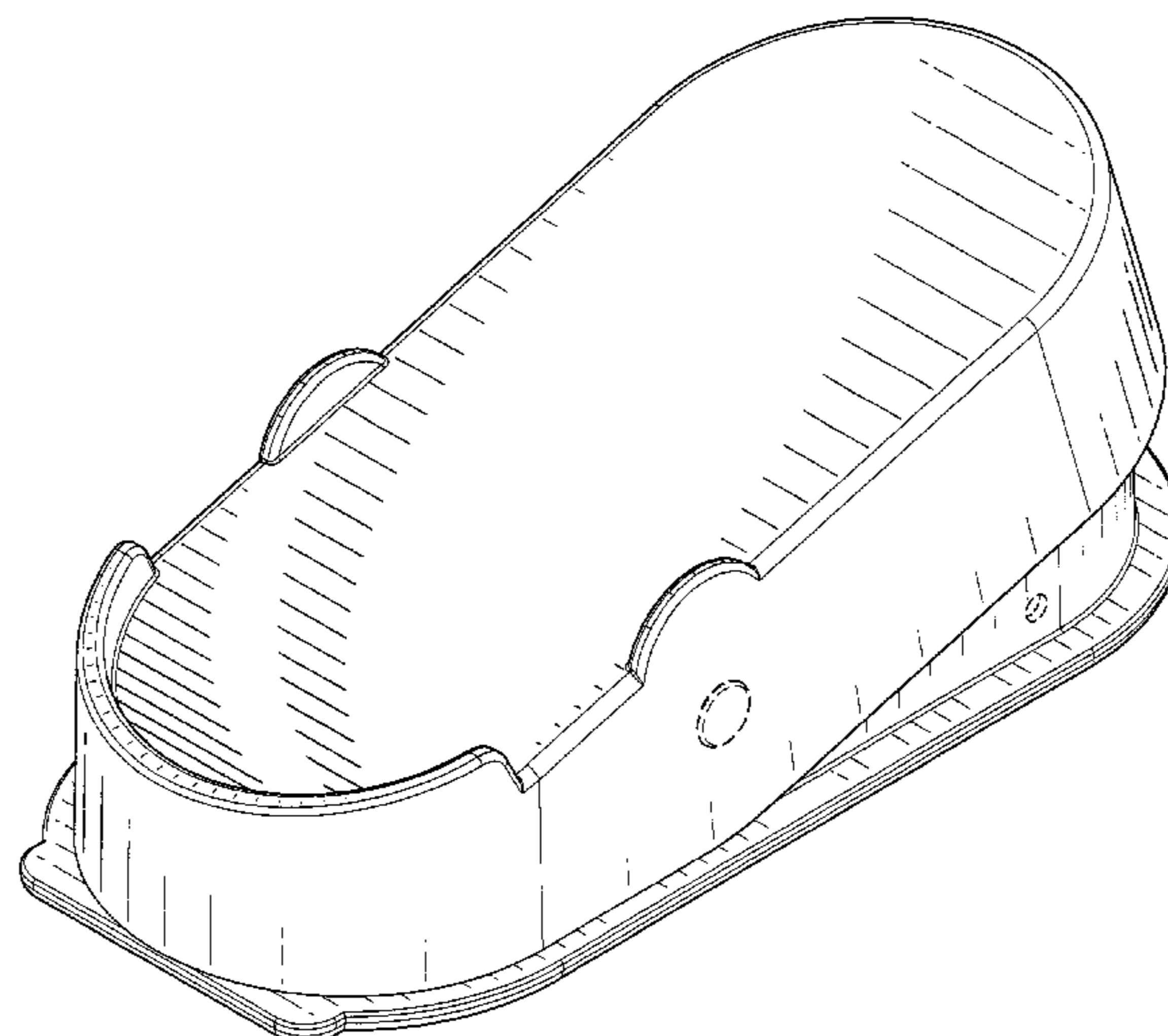
FIG. 7 is a top plan view thereof;

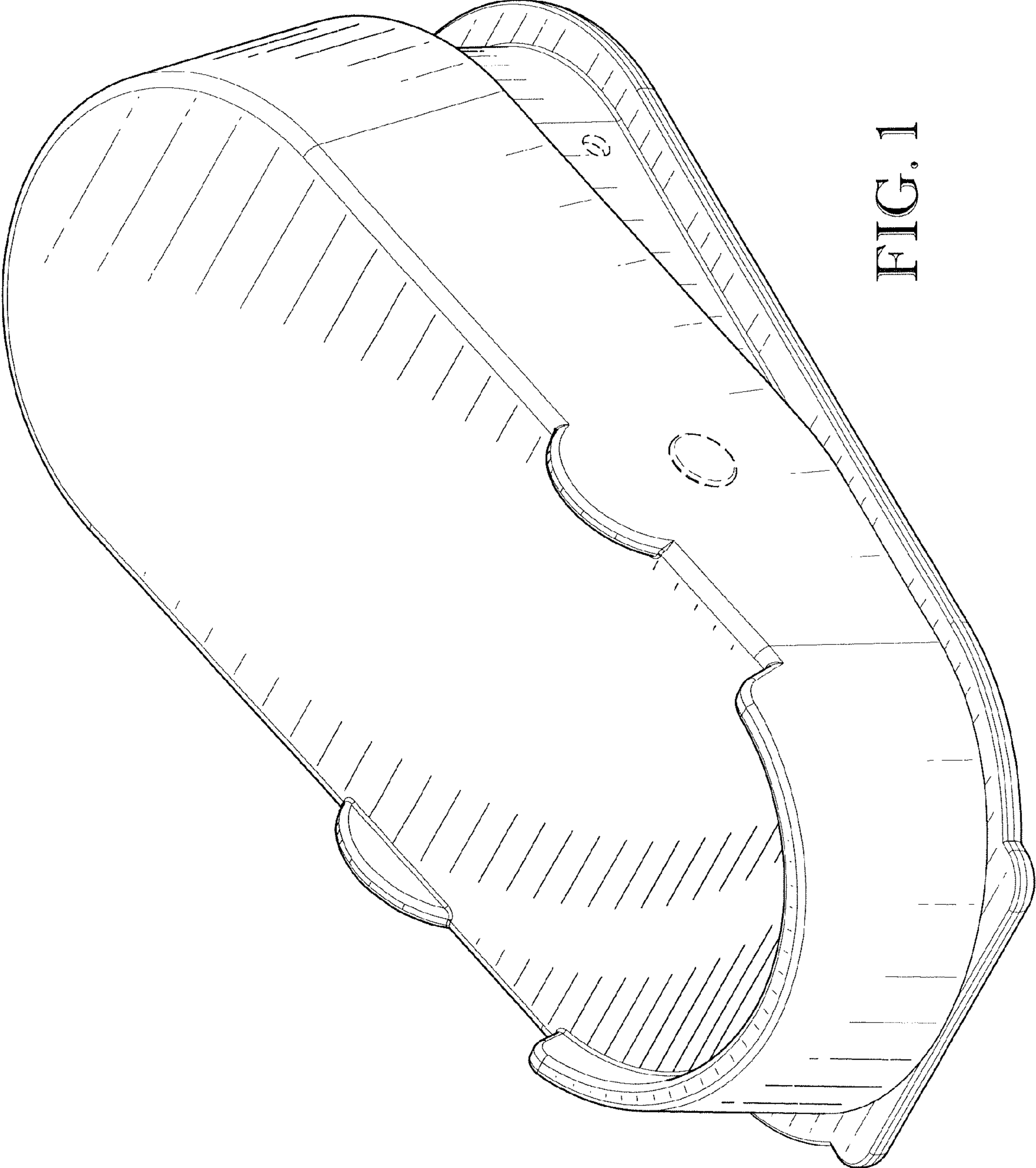

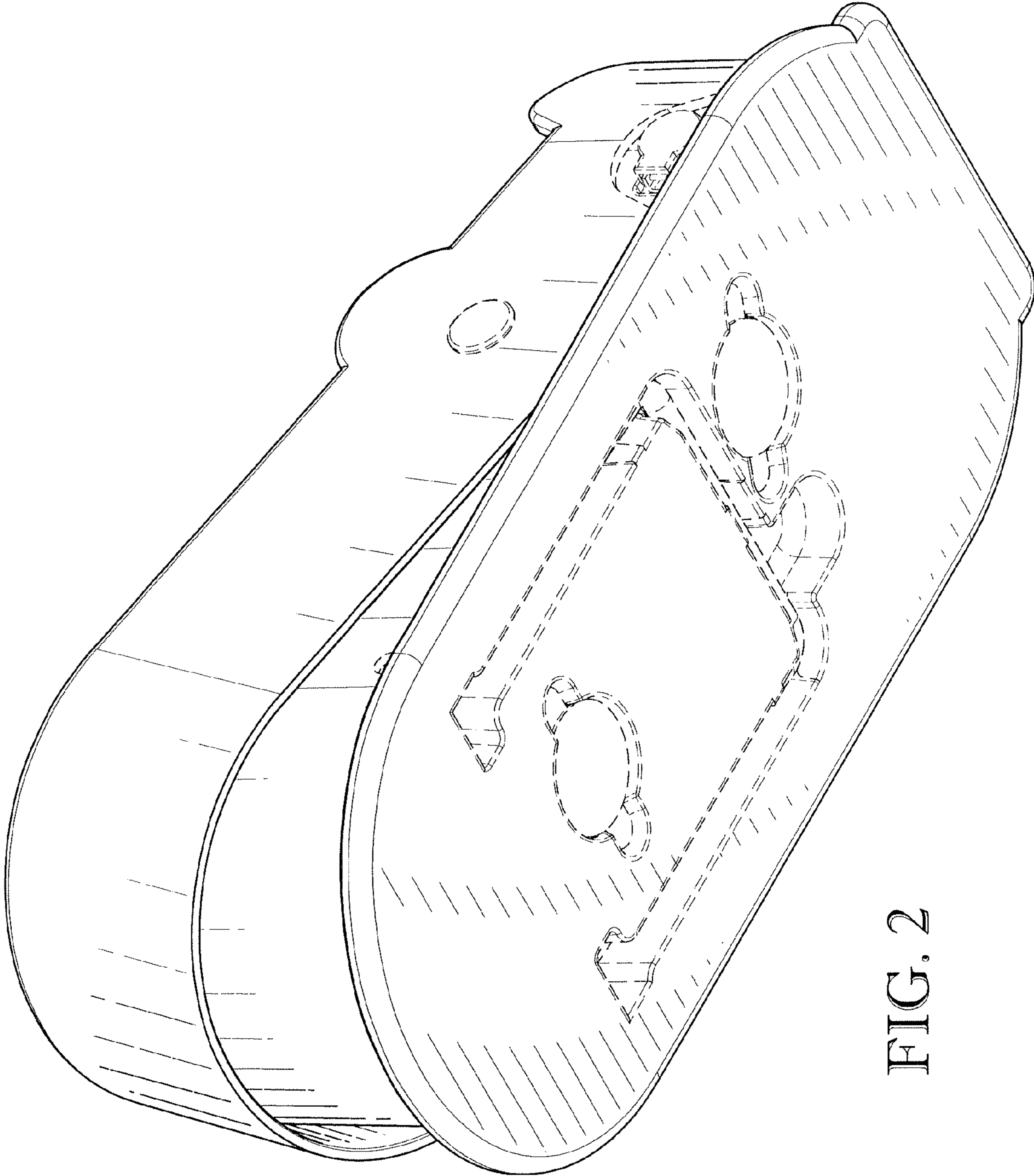

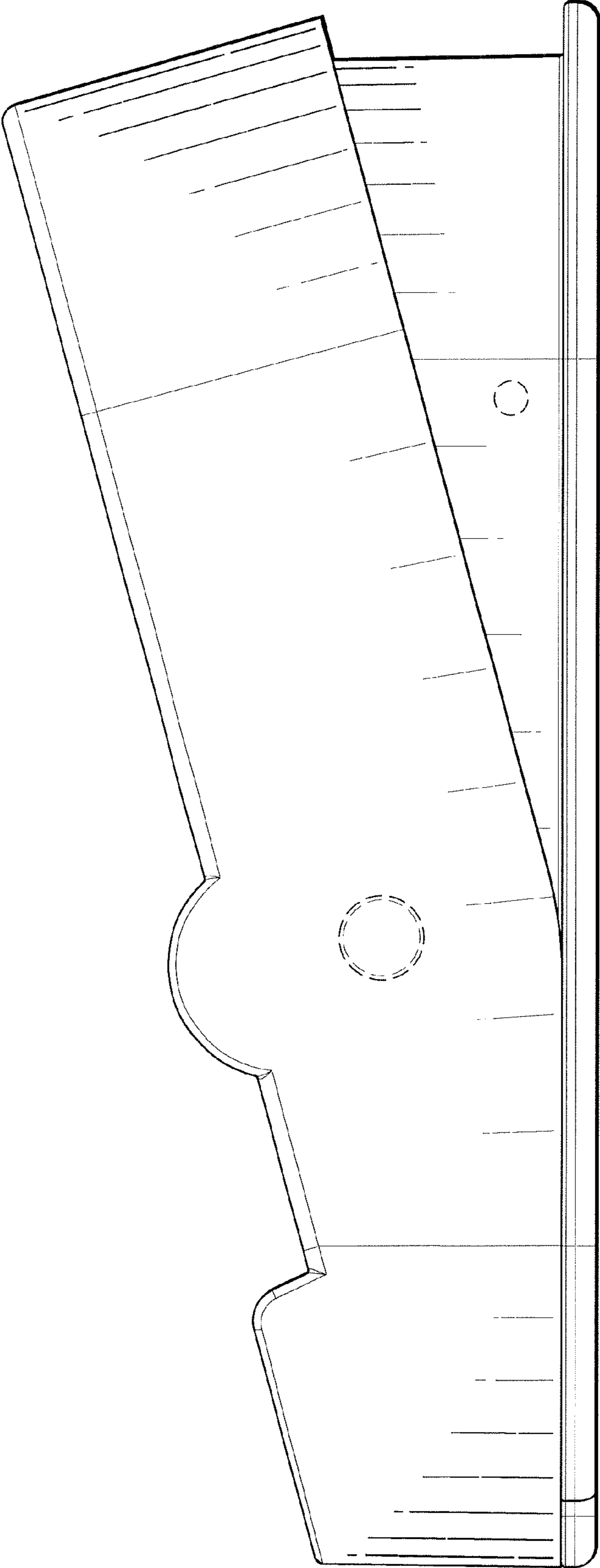

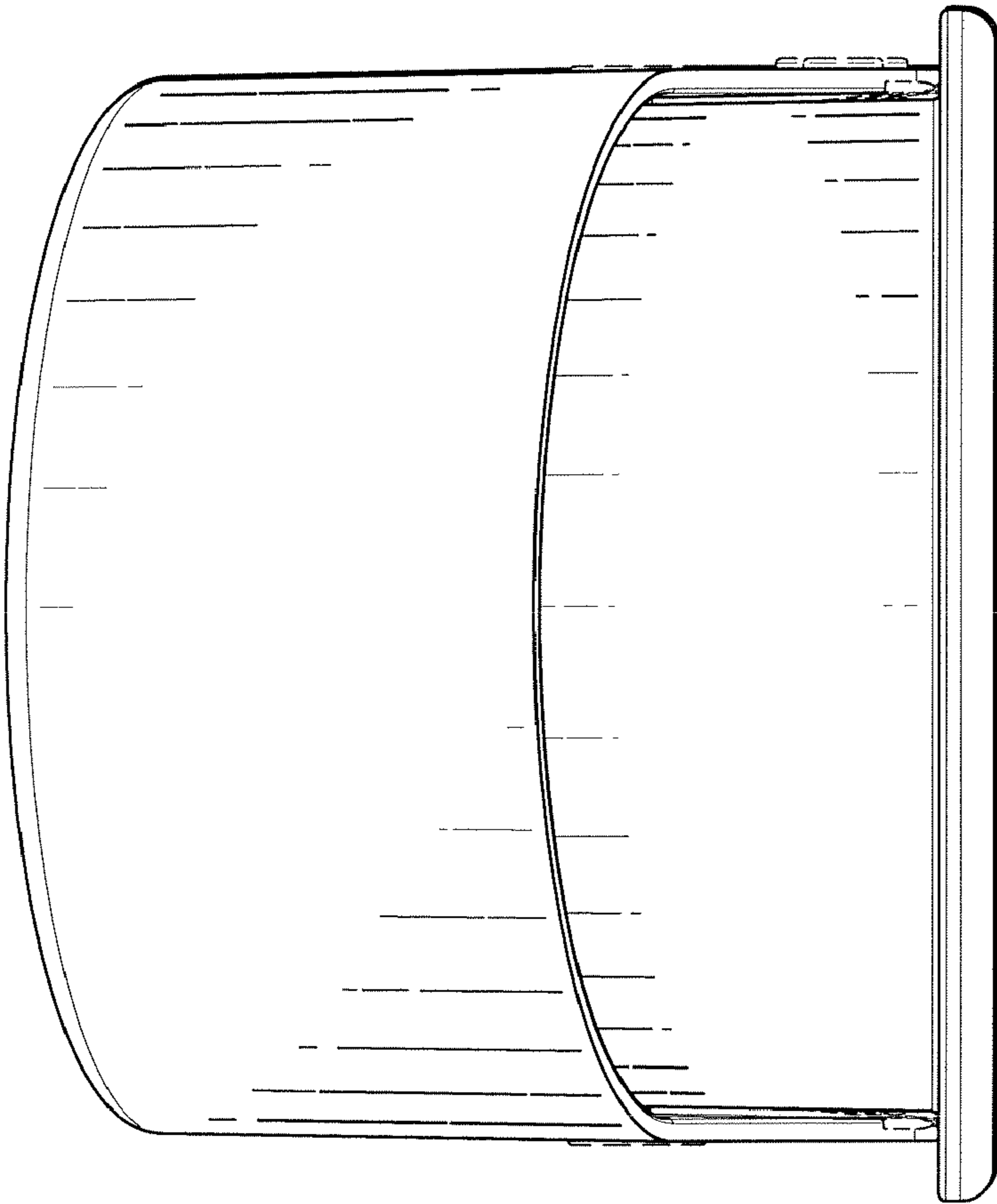

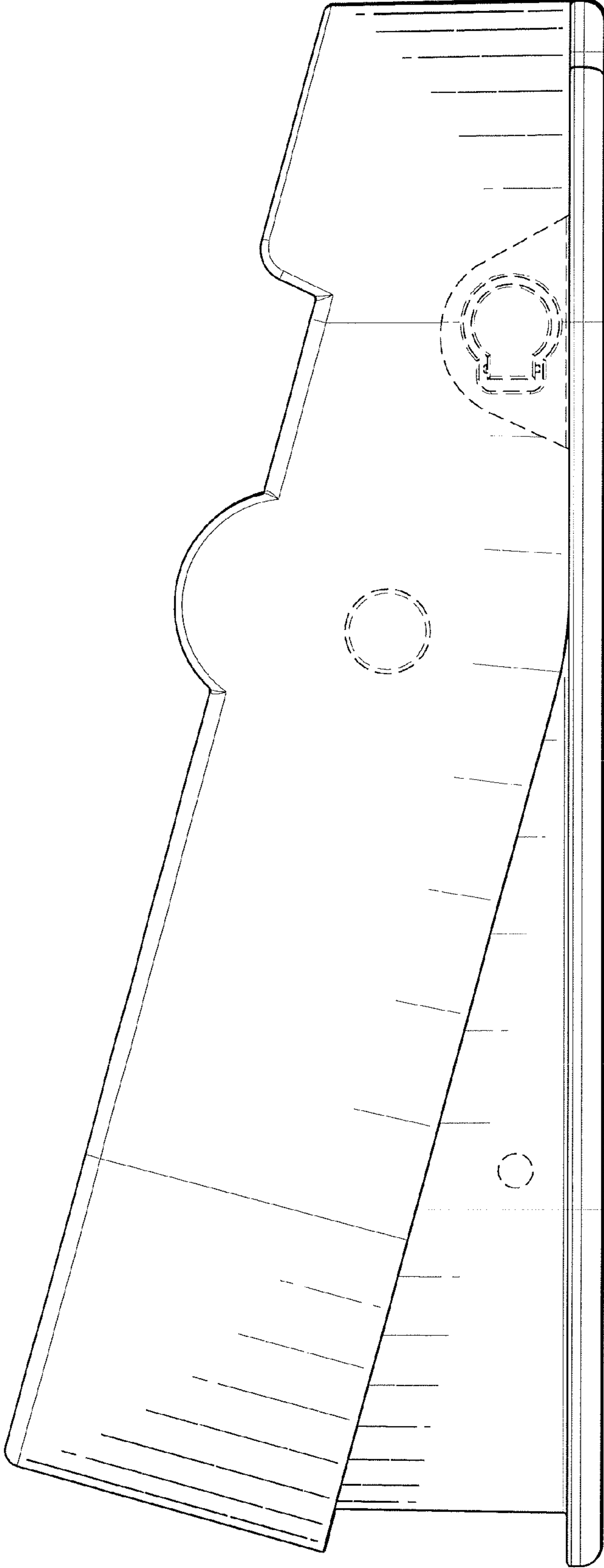

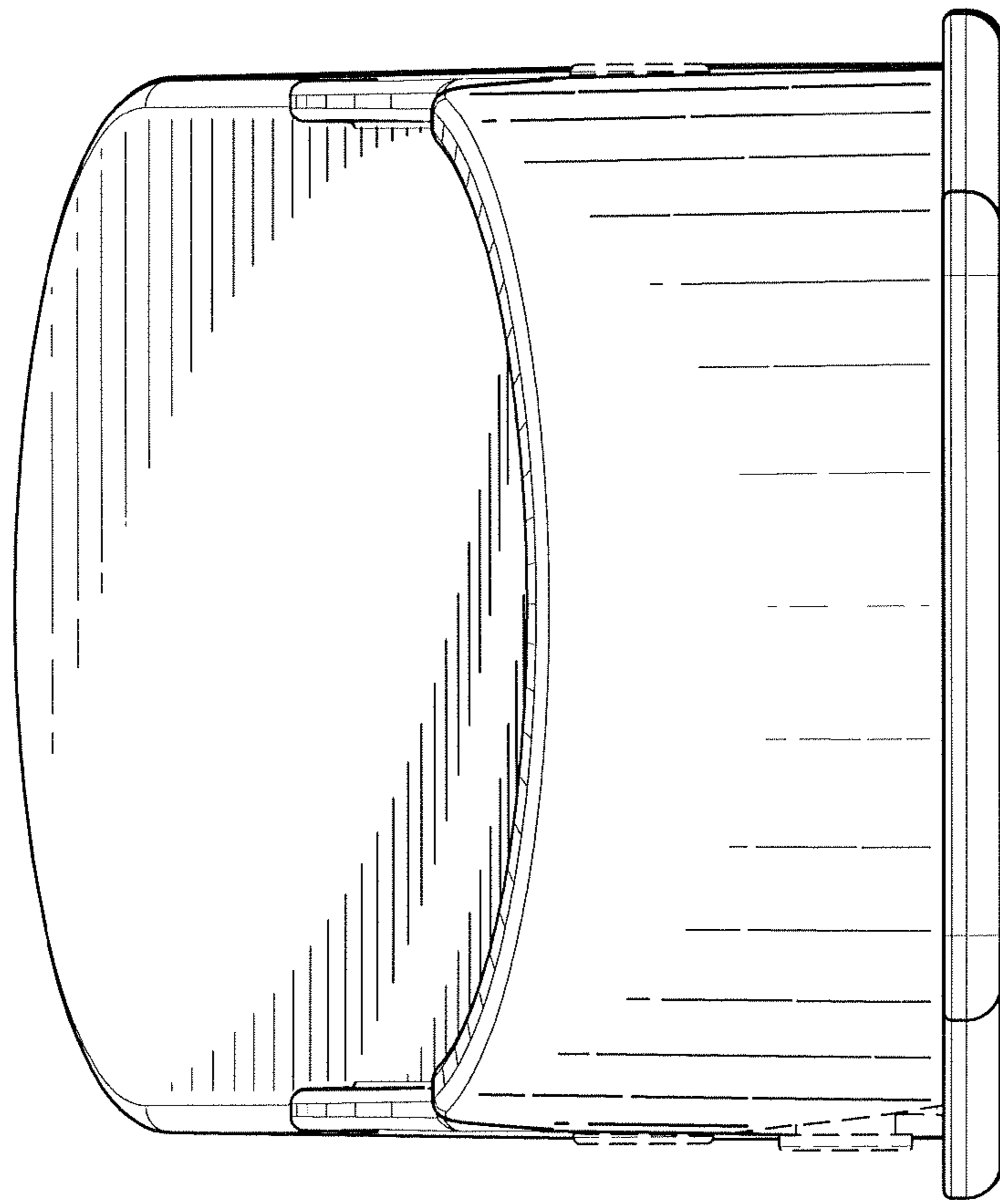

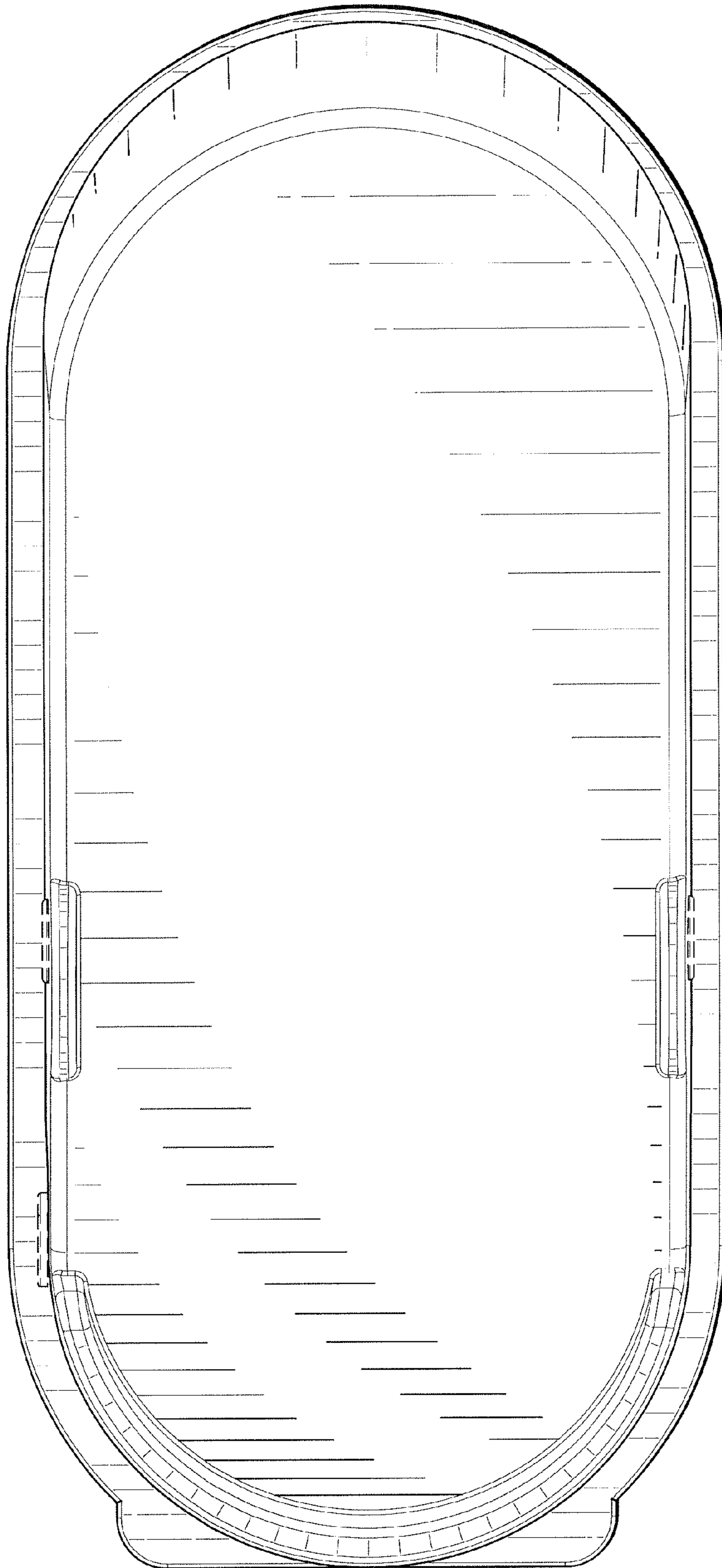

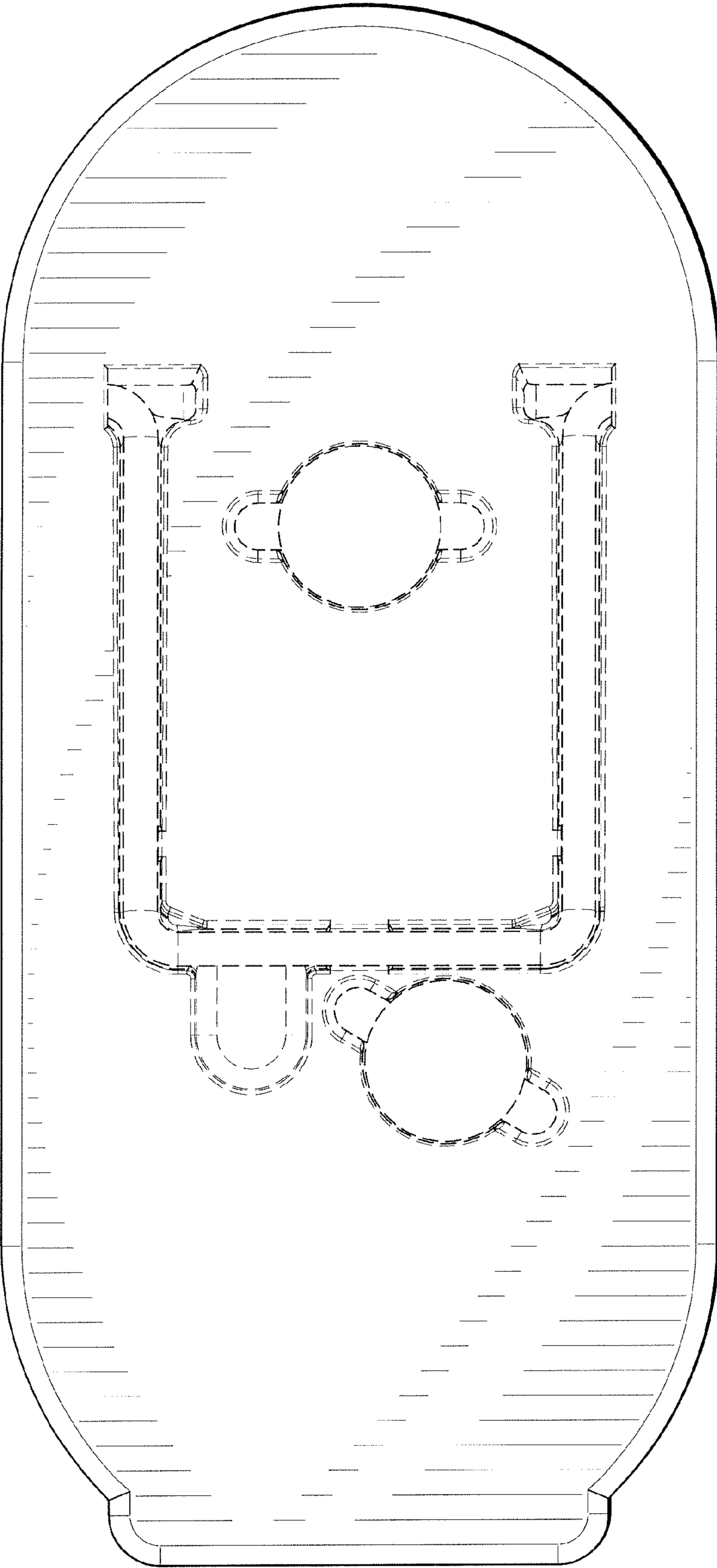

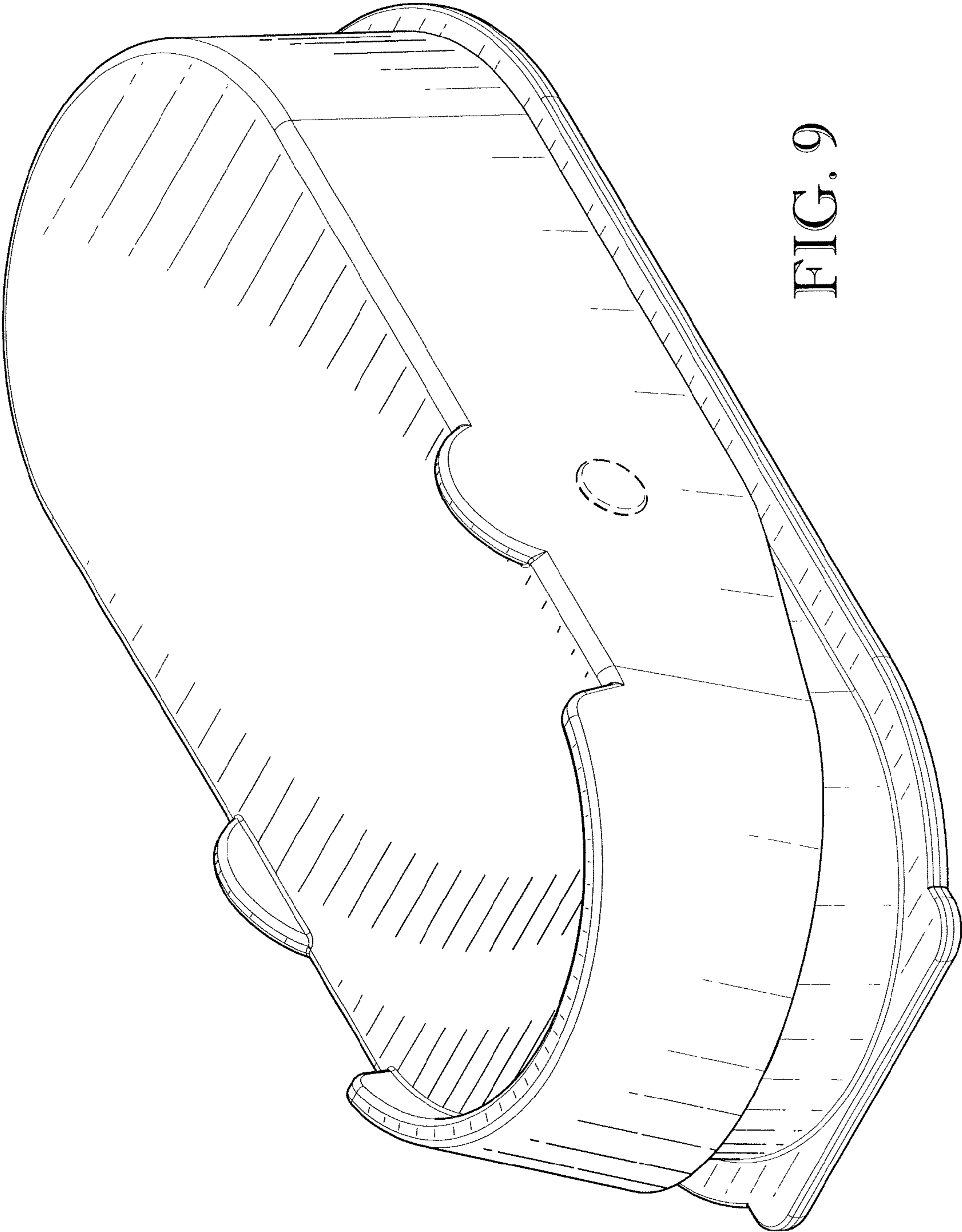
