DESCRIPTION

FIG. 1 is a perspective view of a set top box according to our new design;

FIG. 2 is a front elevational view thereof;

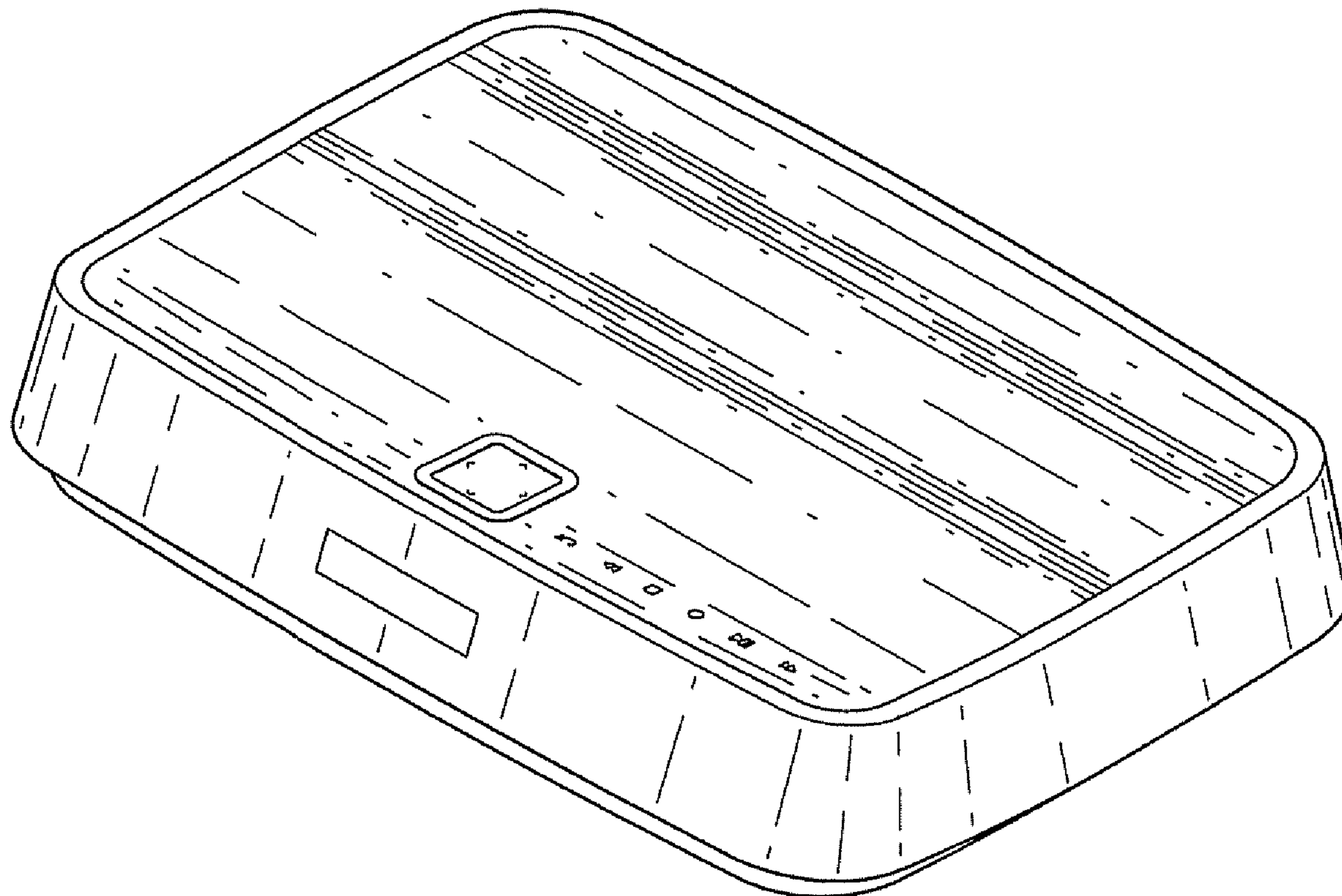

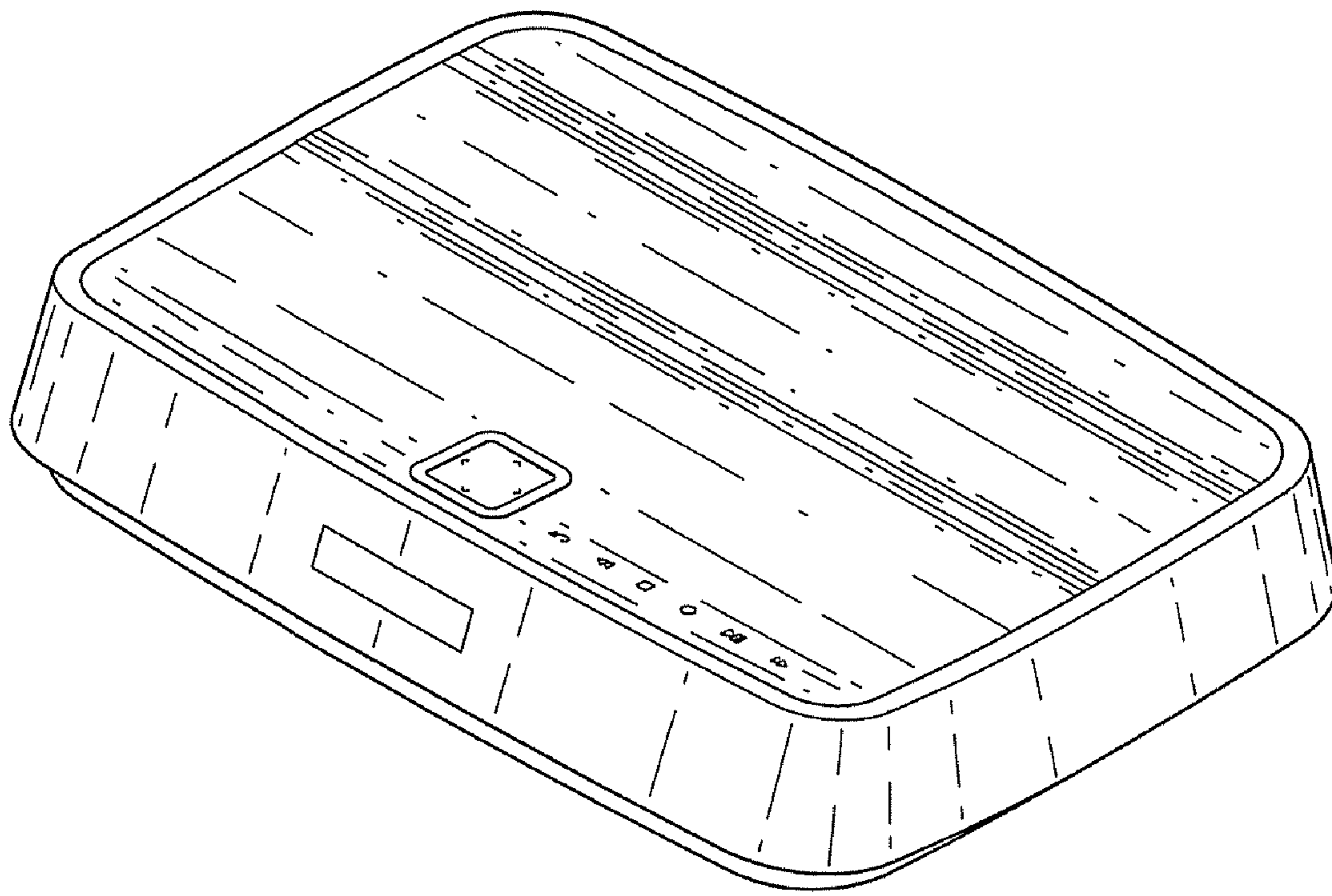

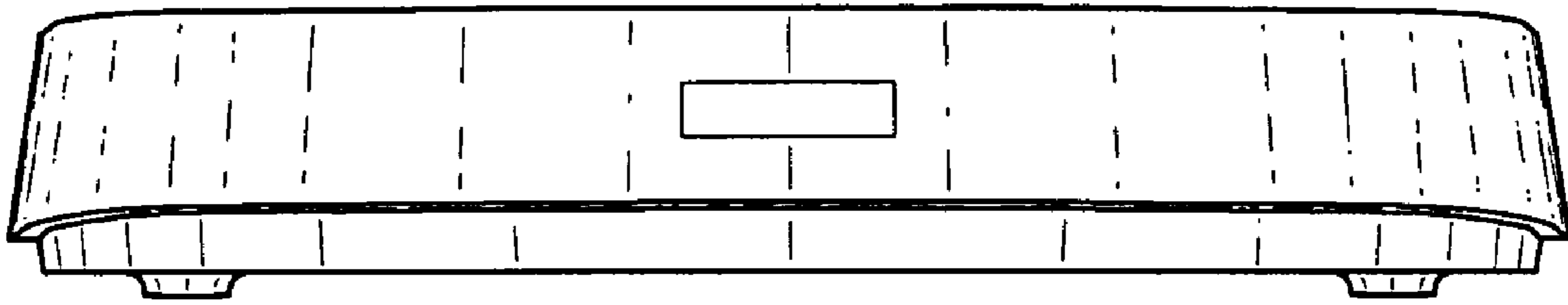

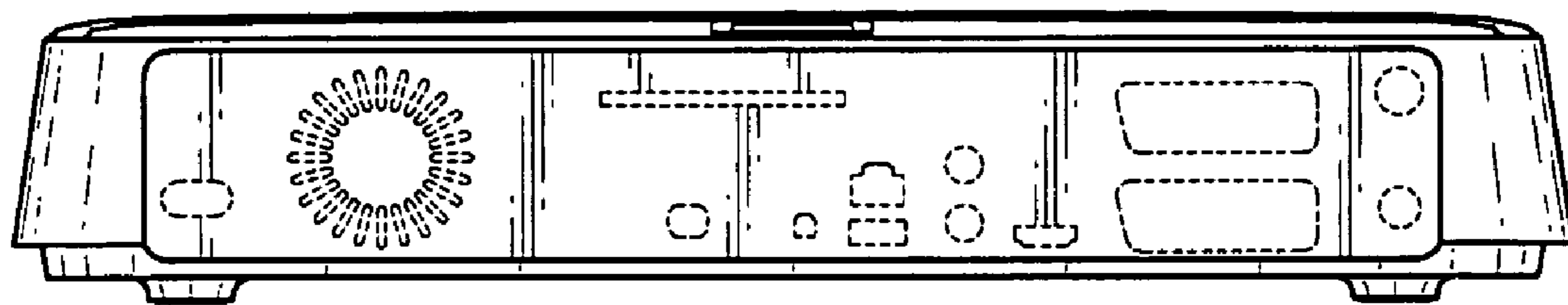

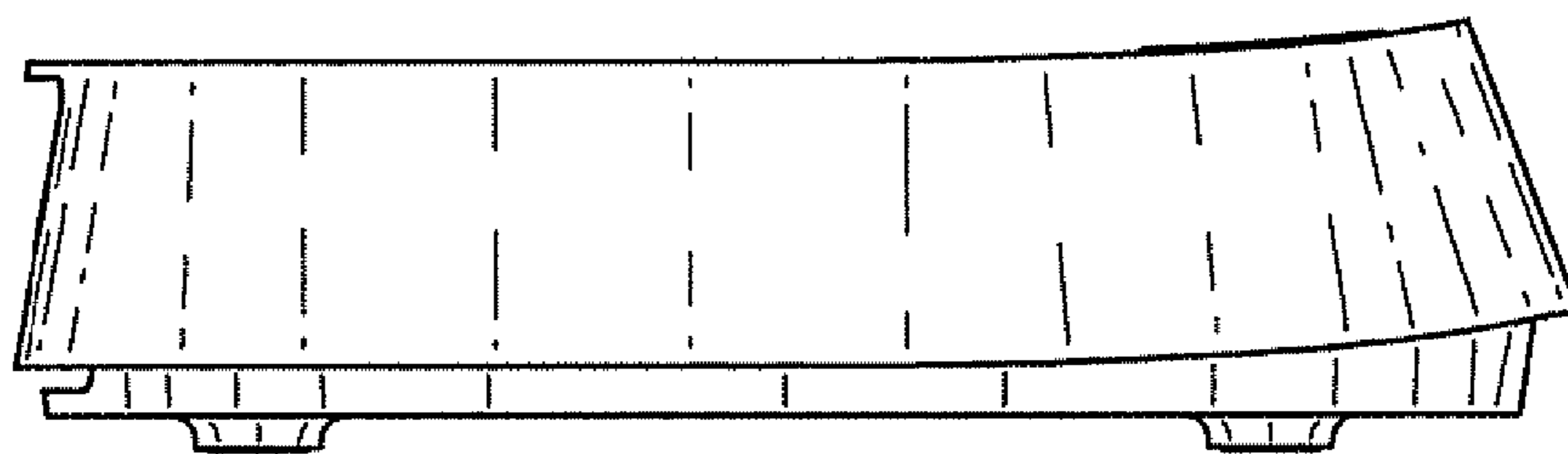

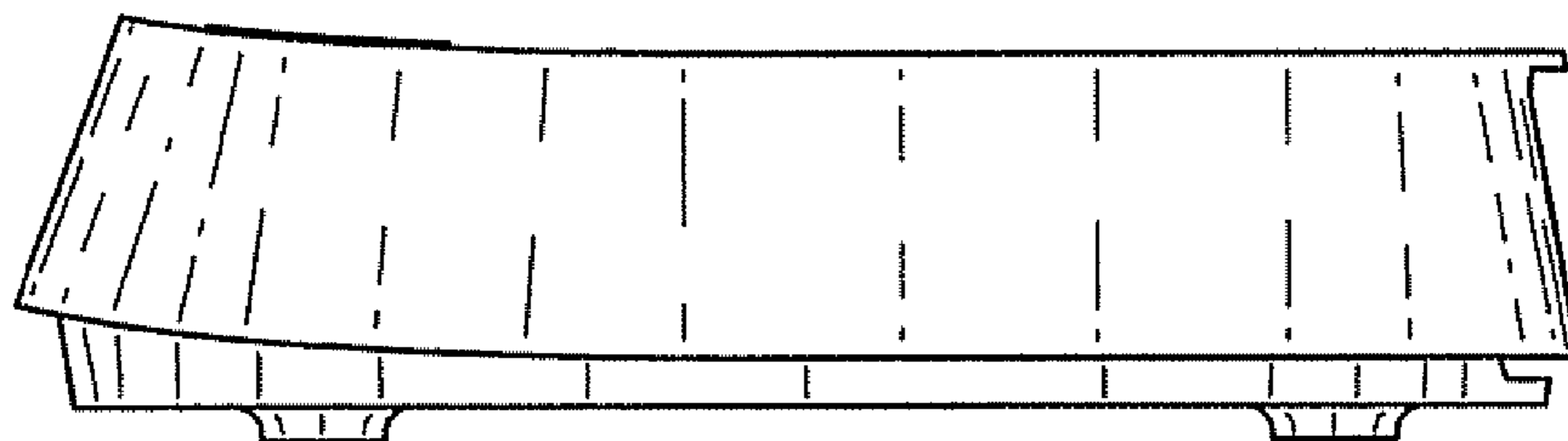

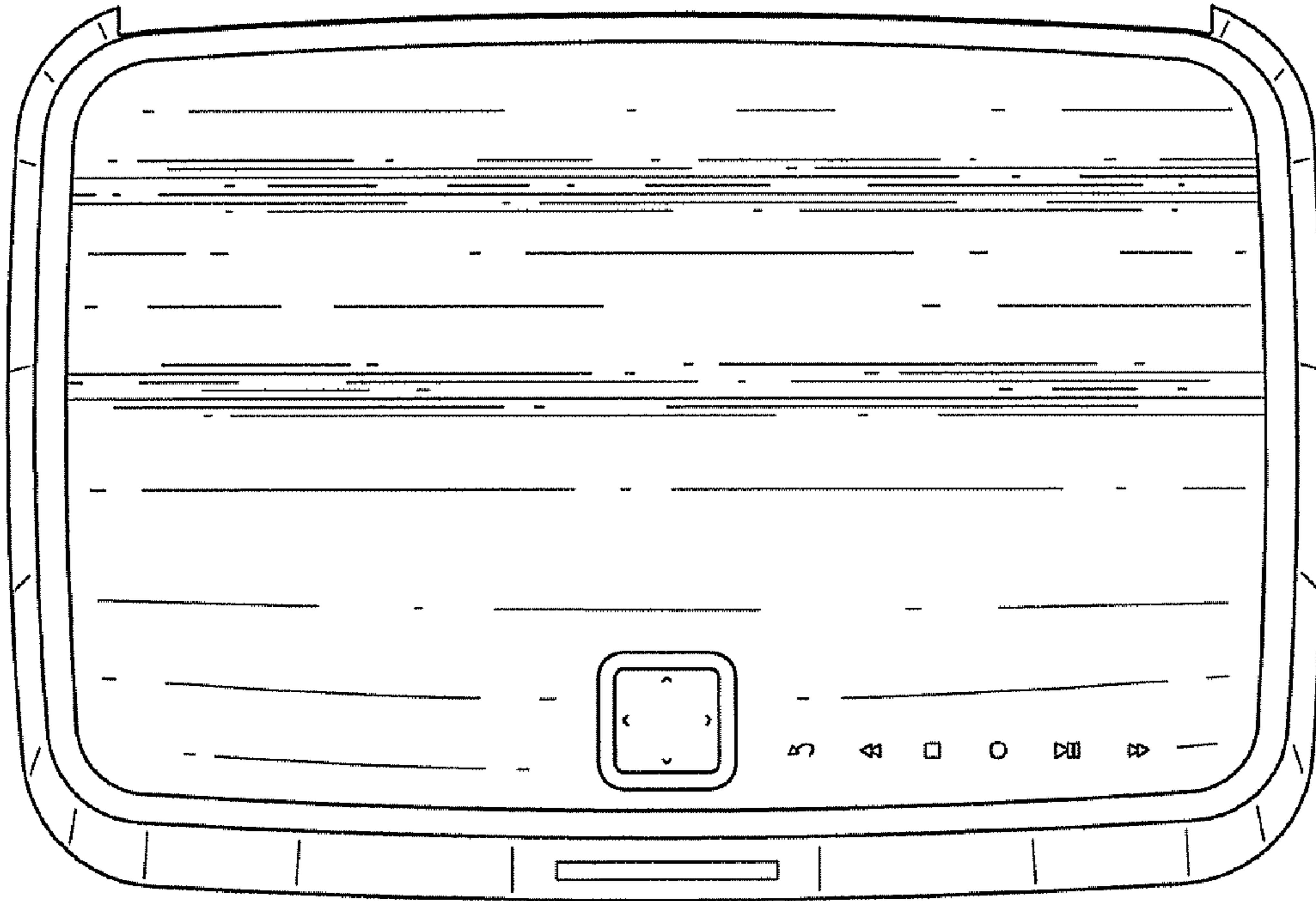
