**DESCRIPTION**

FIG. 1 is a front, right, perspective view of a cellular phone showing our new design;

FIG. 2 is a front view thereof;

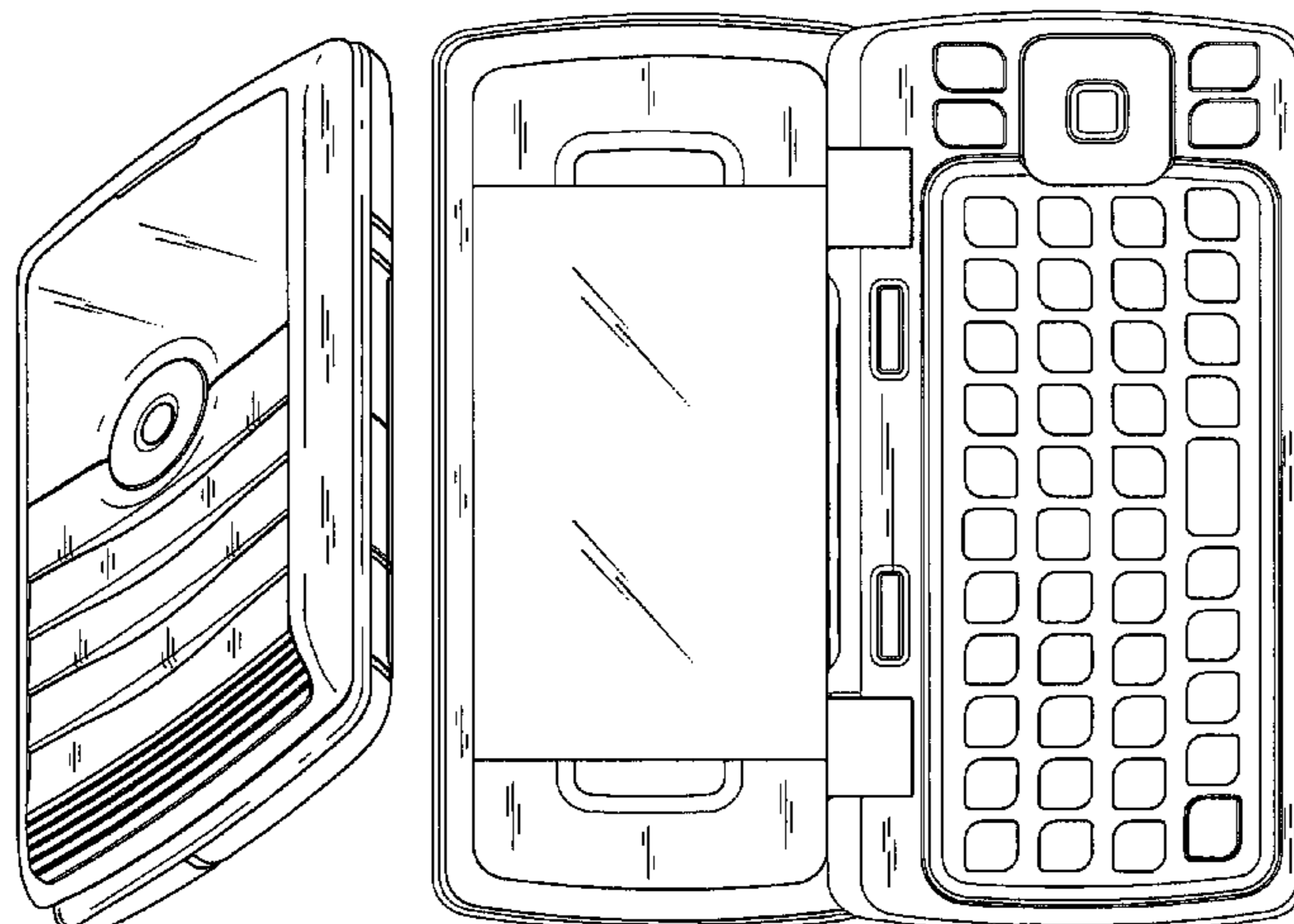

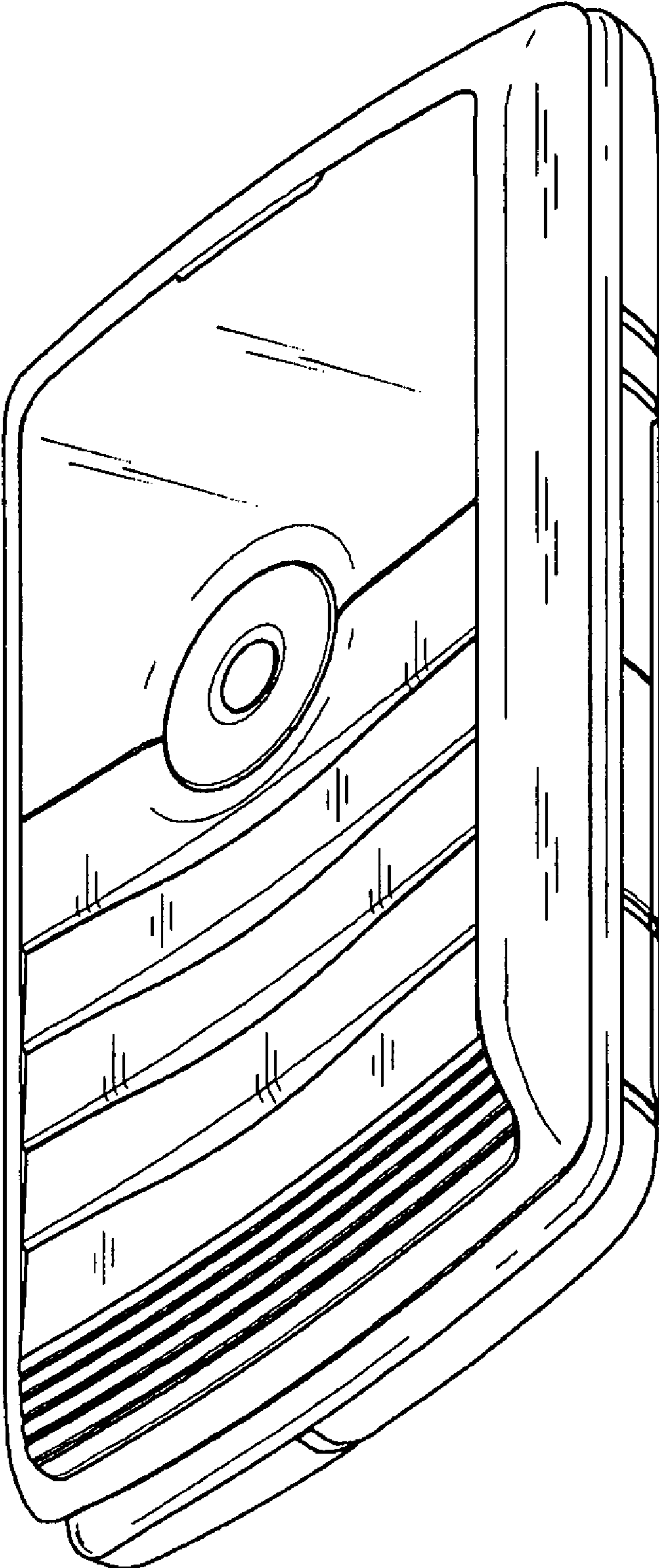

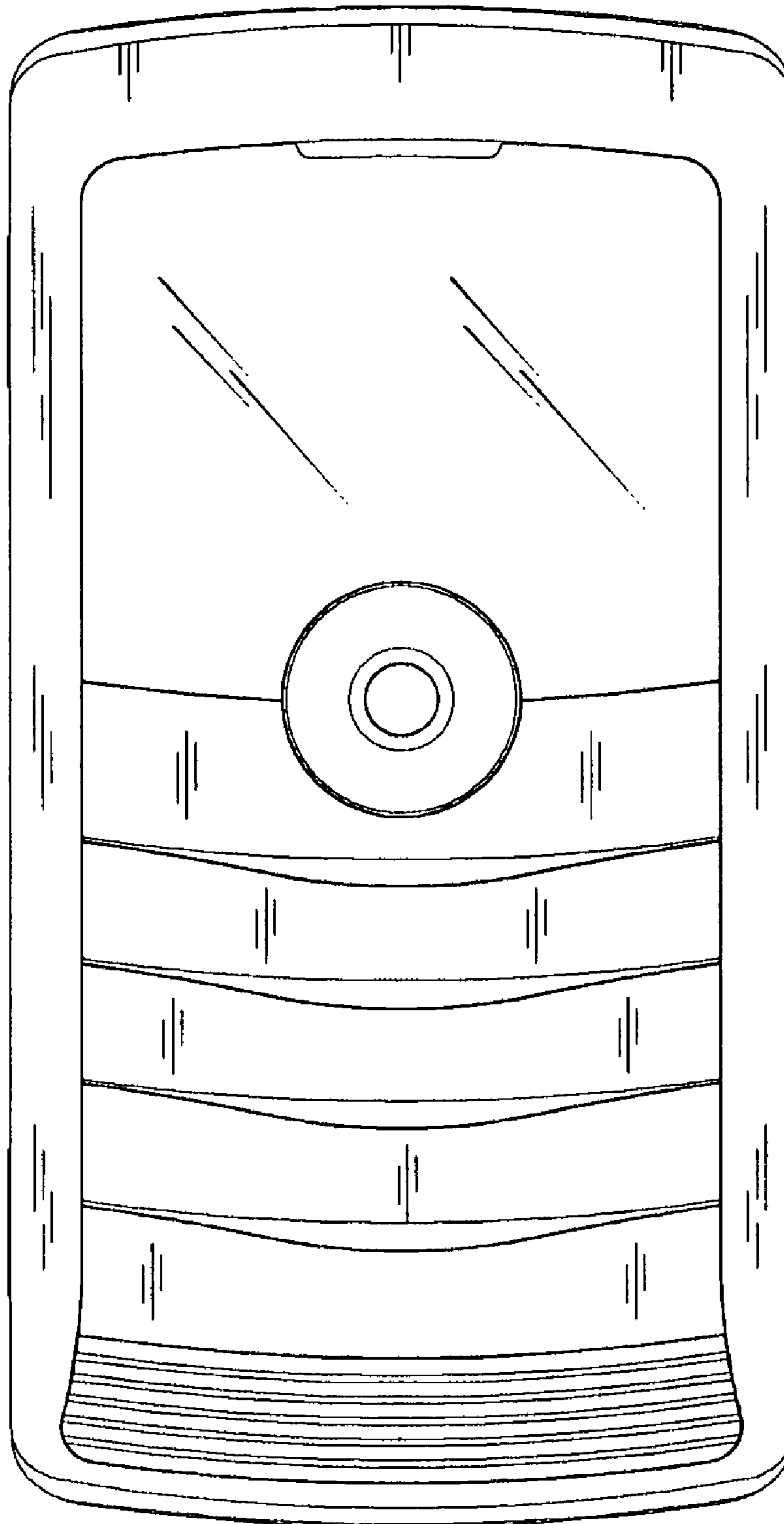

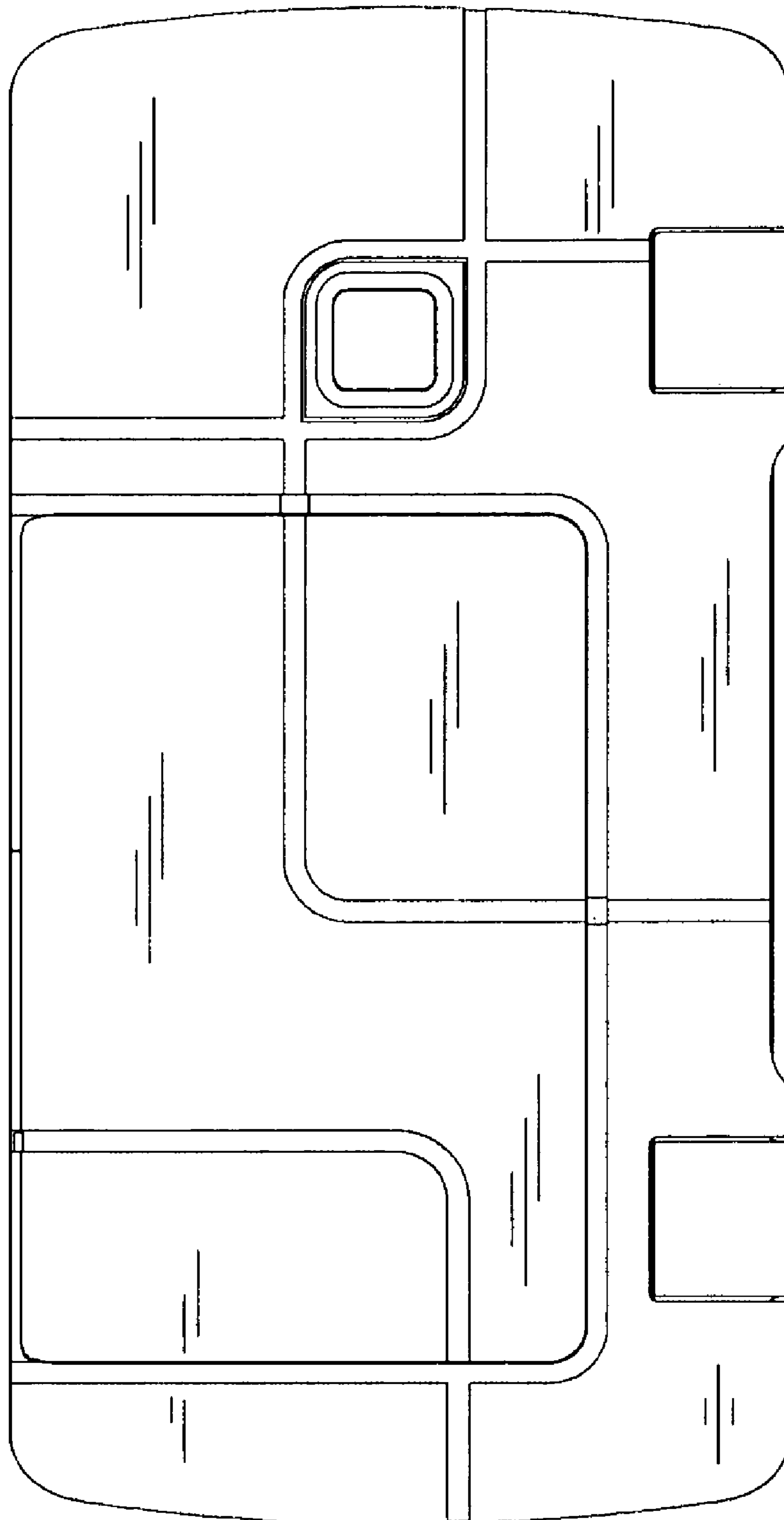

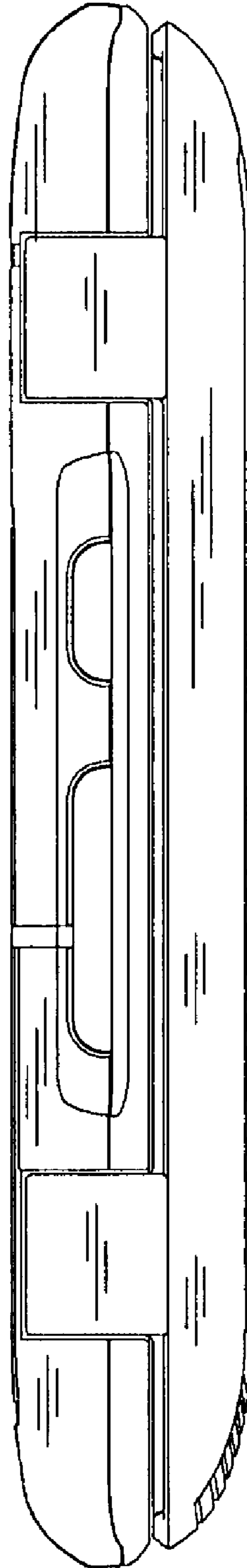

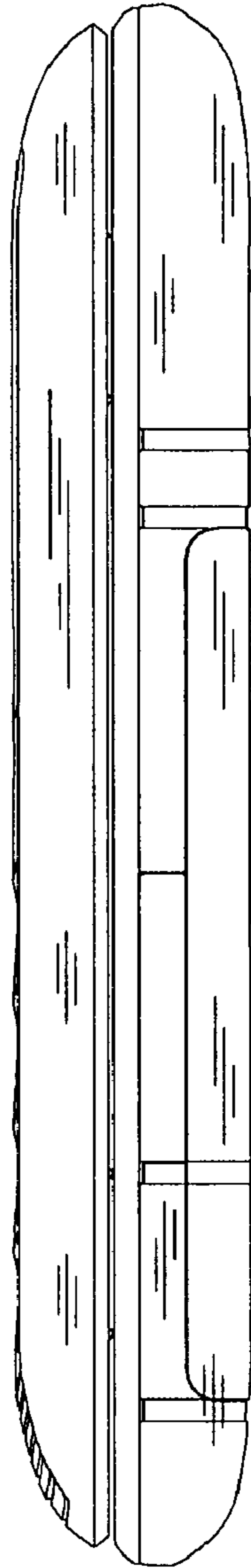

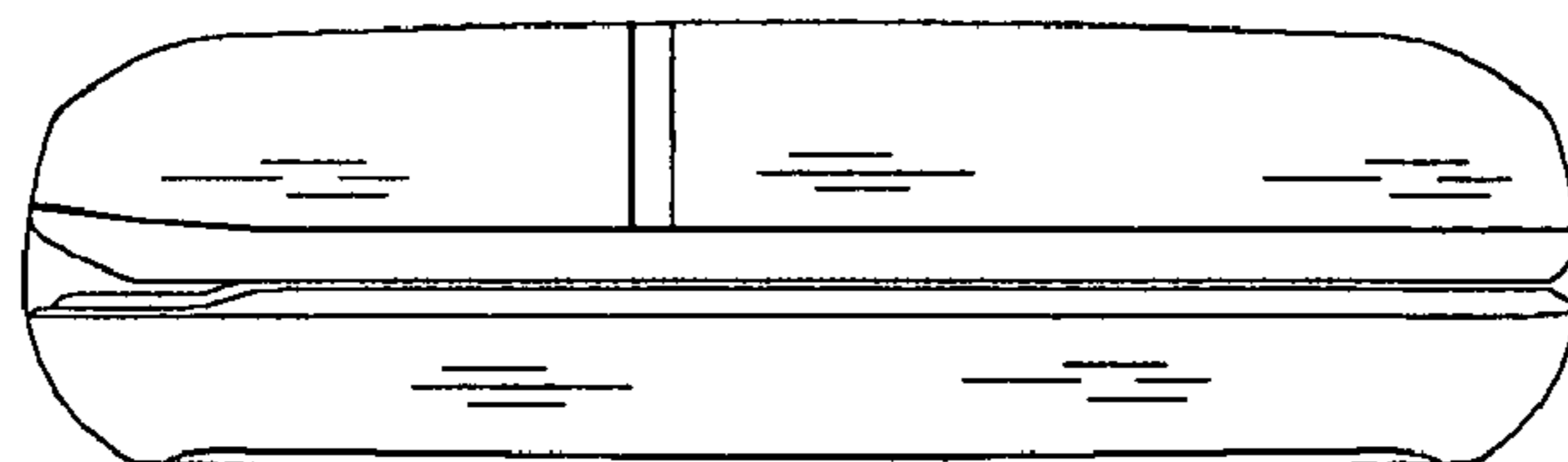

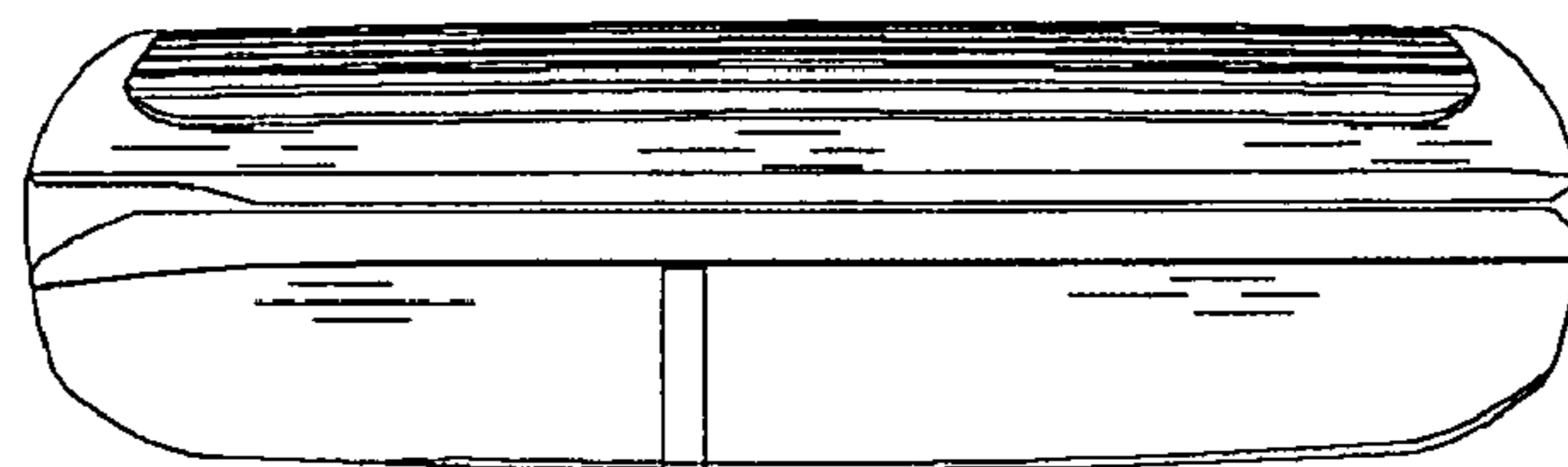
