DESCRIPTION

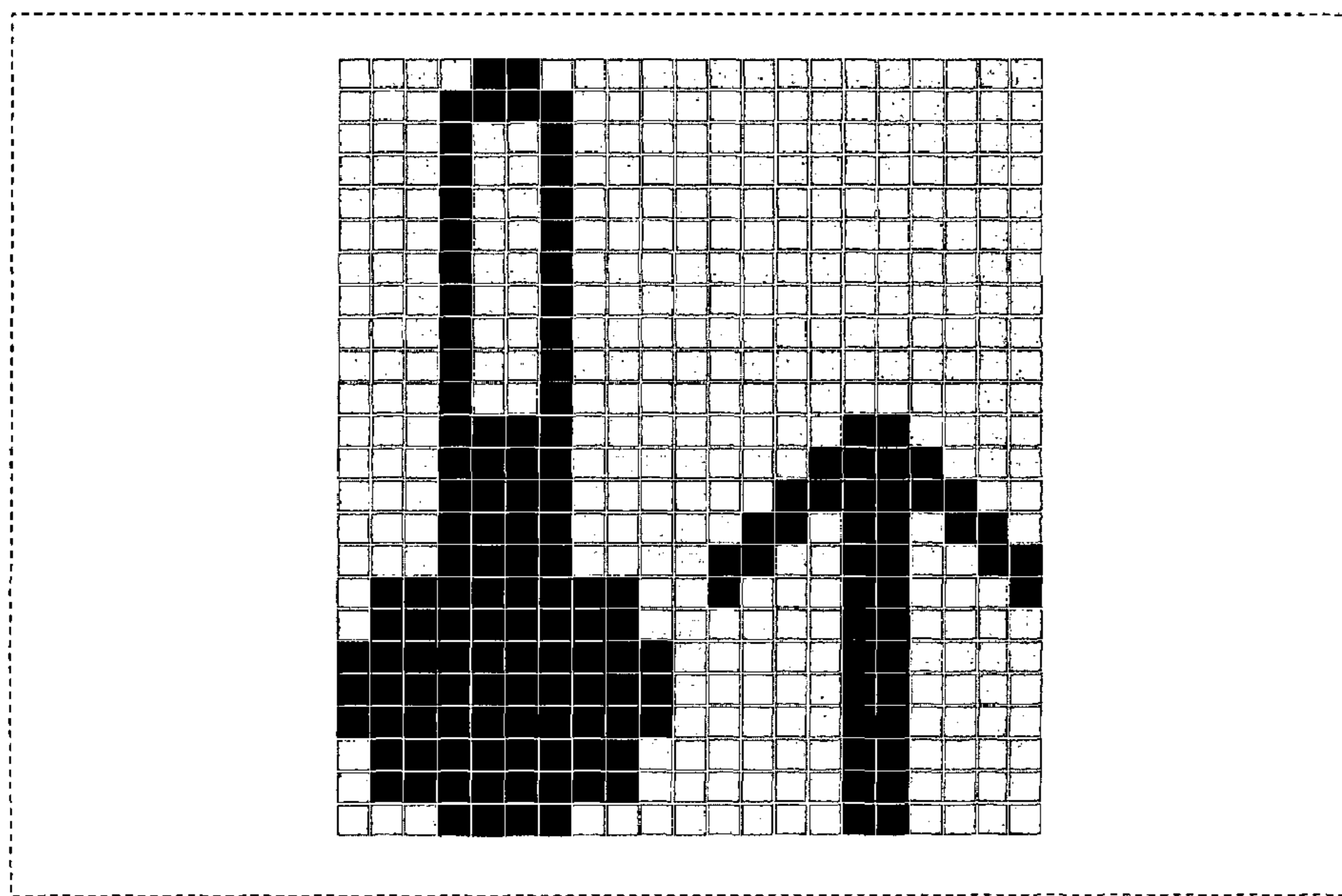
FIG. 1 is a front view of a display for a dishwasher showing my new design;

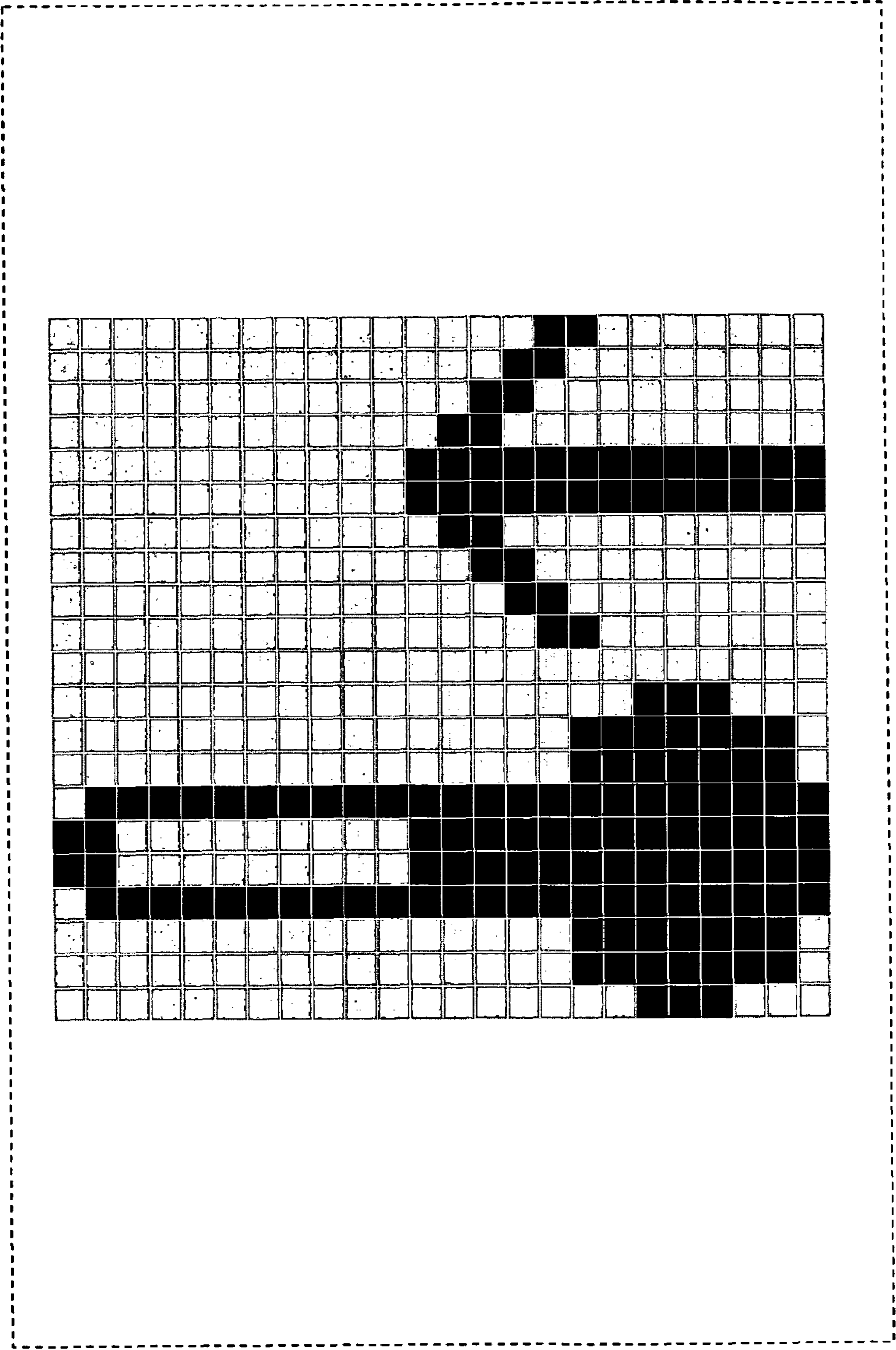

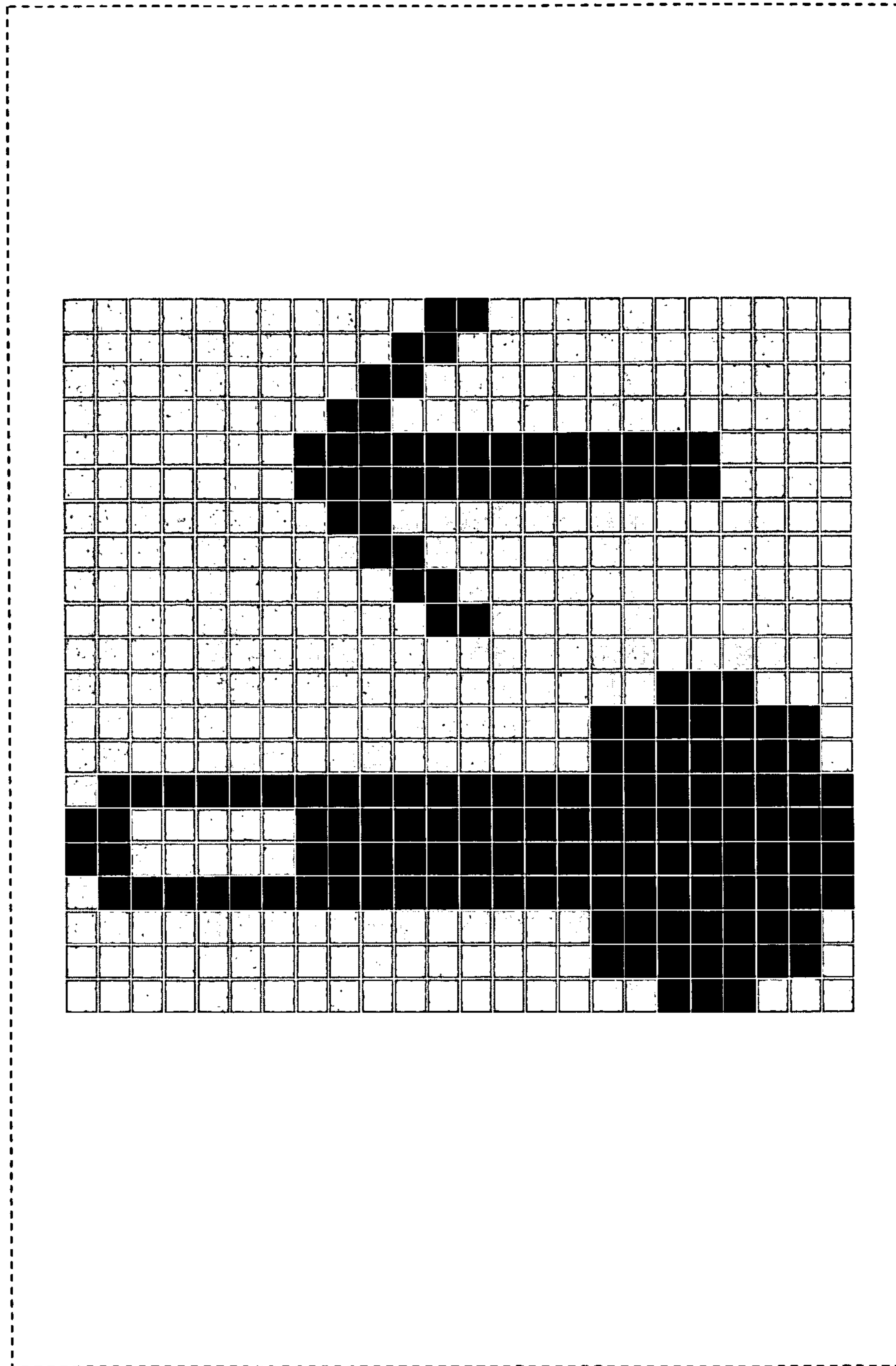
