The ornamental design for an icon for a portion of a display screen, as shown and described.

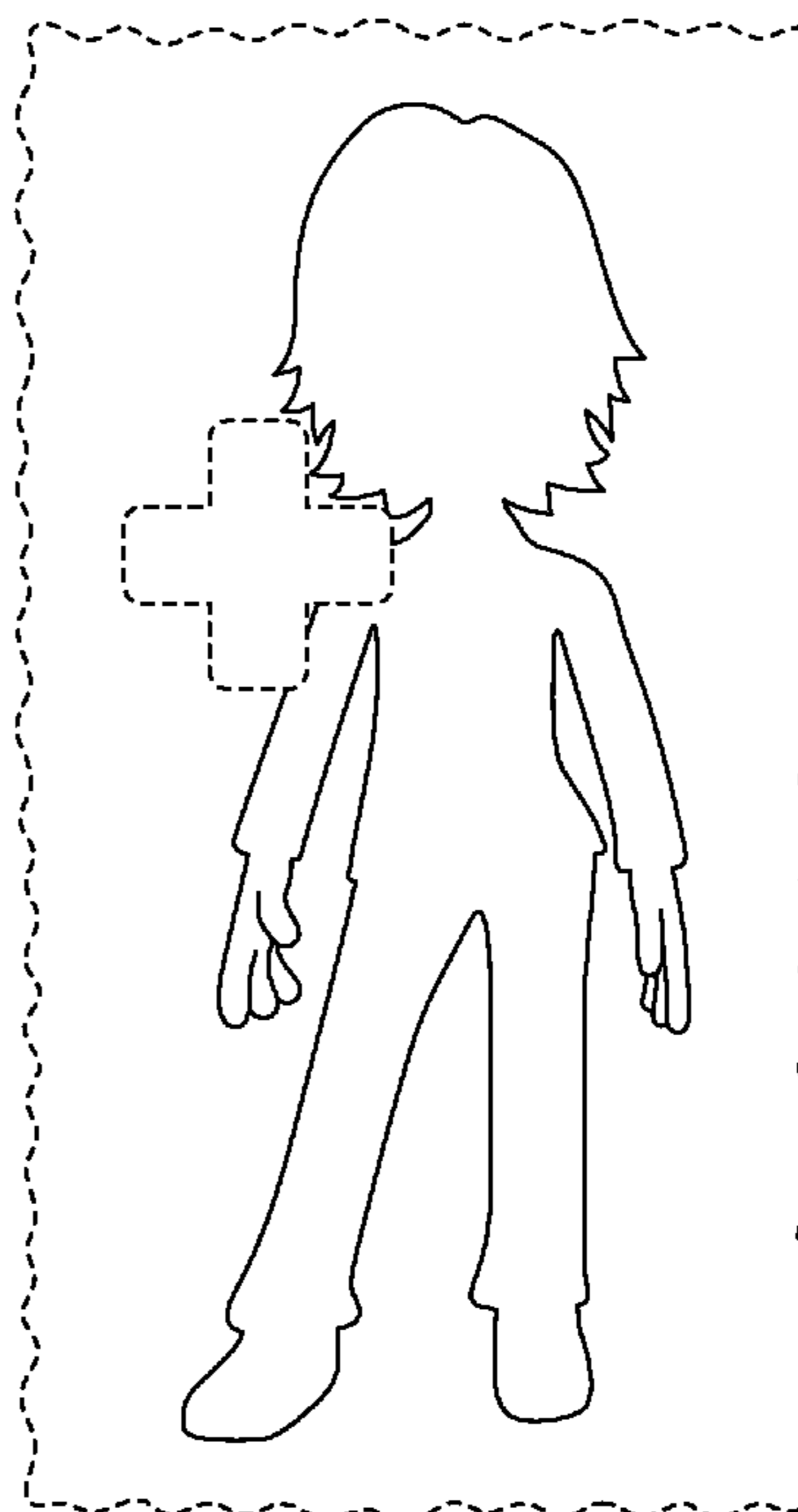
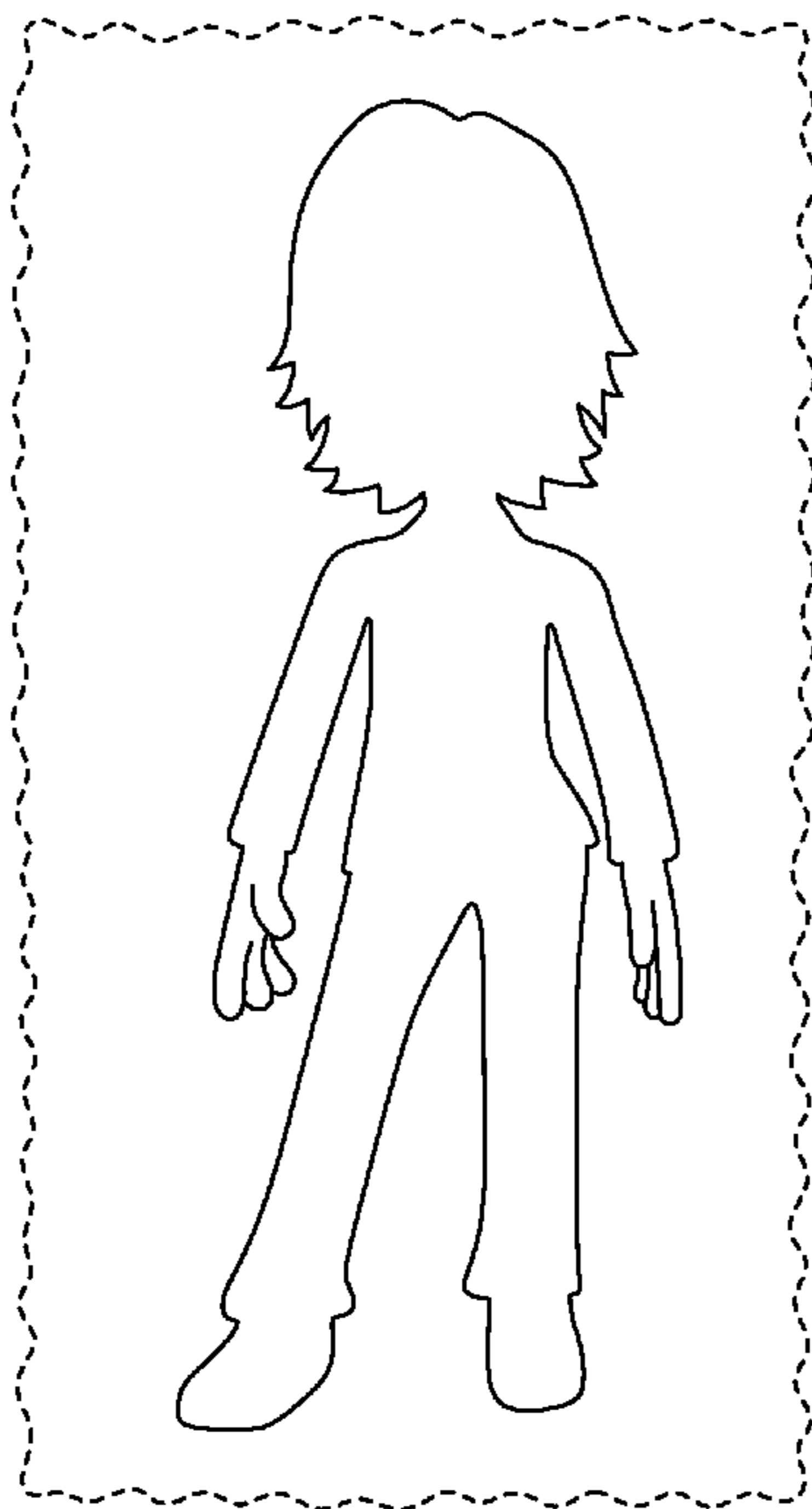
DESCRIPTION

FIG. 1 is a front view of an icon for a portion of a display screen showing the new design in a first embodiment; and,

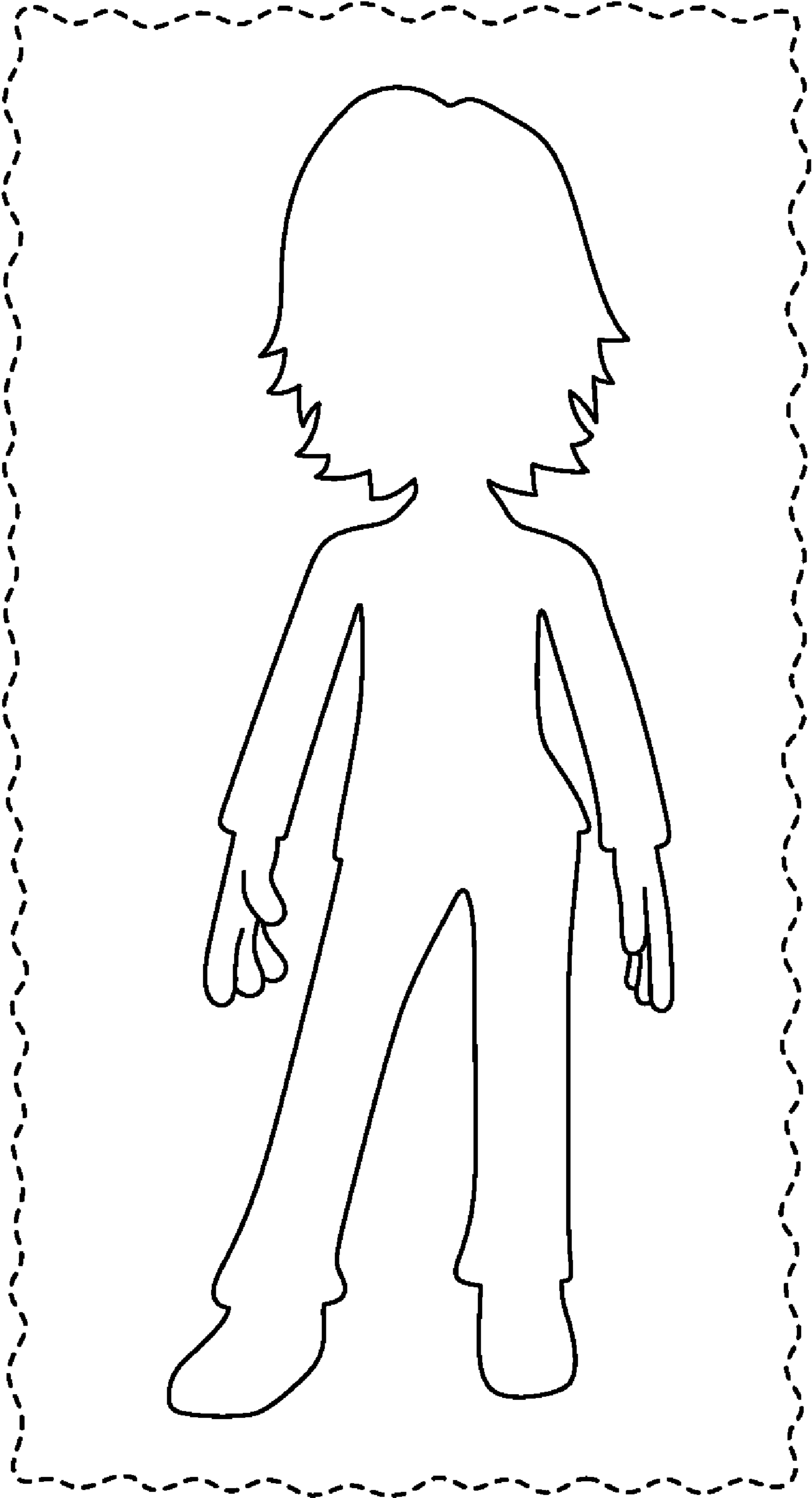

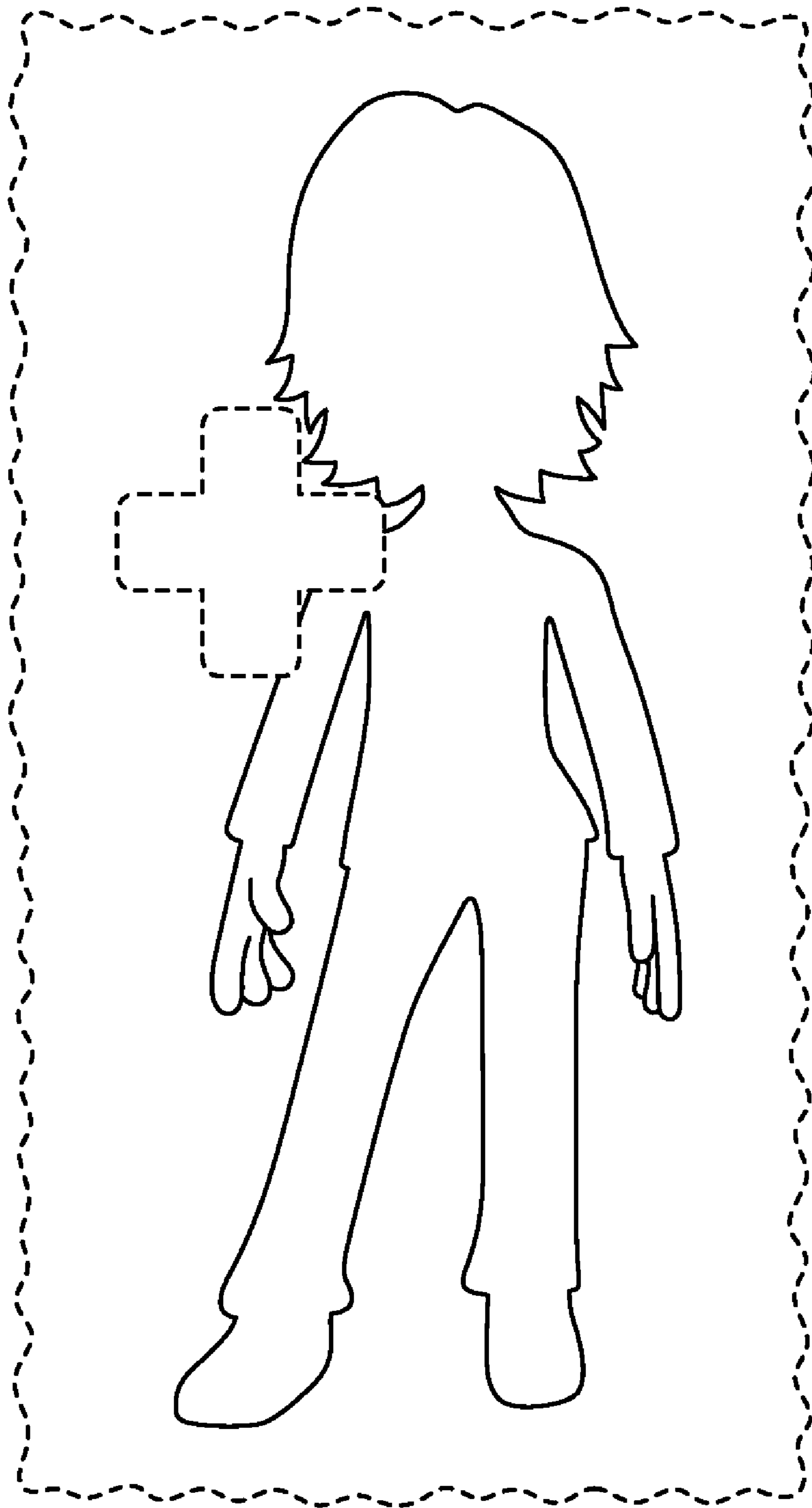
