The ornamental design for a document organizer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the document organizer shown in an expanded position of use;

FIG. 2 is top plan view thereof;

FIG. 4 is an end elevational view of thereof; the opposing side, end elevational view mirrors the view shown;

FIG. 6 shows a perspective, end view of a document organizer.

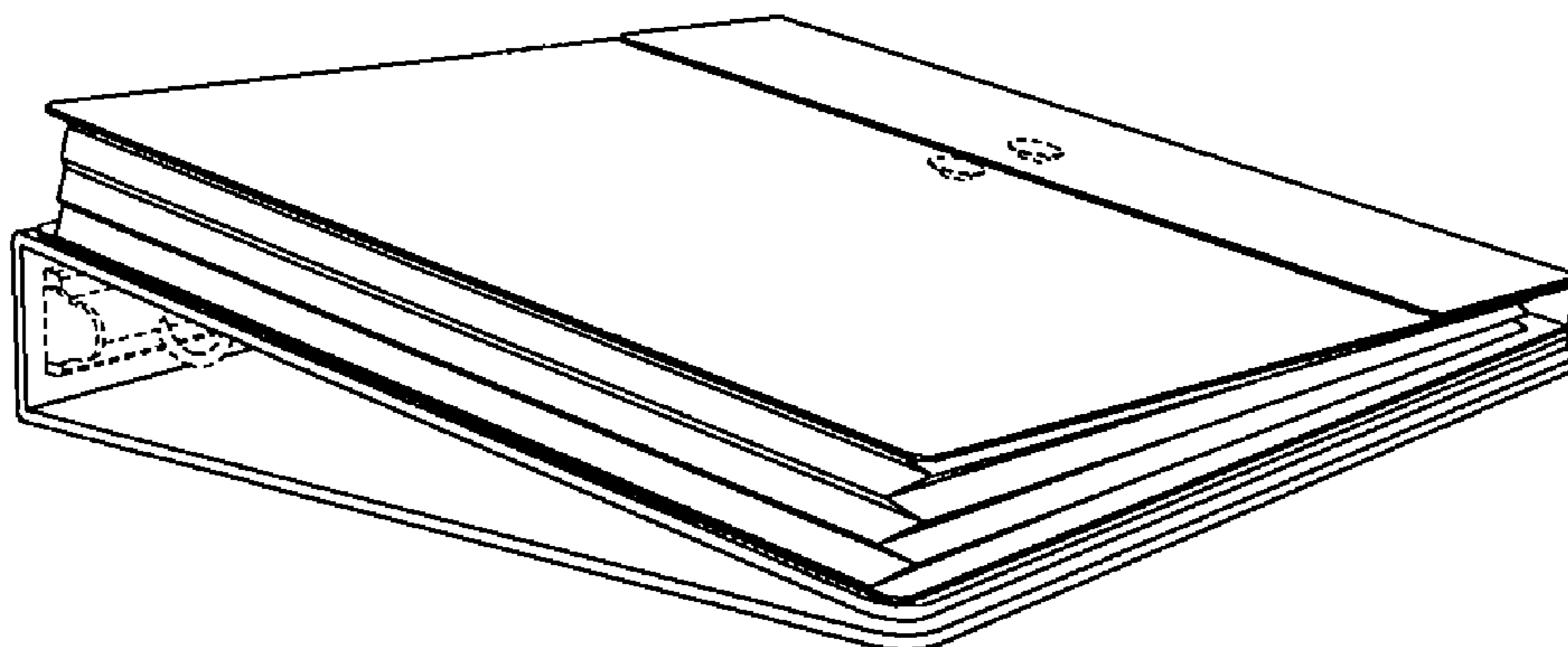
FIG. 7 is side, elevational view of a document organizer.

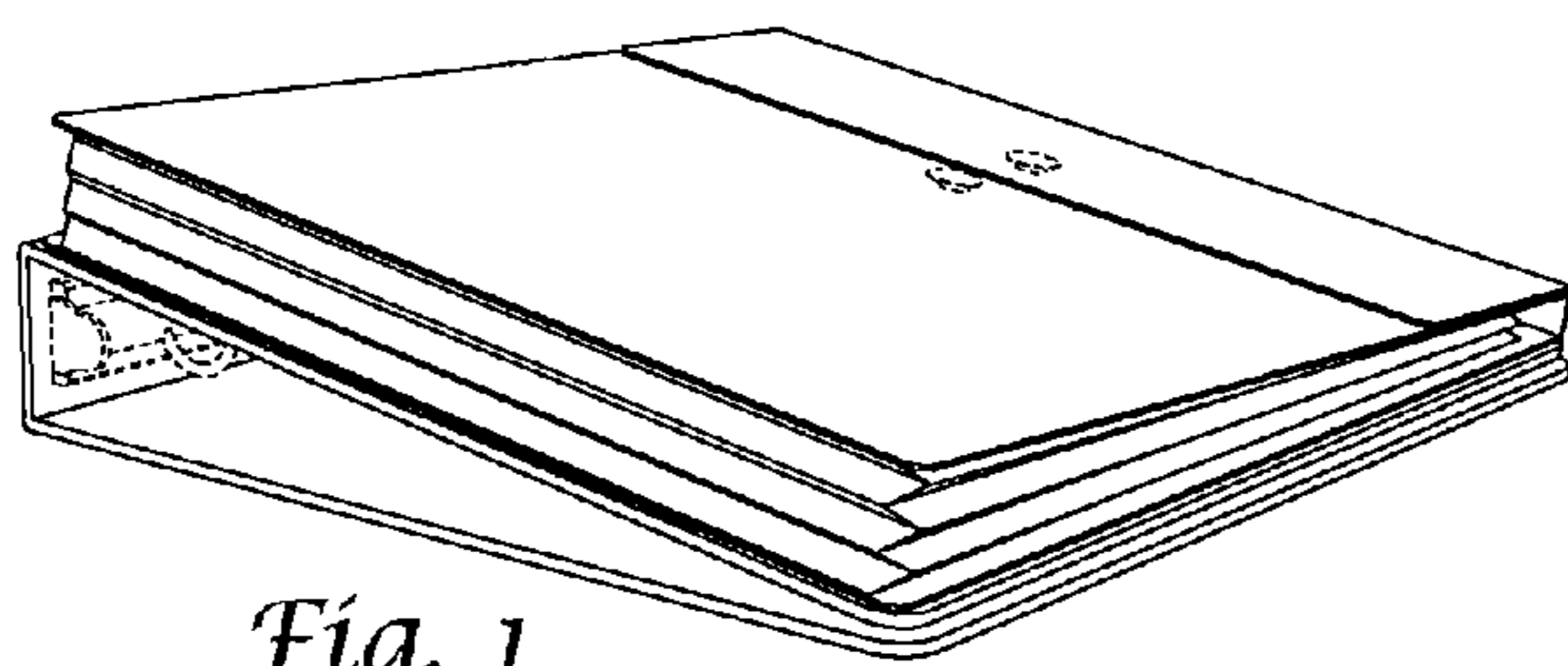
FIG. 8 is an end, elevational view of a document organizer. The opposing side, end elevational view mirrors the view shown; and,

FIG. 9 is a back, elevational view of a document organizer.

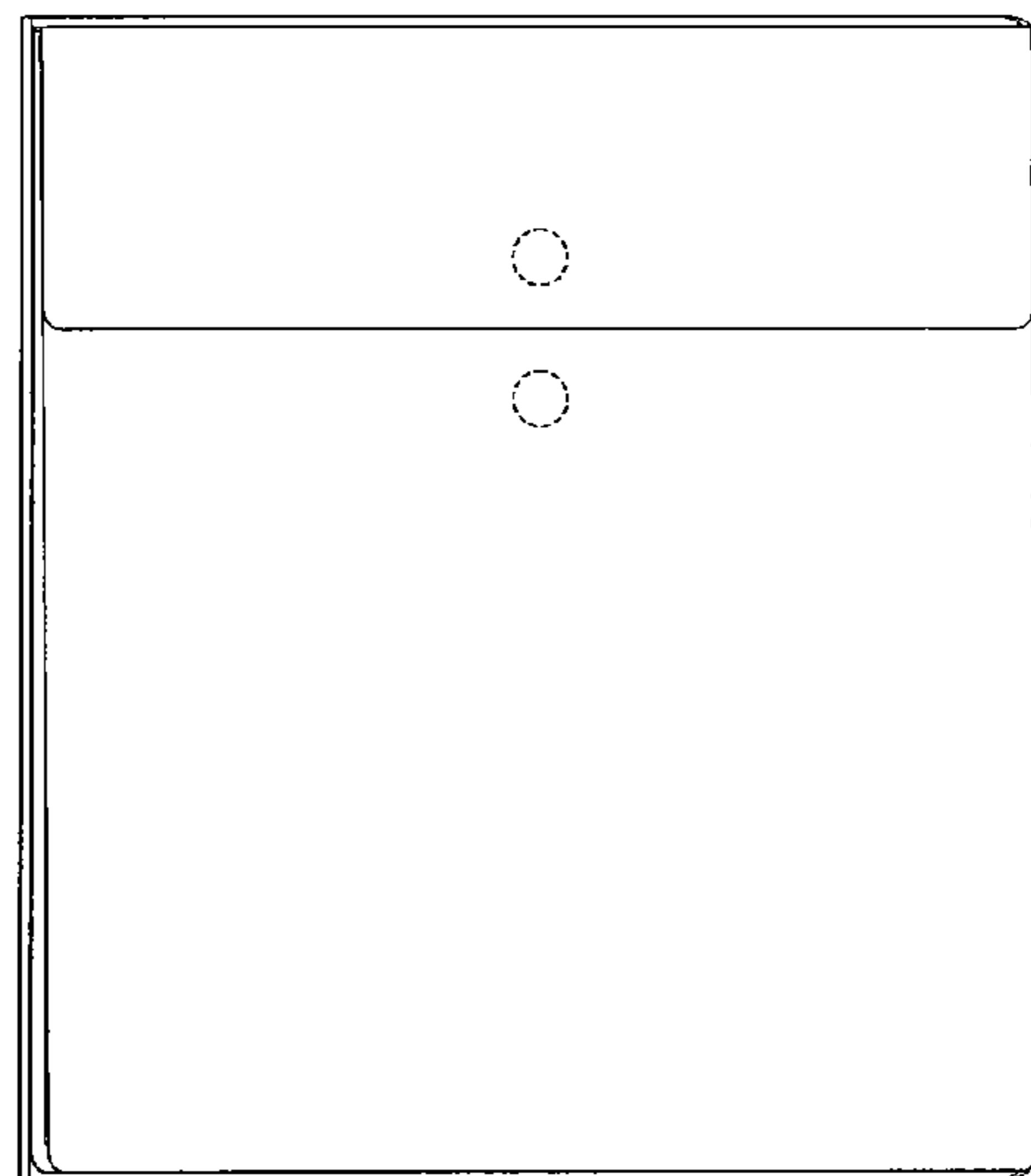
The broken lines shown in the drawings represent unclaimed portions of the document organizer and form no part of the claimed design.

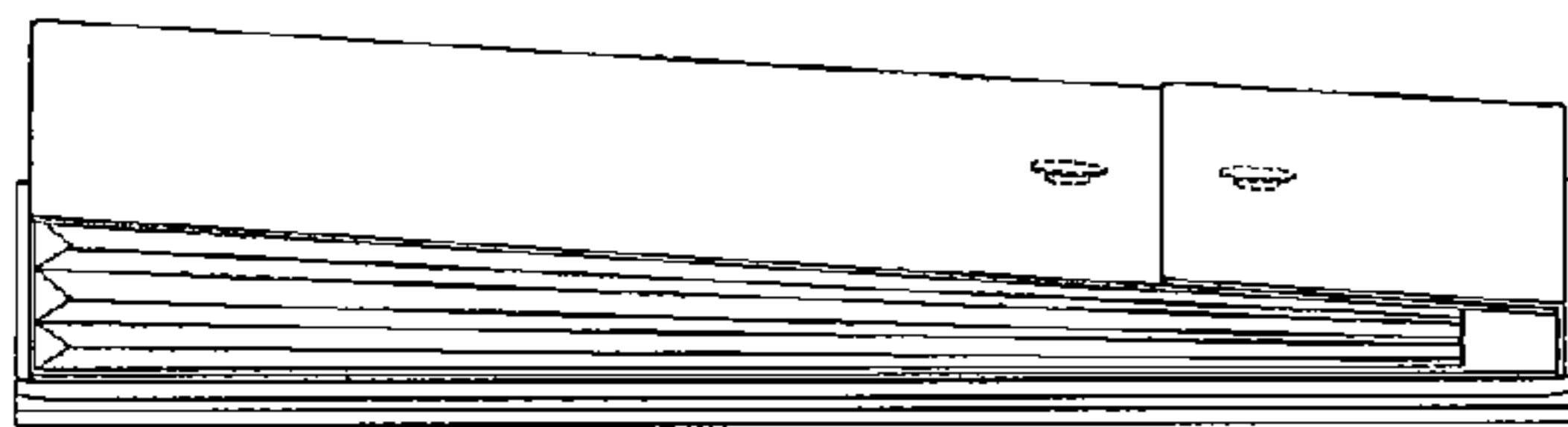




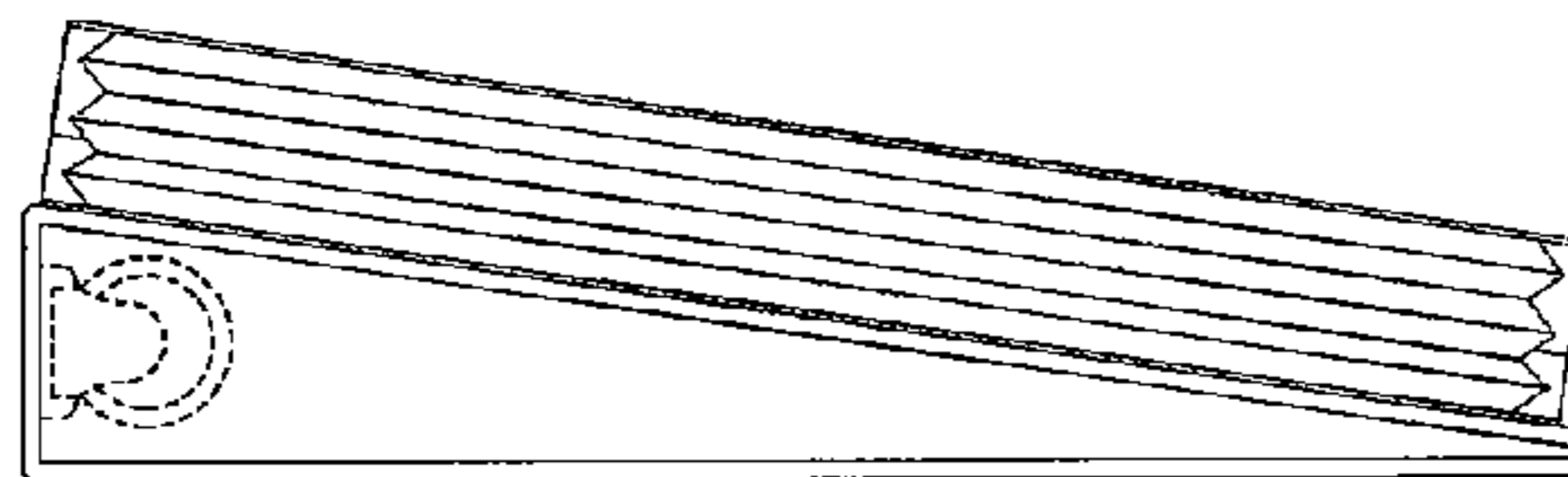

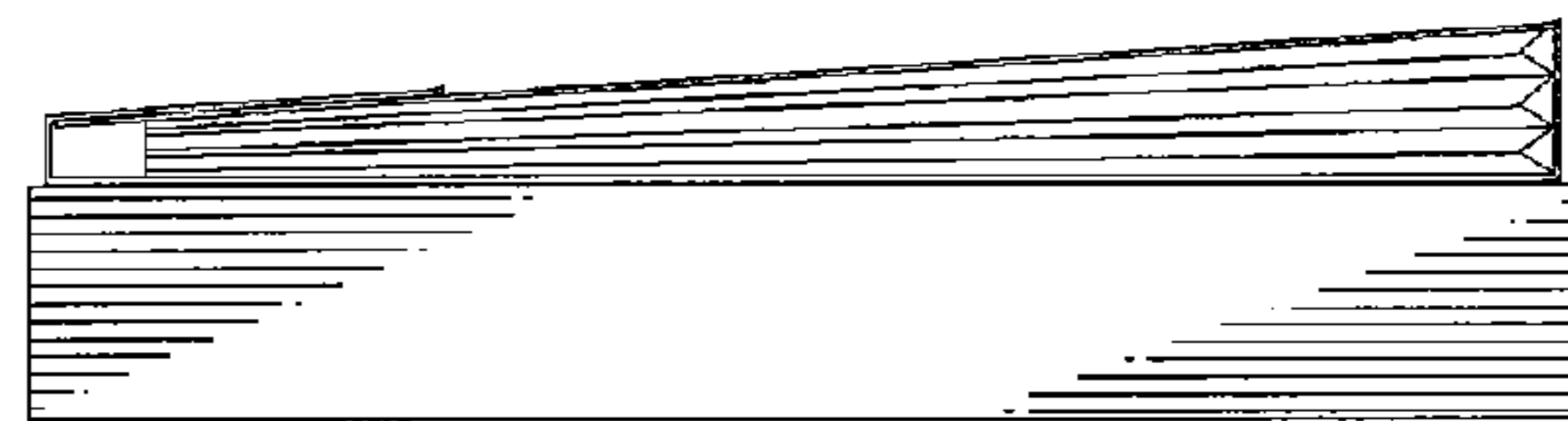


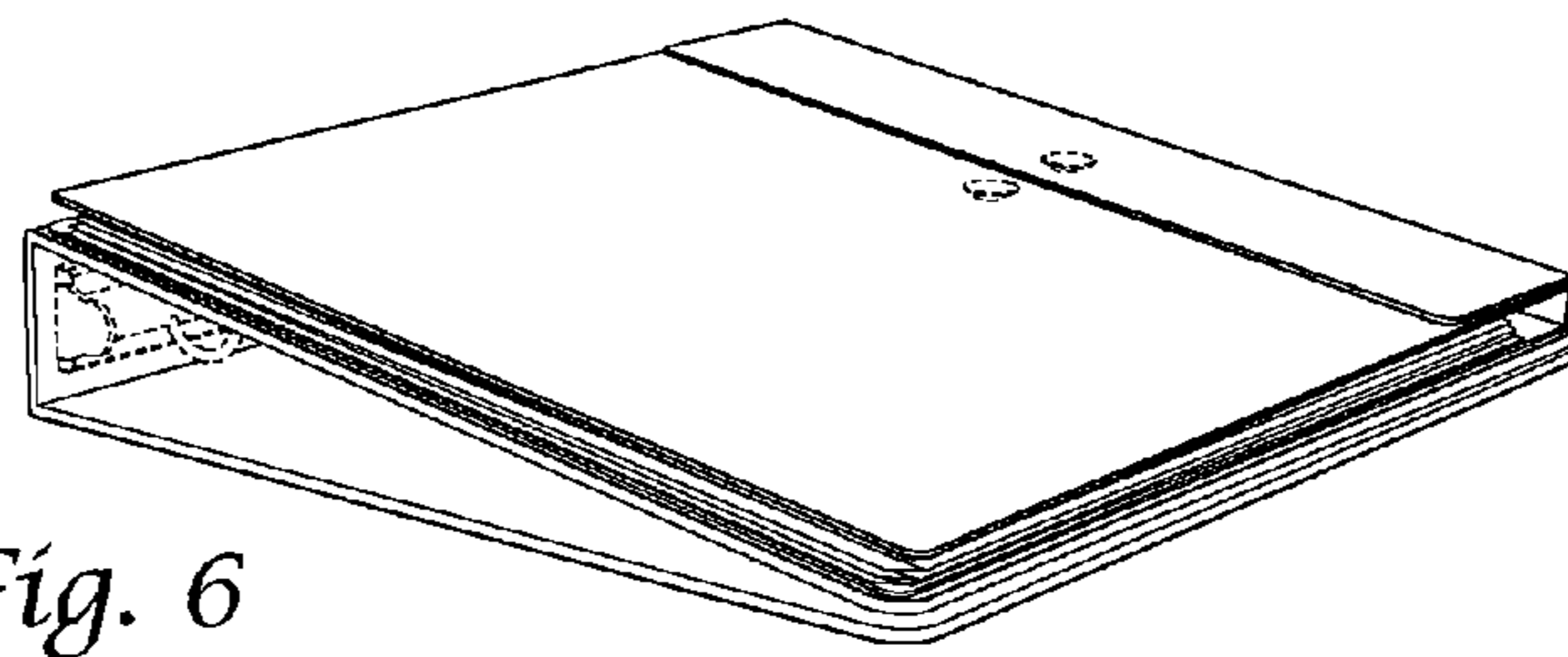

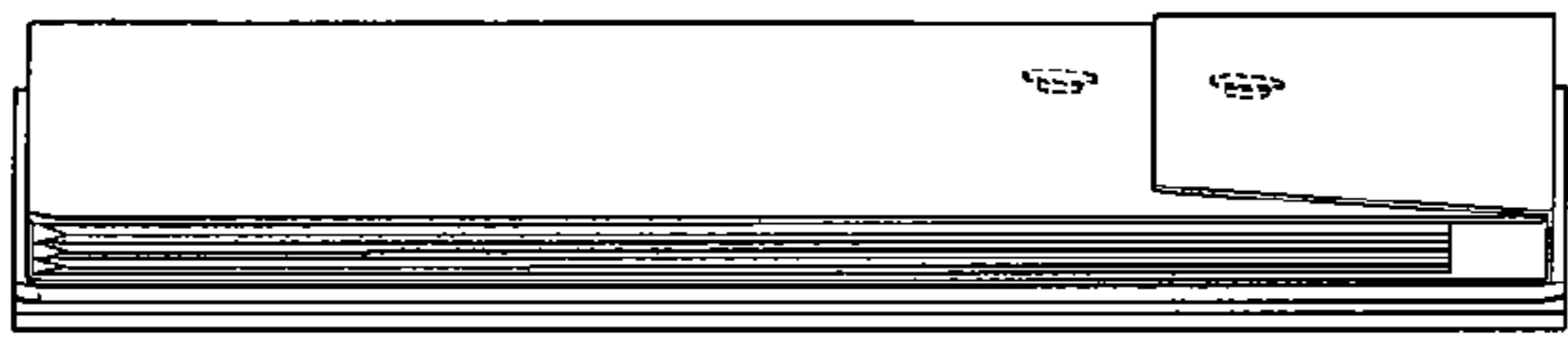

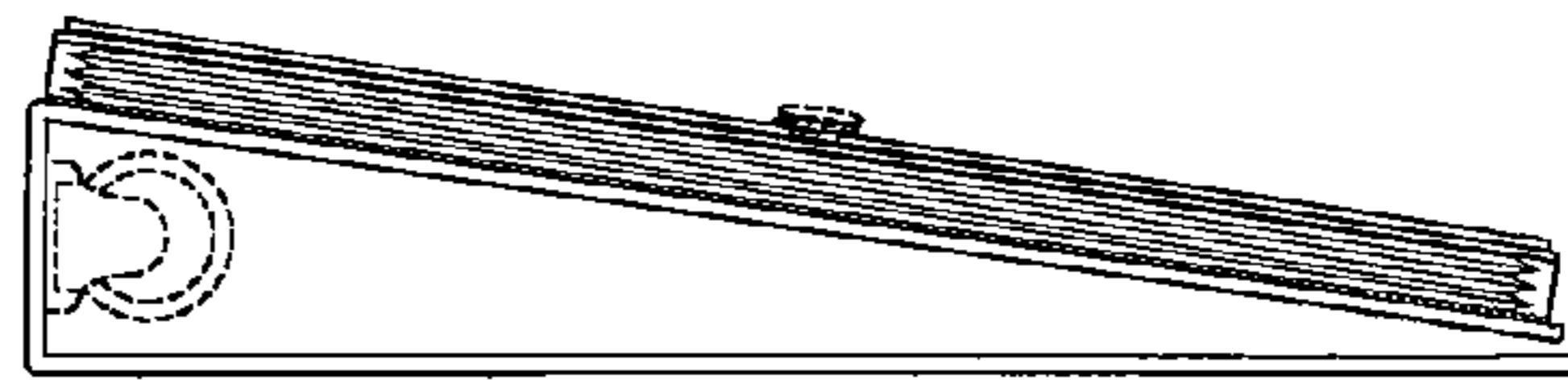




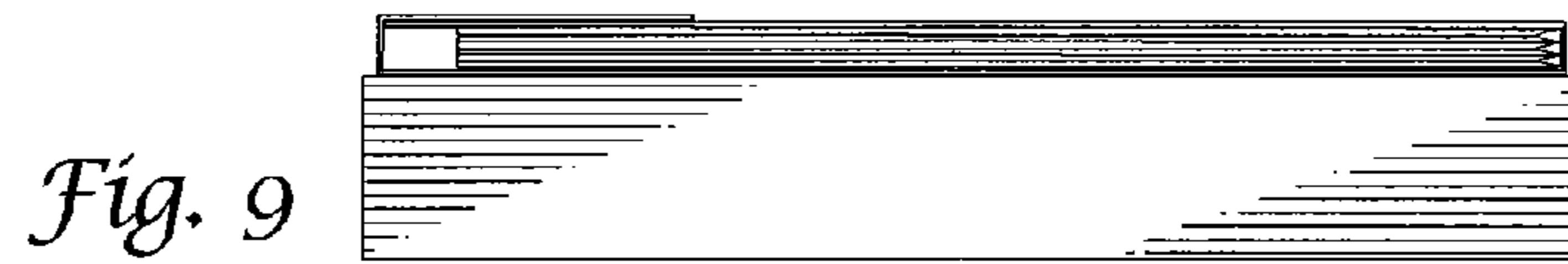
