(57) **CLAIM**

An ornamental design for a writing instrument, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a writing instrument;

FIG. 2 is a right side, elevational view thereof, the side opposite being a mirror image thereof;

FIG. 3 is a top, plan view thereof;

FIG. 4 is a bottom, plan view thereof;

FIG. 5 is a front, elevational view thereof;

FIG. 6 is a rear, elevational view thereof.

FIG. 7 is a perspective view of a second embodiment of a writing instrument;

FIG. 8 is a right side, elevational view thereof, the side opposite being a mirror image thereof;

FIG. 9 is a top, plan view thereof;

FIG. 10 is a bottom, plan view thereof;

FIG. 11 is a front, elevational view thereof;

FIG. 12 is a rear, elevational view thereof;

FIG. 13 is a perspective view thereof, with the cap of the writing instrument removed;

FIG. 14 is a perspective view of a third embodiment of a writing instrument;

FIG. 15 is a right side, elevational view thereof, the side opposite being a mirror image thereof;

FIG. 16 is a top plan view thereof;

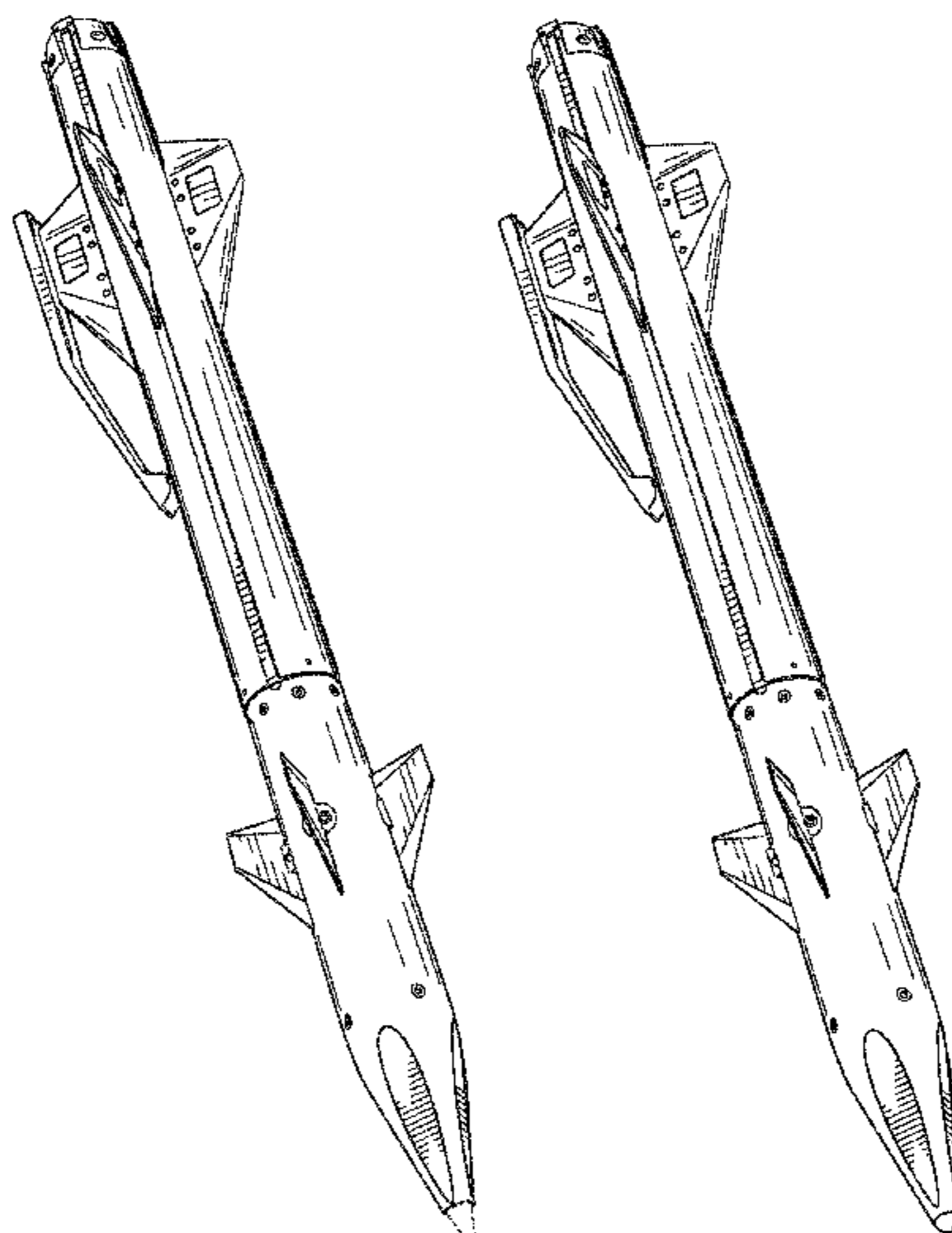
FIG. 17 is a bottom, plan view thereof;

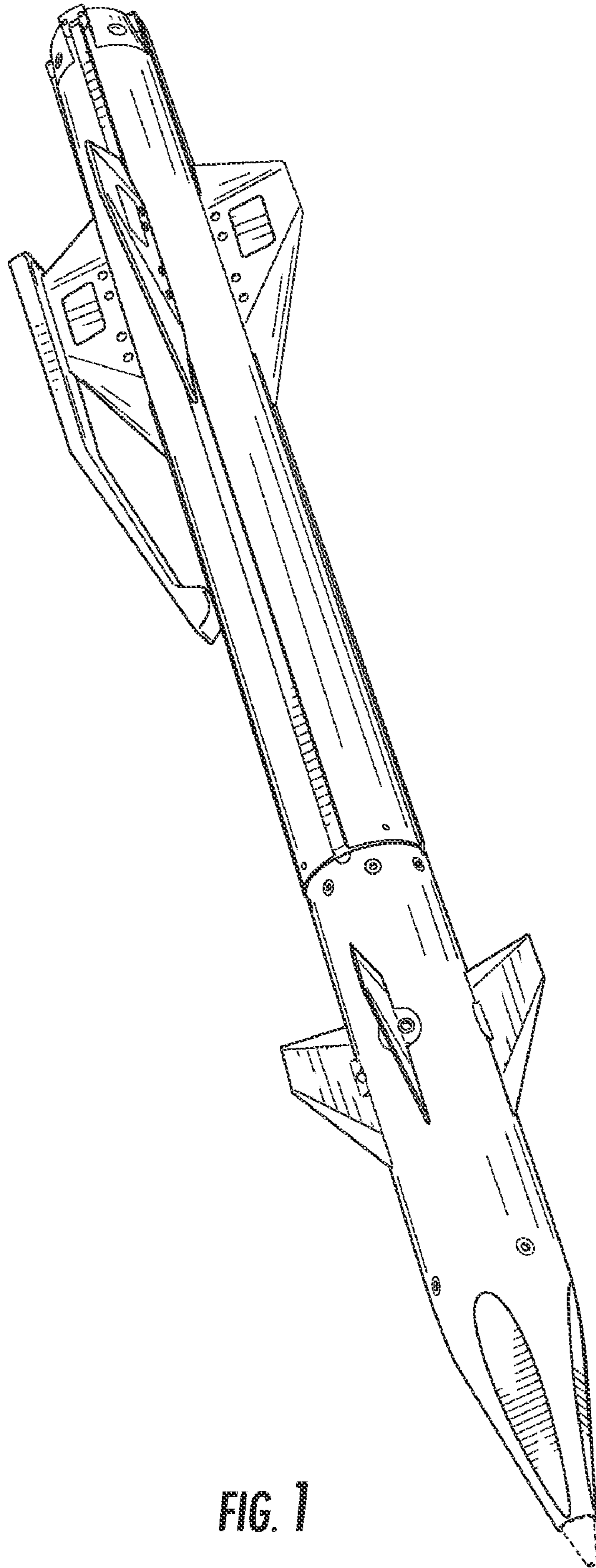

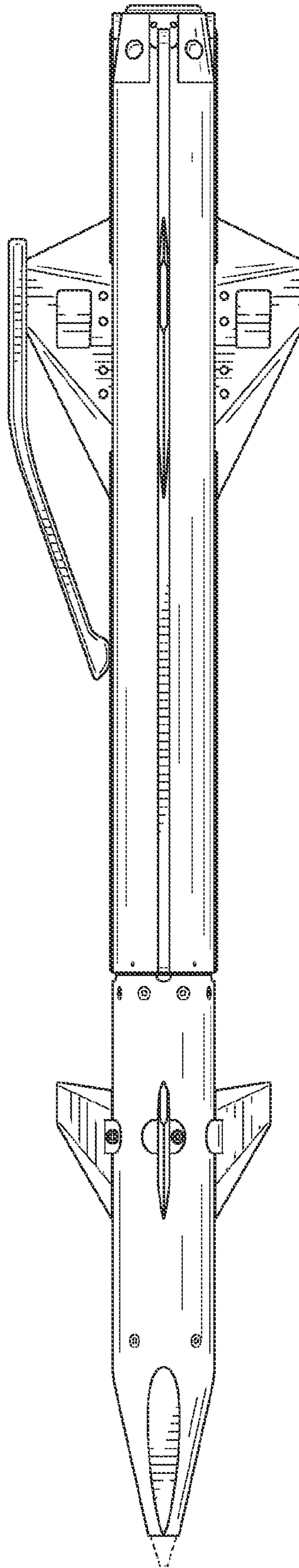
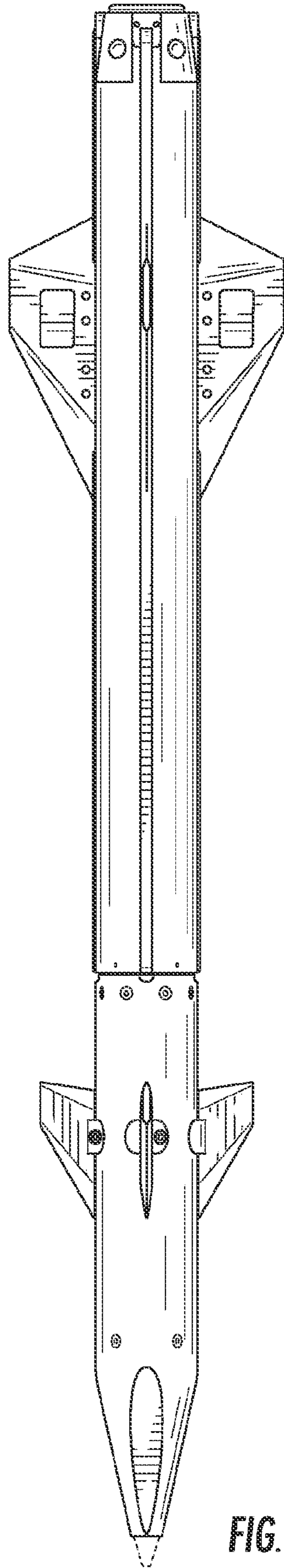
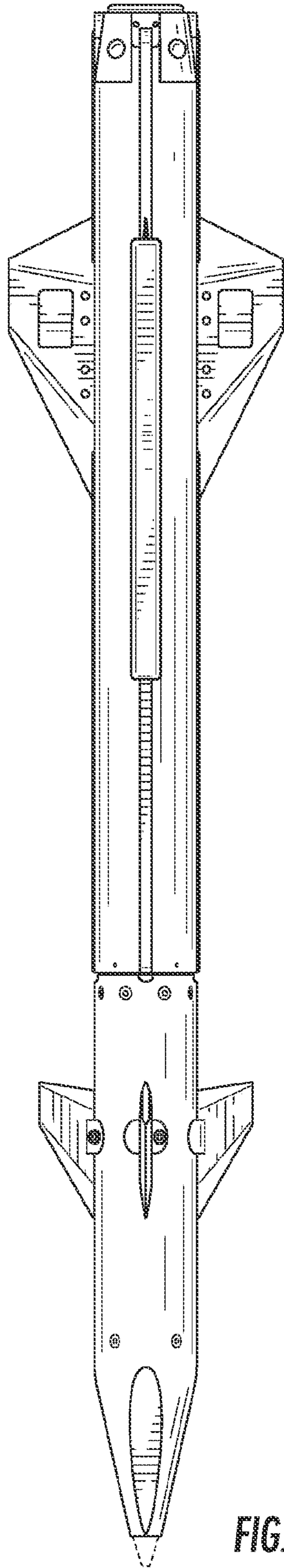
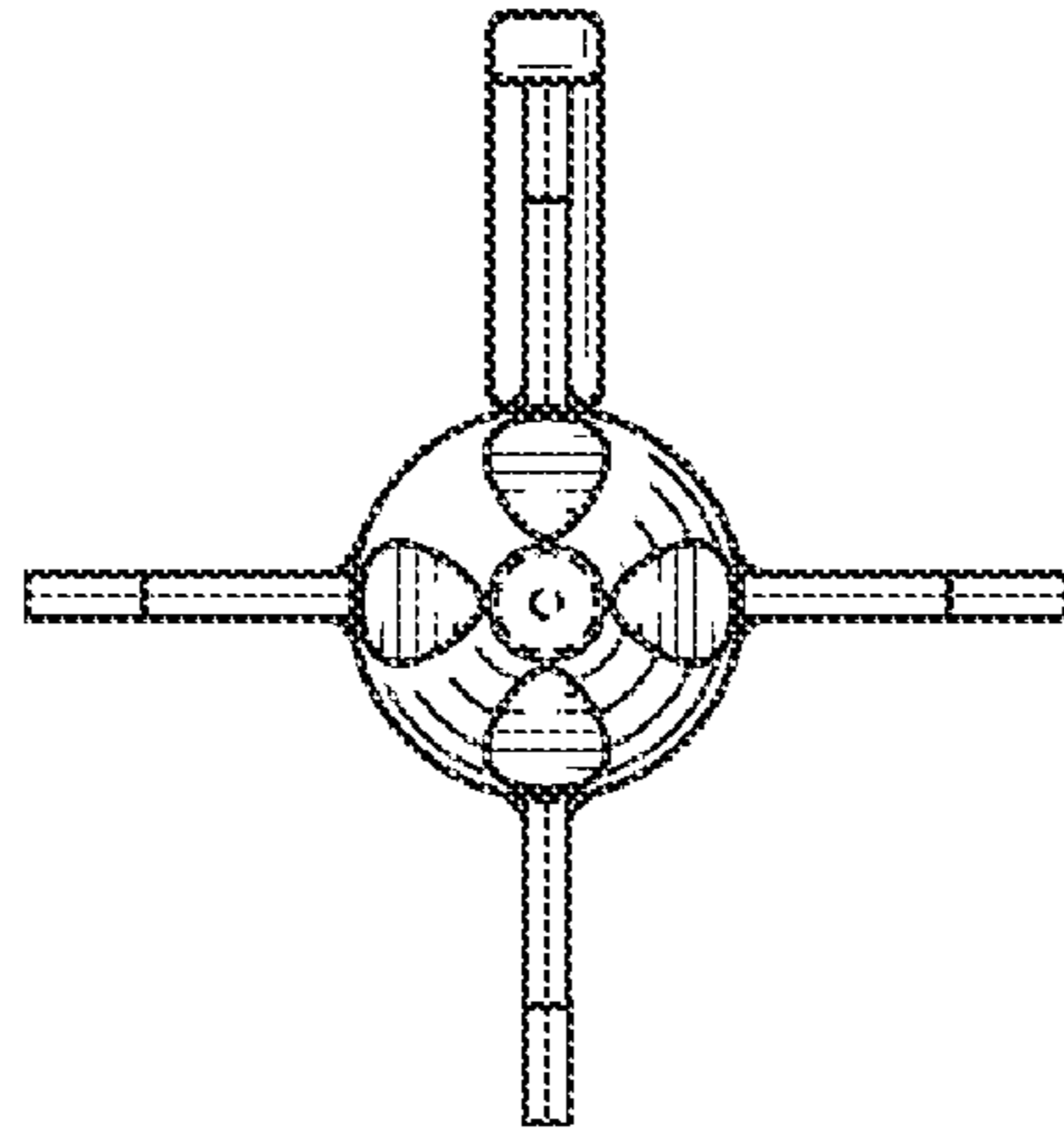
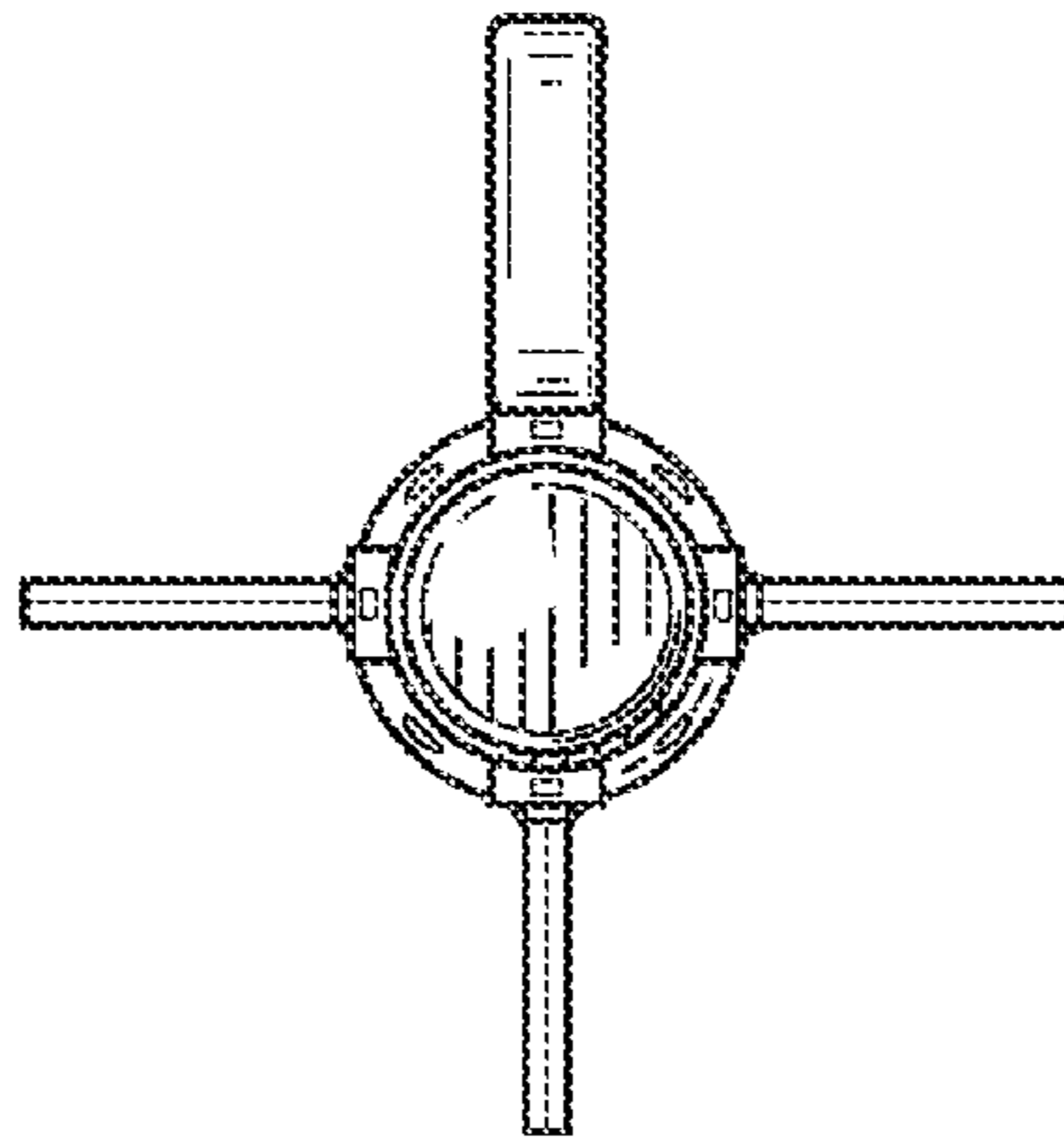

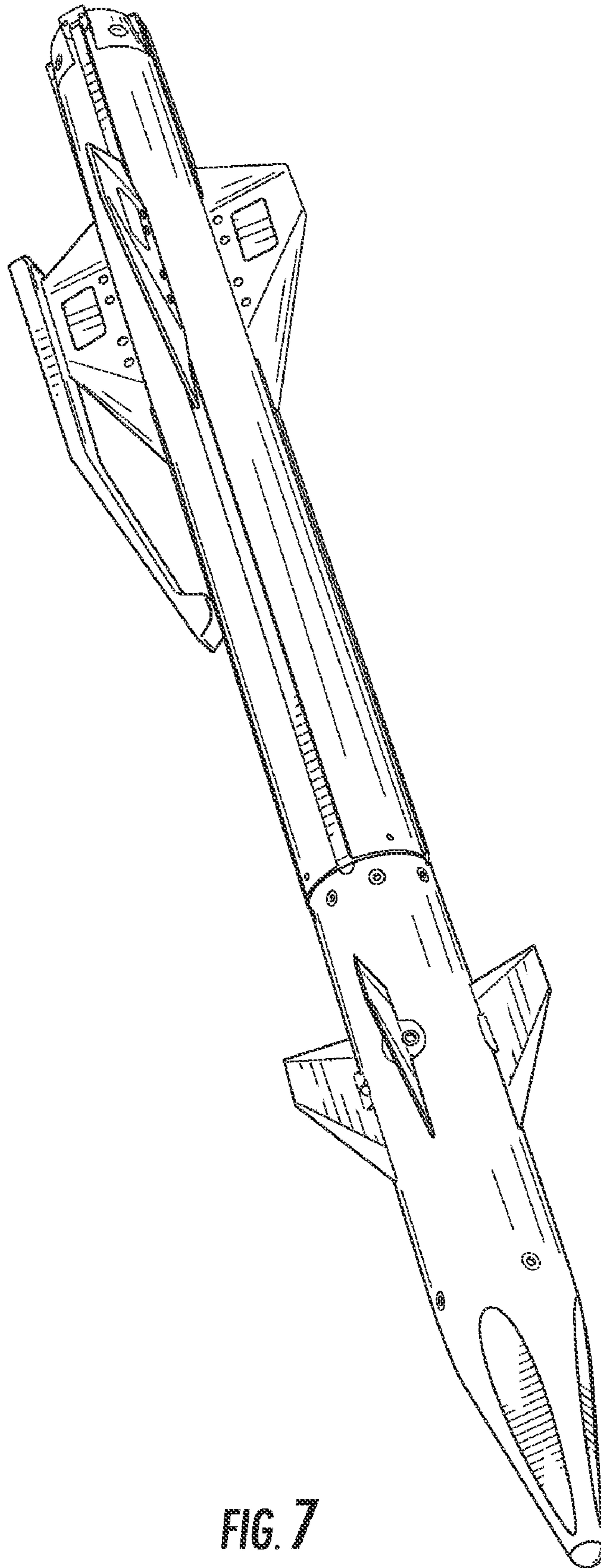

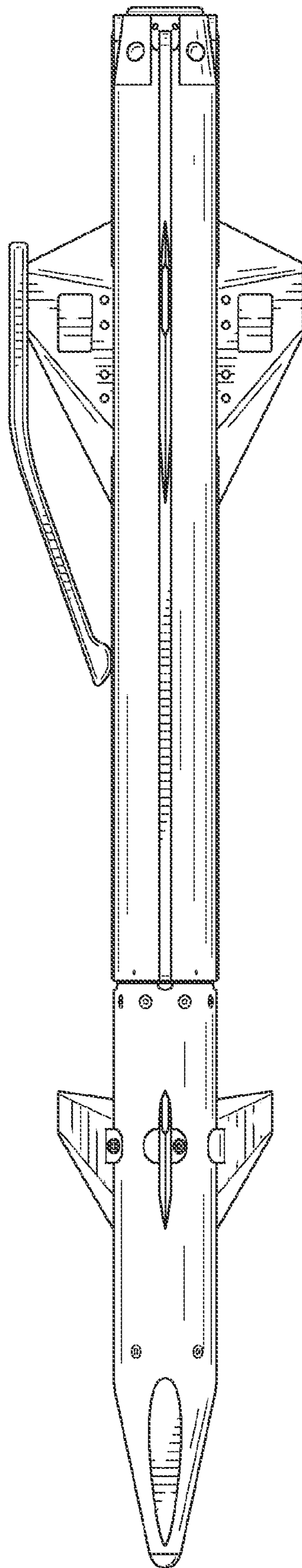
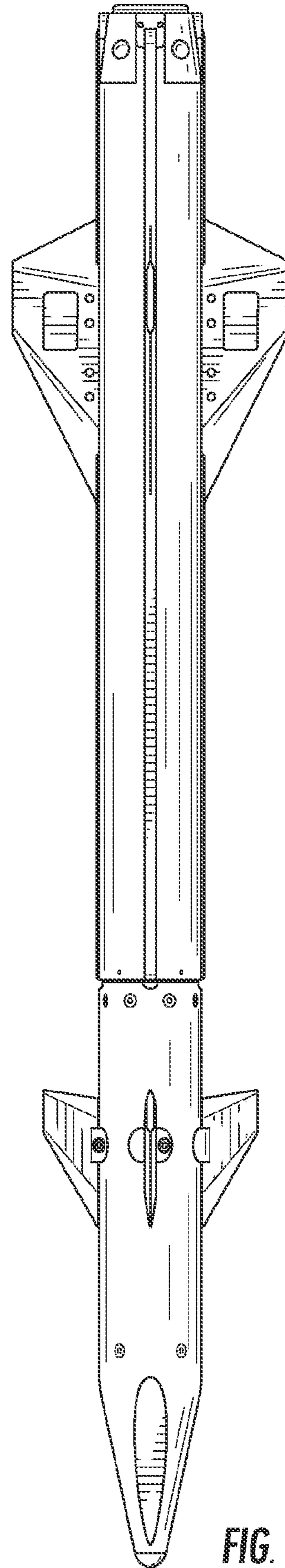
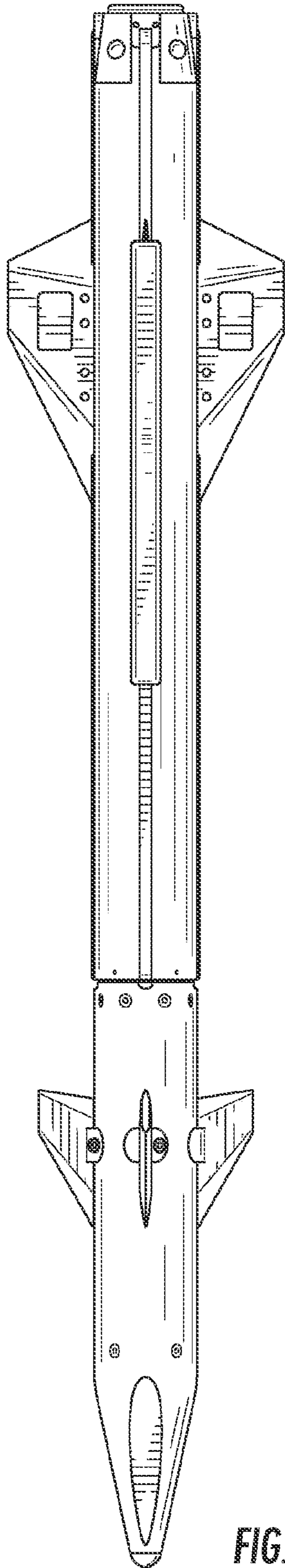
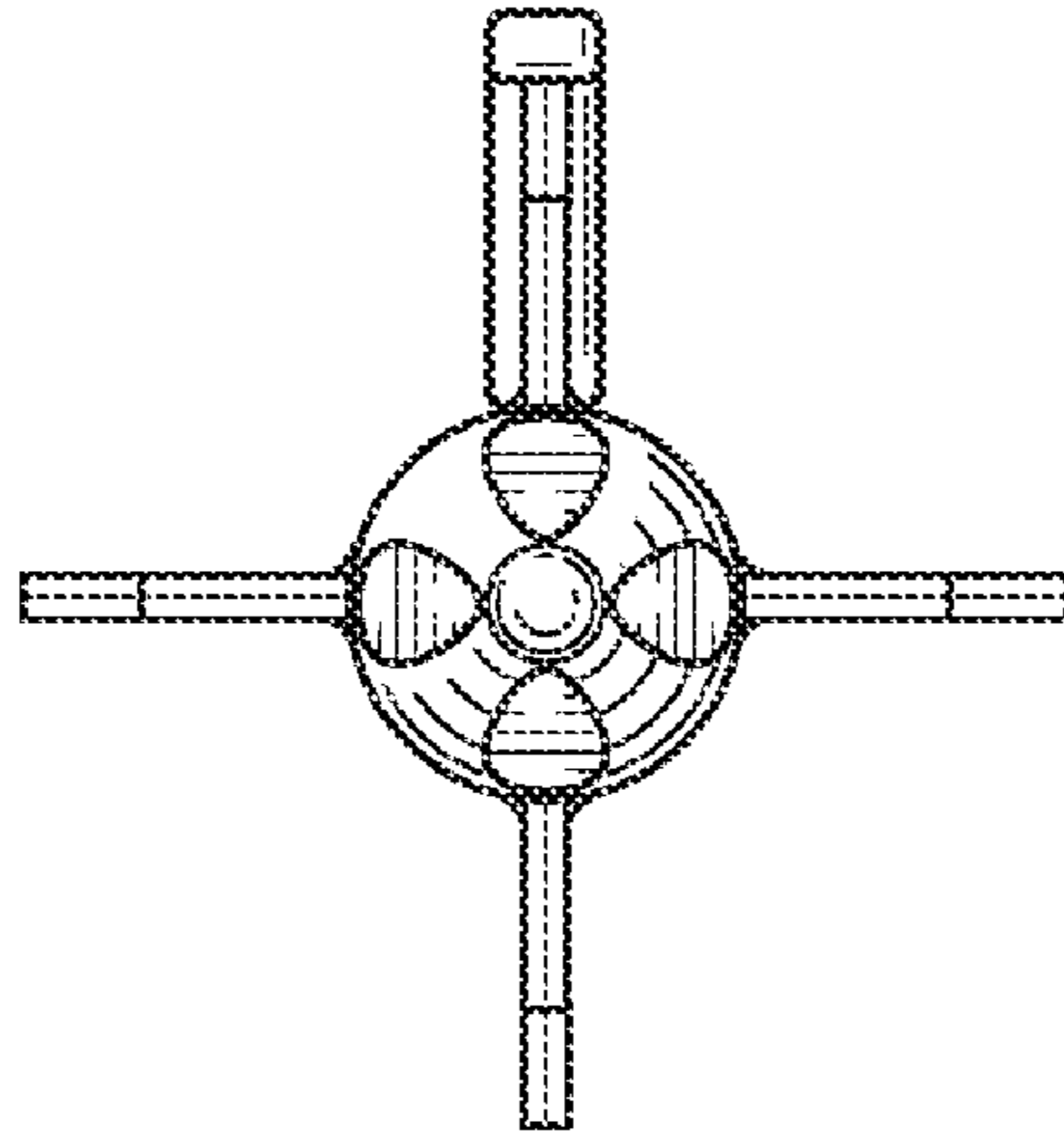


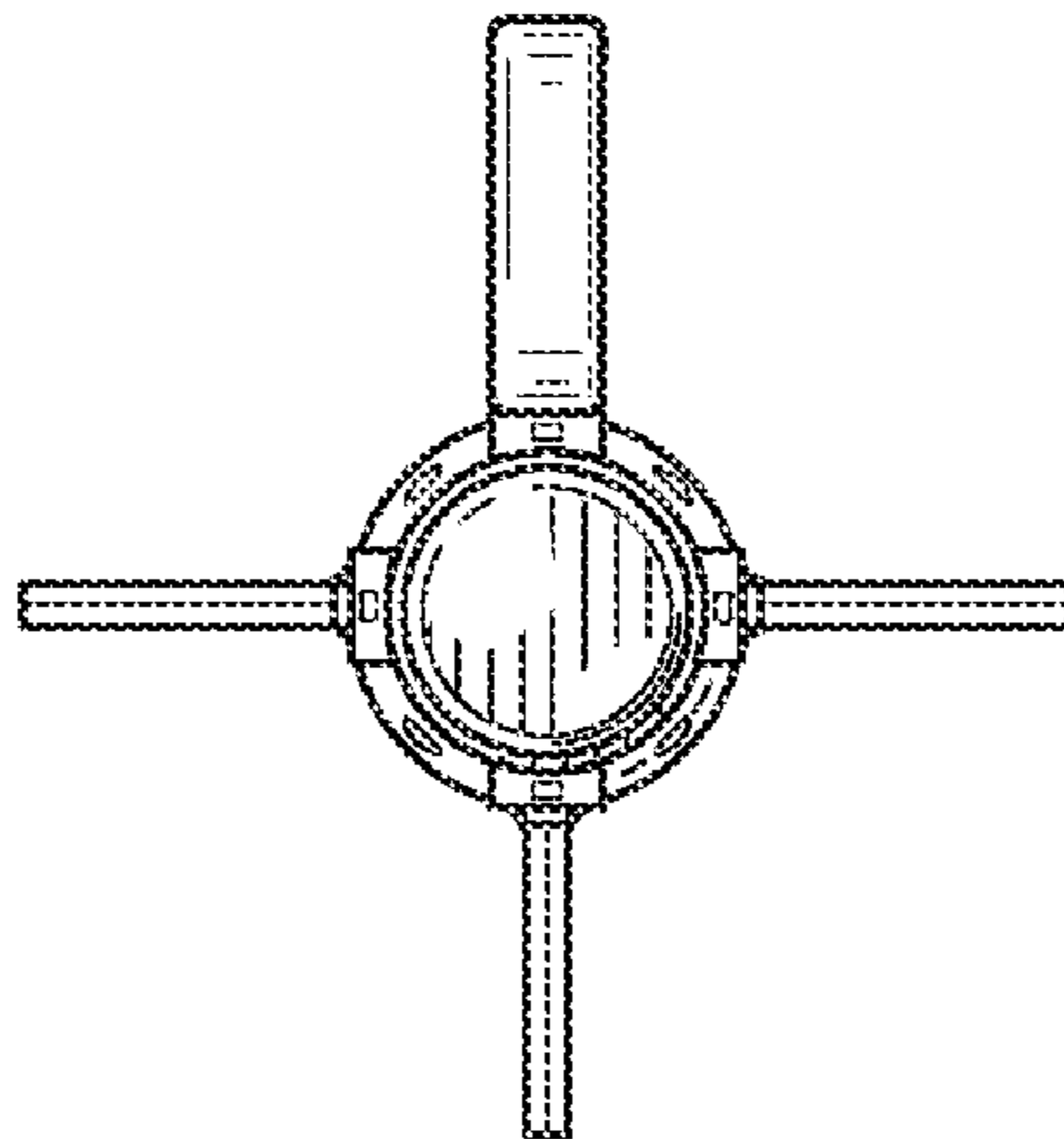

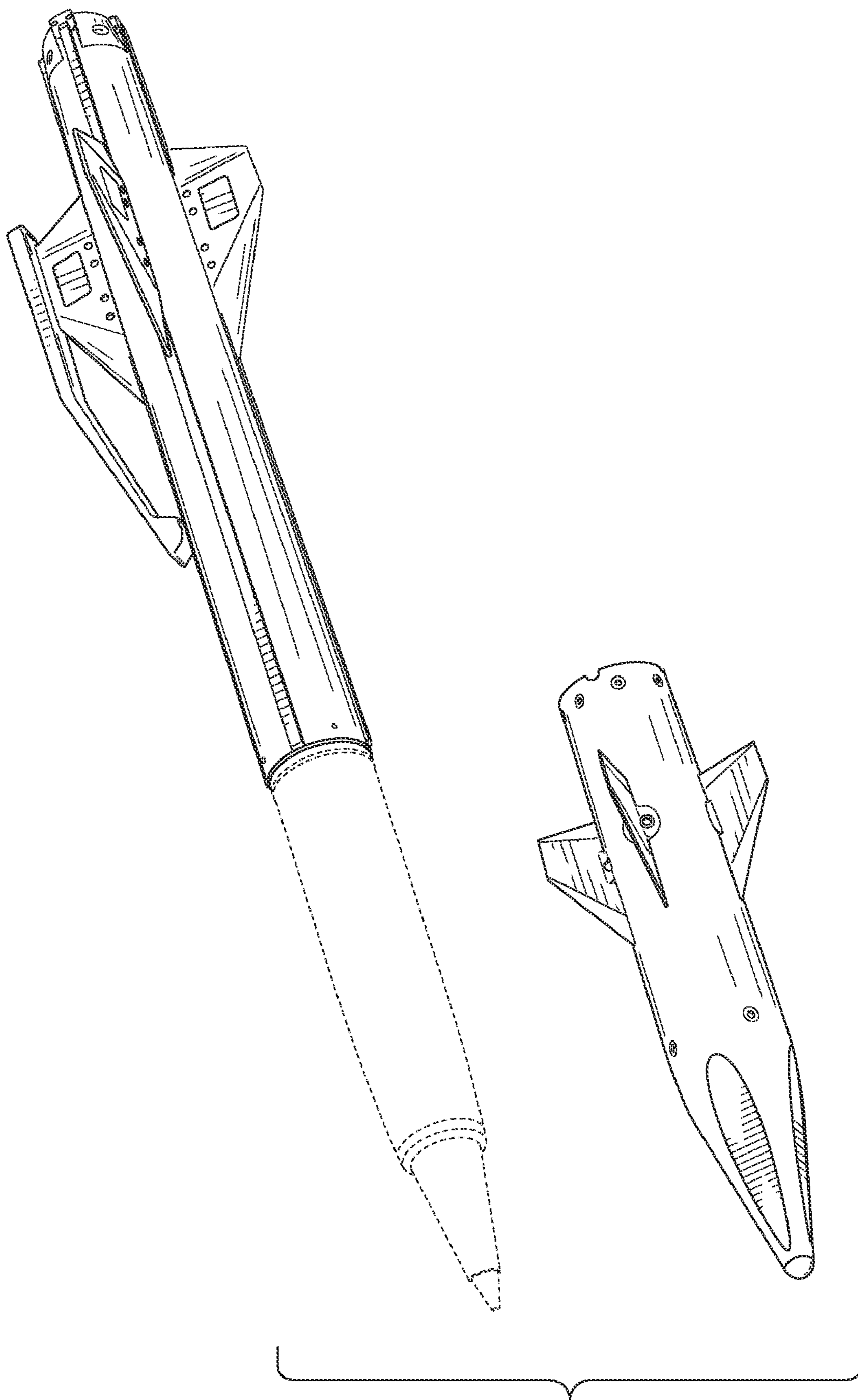

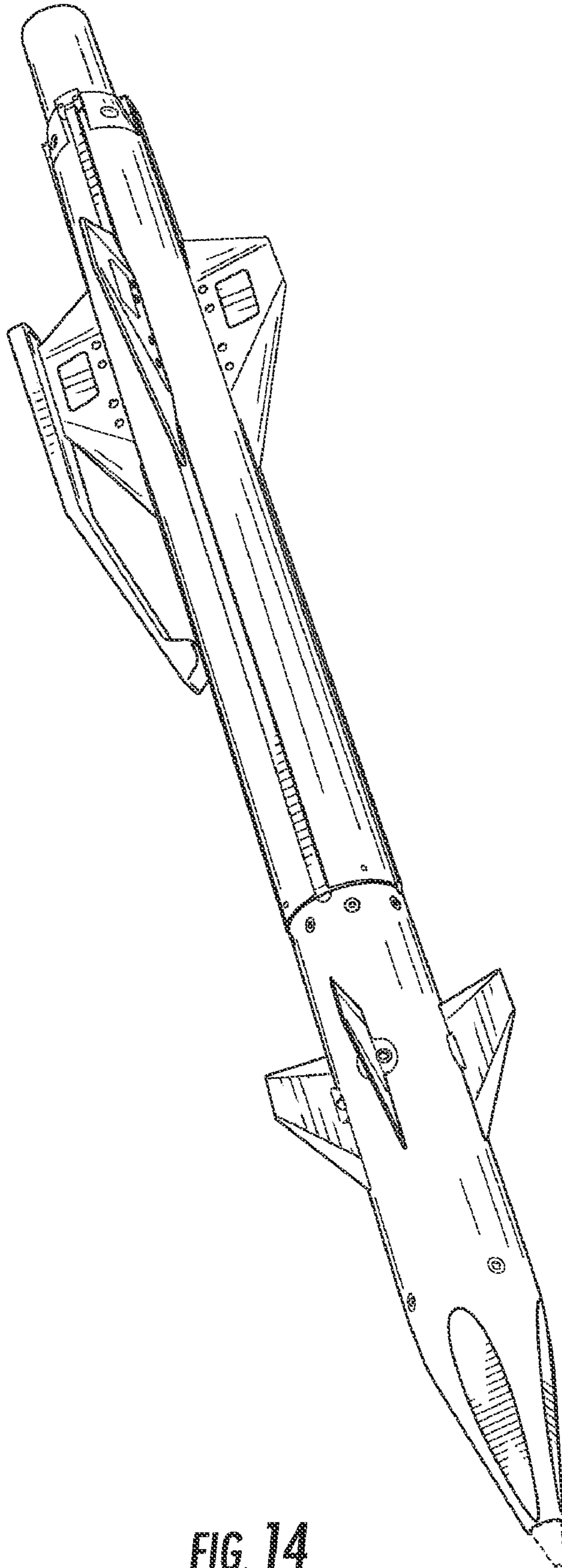

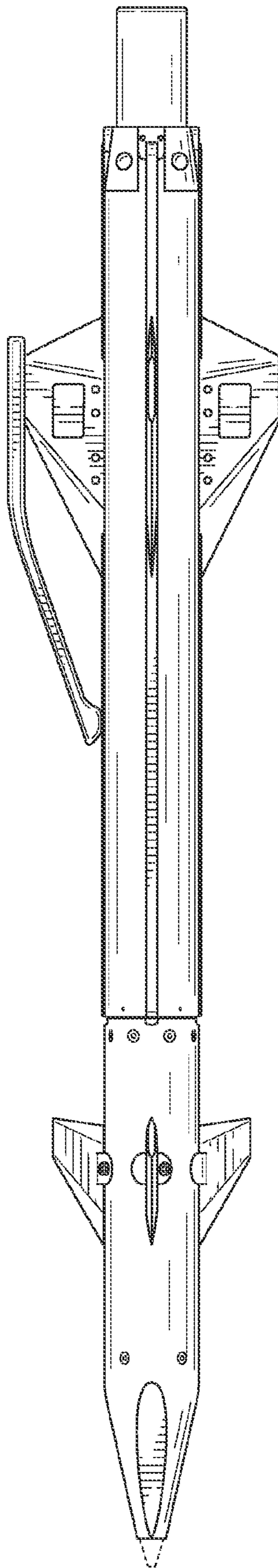

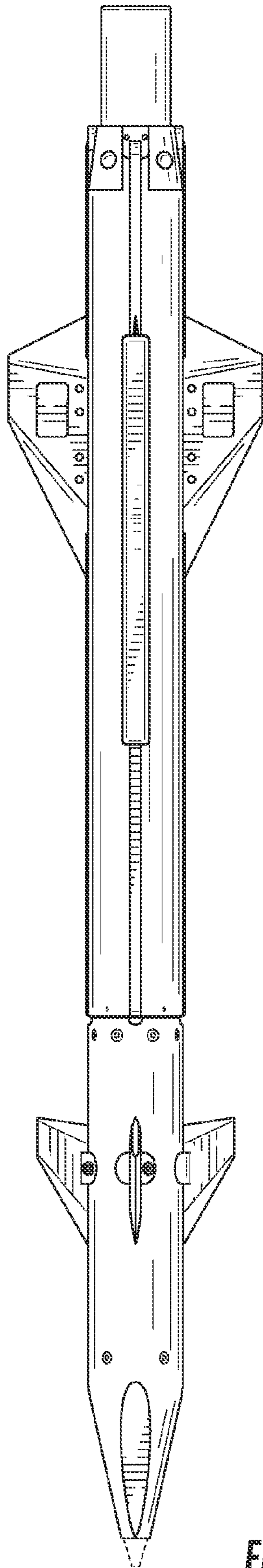

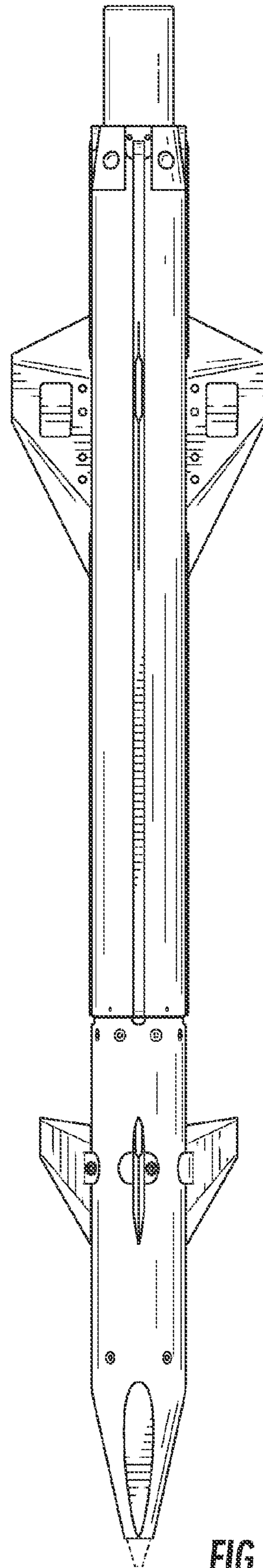
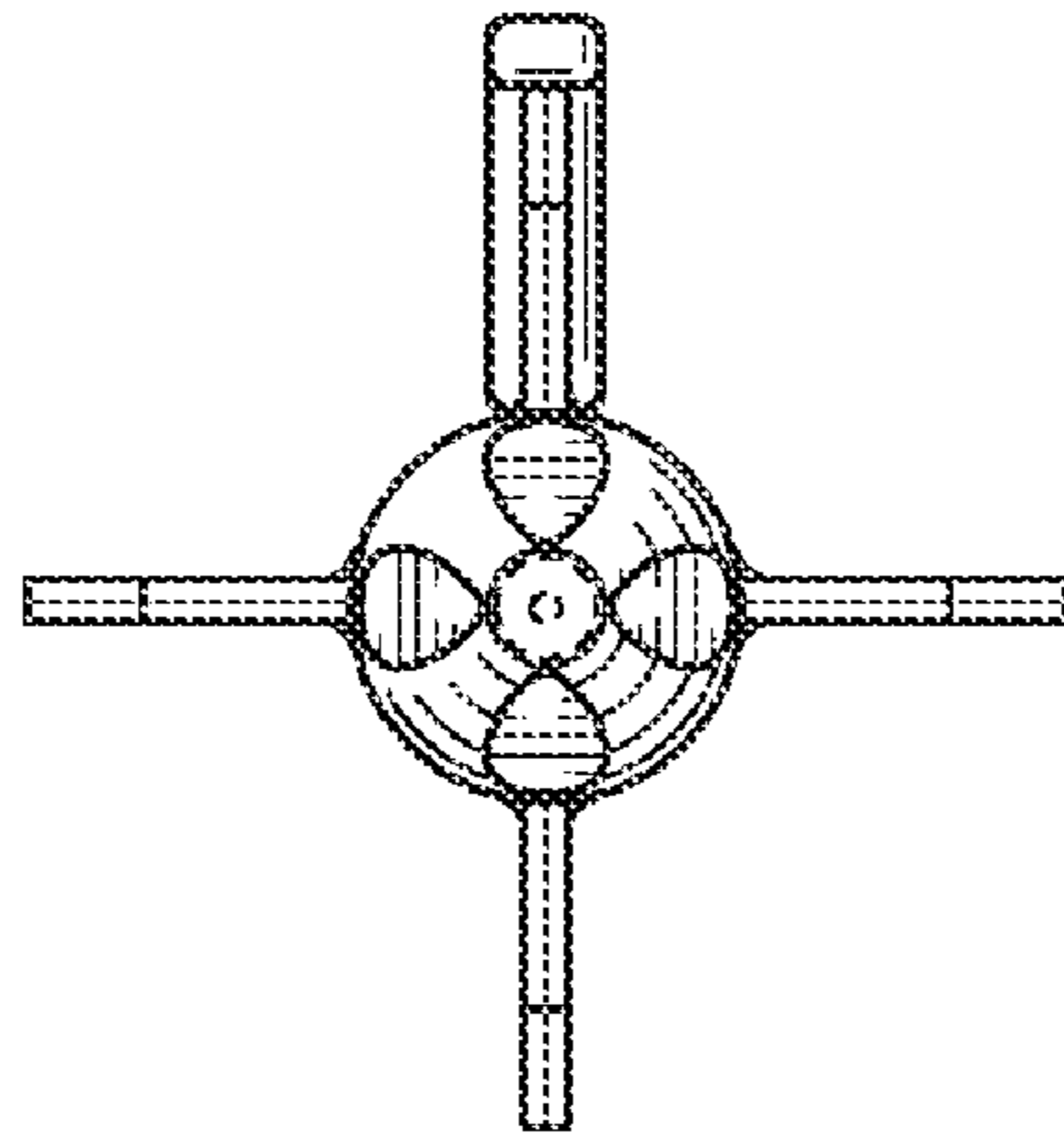
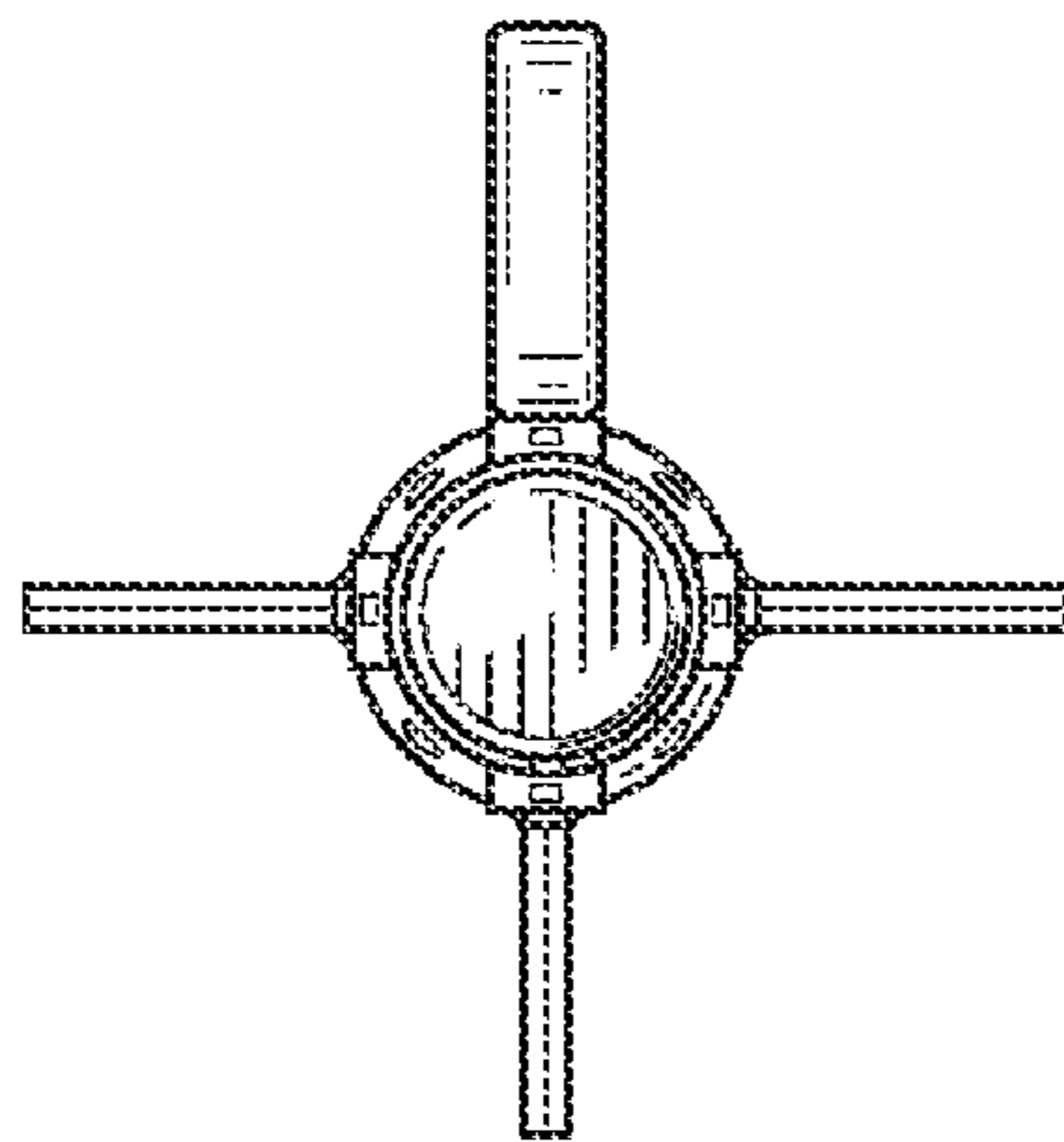
