The ornamental design for a ring binder clipboard, as shown and described.

DESCRIPTION

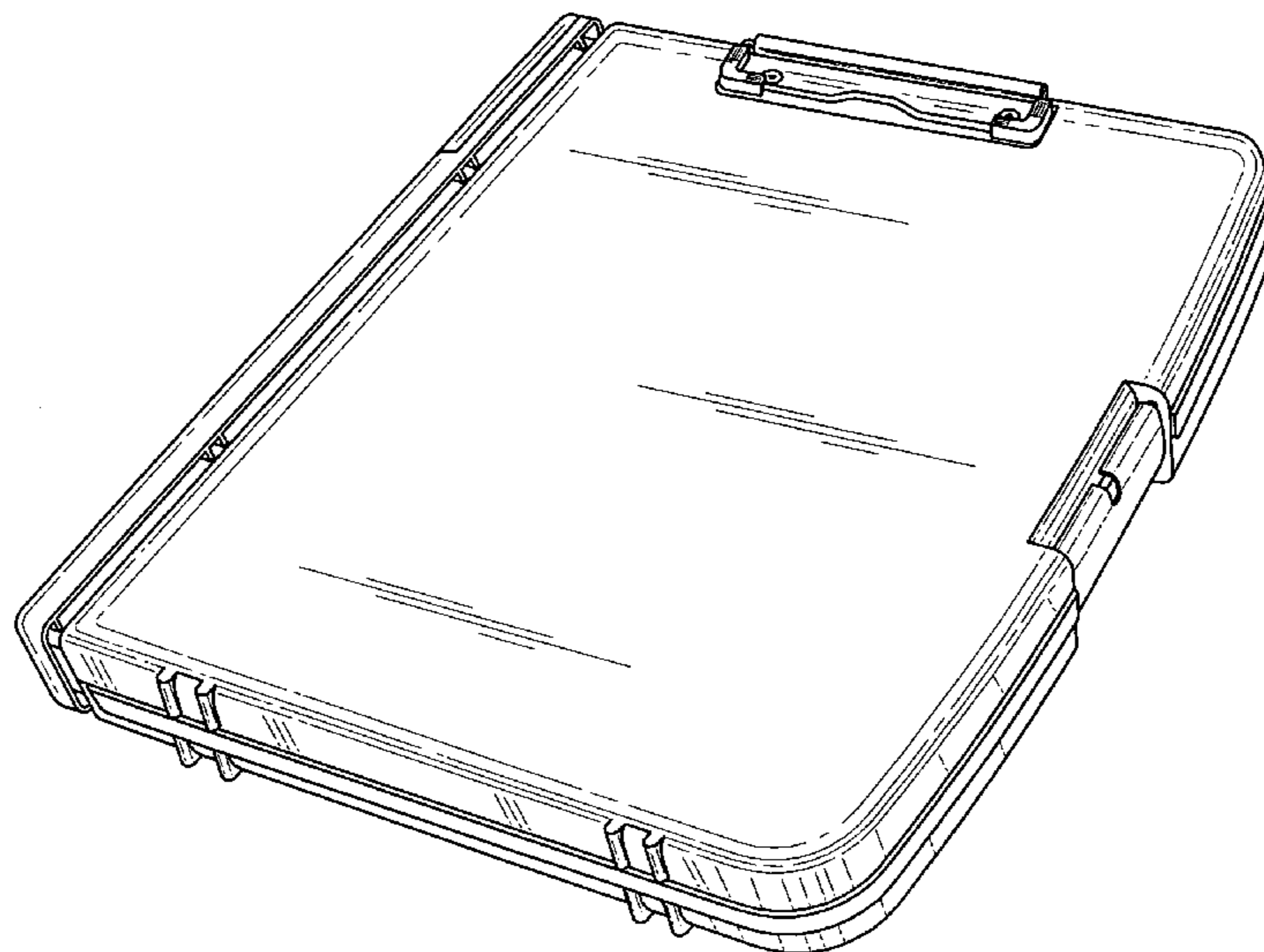

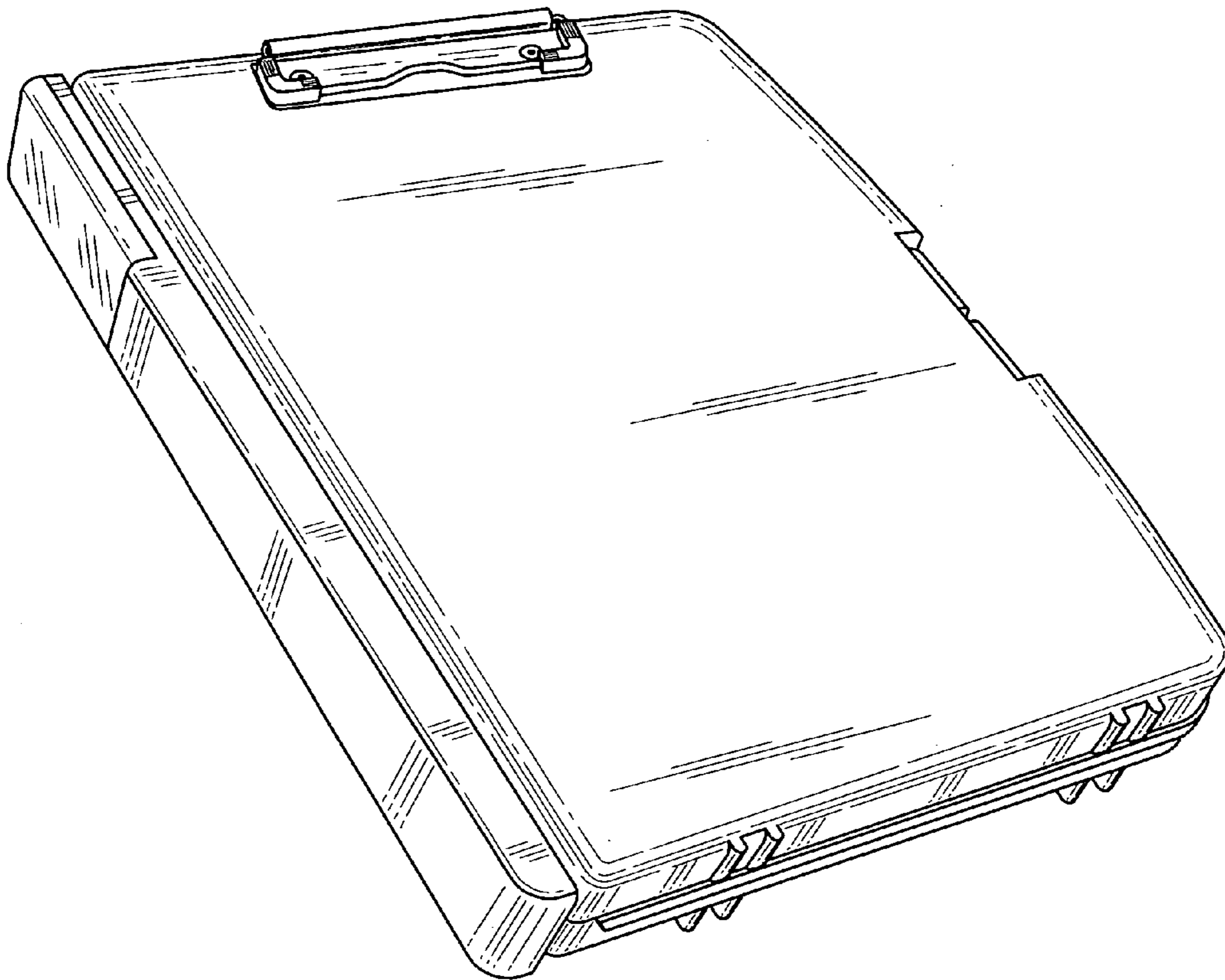

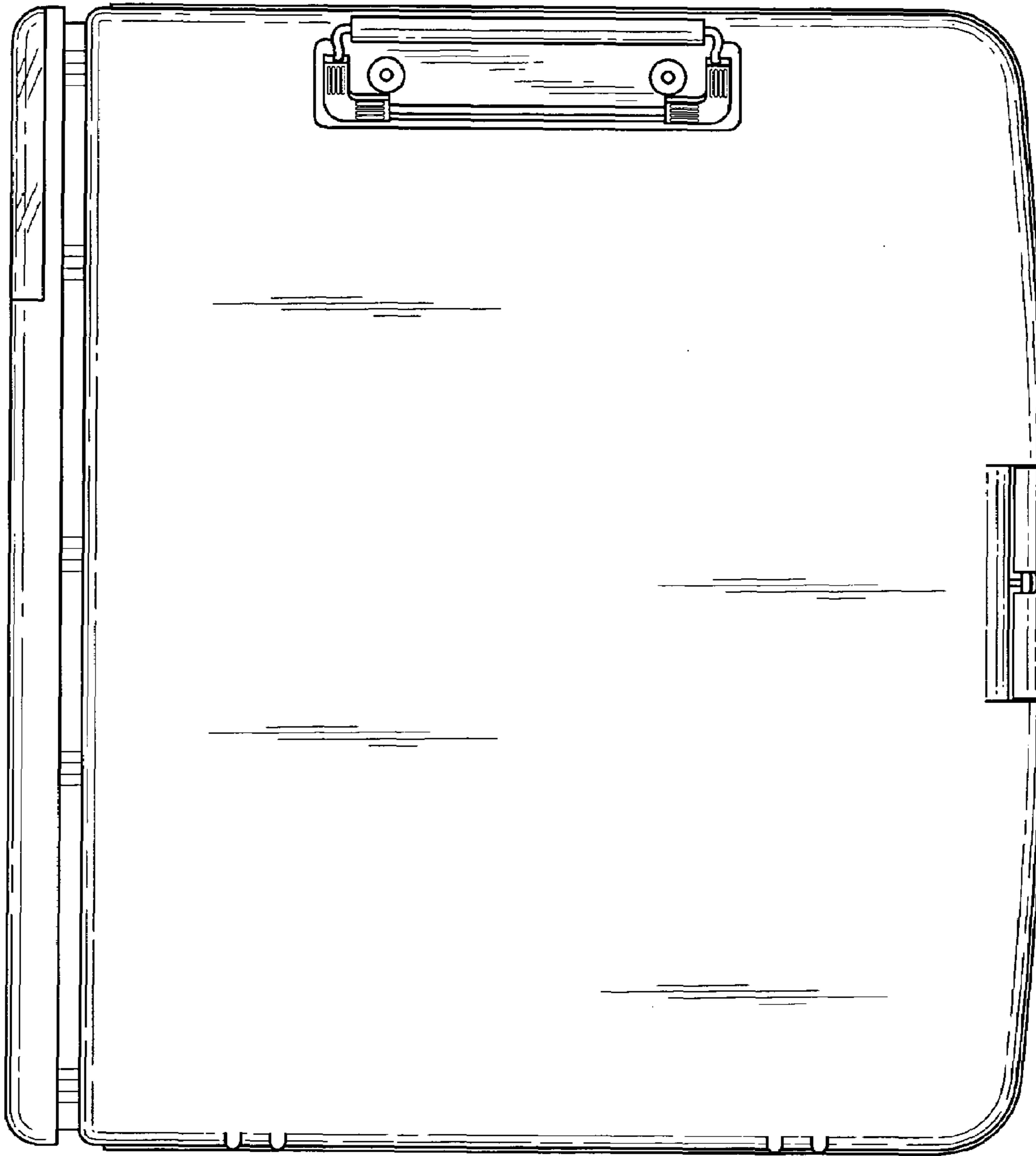

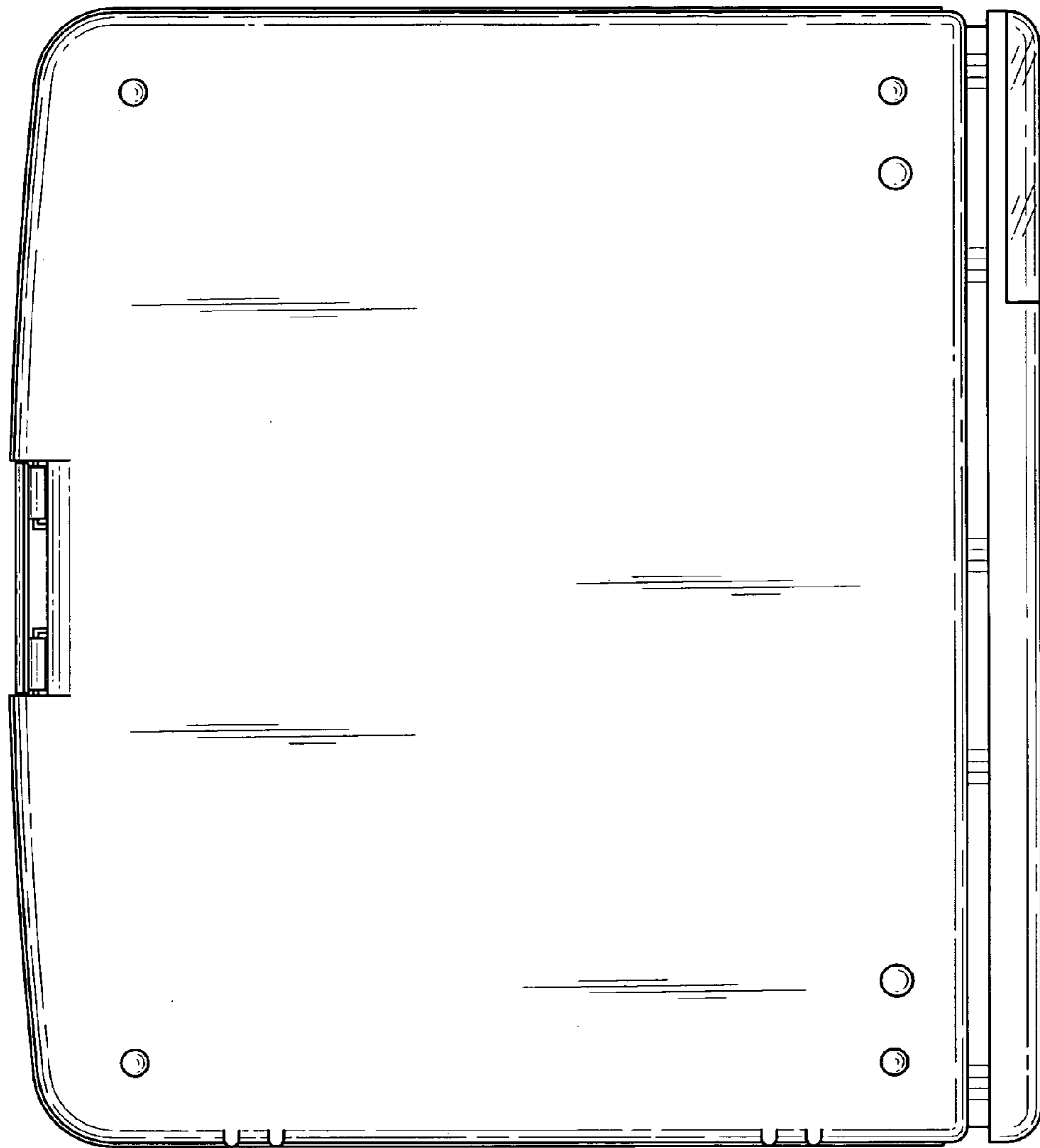

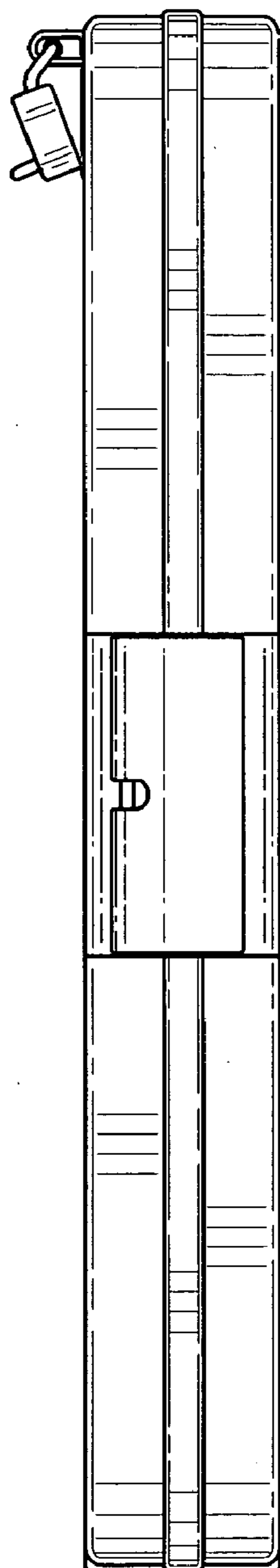

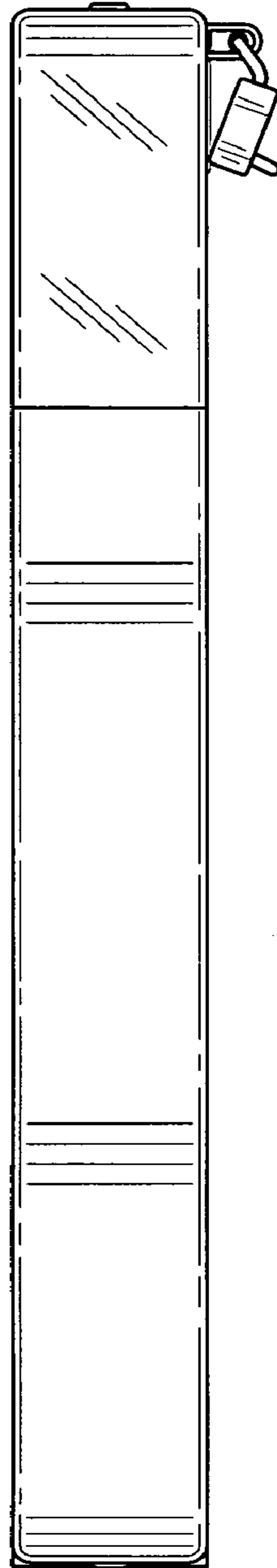

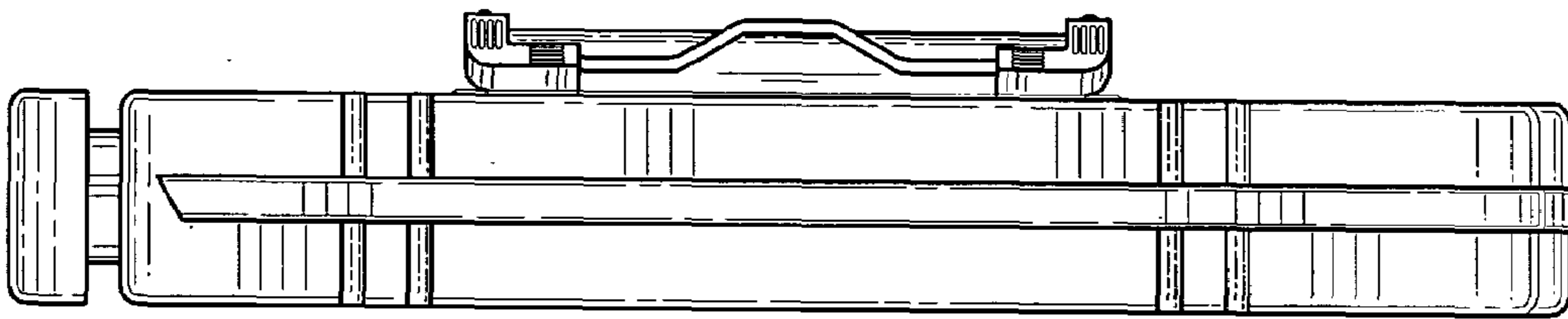

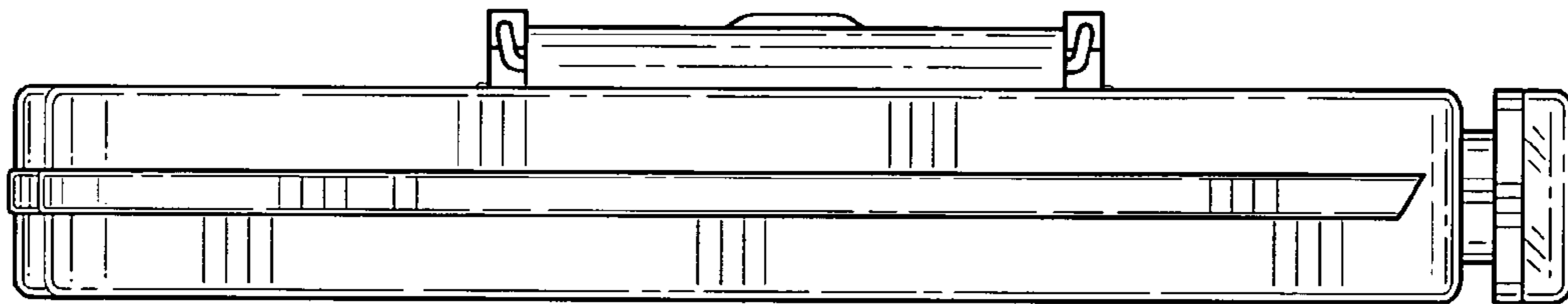

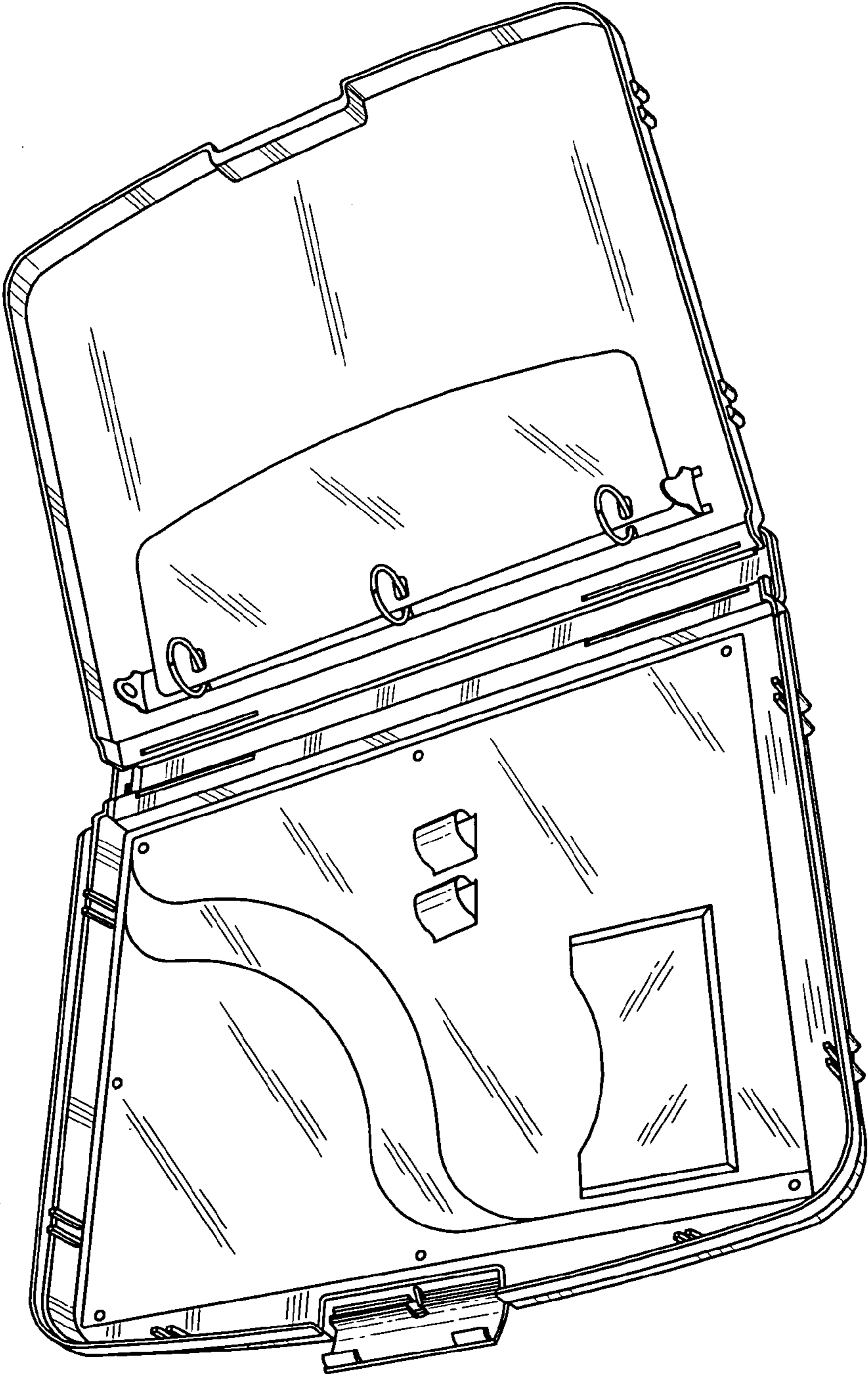
