(57) **CLAIM**

The ornamental design for a nozzle, as shown and described.

DESCRIPTION

Cross reference is made to co-pending U.S. patent application Ser. No. 29/326,959, entitled “Nozzle” by William F. Zore, which was filed on Oct. 28, 2008 and is assigned to the same assignee of the present invention. The above-identified patent application is herein incorporated by reference in its entirety.

FIG. 1 is a perspective view of a nozzle showing my new design;

FIG. 2 is a left side elevational view showing the design for the nozzle of FIG. 1;

FIG. 3 is a right side elevational view showing the design for the nozzle of FIG. 1;

FIG. 4 is a front elevational view showing the design for the nozzle of FIG. 1;

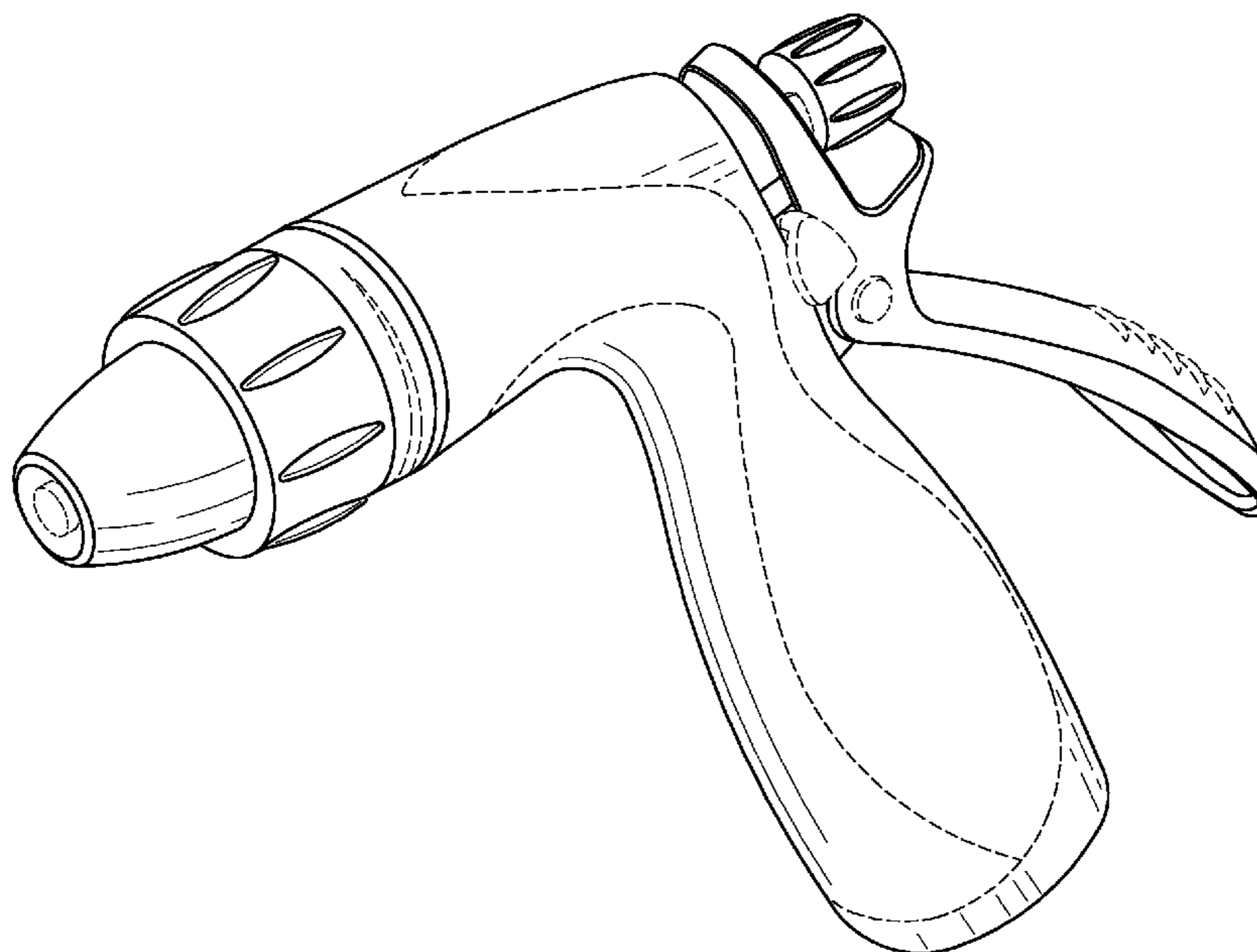
FIG. 5 is a rear elevational view showing the design for the nozzle of FIG. 1;

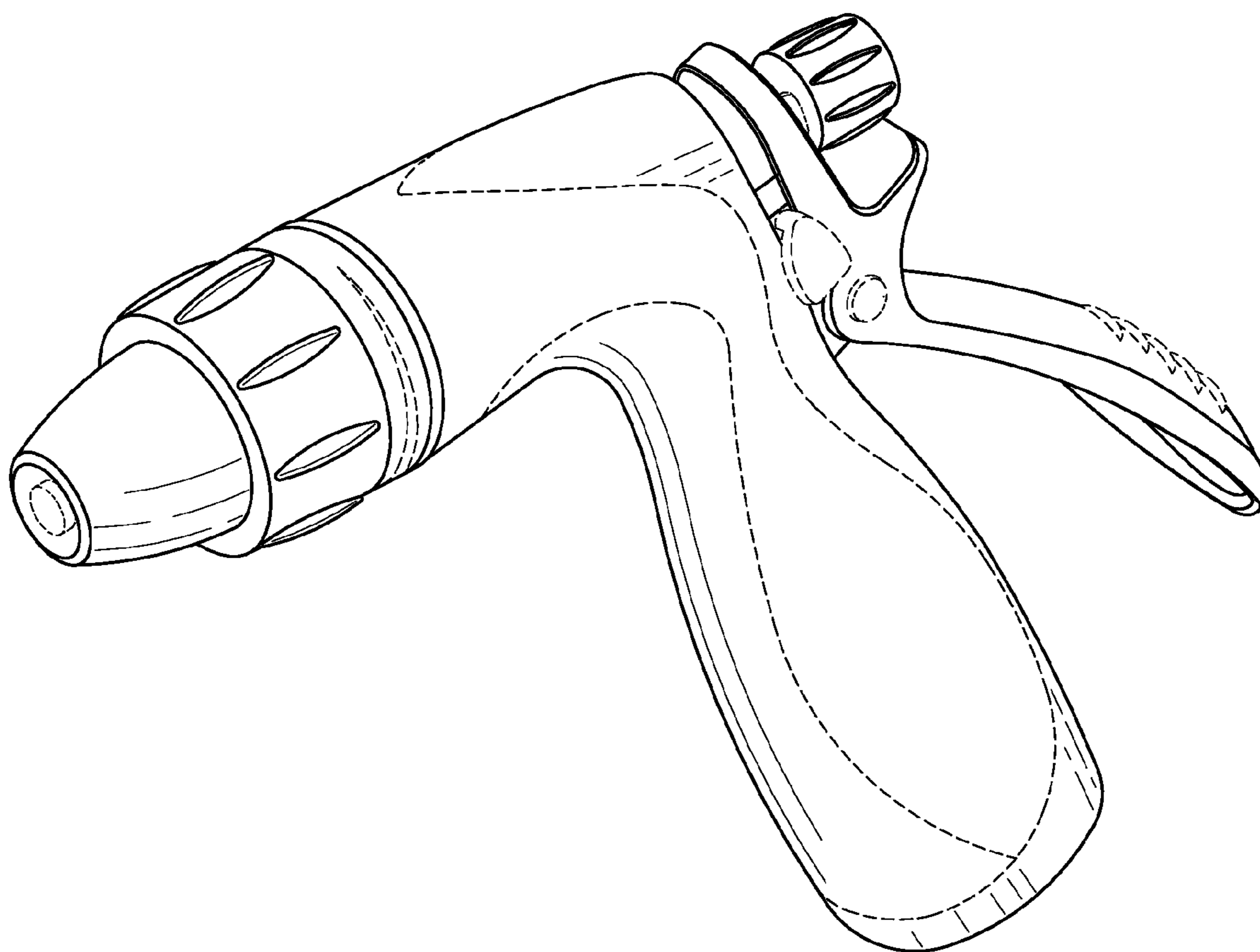

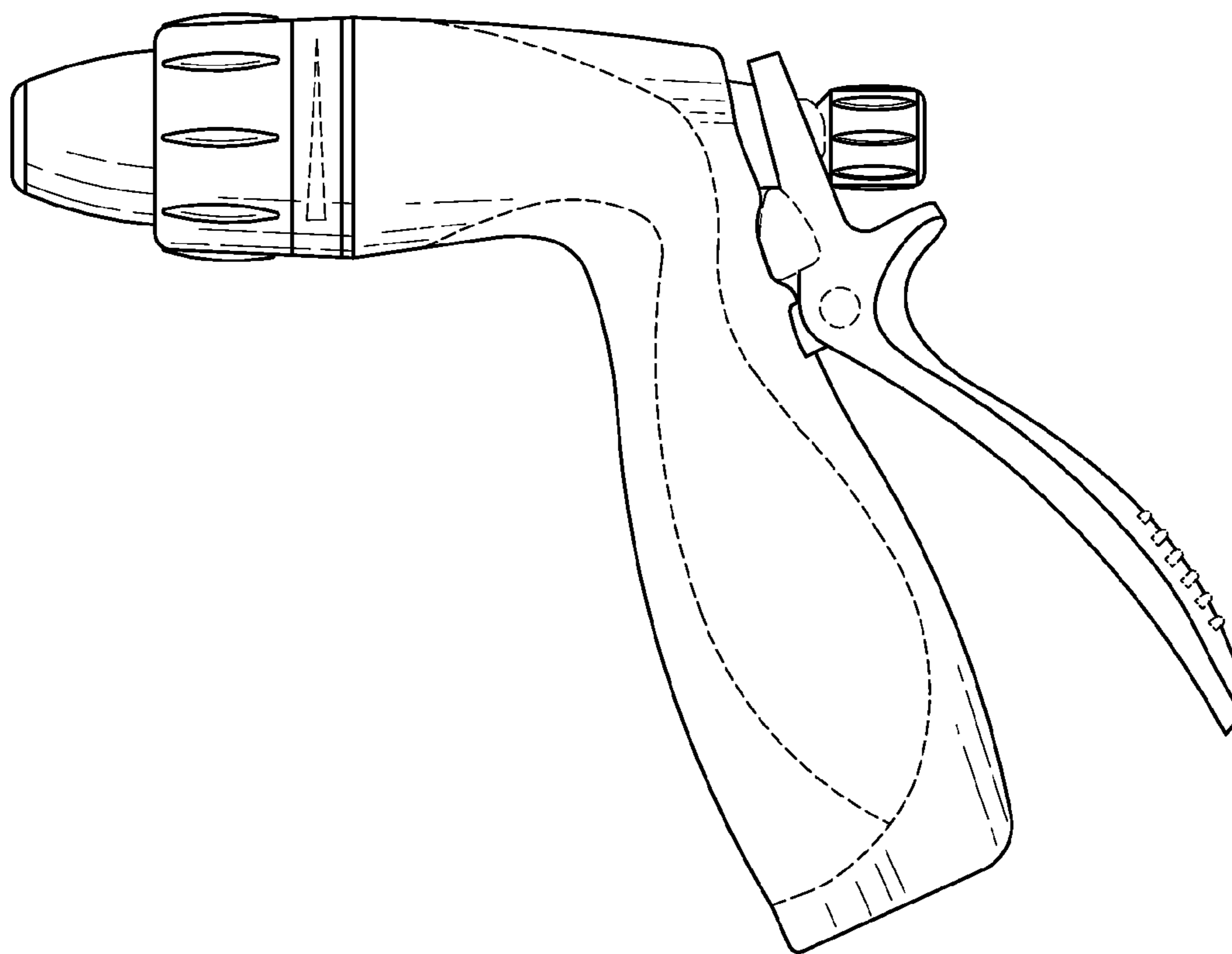

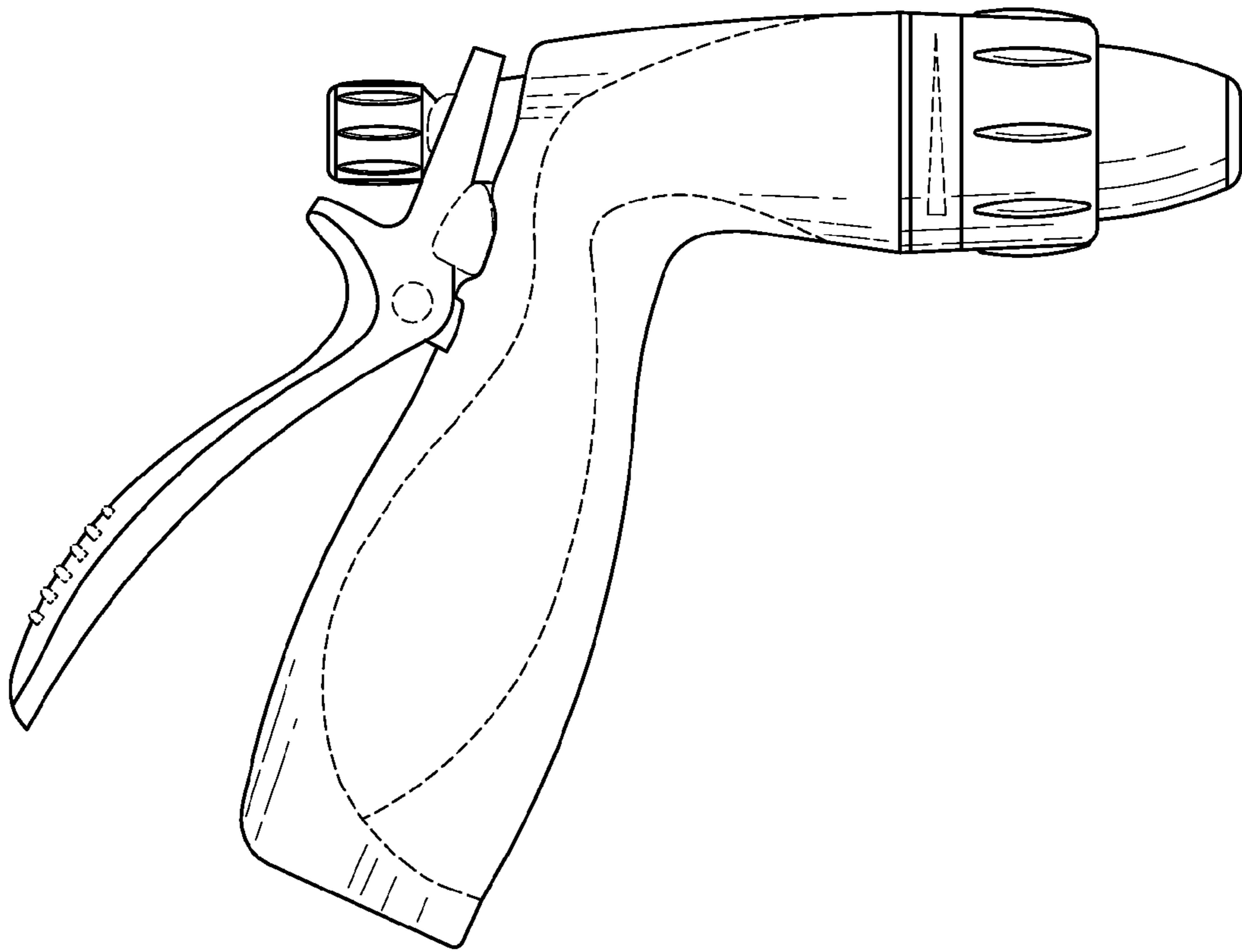

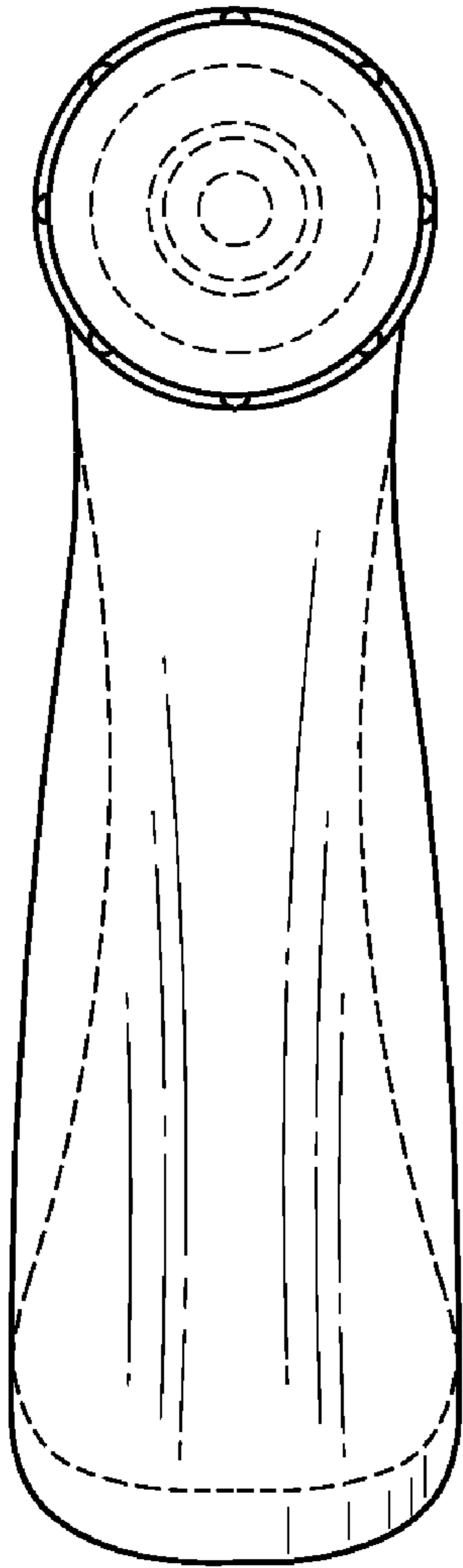

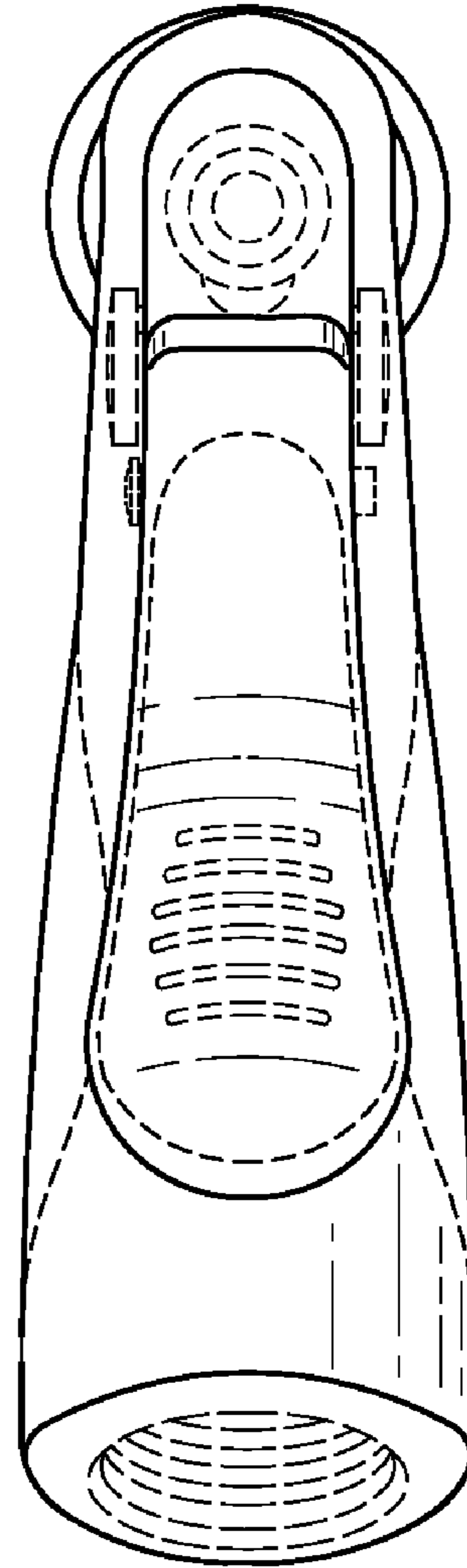

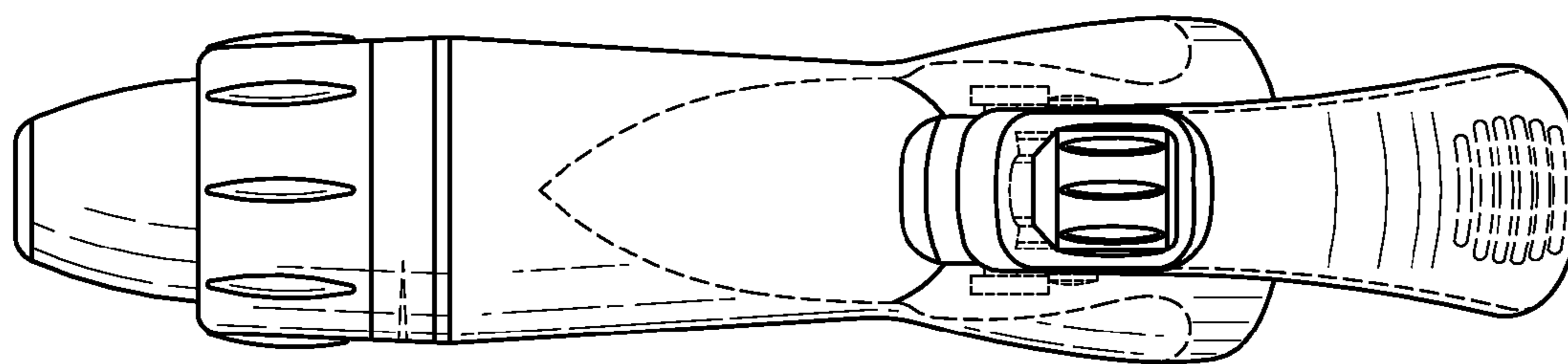

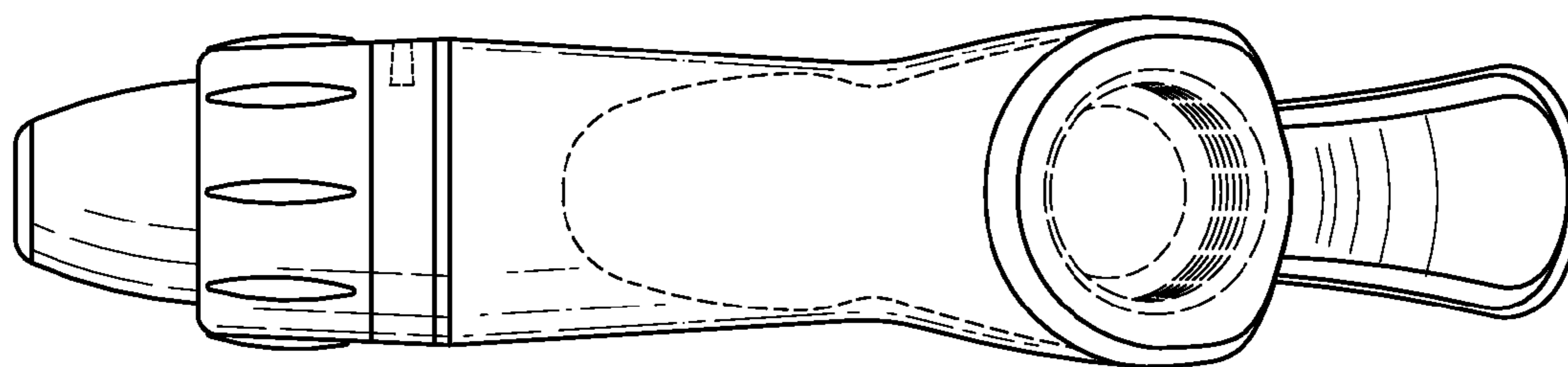
