FIG. 1 is a perspective view of a surgical drill showing my new design;

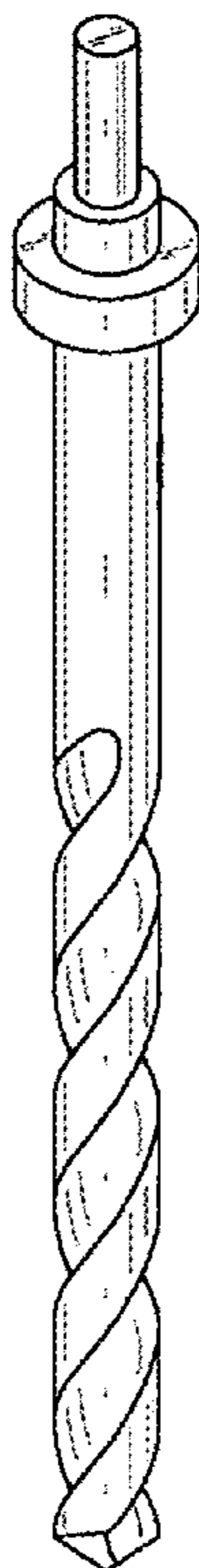
FIG. 2 is side view thereof;

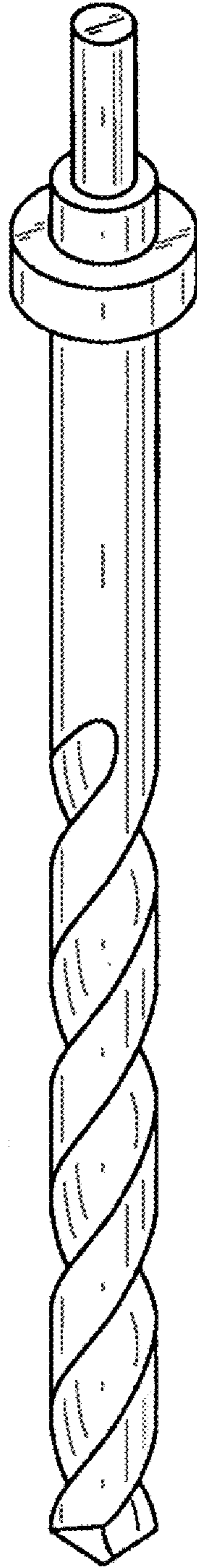

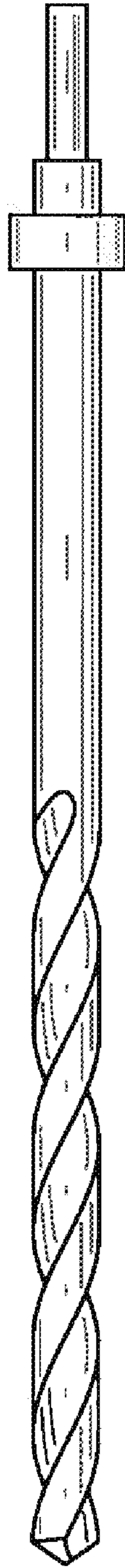

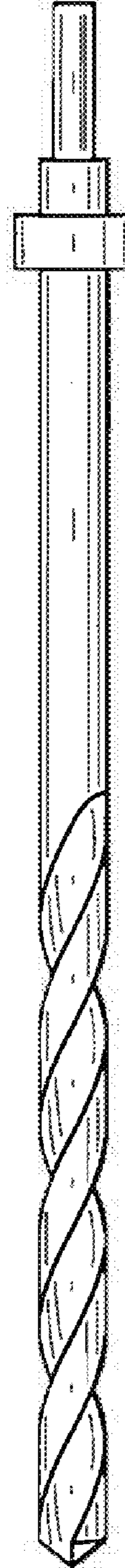

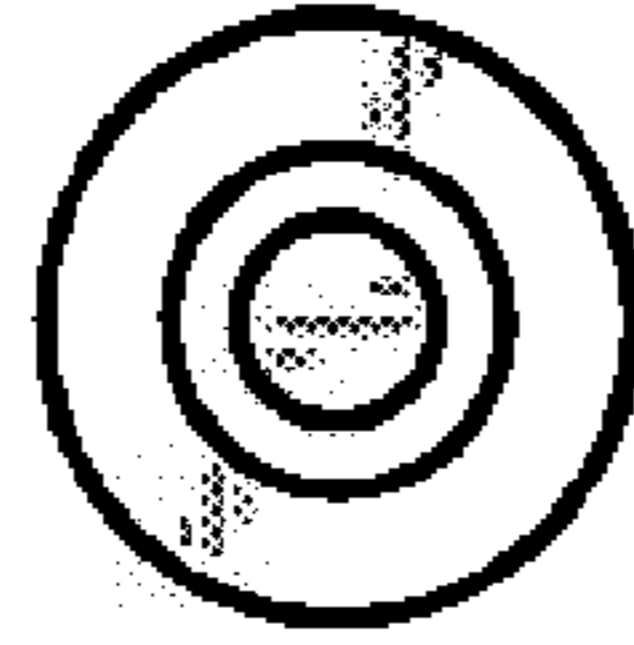

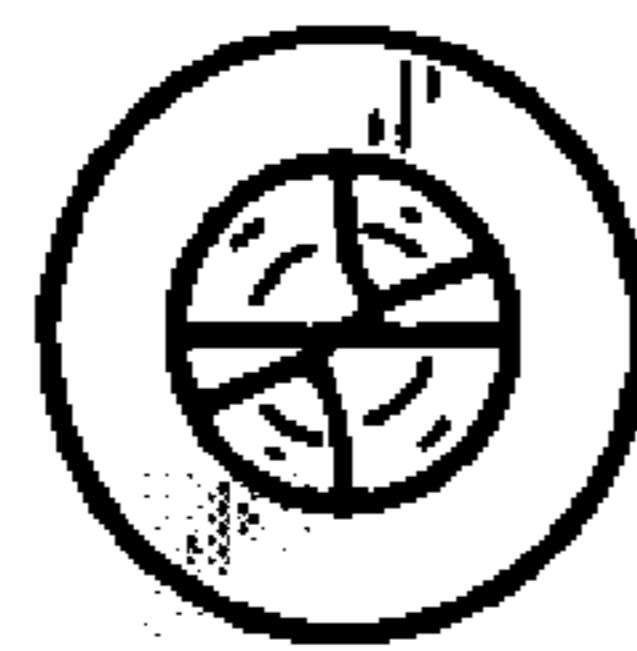
