(57) **CLAIM**

The ornamental design for a combined door and door arrangement, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an exemplary embodiment of a combined door and door arrangement for an enclosure such as a shed;

FIG. 2 is a front view of the combined door and door arrangement as shown in FIG. 1;

FIG. 3 is a right side view of the combined door and door arrangement as shown in FIG. 1;

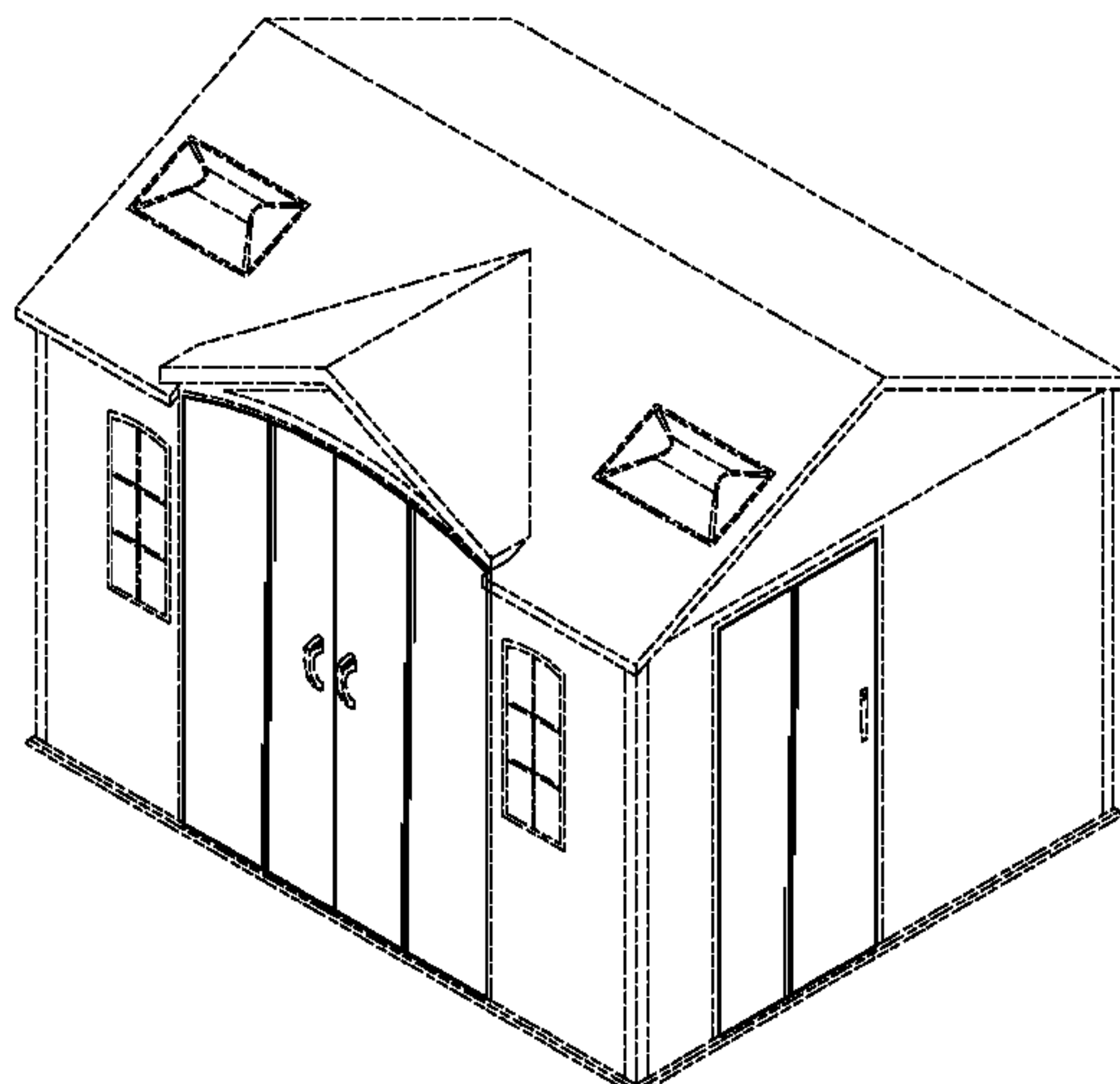
FIG. 4 is a perspective view of another exemplary embodiment of a combined door and door arrangement for an enclosure such as a shed;

FIG. 5 is a front view of the combined door and door arrangement as shown in FIG. 4;

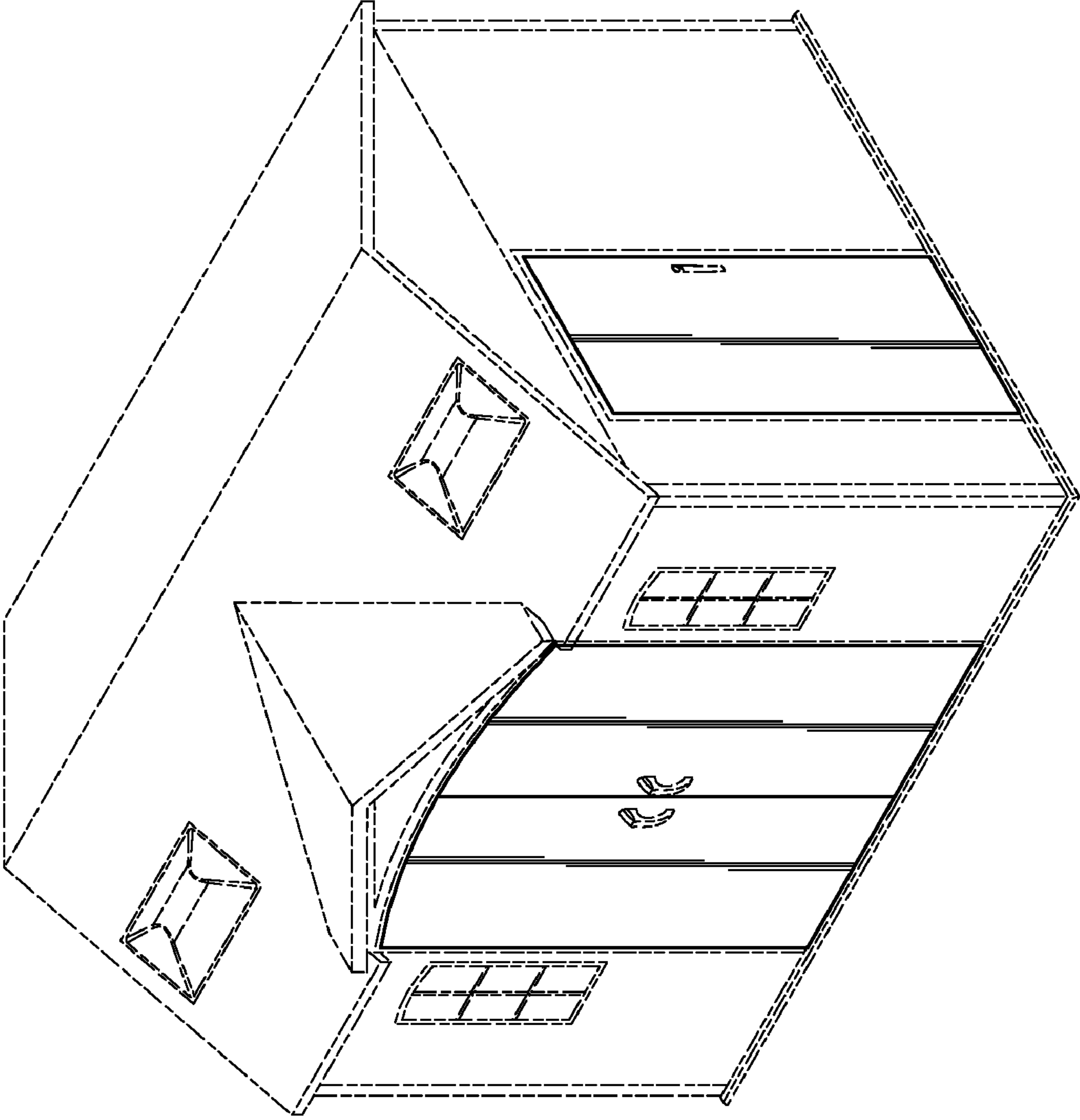

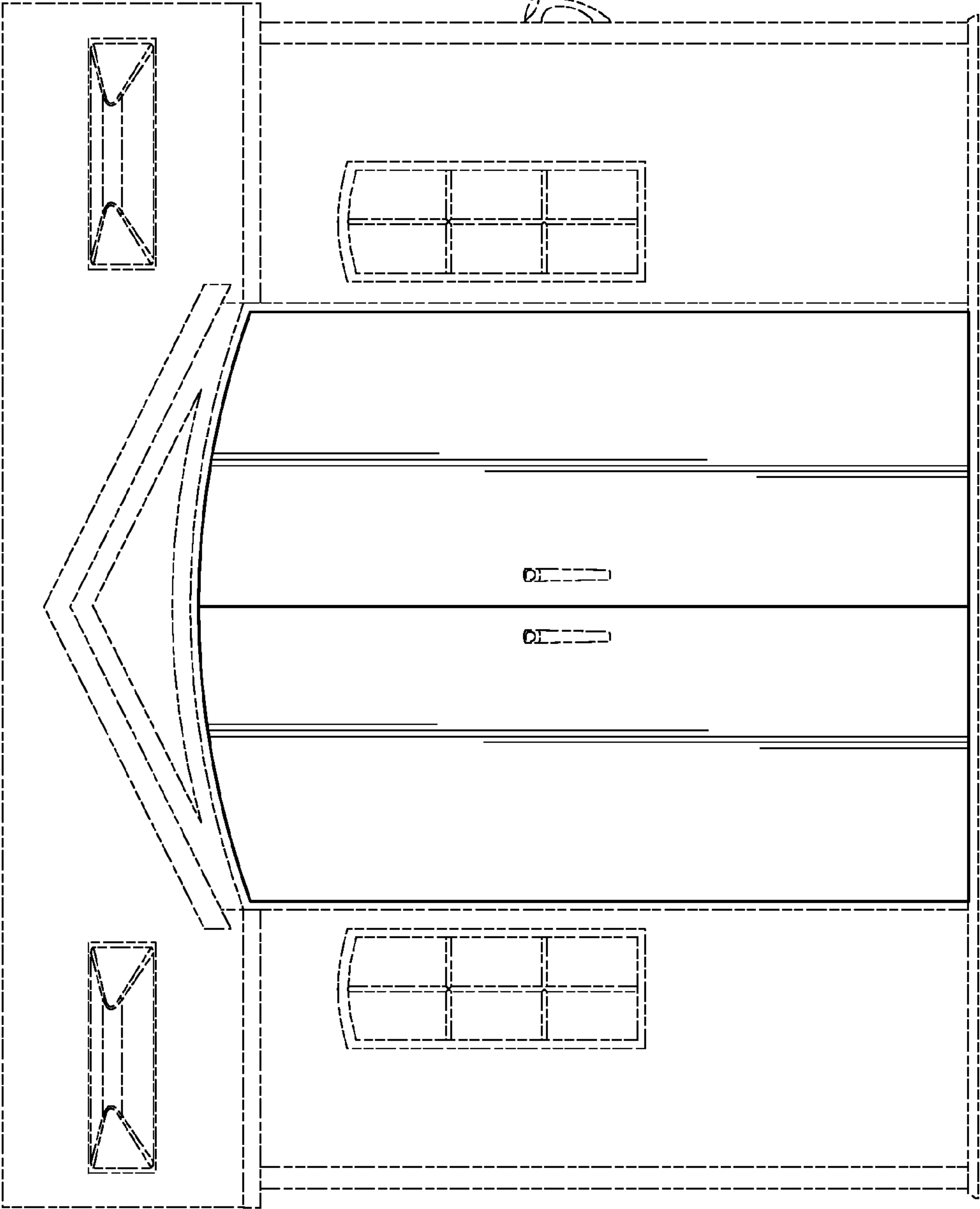

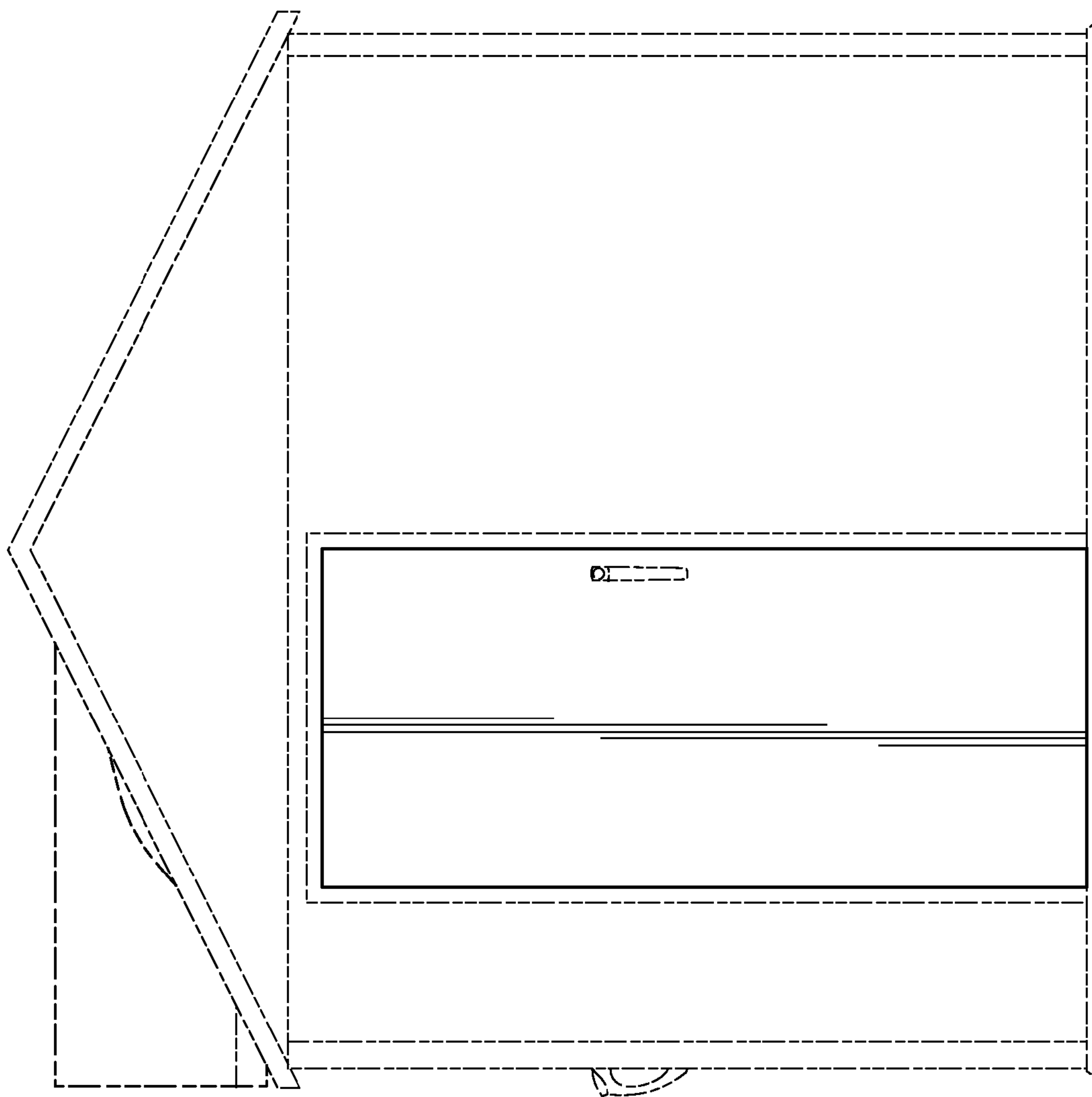

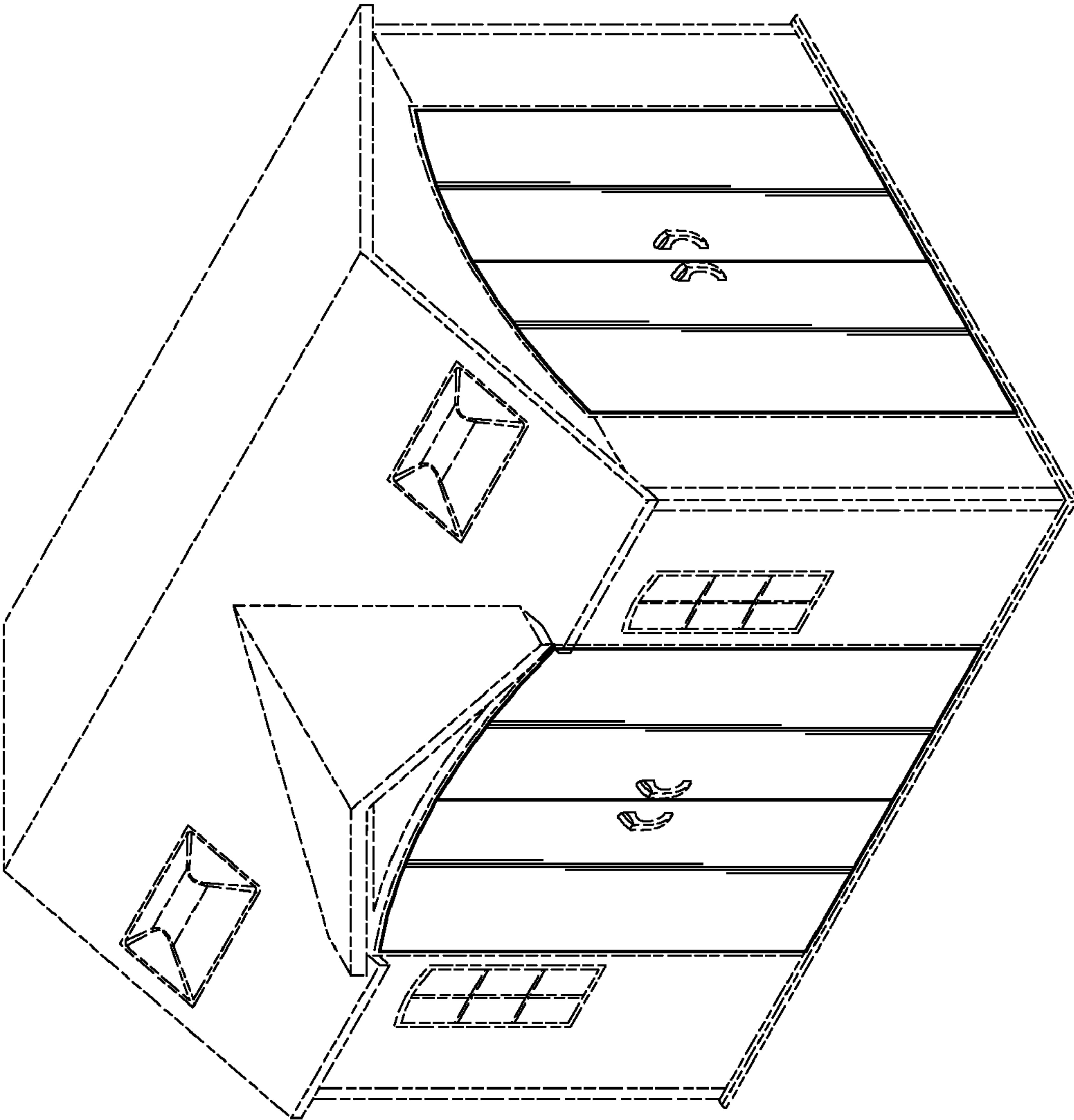

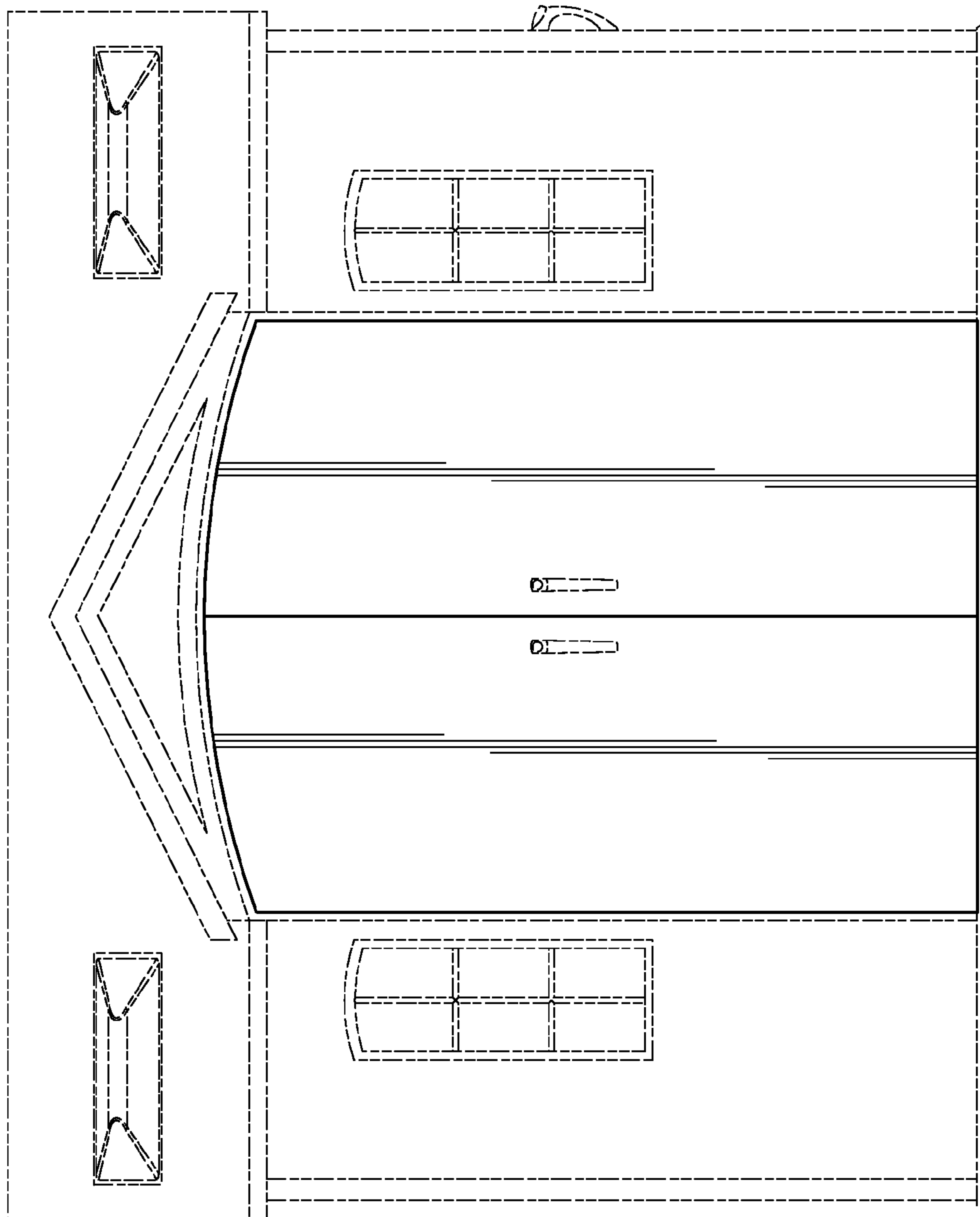

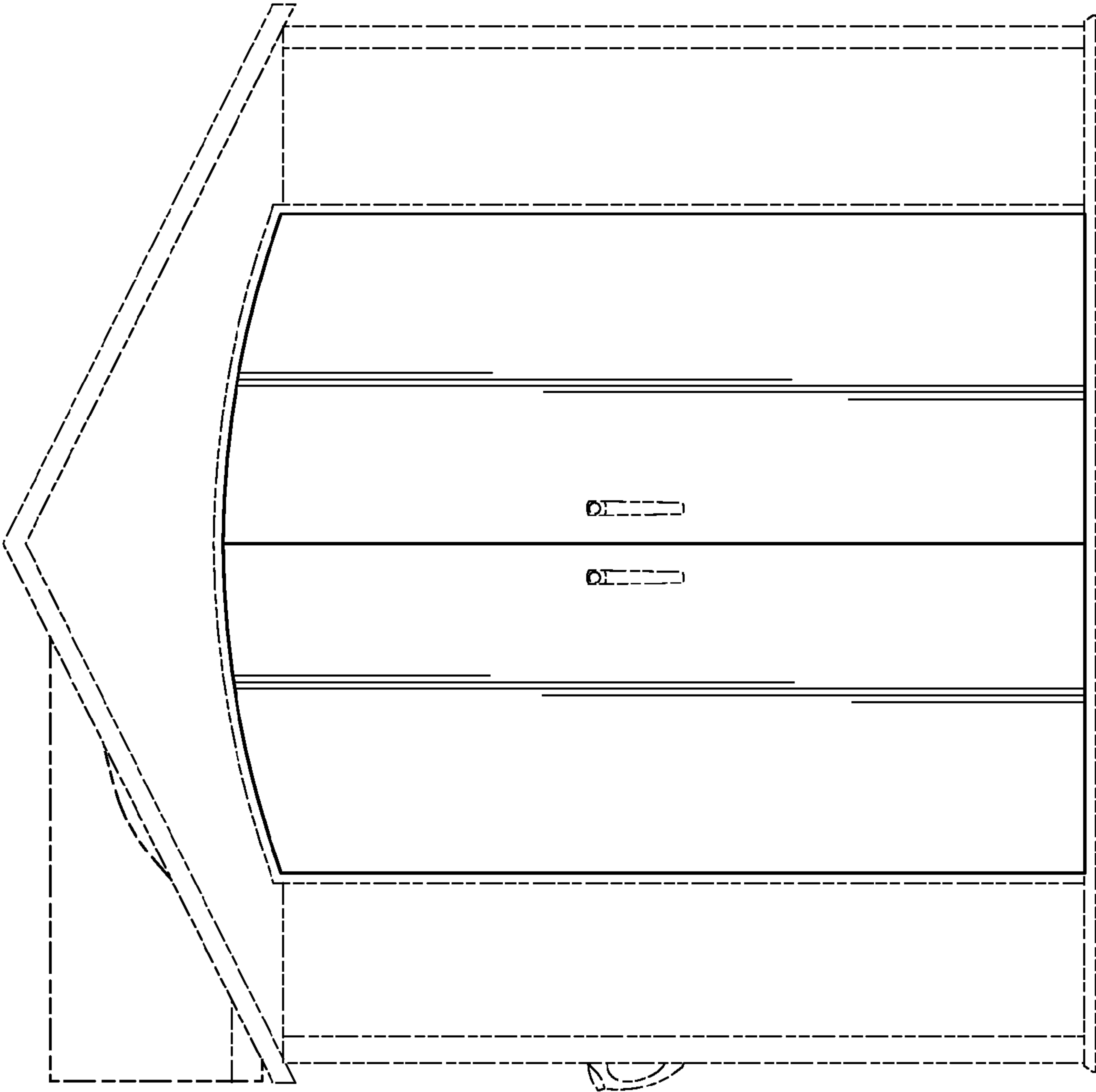
