**DESCRIPTION**

FIG. 1 is front view of jeans according to the present invention.

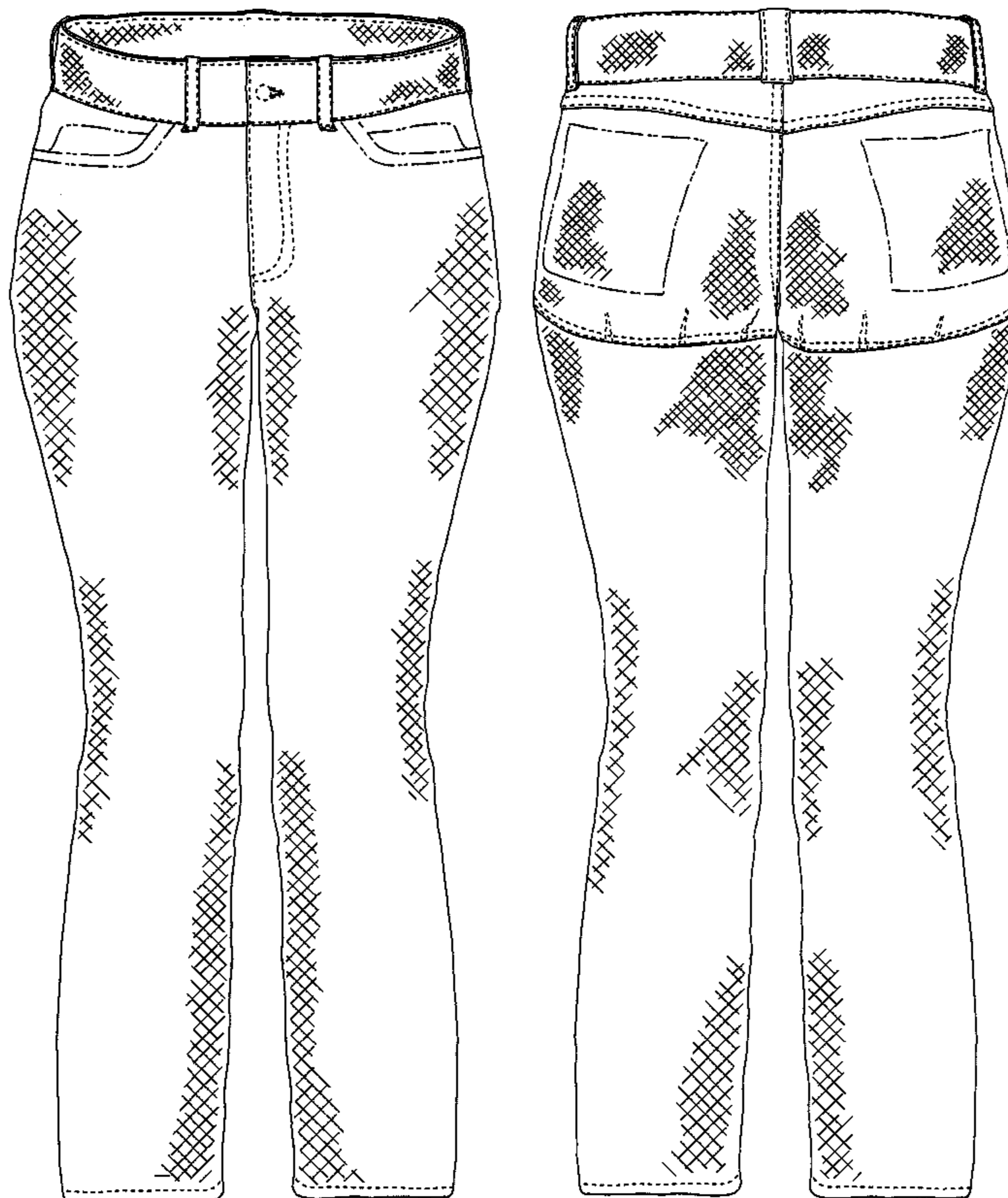
FIG. 2 is a back view thereof; and,

FIG. 3 is a right side view thereof, the left side being a mirror image thereof.

The dashed lines shown in FIGS. 1–3 represent stitching, and this stitching includes darts shown along the bottom of each seat panel.

The portions shown in dot-dot-dash lines are for illustrative purposes only and form no part of the claimed invention.

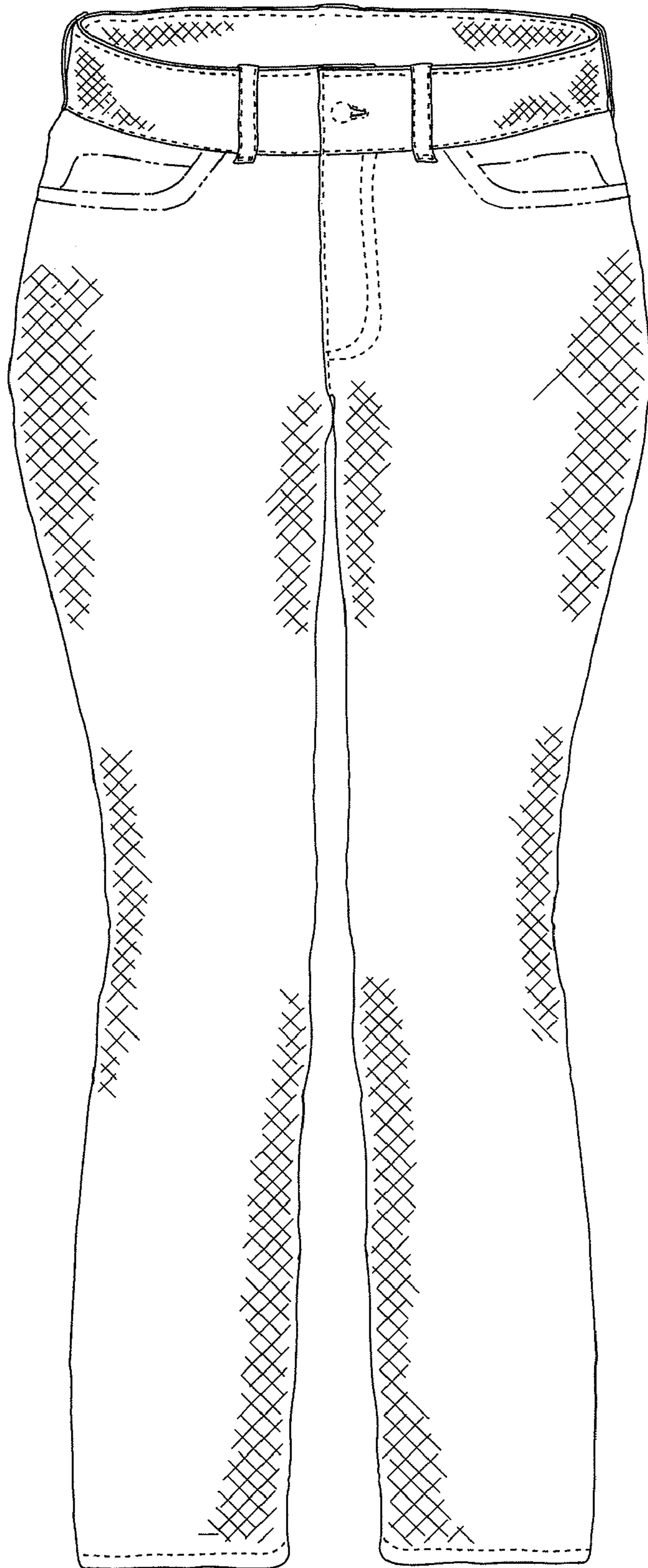

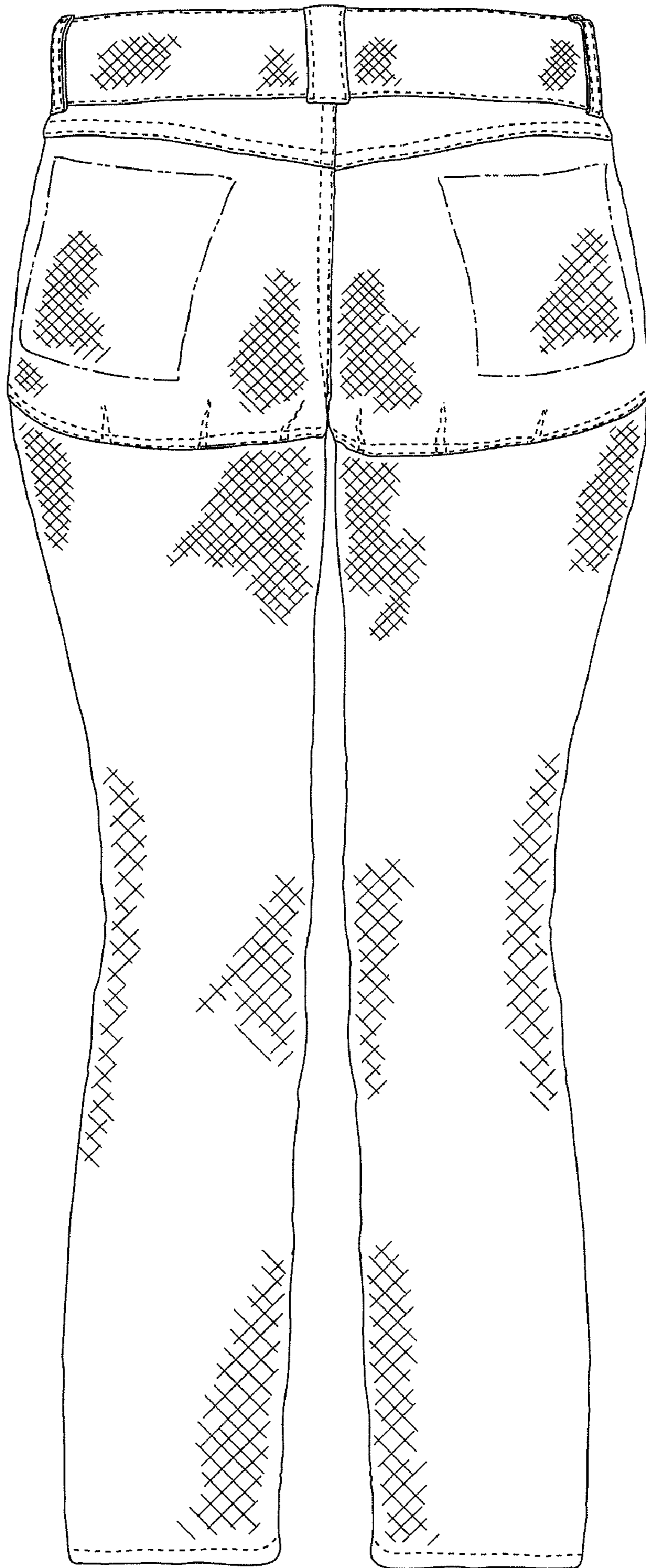

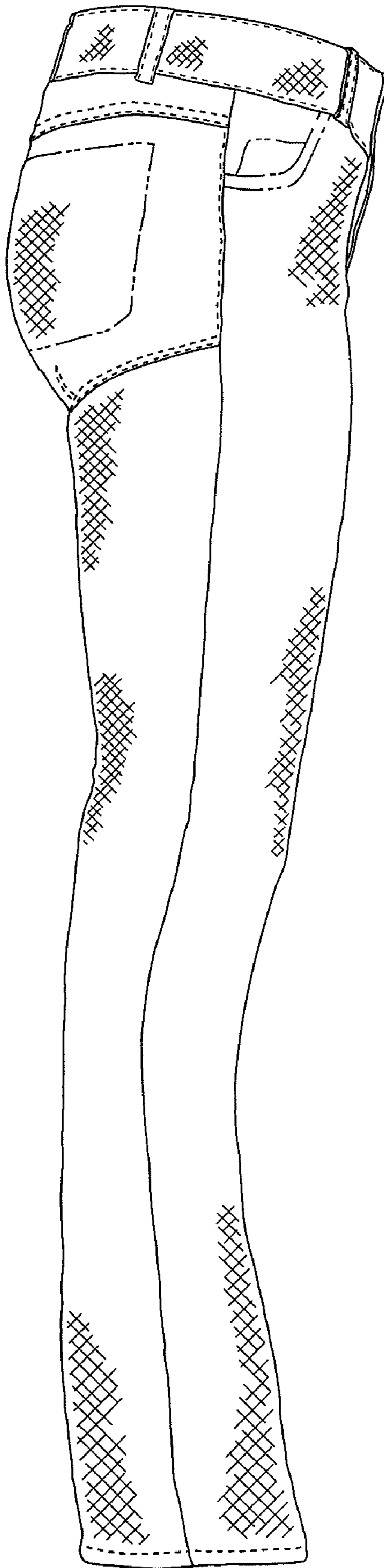
