The ornamental design for a tobacco chew case, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a tobacco holder according to my new design;

FIG. 10 is a front view of the tobacco holder of FIG. 8;

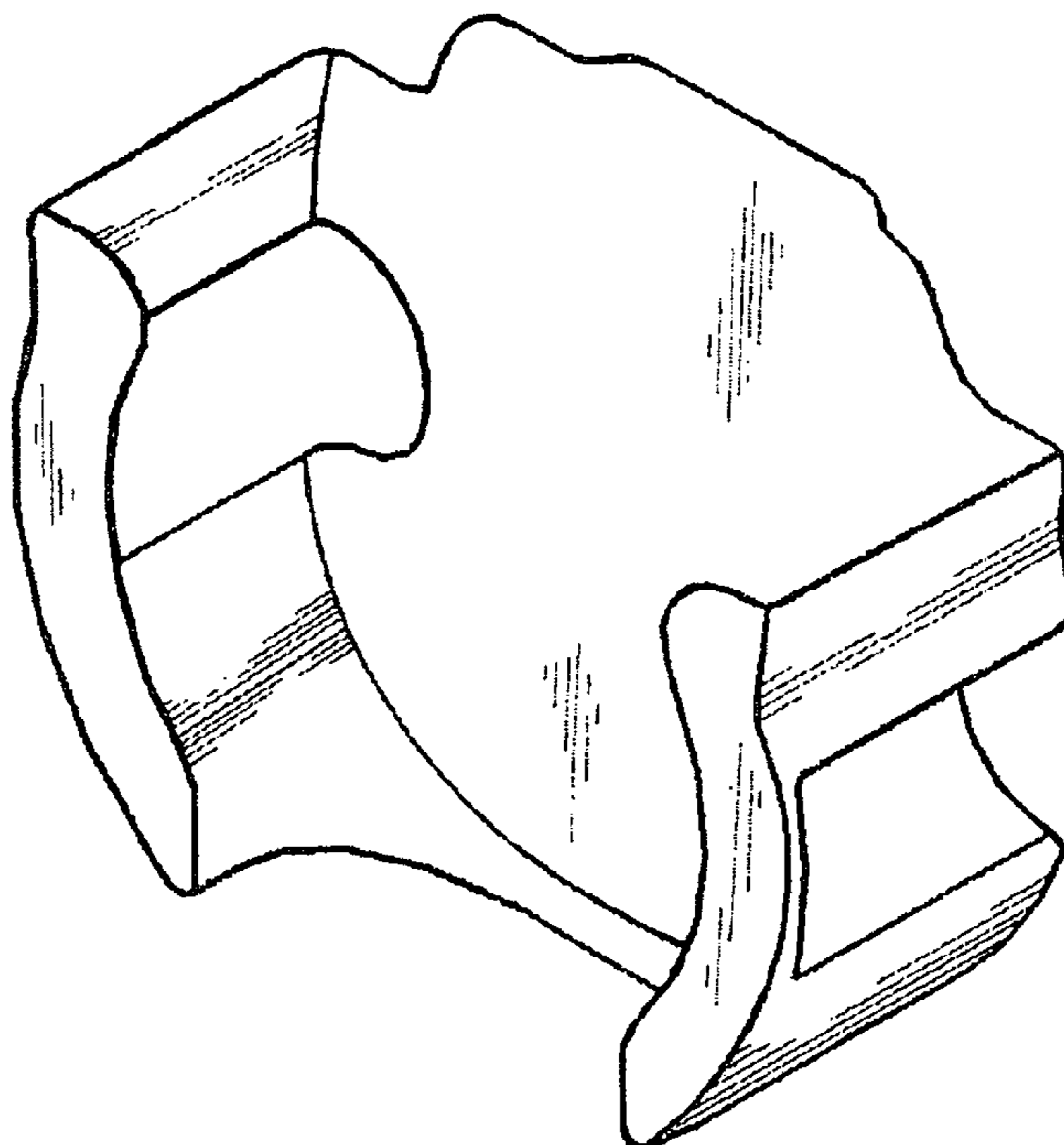
FIG. 11 is a bottom view of the tobacco holder of FIG. 8;

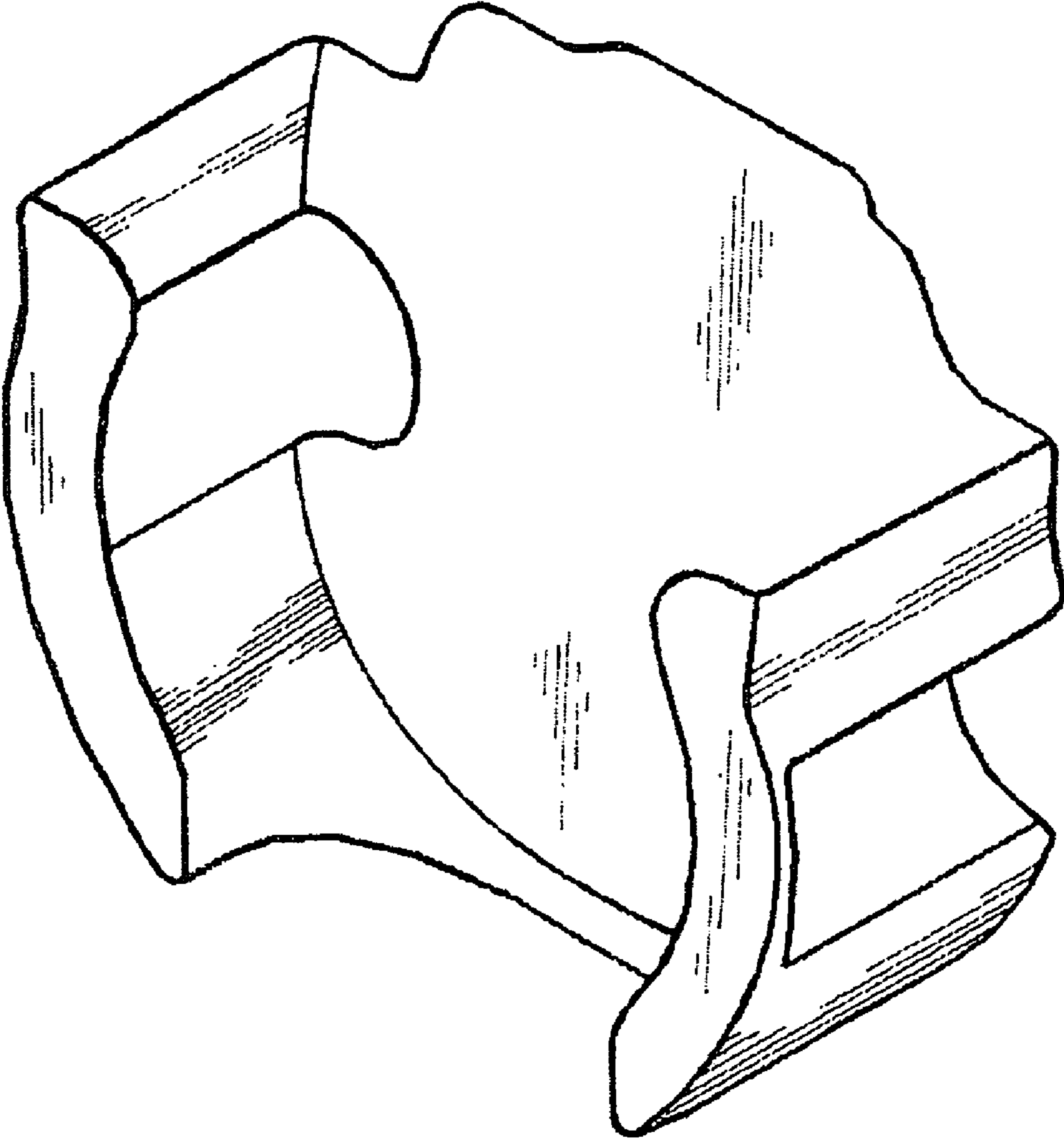

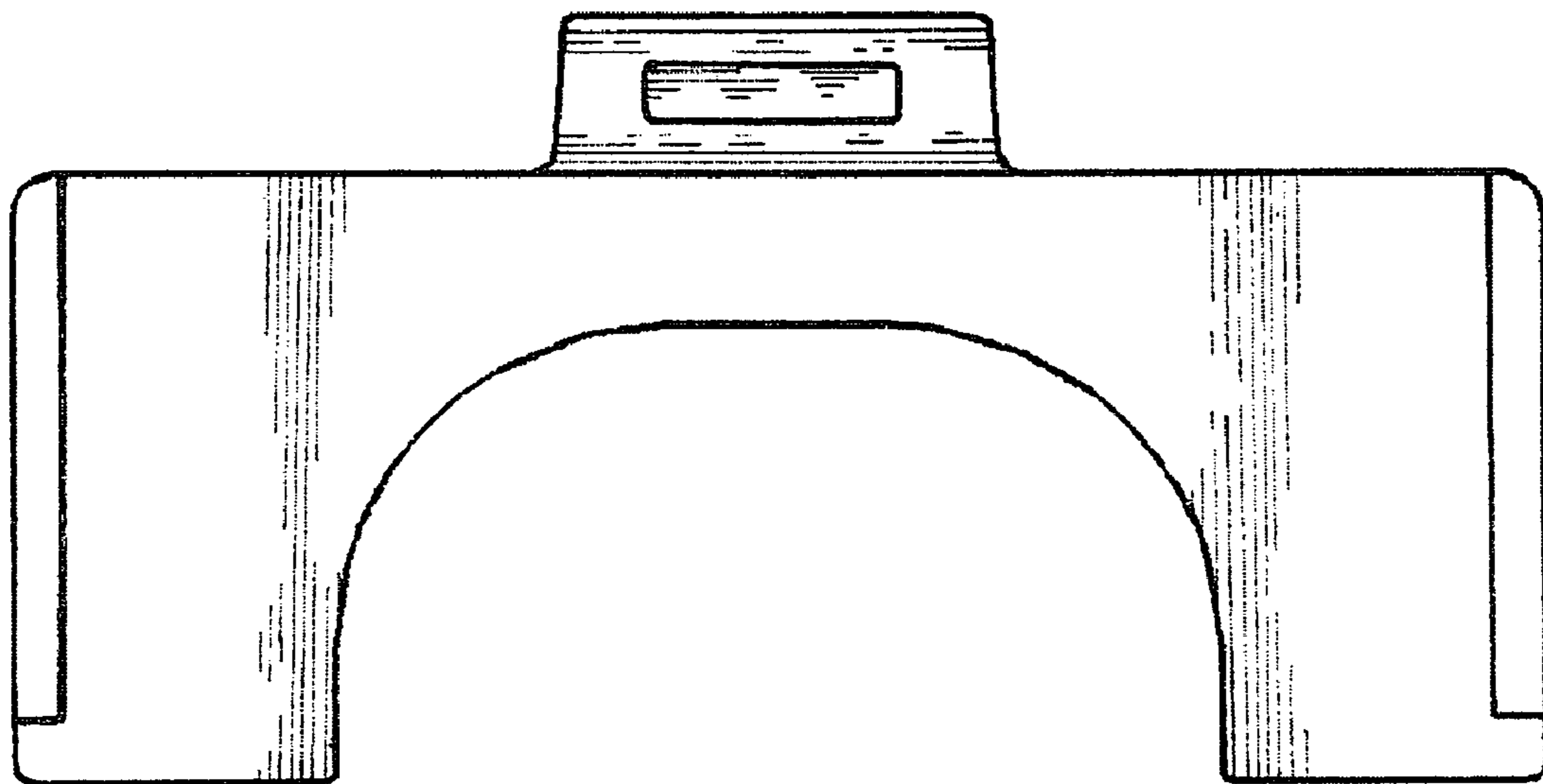

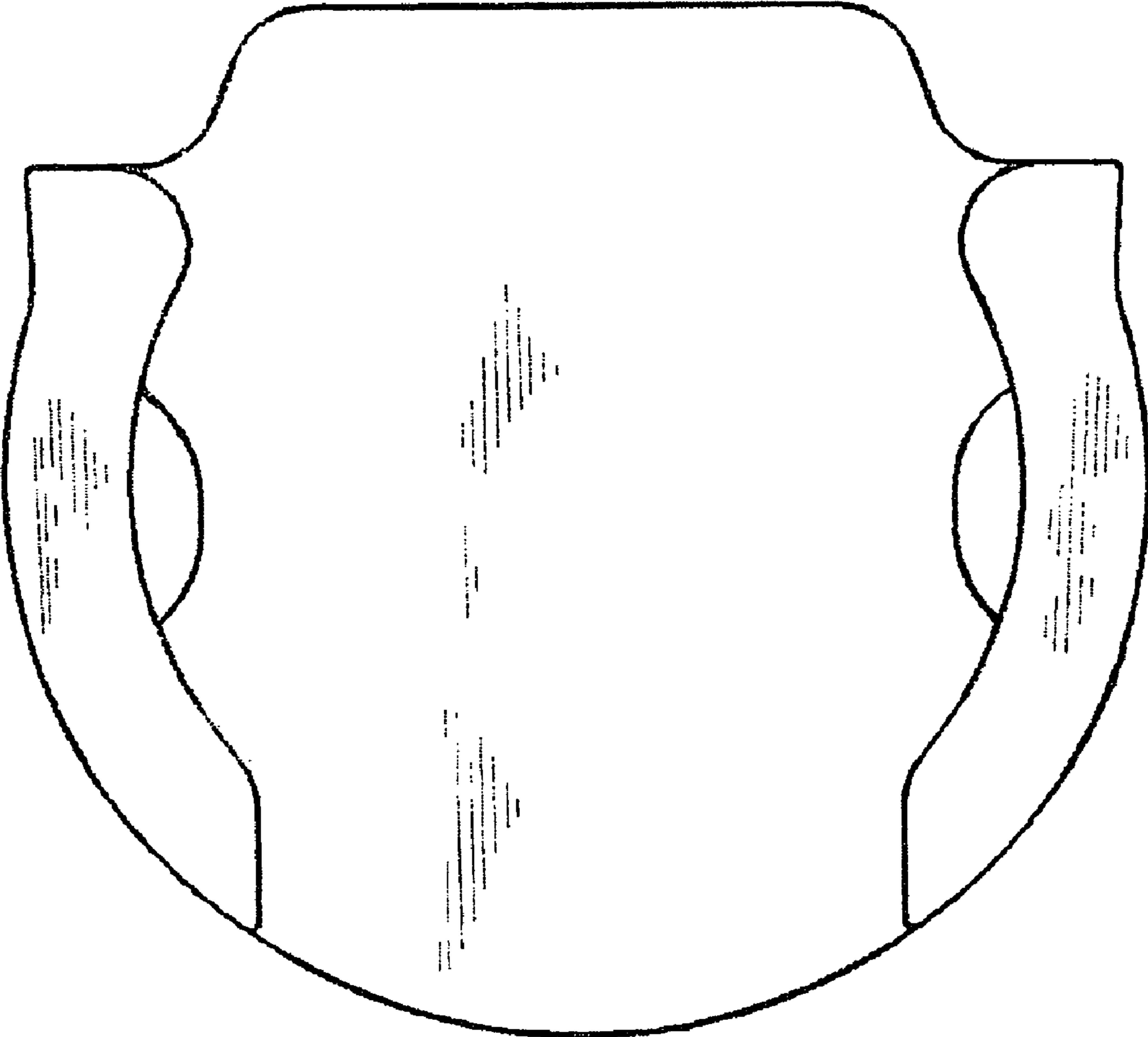

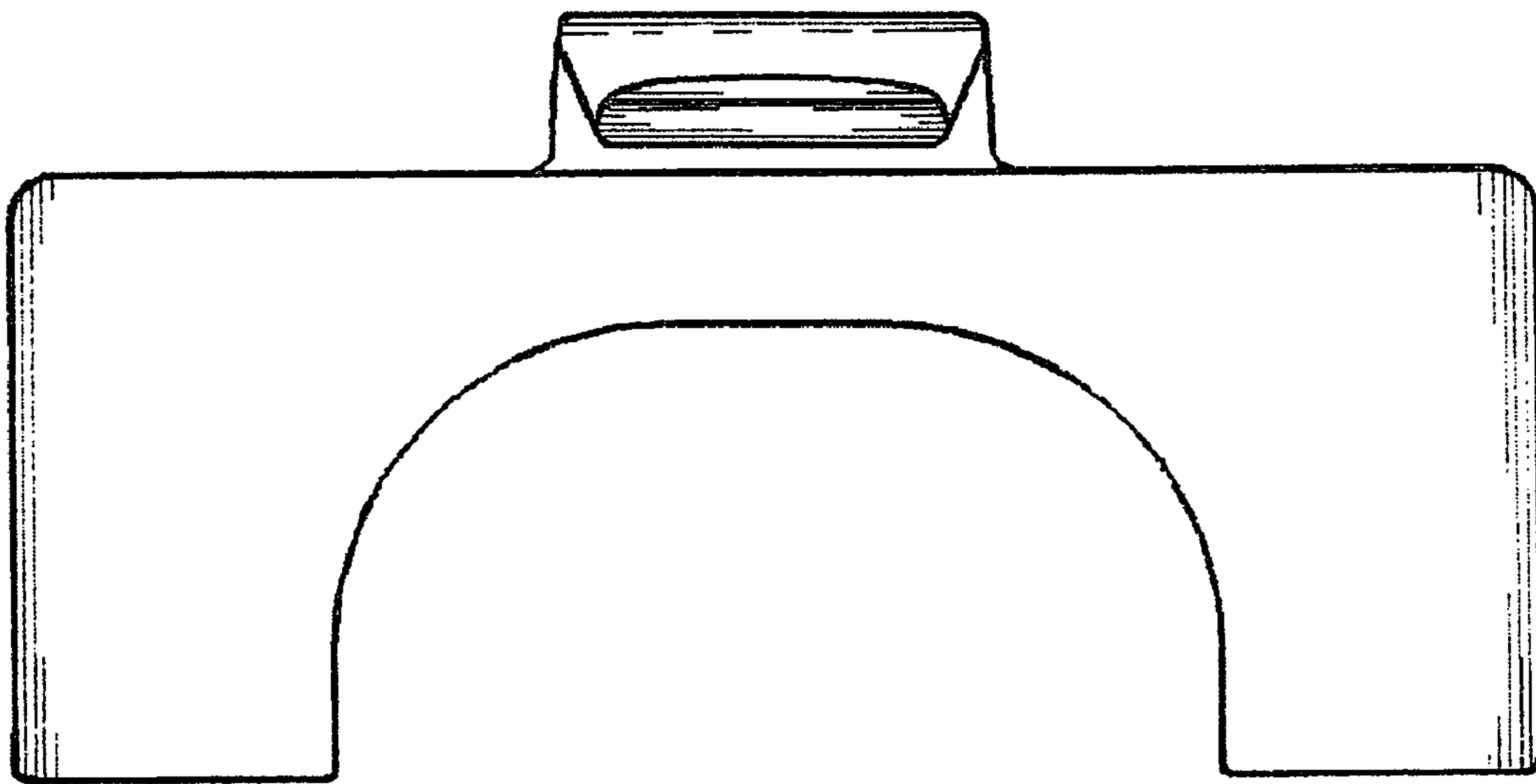

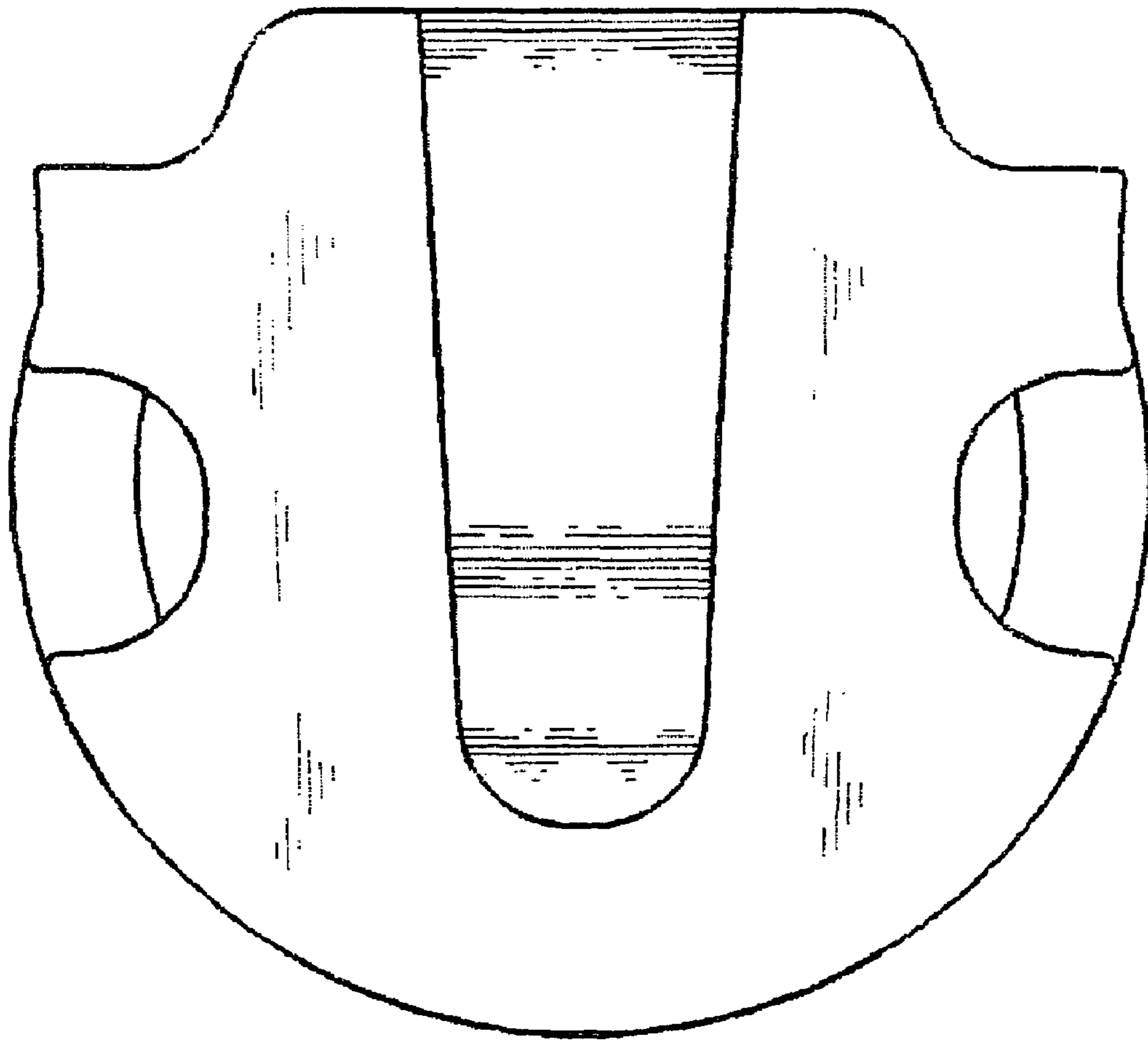

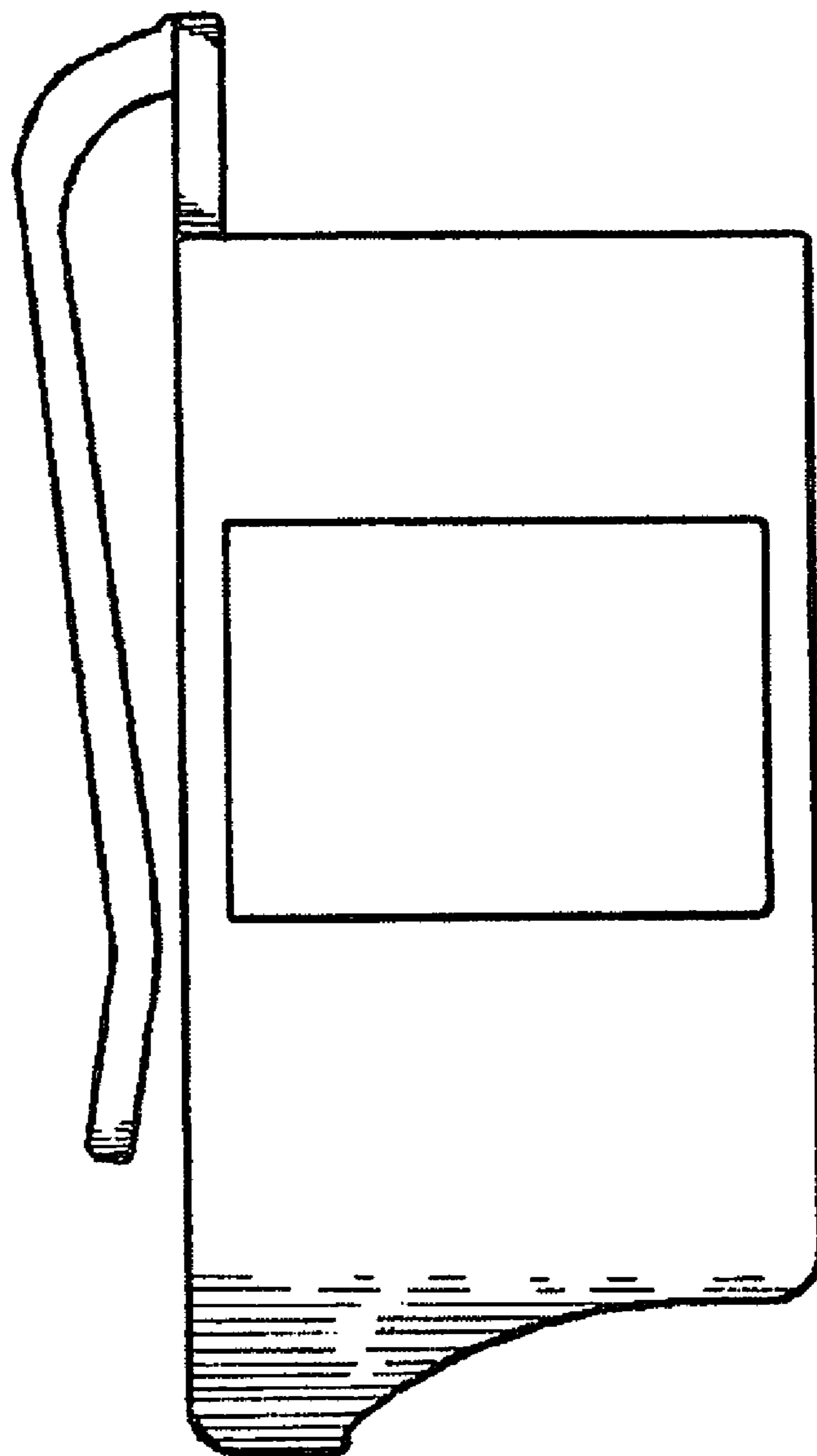

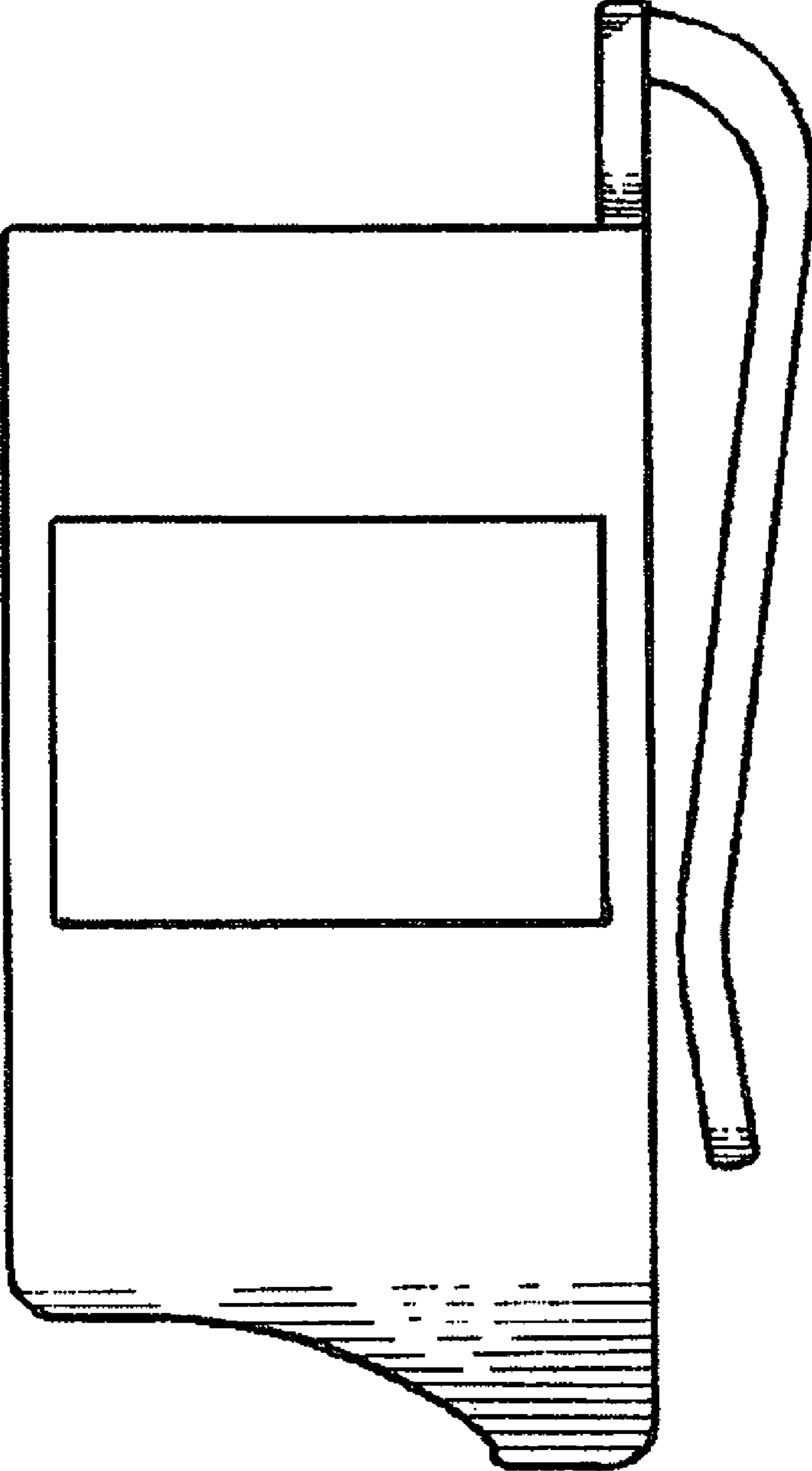

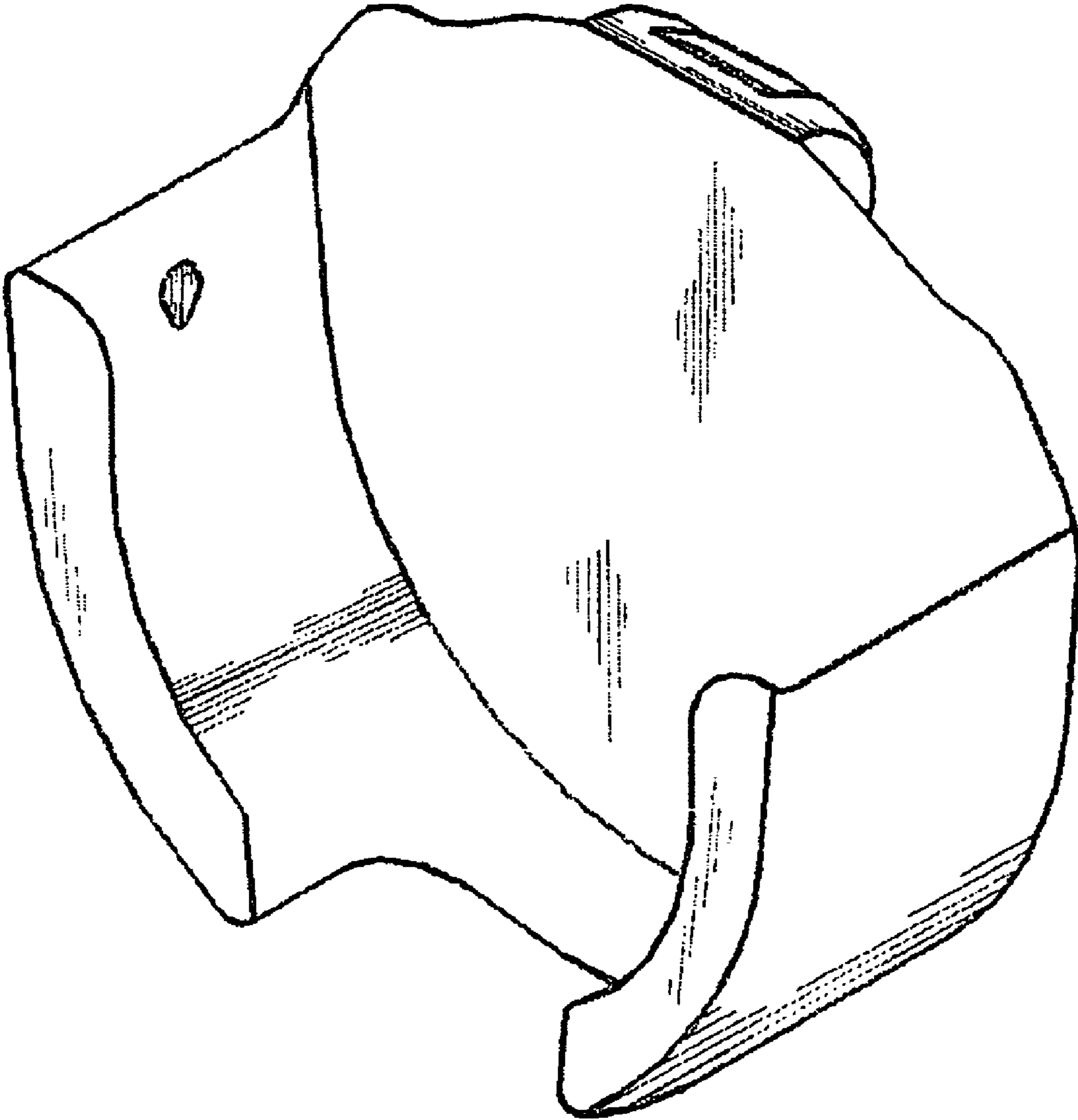

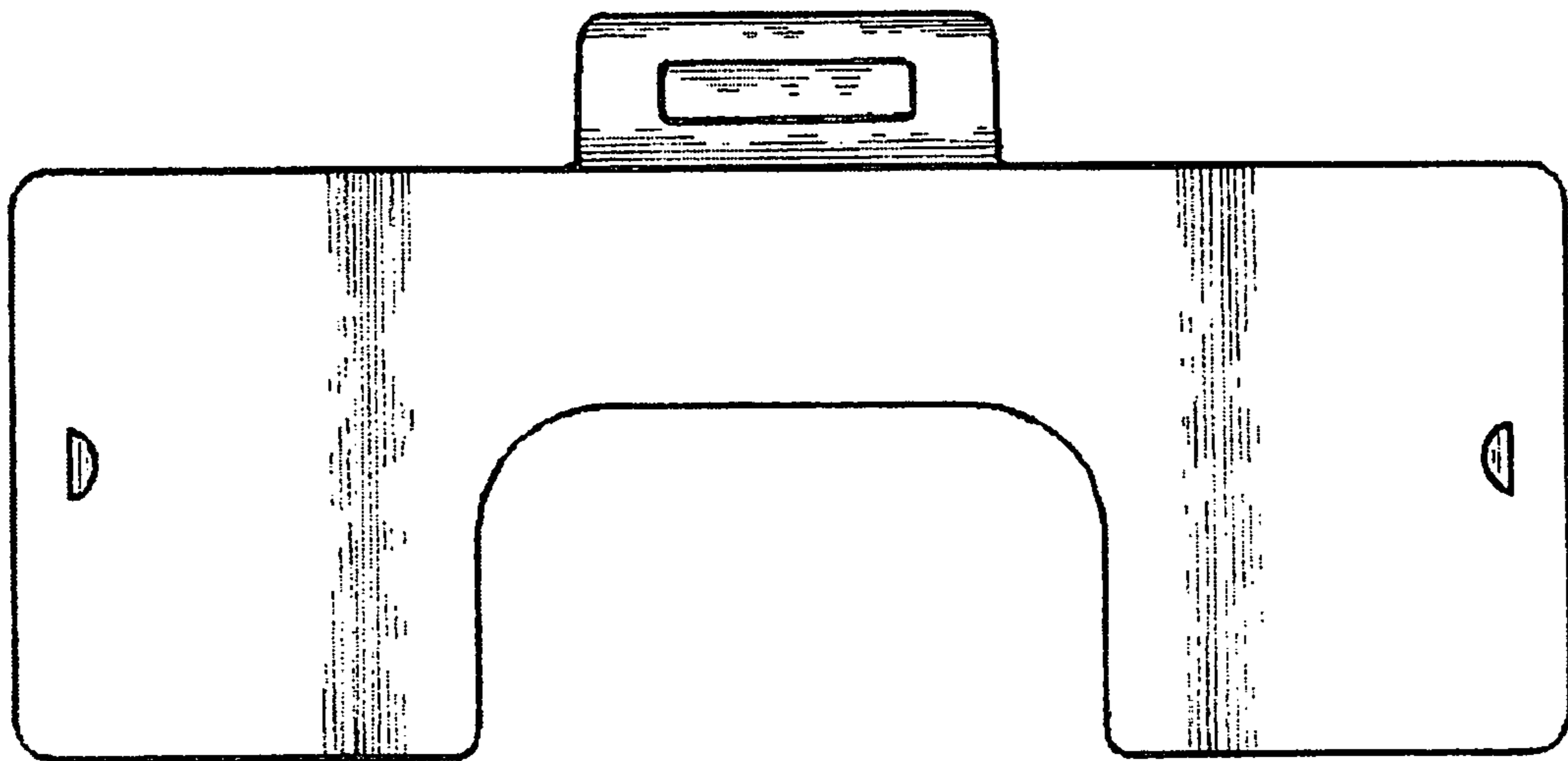

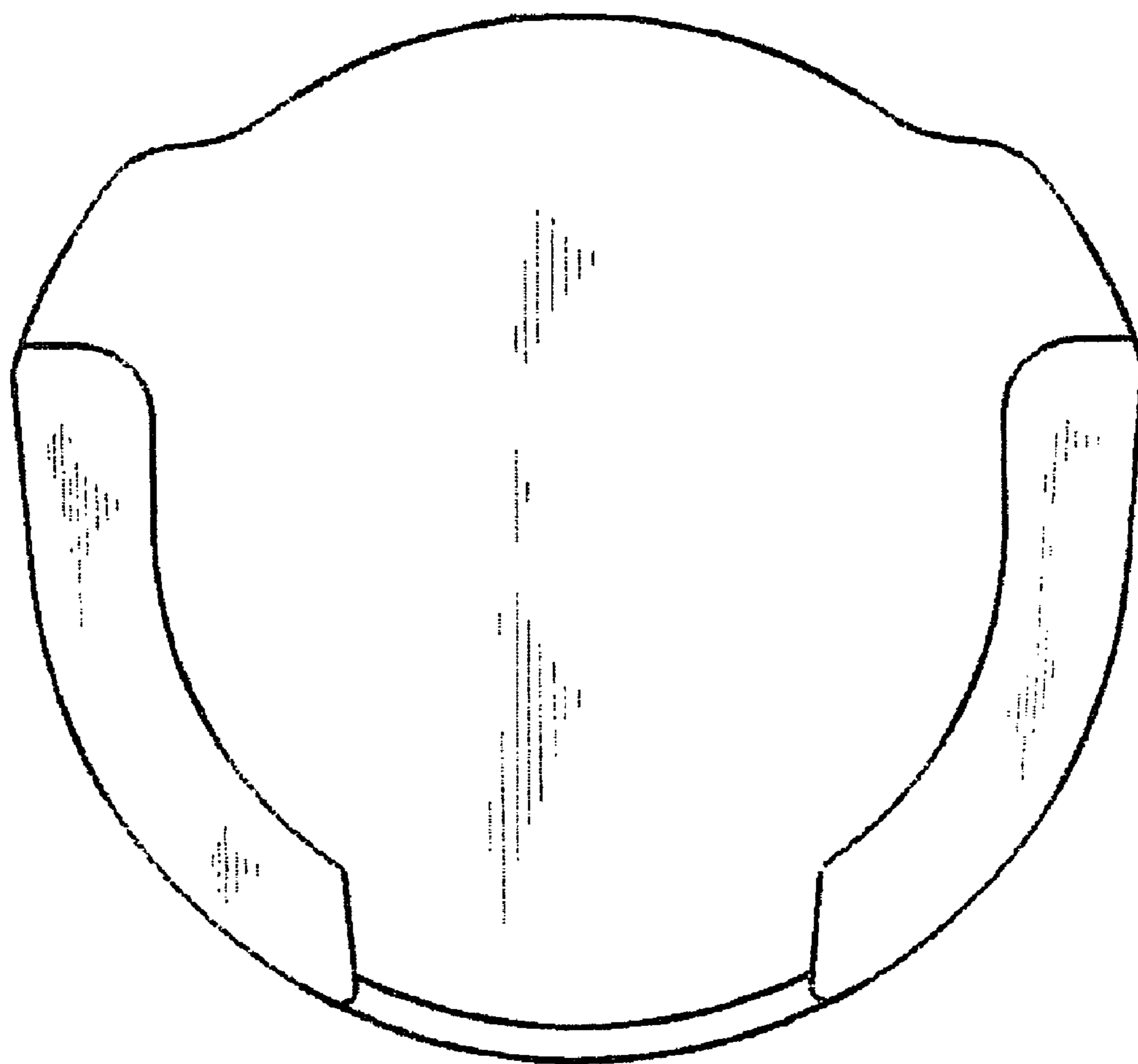

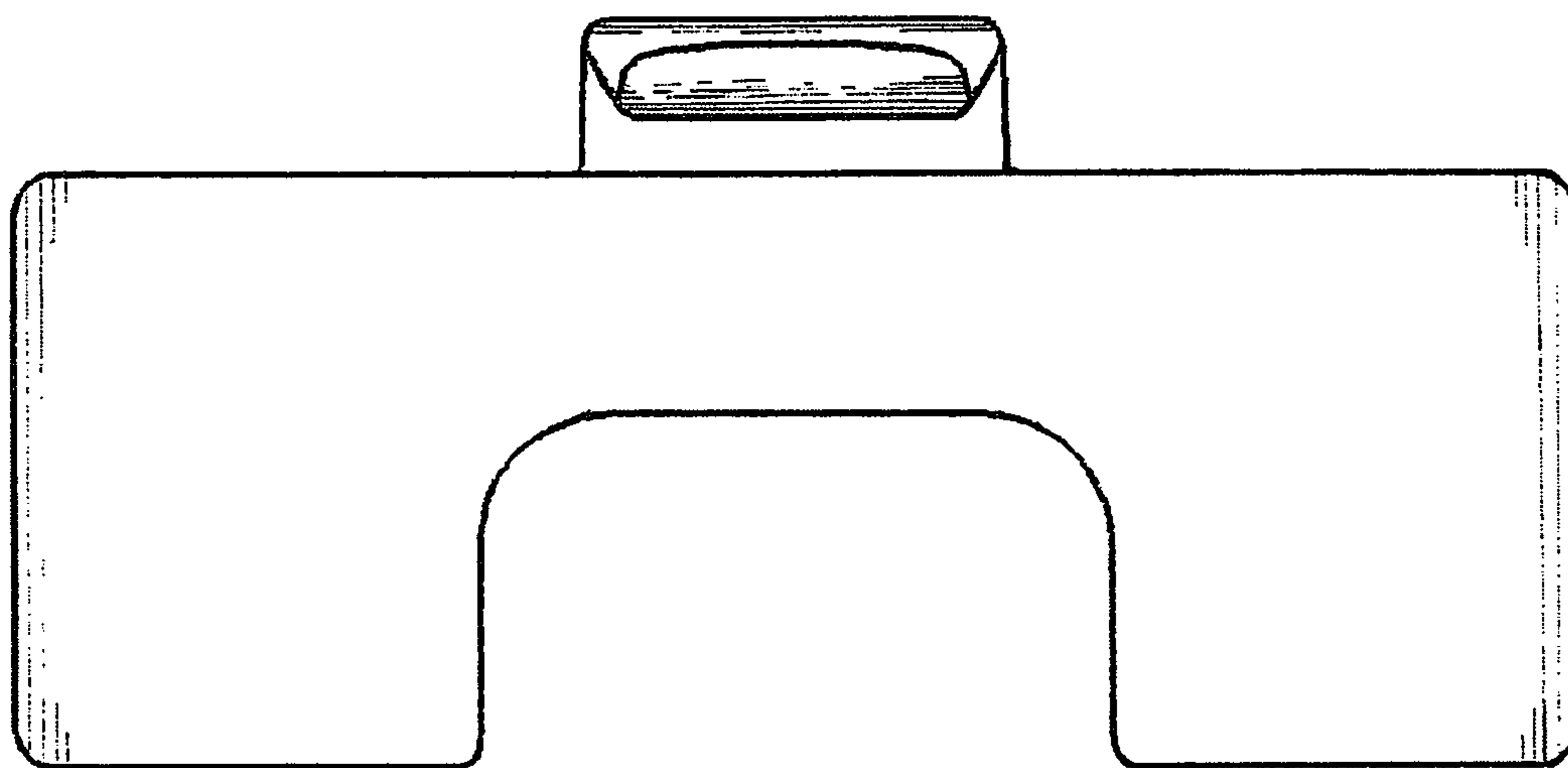

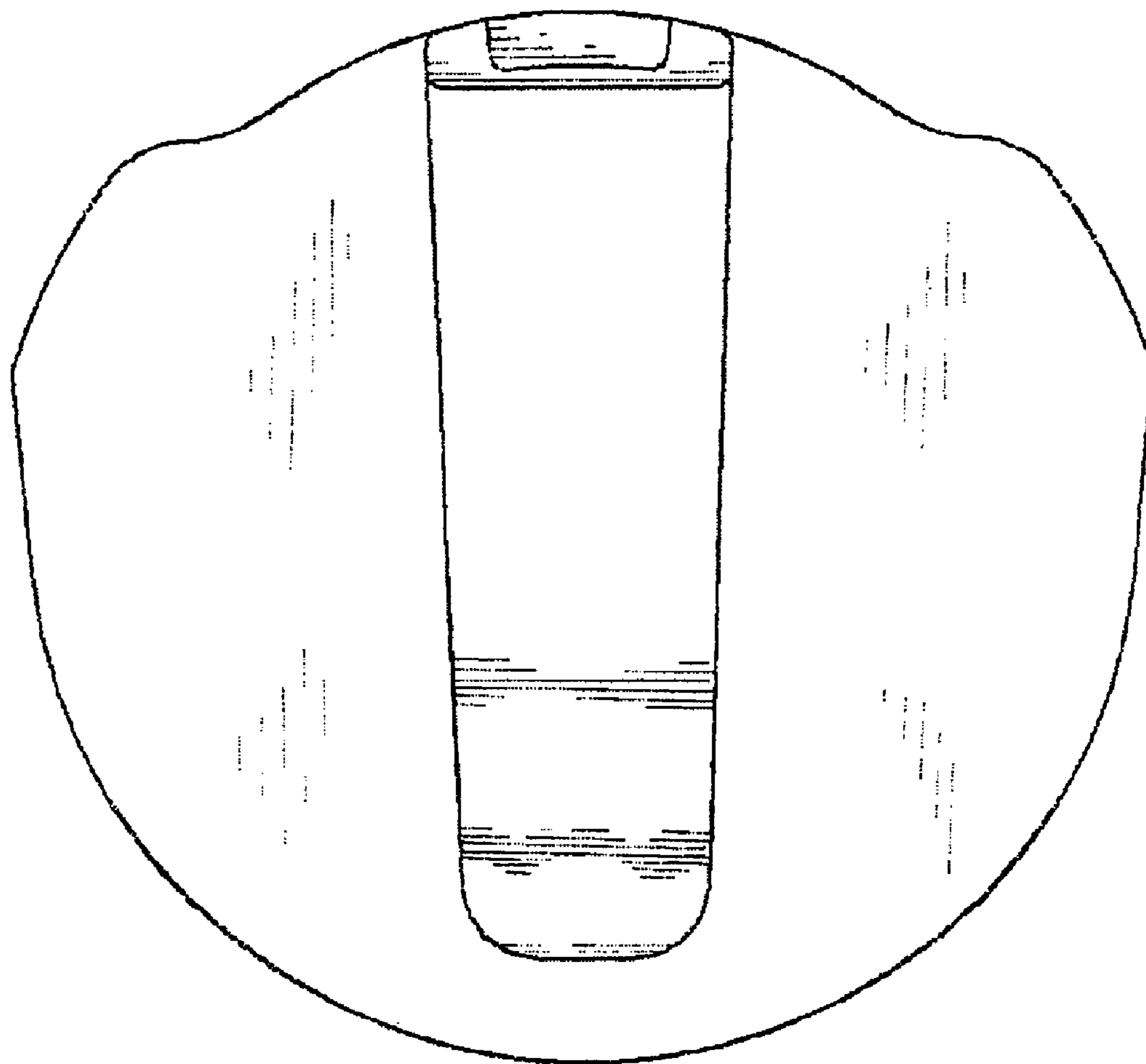

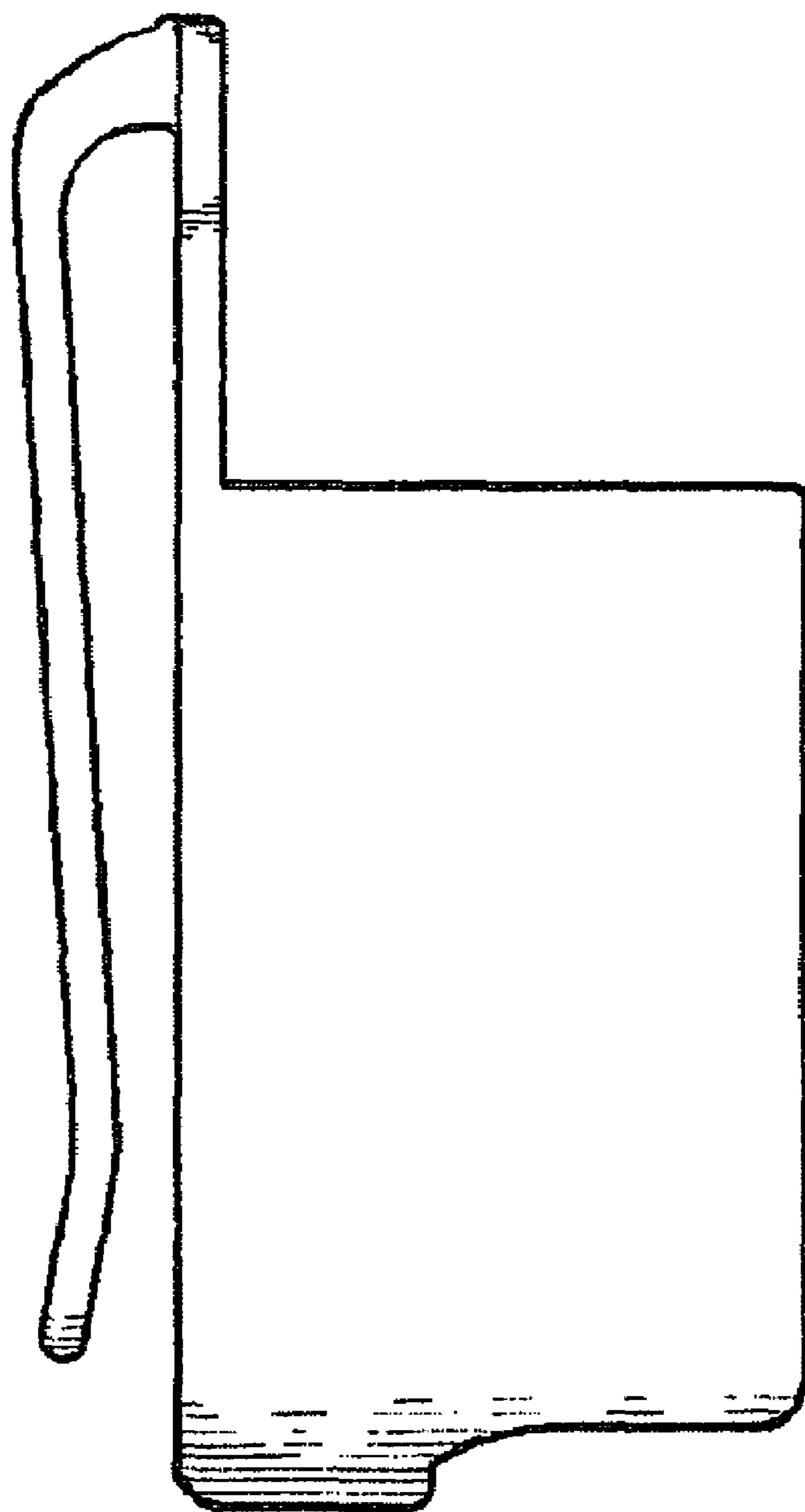

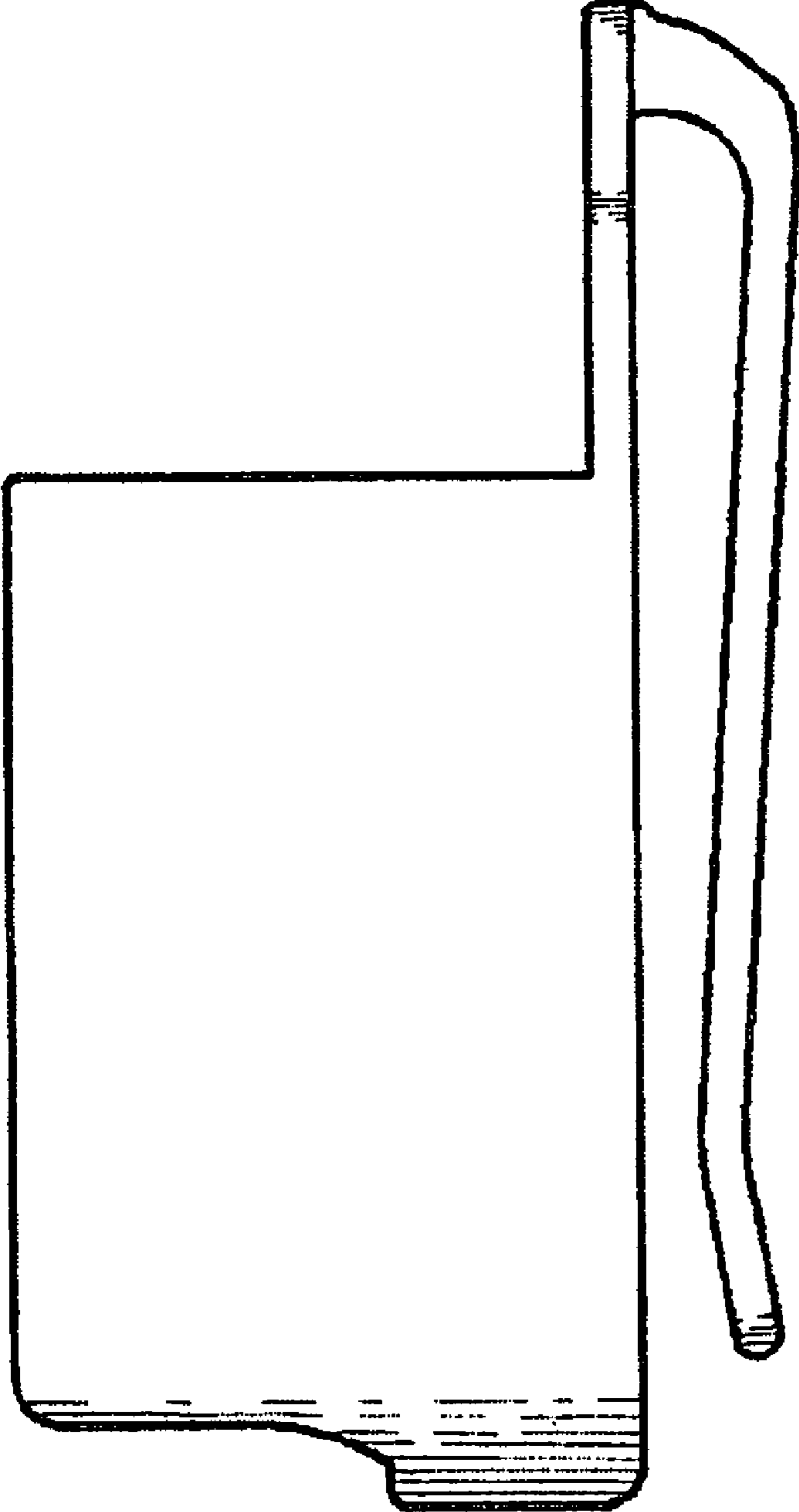
