The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of the handbag constructed according to my new design with the upper portion shown in the upright condition;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a rear, top and left side perspective view thereof;

FIG. 9 is a rear, top and left side perspective view thereof; and,

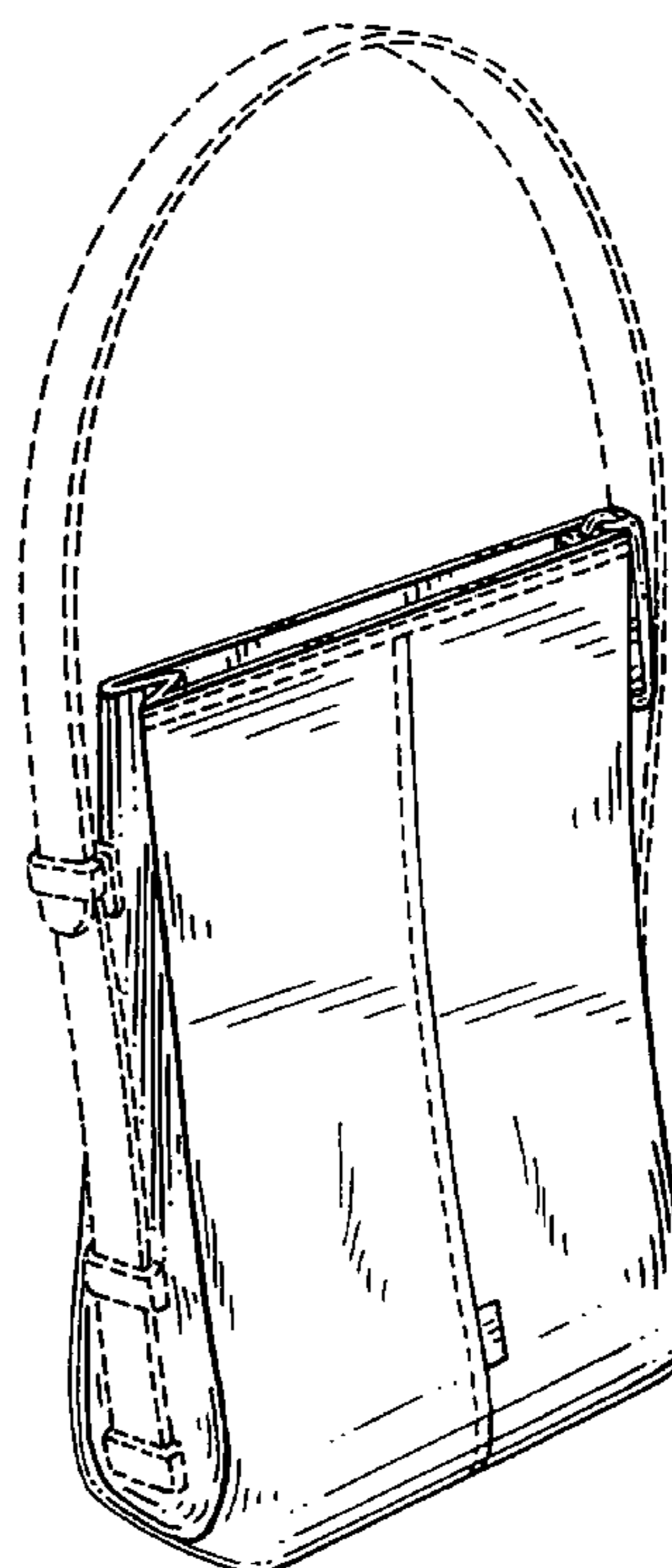
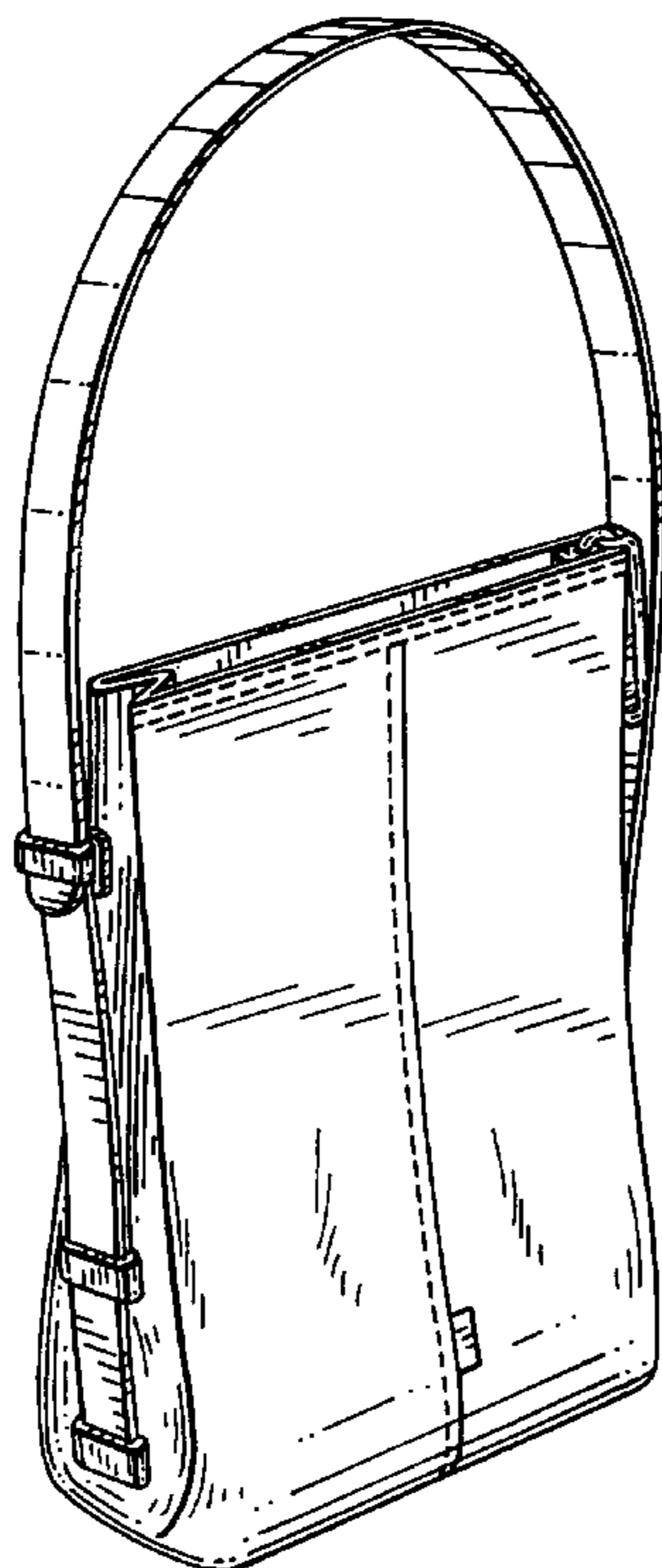
FIG. 10 is a front, top and left side perspective view thereof.

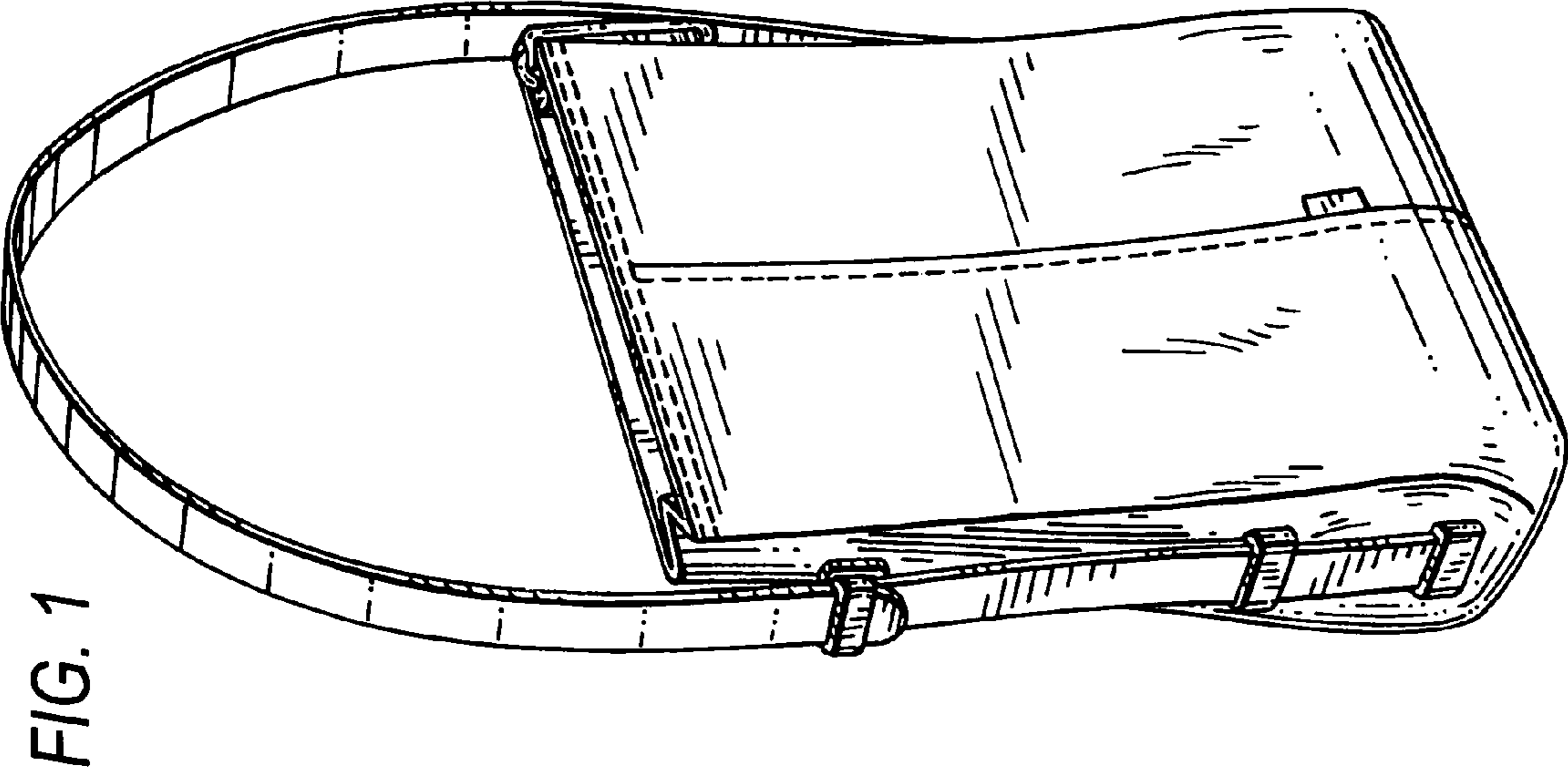

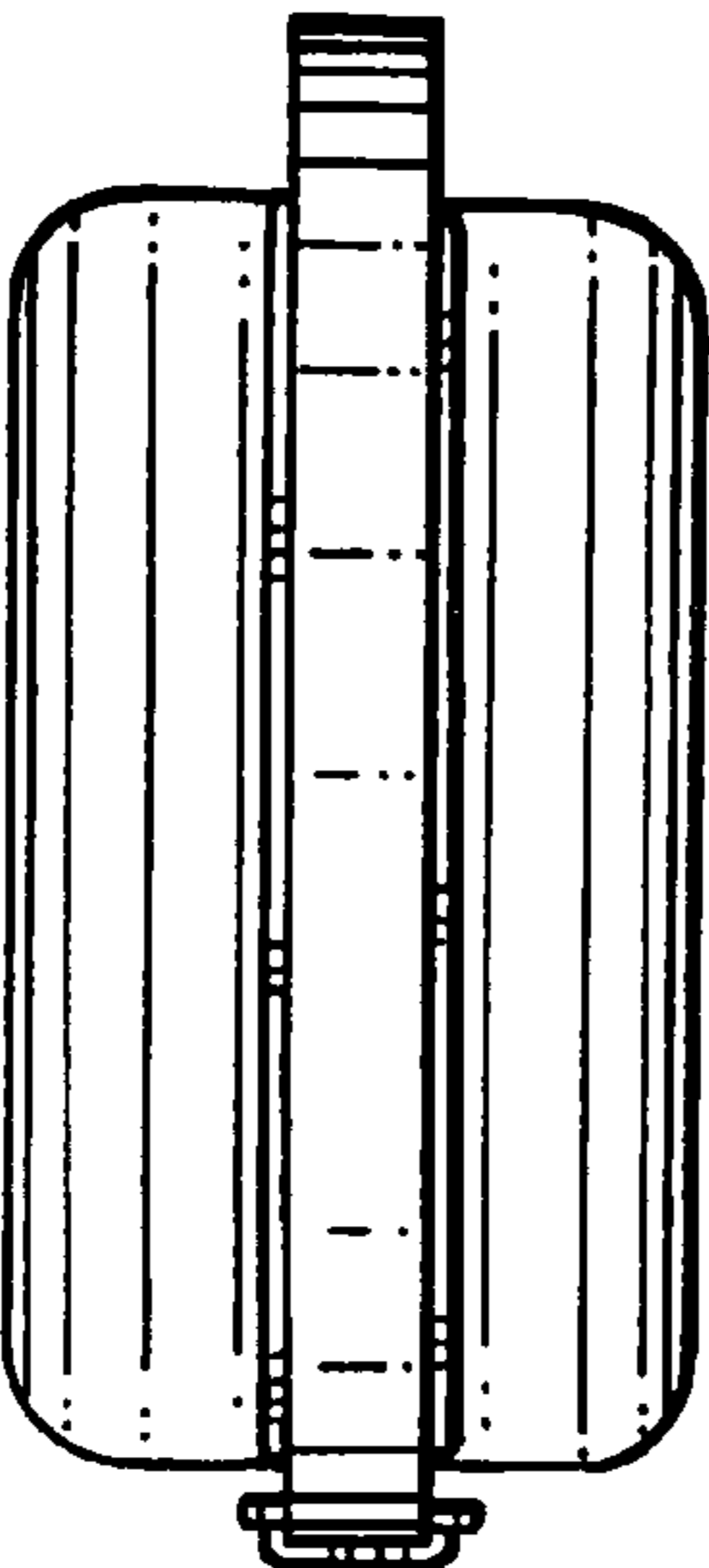

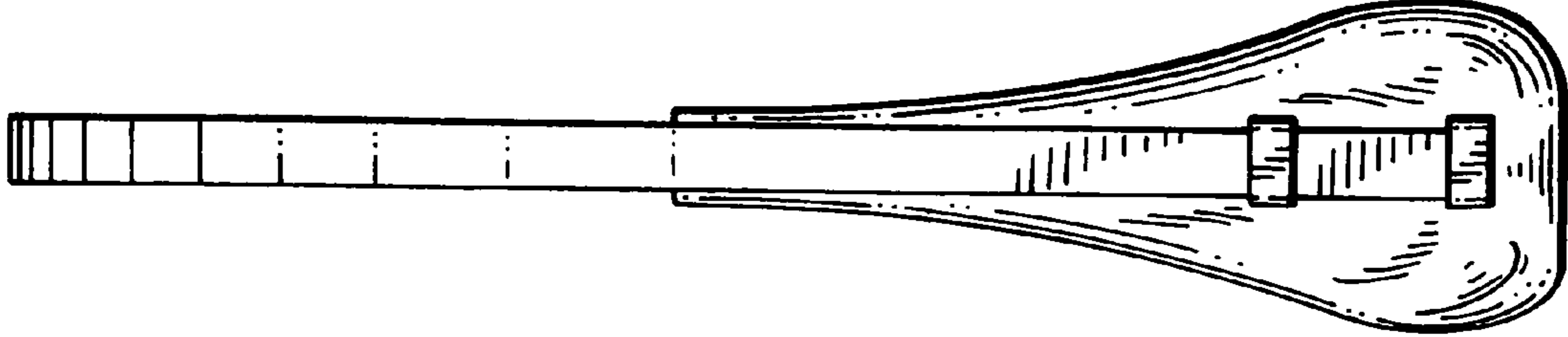

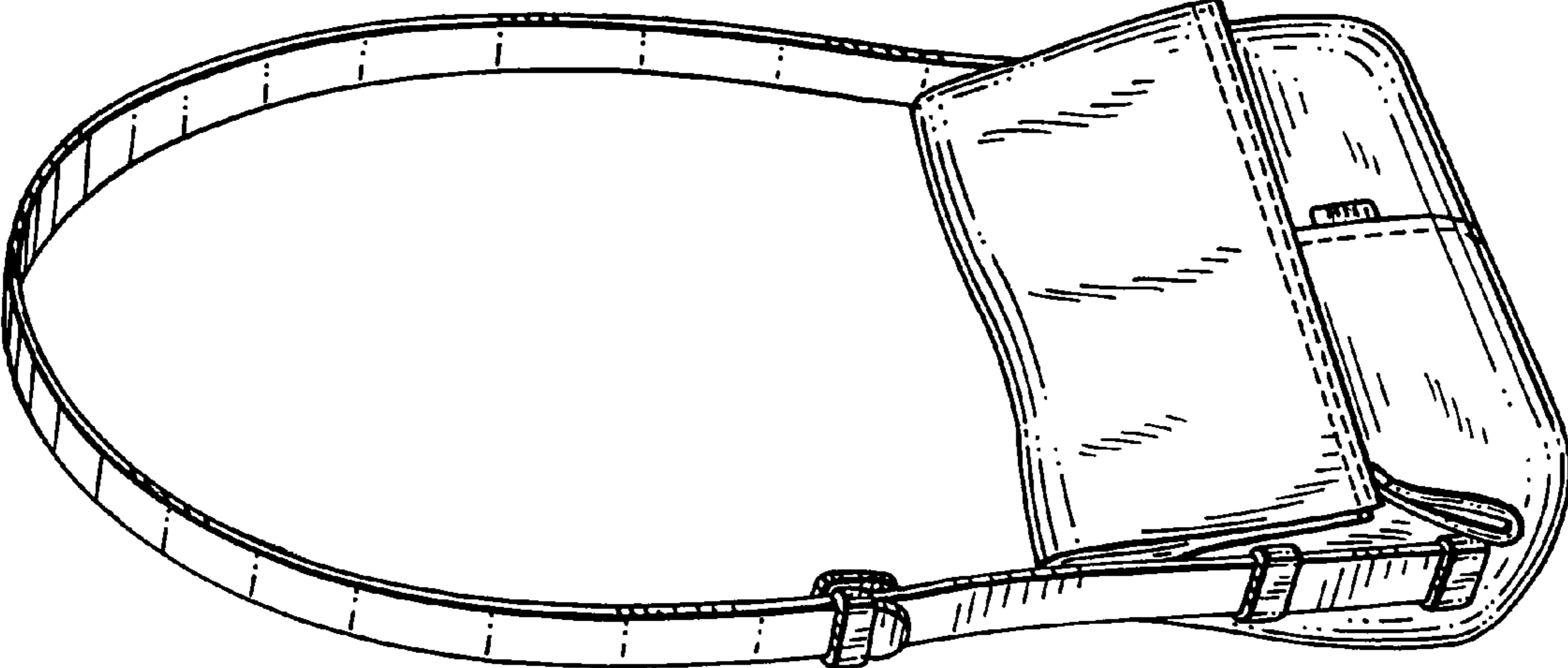
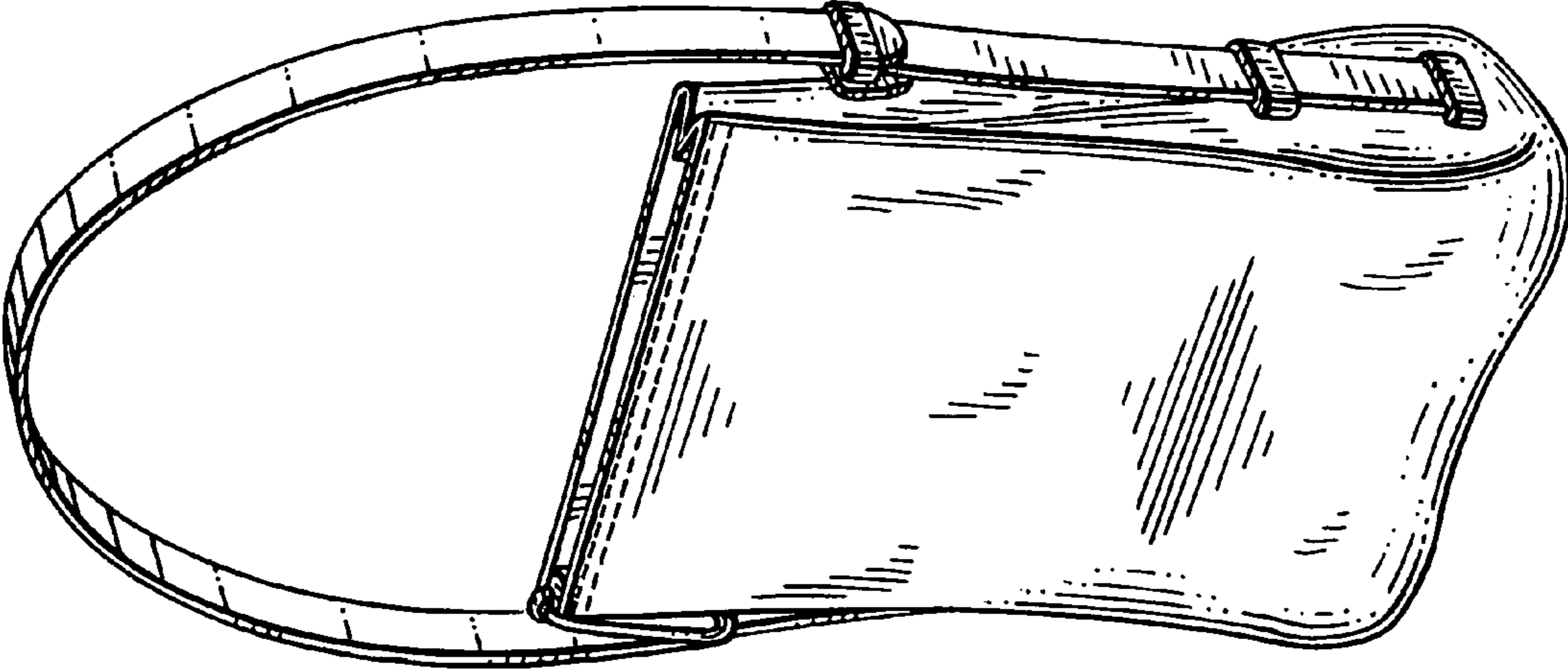

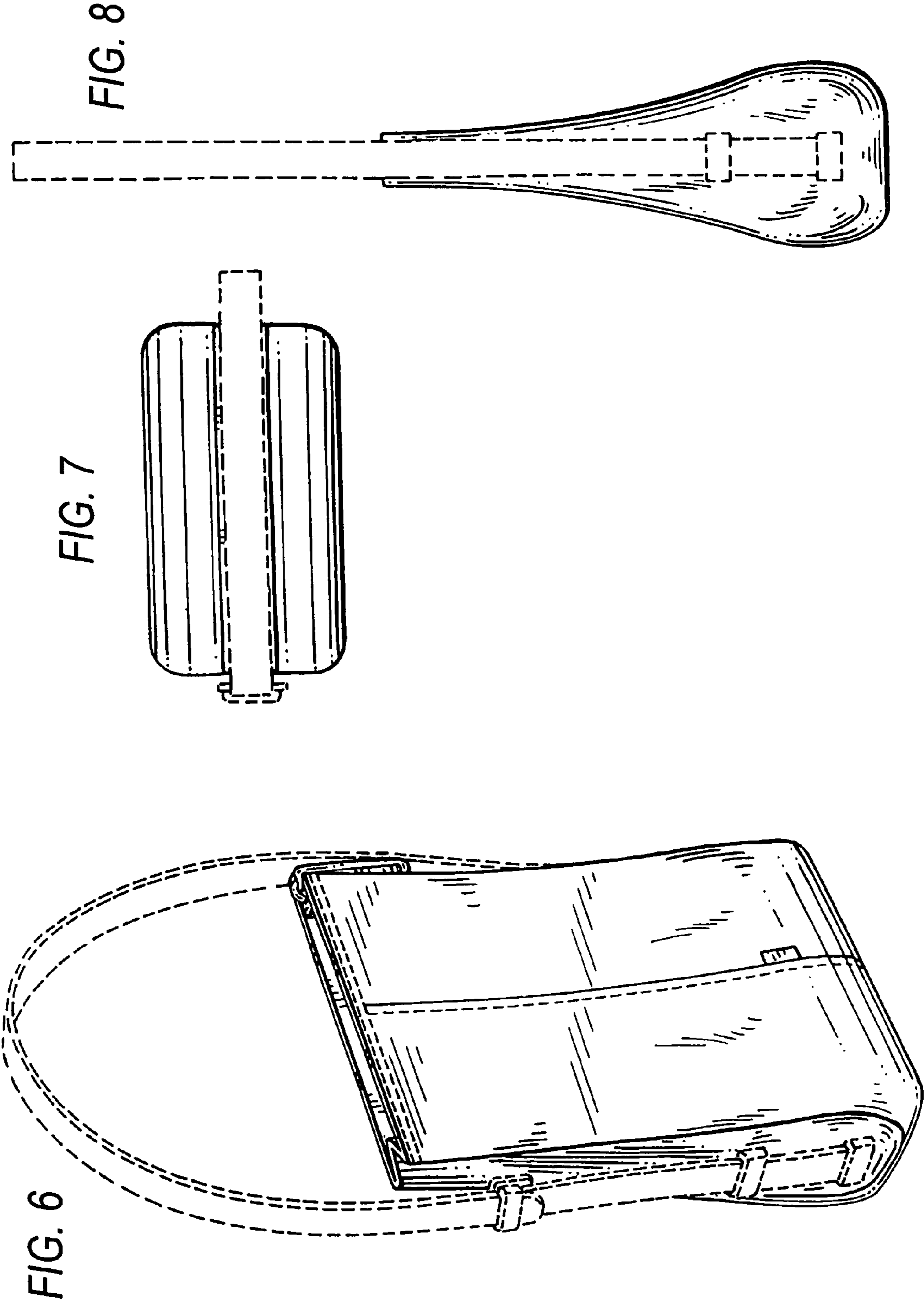

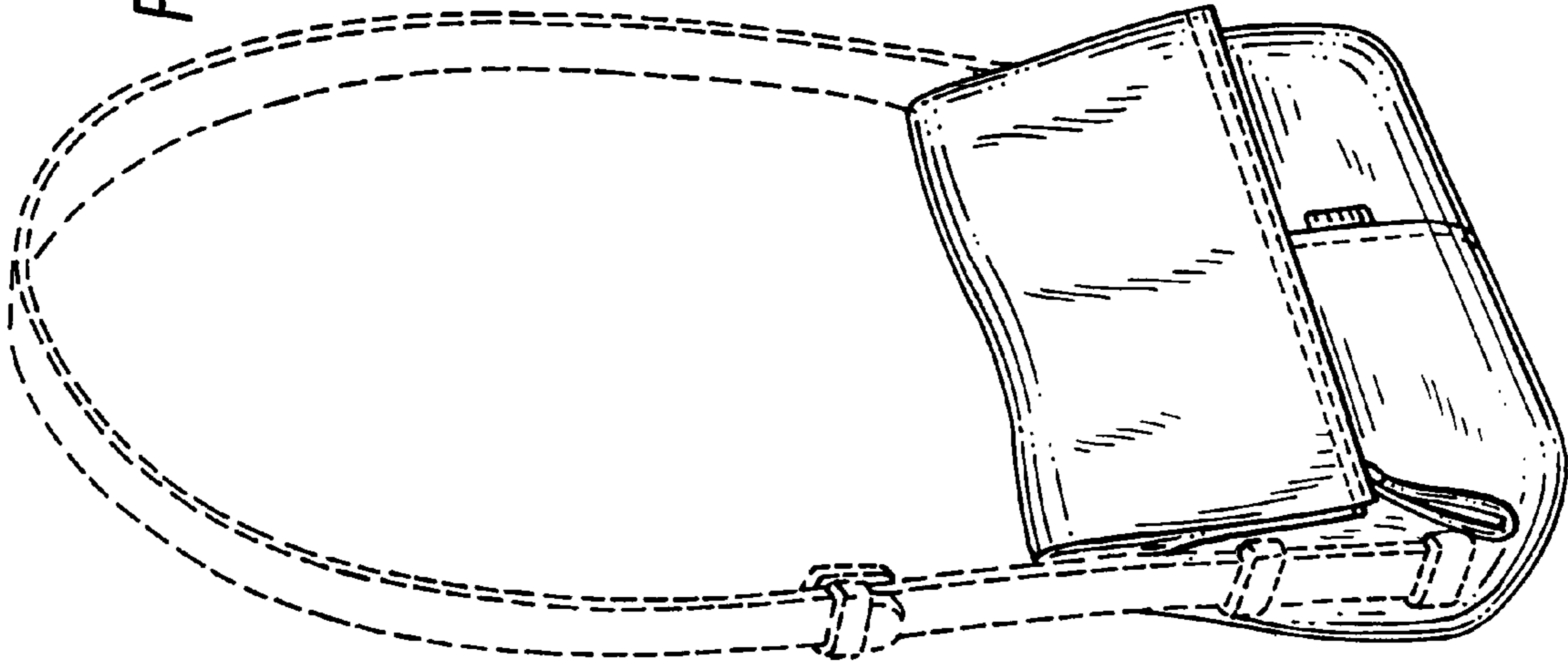
