FIG. 4 is a bottom plan view thereof;

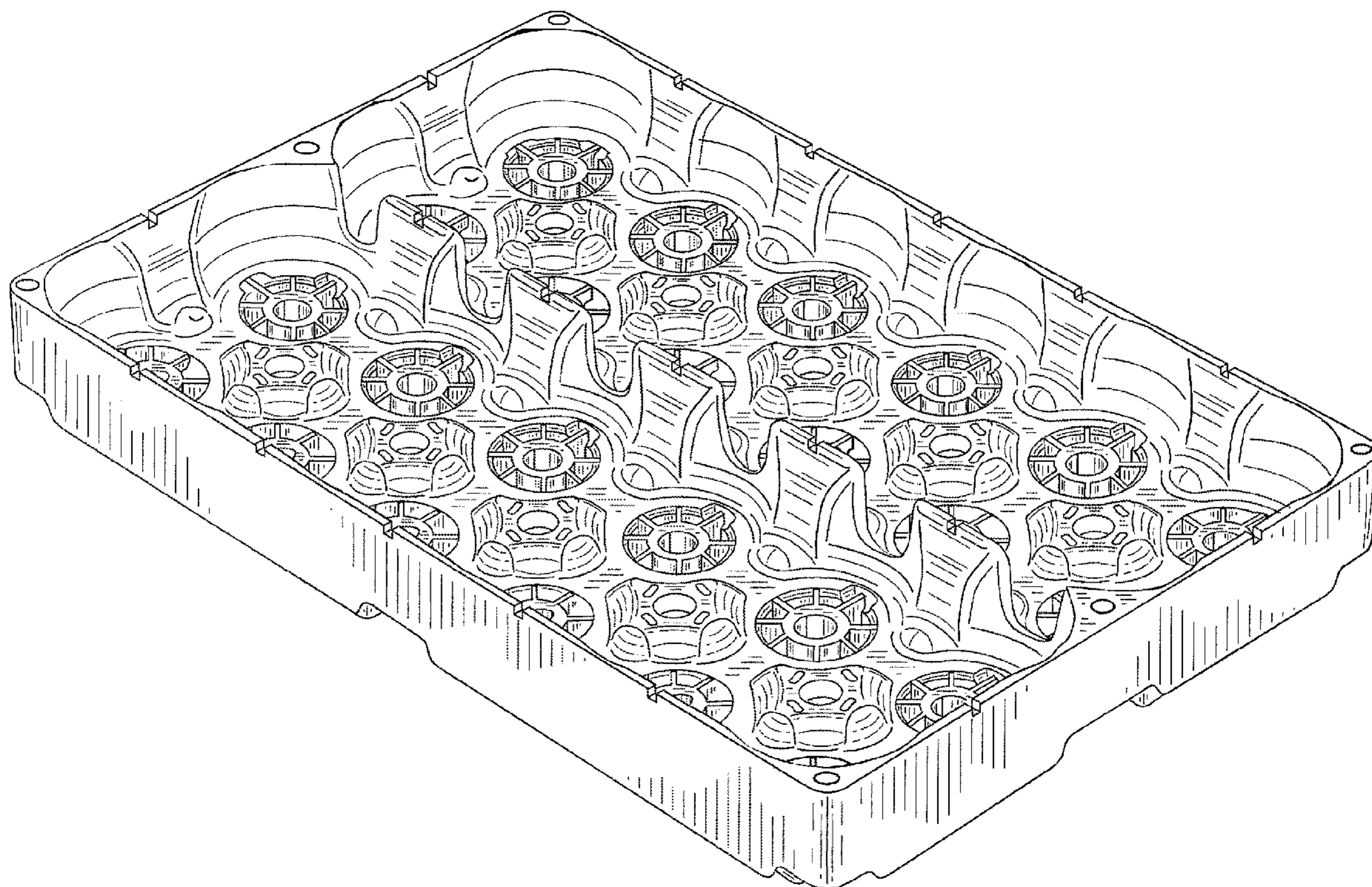
FIG. 5 is a left side view thereof;

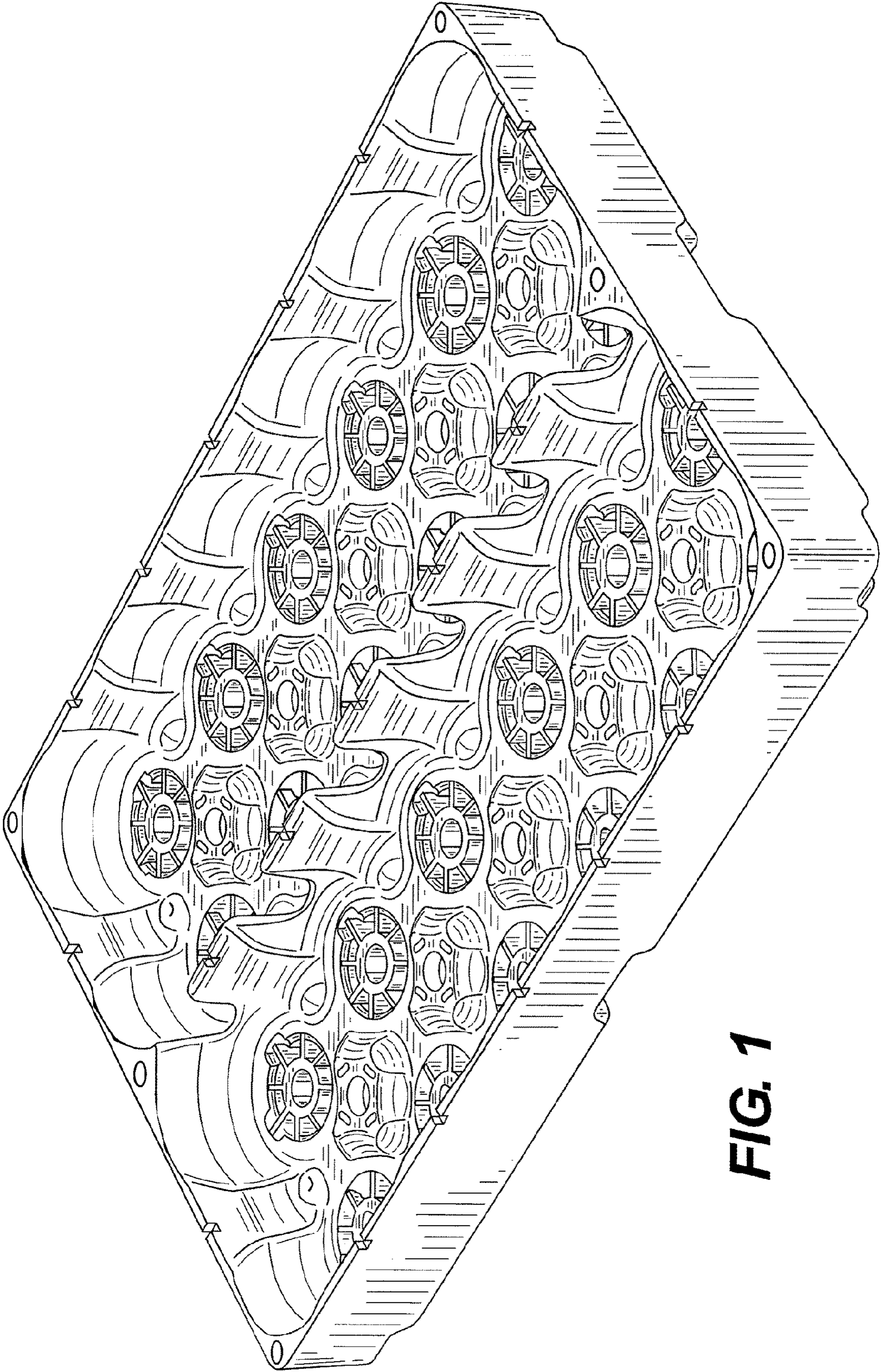
FIG. 6 is a right side view thereof;

FIG. 7 is a front elevational view thereof; and,

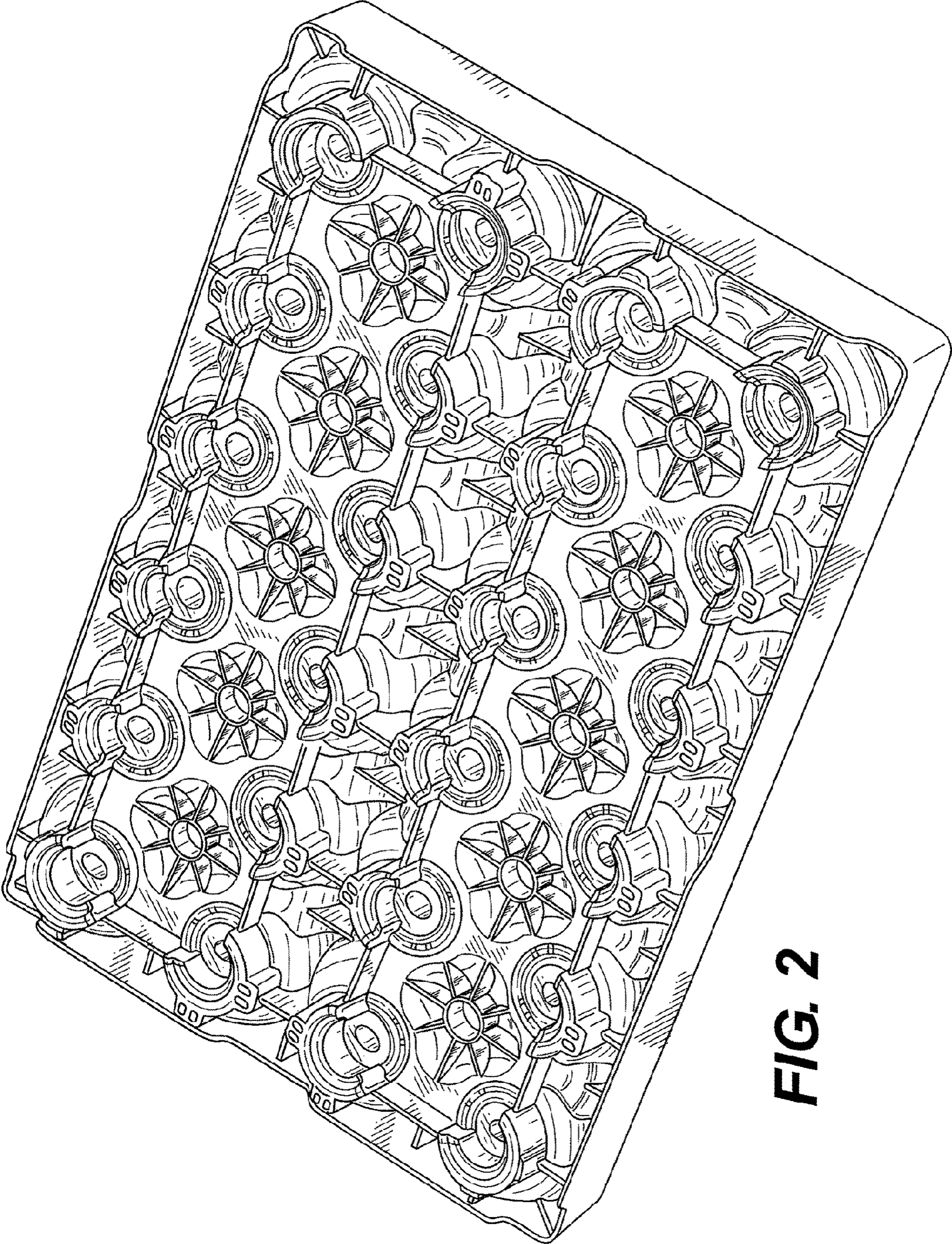
FIG. 8 is a rear elevational view thereof.

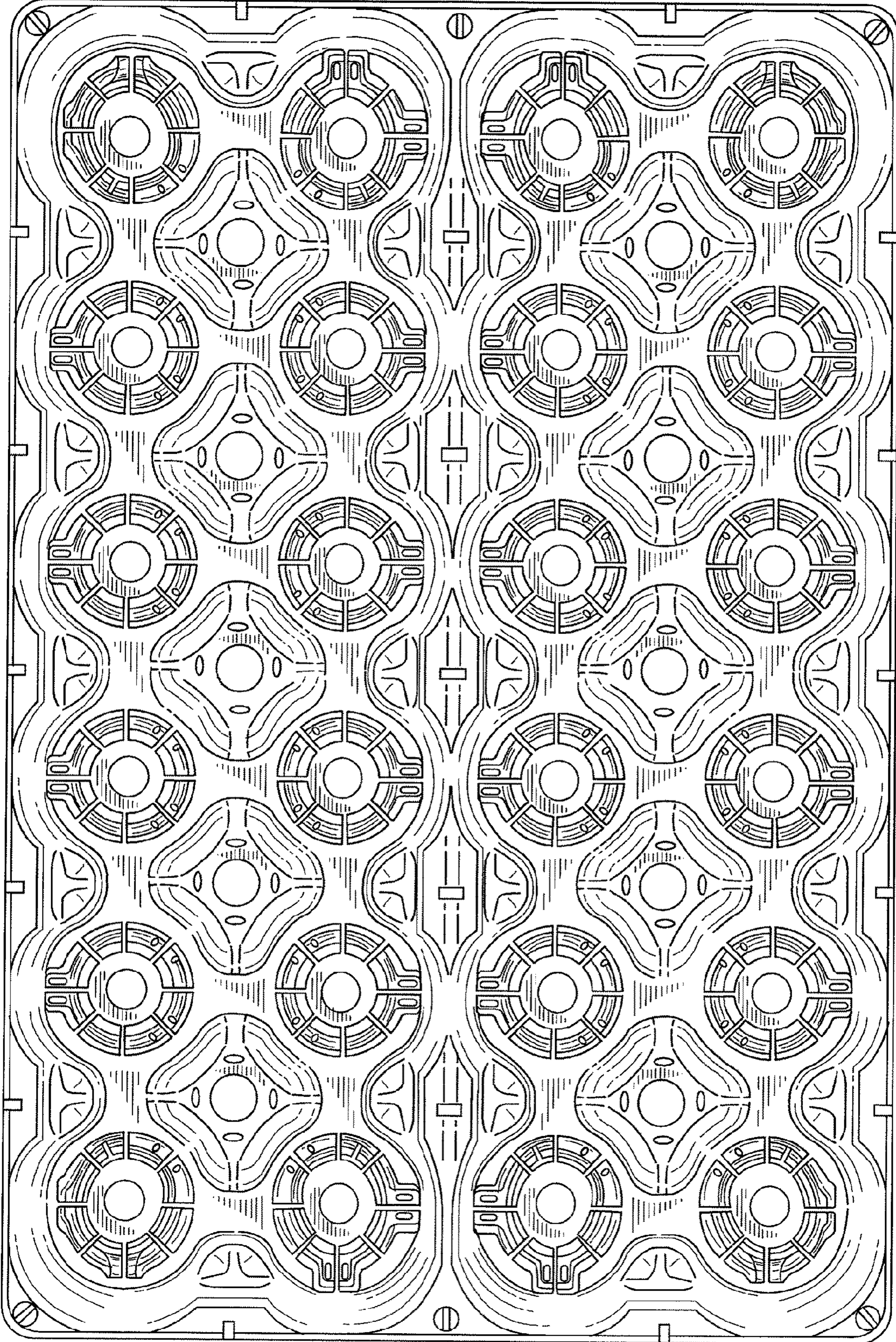




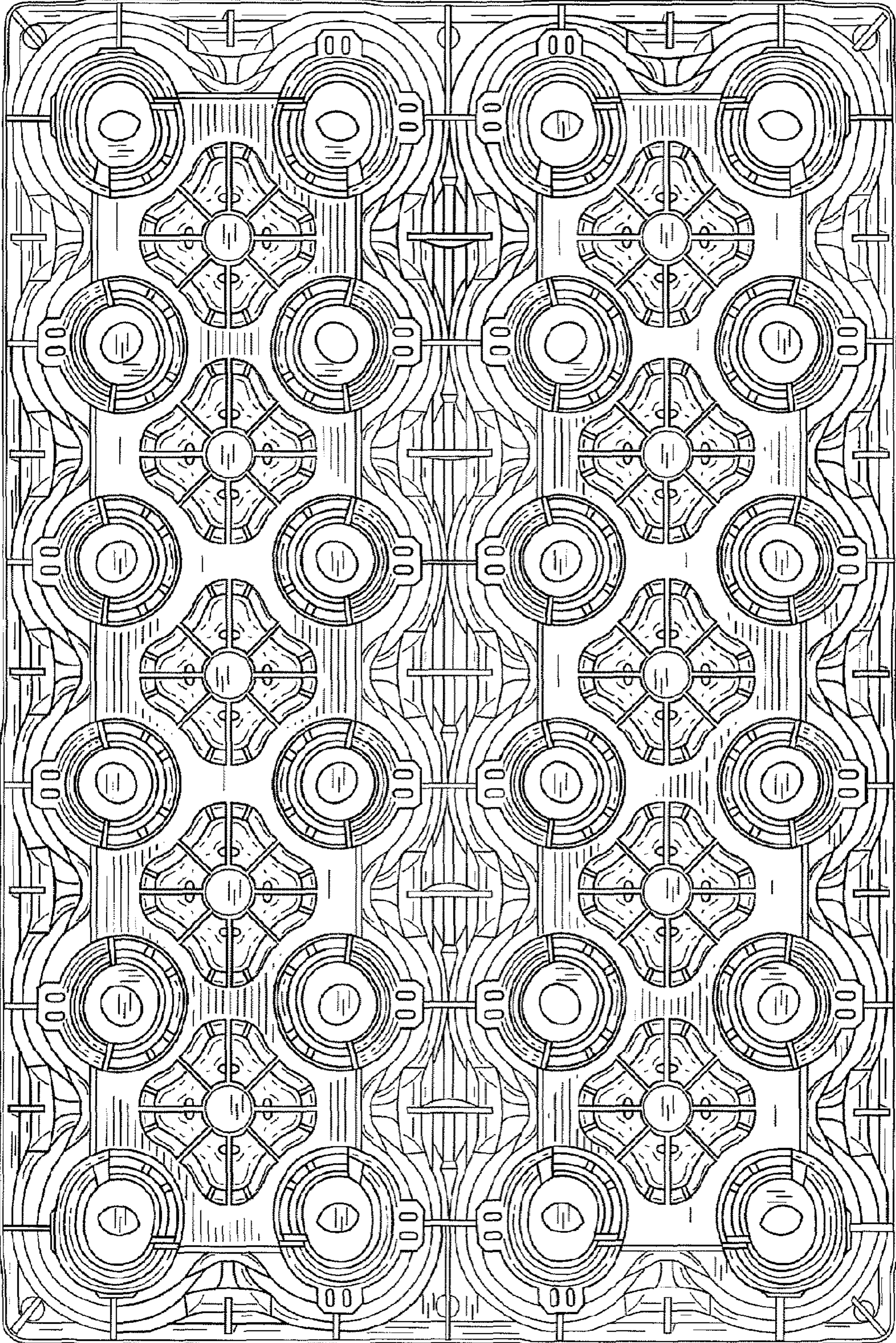

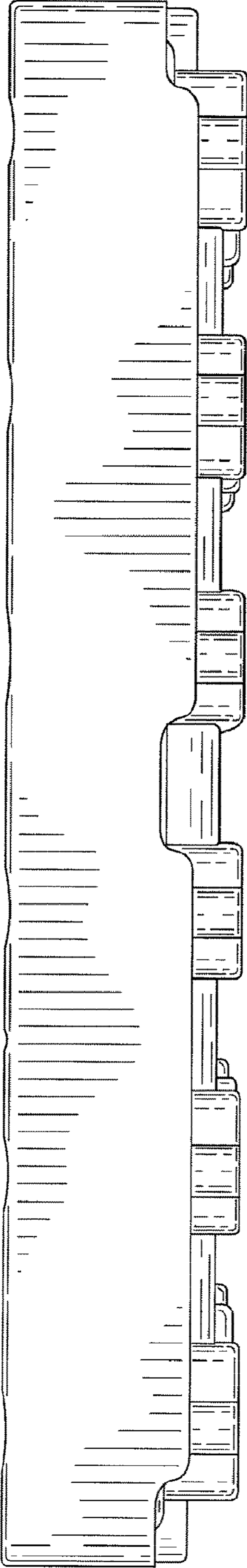

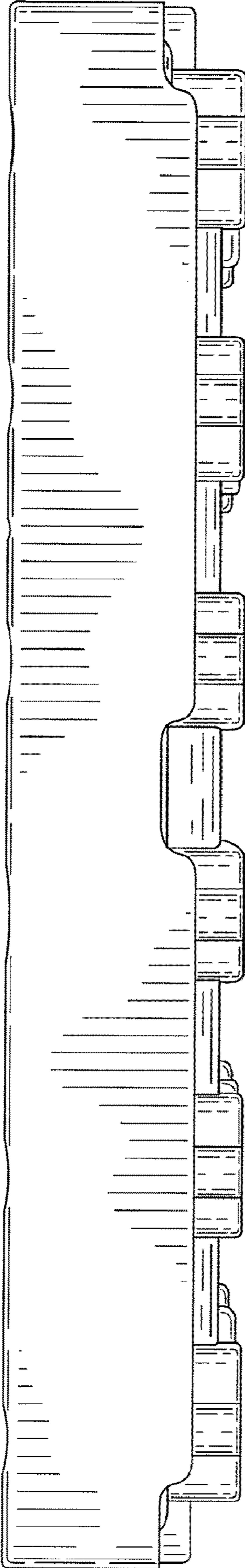

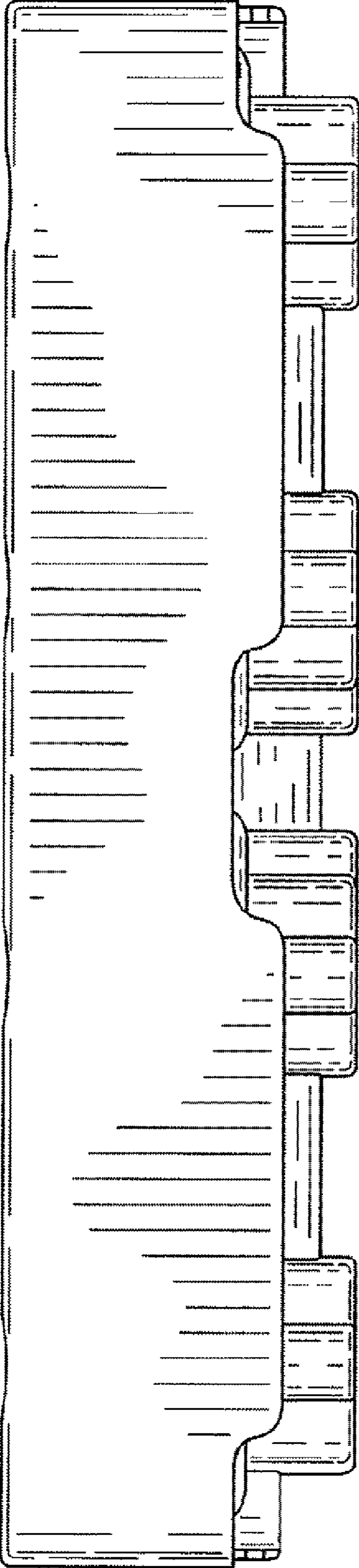

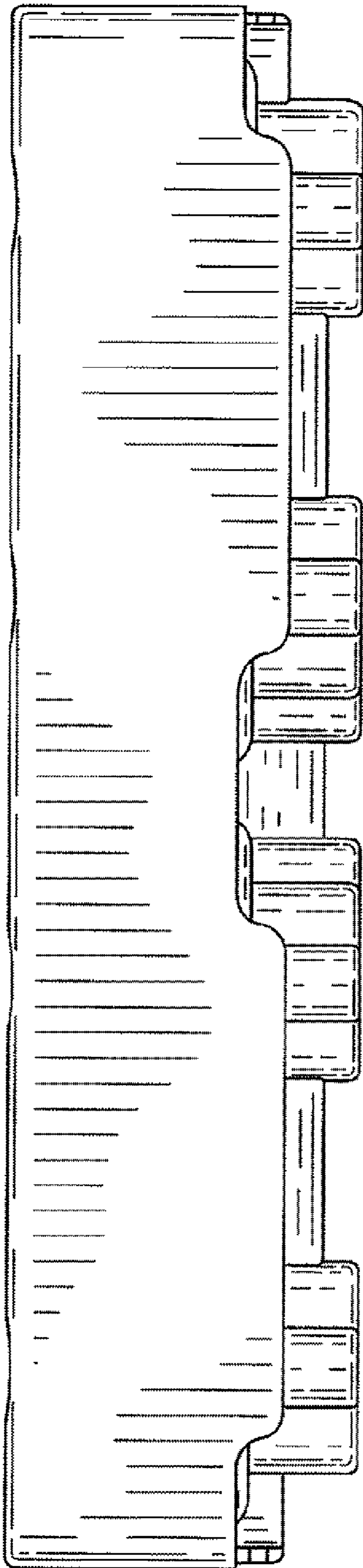
