DESCRIPTION

FIG. 1 is a top plan view of a chair in accordance with the new design;

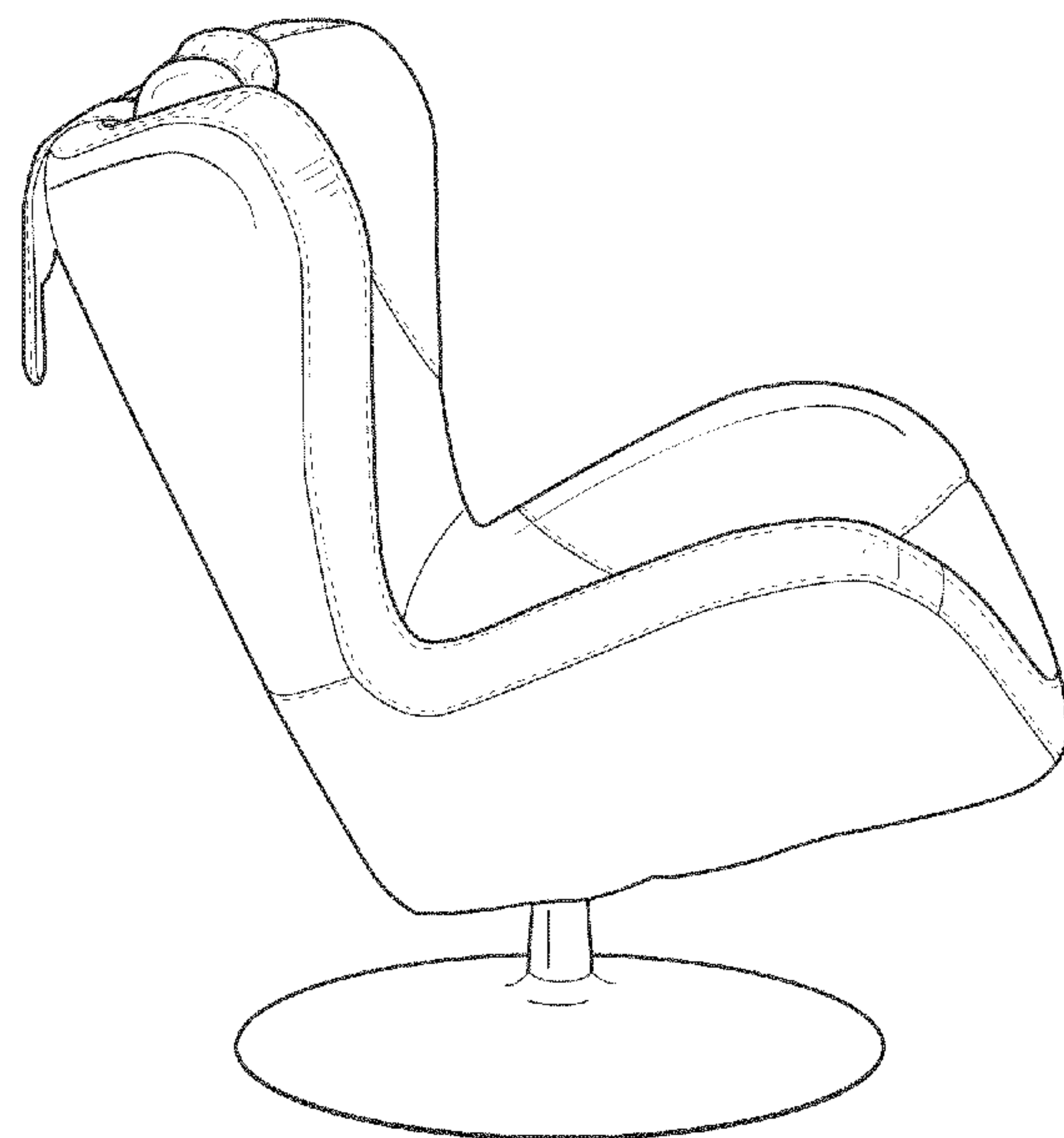
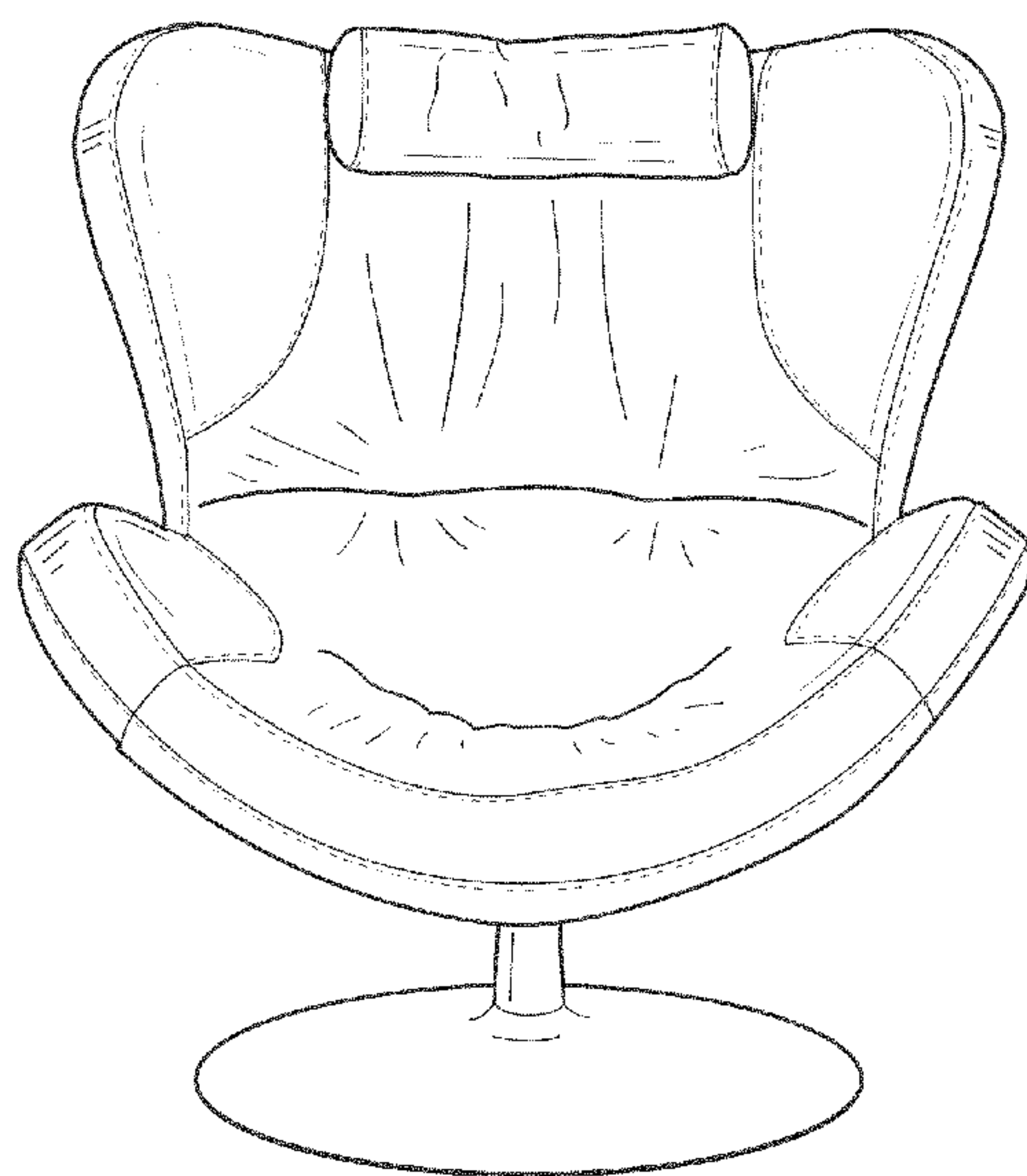
FIG. 2 is a front perspective view thereof;

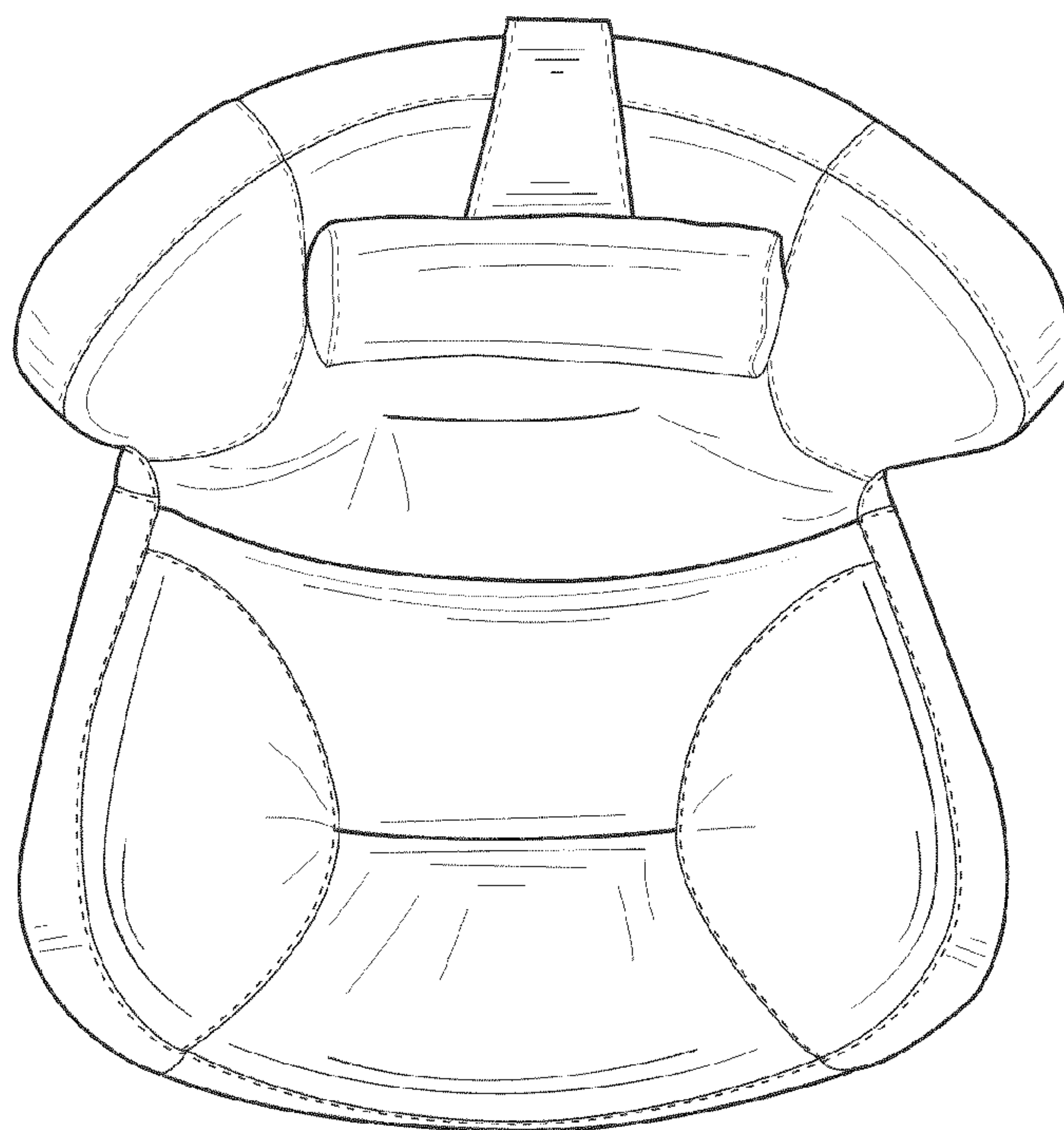

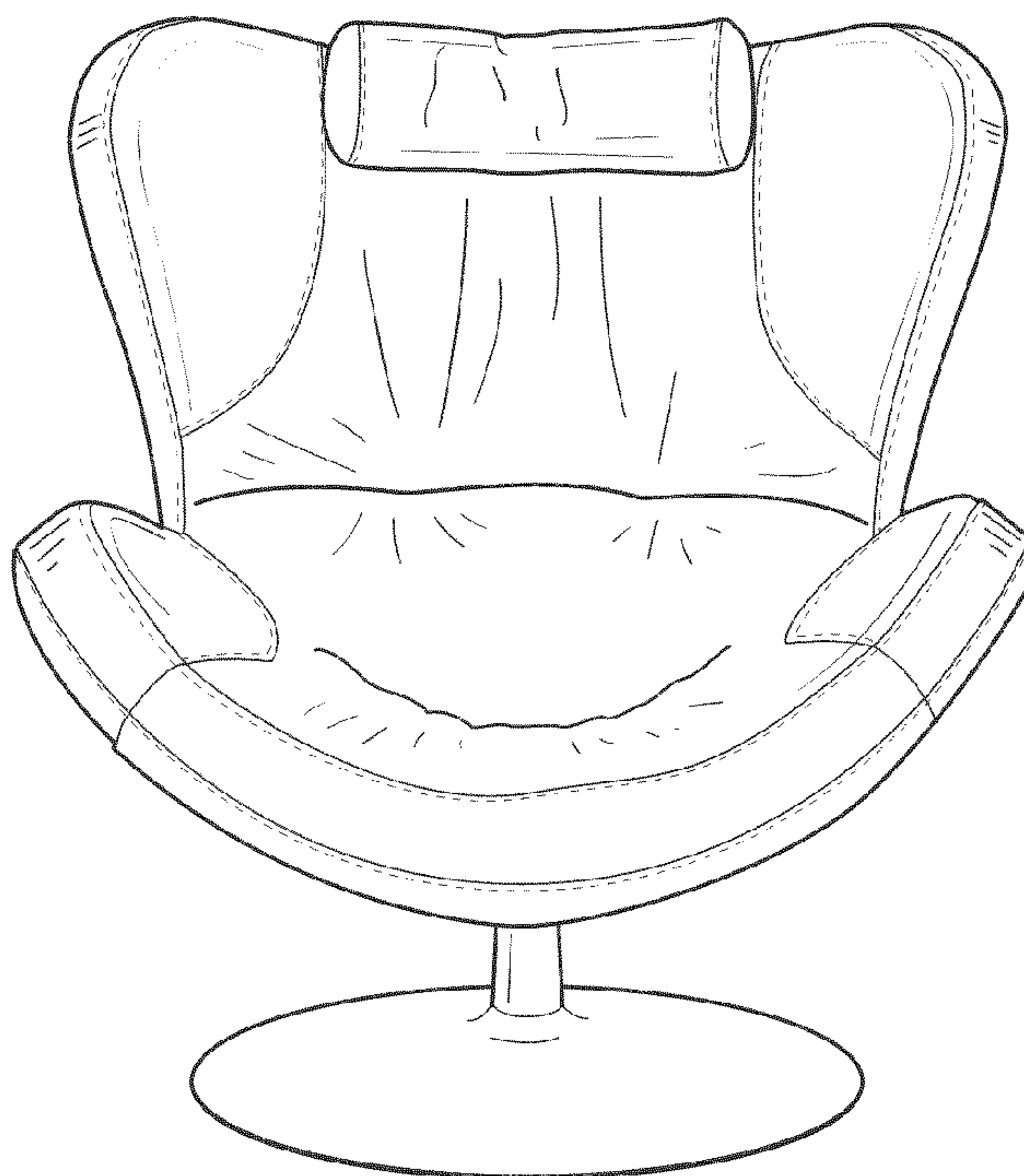

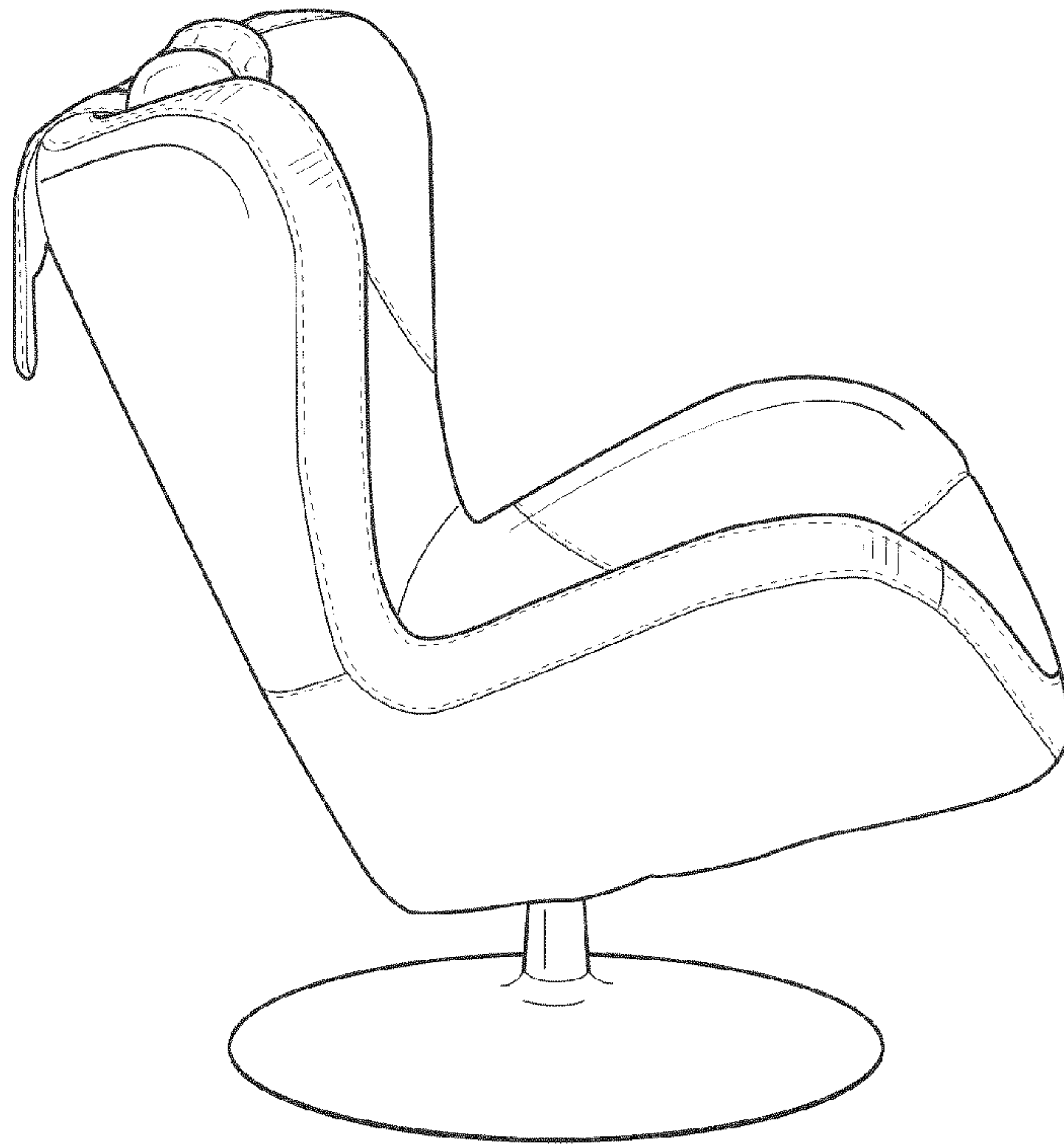

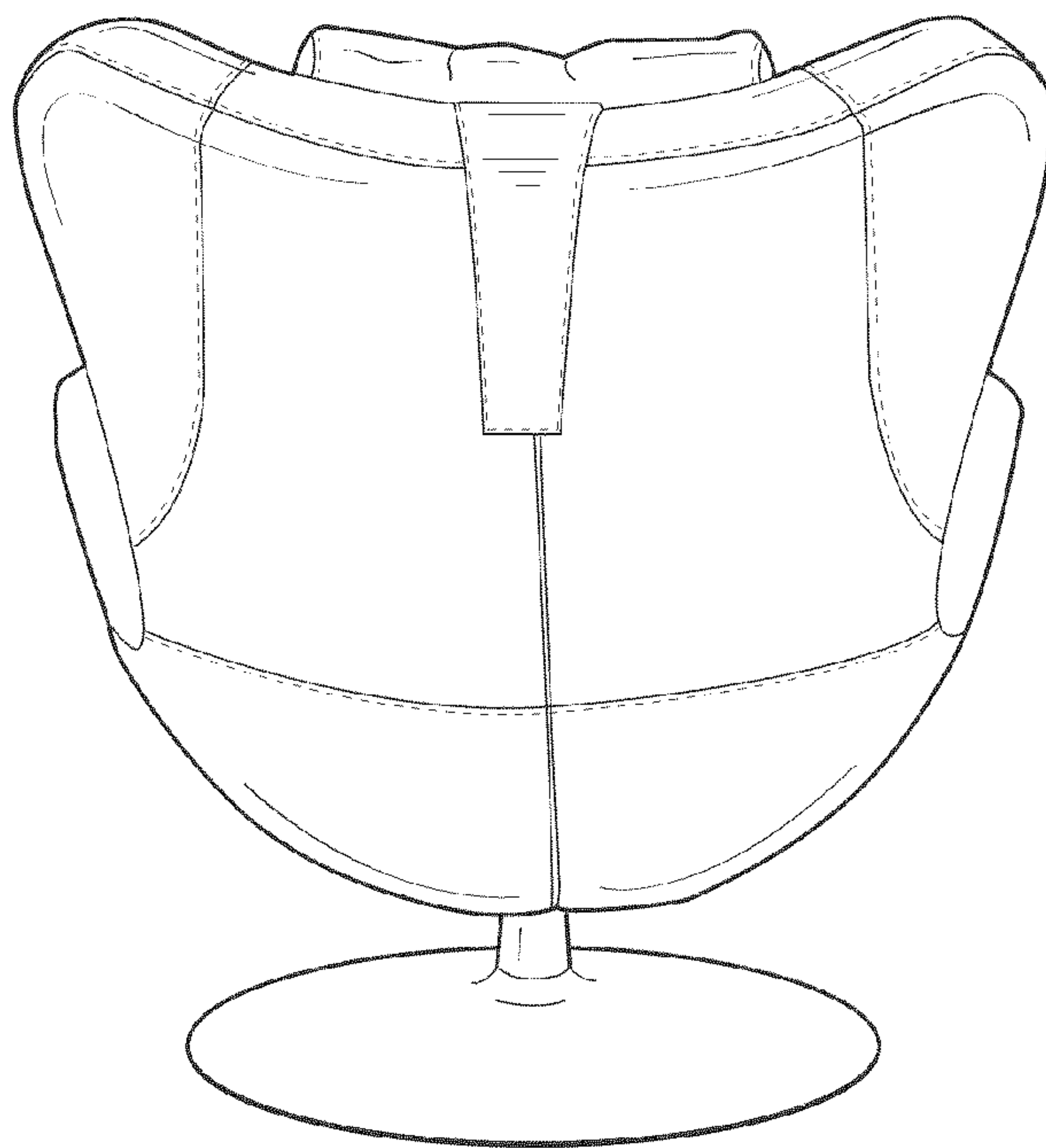
