DESCRIPTION

FIG. 1 is a top front side perspective view of a cabinet handle showing our new design.

FIG. 4 is a side view of the handle shown in FIG. 1.

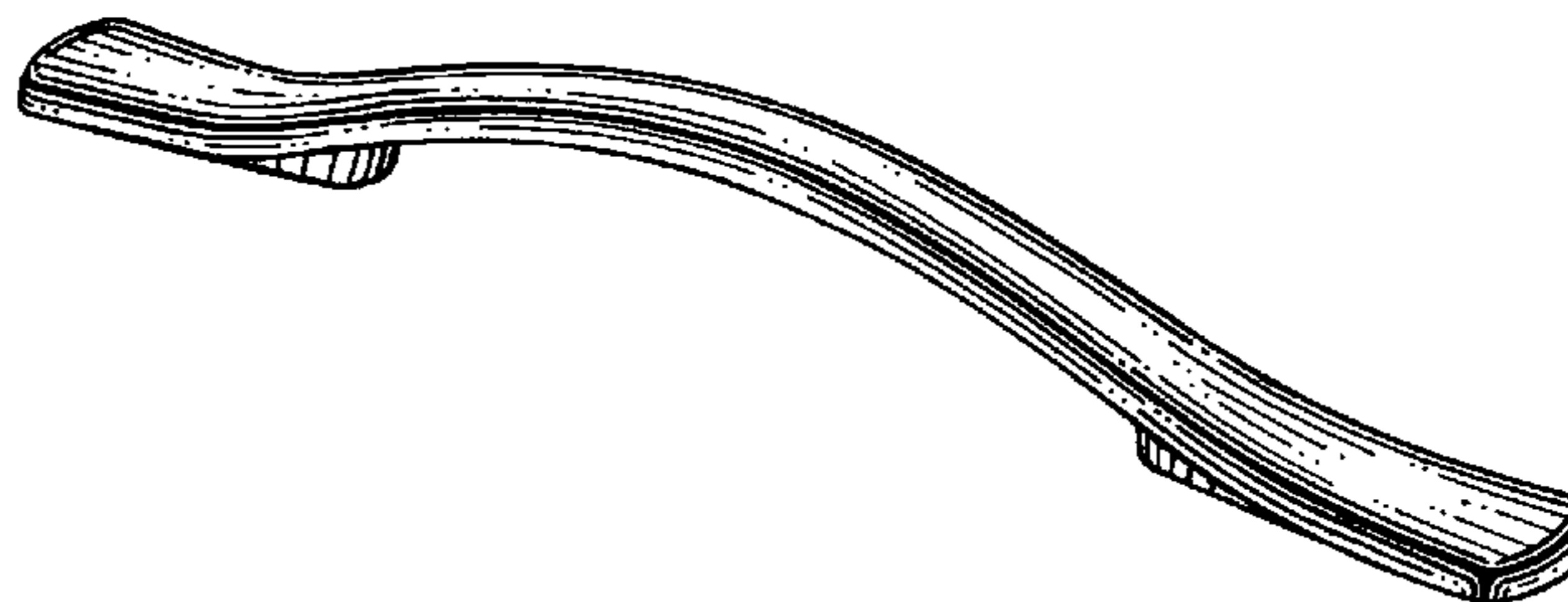
FIG. 5 is a top front side perspective view of a second embodiment of a cabinet handle showing our new design.

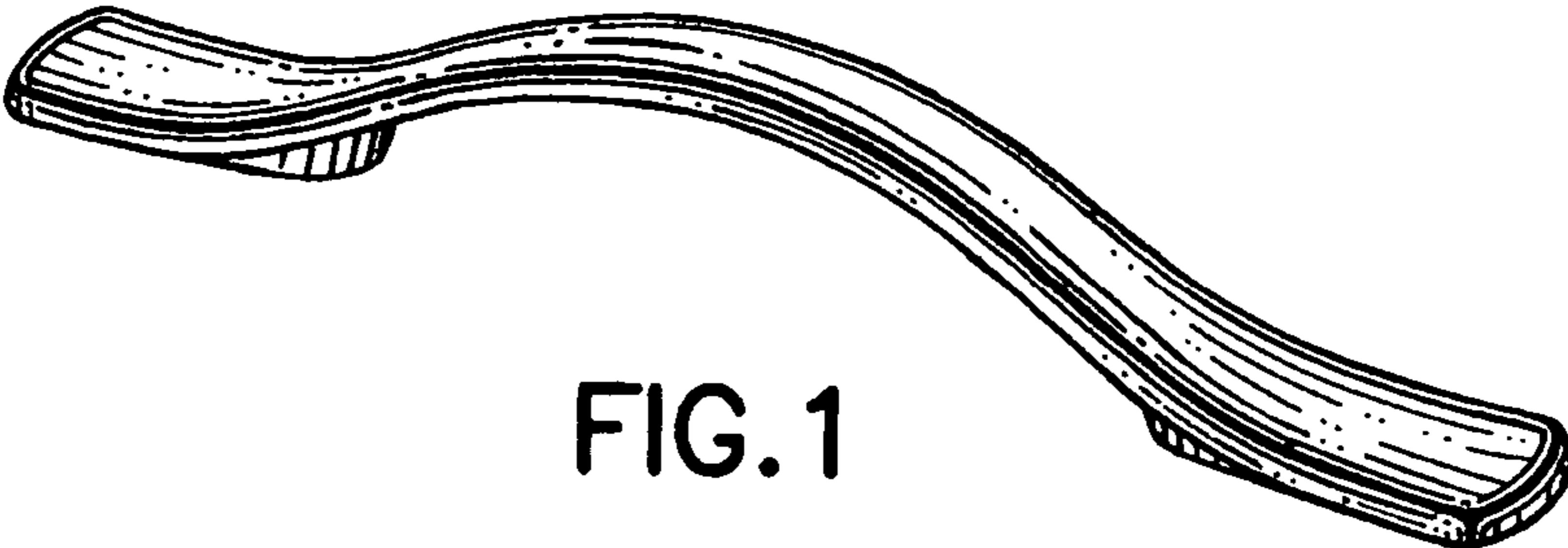

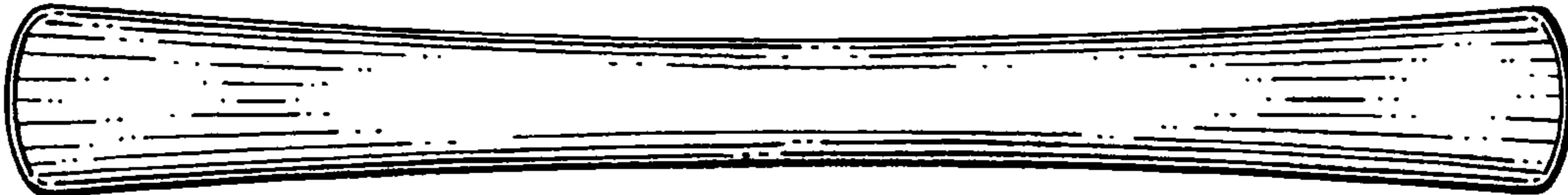

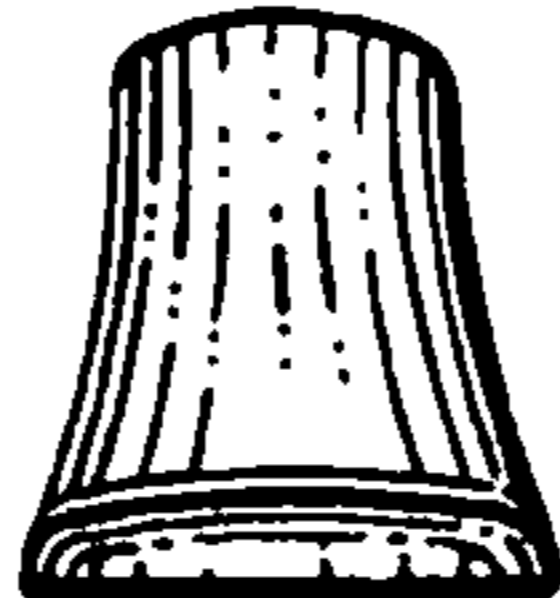

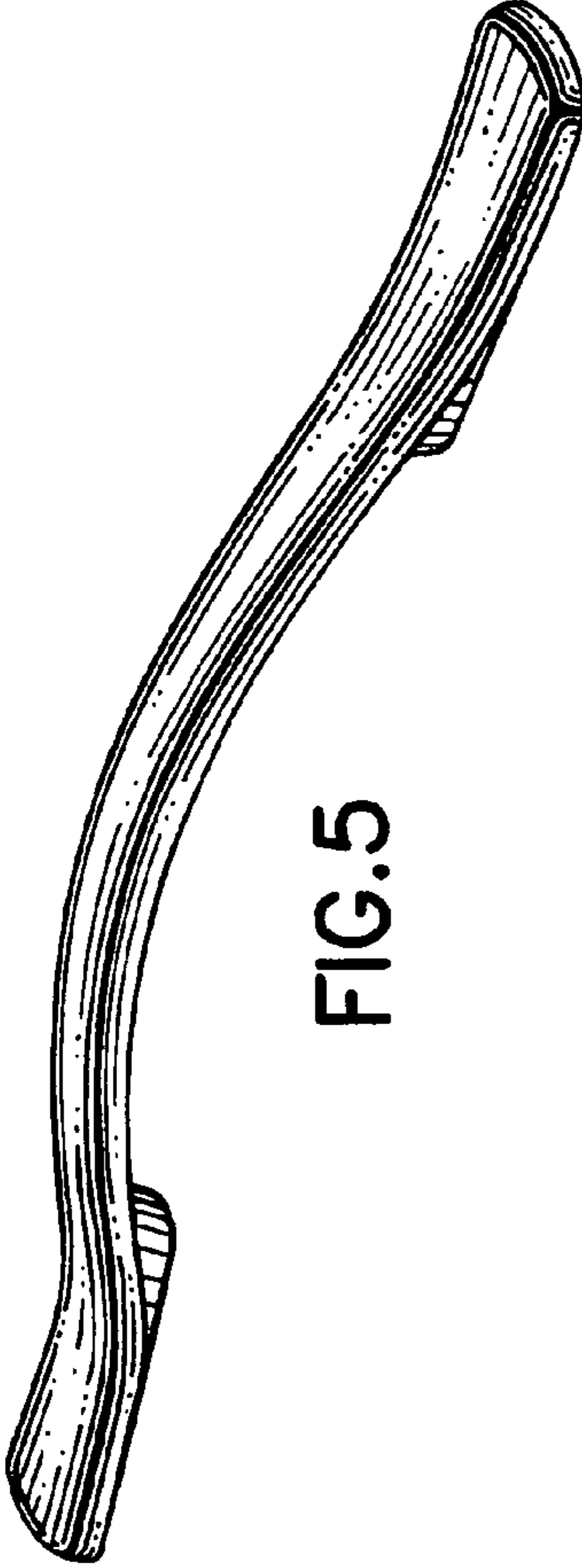

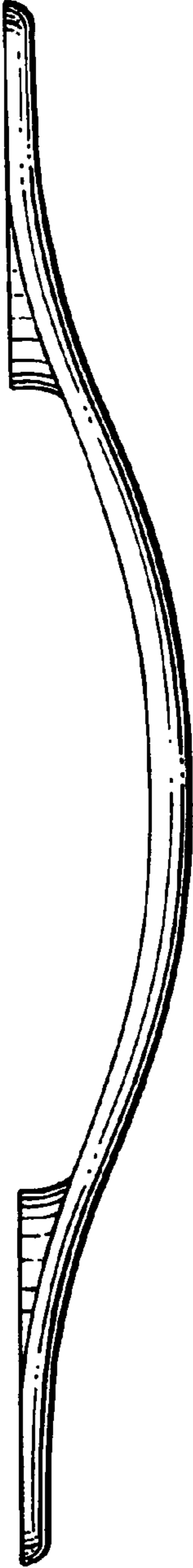

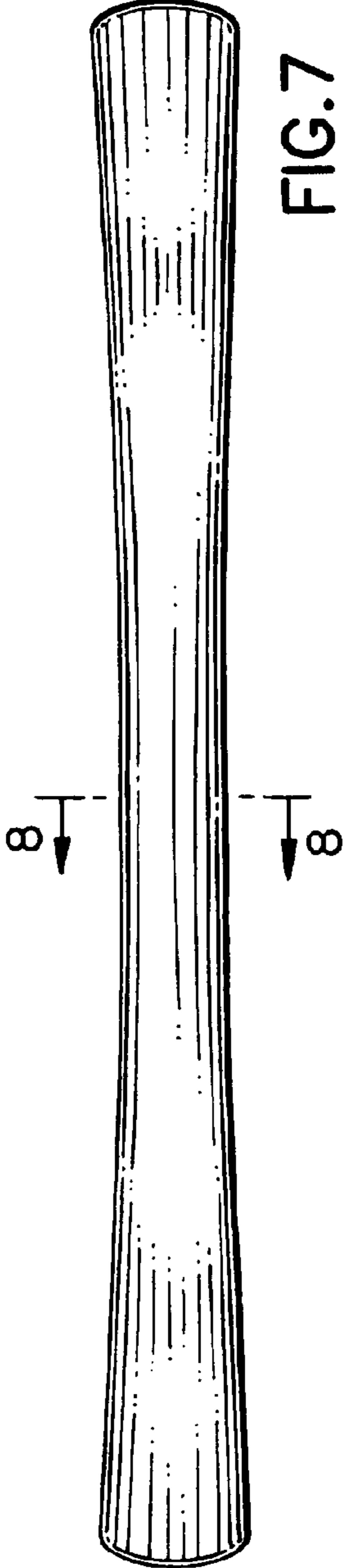

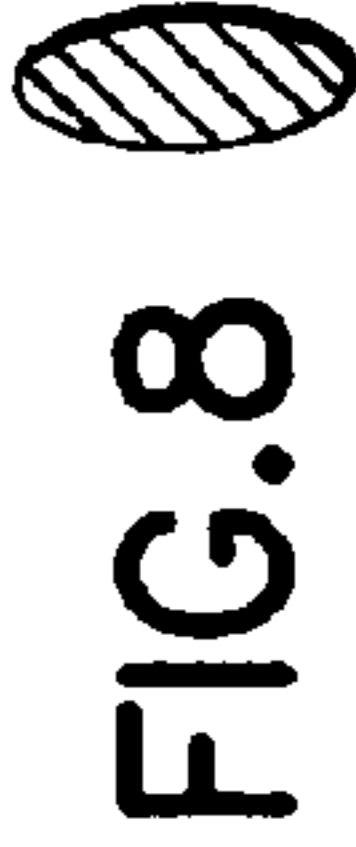
