**DESCRIPTION**

FIG. 1 is a front view of the automobile tire;

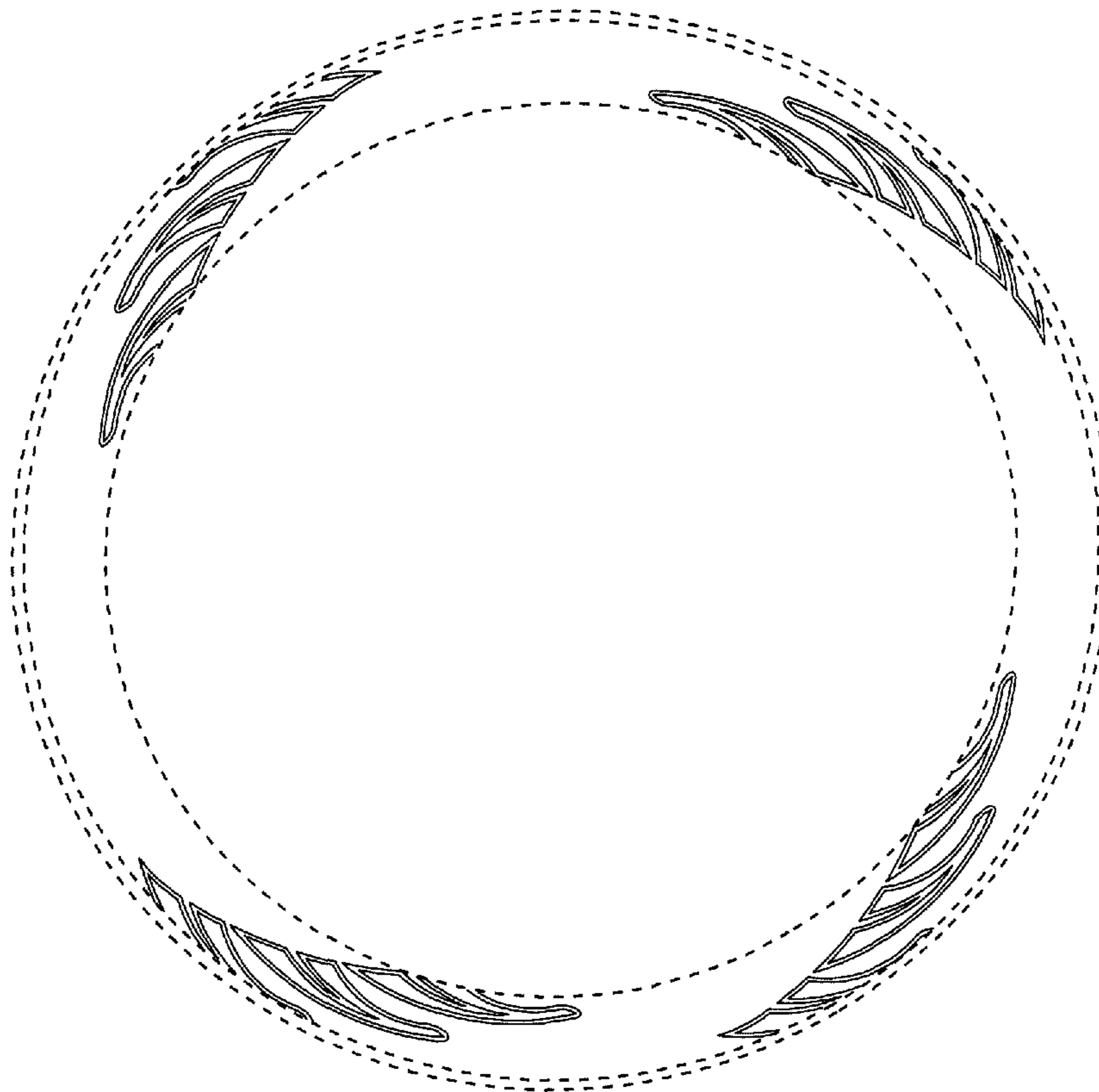
FIG. 2 is a rear view of the automobile tire;

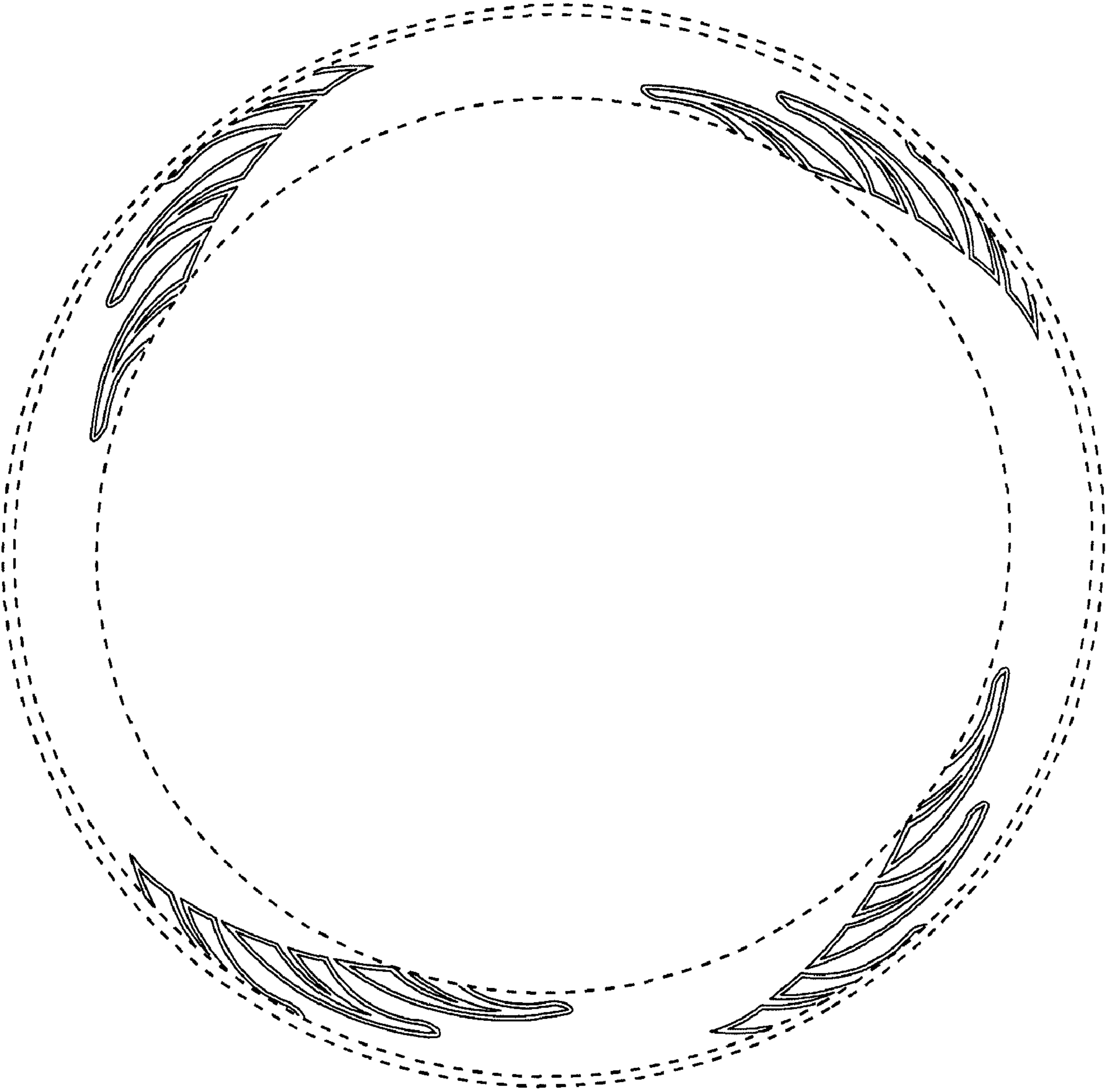

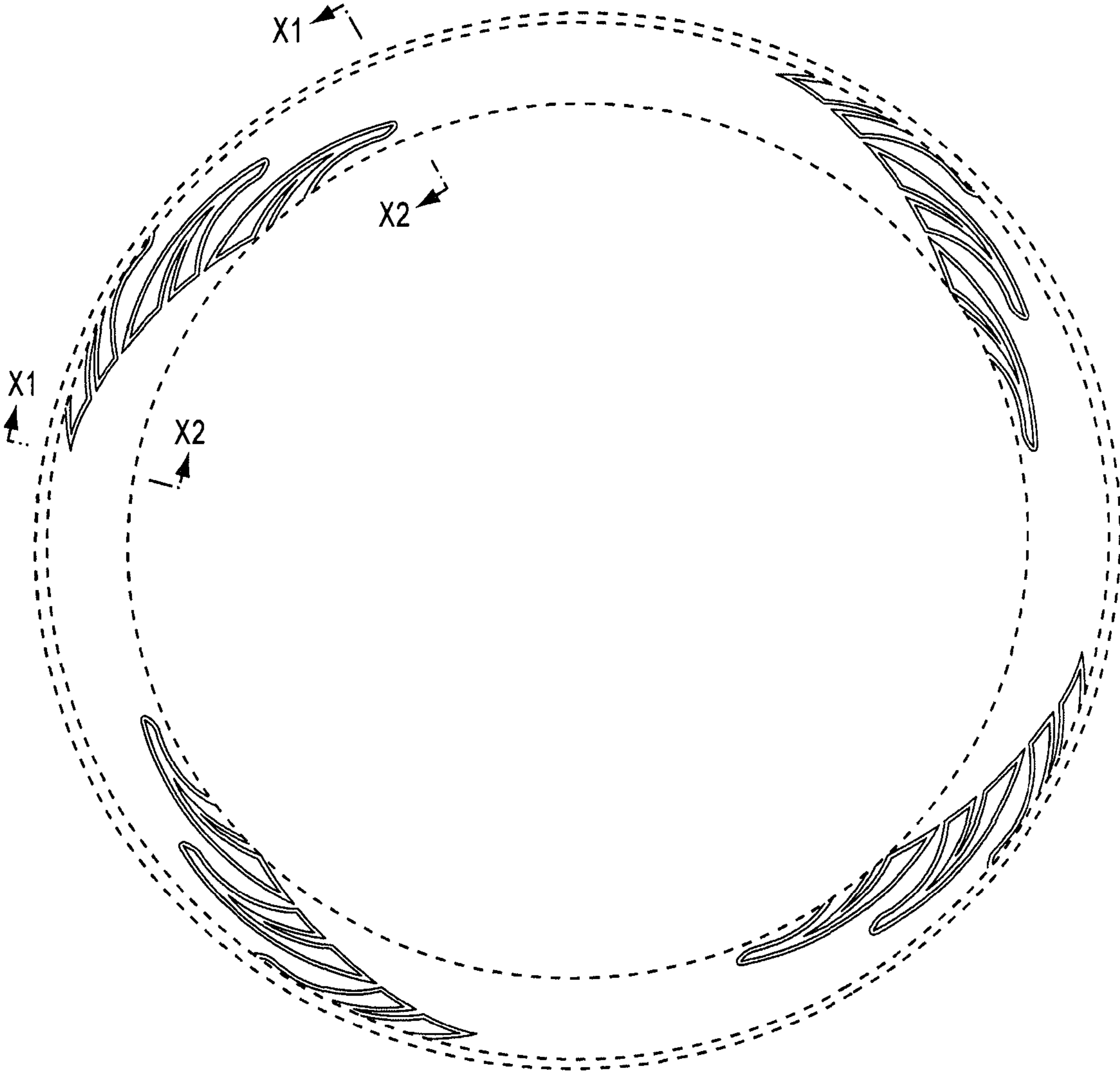

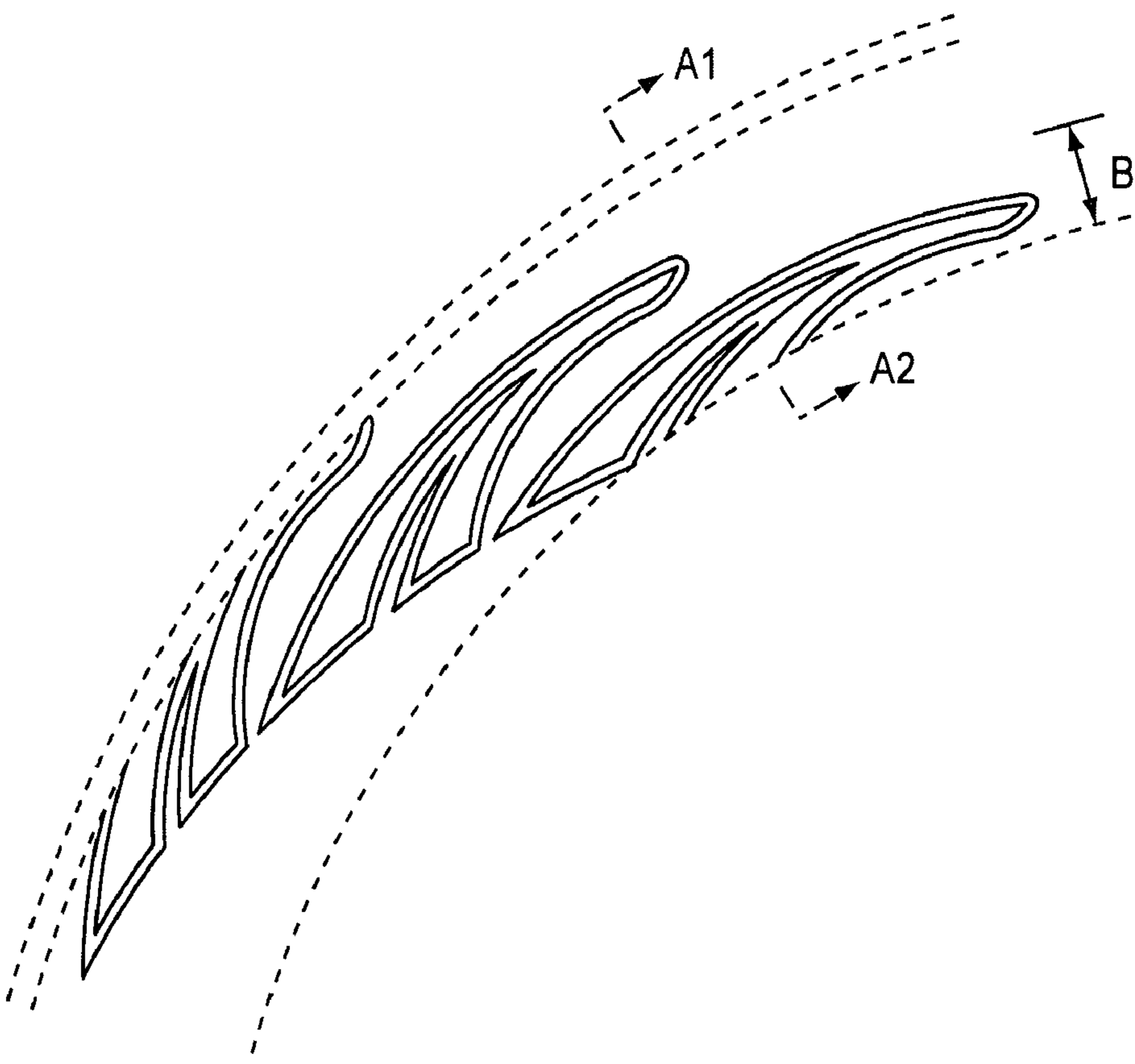

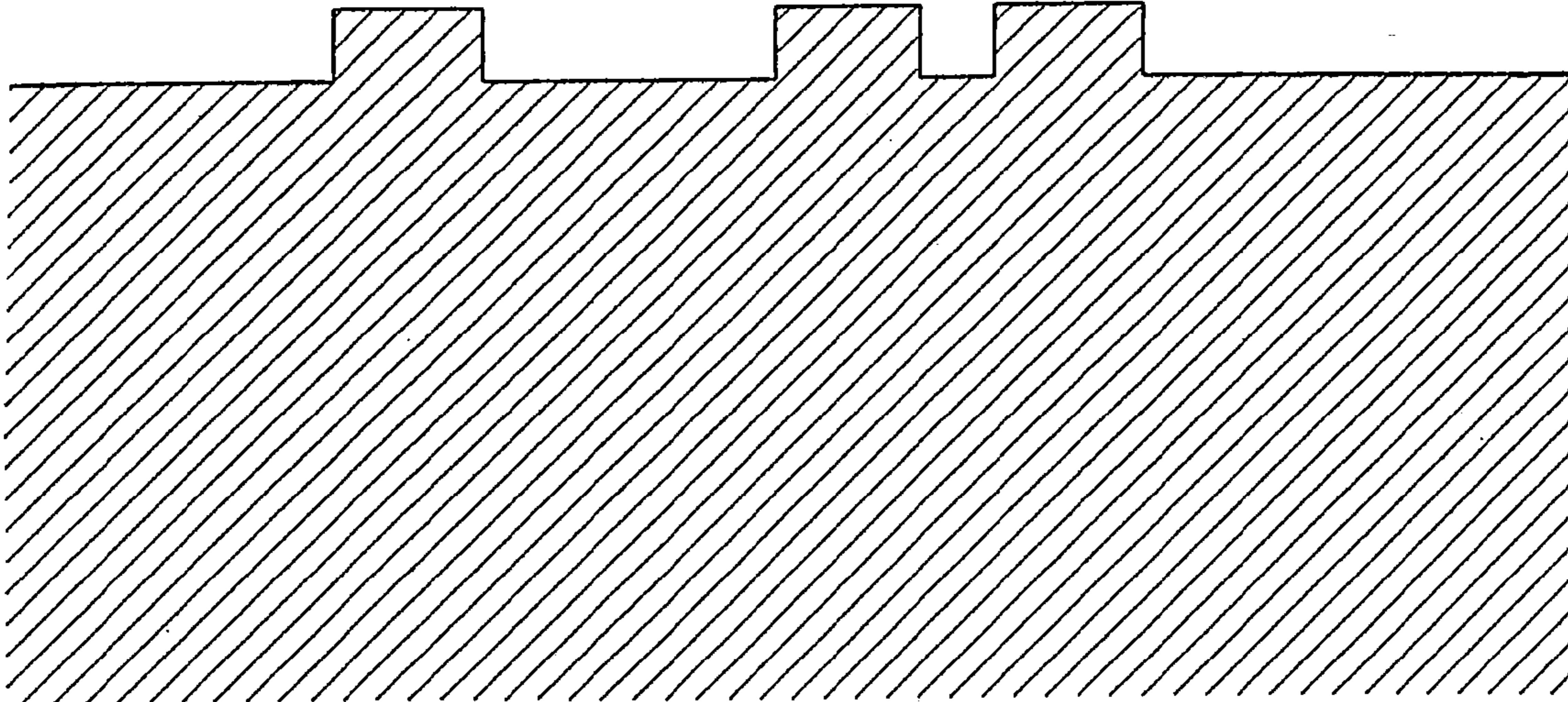
