I claim, the ornamental design for an ornamental magnet, as shown and described.

**DESCRIPTION**

FIG. 3 is a bottom plan view of the ornamental magnet;

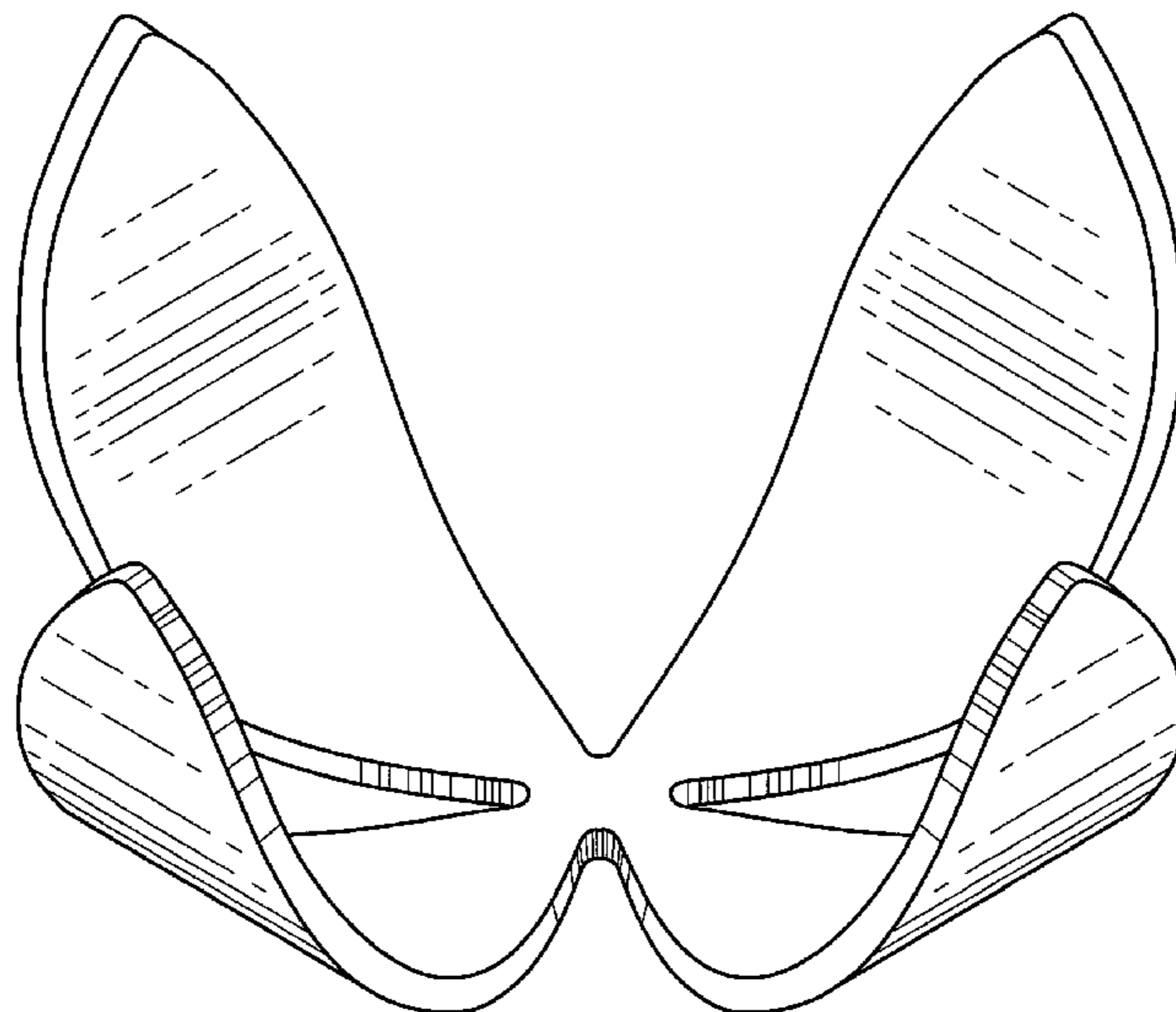
FIG. 4 is a front elevational view of the ornamental magnet;

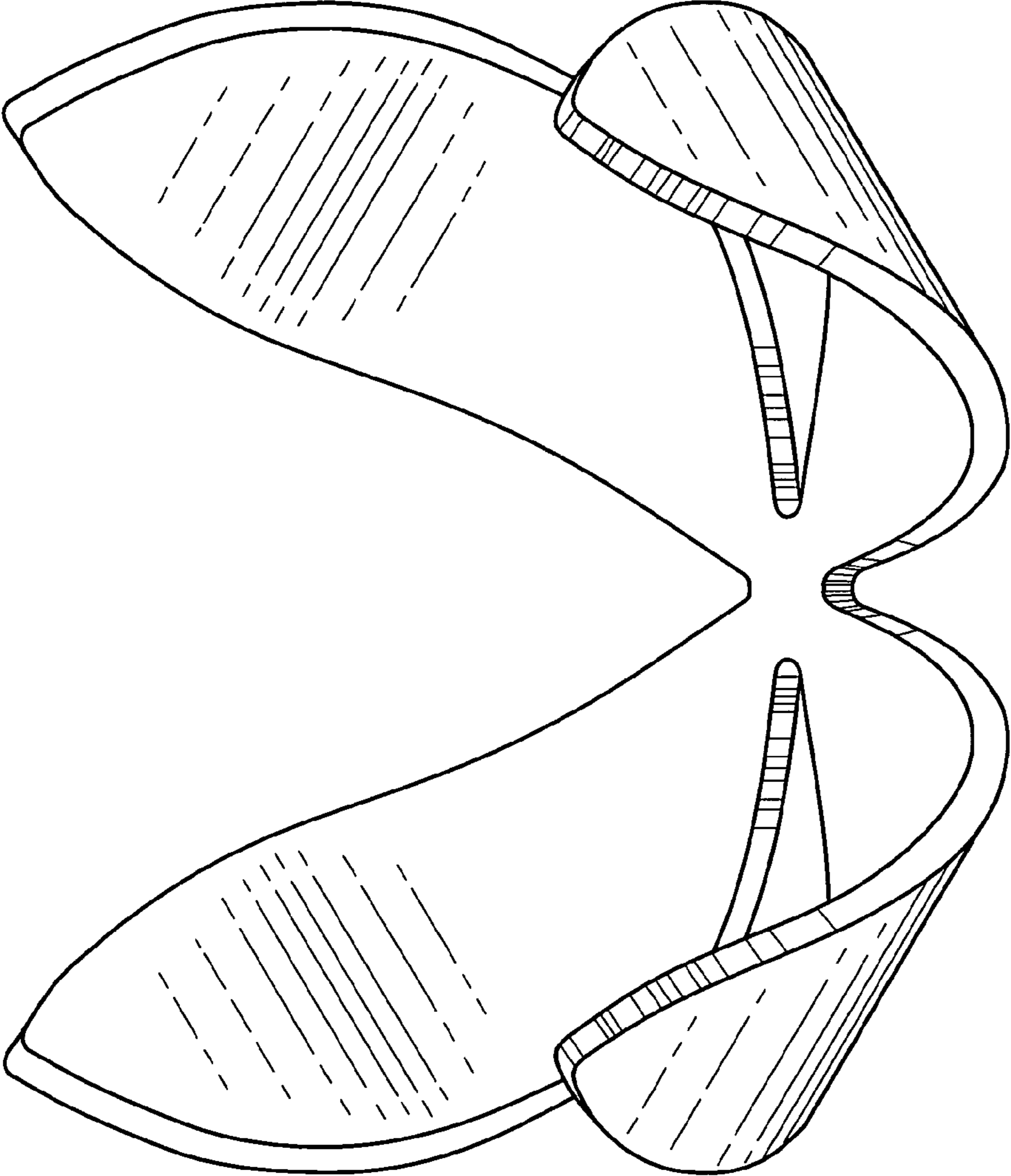

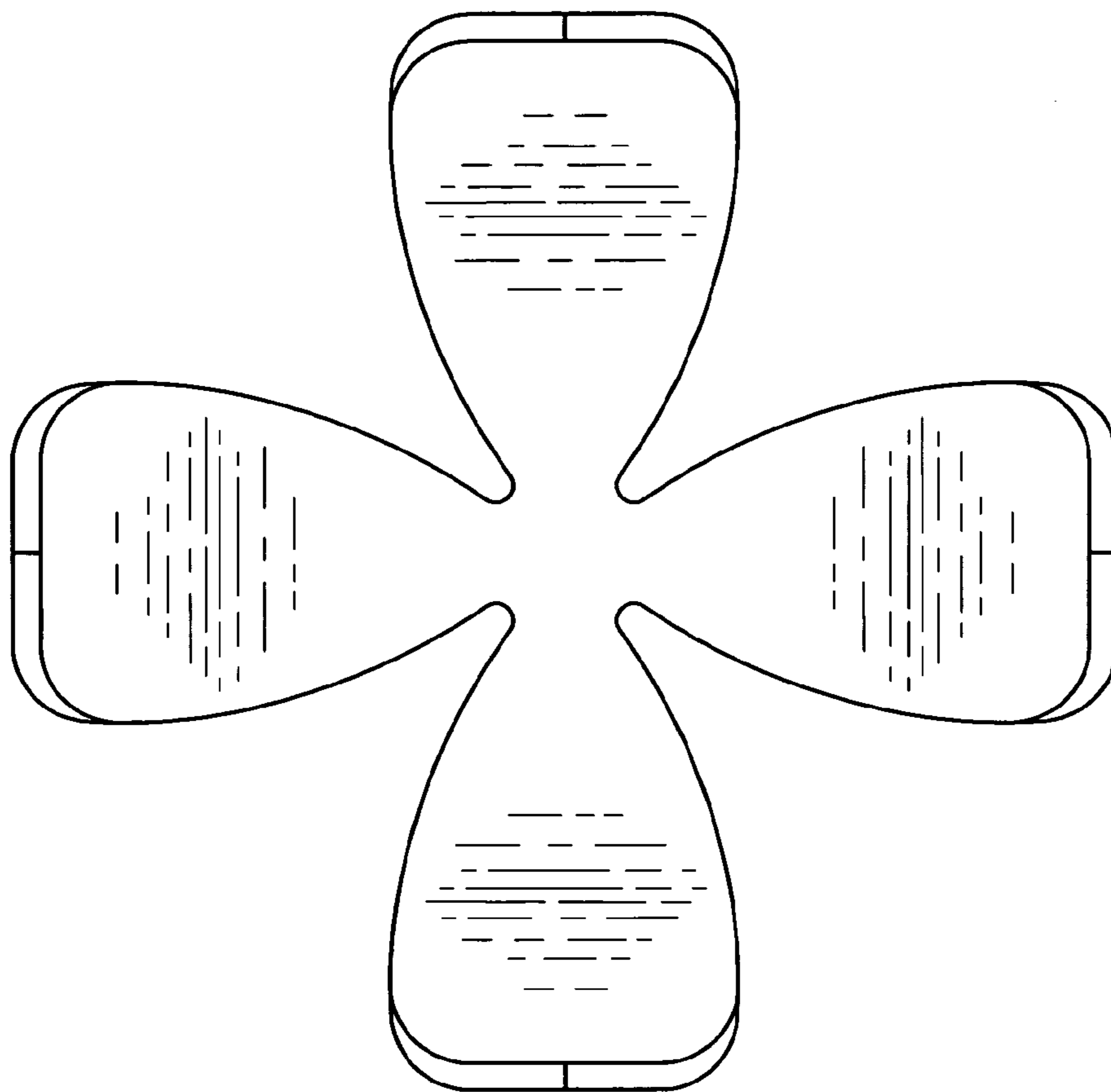

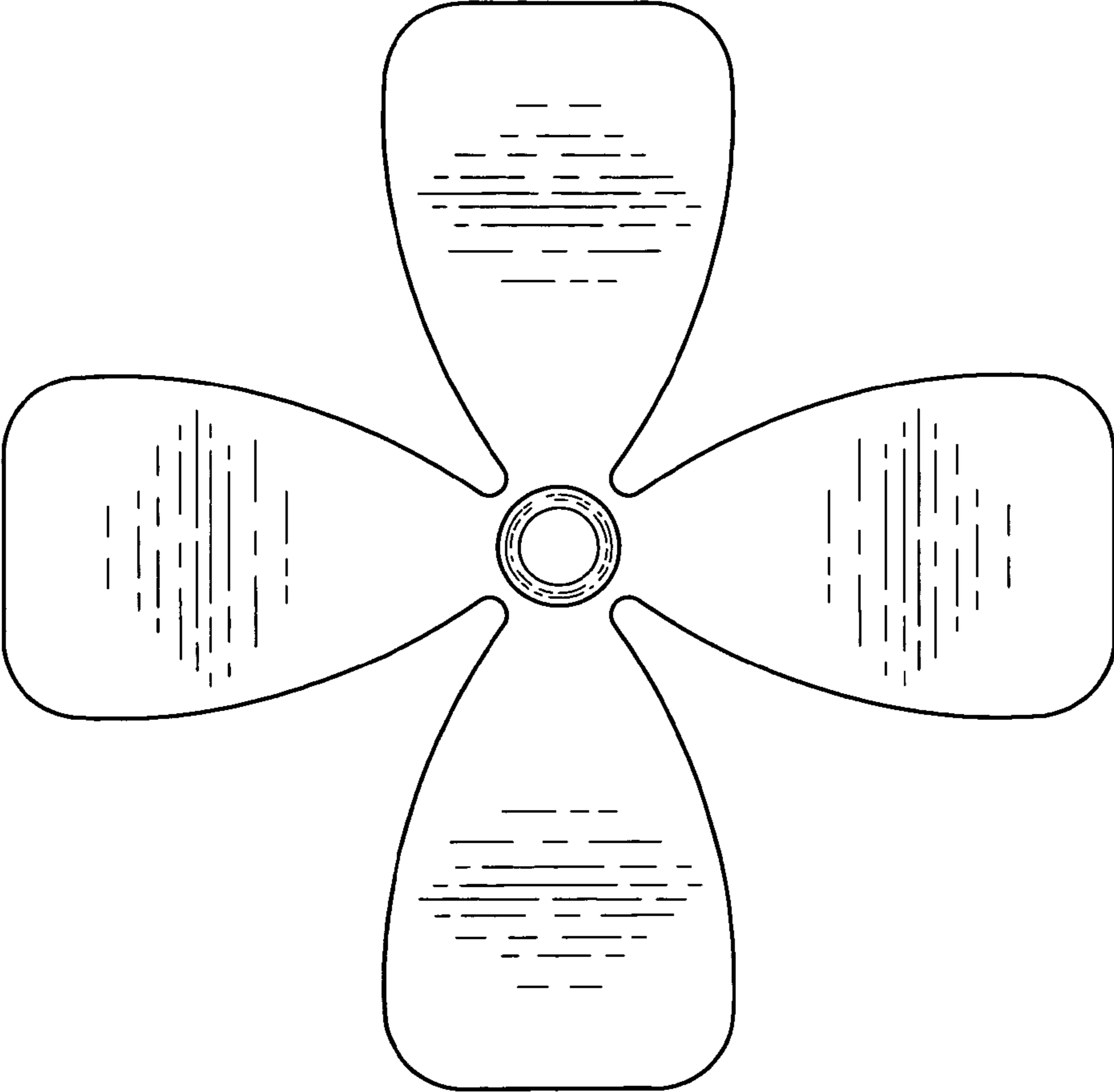

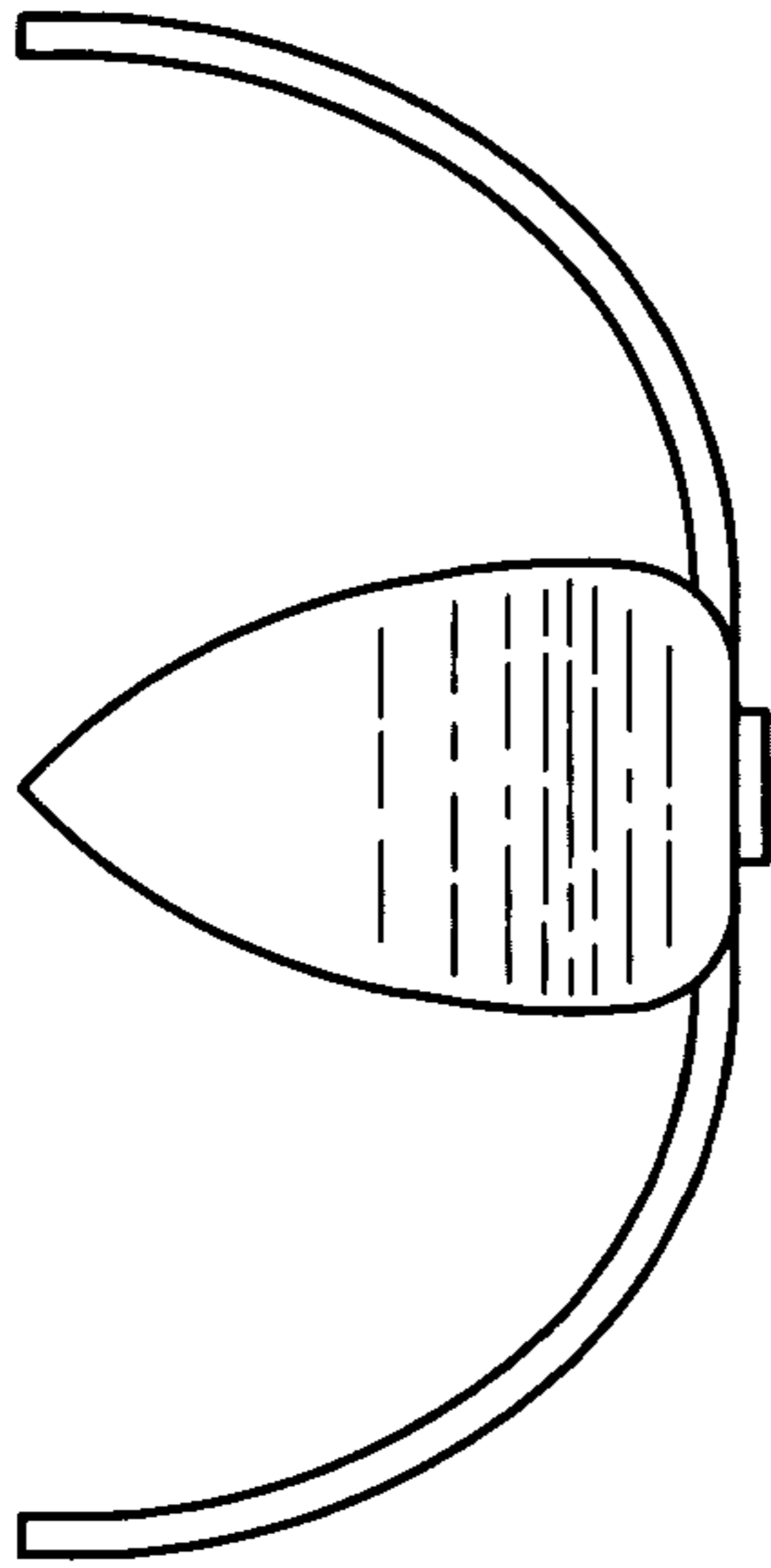

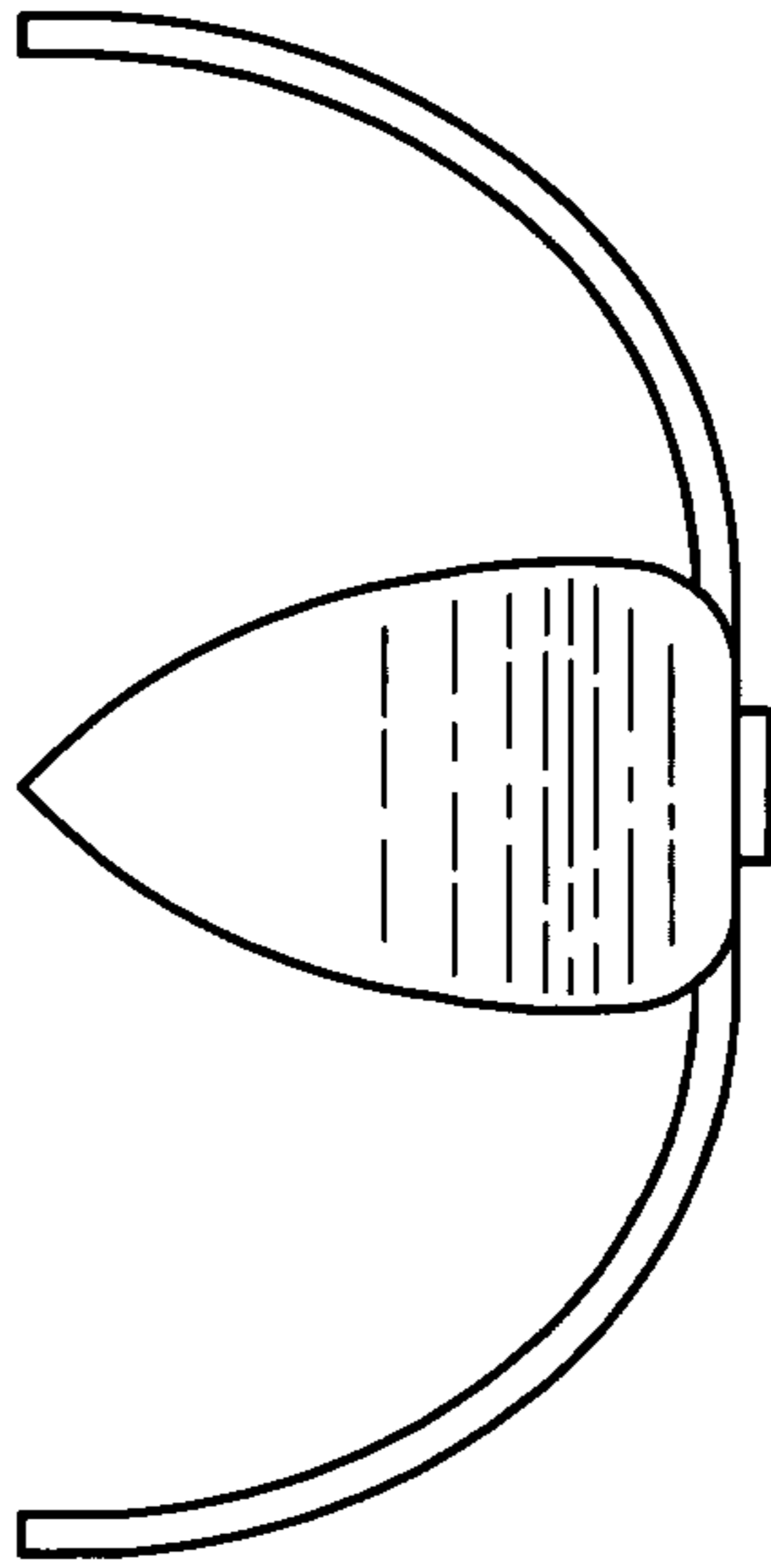

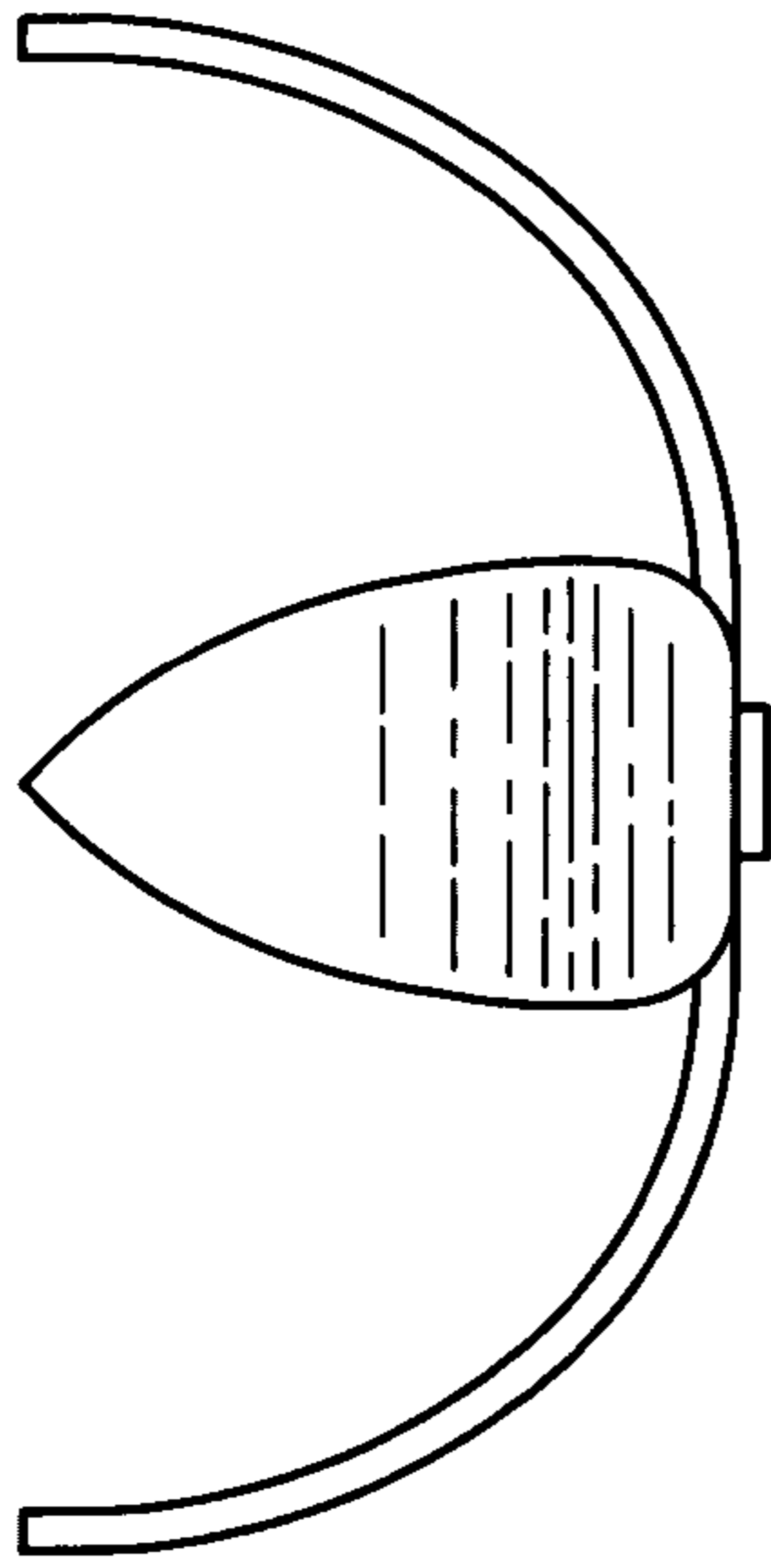

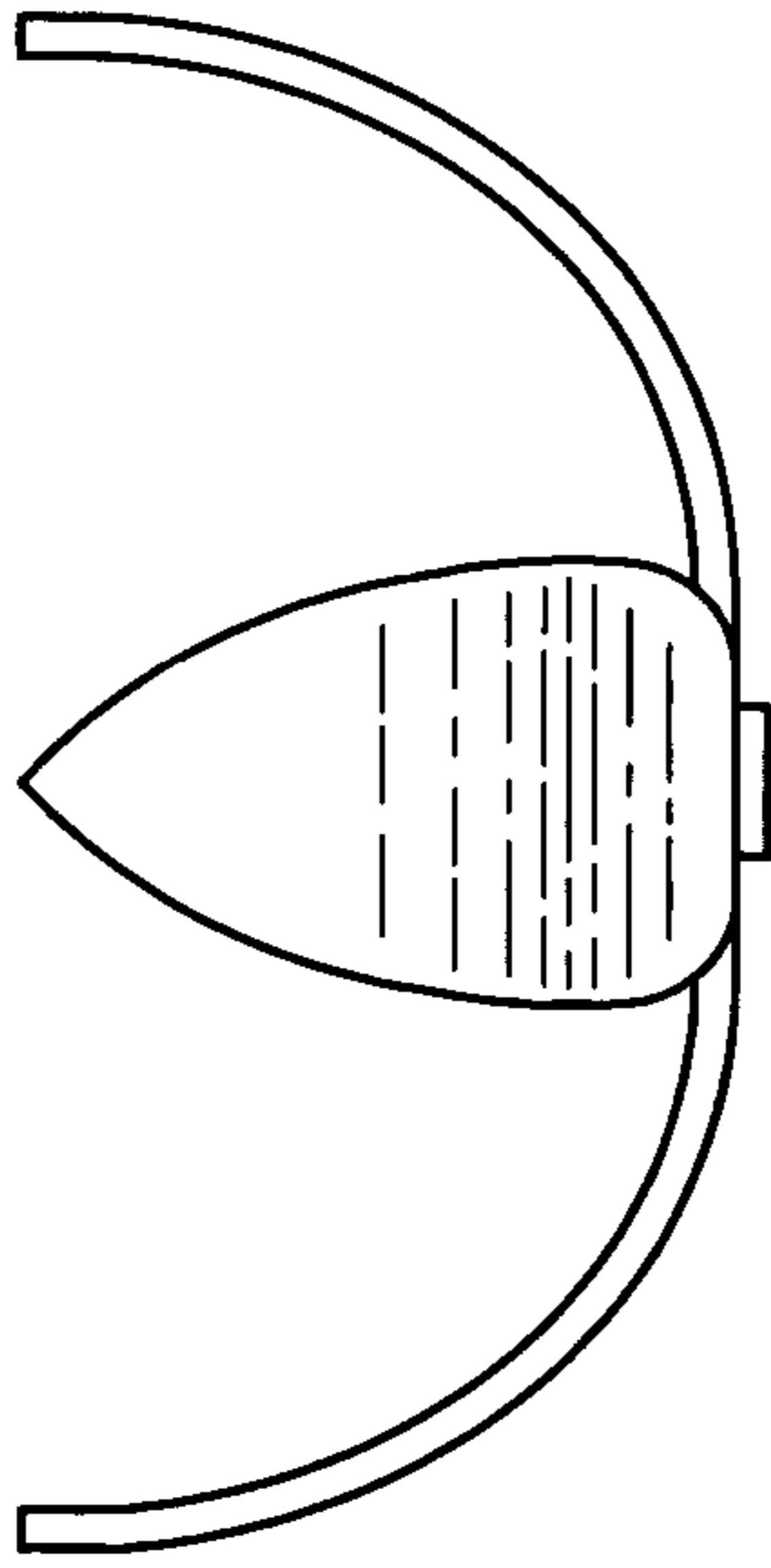
