(57) **CLAIM**

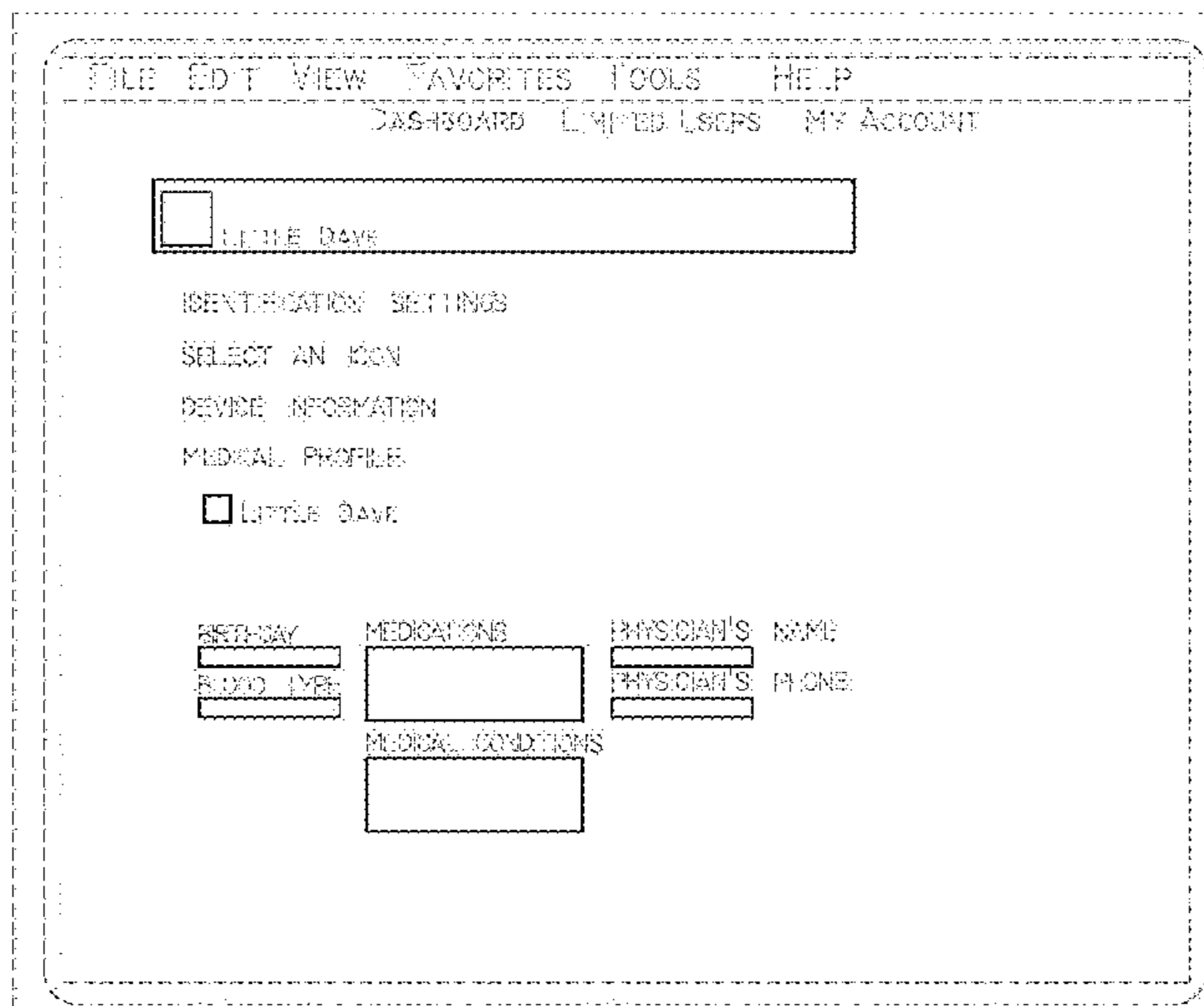
The ornamental design for a user interface for displaying medical information associated with an individual being monitored by a location tracking system on a computer display screen, as shown and described.
