The ornamental design for a chaff cutting blade for a band saw or the like, as shown and described.

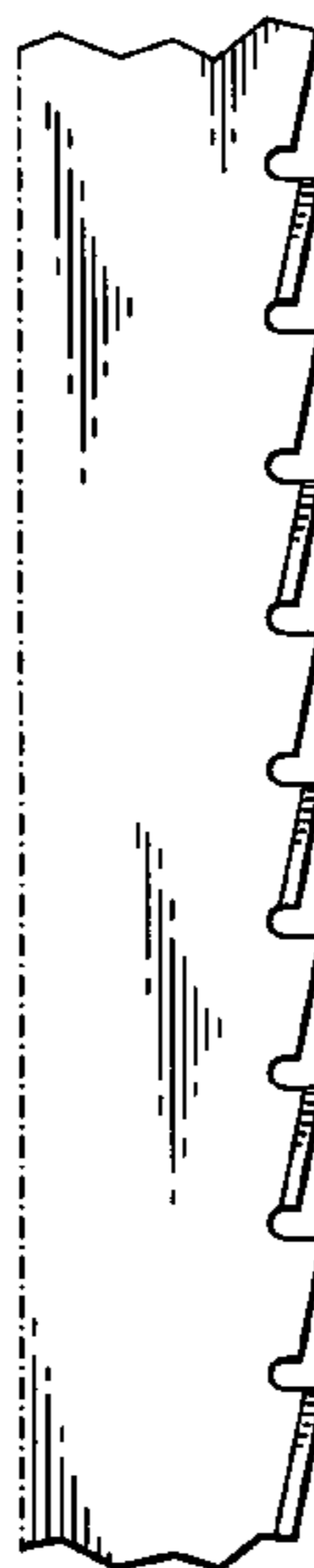
DESCRIPTION

FIG. 1 is a partial front elevational view of a chaff cutting blade for a band saw or the like showing a portion of the repeating pattern of the design according to the present invention;

FIG. 2 is a partial right side elevational view of FIG. 1; and, FIG. 3 is a partial perspective view of FIG. 1.

The details shown in dotted lines are for illustrative purposes only and form no part of the claimed ornamental design.

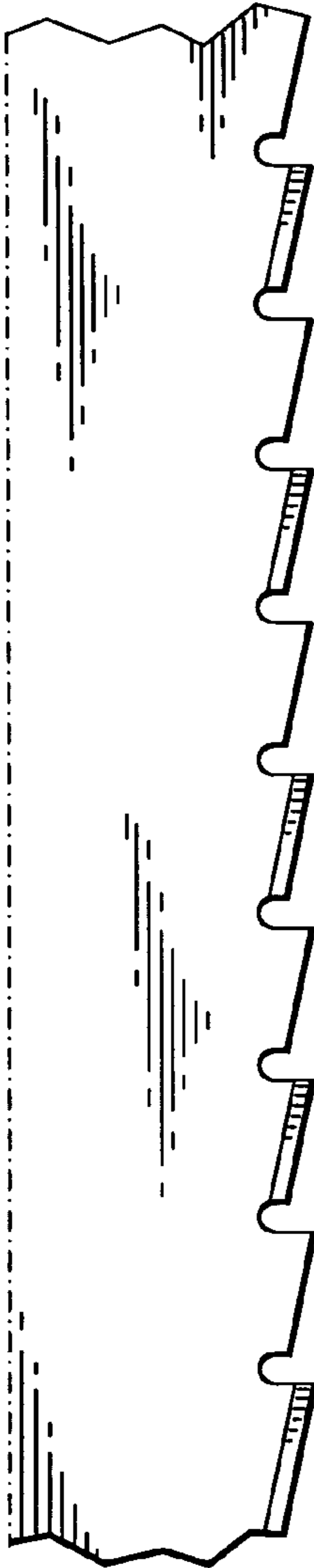

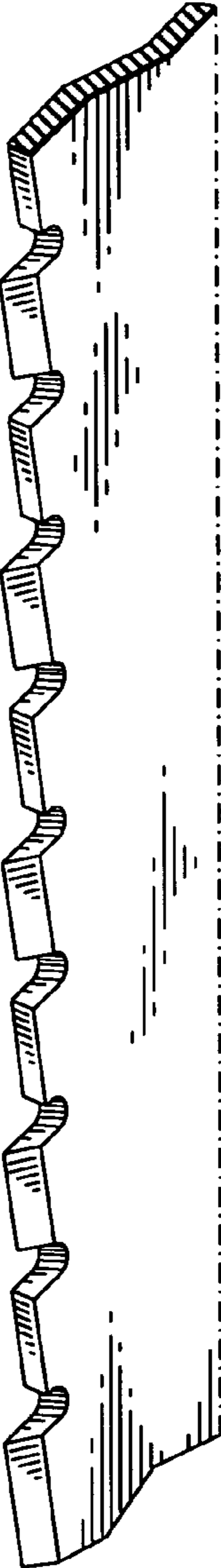
