(57) **CLAIM**

I claim the ornamental design for a remote grease fitting, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a remote grease fitting, showing my new design;

FIG. 2 is a right side elevational view thereof;

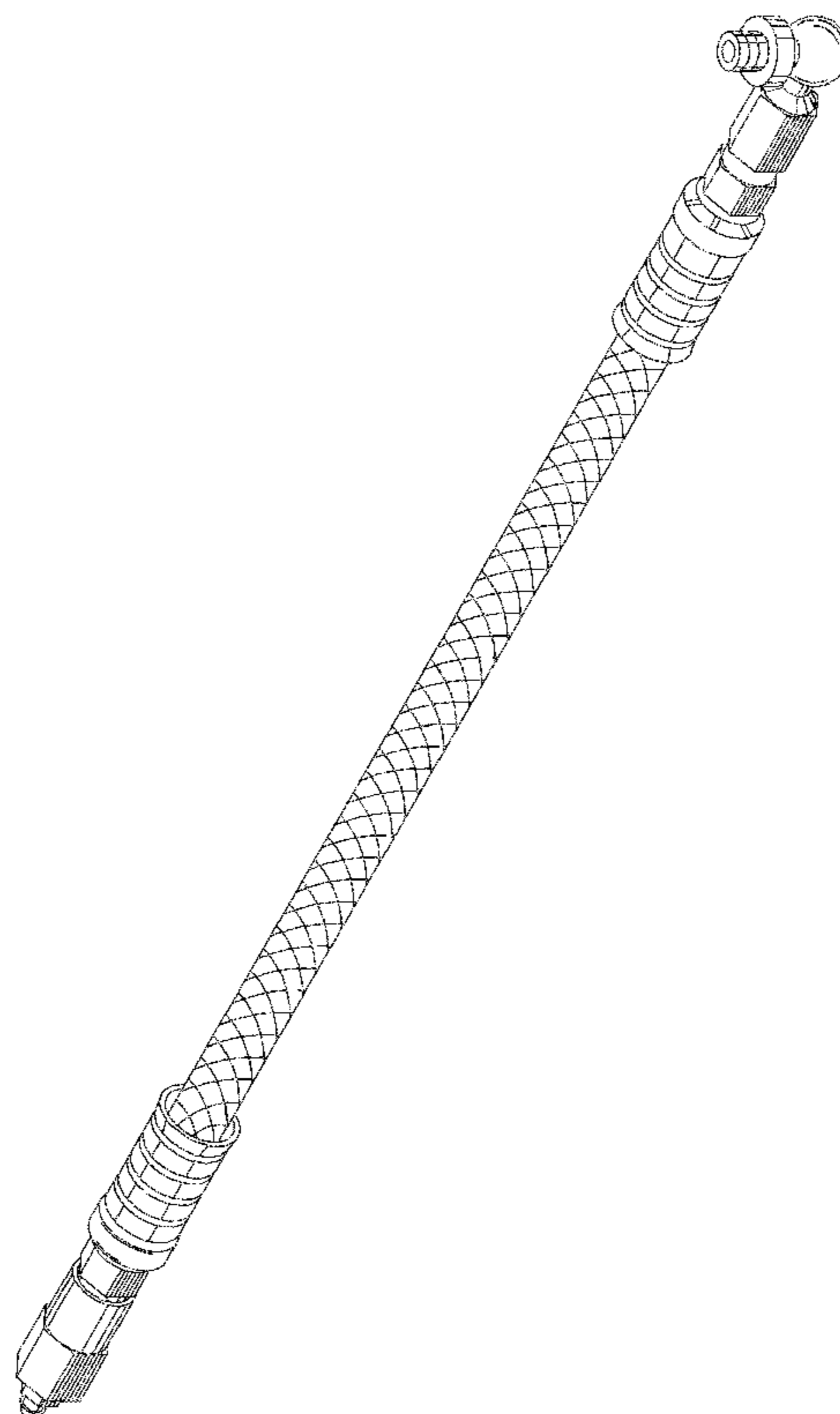
FIG. 3 is a left side elevational view thereof;

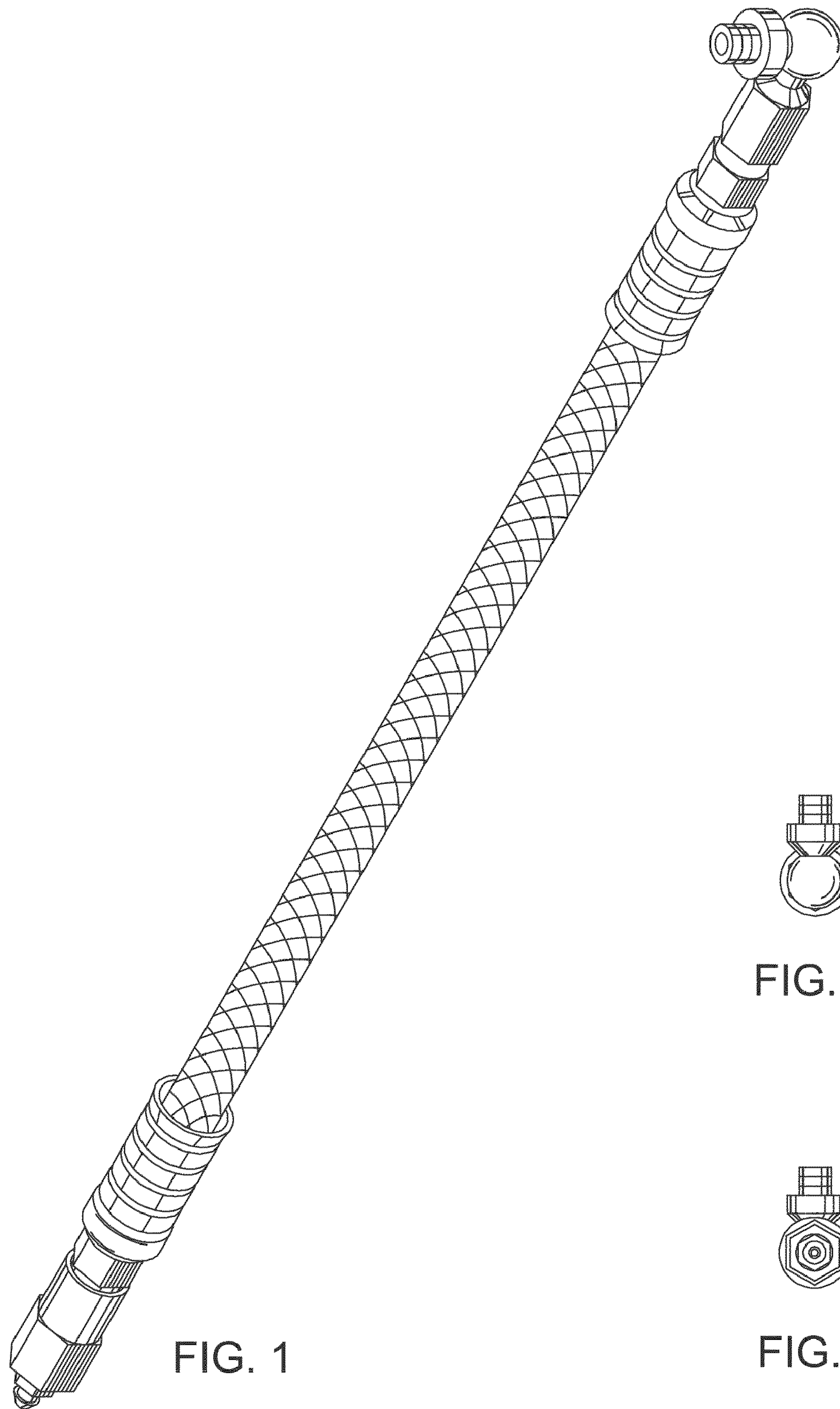

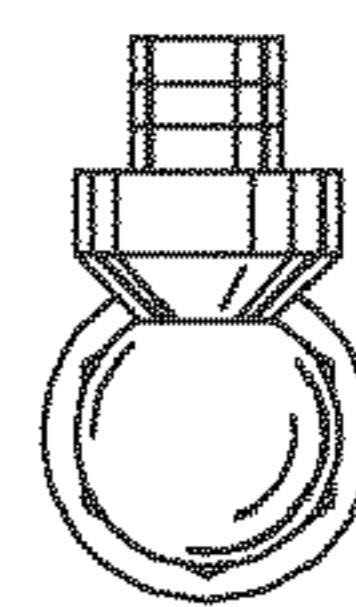

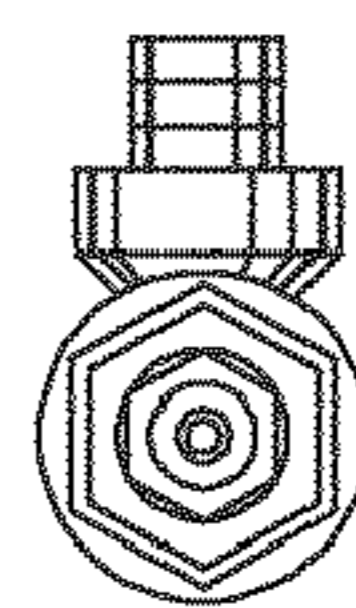

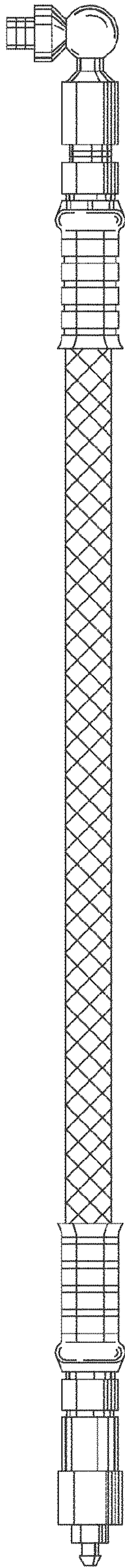

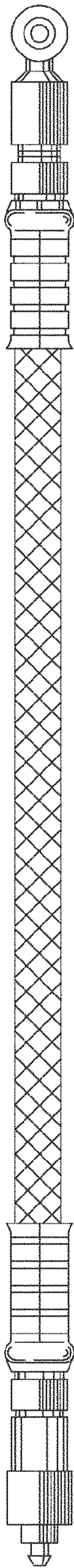

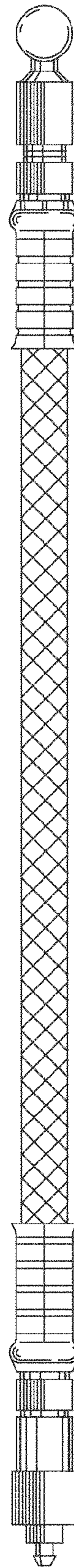
