FIG. 3 is a rear elevational view of the invention;

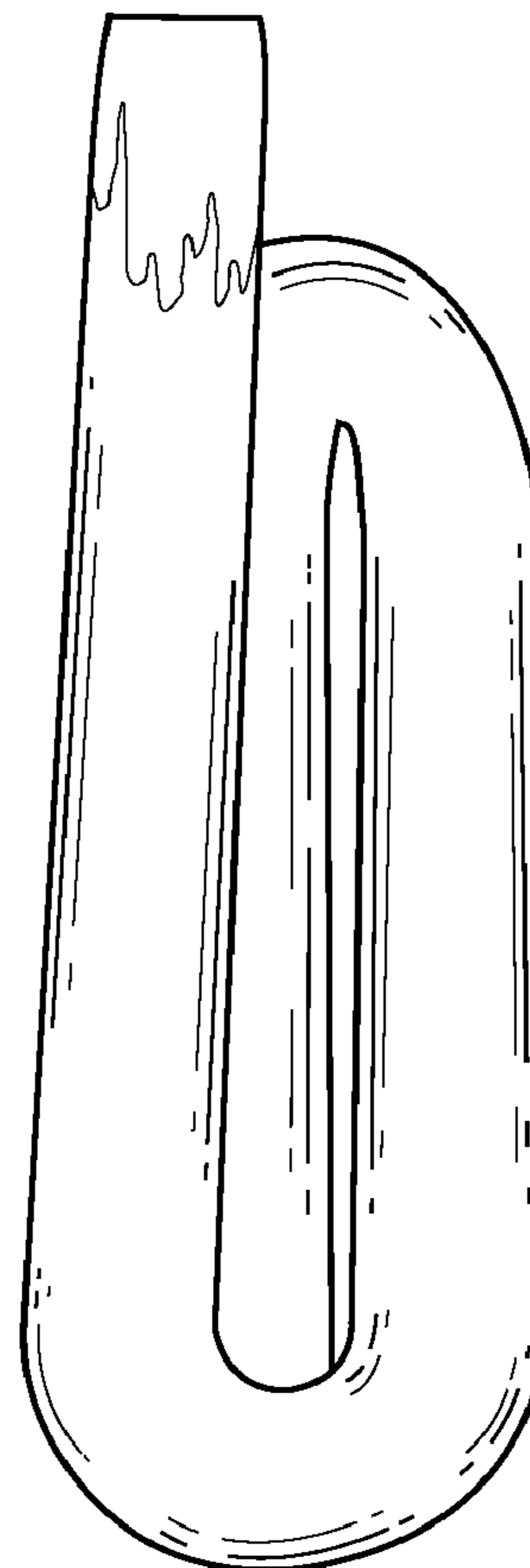
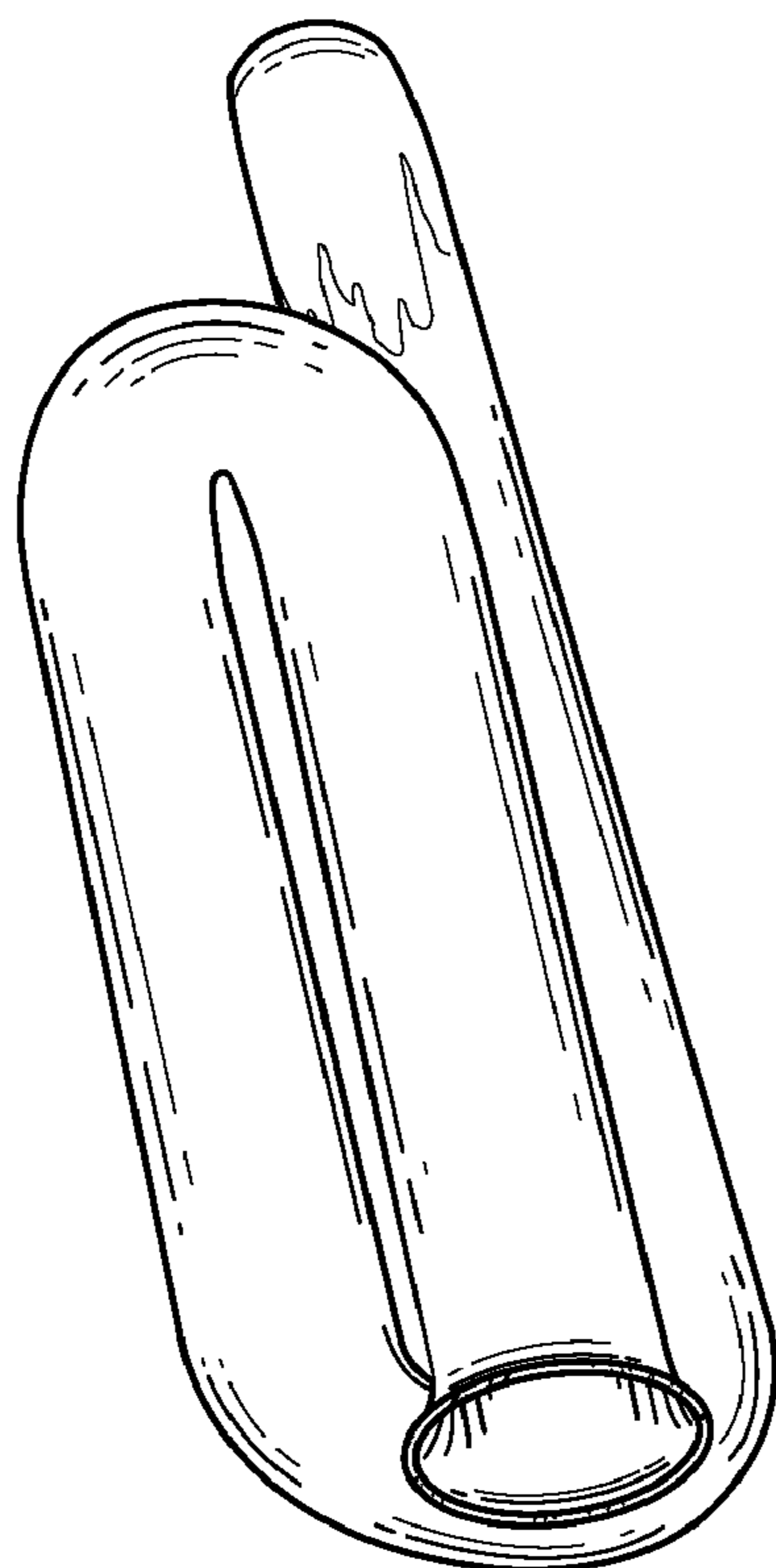
FIG. 4 is a right-side elevational view of the invention;

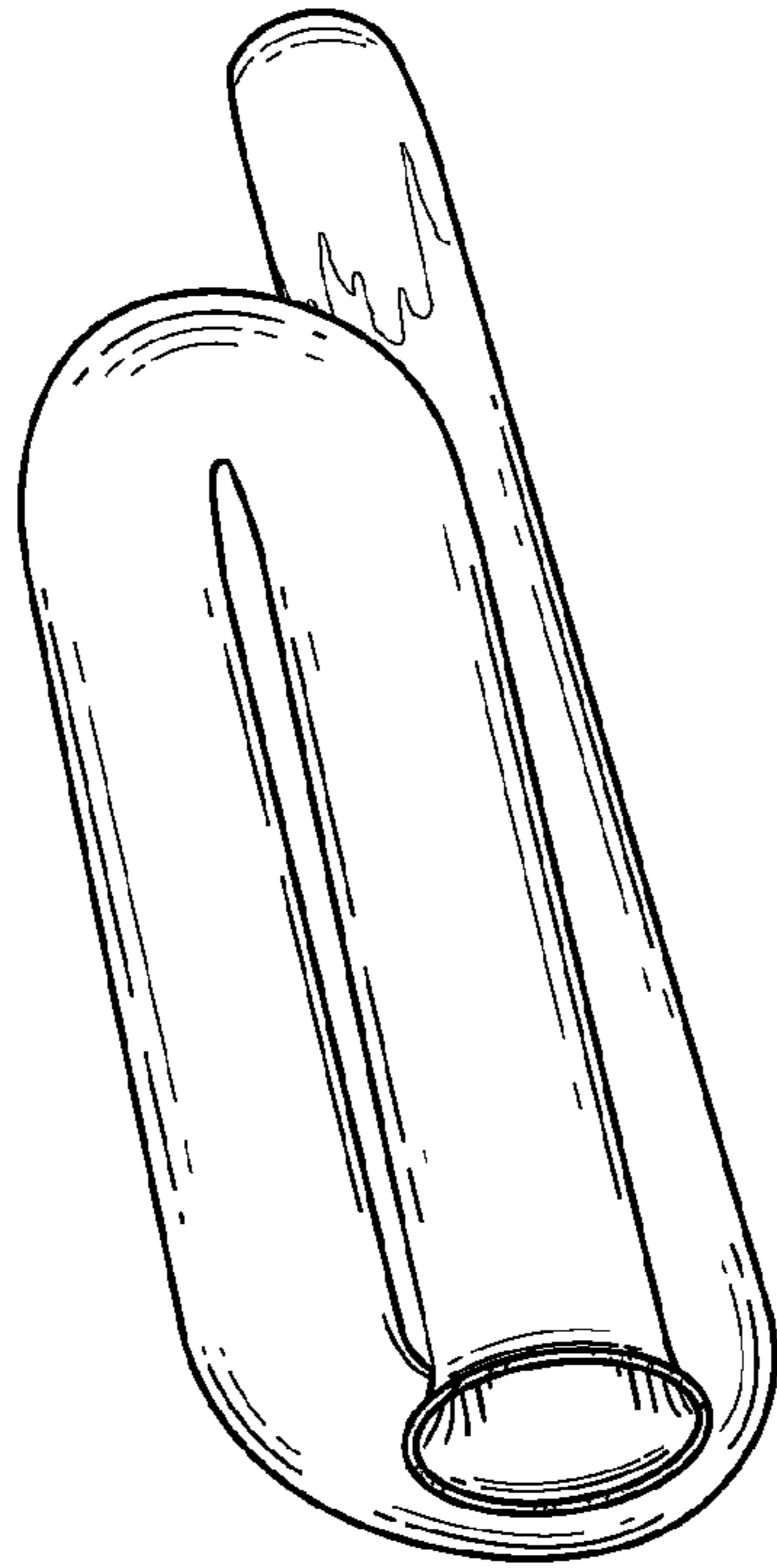

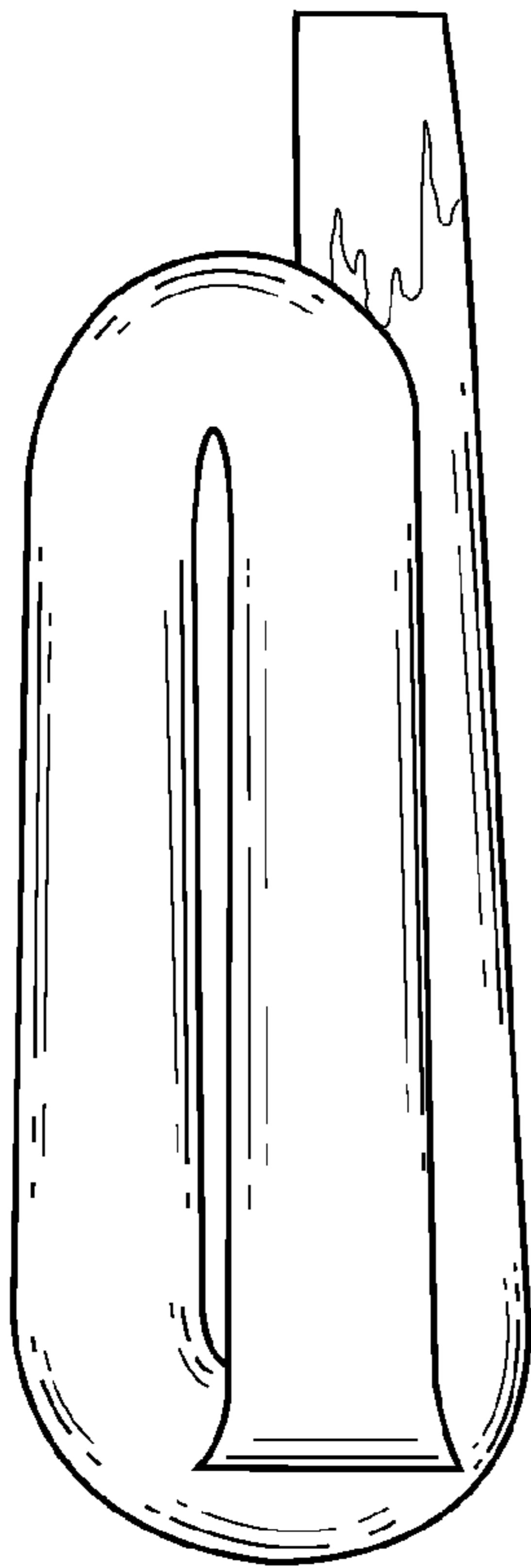

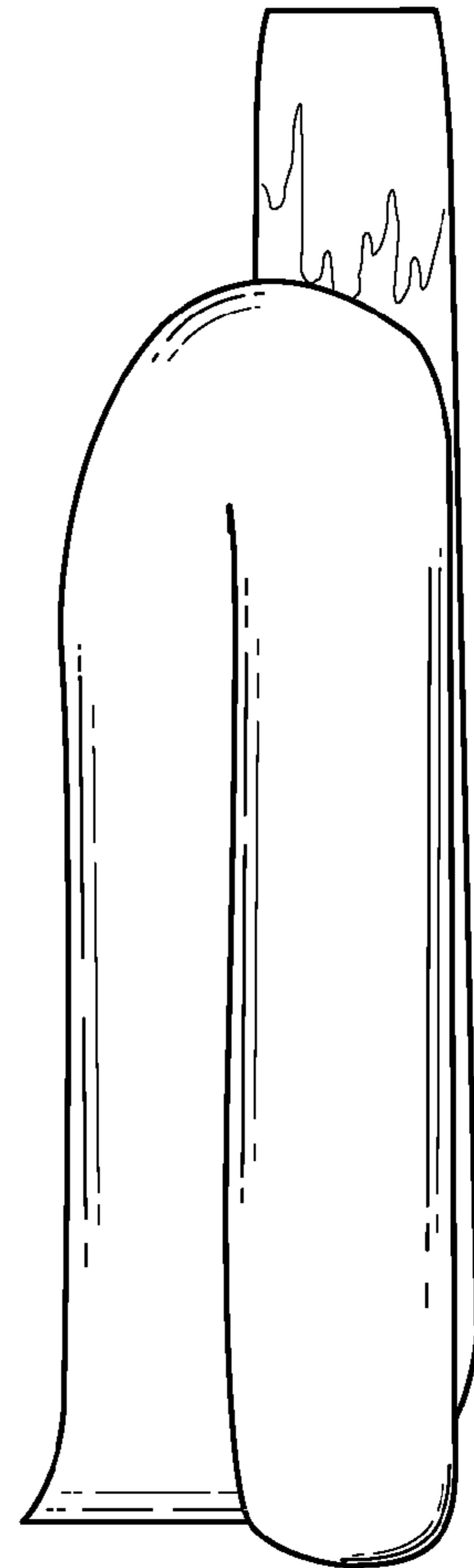

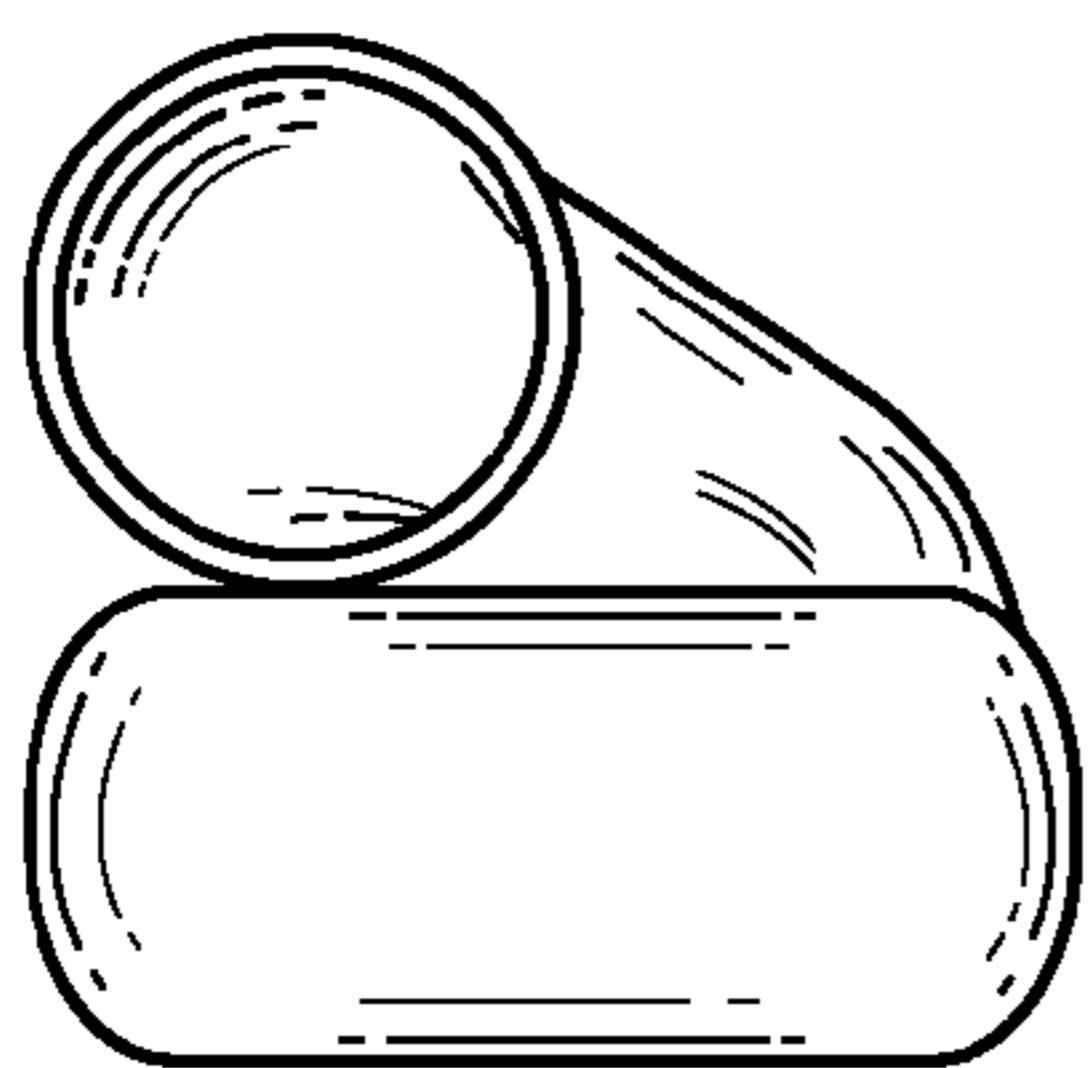

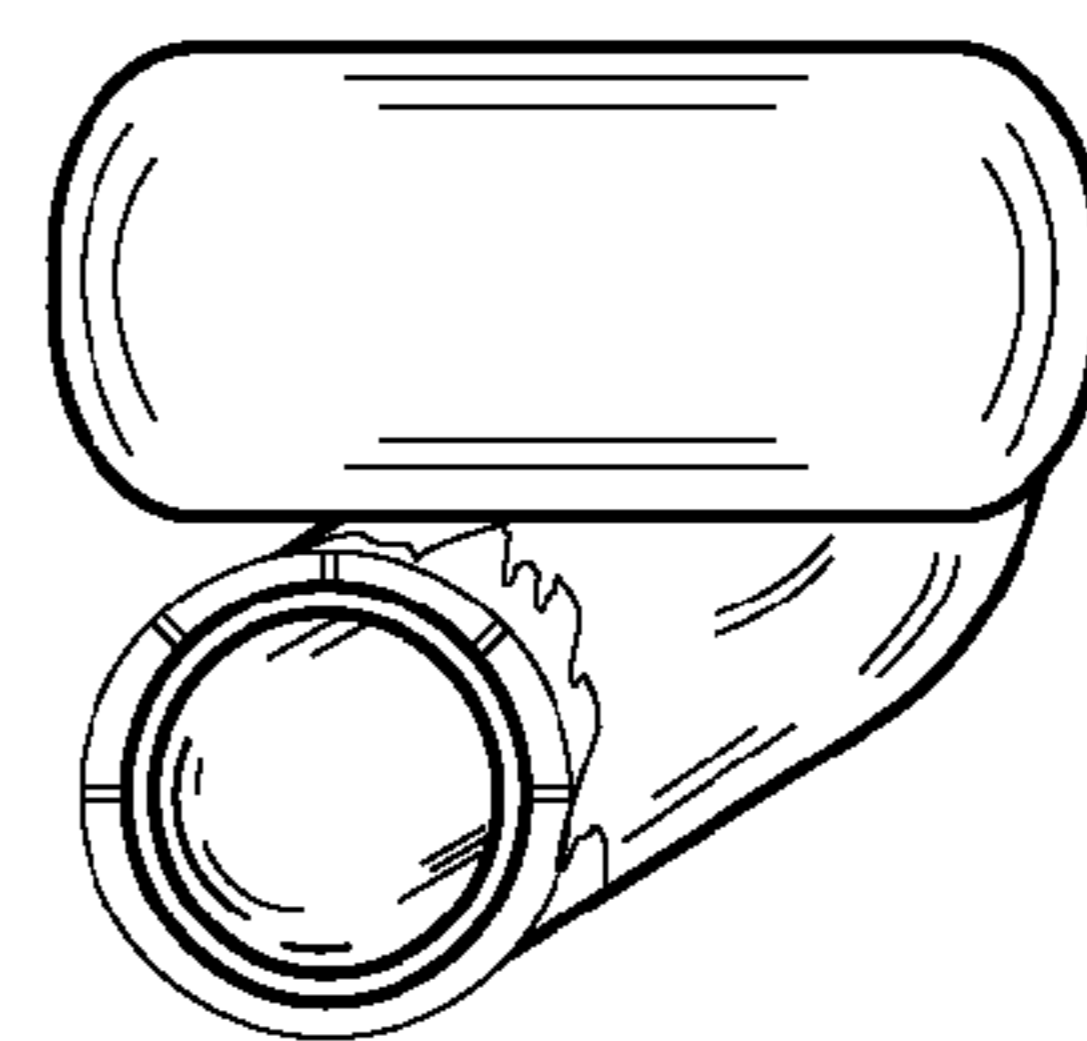
