(57) **CLAIM**

The ornamental design of a badge for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a badge for a golf club head, the broken line showing of the golf club head is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is an enlarged top perspective view of the badge for a golf club head only;

FIG. 3 is a front view of FIG. 2;

FIG. 4 is a rear view of FIG. 2;

FIG. 5 is a top view of FIG. 2;

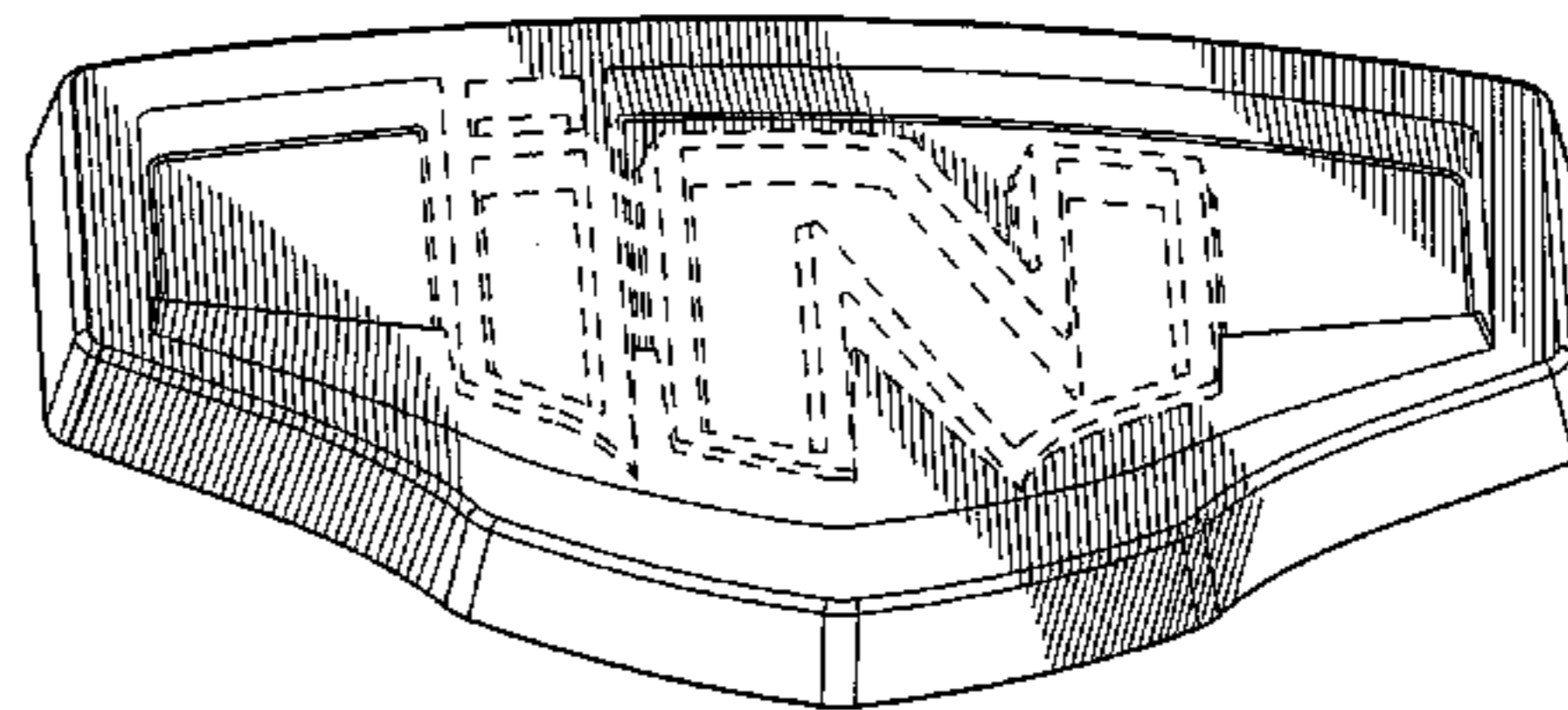
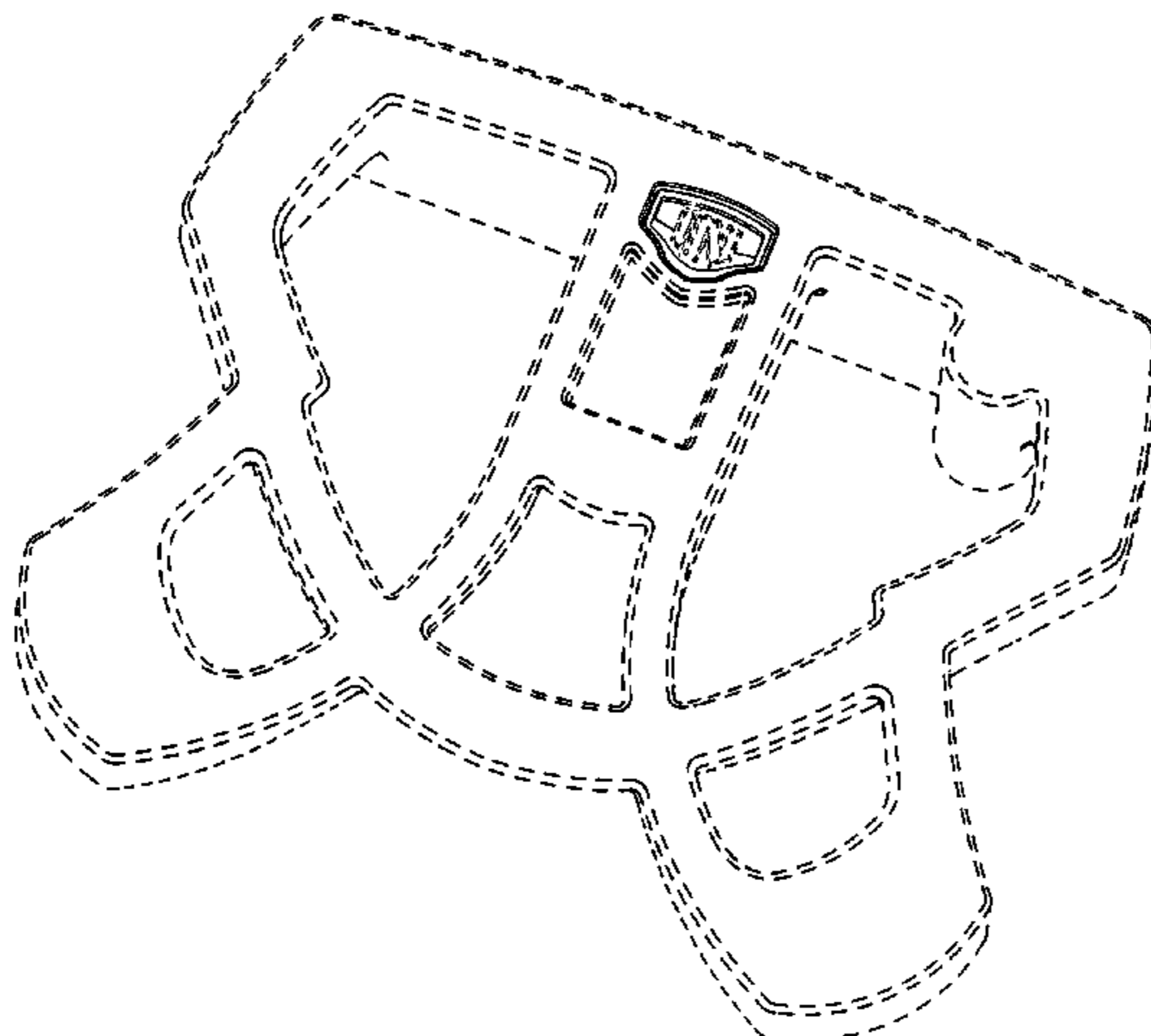
FIG. 6 is a bottom view of FIG. 2;

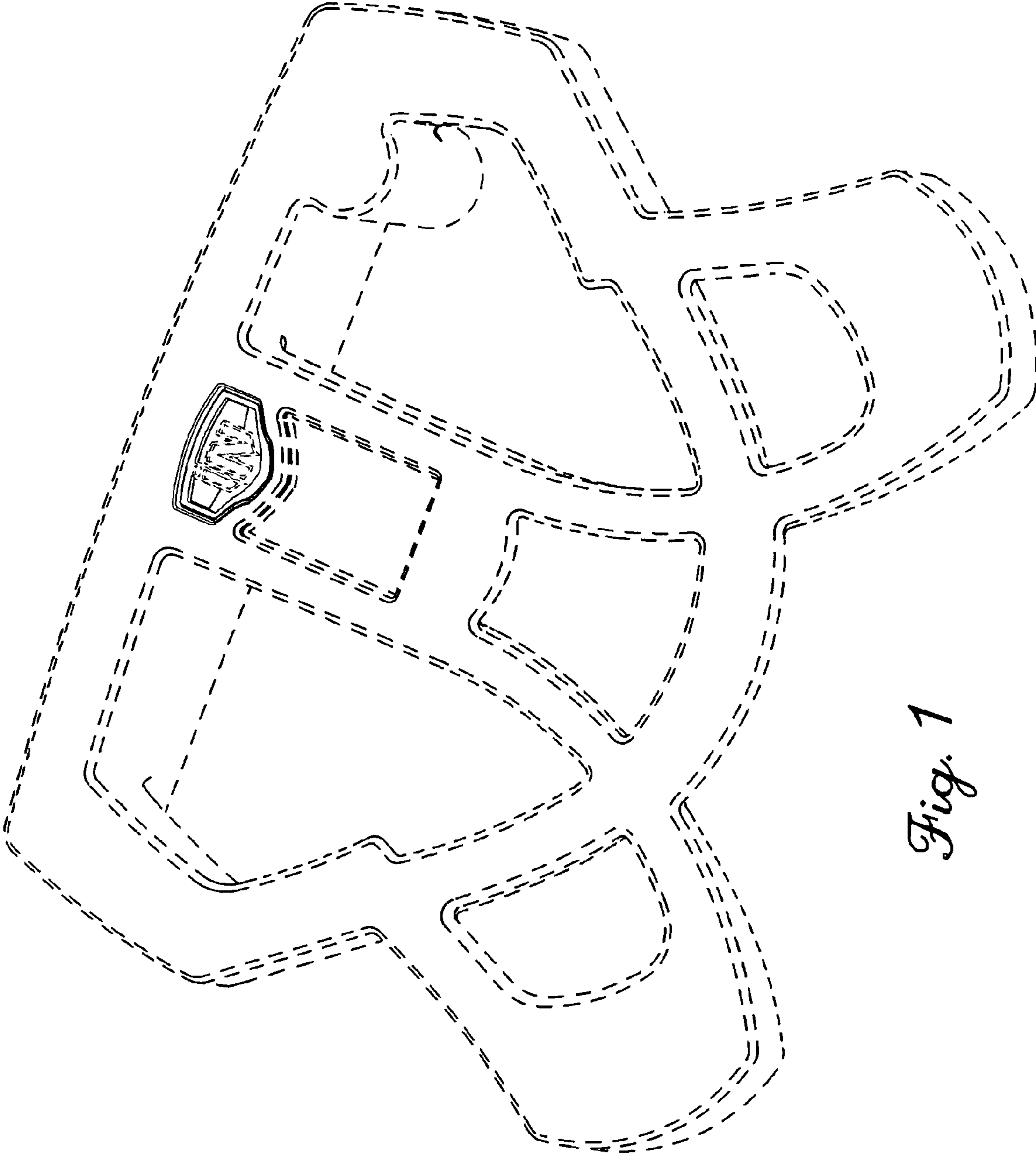

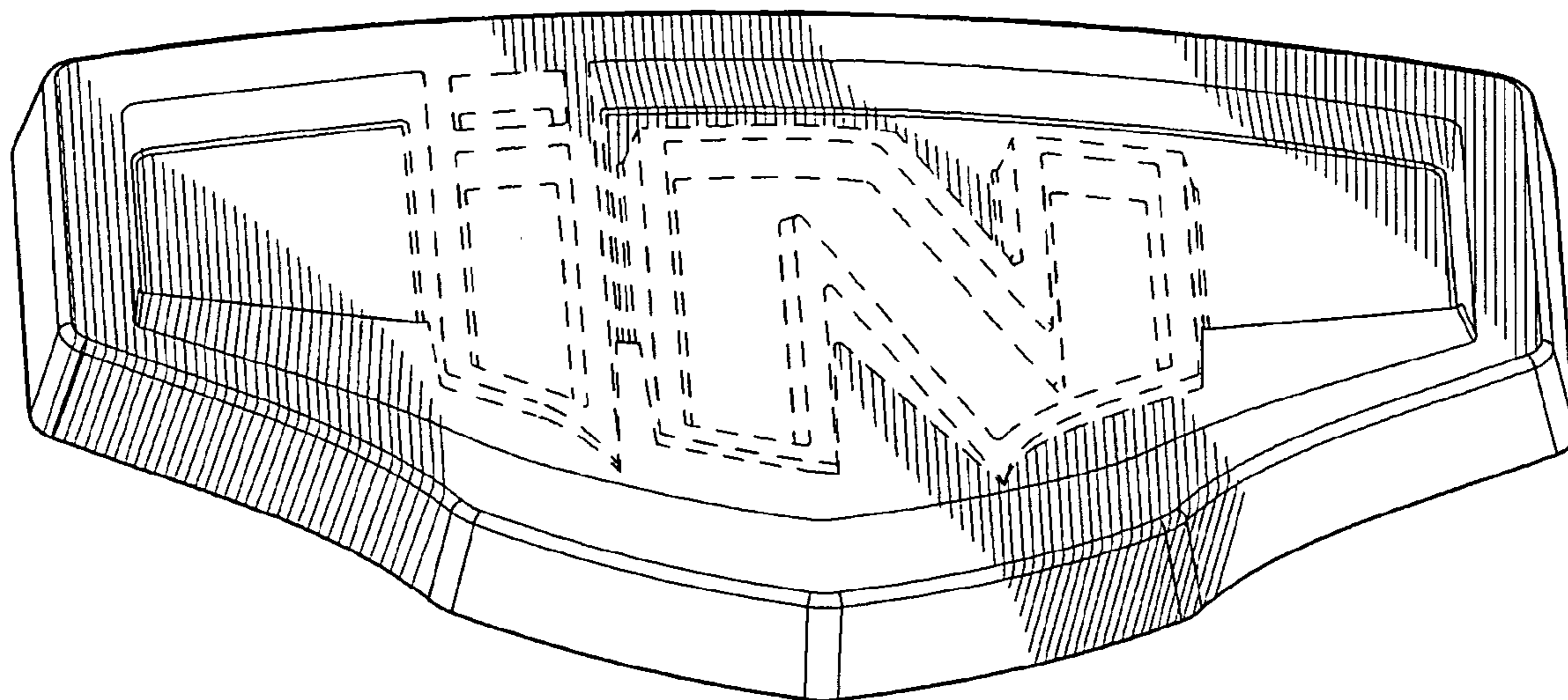

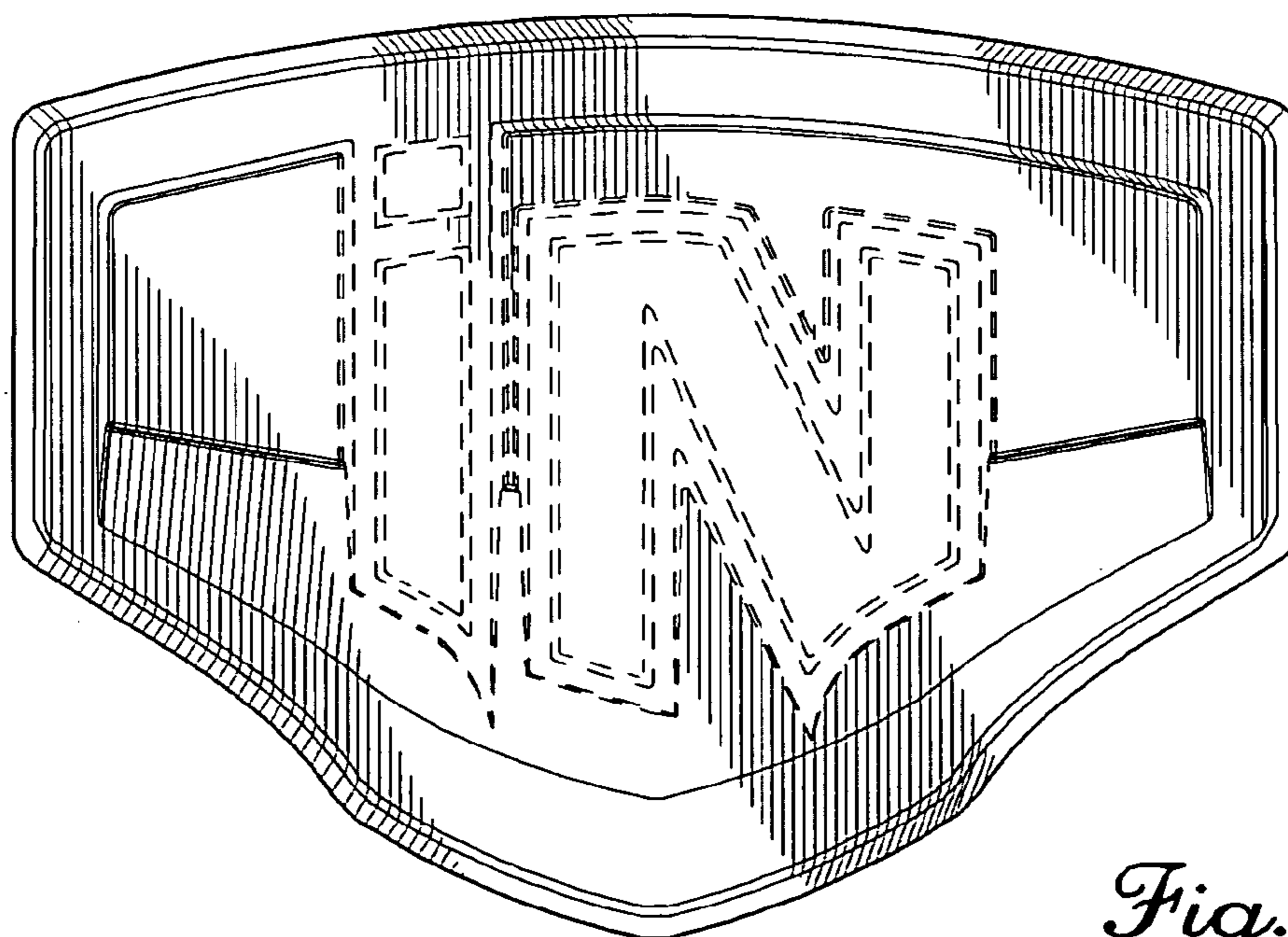

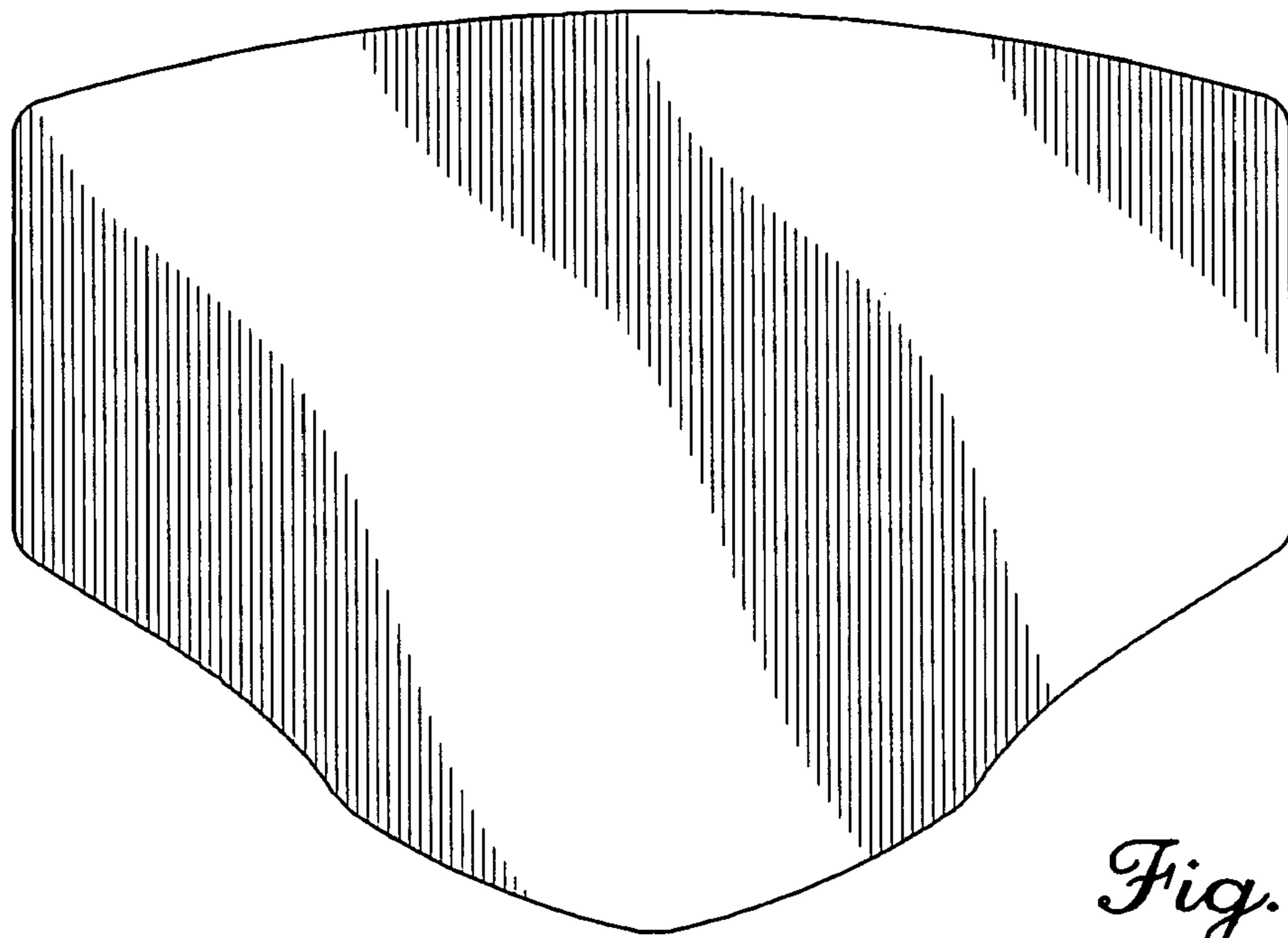

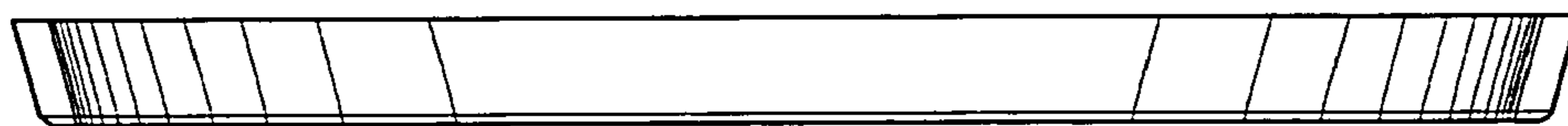

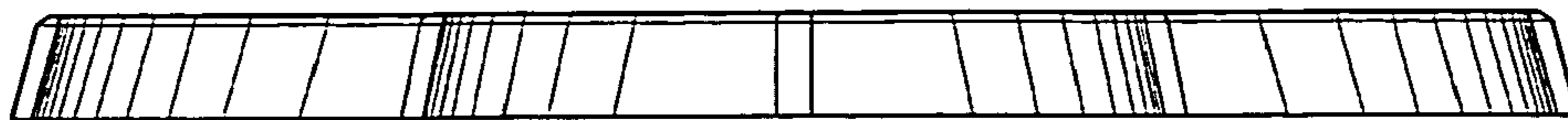

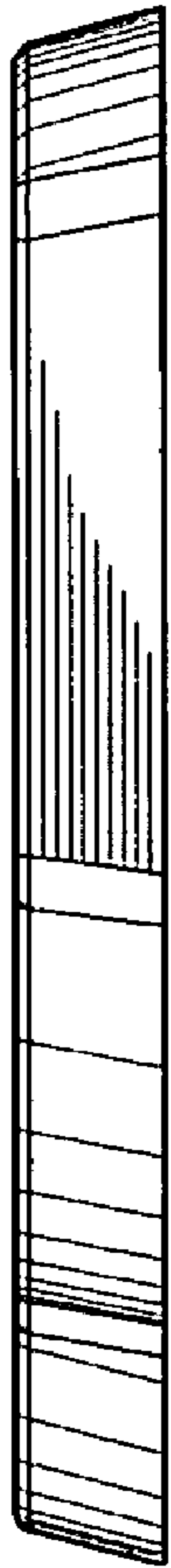
