**DESCRIPTION**

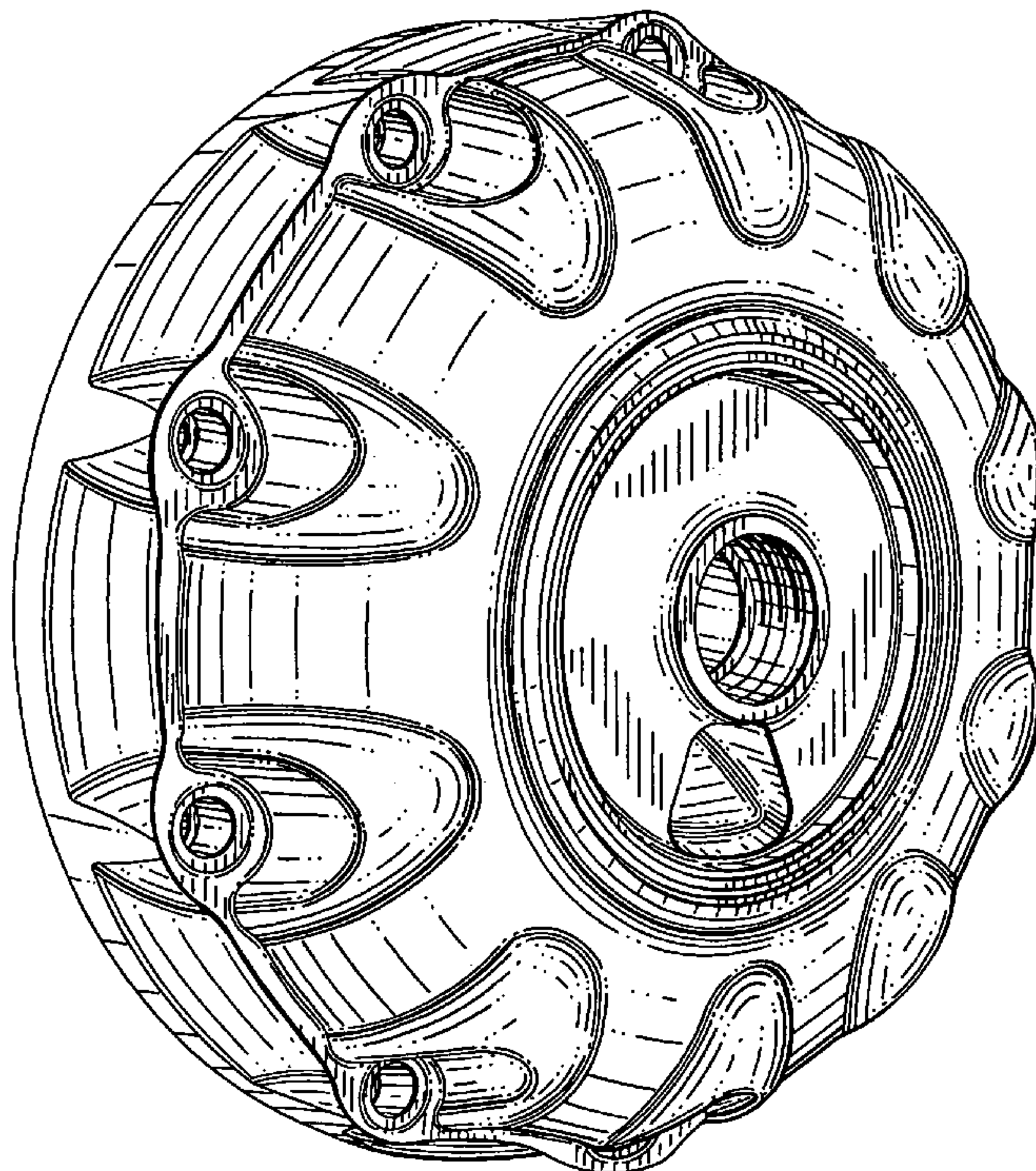

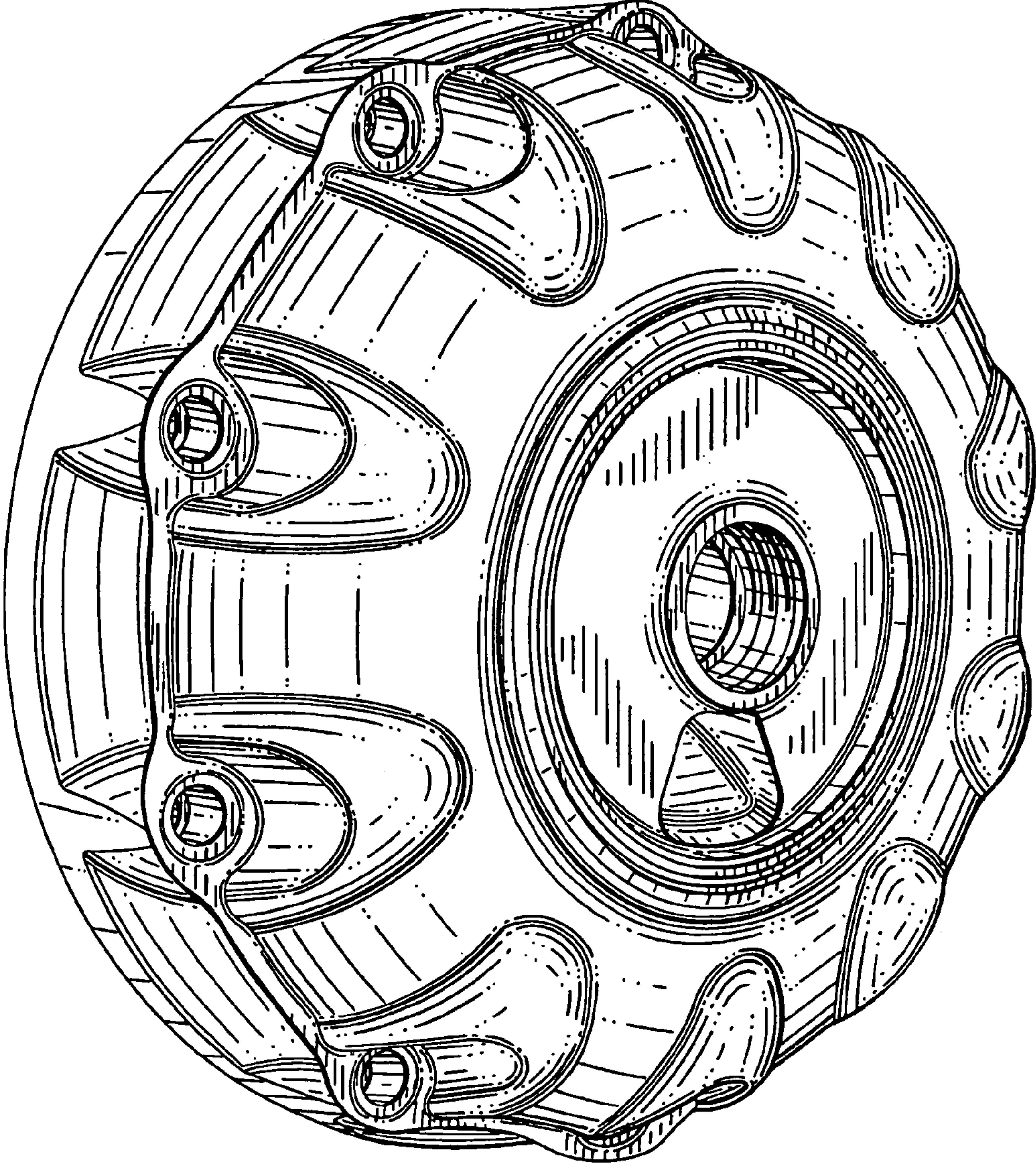

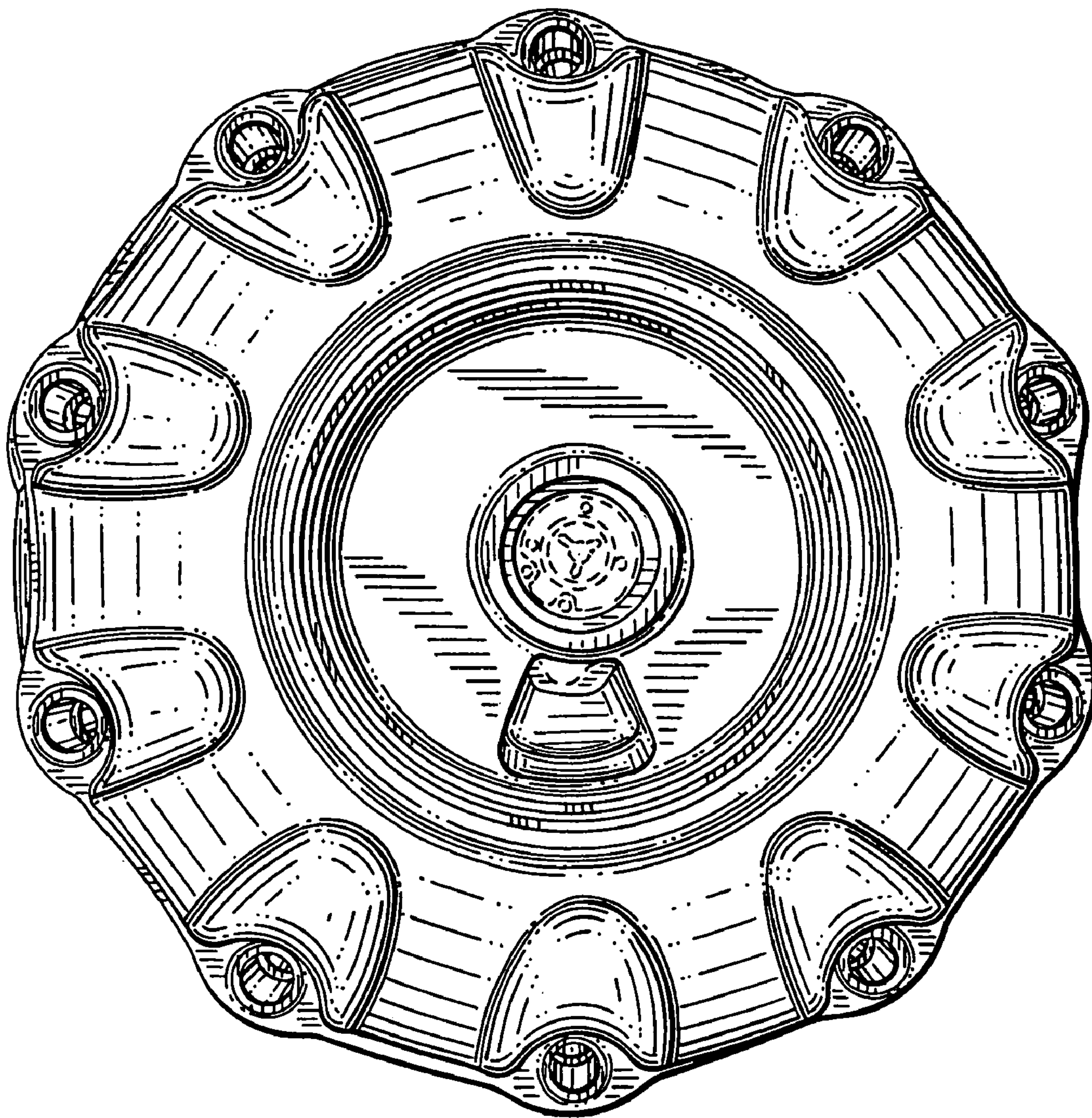

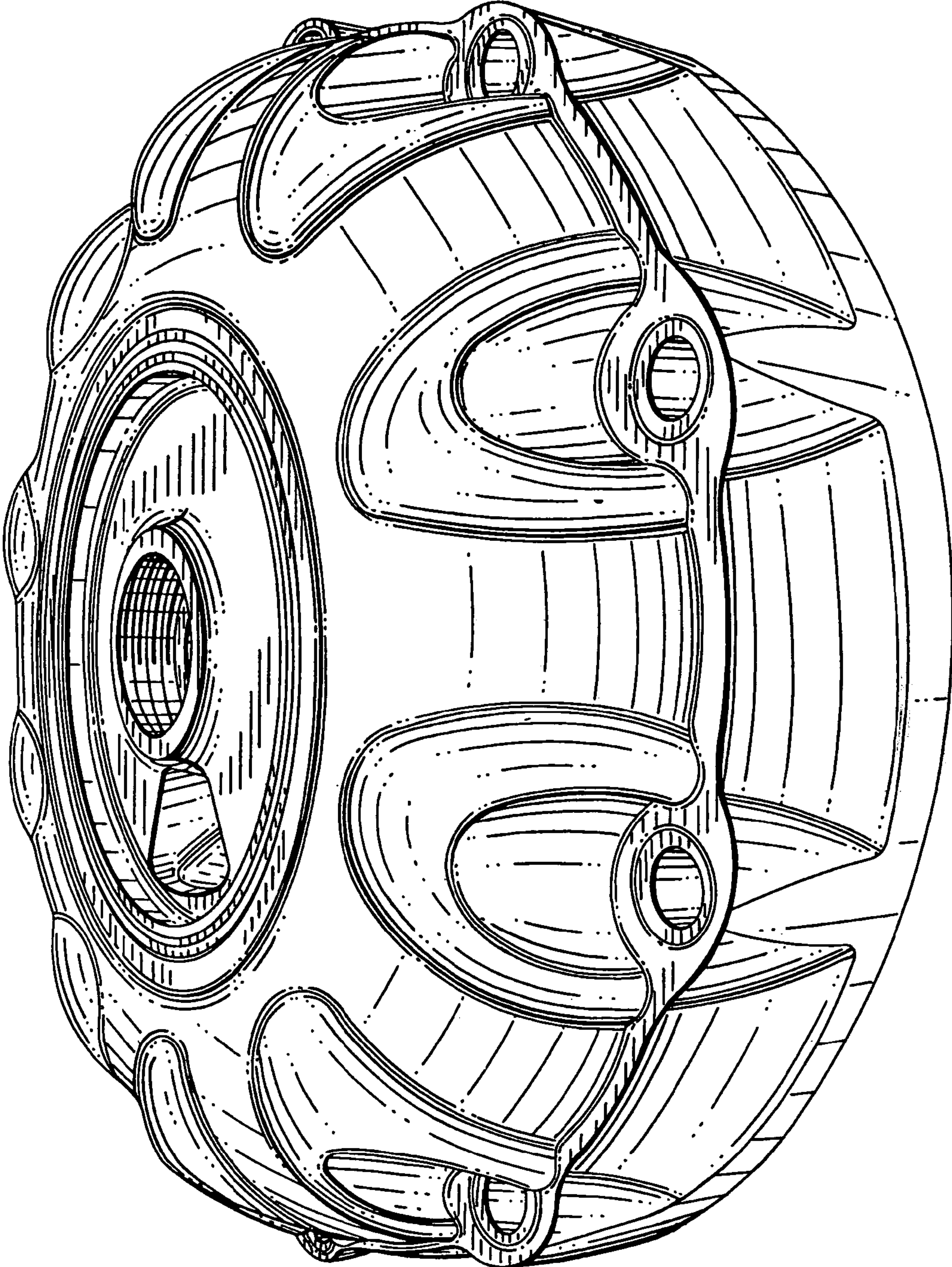
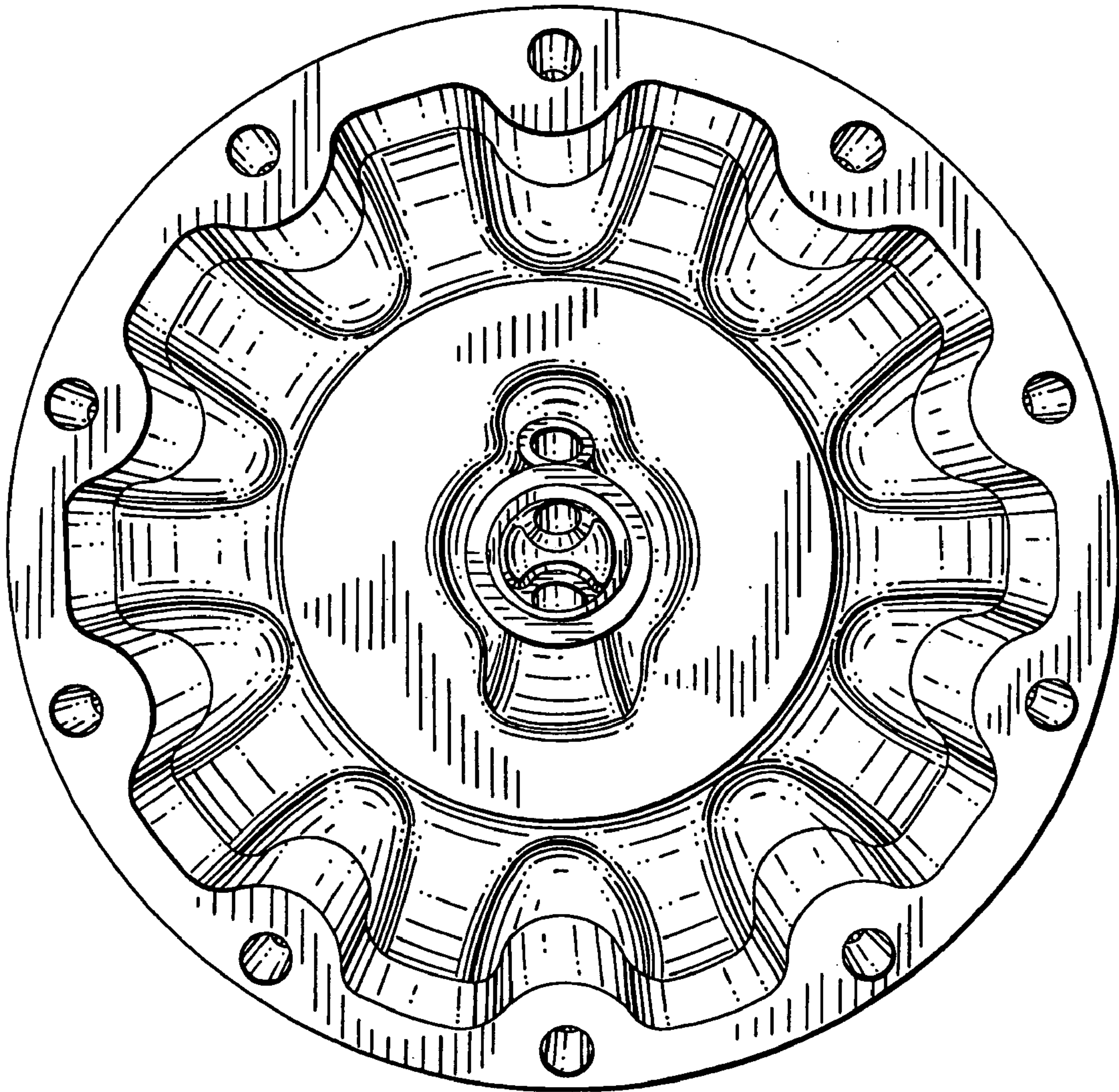

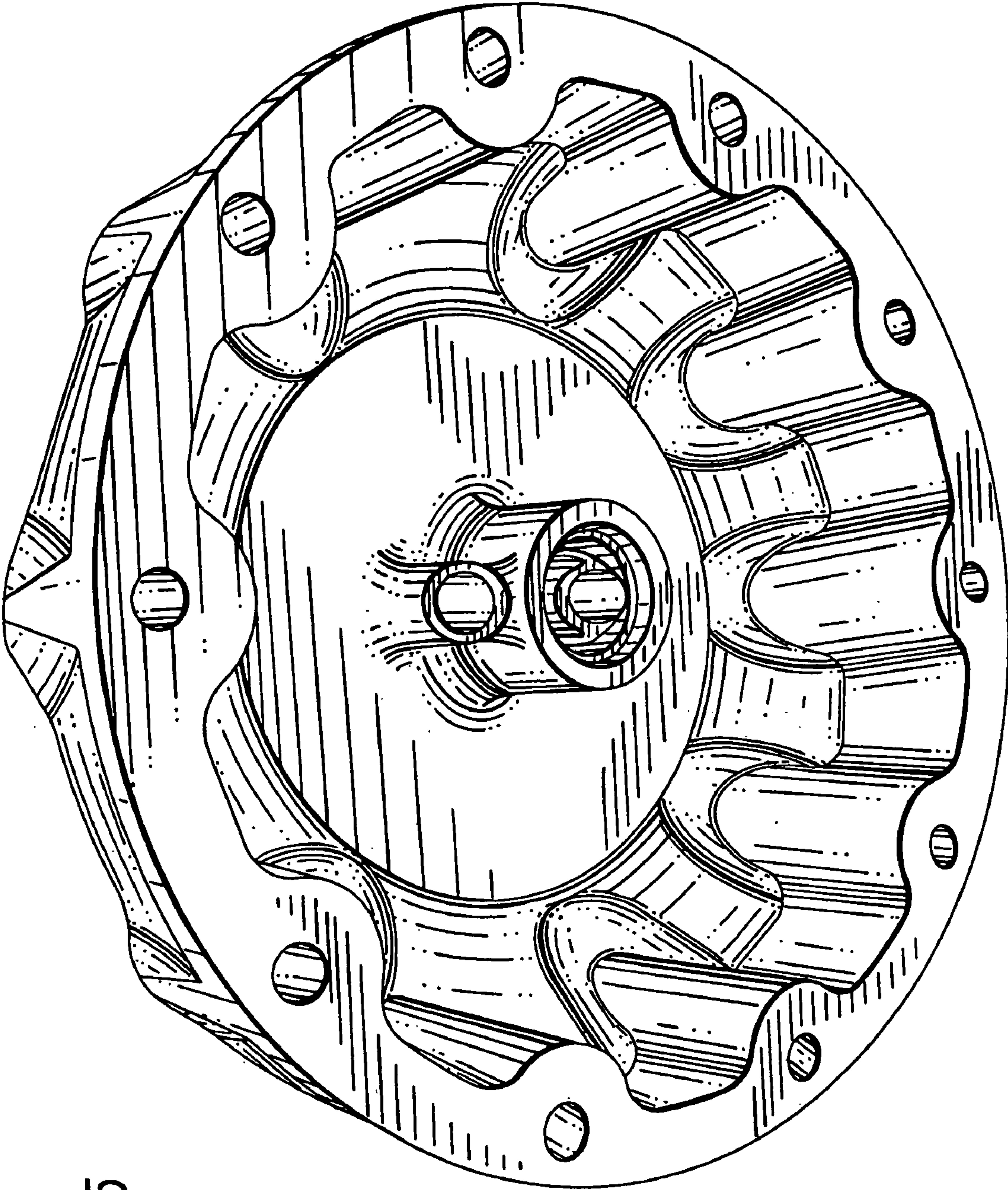

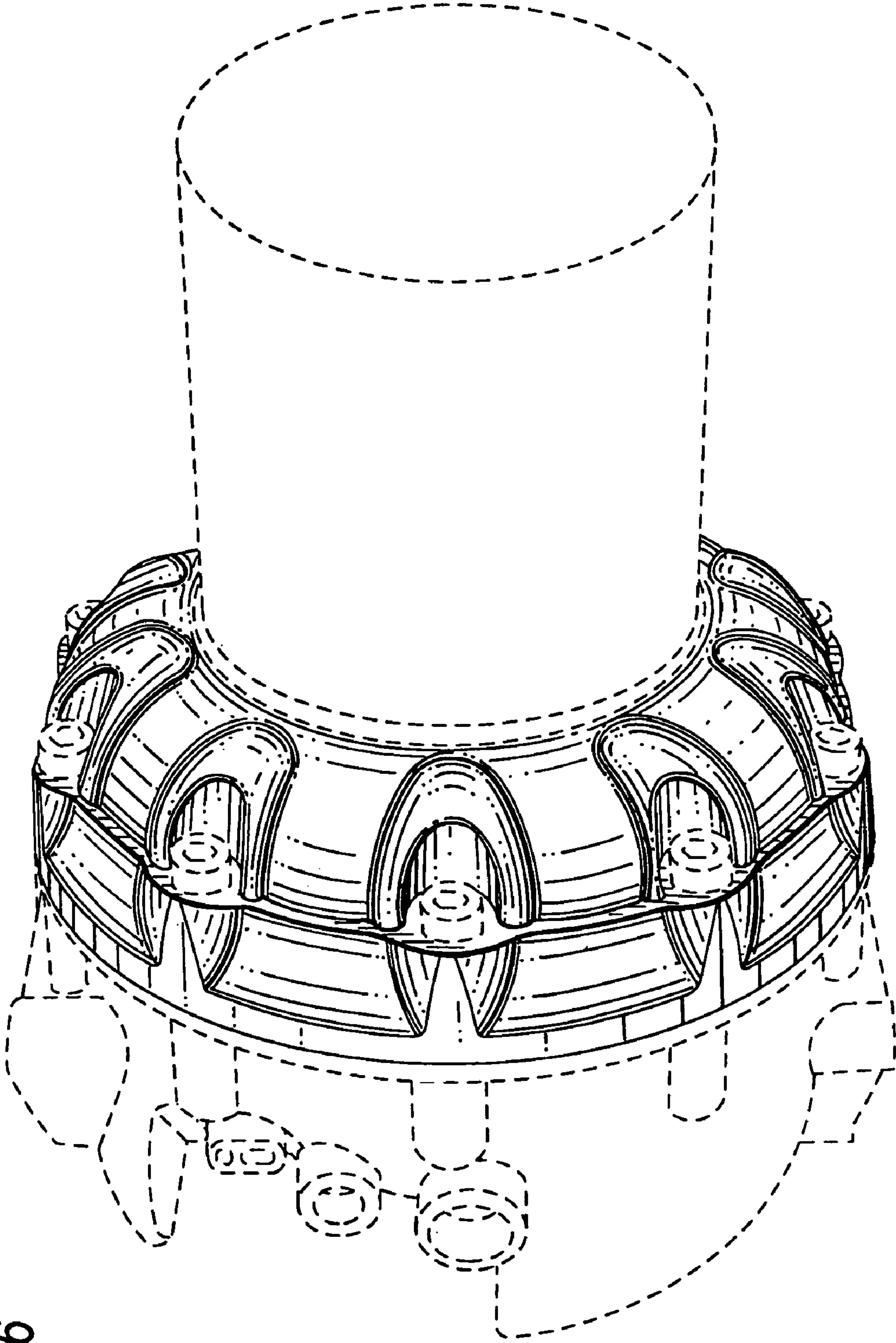
