The ornamental design for a fan blade, as shown.

DESCRIPTION

FIG. 1 is a perspective bottom view of a fan blade in use.

FIG. 2 is a perspective top view of the fan of FIG. 1.

FIG. 3 is a bottom view of the fan of FIG. 1.

FIG. 4 is a top view of the fan of FIG. 1.

FIG. 5 is a front side view of the fan of FIG. 1.

FIG. 6 is a rear side view of the fan of FIG. 1.

FIG. 7 is a left side view of the fan of FIG. 1.

FIG. 8 is a right side view of the fan of FIG. 1.

FIG. 9 is perspective bottom view of another fan having three twisted blades with a hub.

FIG. 10 is a perspective top view of the fan of FIG. 9.

FIG. 11 is a bottom view of the fan of FIG. 9.

FIG. 12 is a top view of the fan of FIG. 9.

FIG. 13 is a front side view of the fan of FIG. 9.

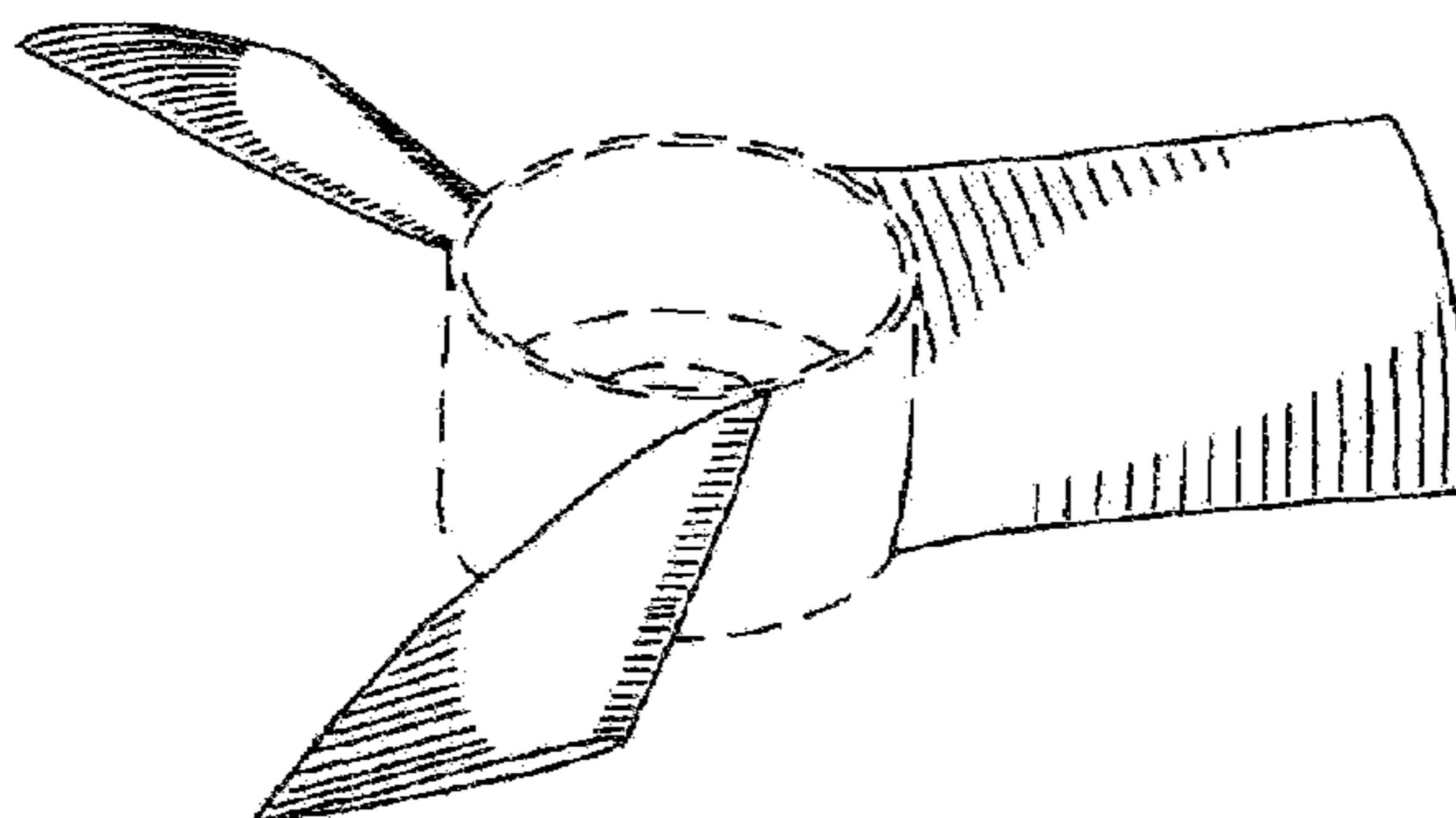
FIG. 14 is a rear side view of the fan of FIG. 9.

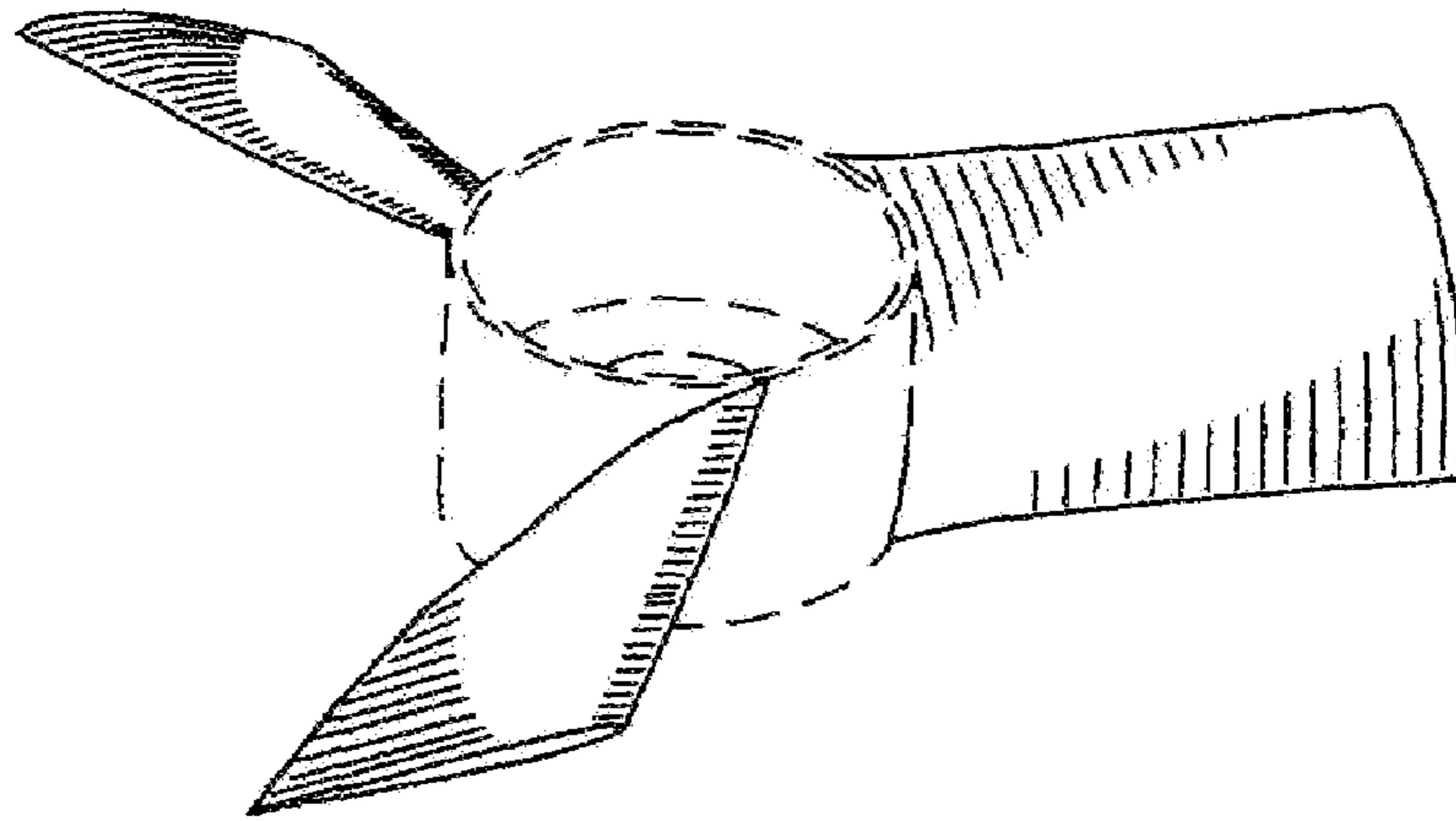
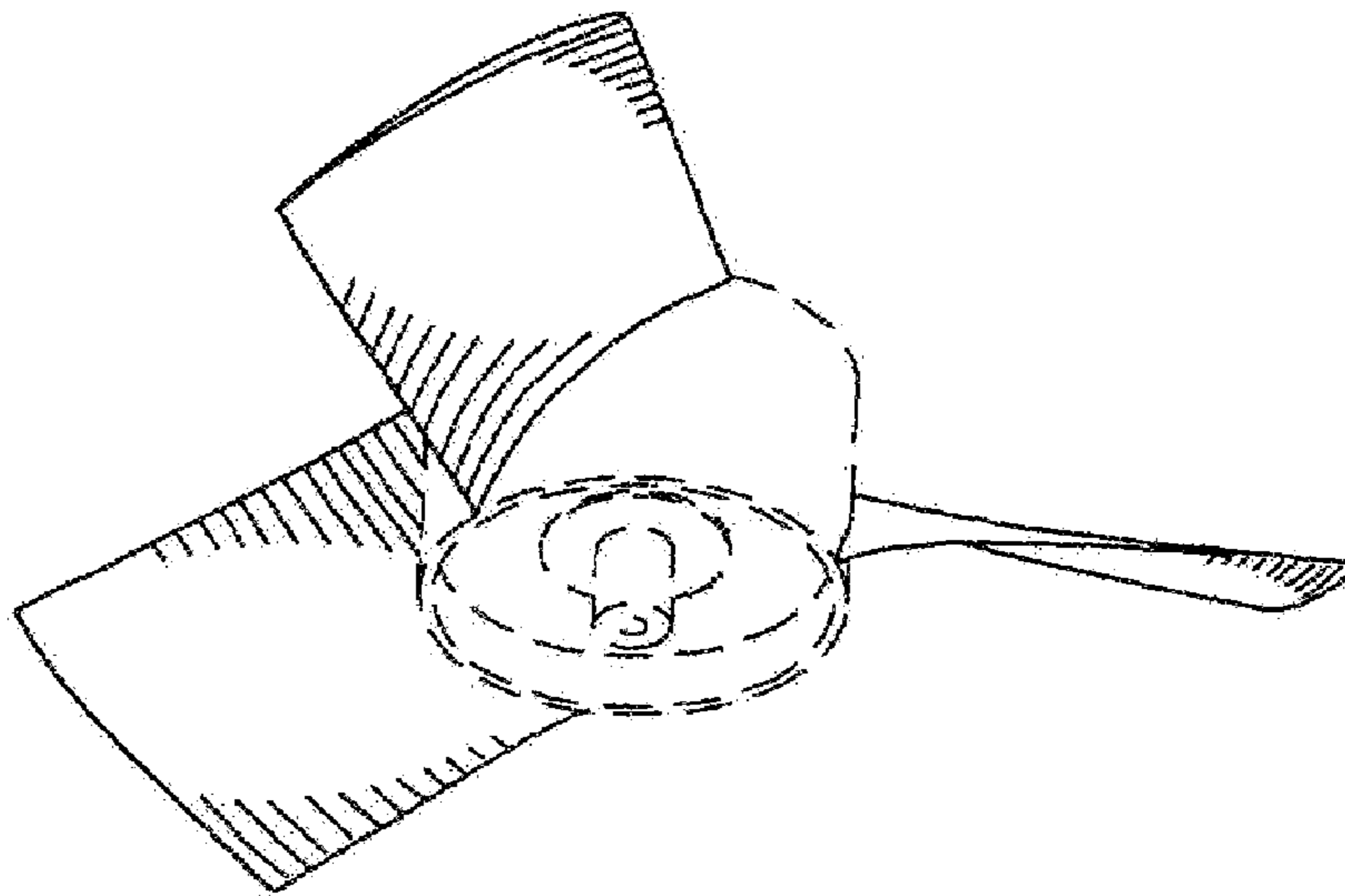

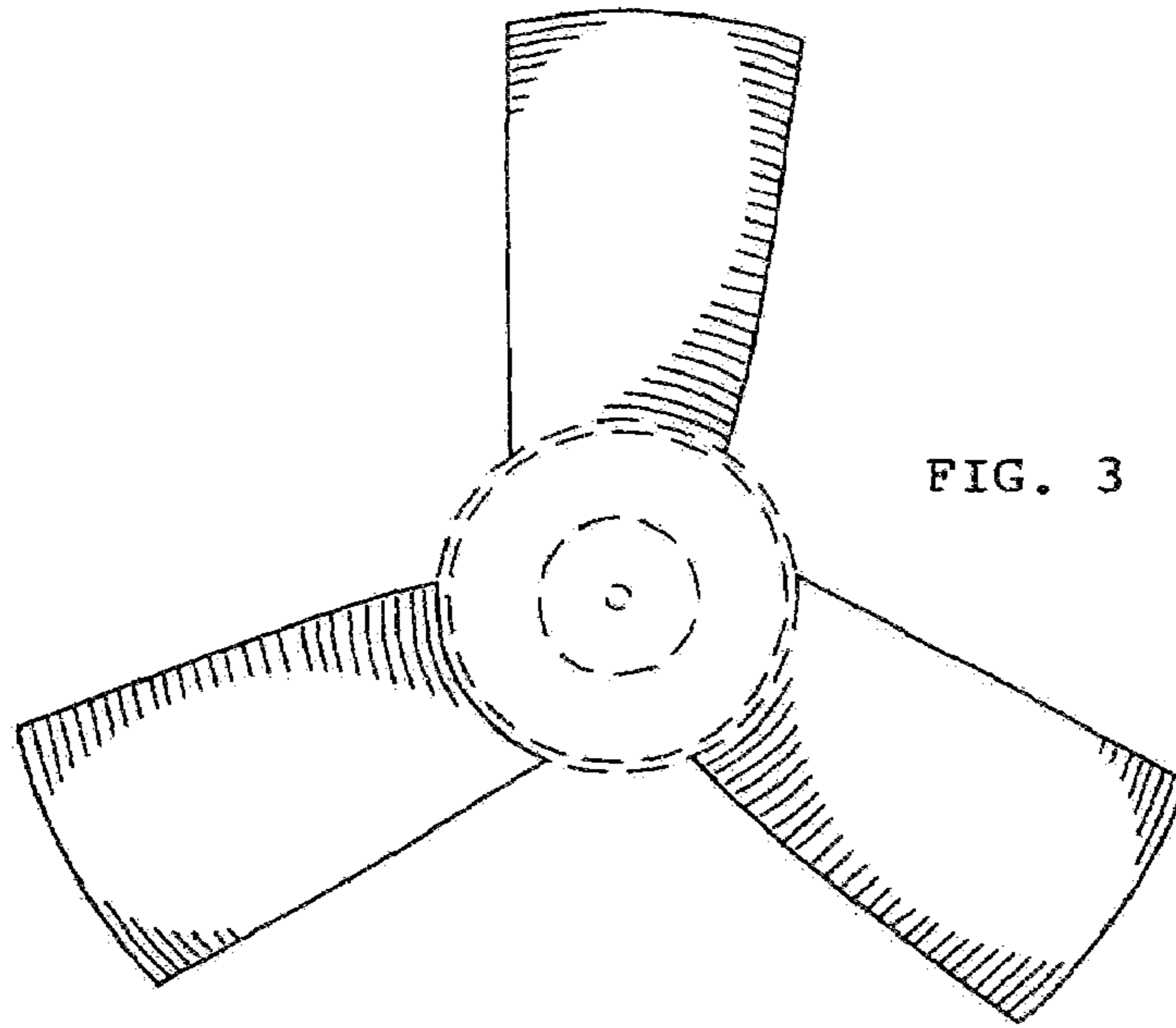

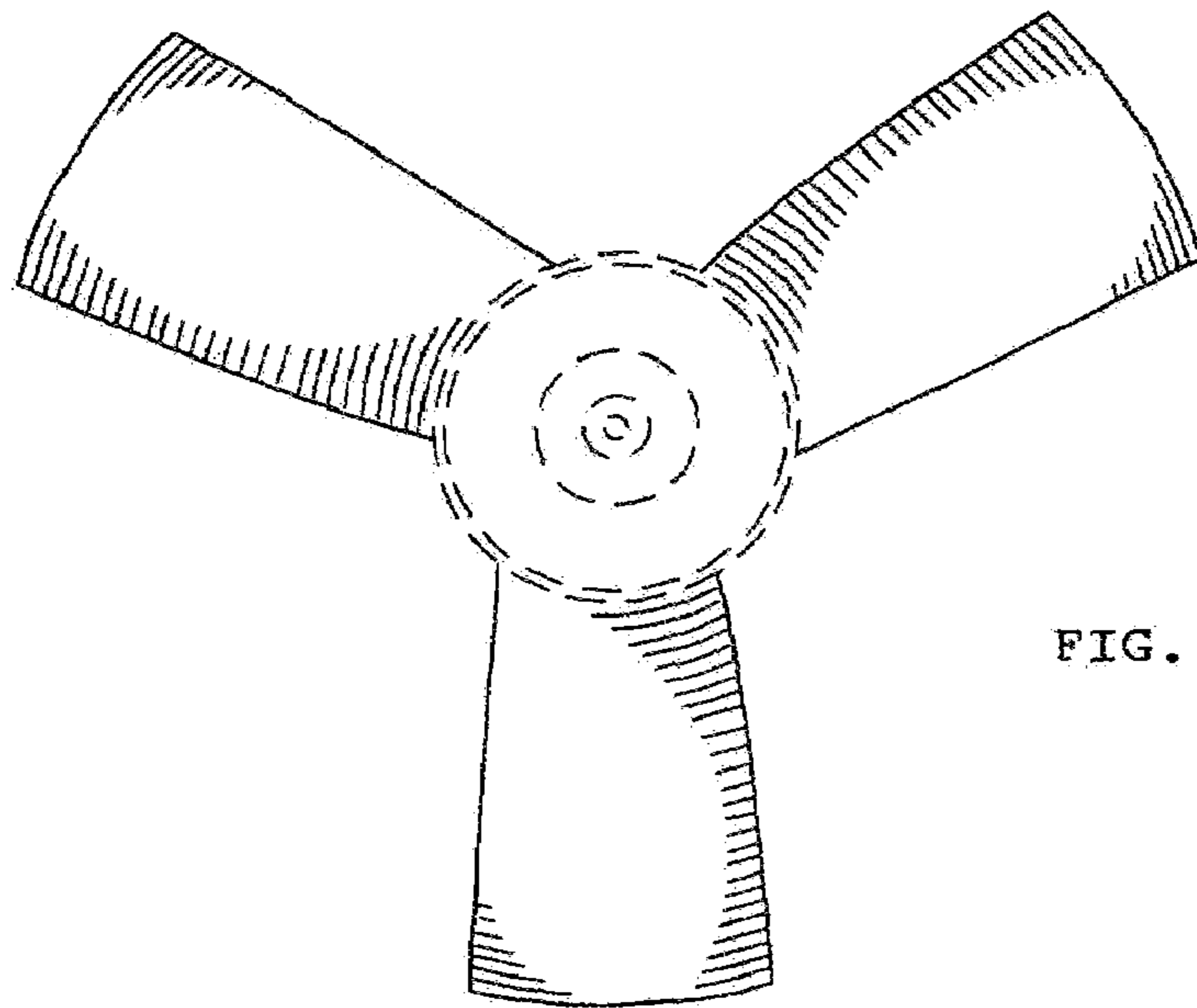

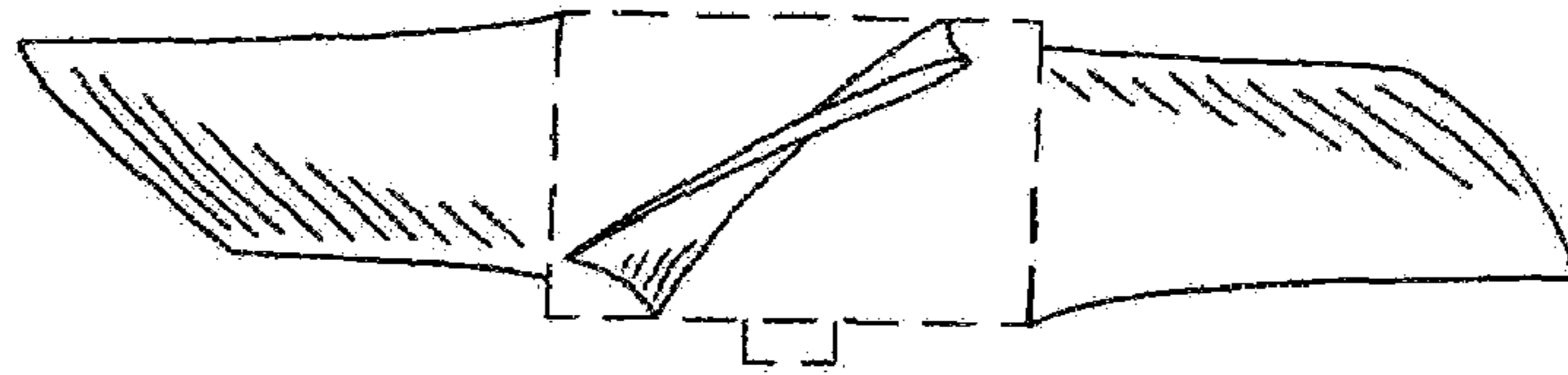

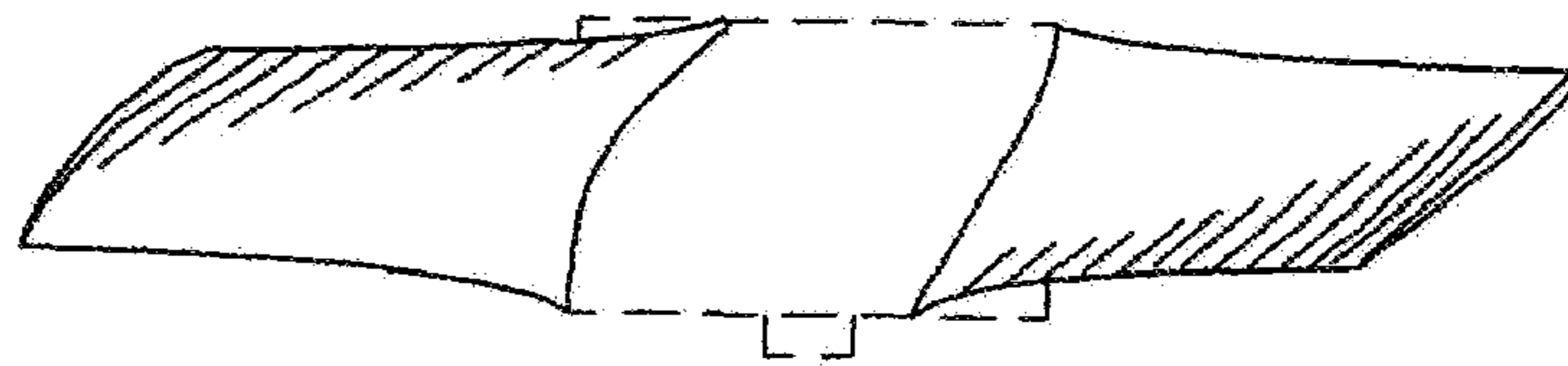

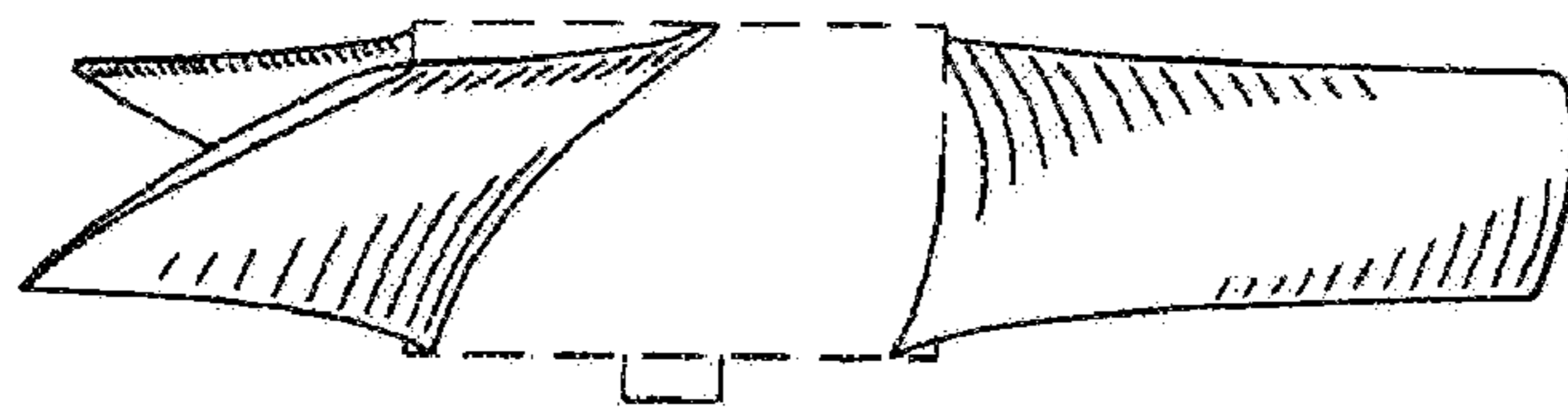

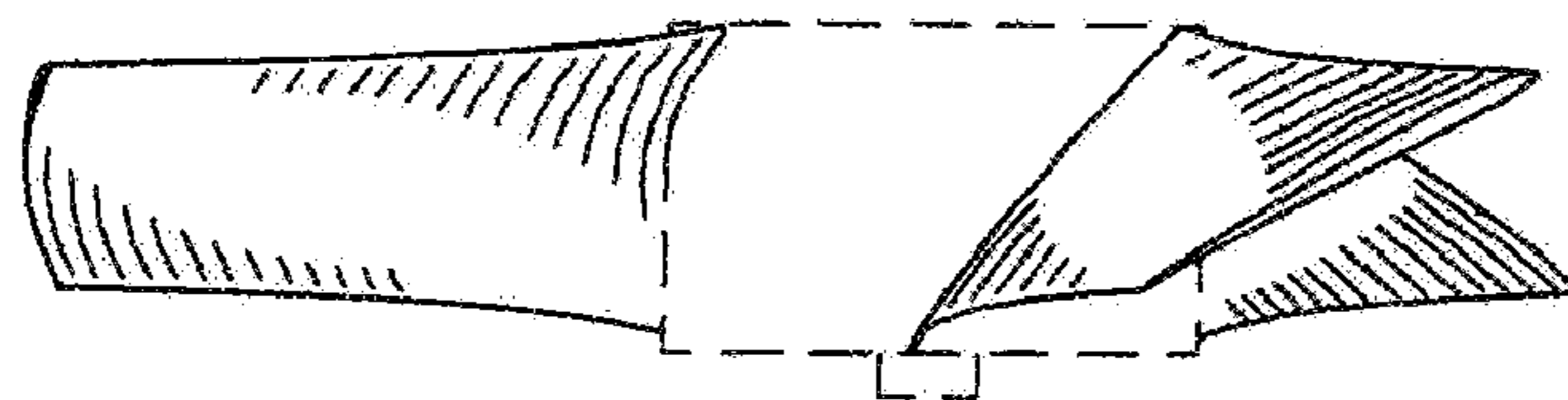

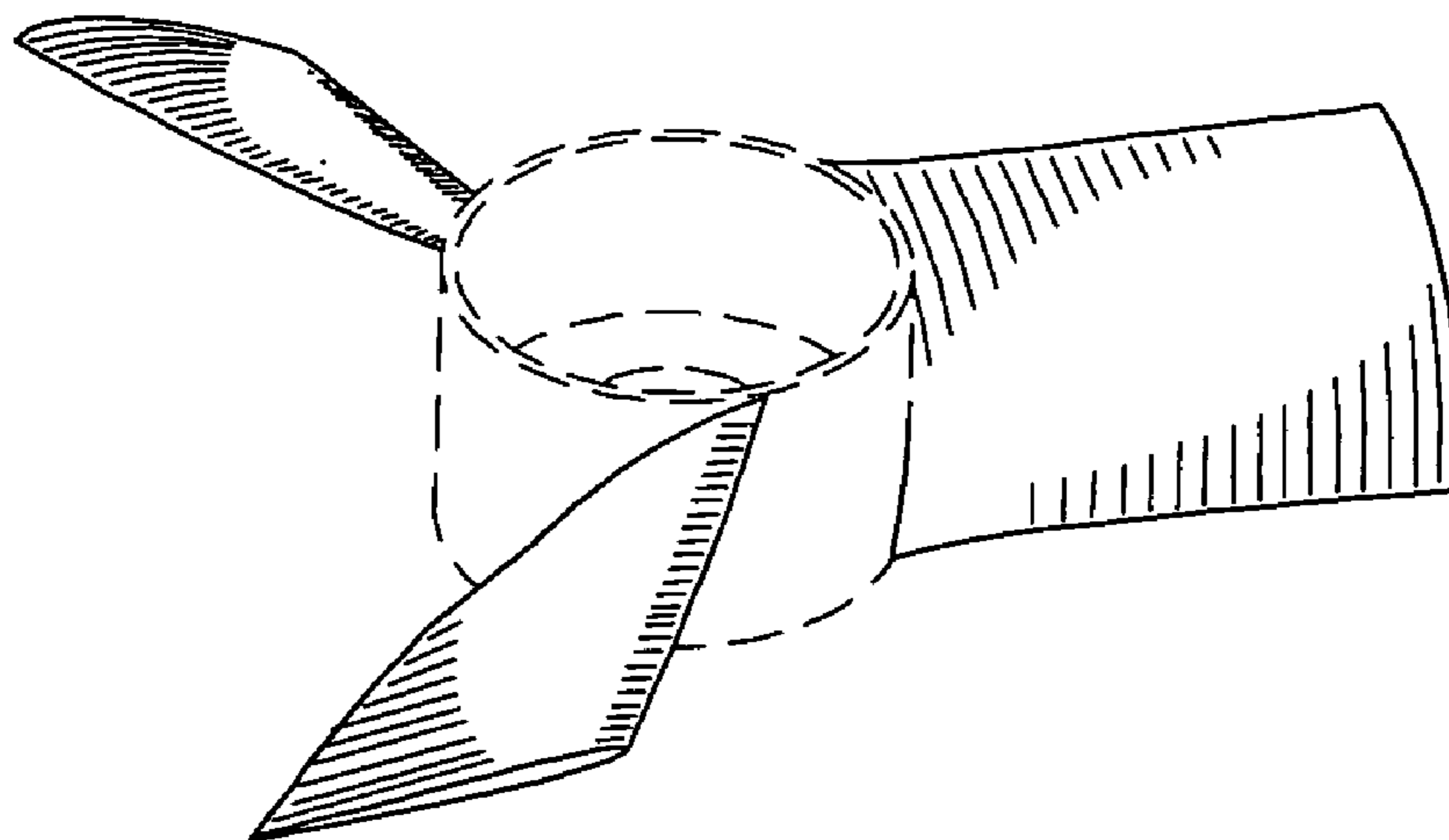
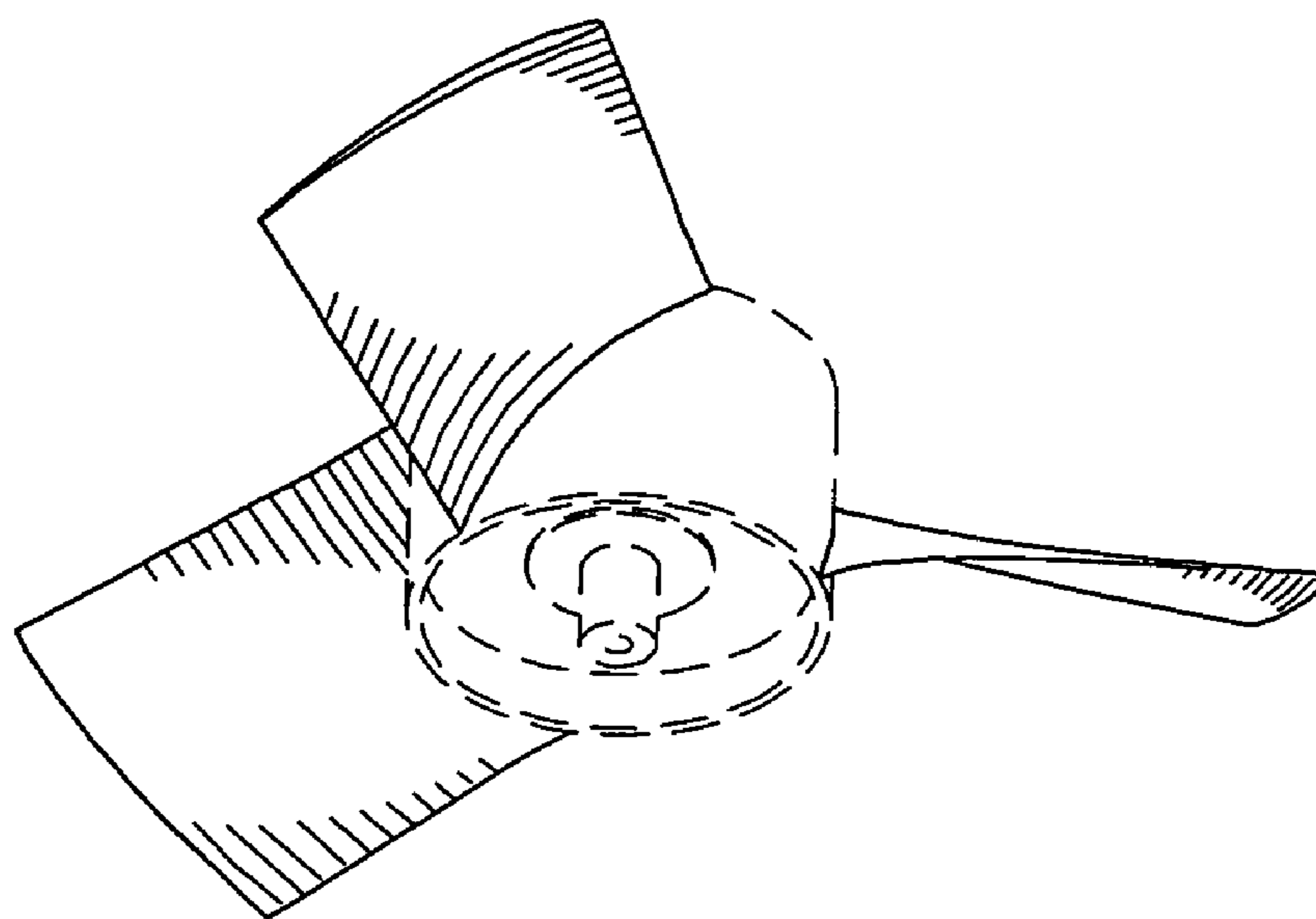

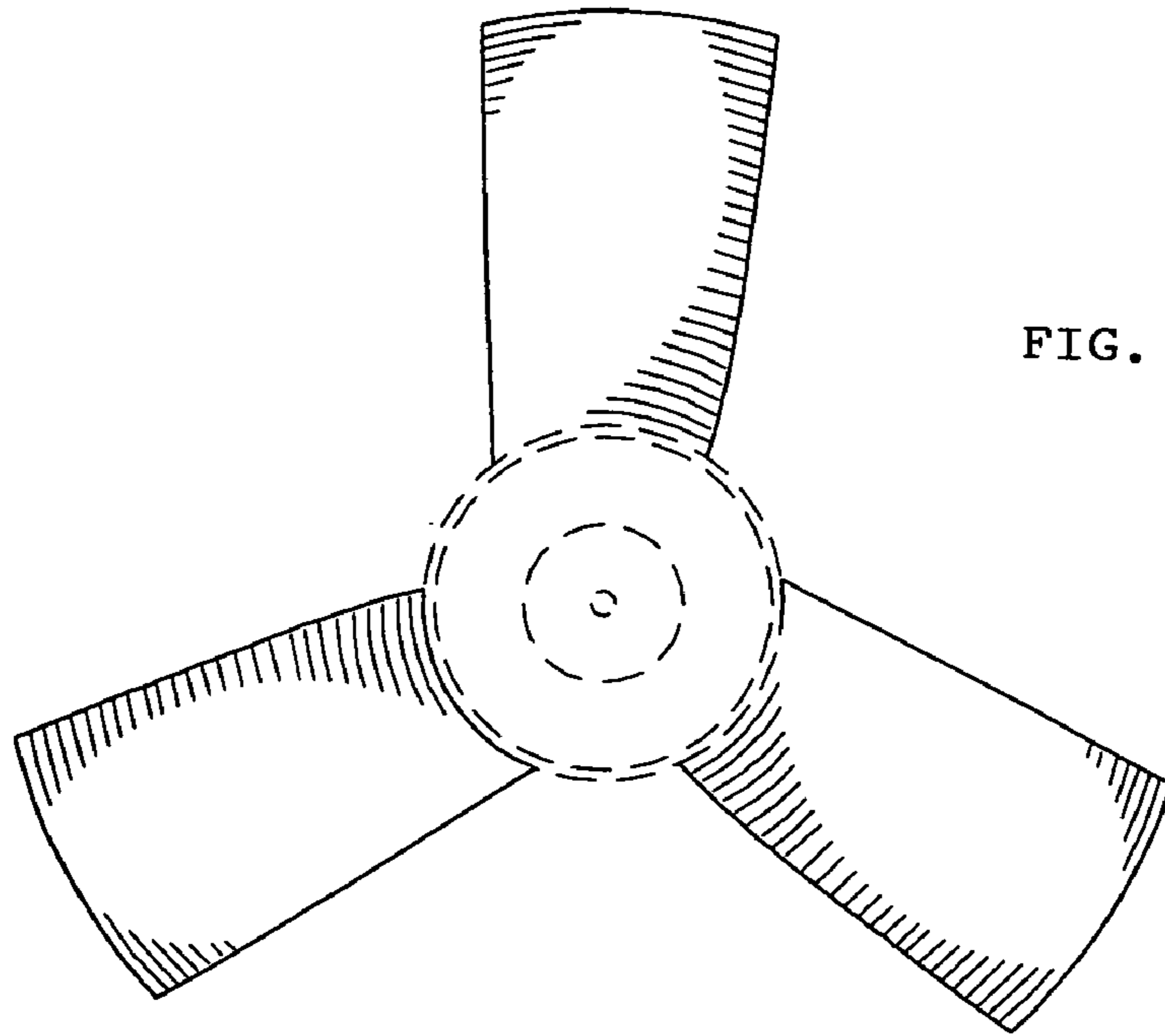

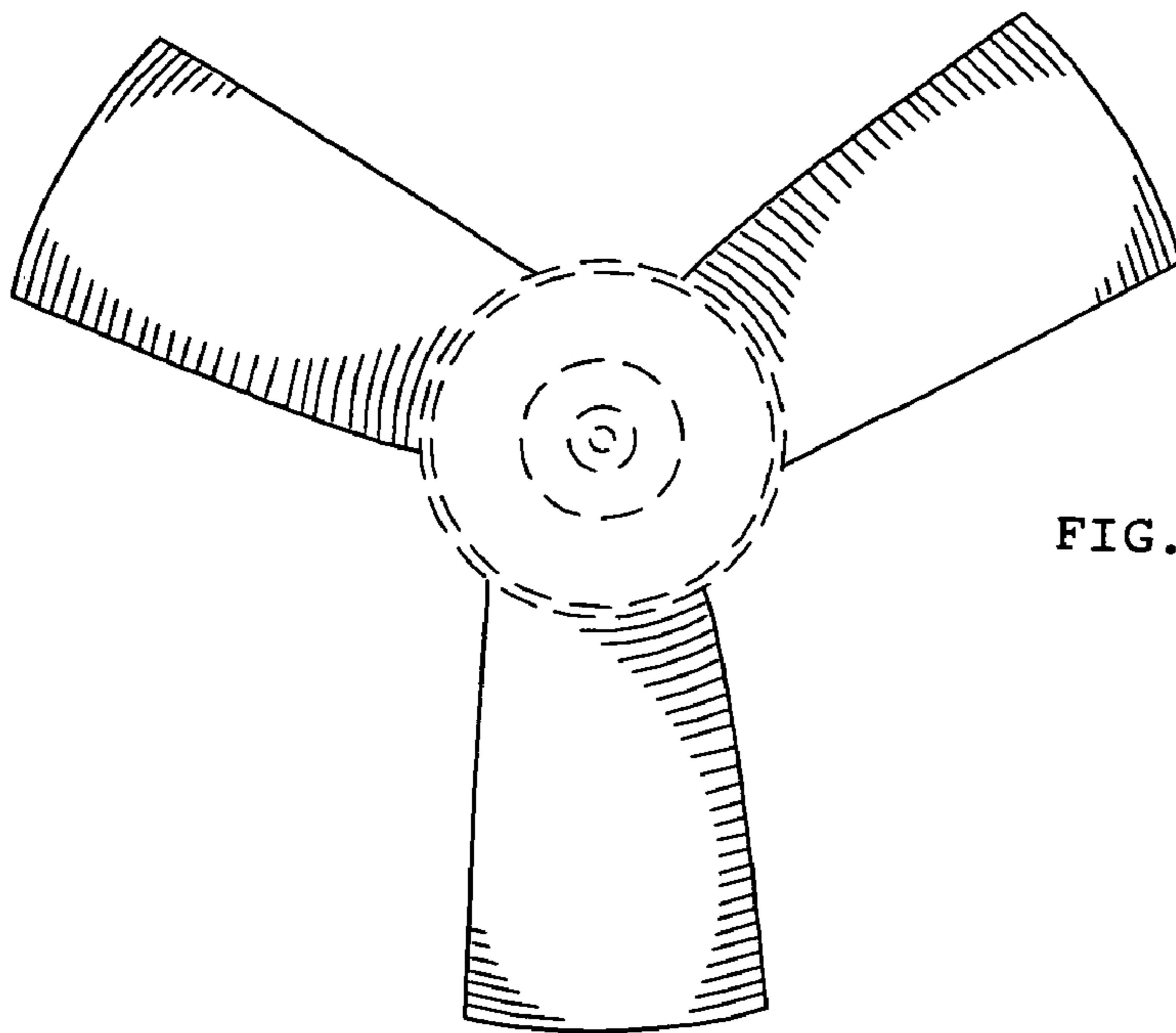

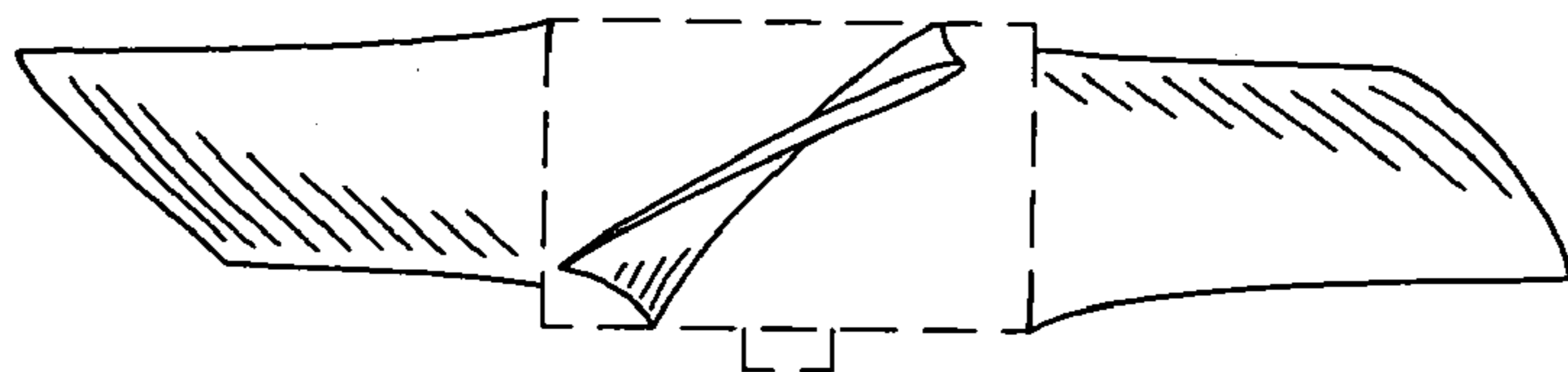

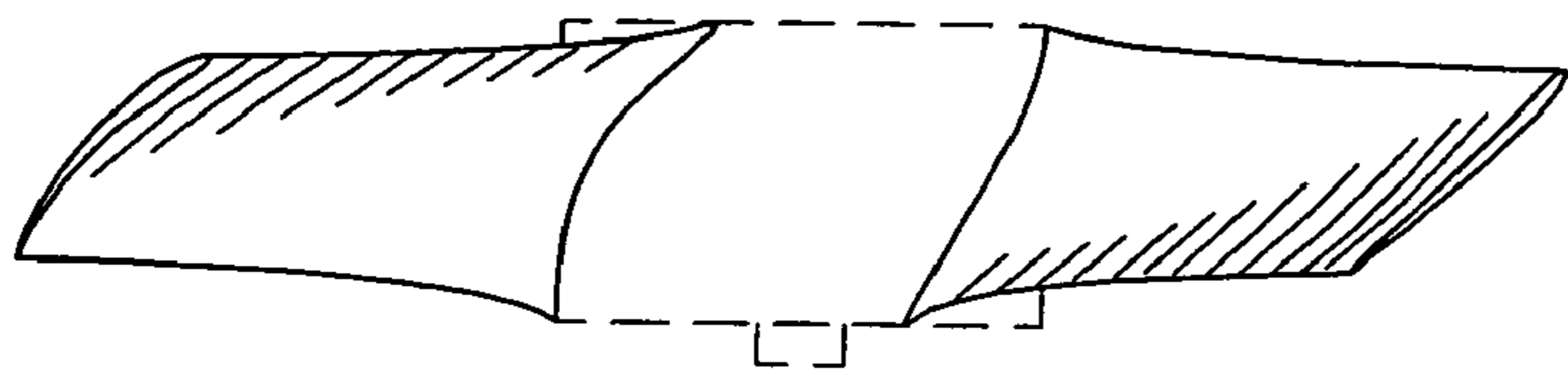

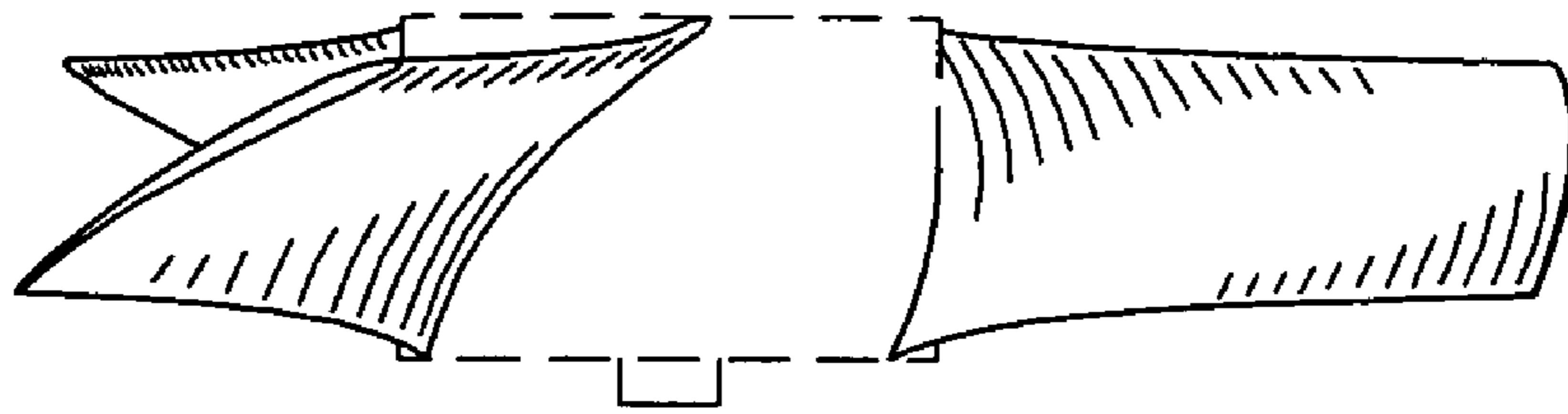
