**DESCRIPTION**

FIG. 1 is a front elevational view of an analgesic belt showing  
my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a plan view thereof, the bottom view being a mirror  
image of the plan view shown;

FIG. 4 is a right side view thereof;

FIG. 6 is a partial enlarged view of FIG. 1;

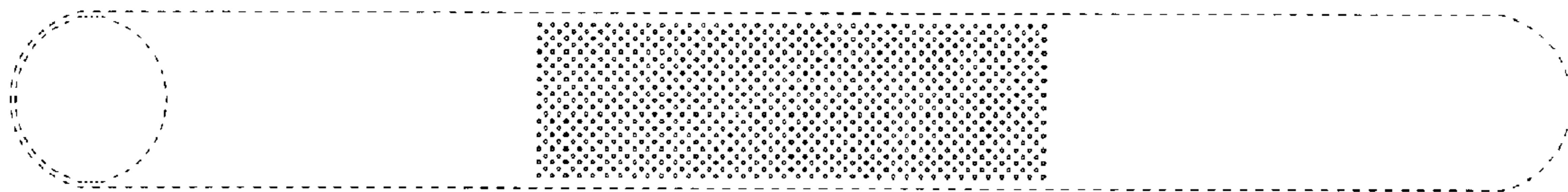
FIG. 7 is a partial enlarged view of FIG. 3;

FIG. 8 is an enlarged right side view thereof; and,

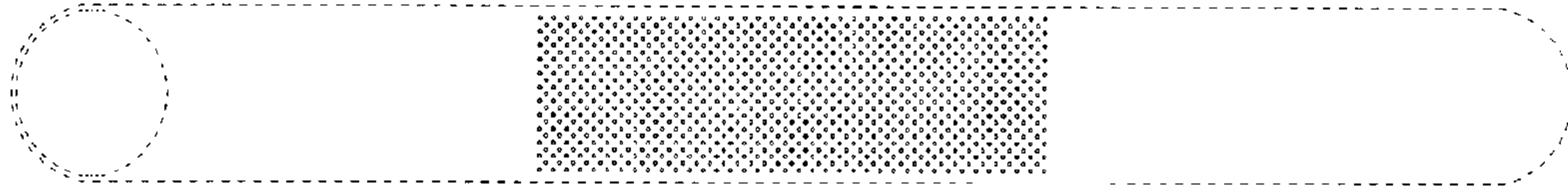
FIG. 9 is an enlarged cross-sectional view taken along a line

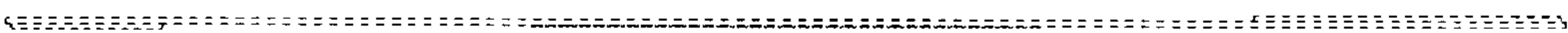

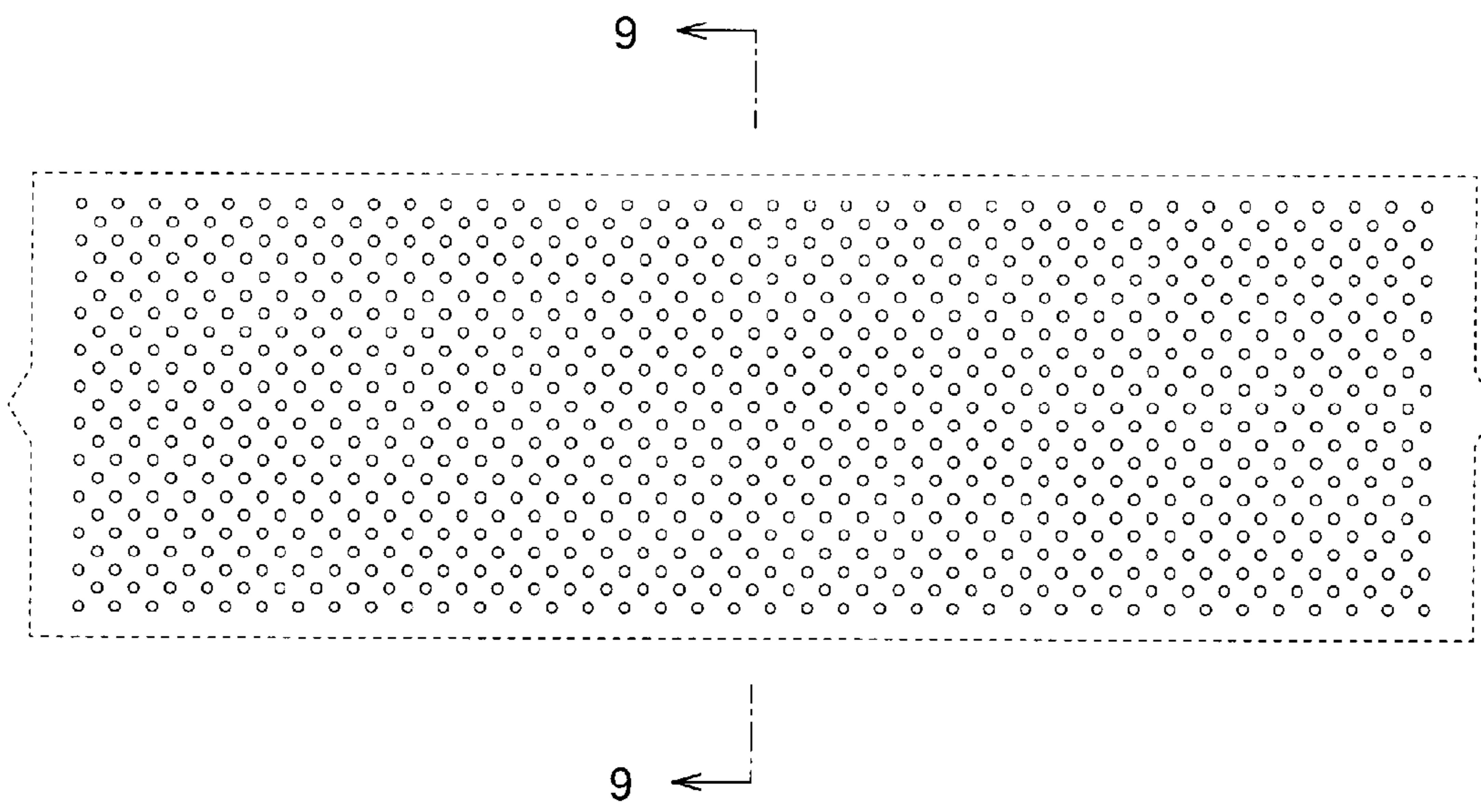

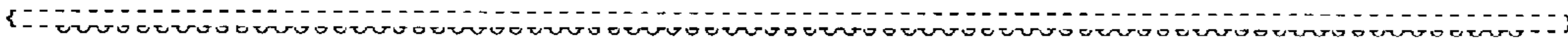

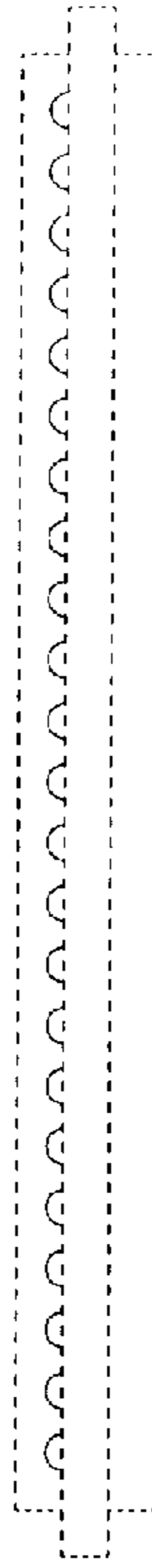
