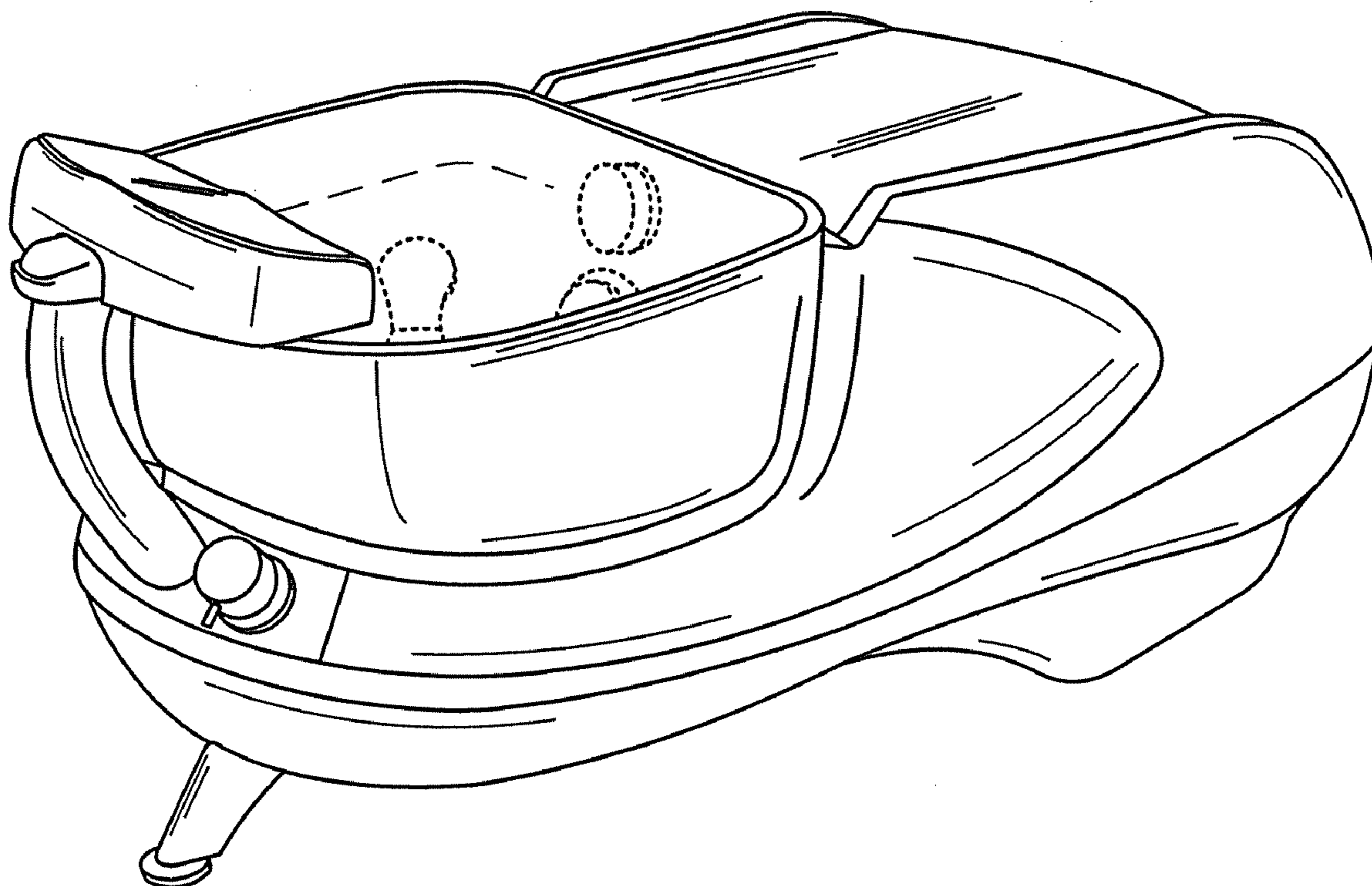
FIG. 4 is a top view of the pedicure spa, such as that shown in FIG. 1;

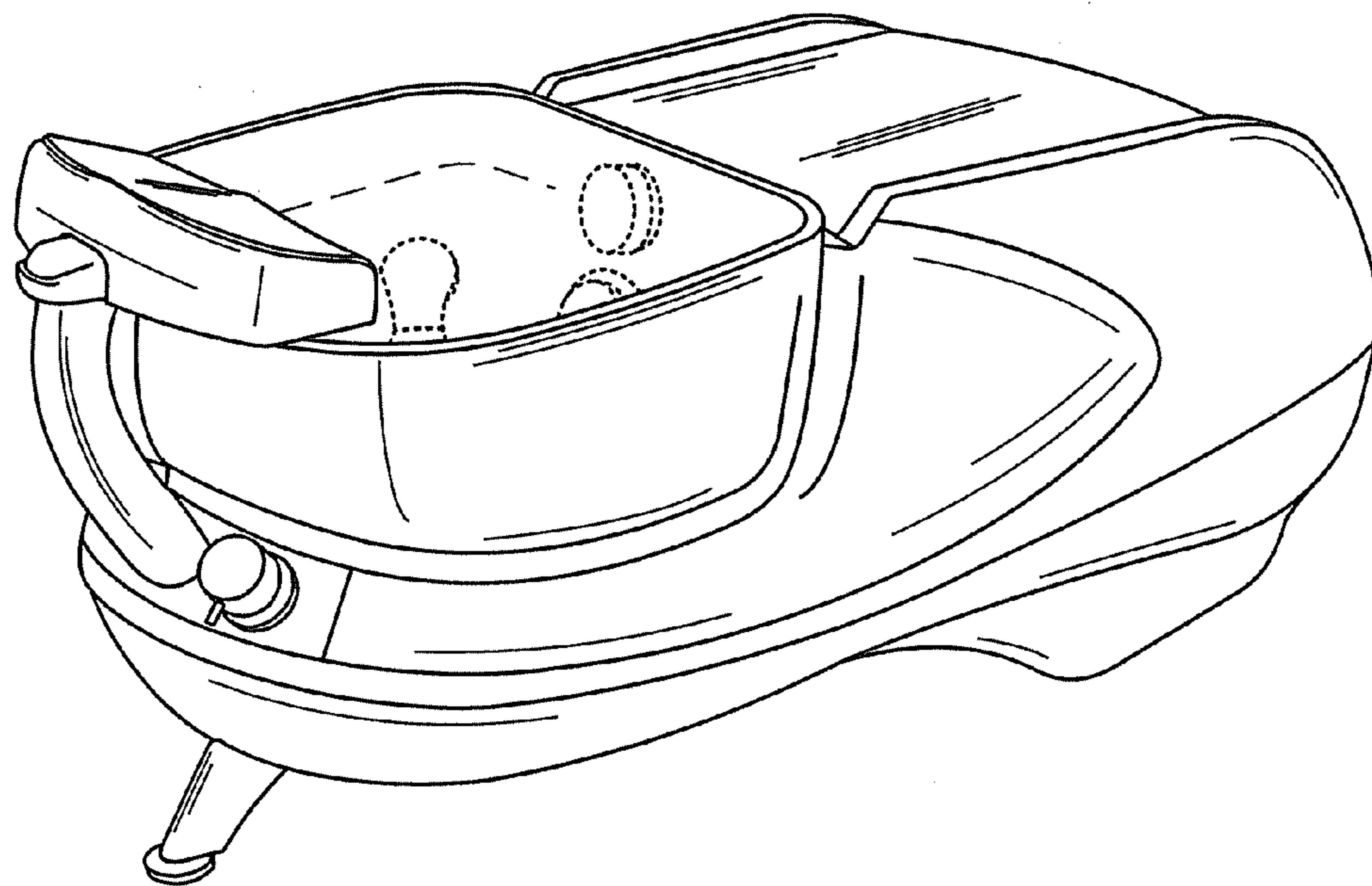

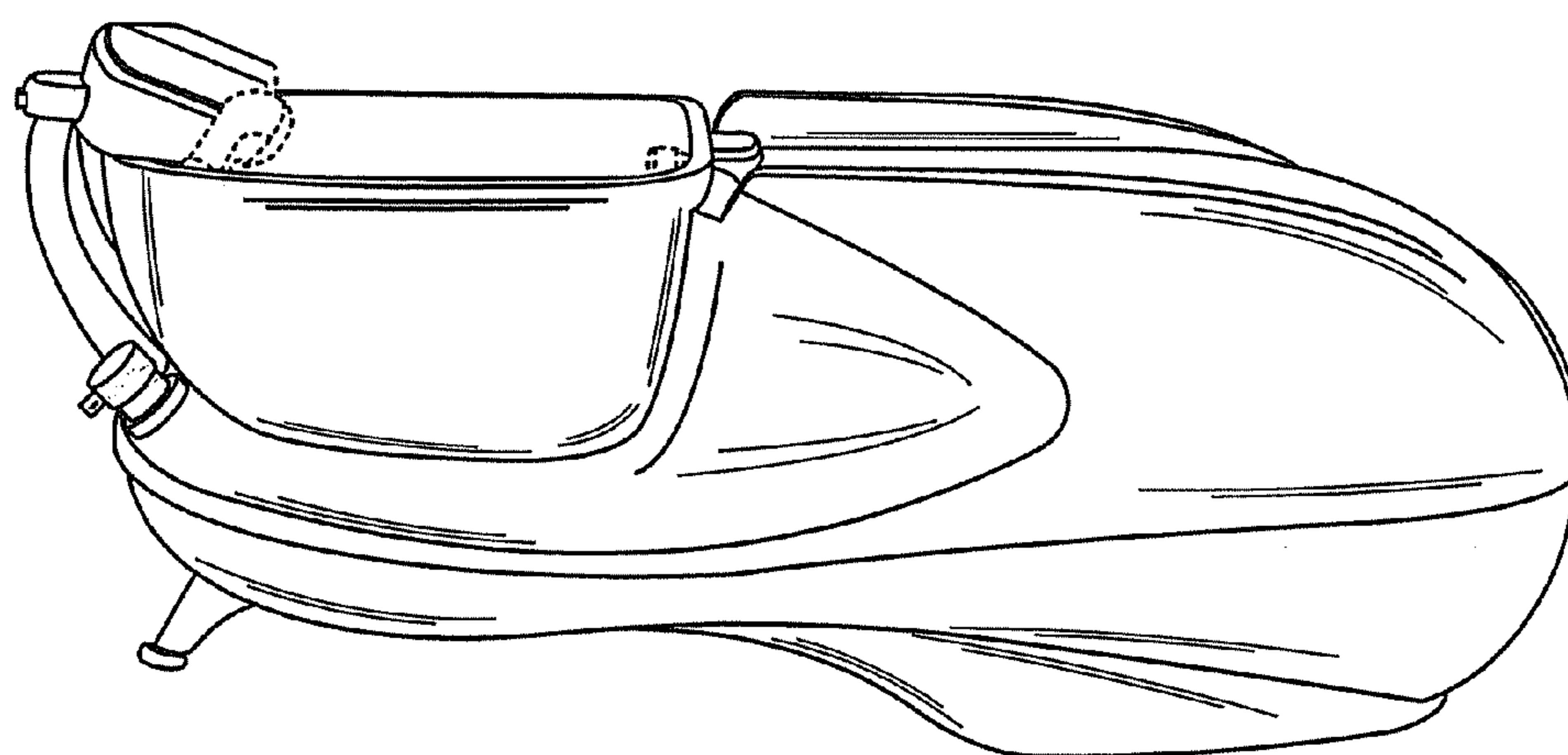

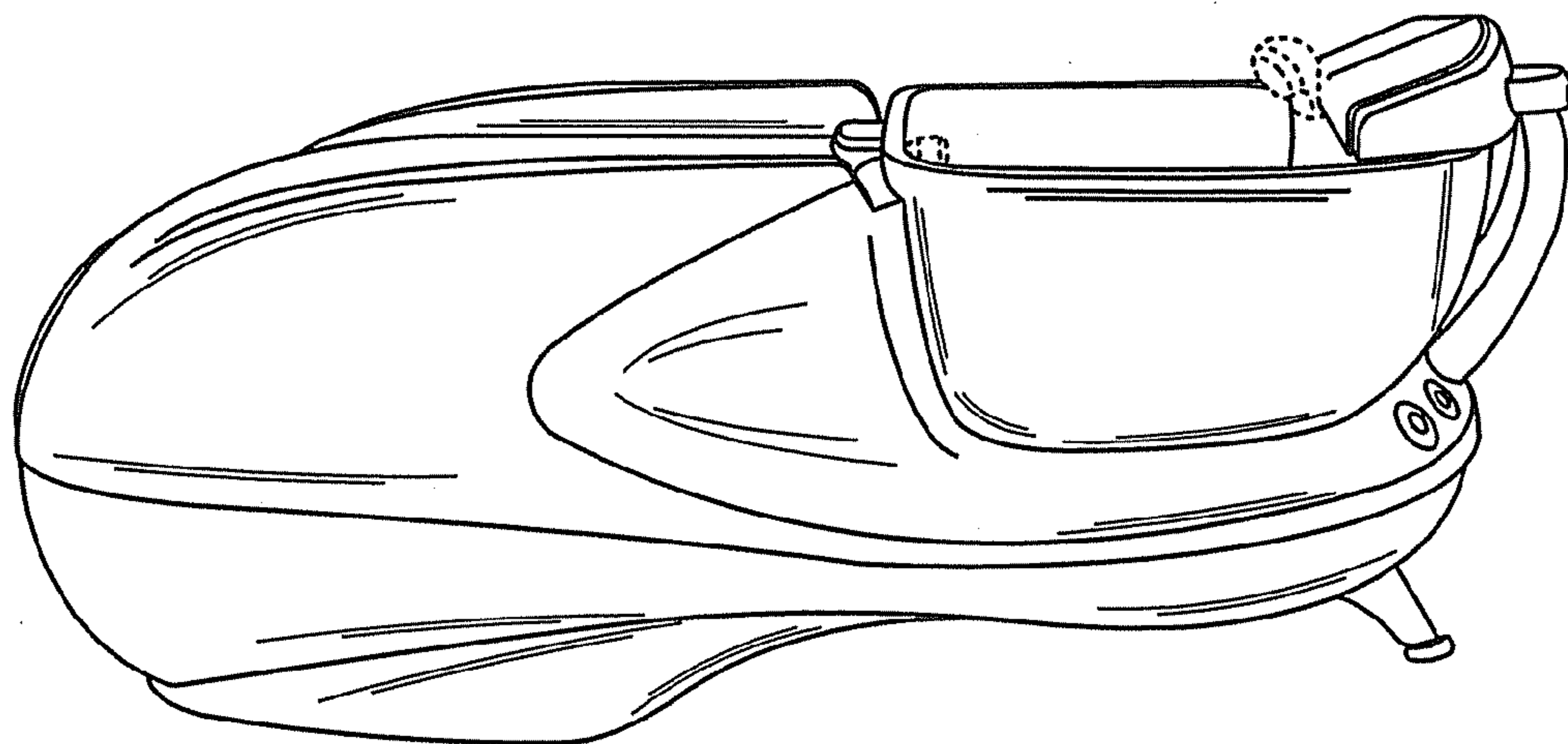

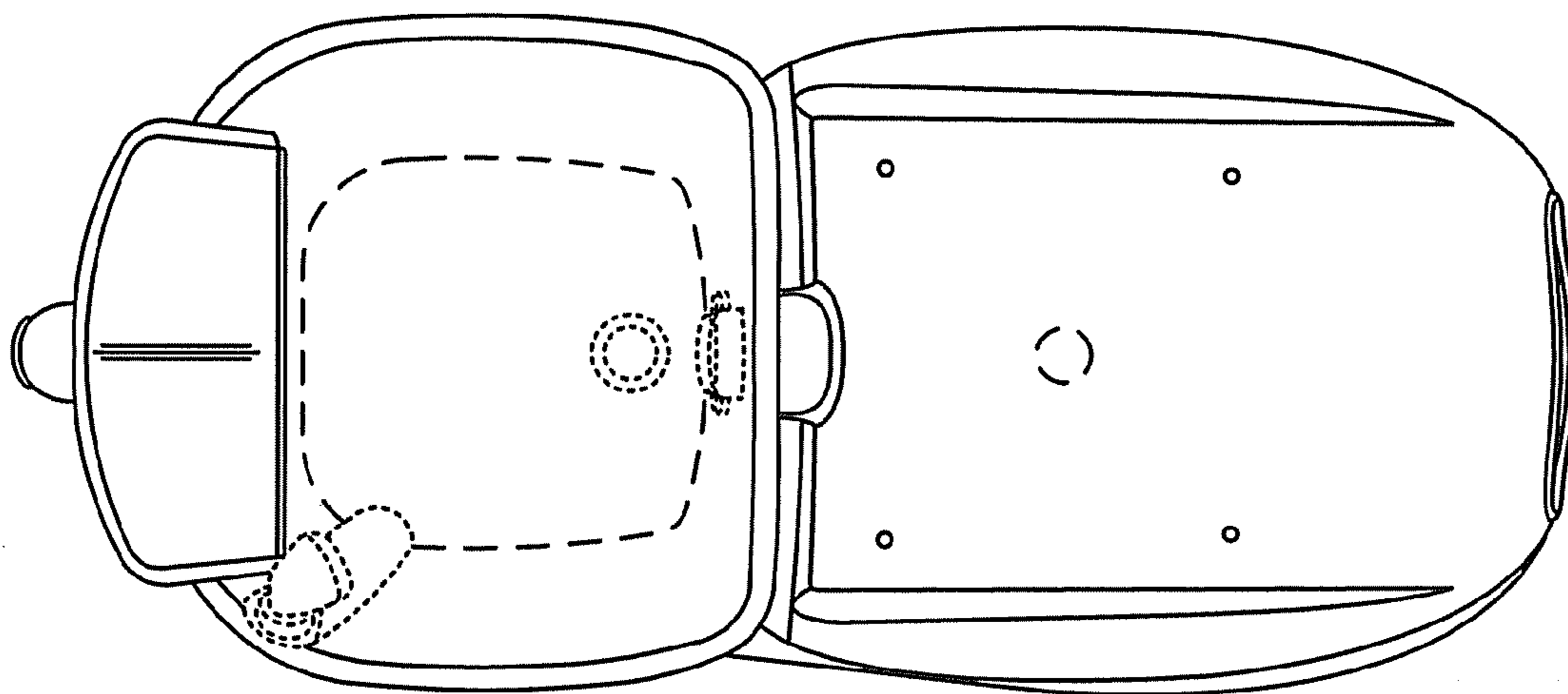

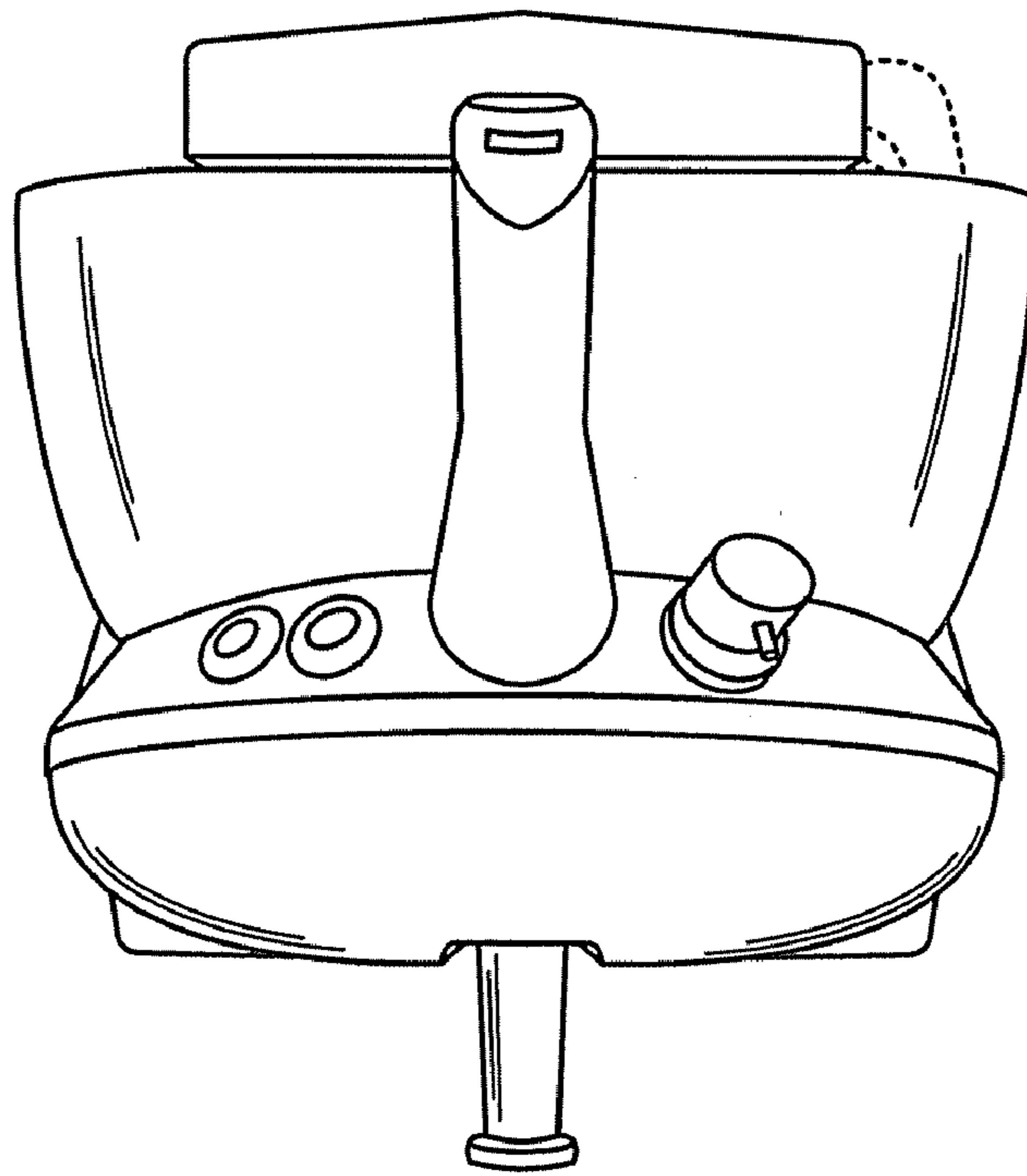

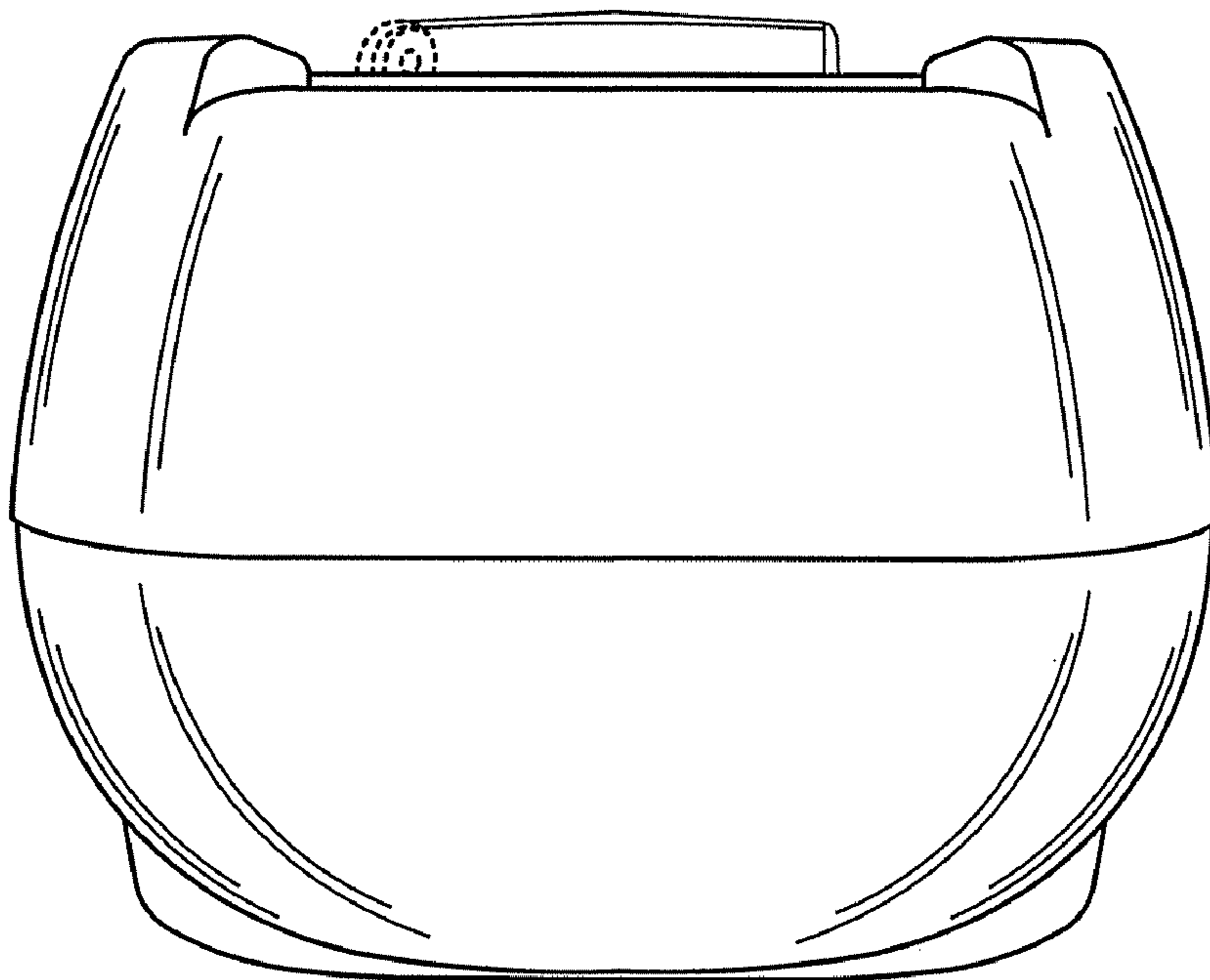
