FIG. 31 is a right side view of the fifth embodiment;

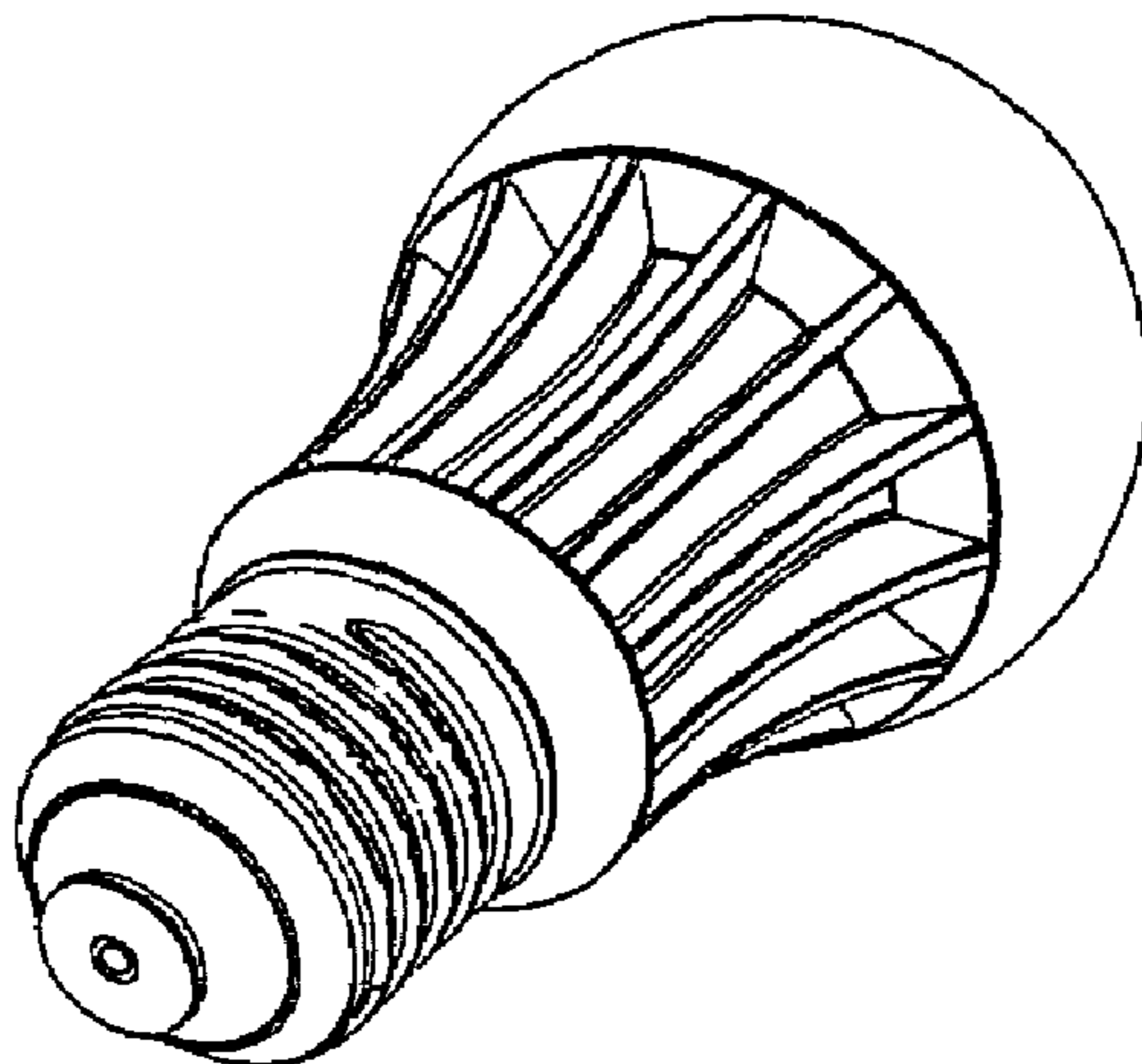
FIG. 32 is a back view of the fifth embodiment;

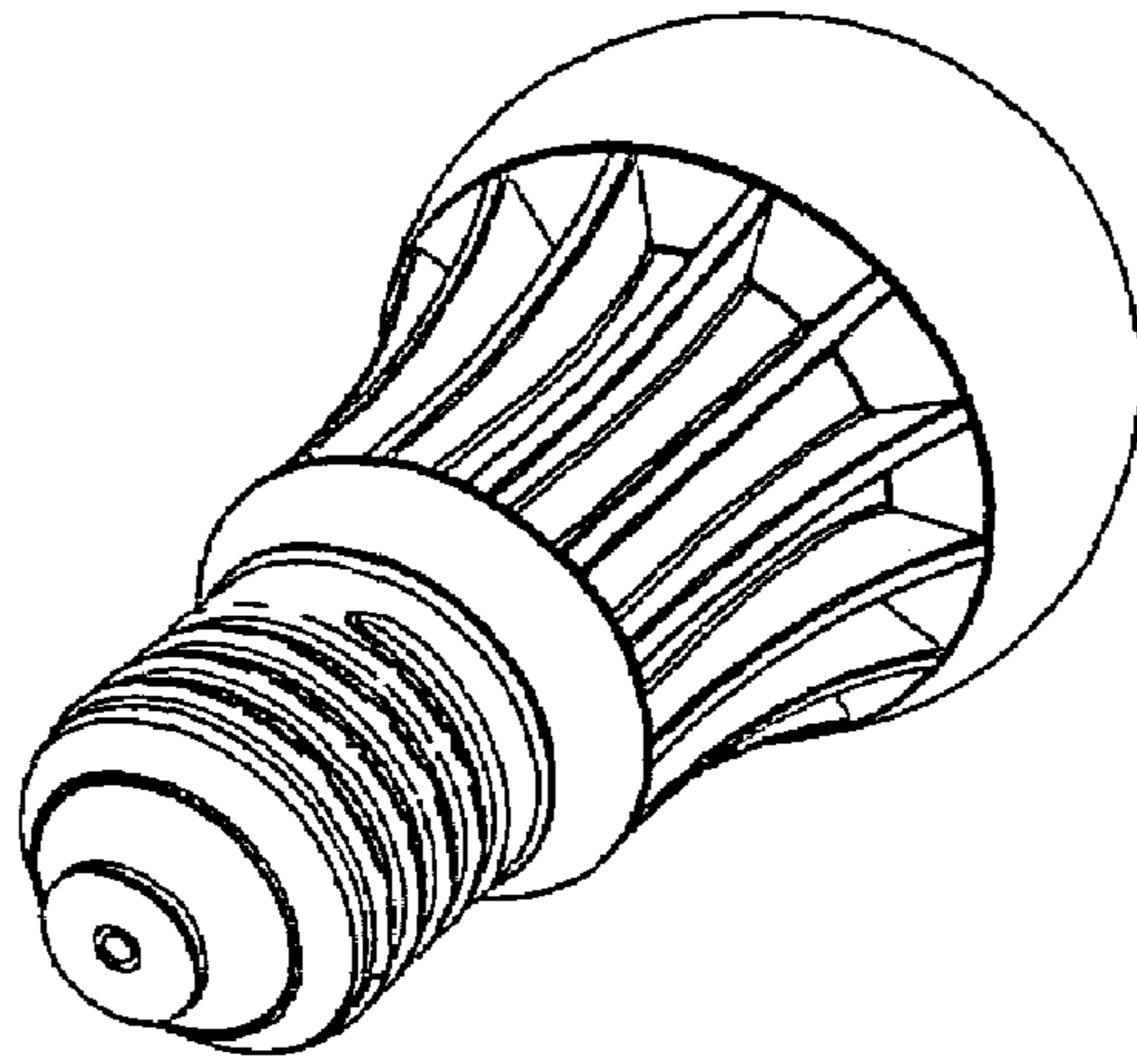

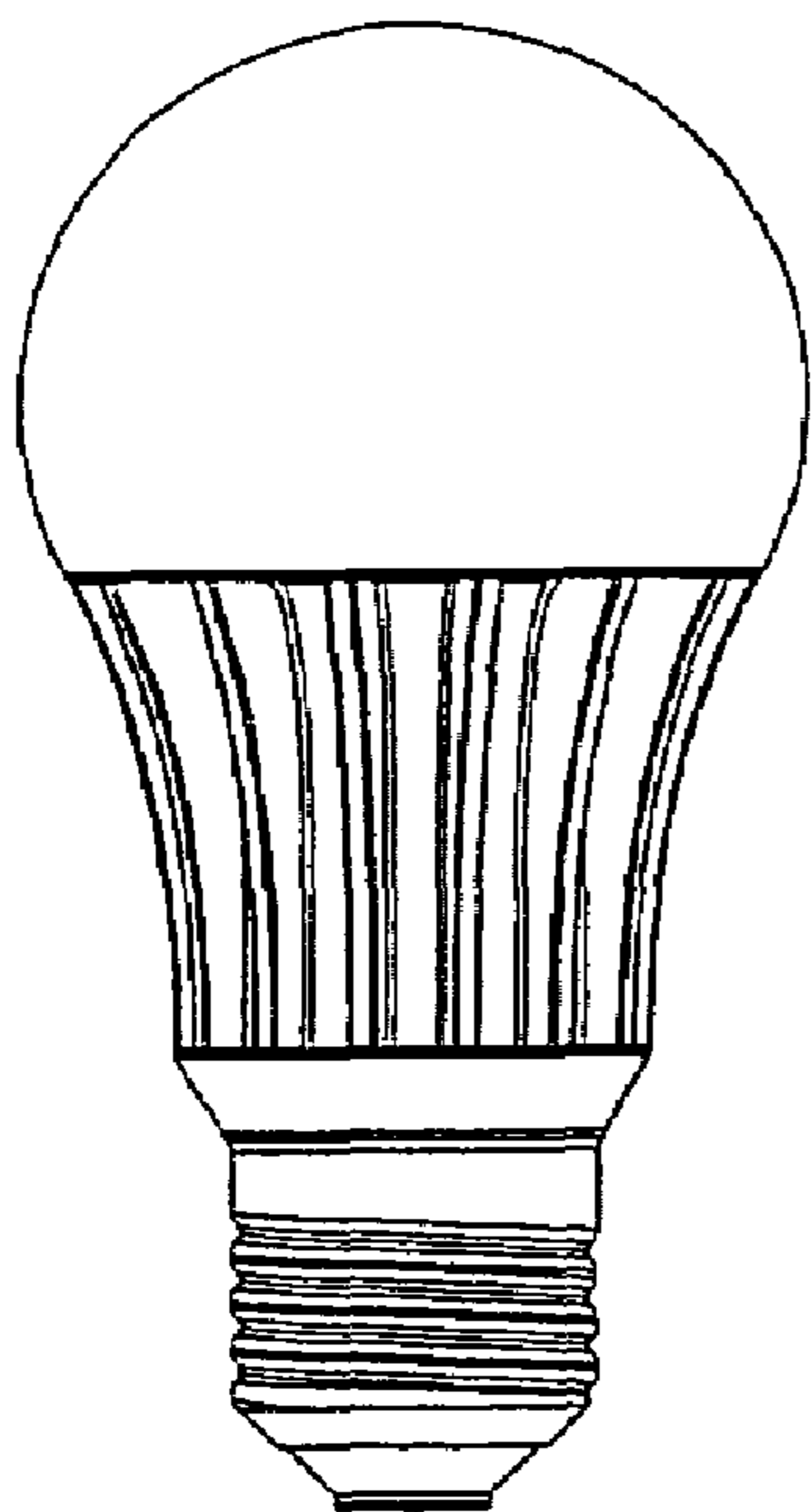

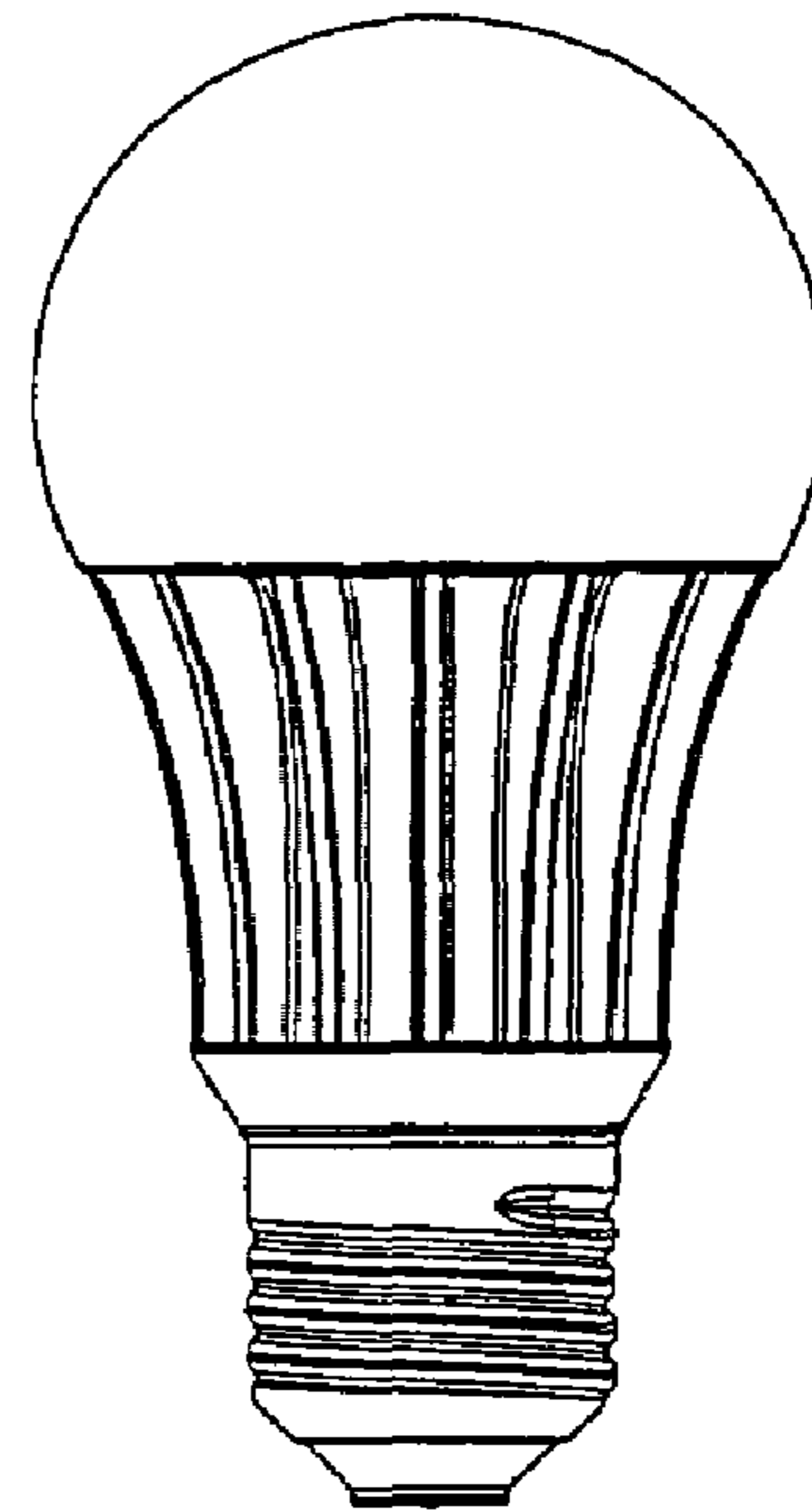

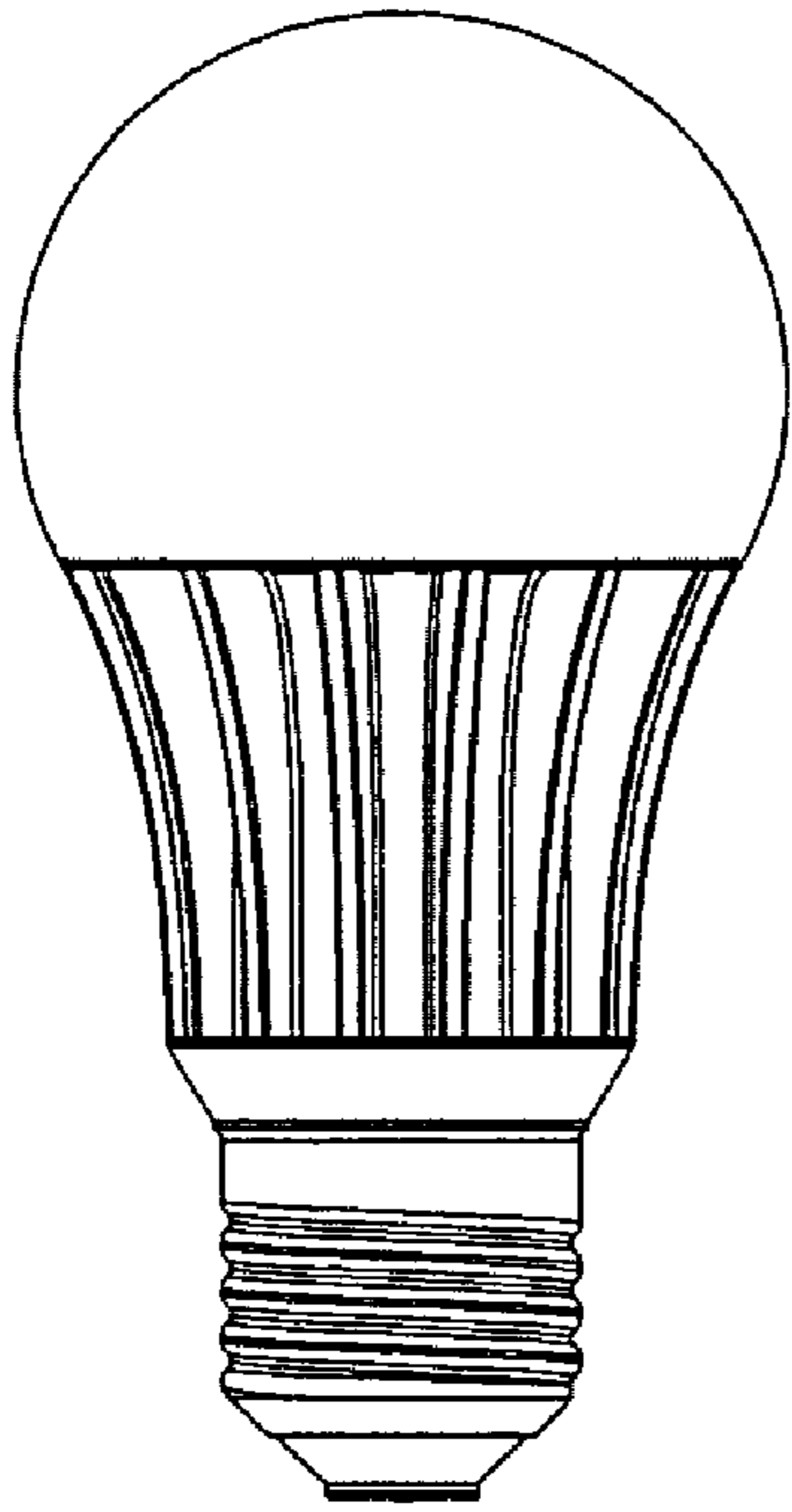

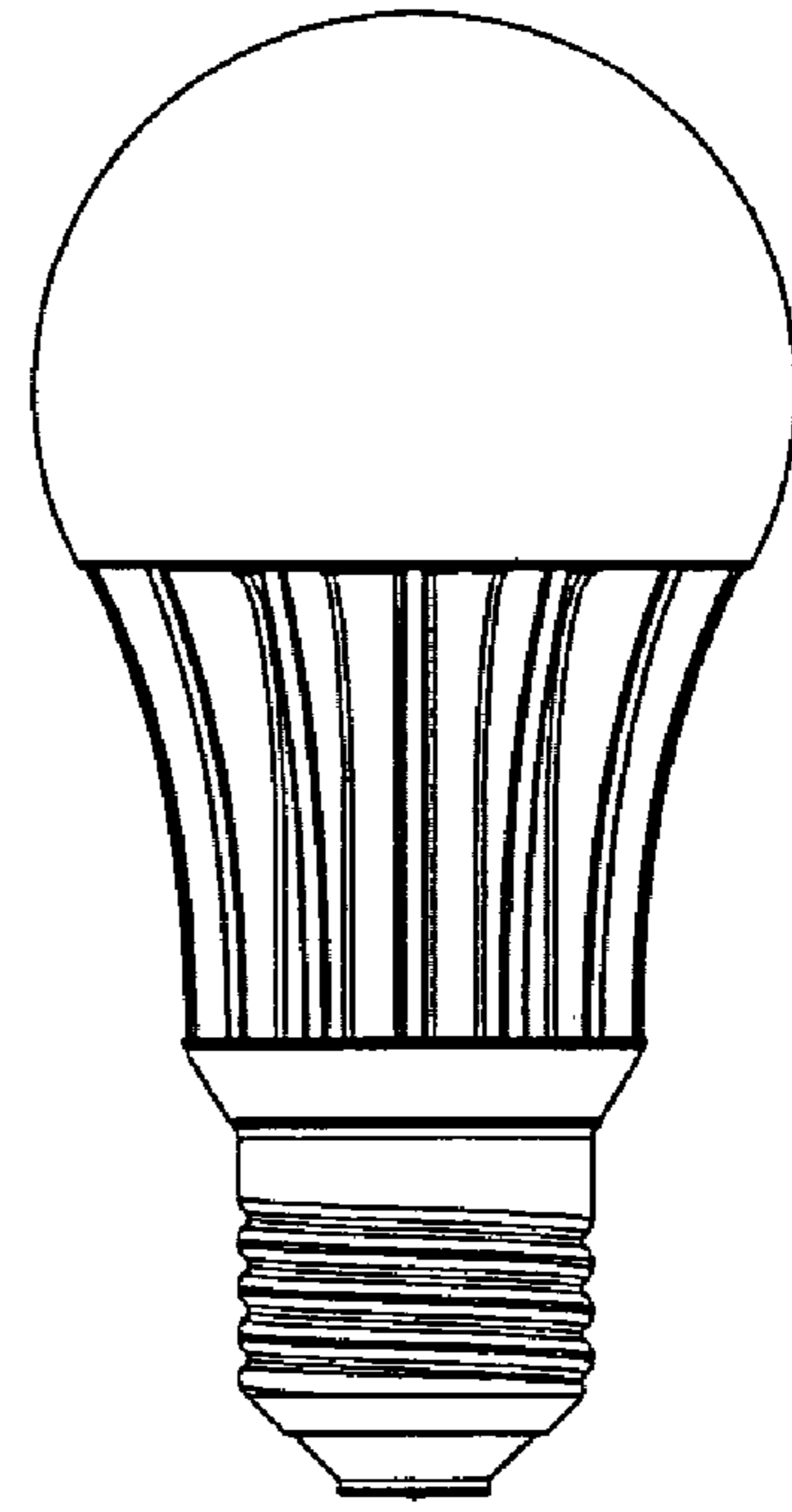

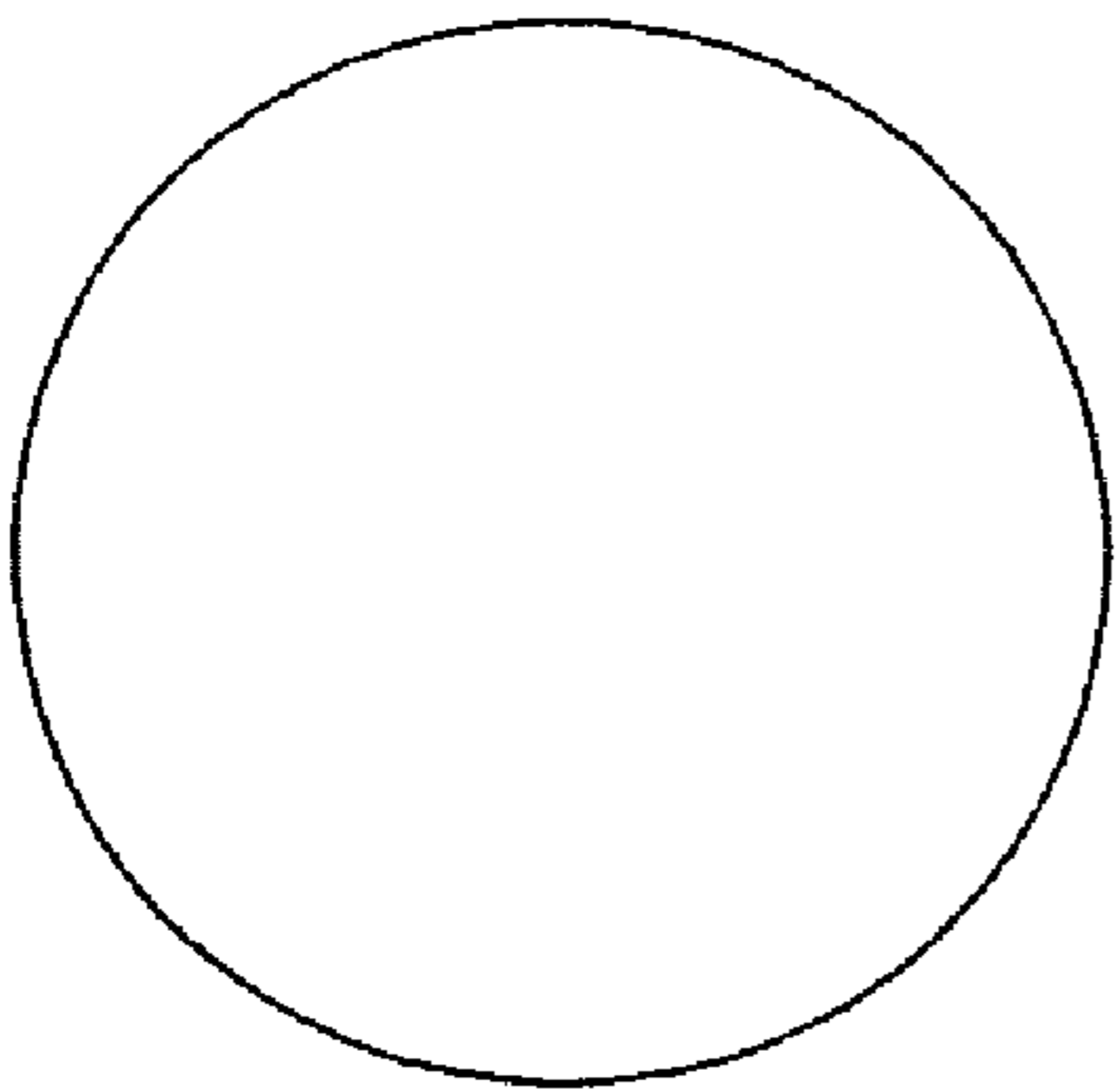

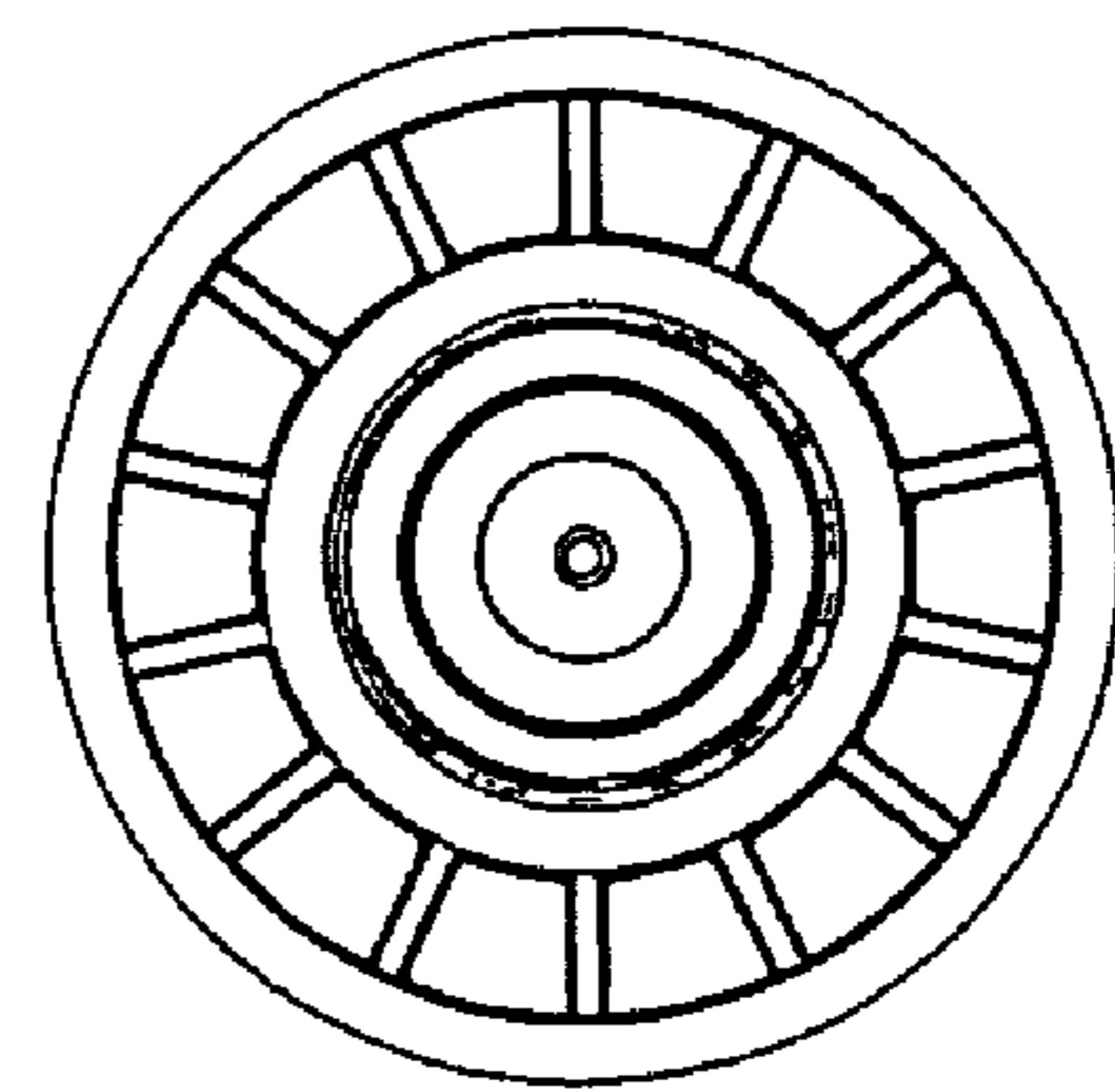

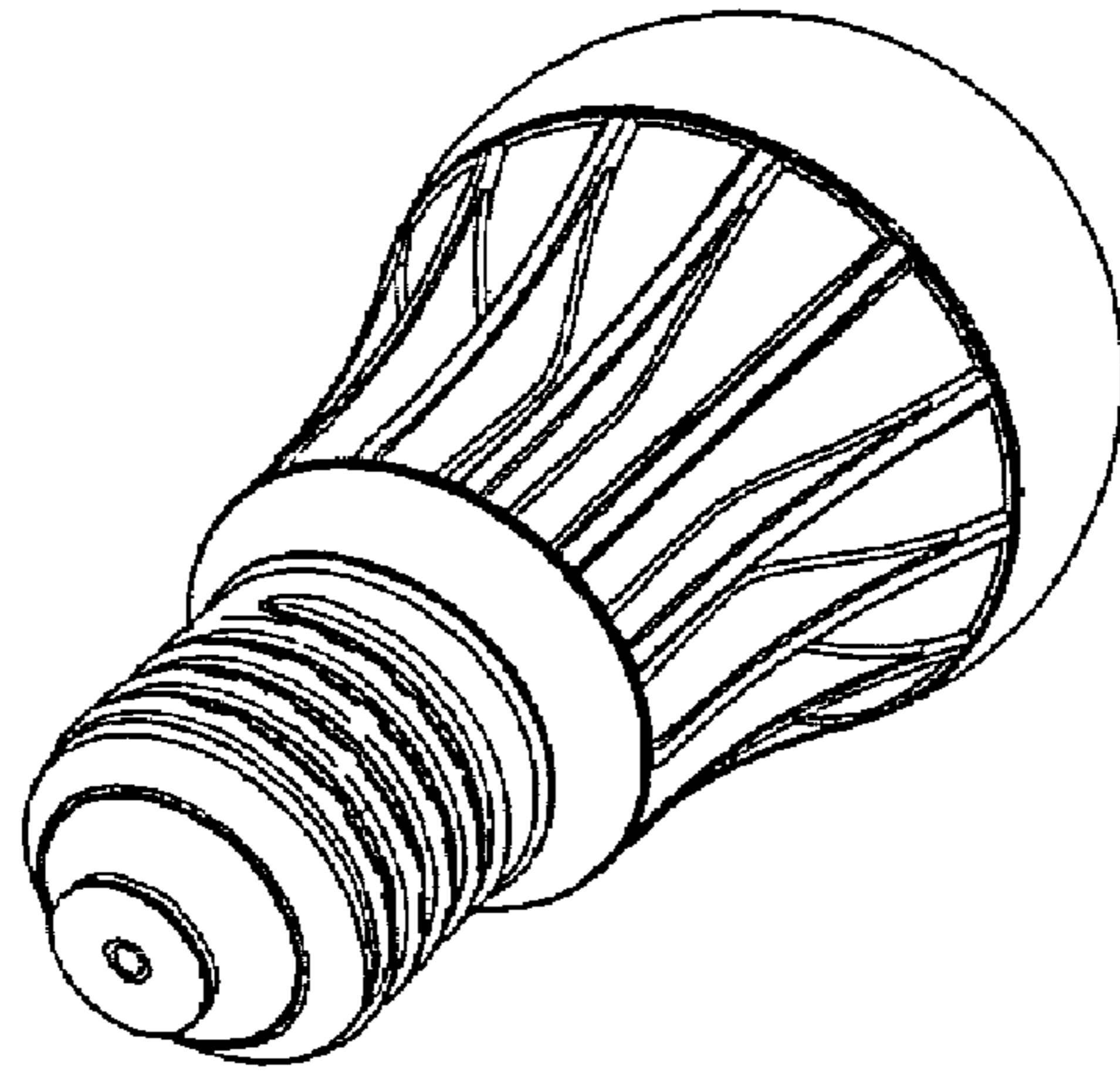

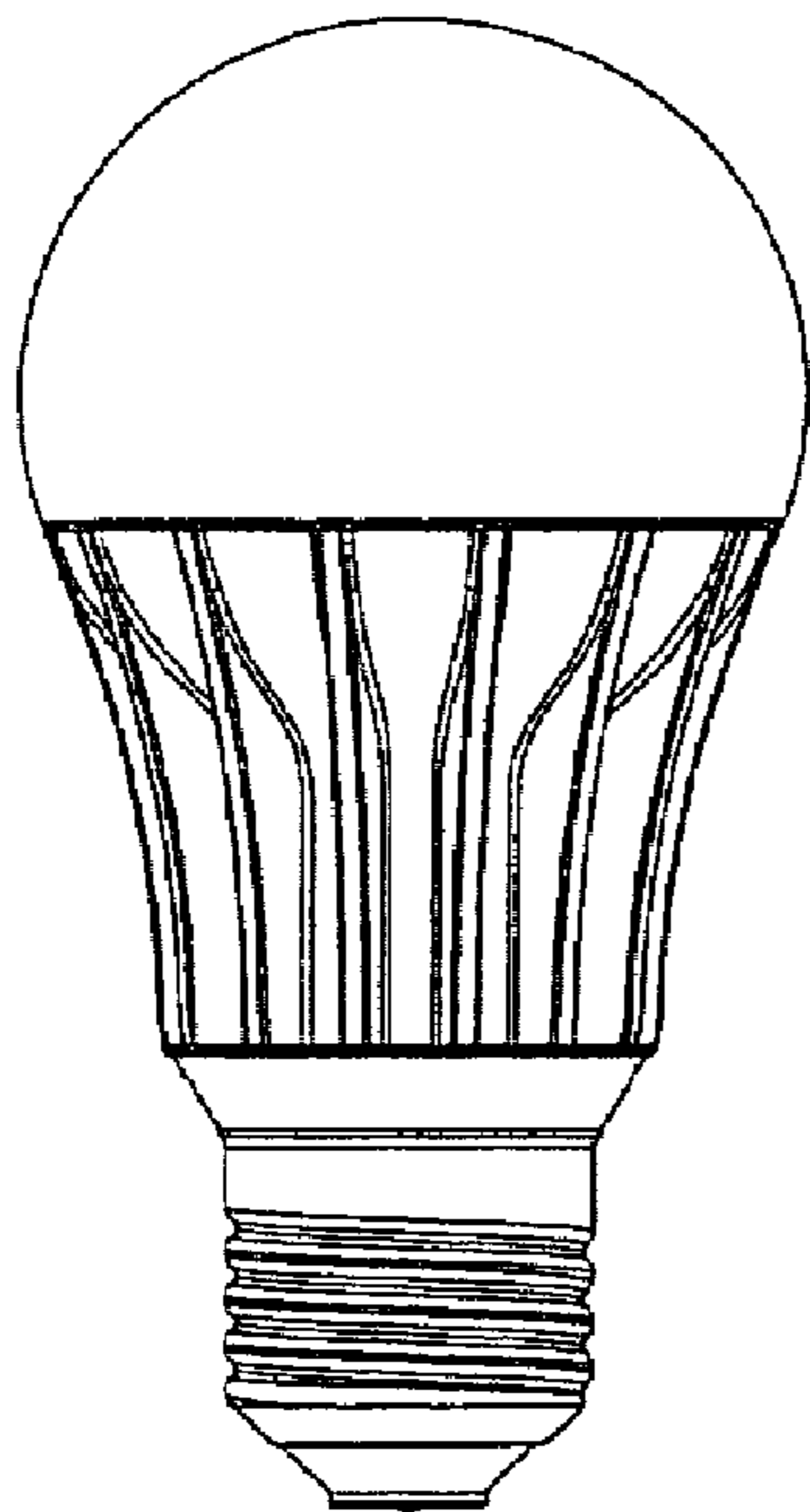

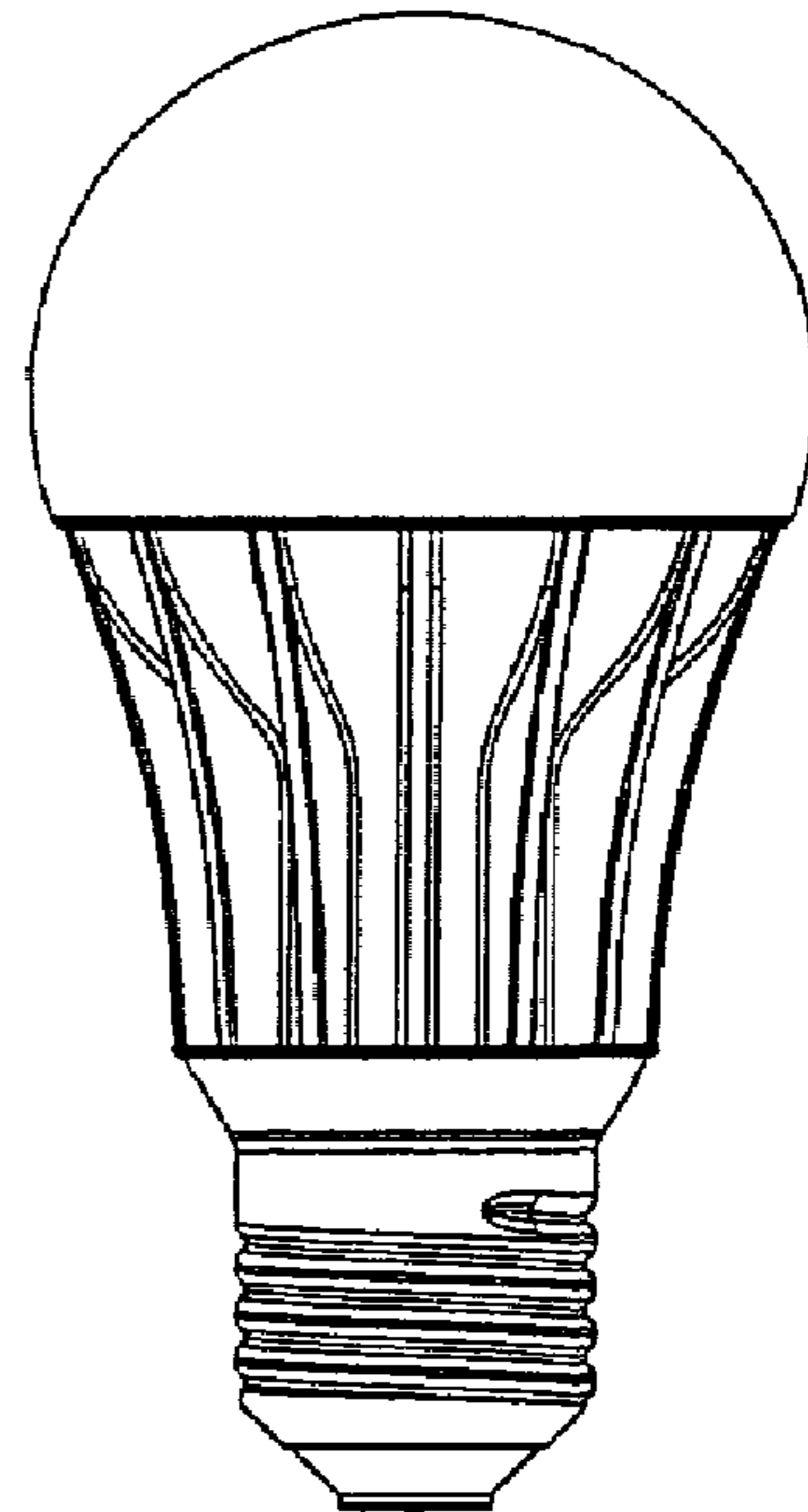

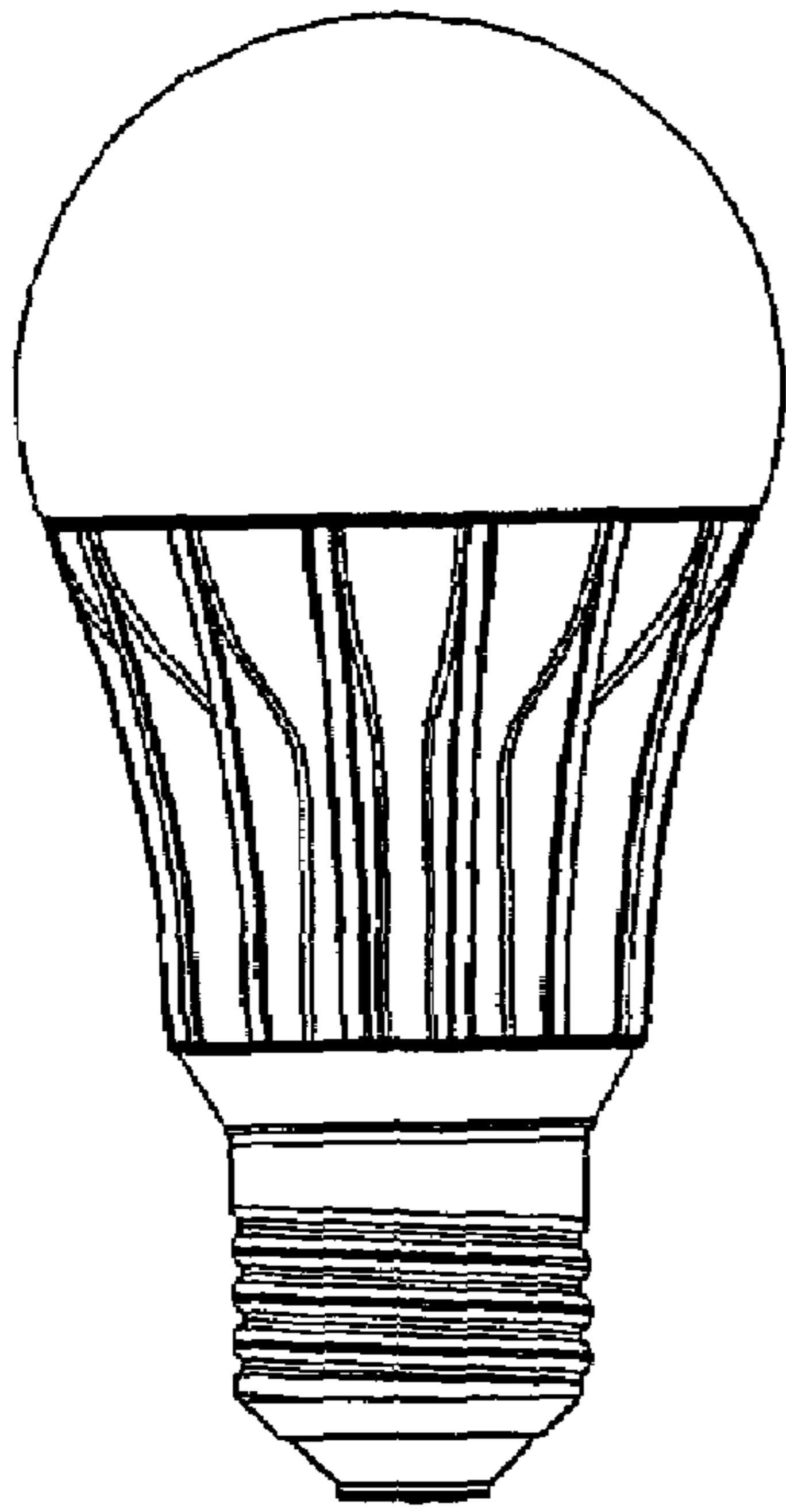

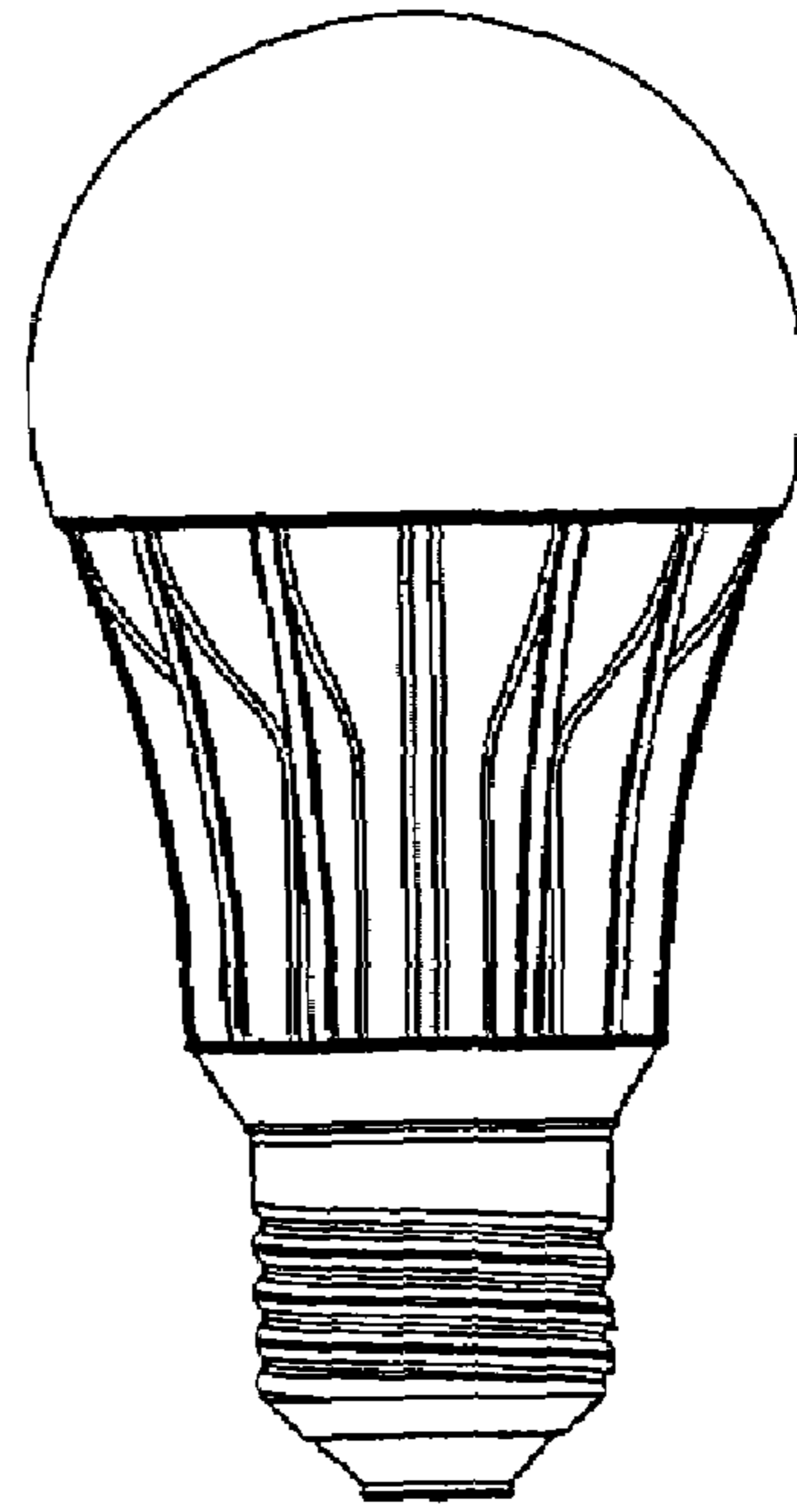

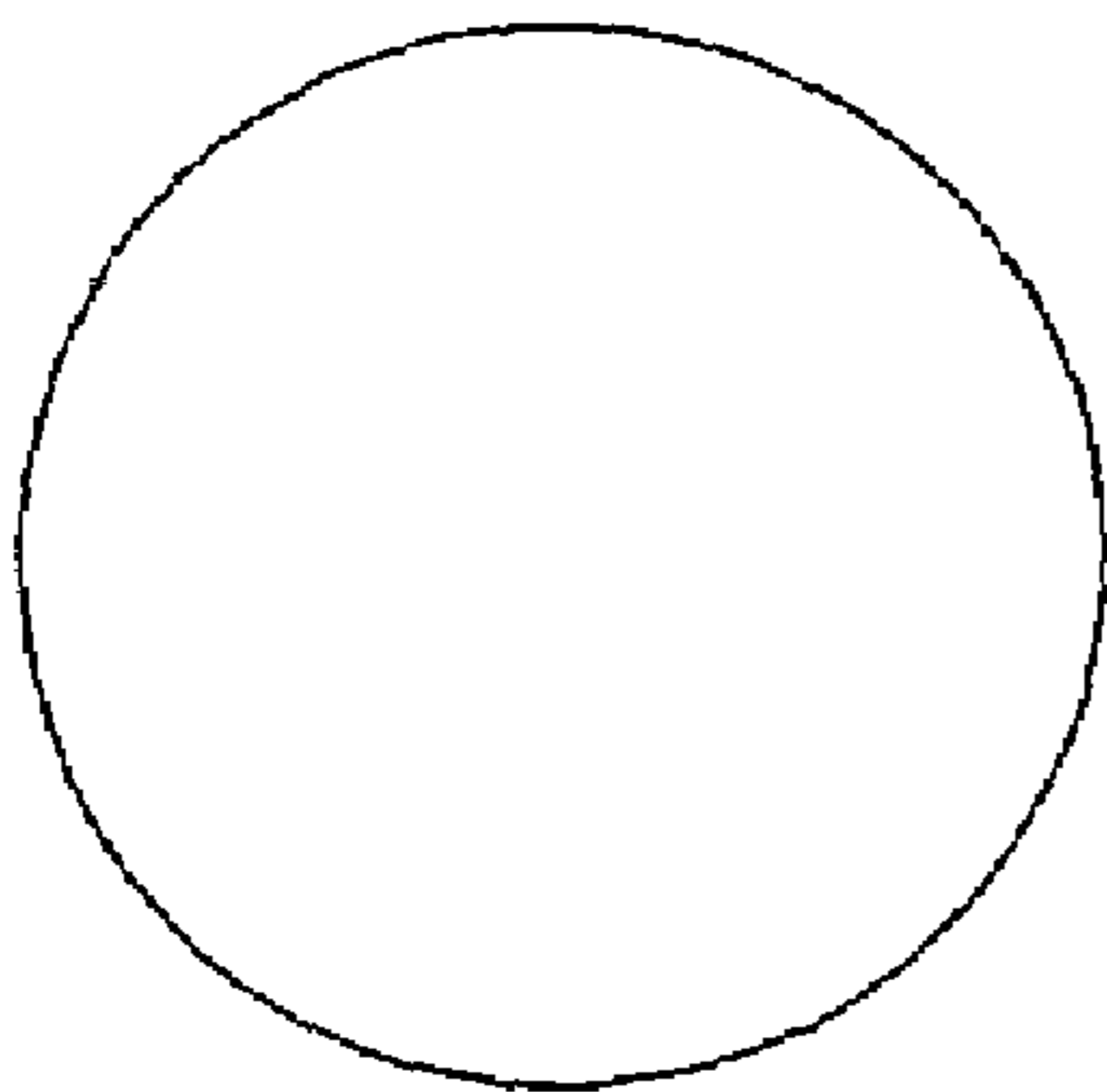

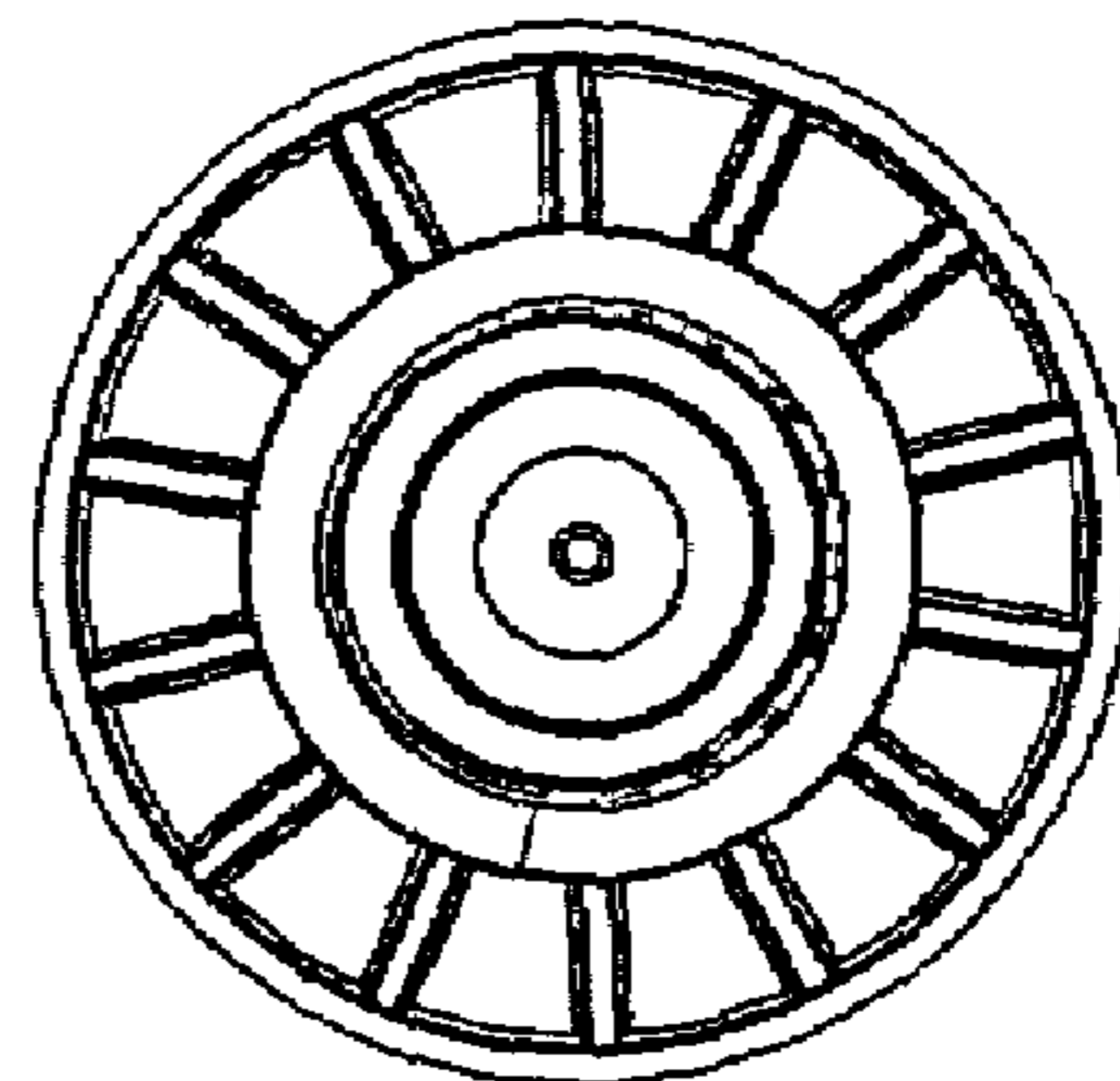

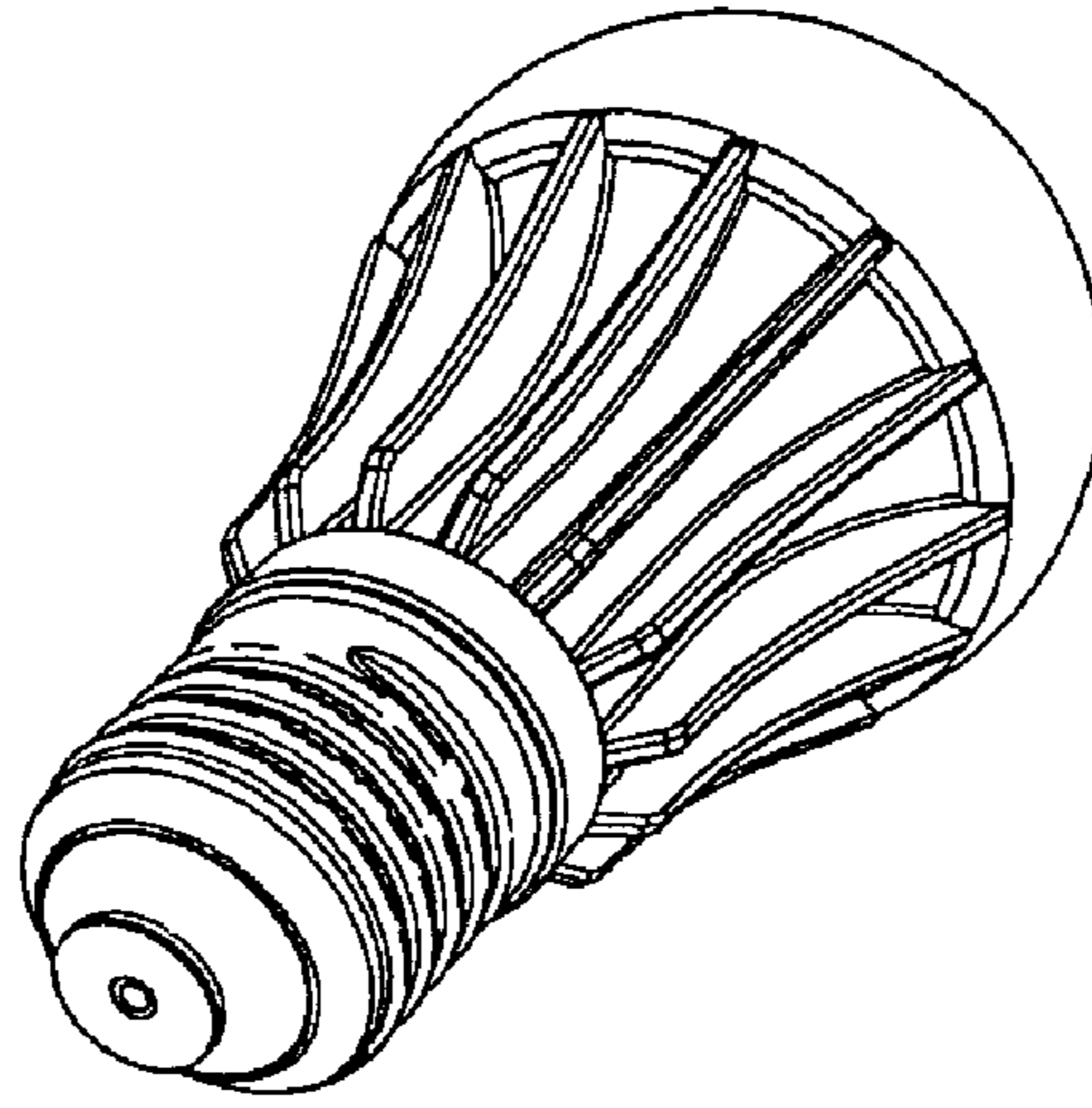

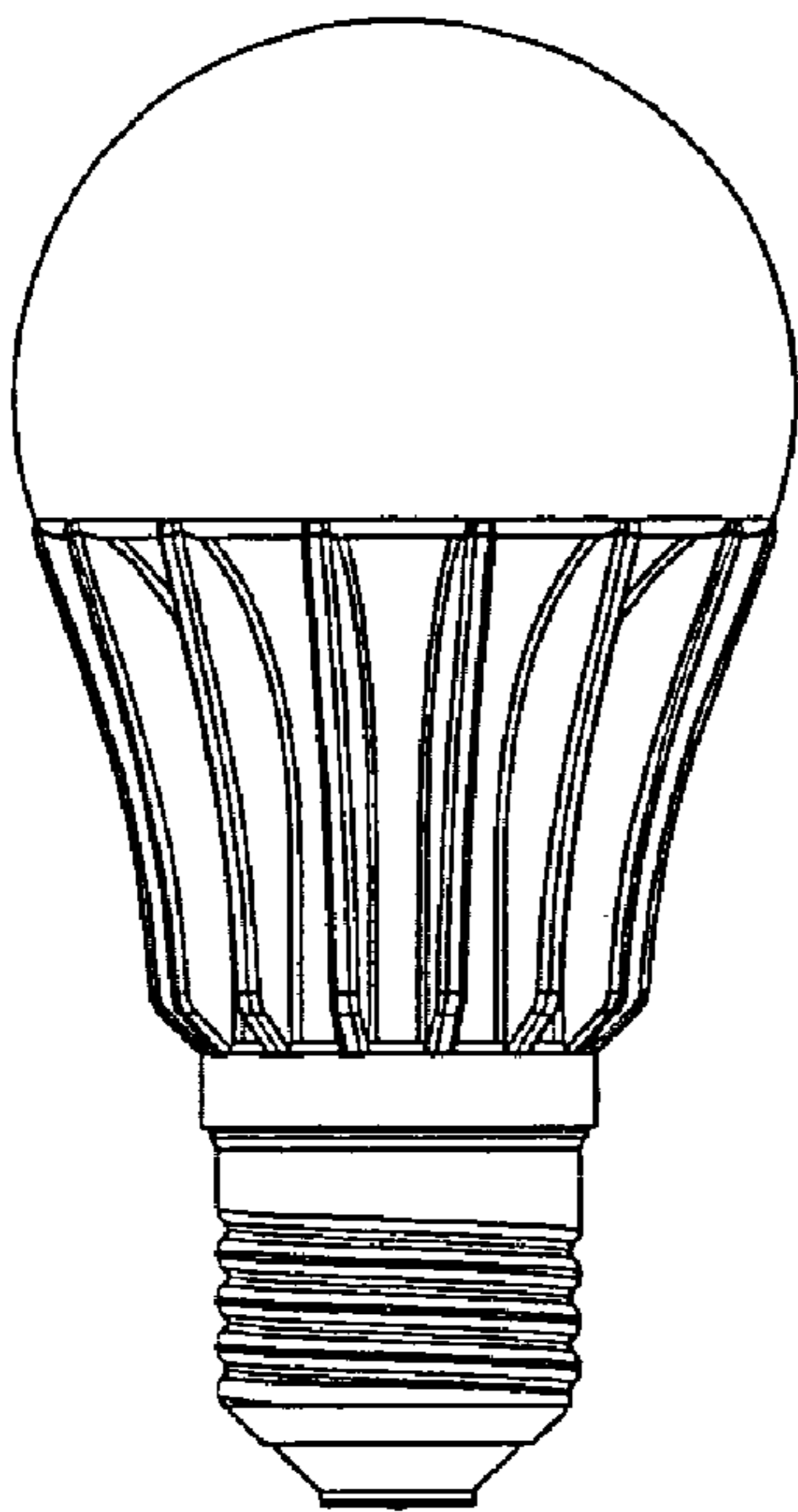

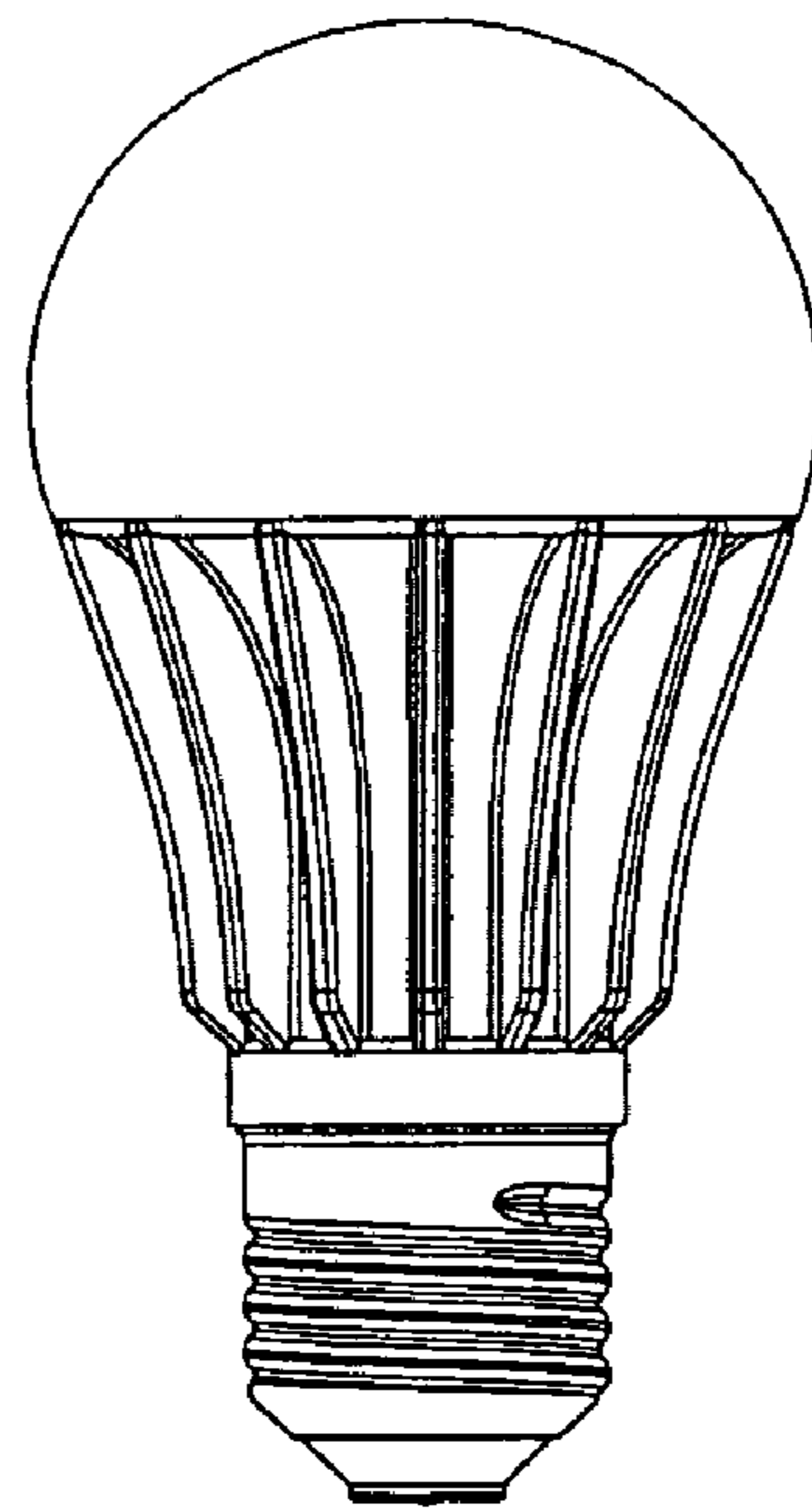

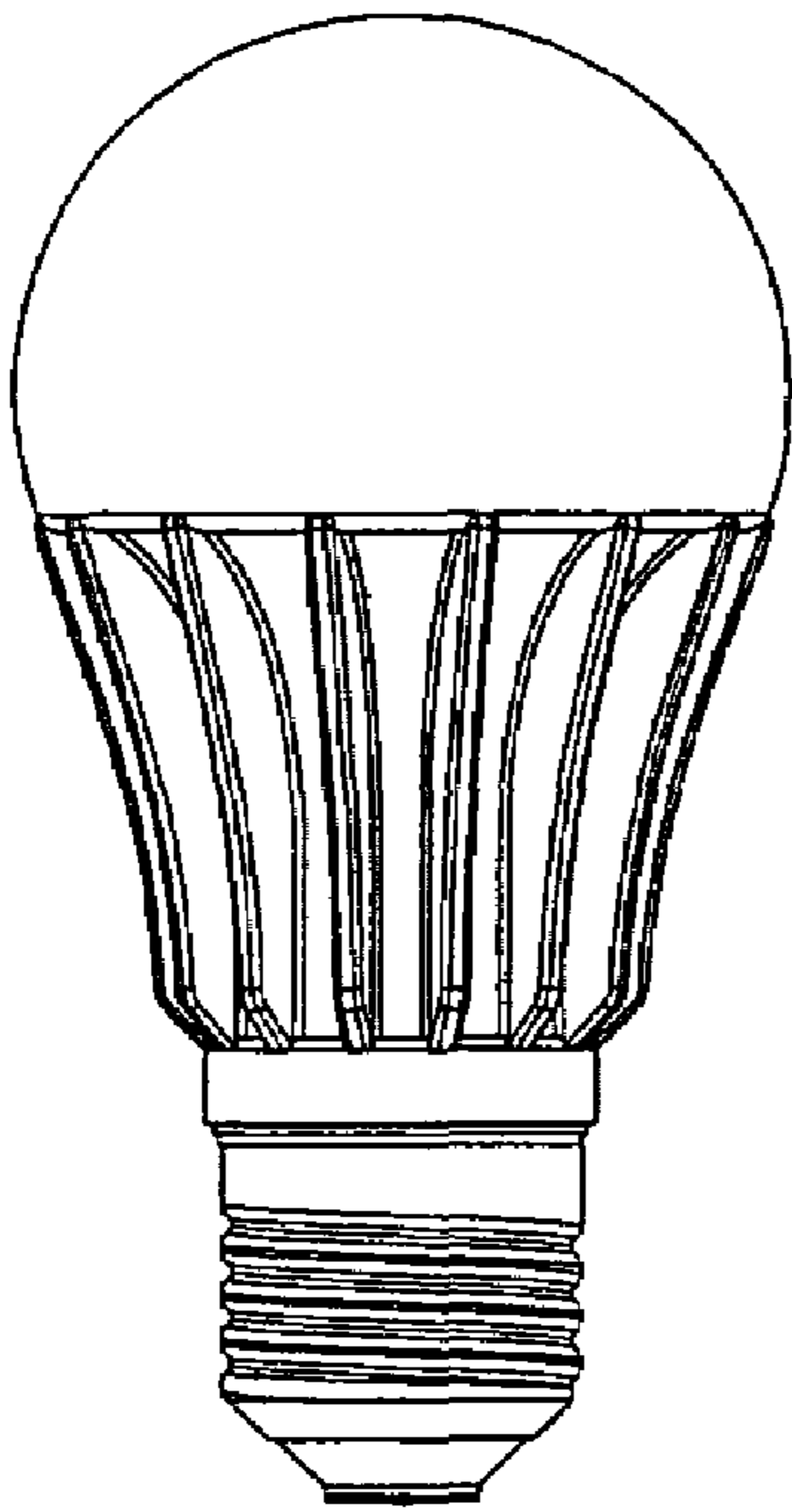

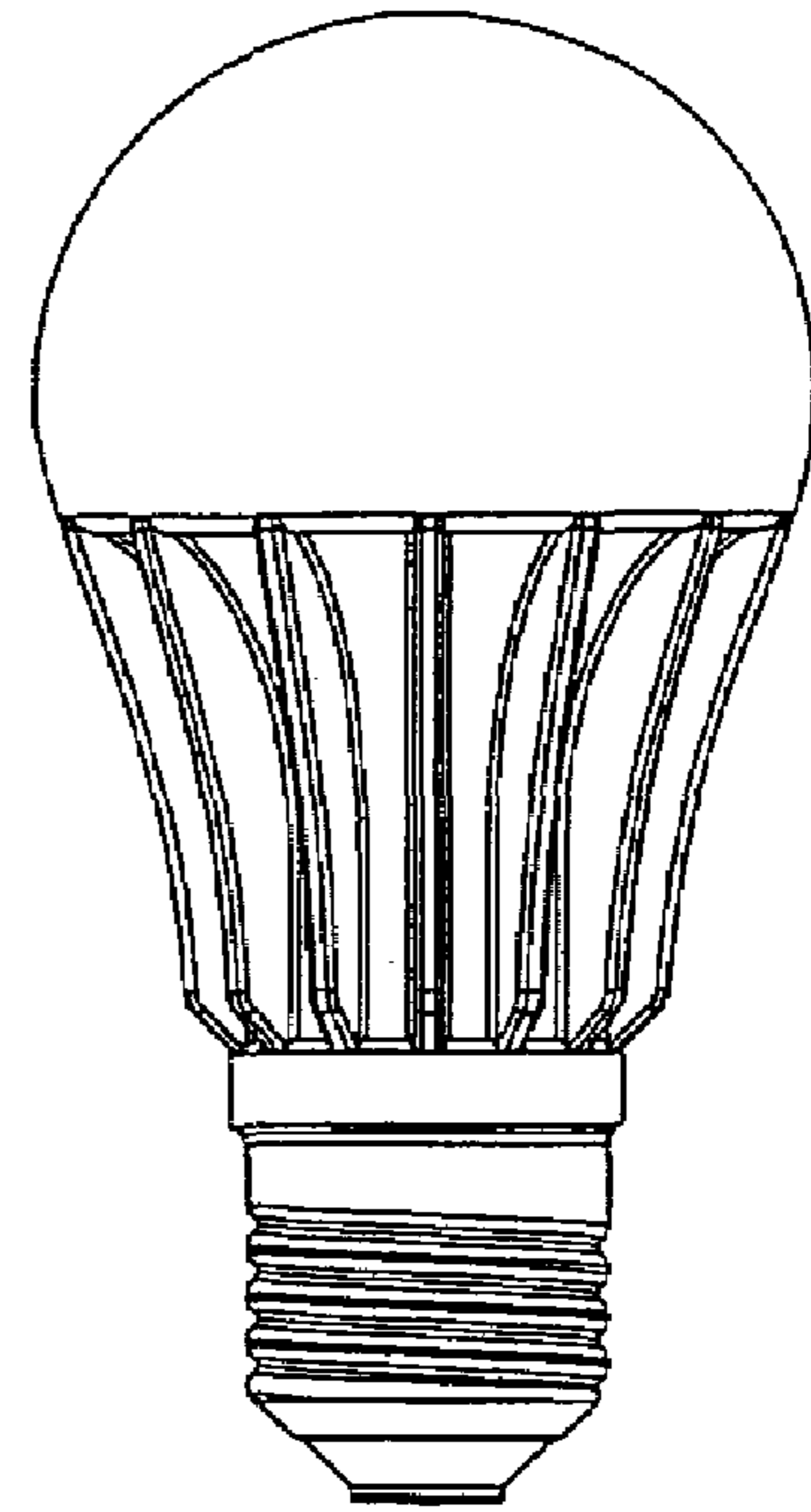

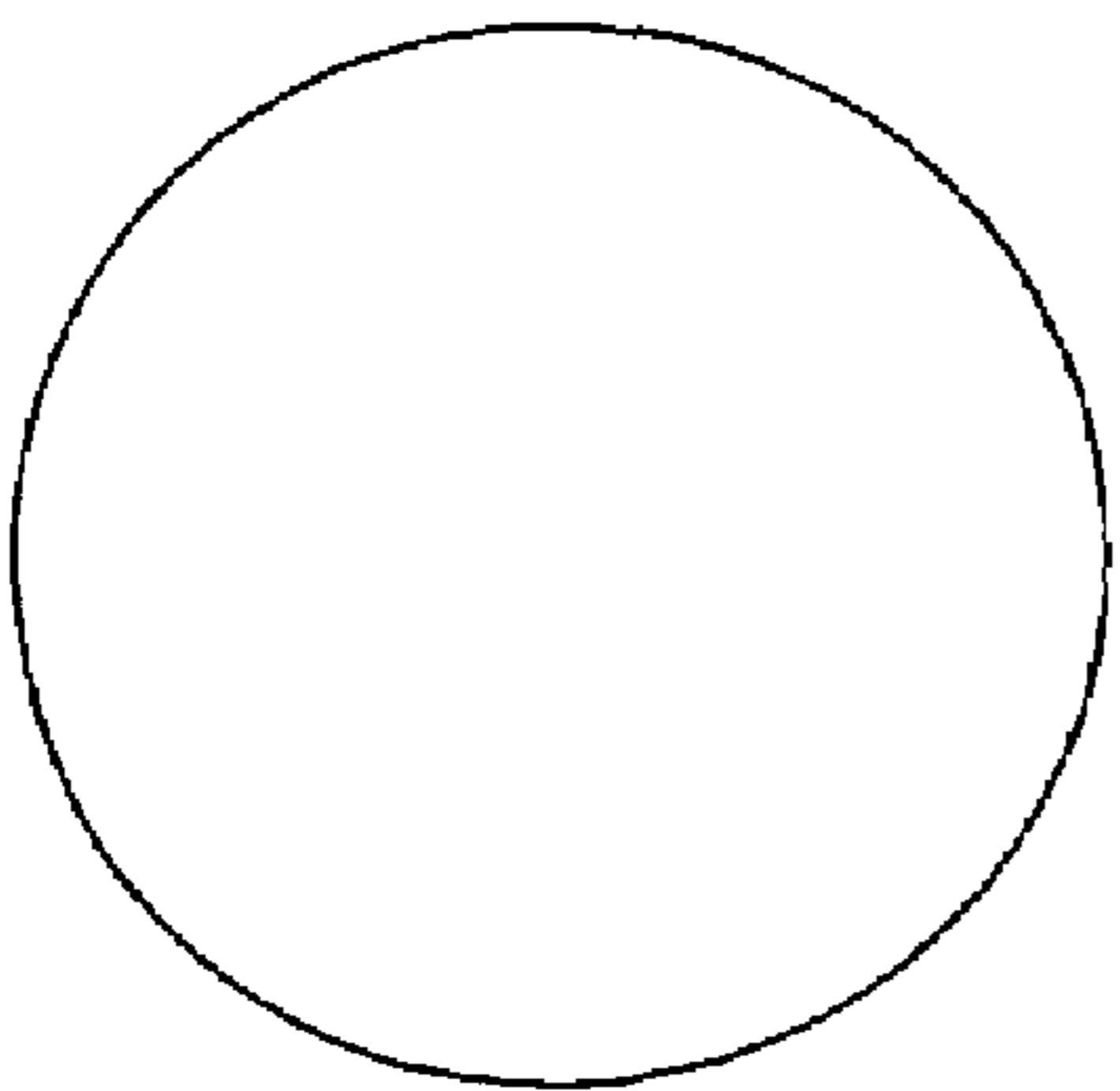

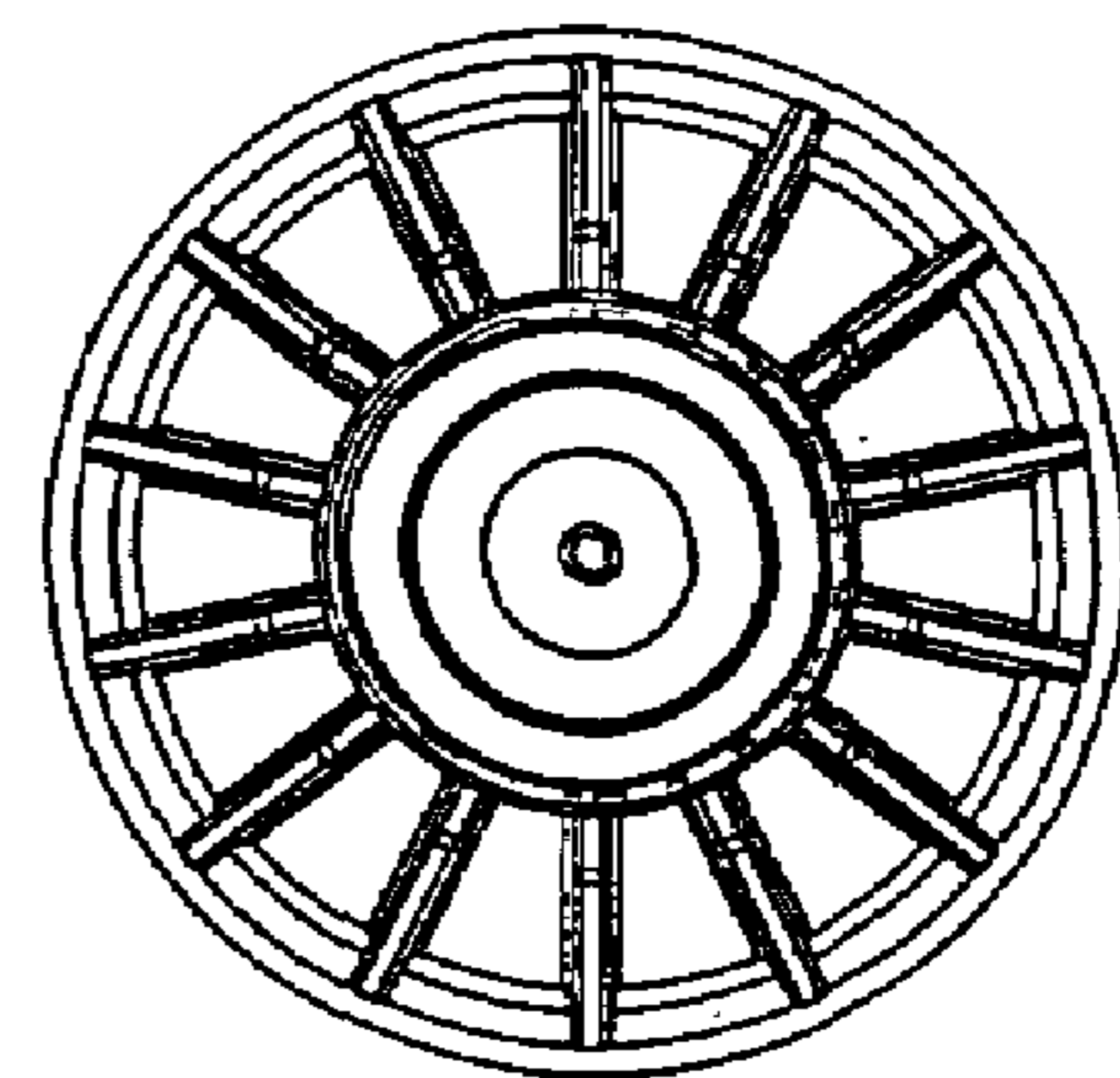

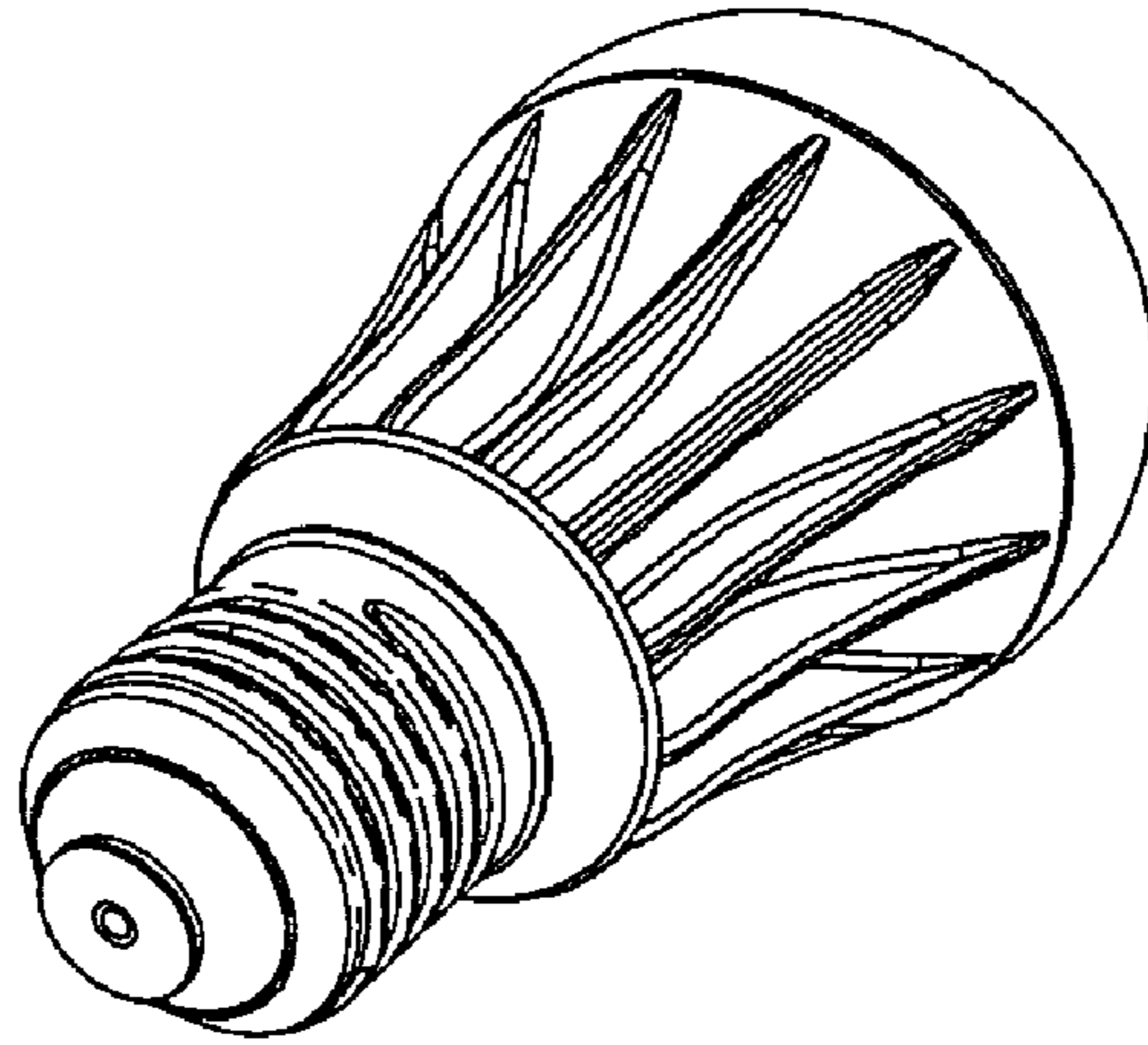

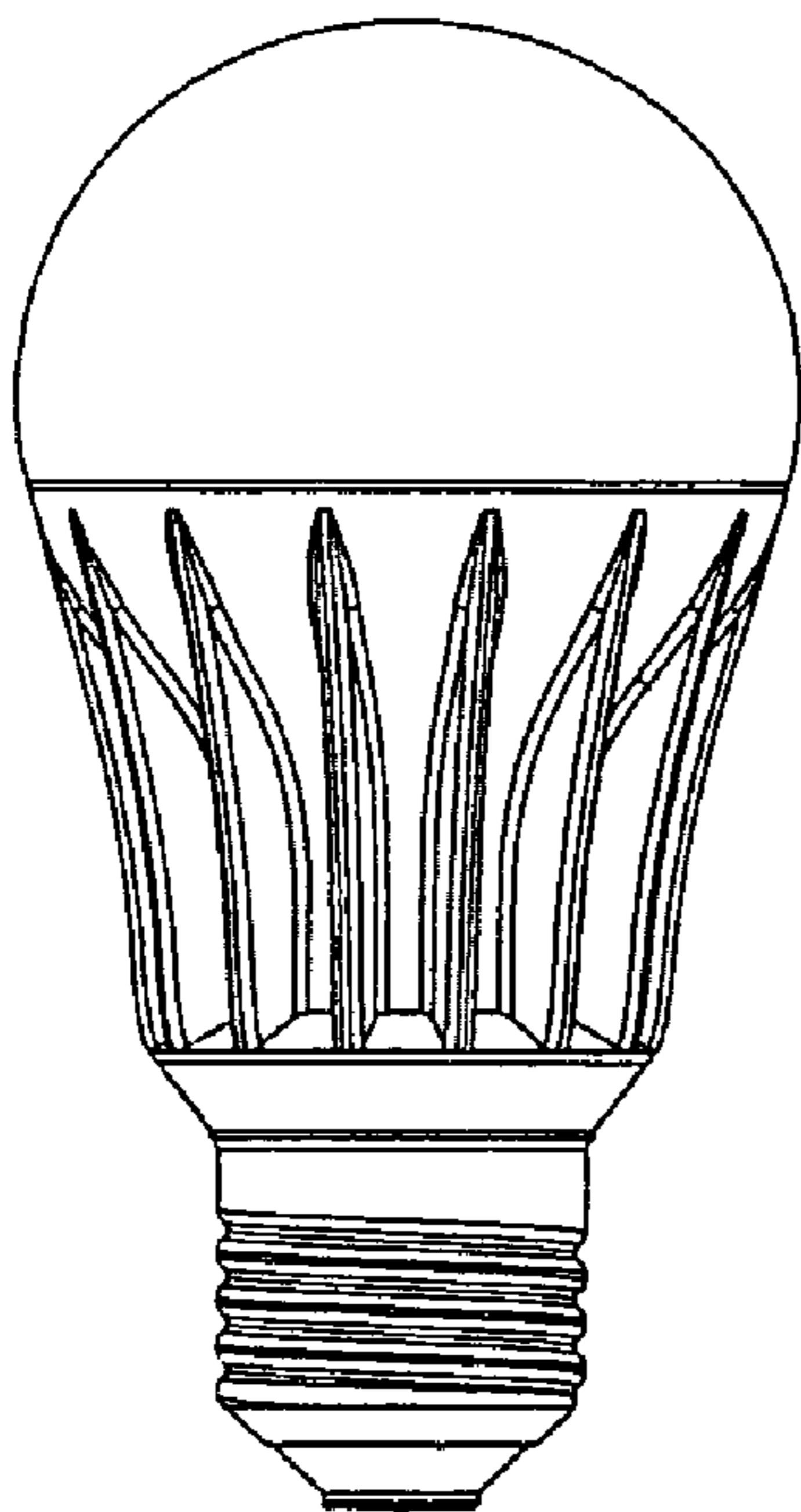

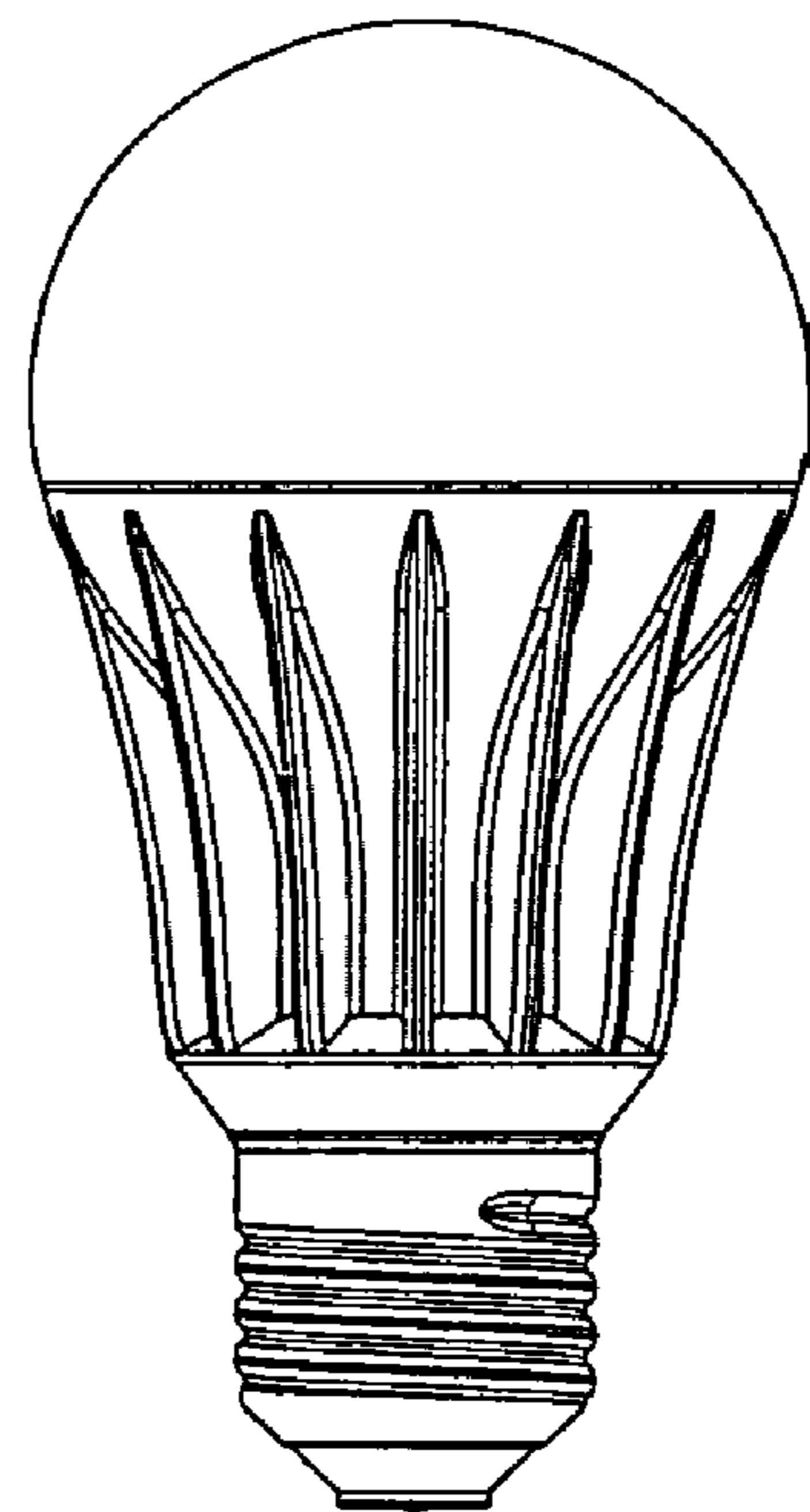

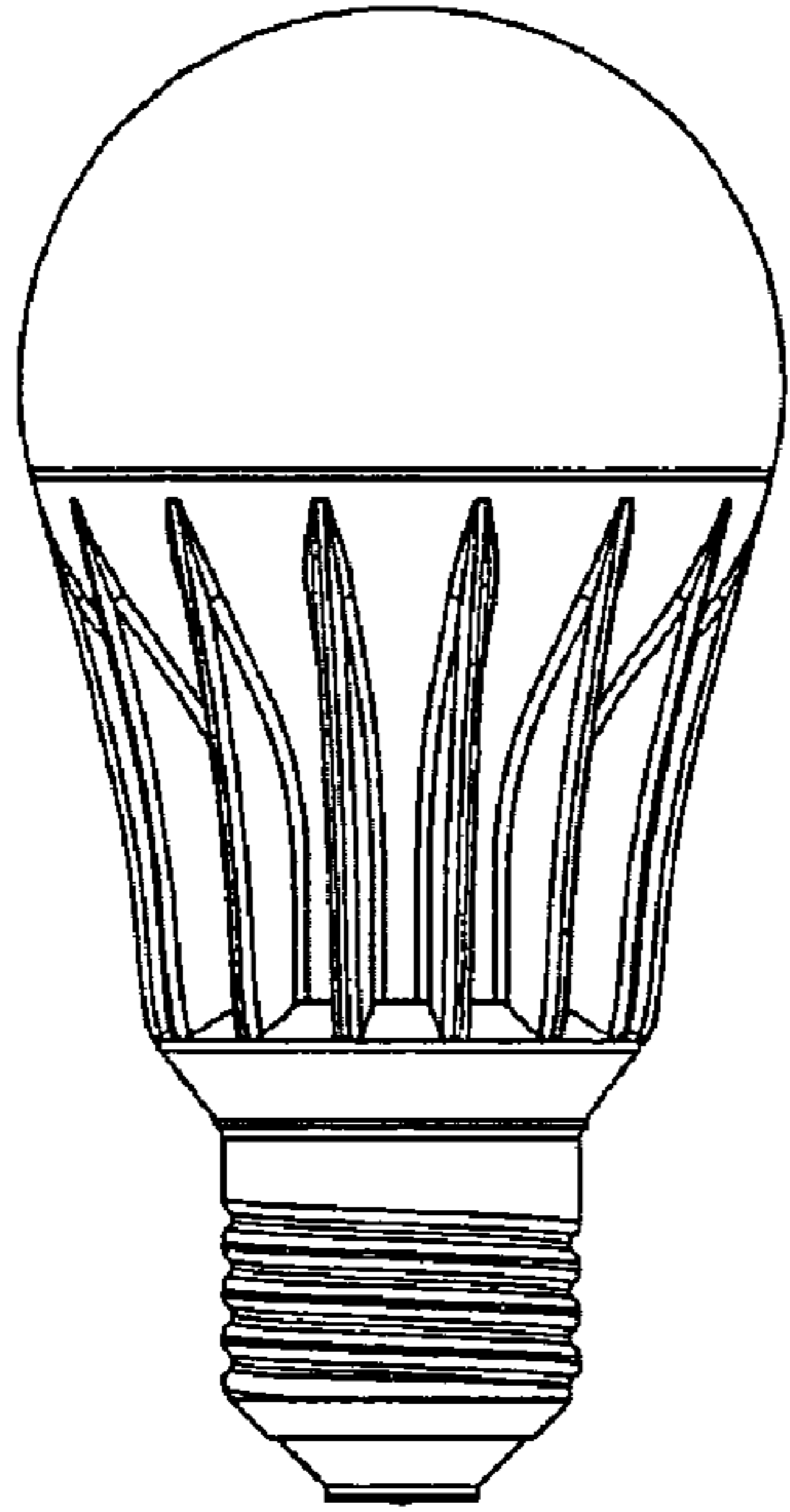

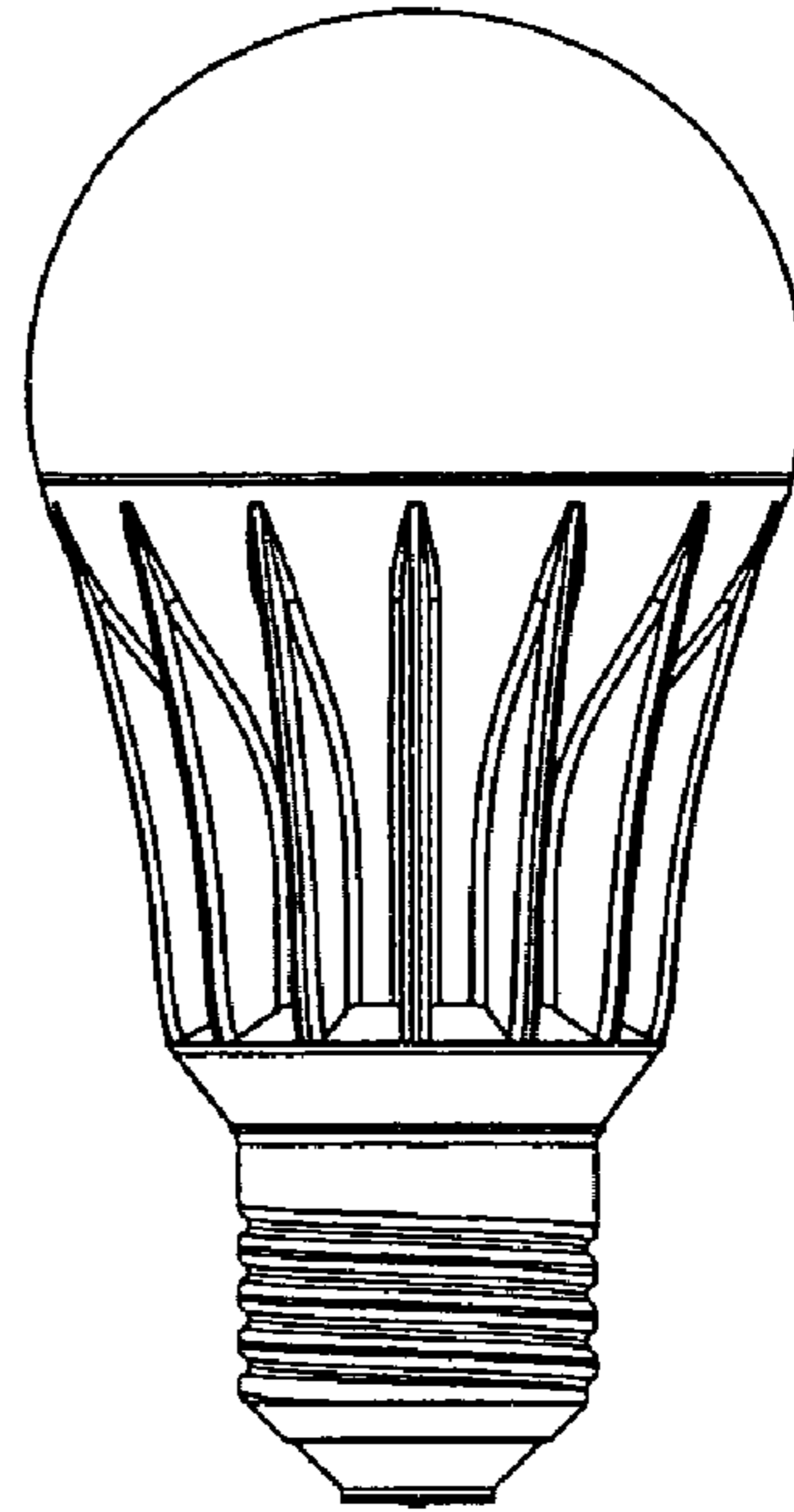

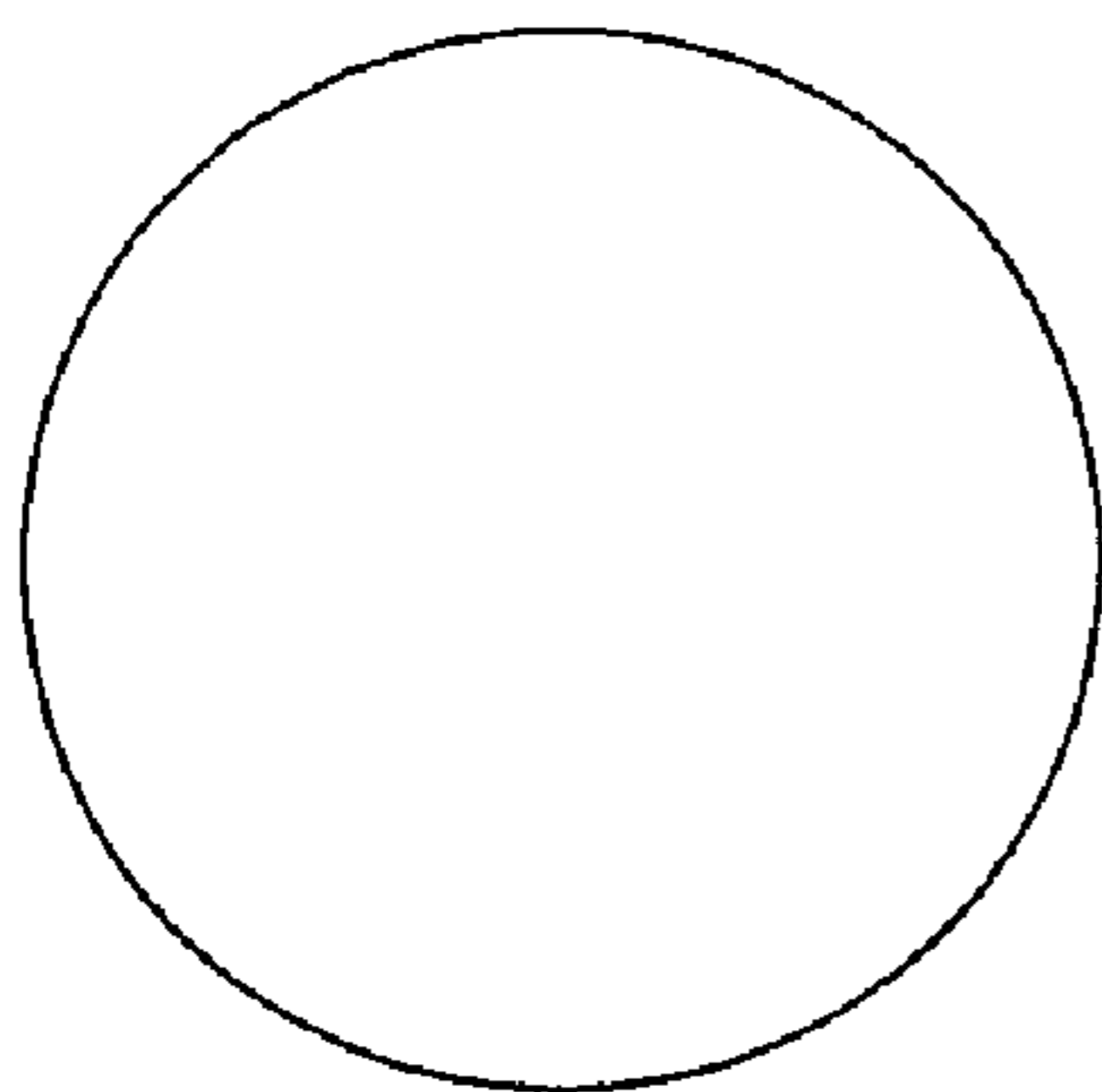

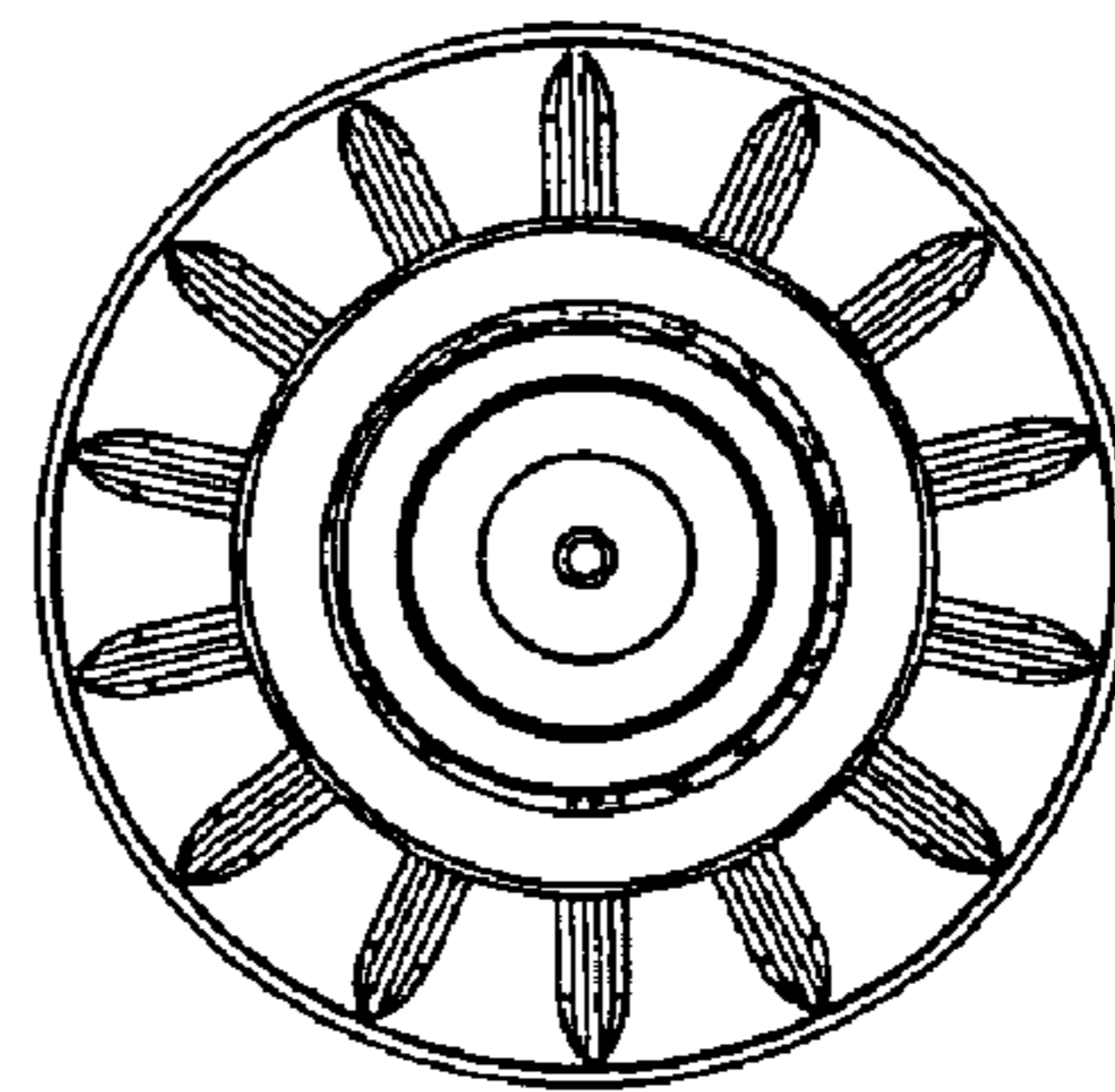

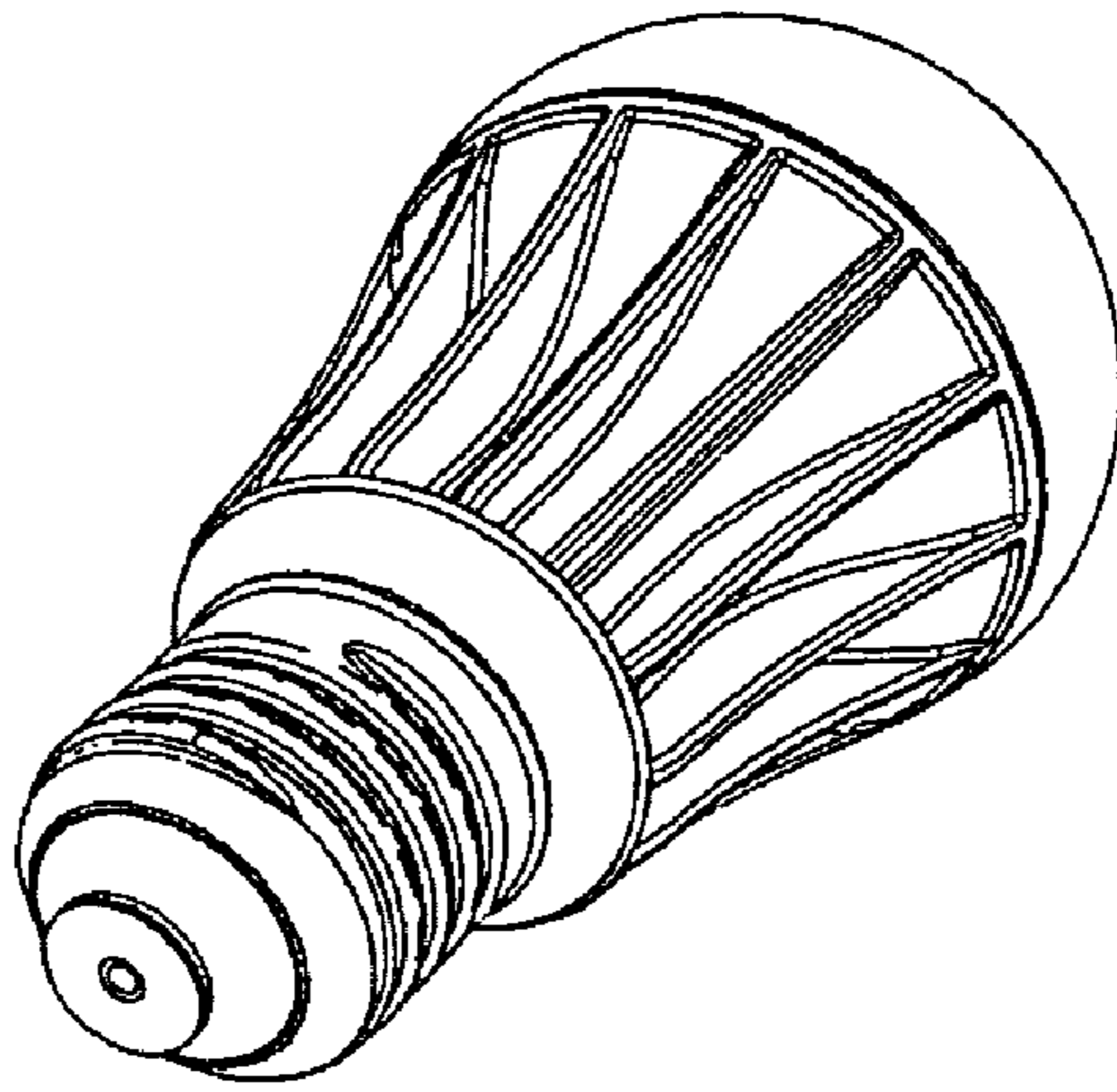

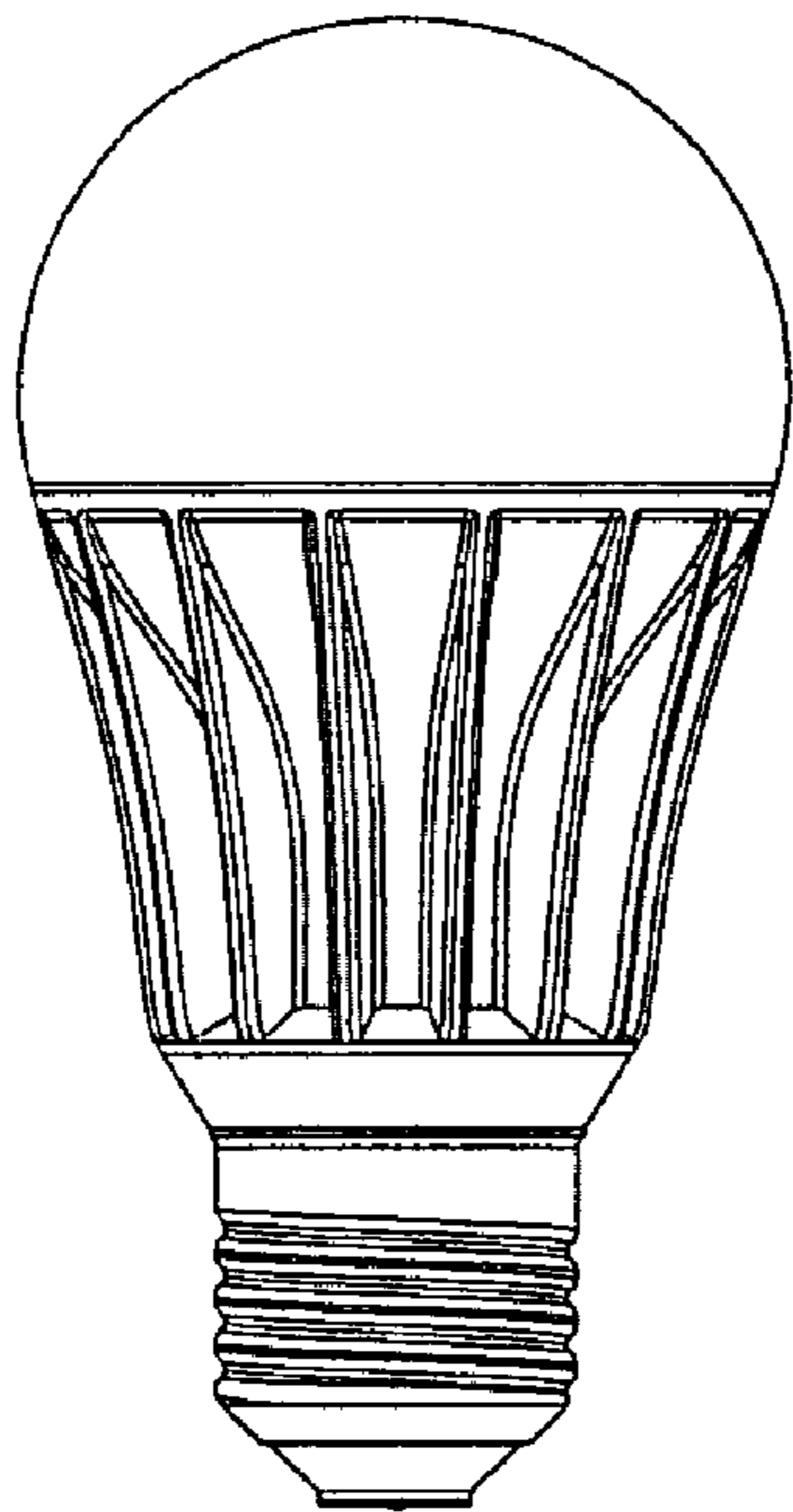

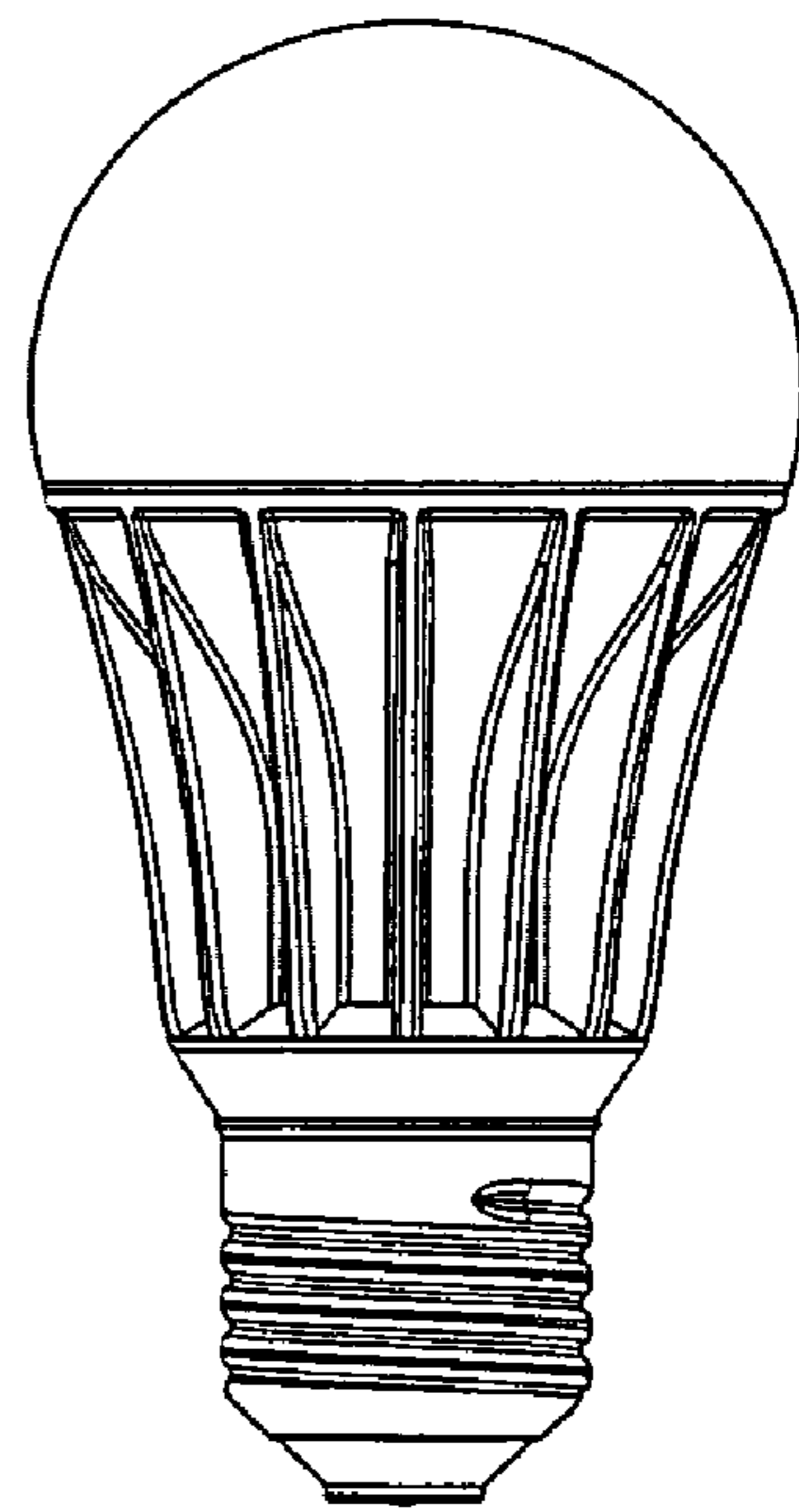

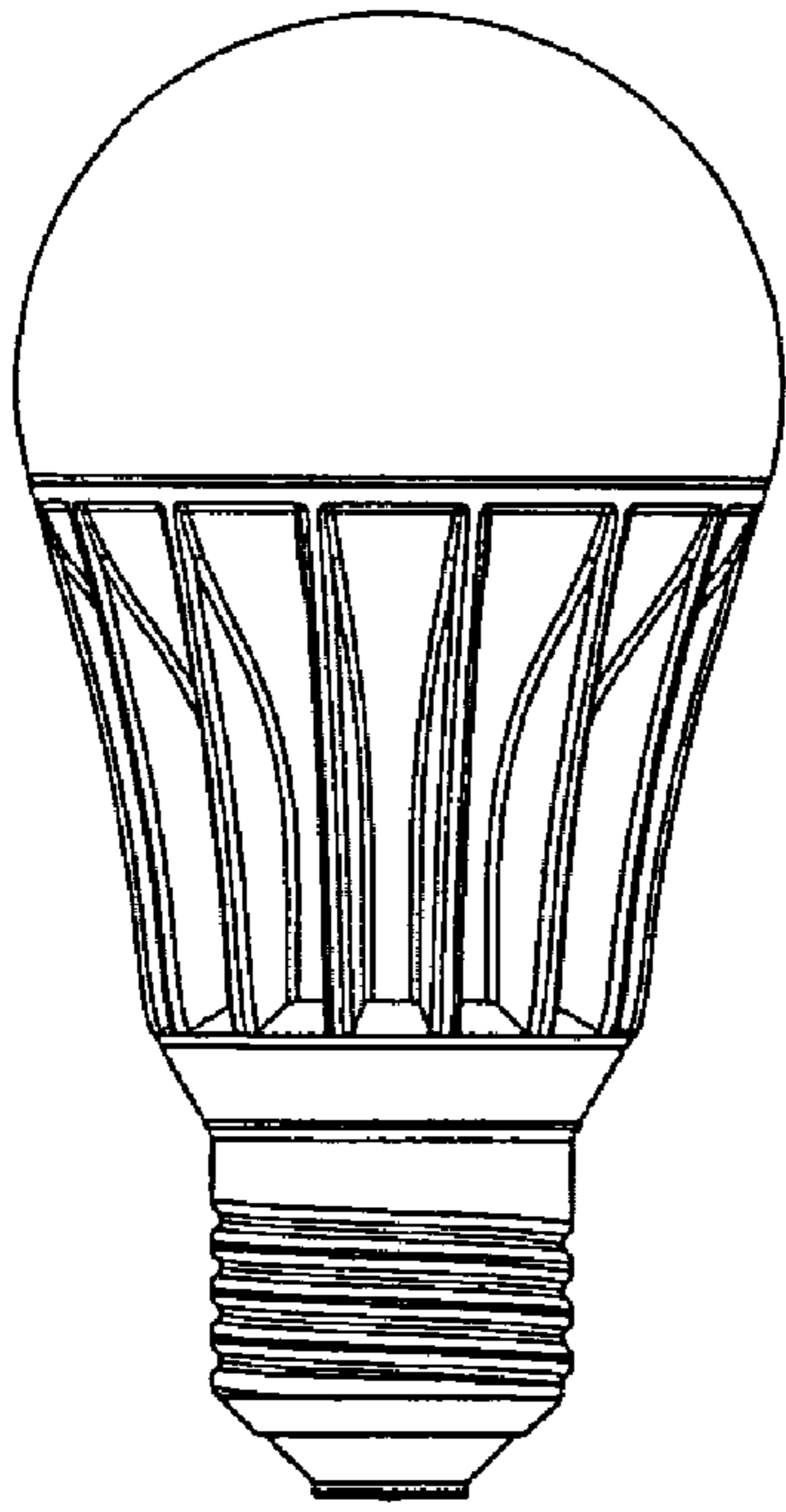

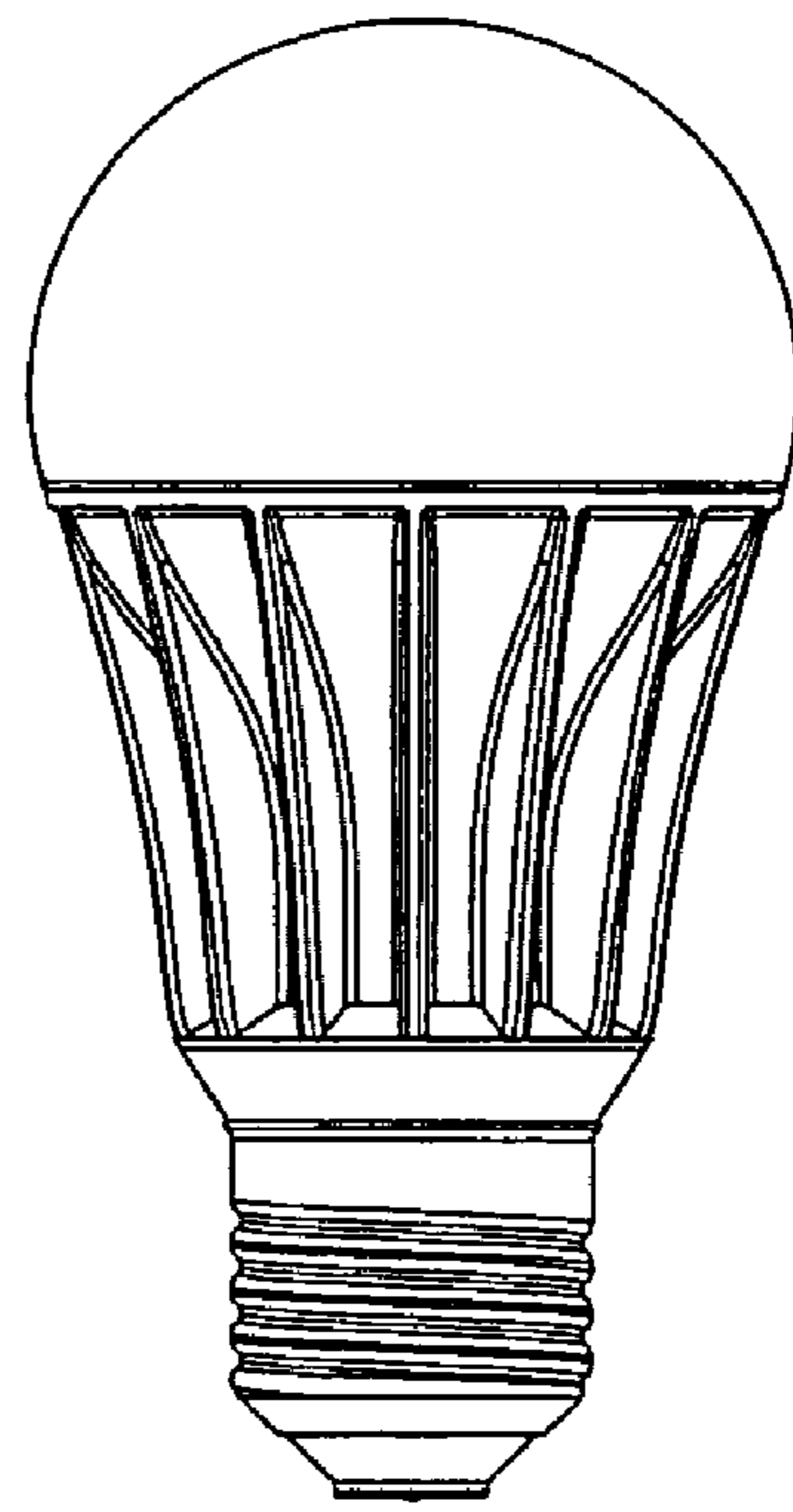

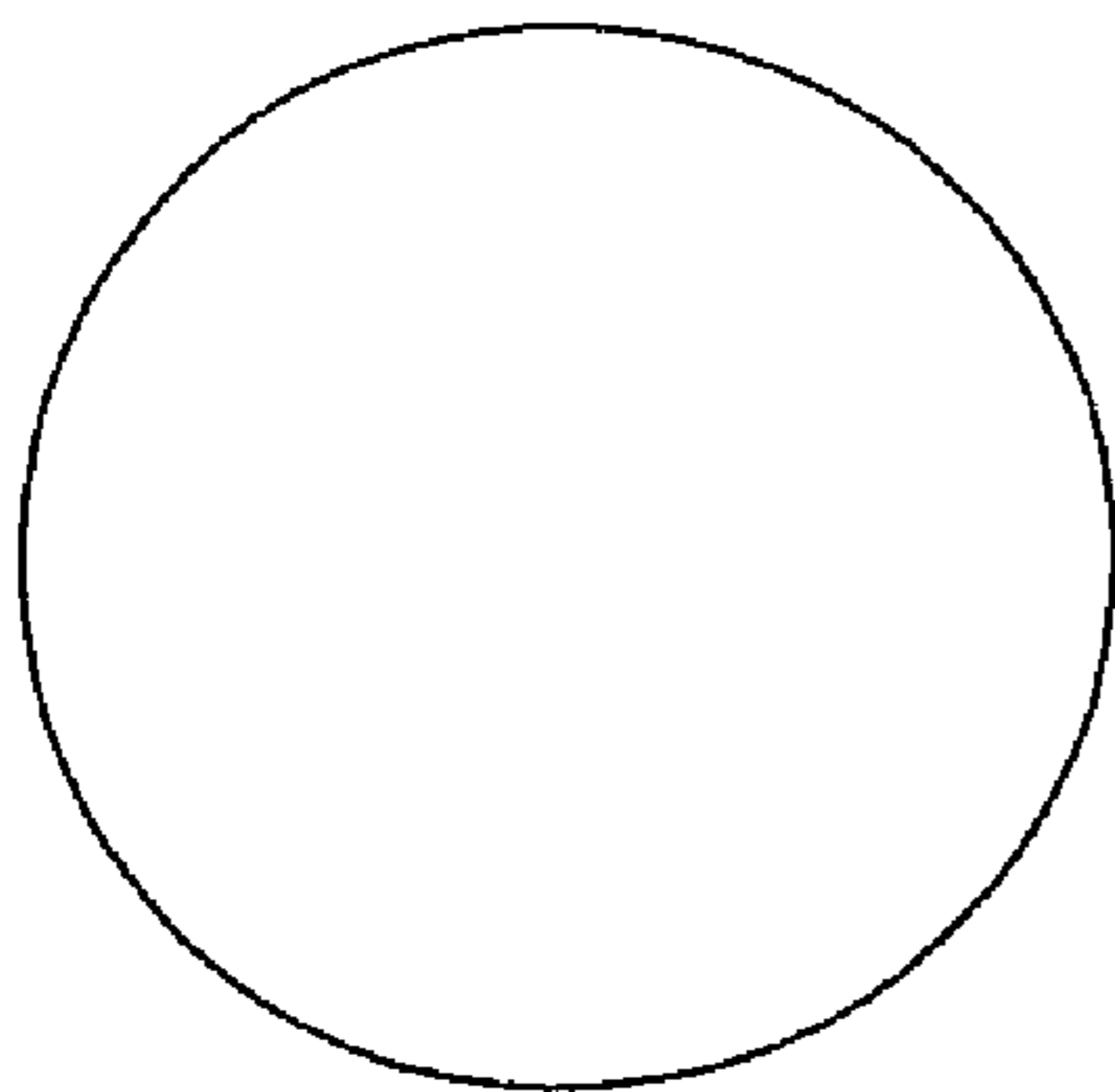

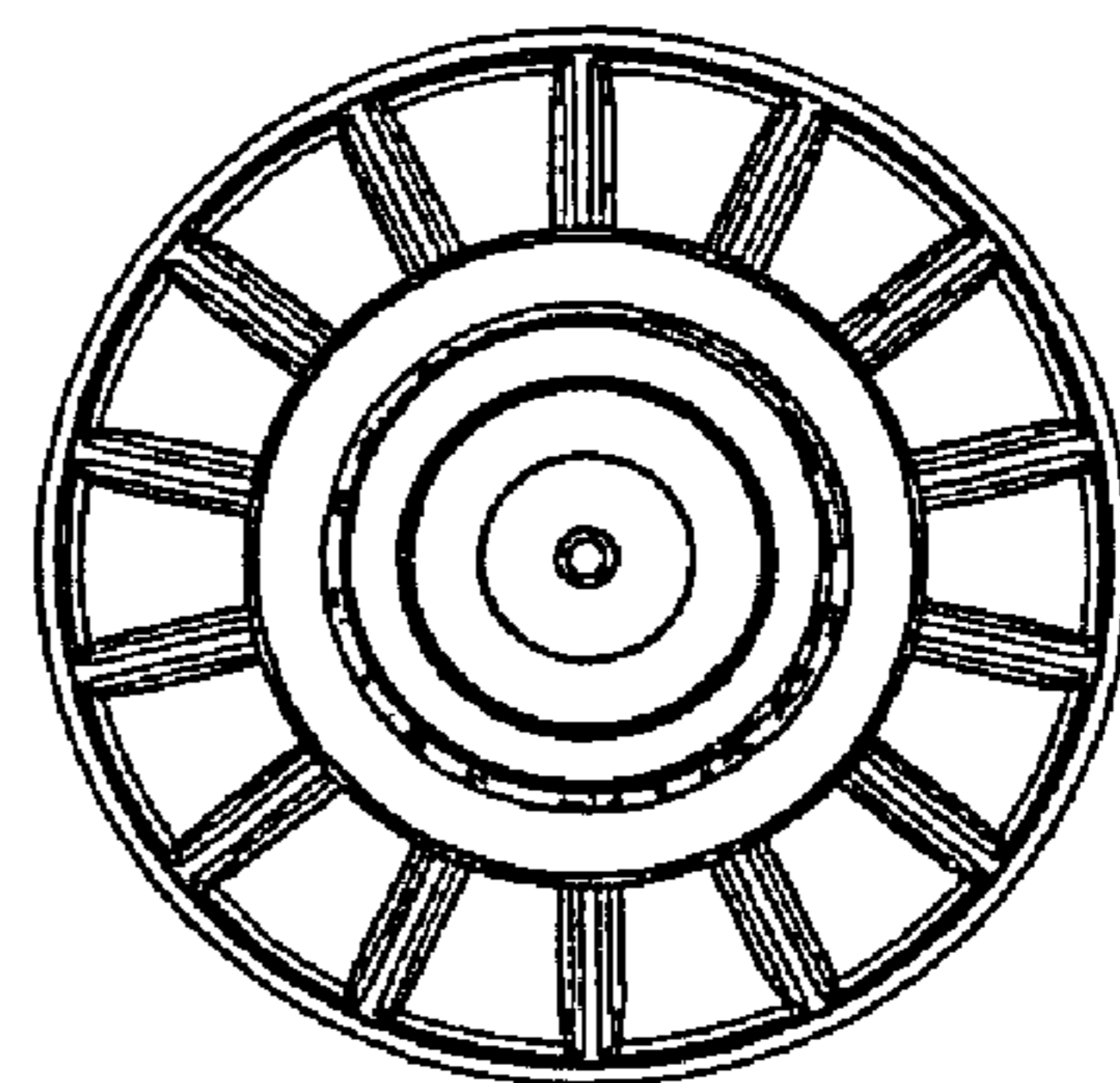
