The ornamental design for a tiller arm, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a tiller arm showing our new design;

FIG. 2 is a top view of the tiller arm of FIG. 1;

FIG. 3 is a left side view of the tiller arm of FIG. 1;

FIG. 4 is a bottom view of the tiller arm of FIG. 1;

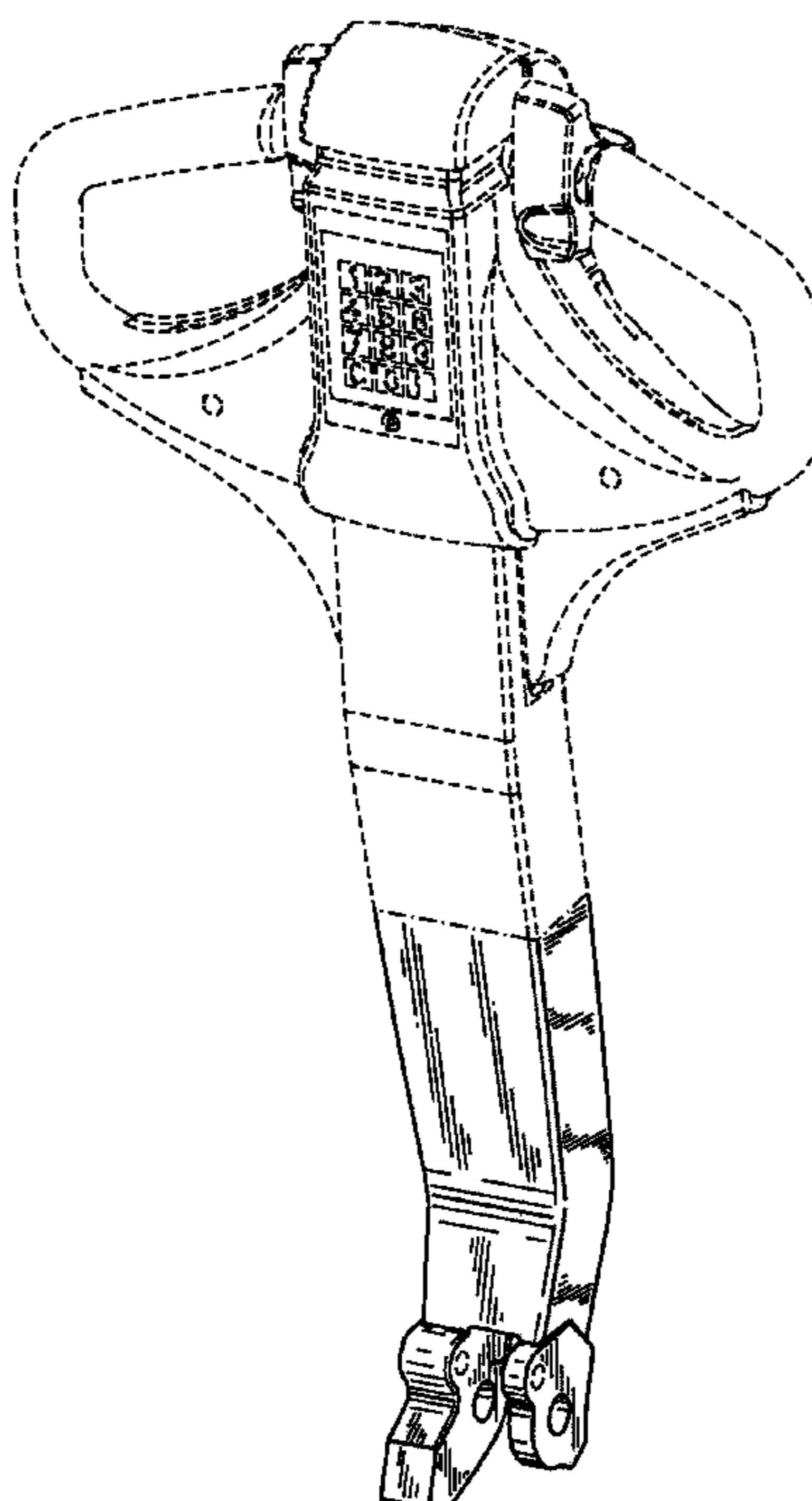
FIG. 5 is a right side view of the tiller arm of FIG. 1;

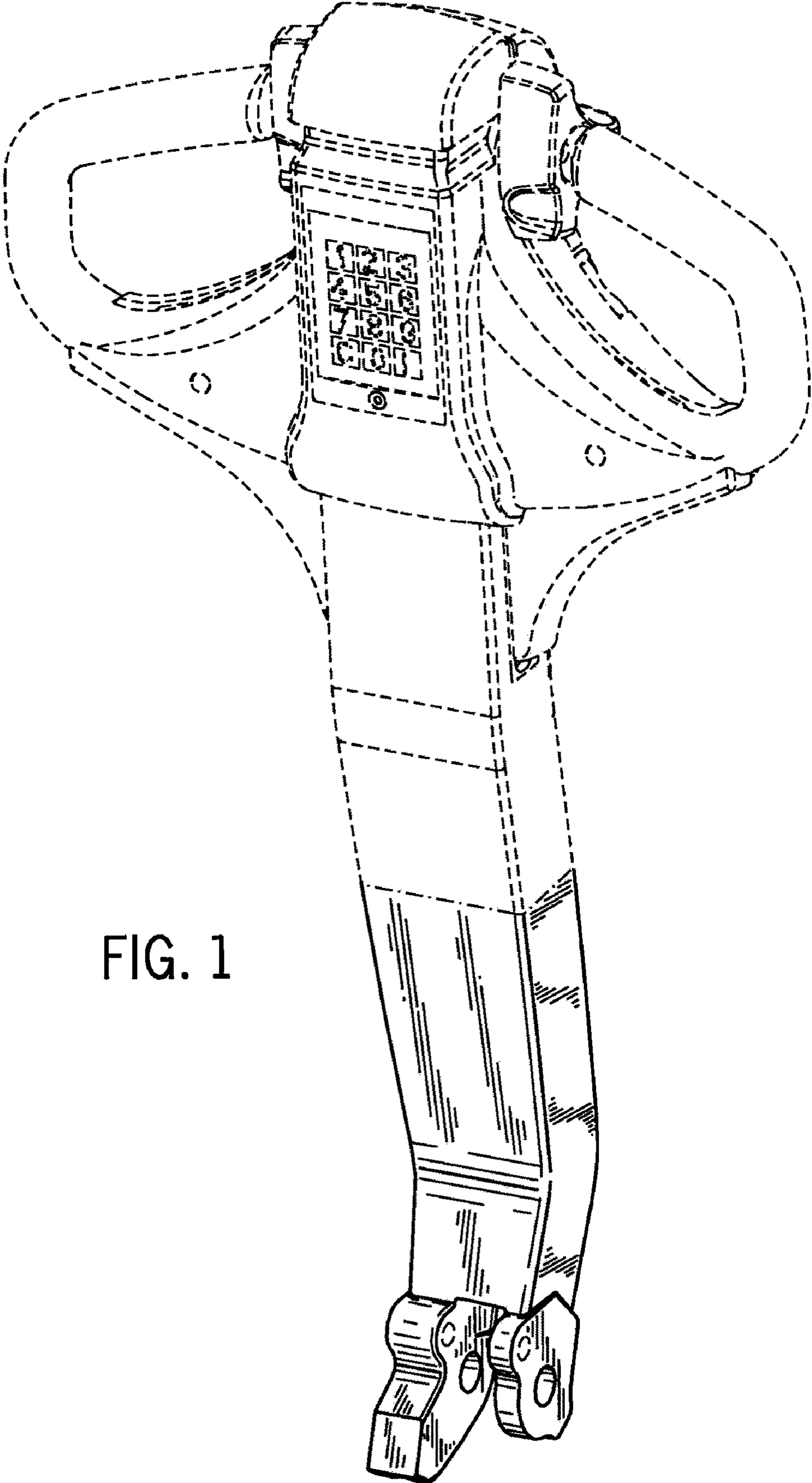

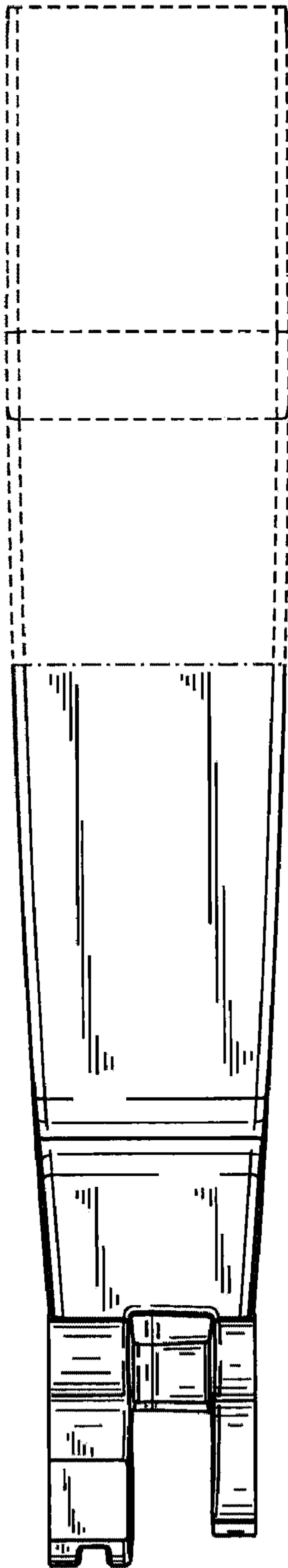

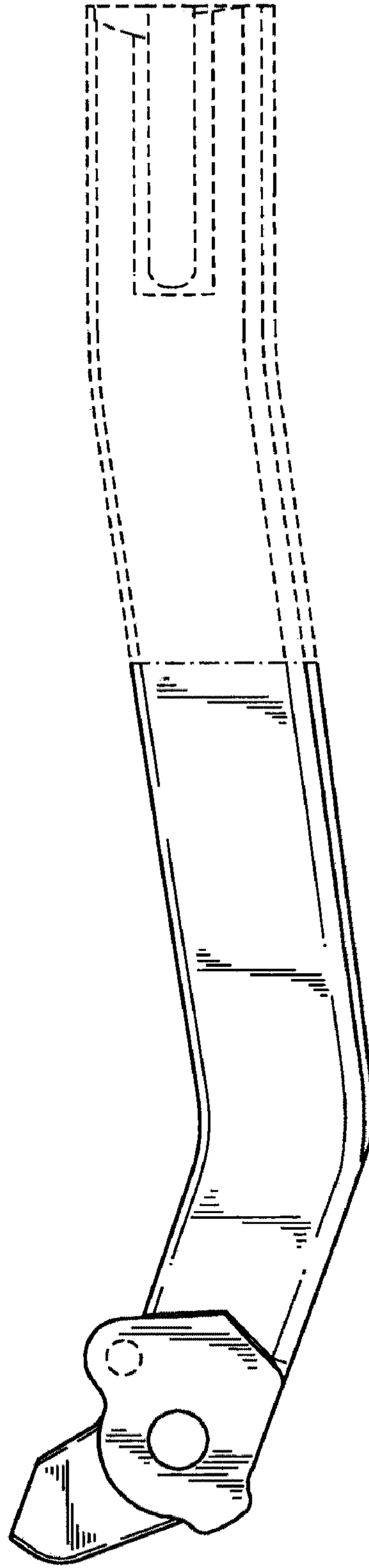

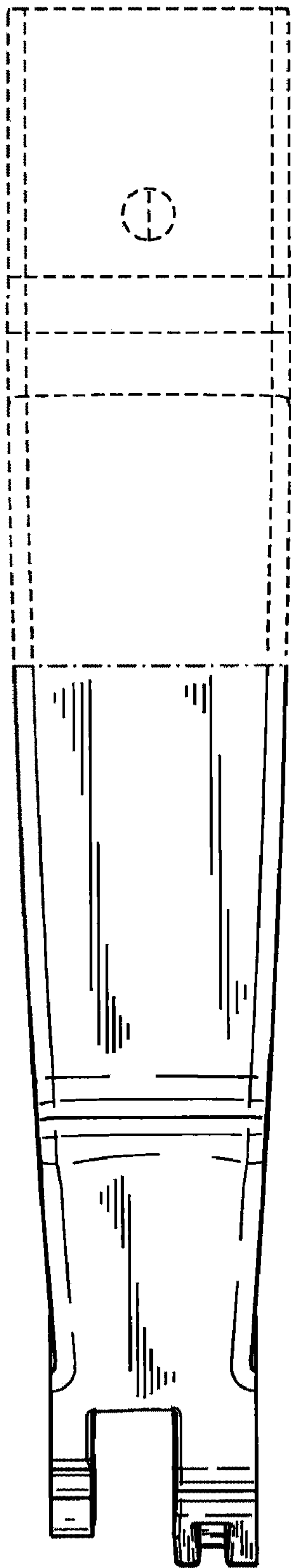

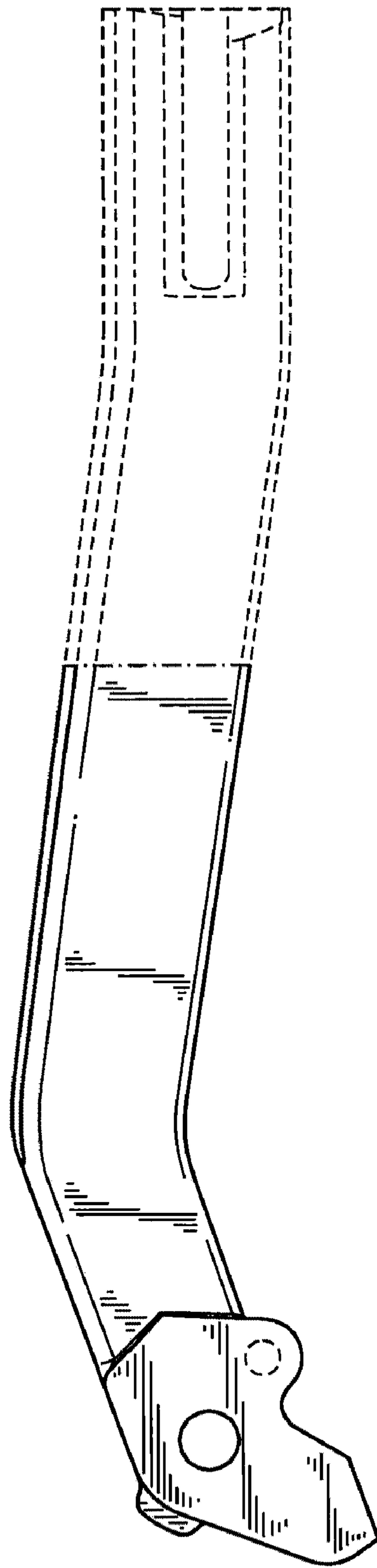

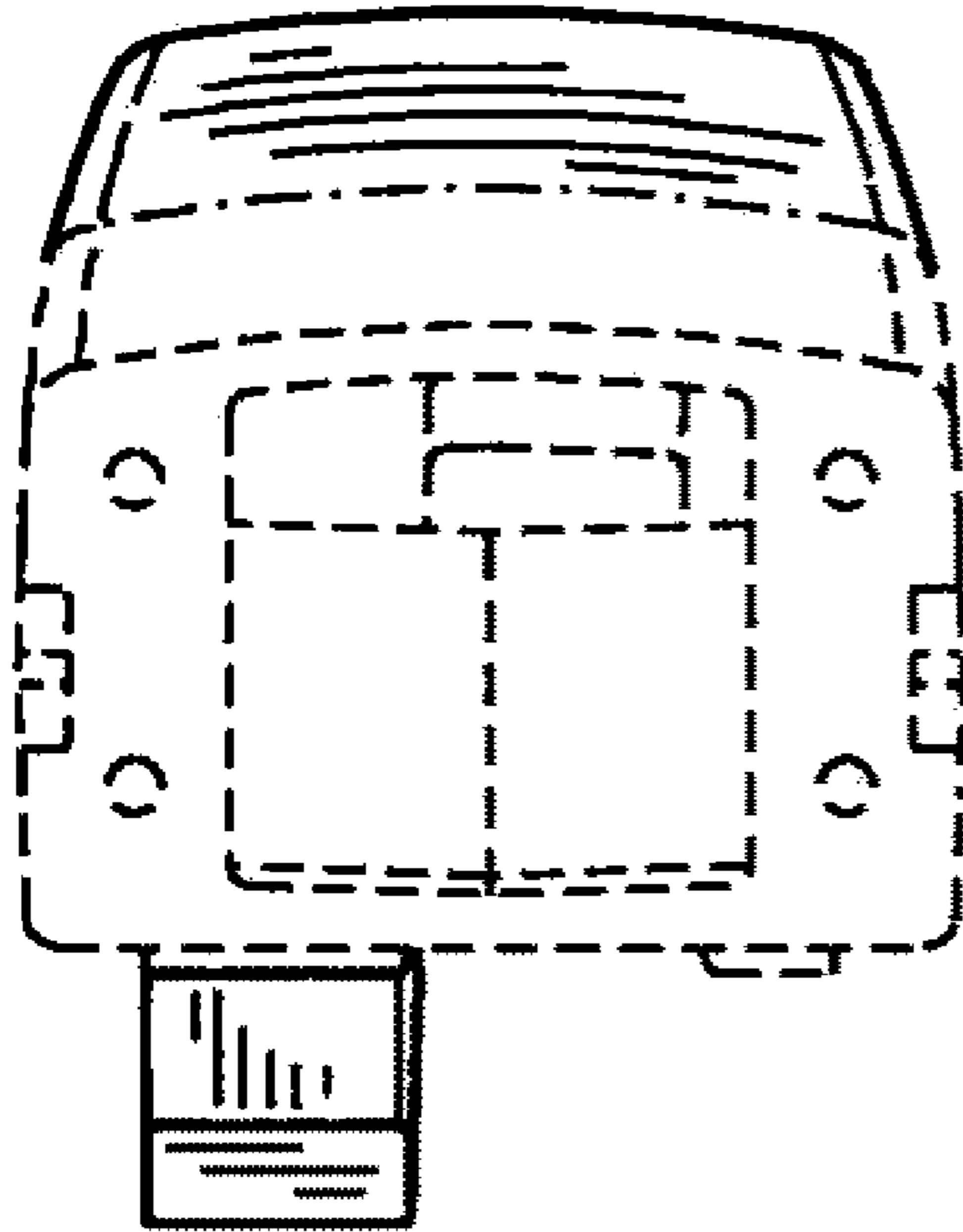

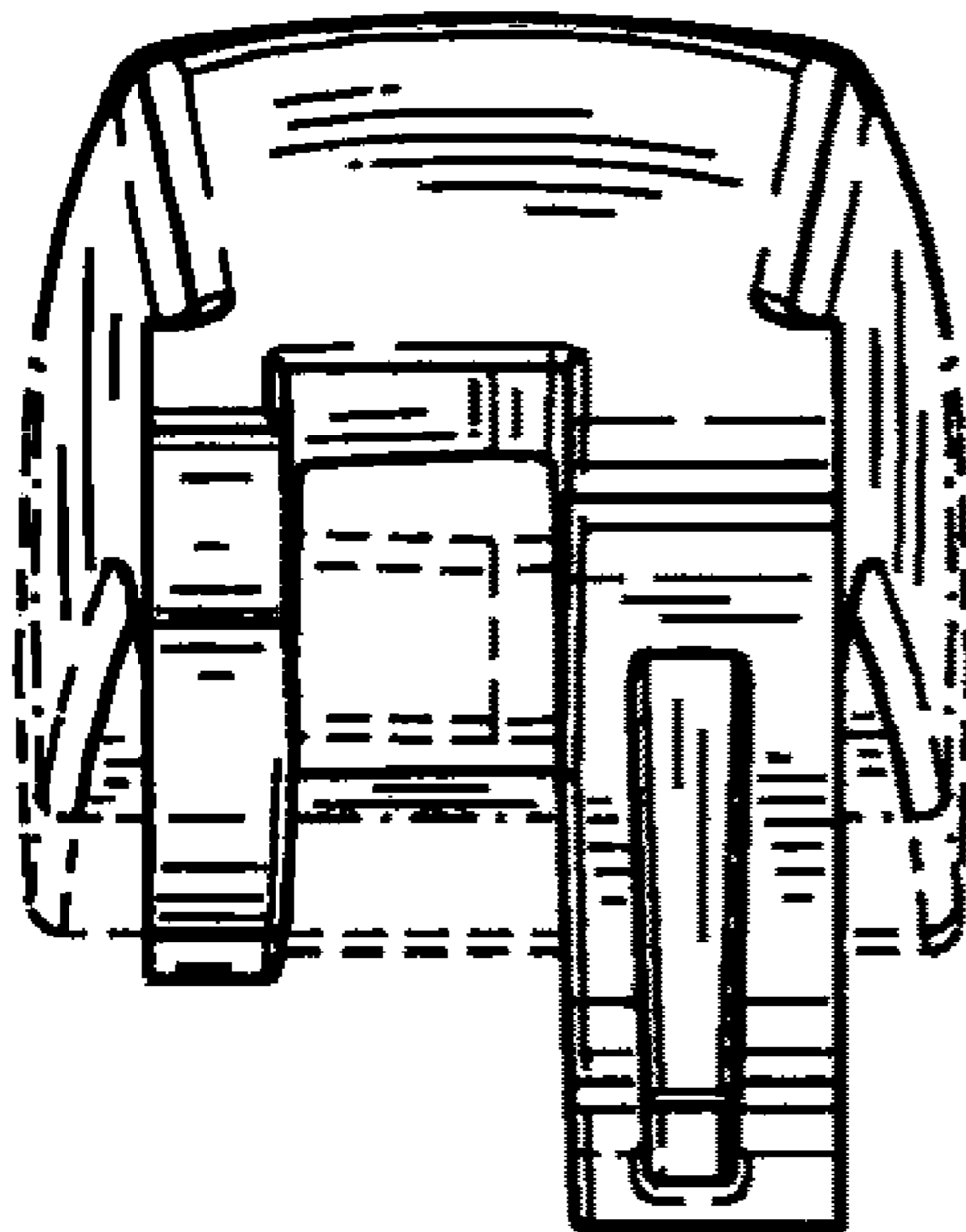
