FIG. 6 is a side elevation view thereof;

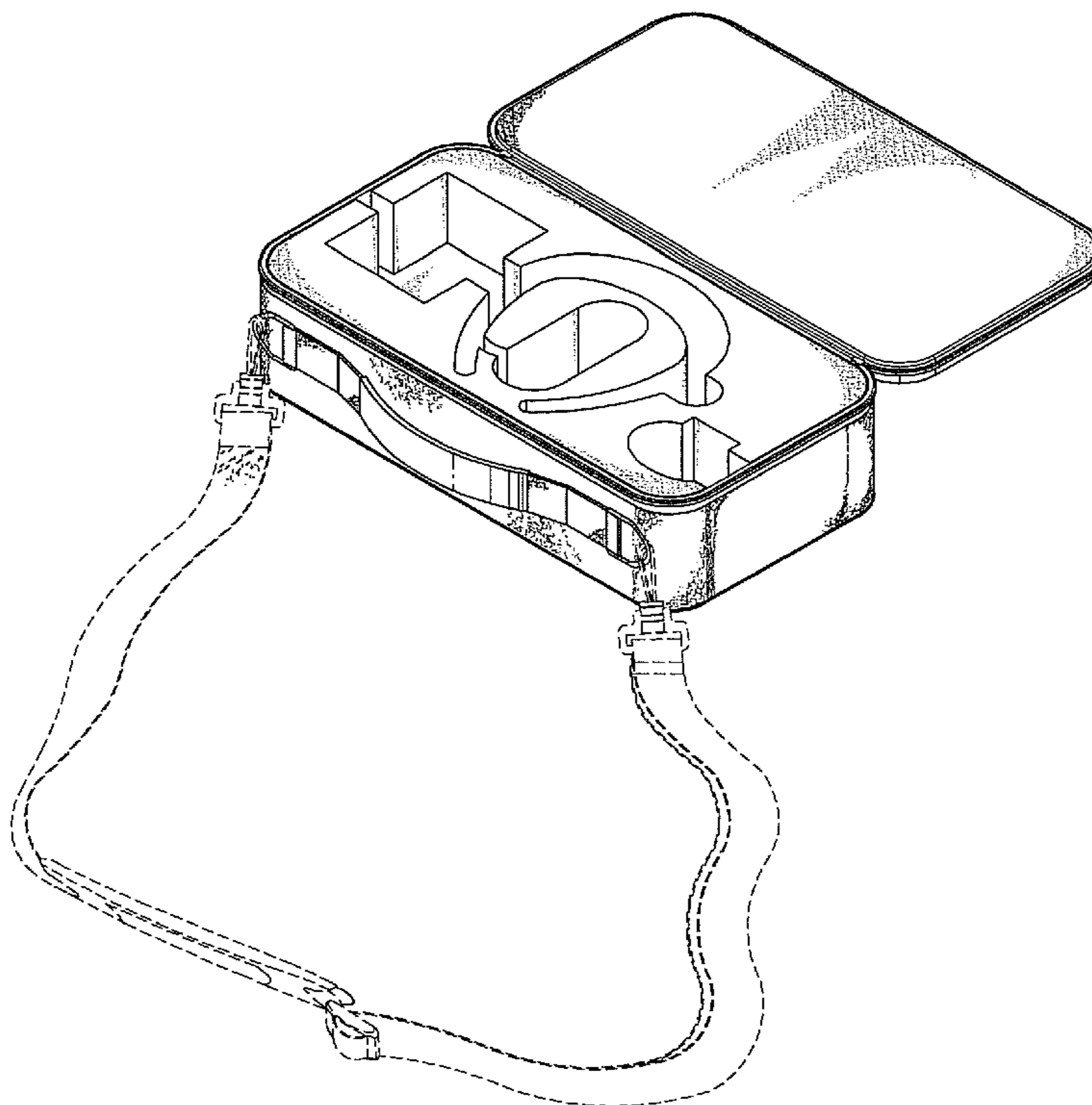
FIG. 7 is a opposite side elevational view thereof;

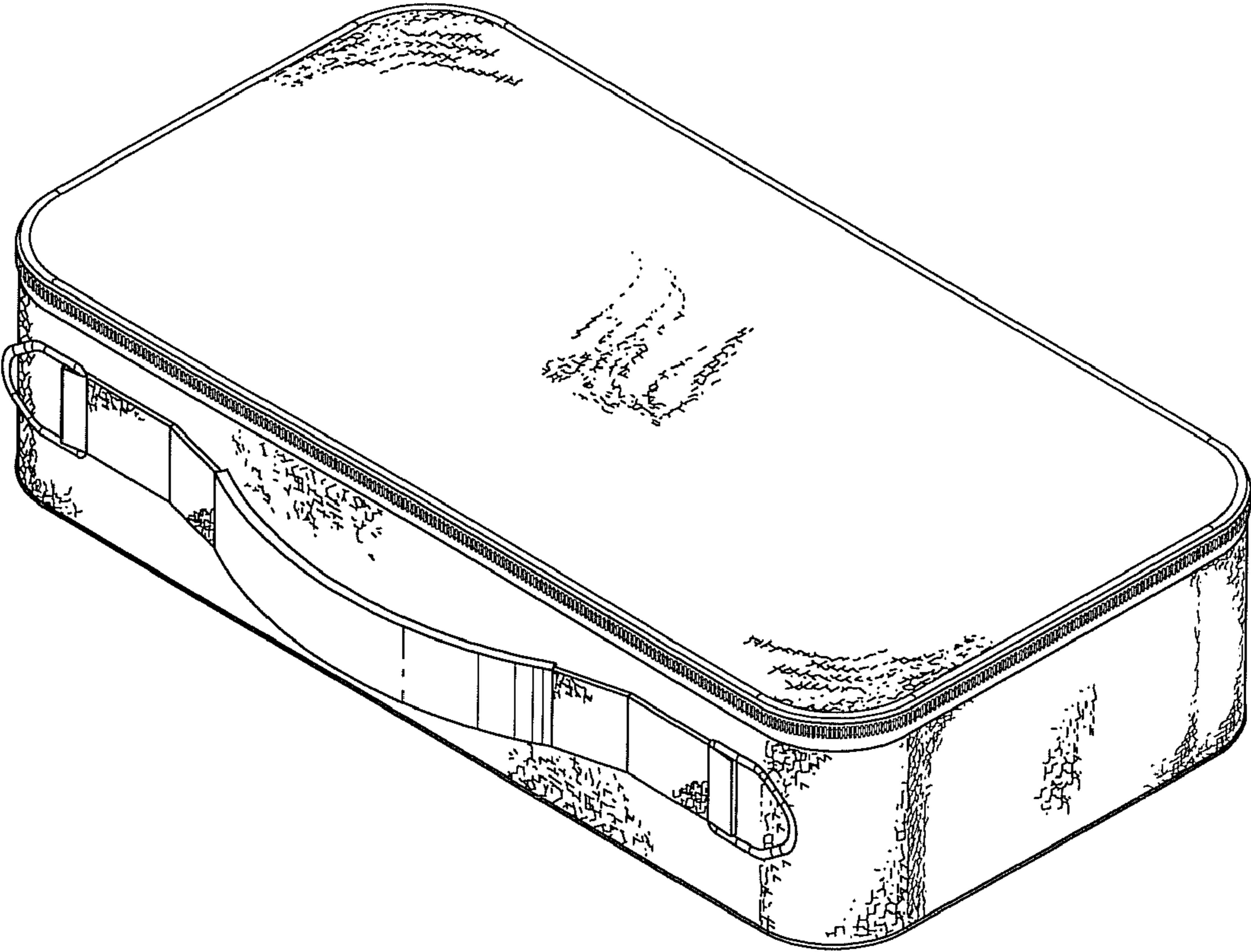

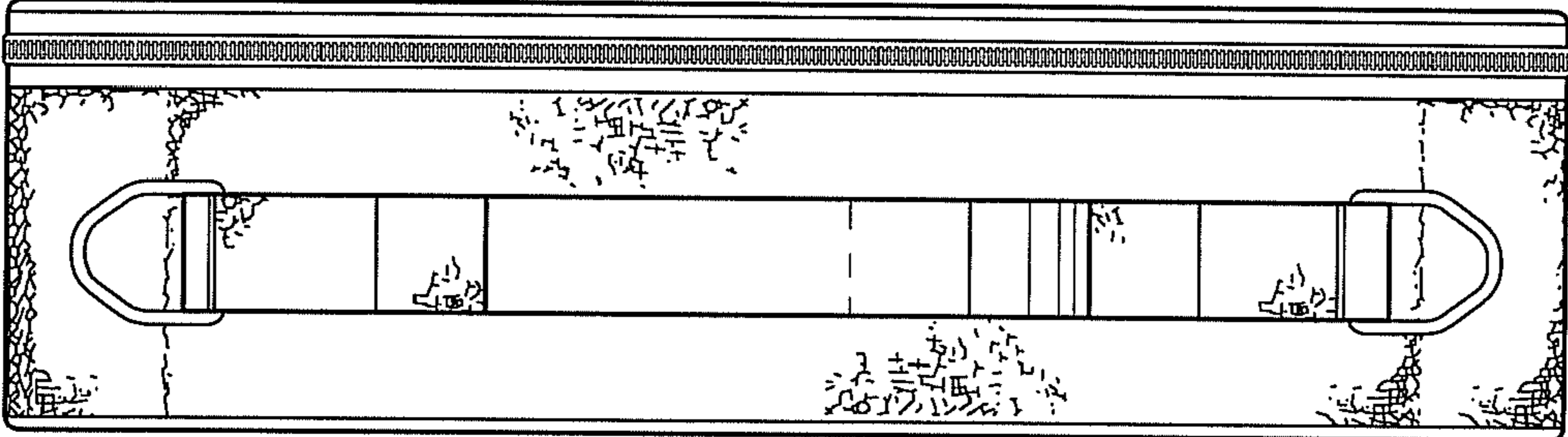

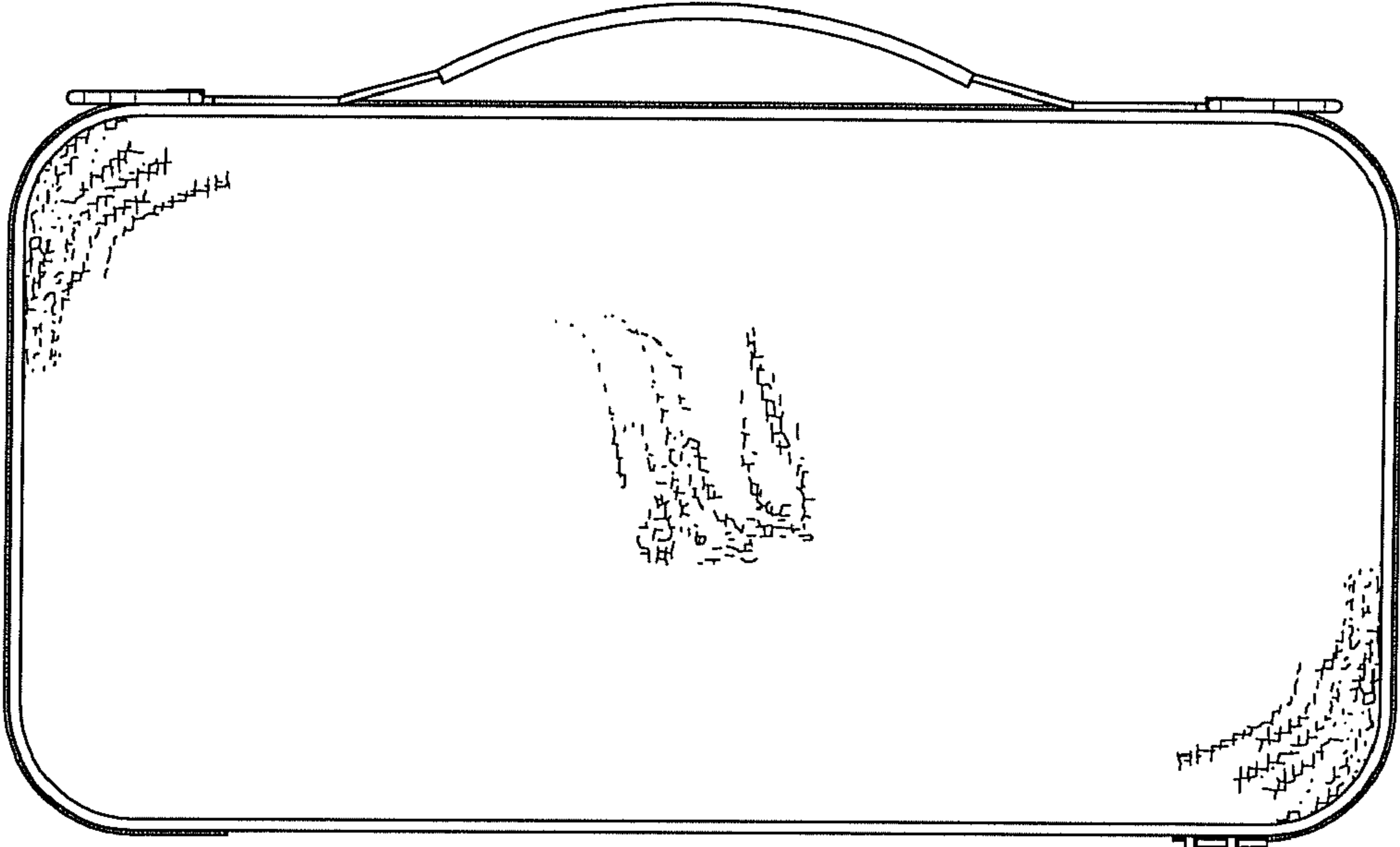

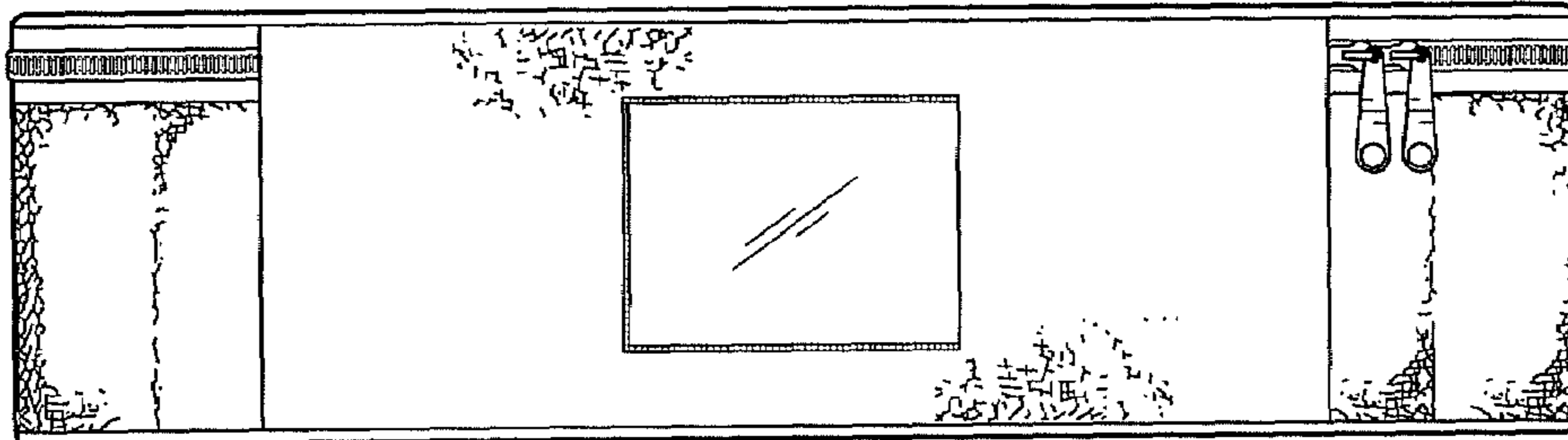

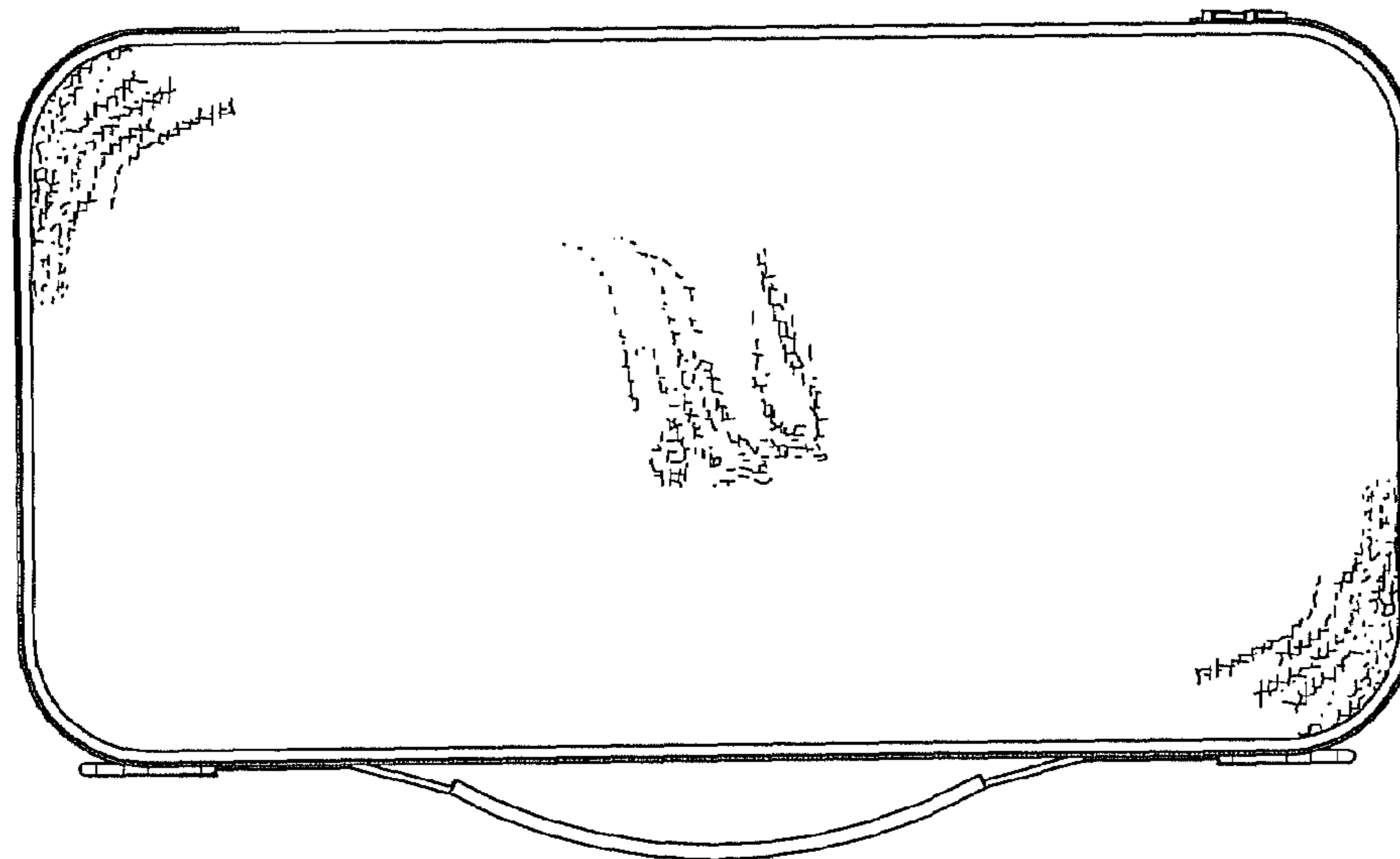

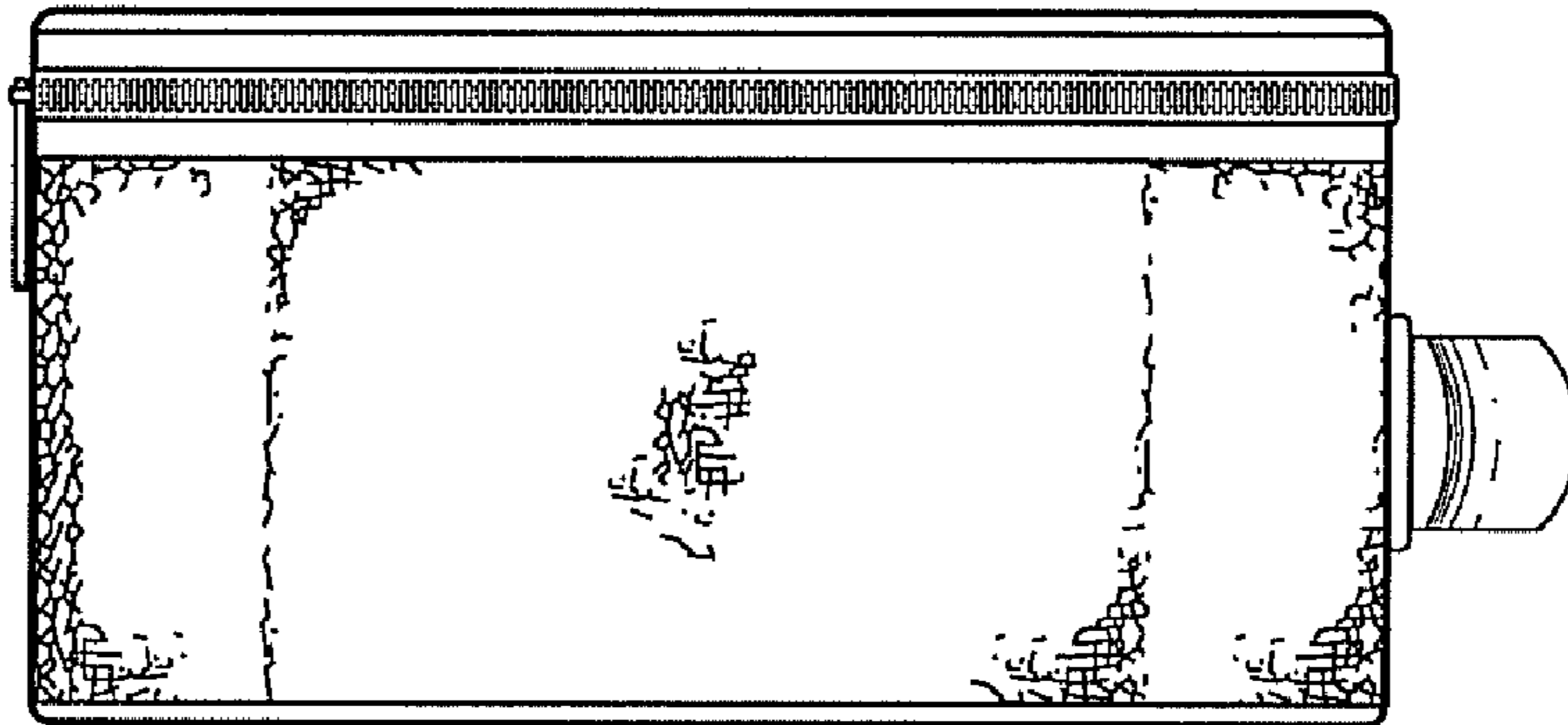

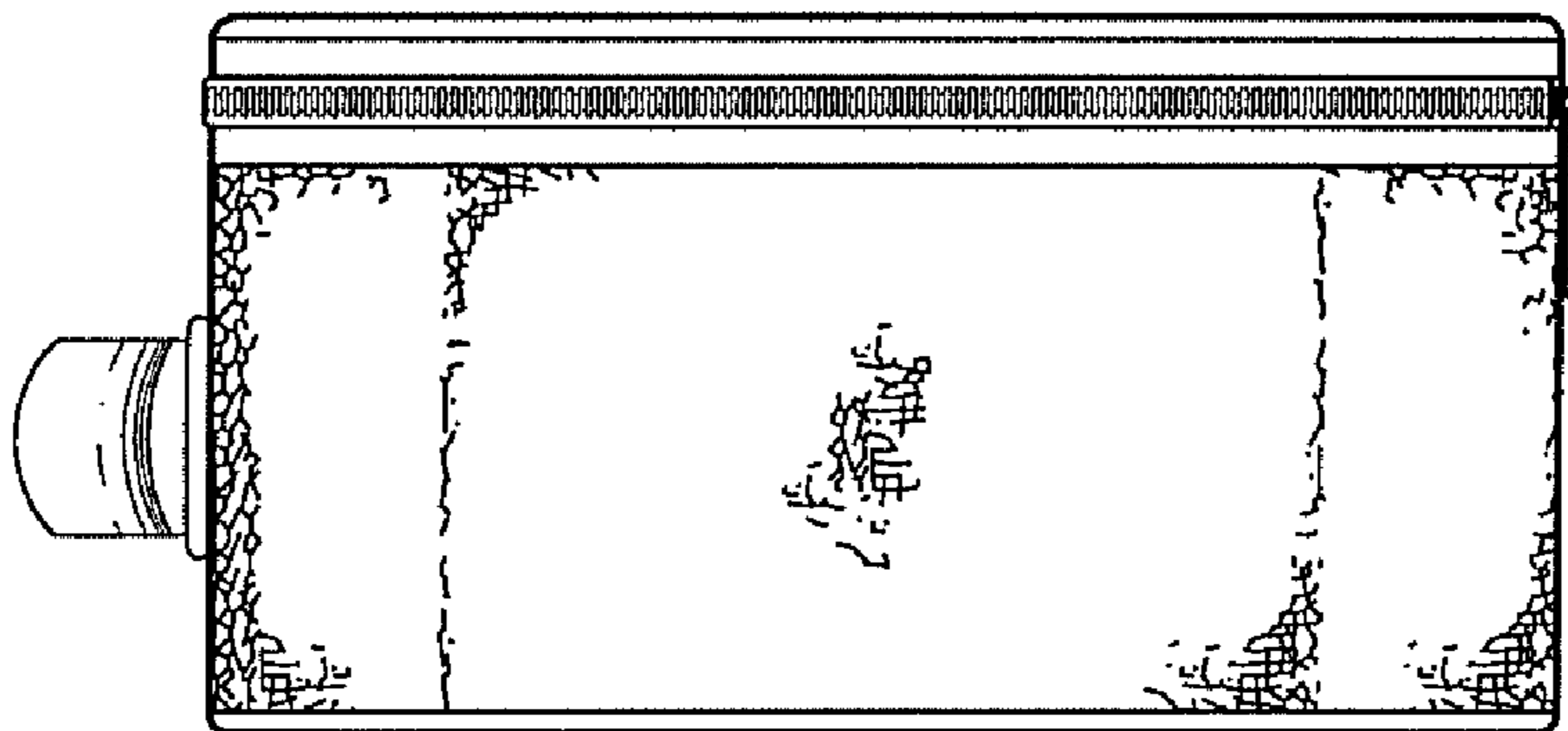

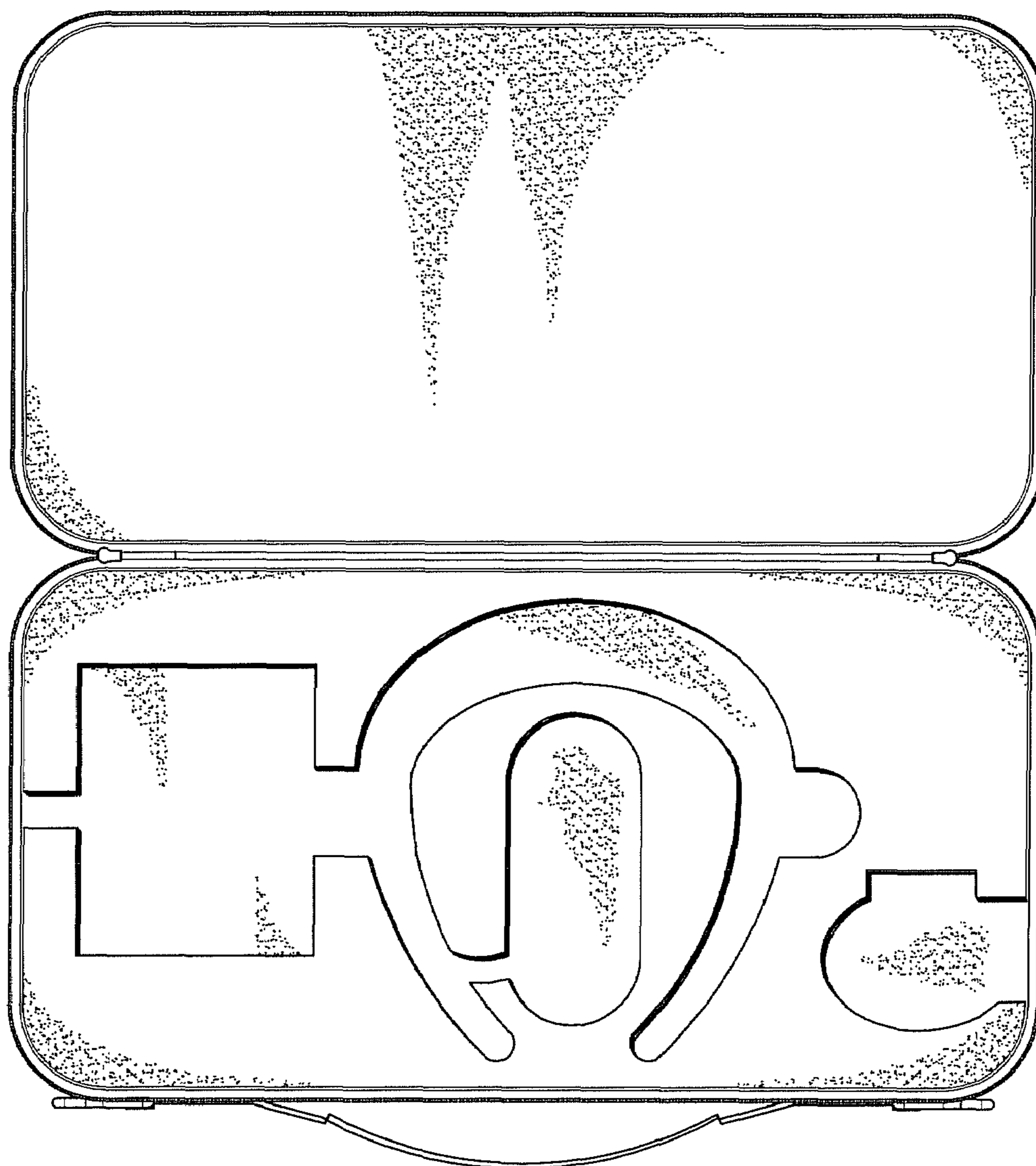

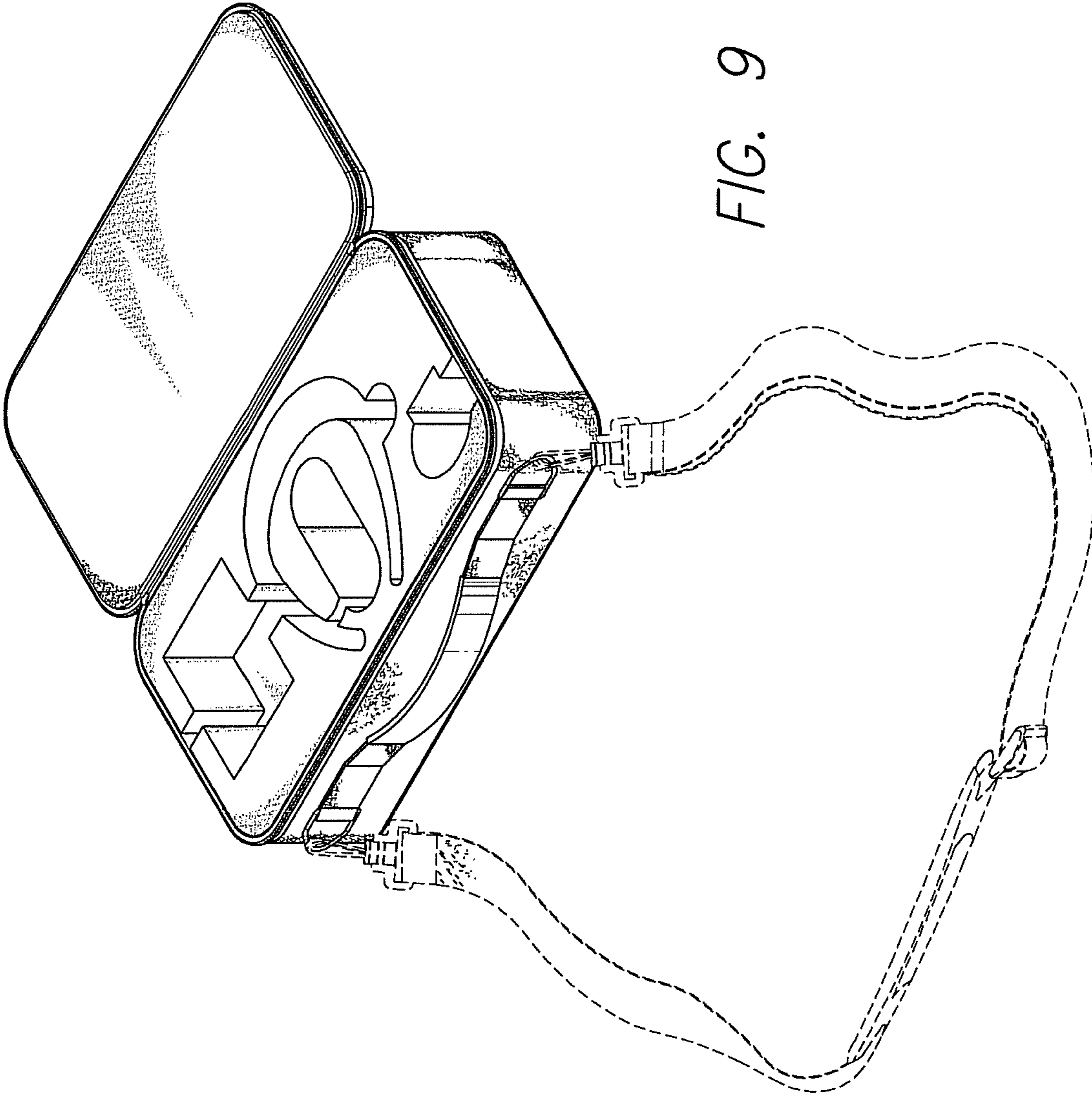
