The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a handbag showing my new design;

FIG. 2 is a front view of the handbag shown in FIG. 1;

FIG. 4 is a left side view of the handbag shown in FIG. 1;

FIG. 7 is a bottom view of the handbag shown in FIG. 1;

FIG. 8 is a front perspective view of an alternative embodiment of the handbag shown in FIG. 1;

FIG. 9 is a front view of the alternative embodiment of the handbag shown in FIG. 8;

FIG. 10 is a rear view of the alternative embodiment of the handbag shown in FIG. 8;

FIG. 11 is a left side view of the alternative embodiment of the handbag shown in FIG. 8;

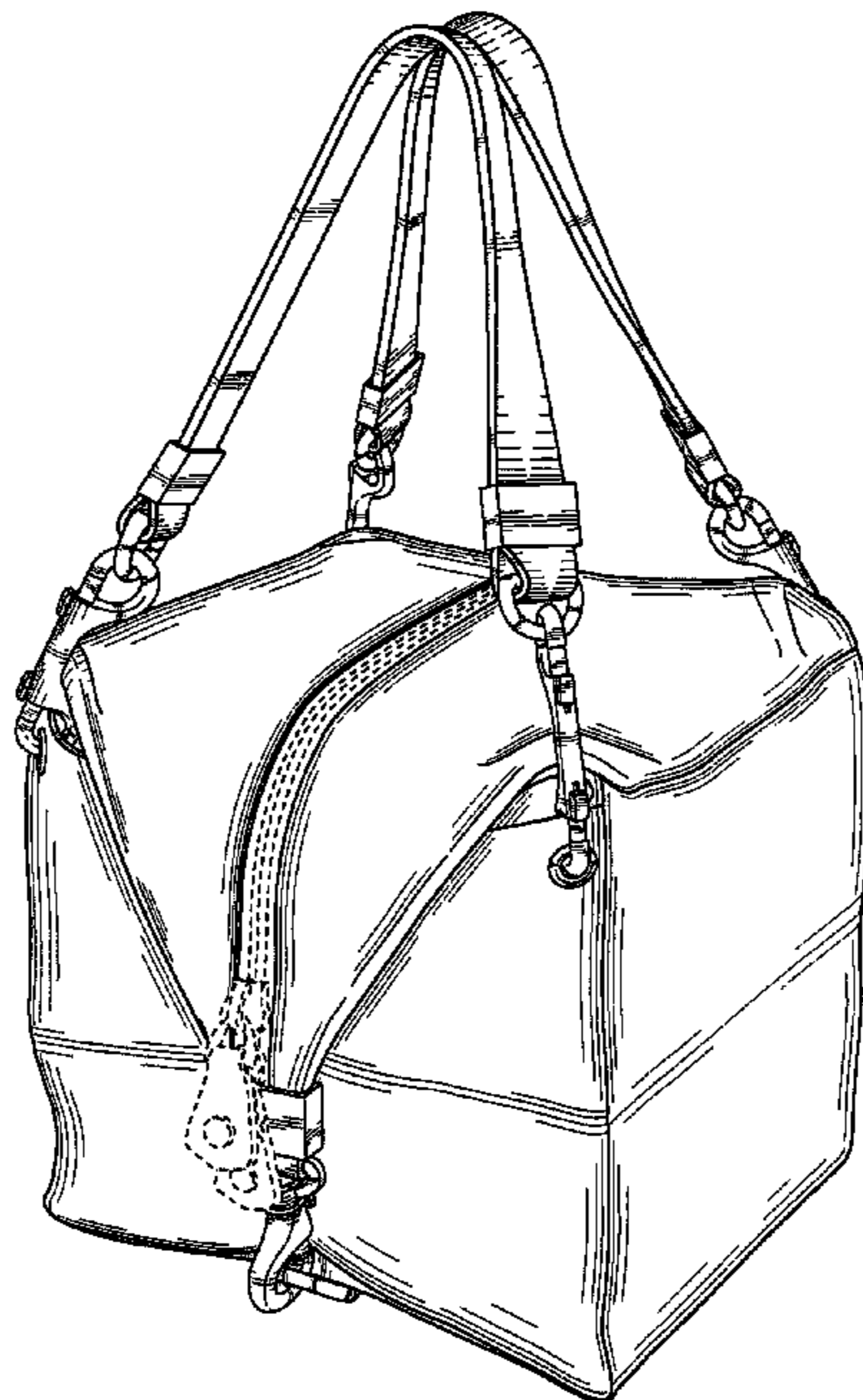
FIG. 12 is a right side view of the alternative embodiment of the handbag shown in FIG. 8;

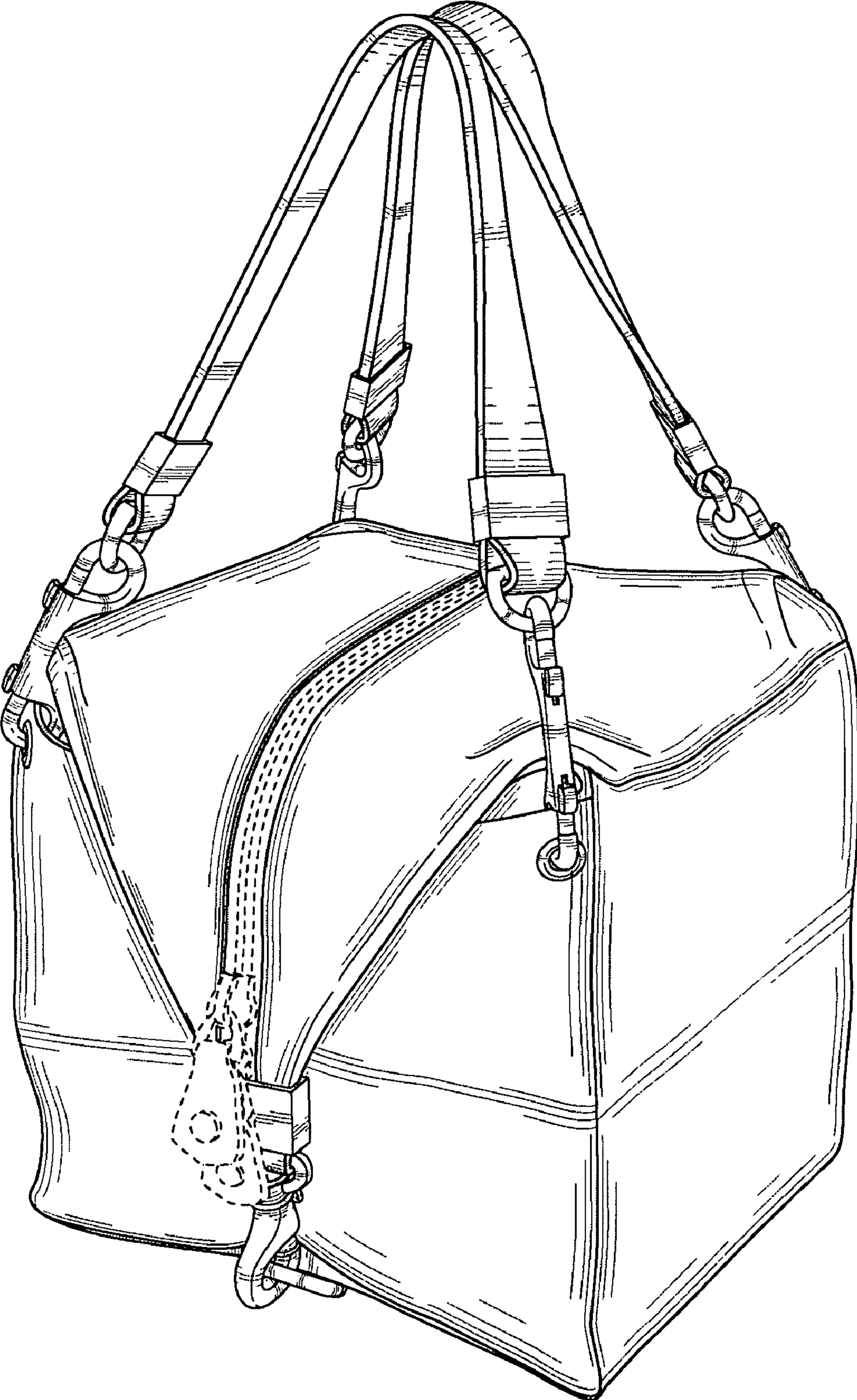

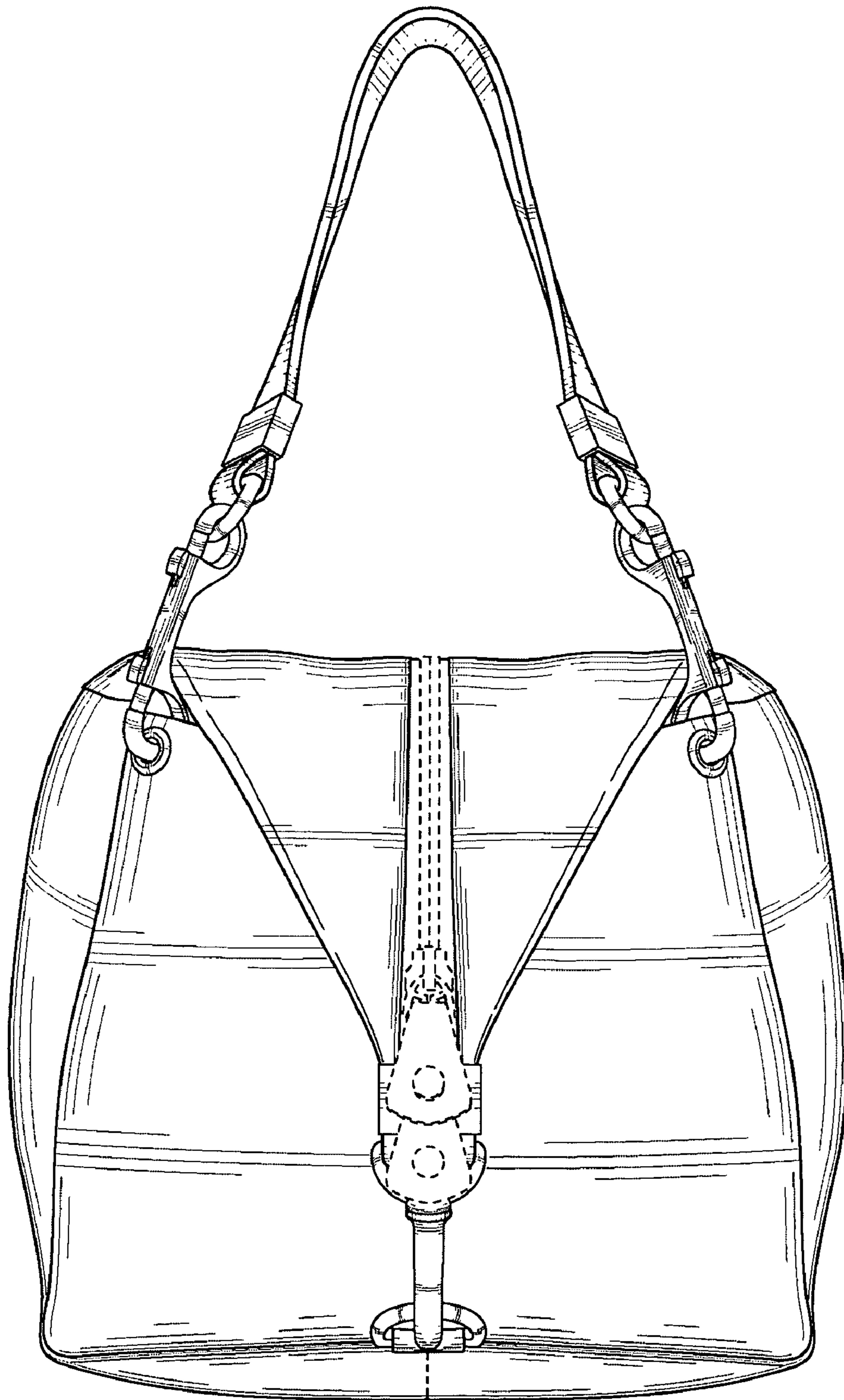

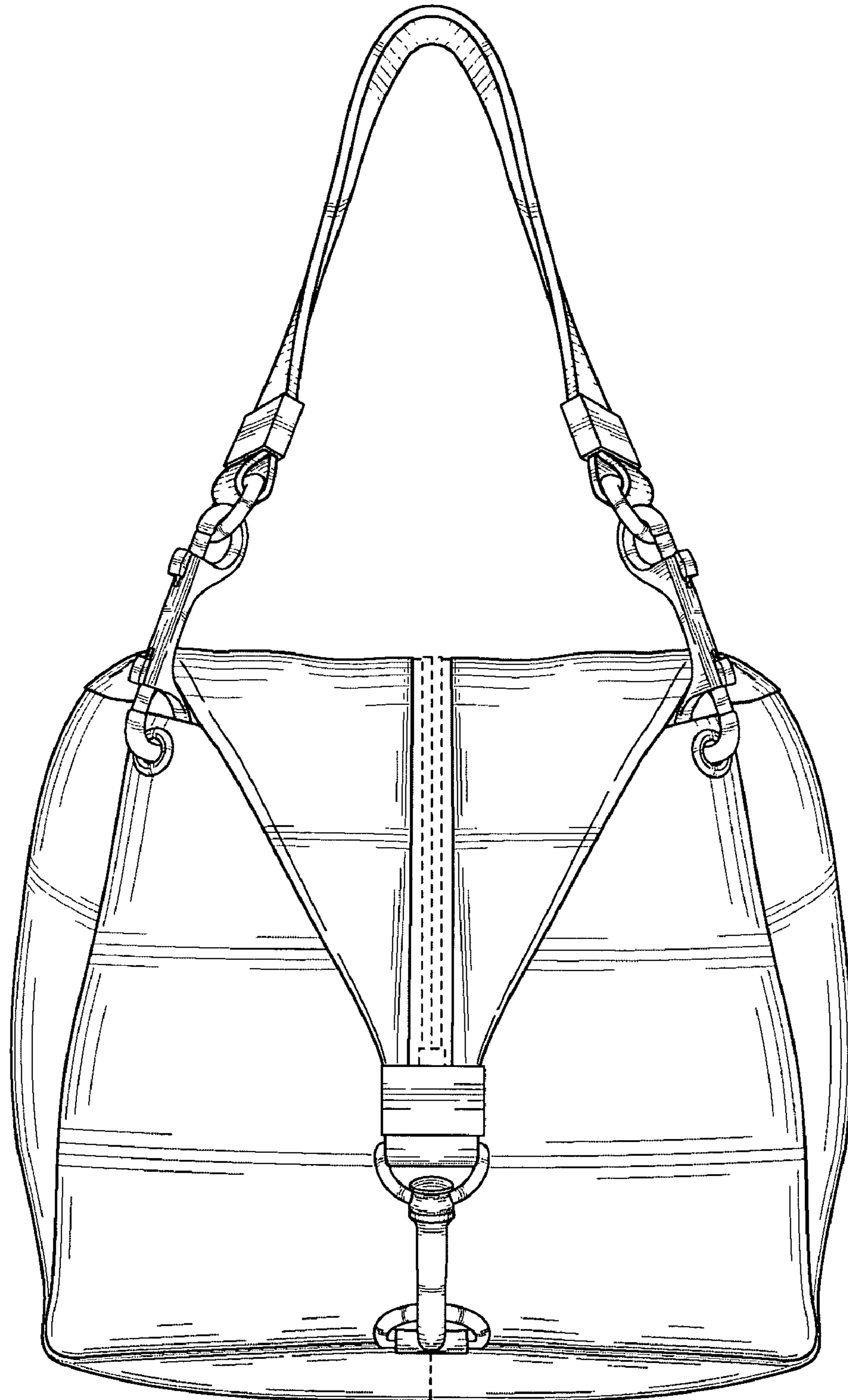

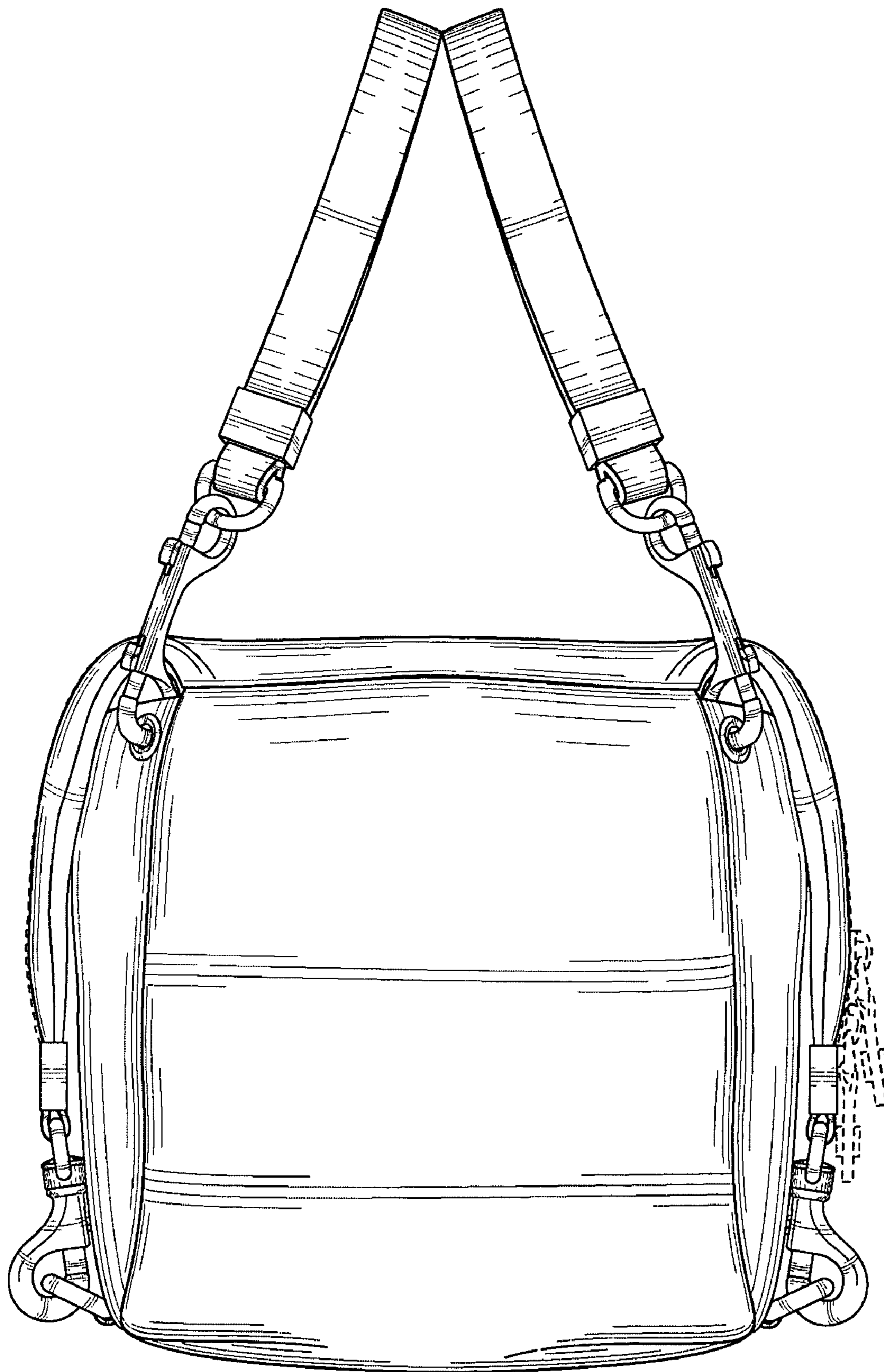

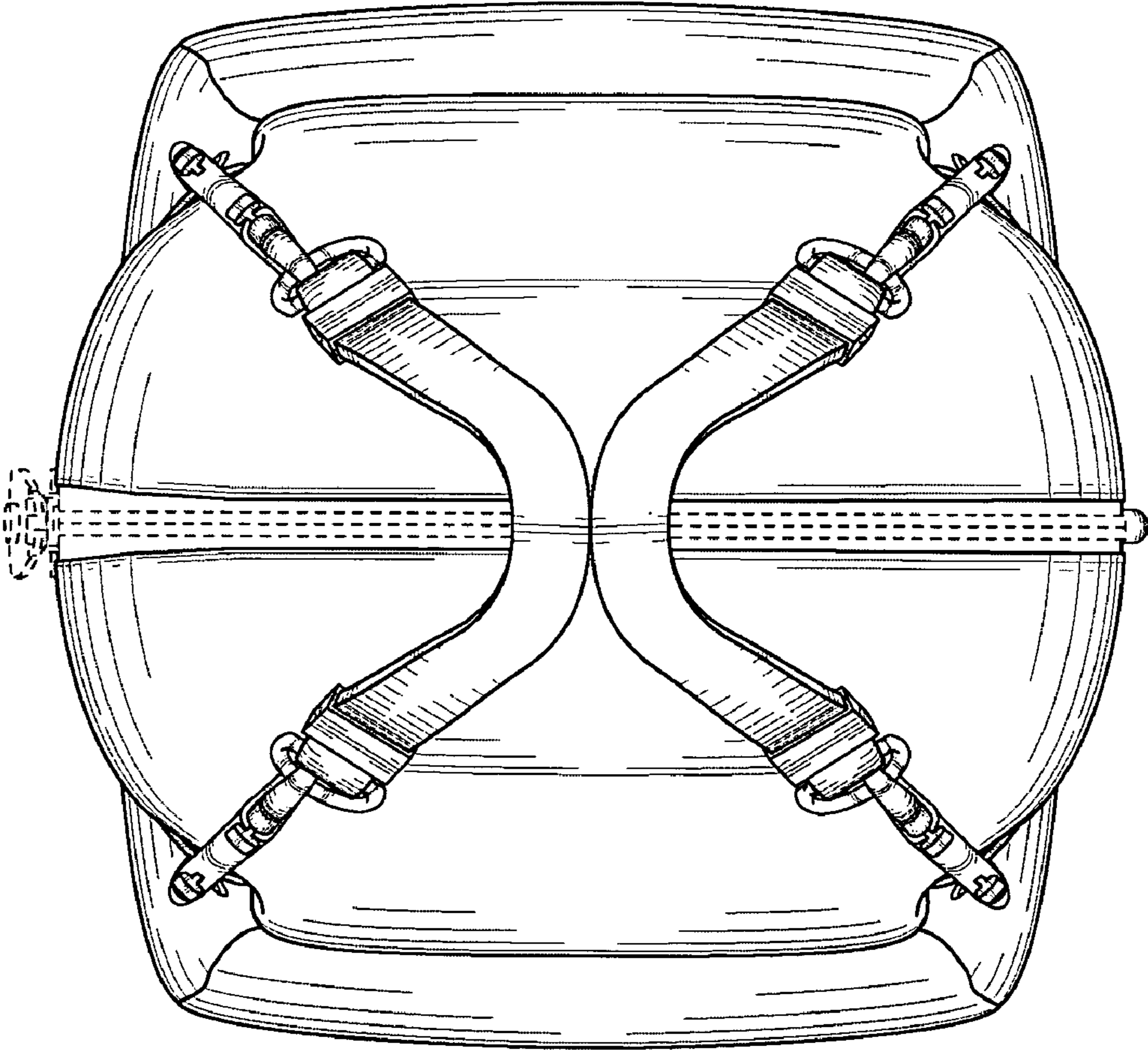

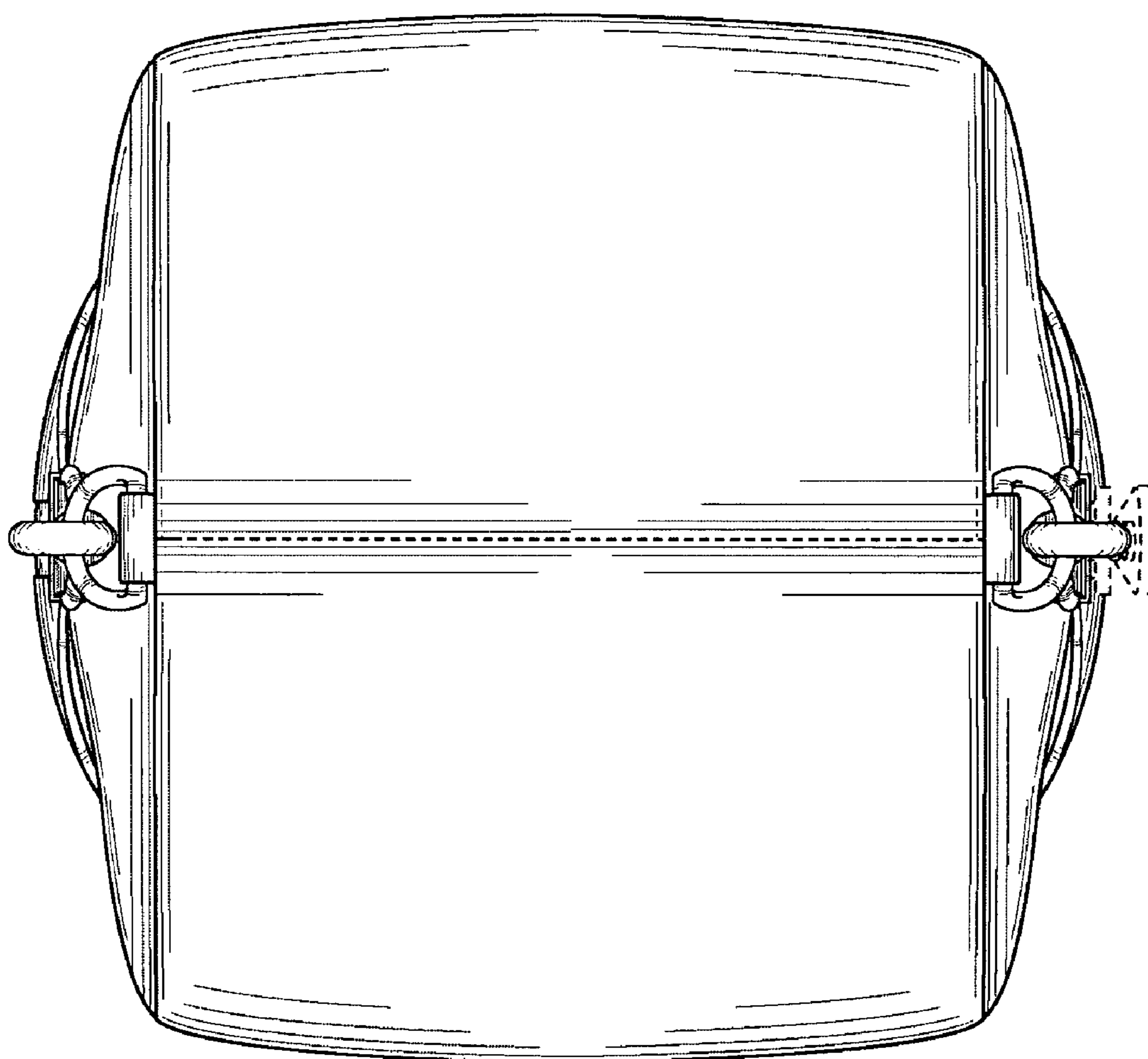

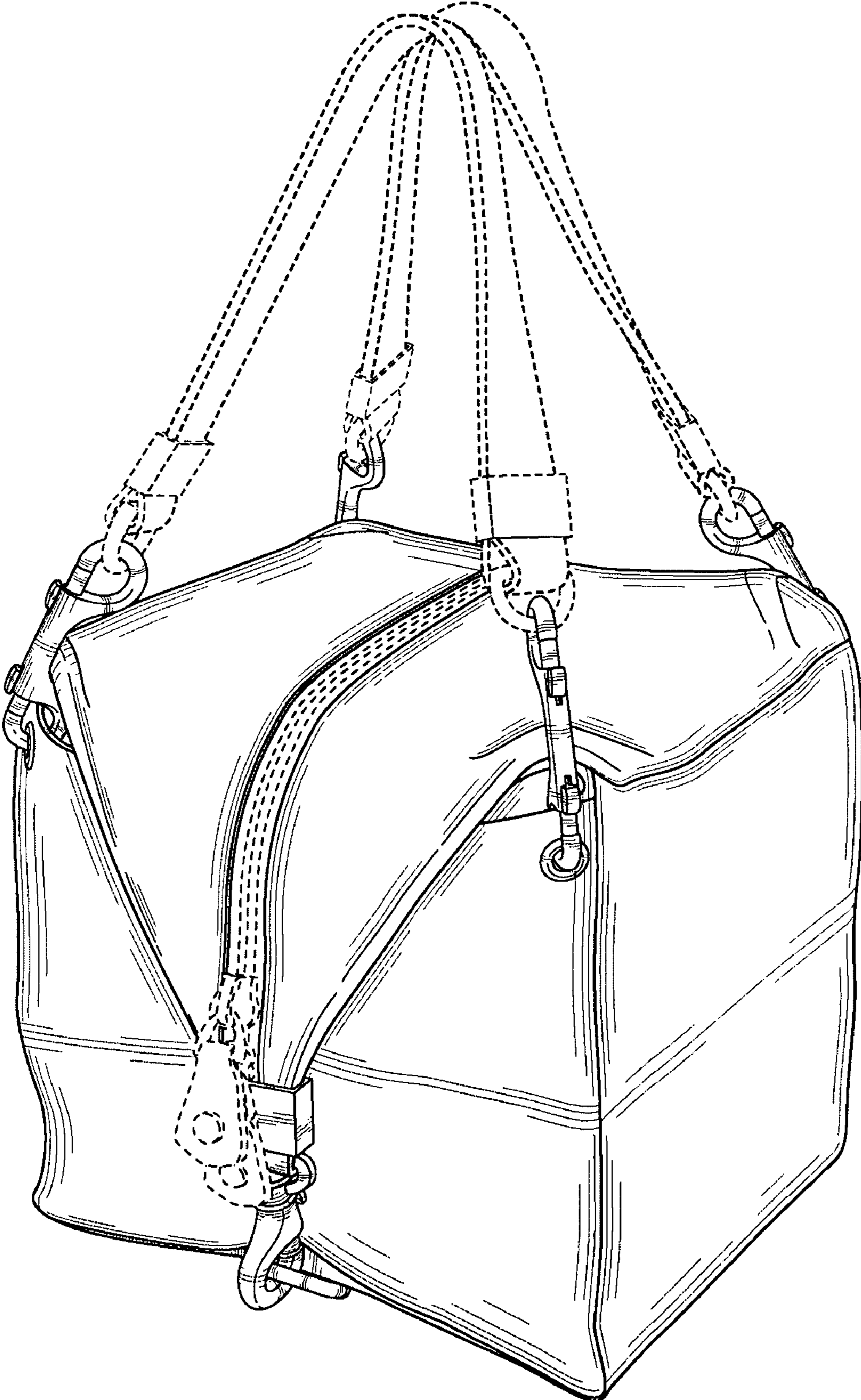

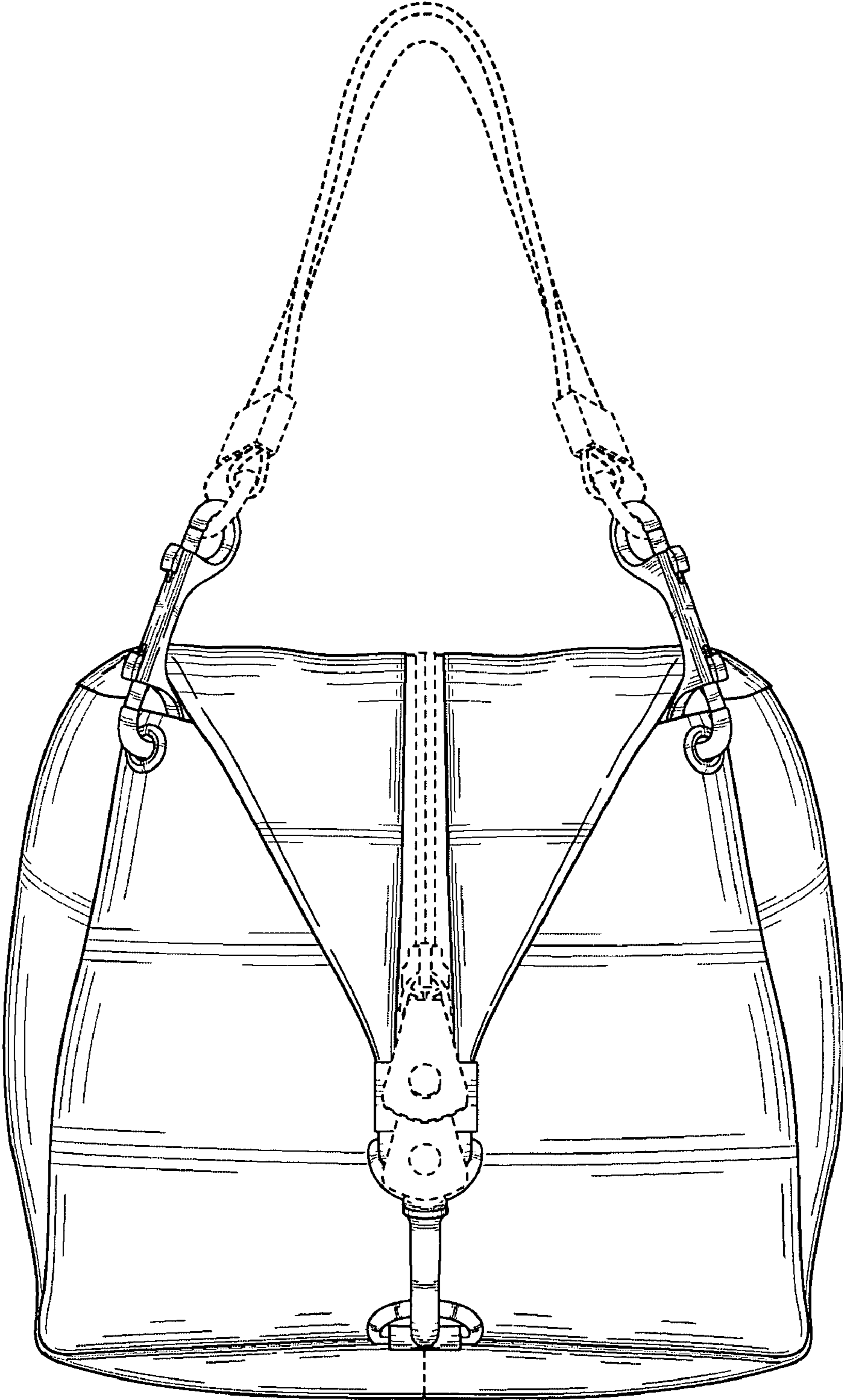

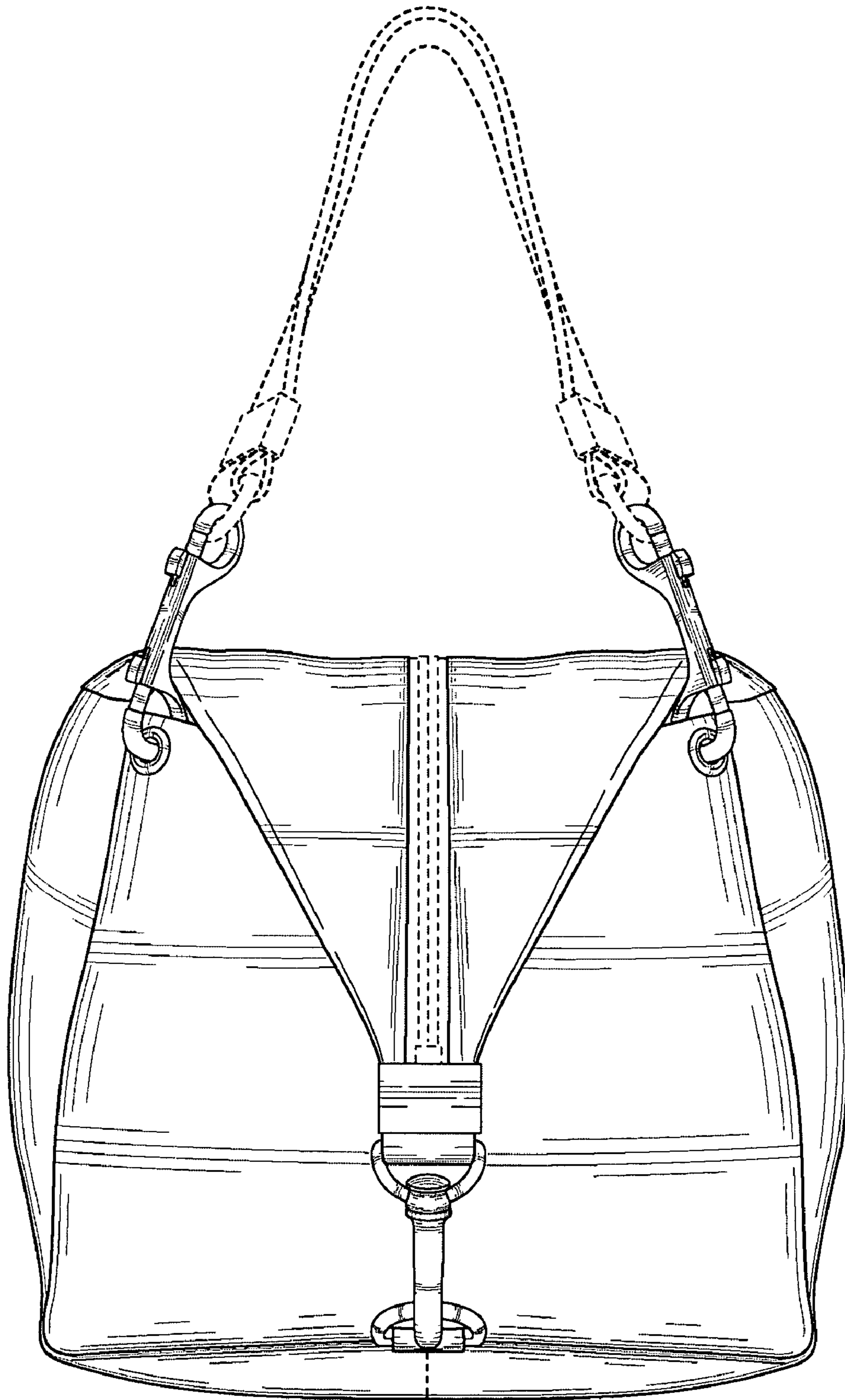

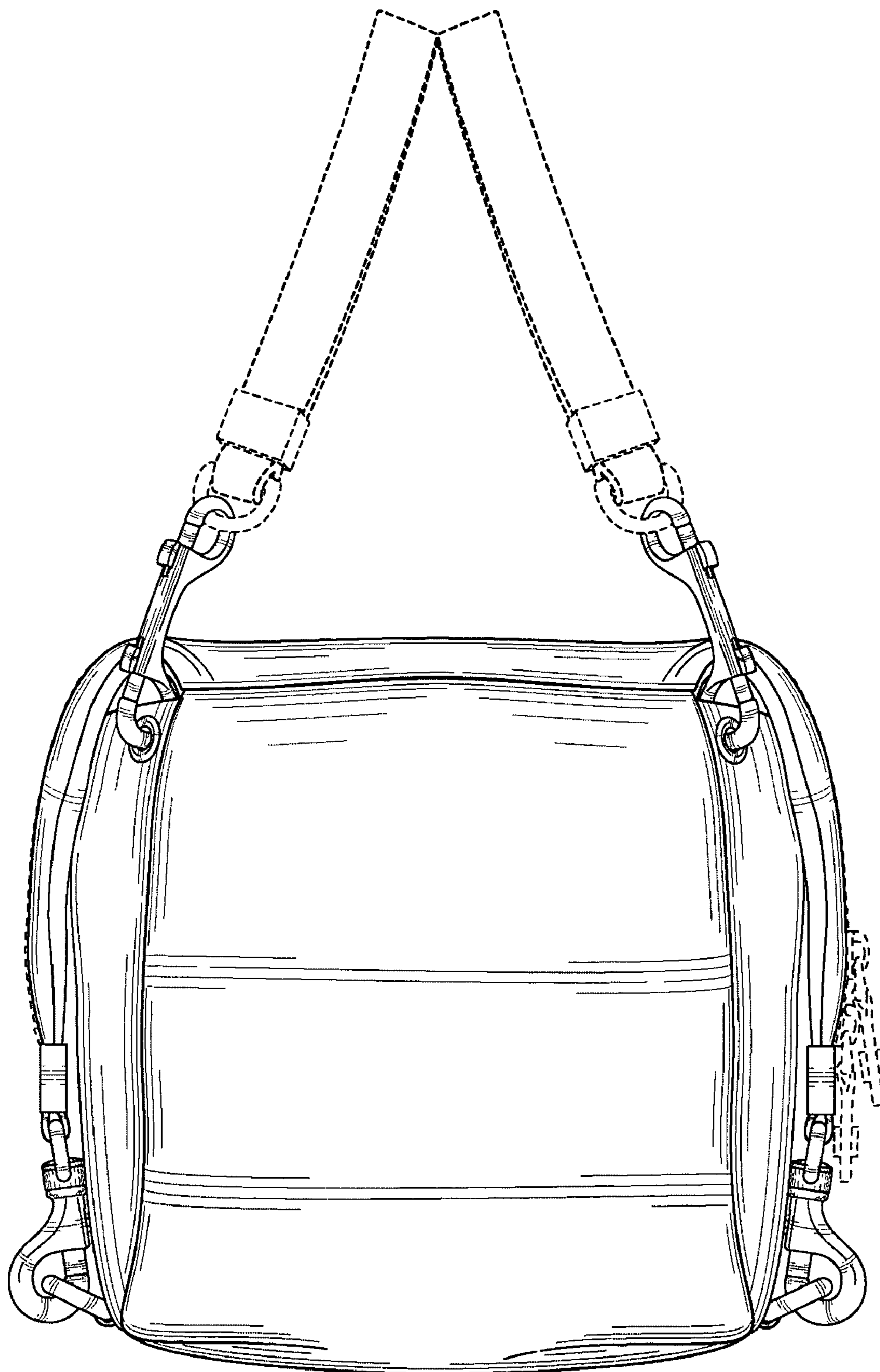

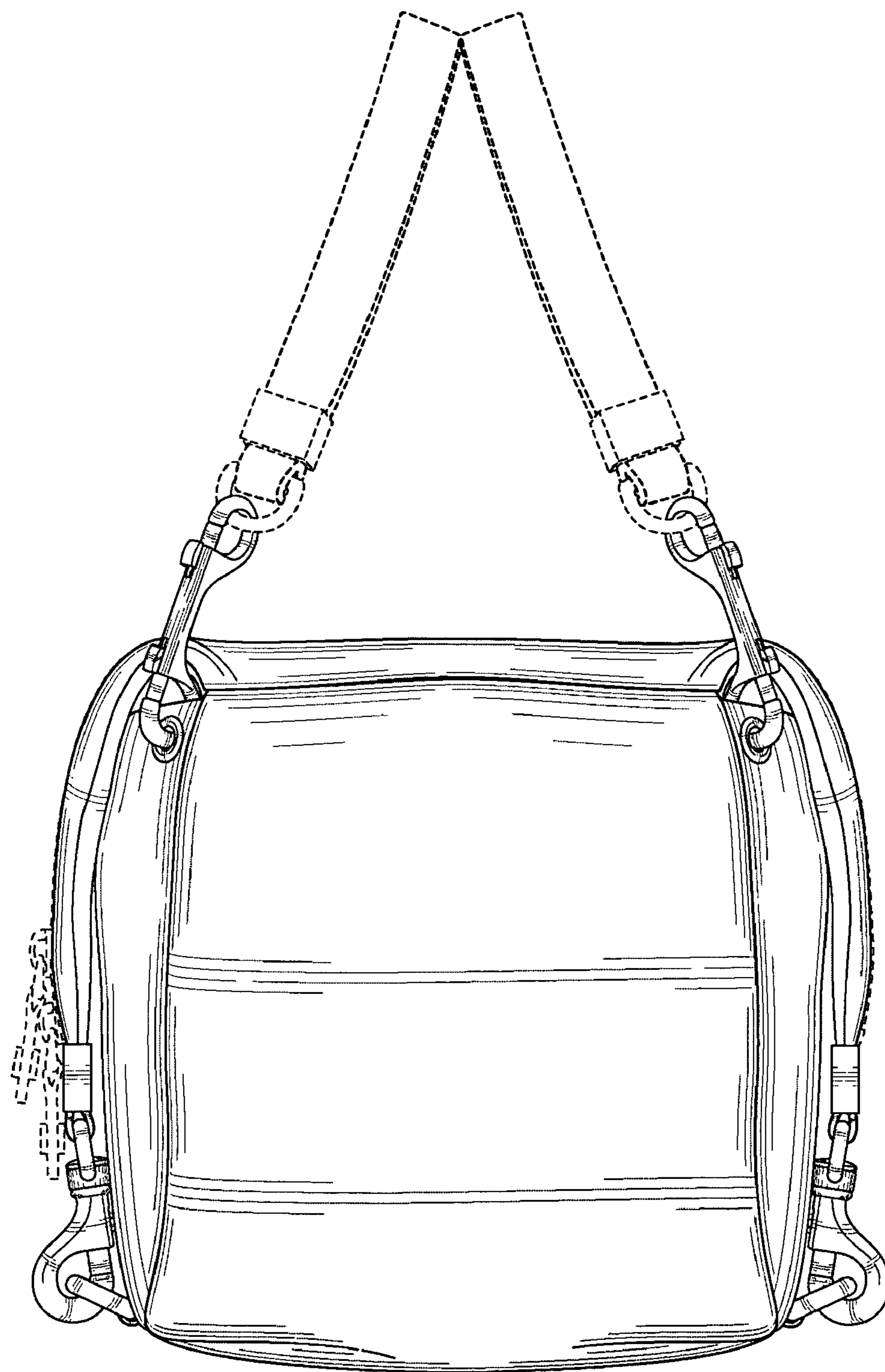

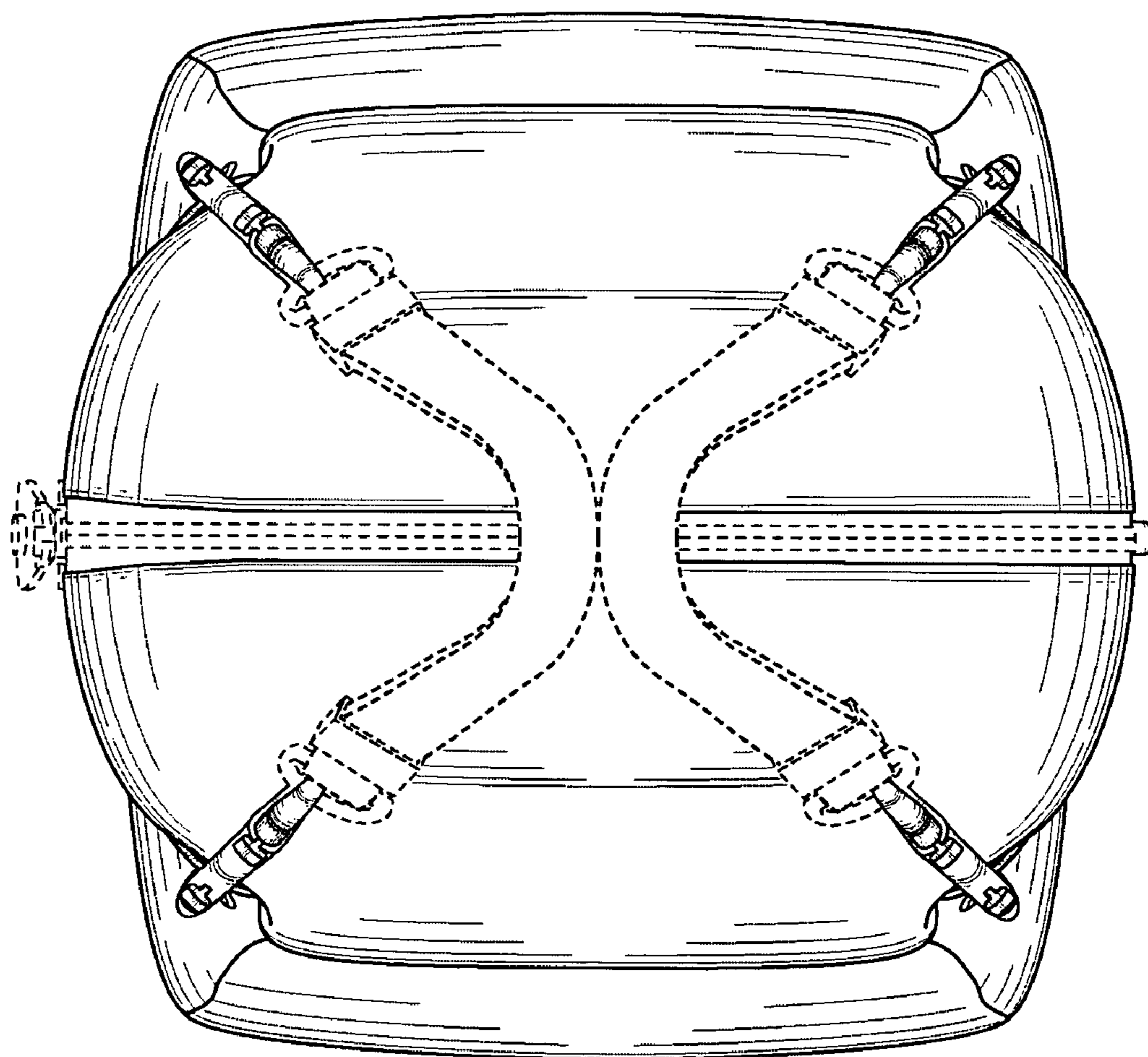

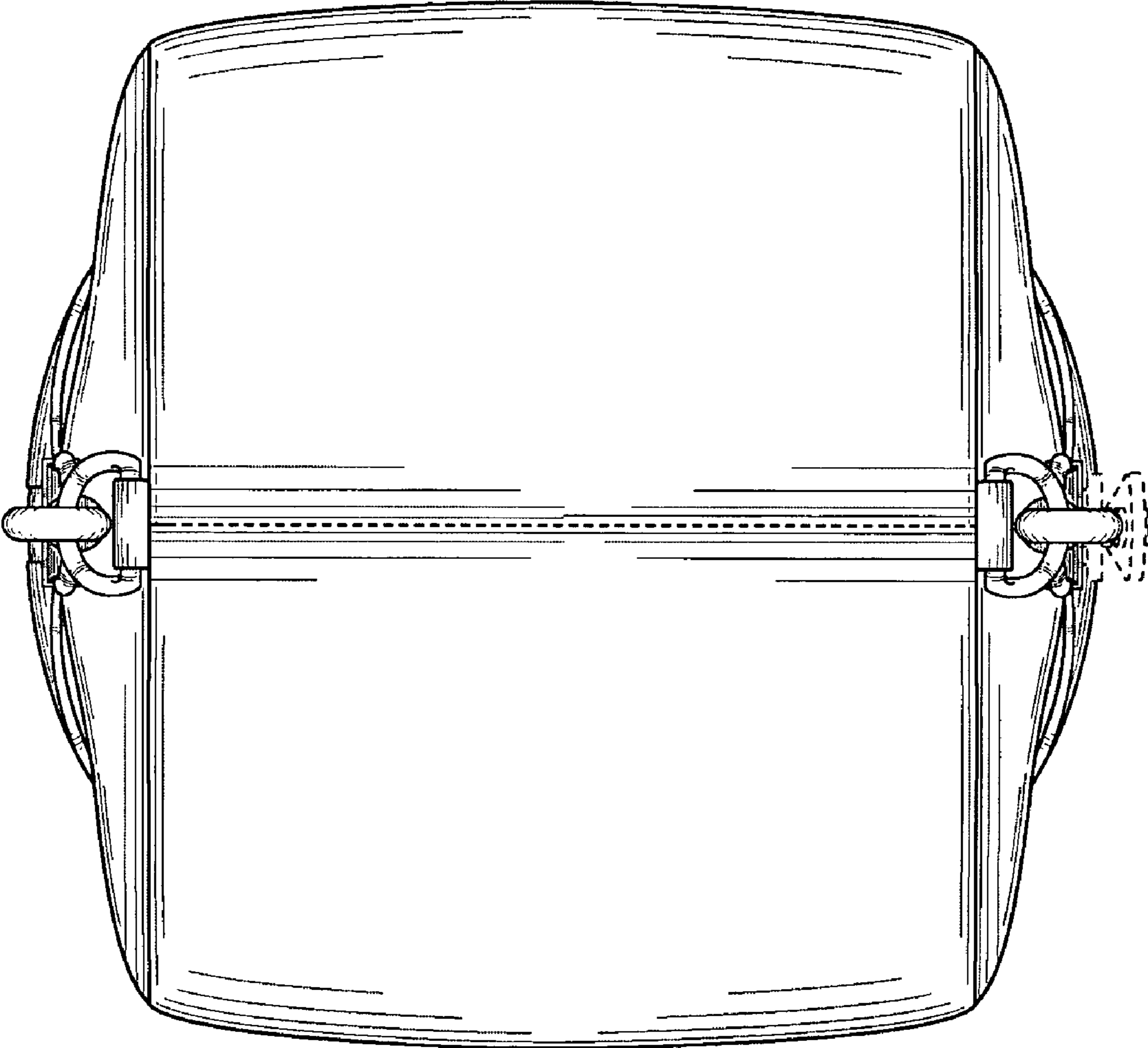
